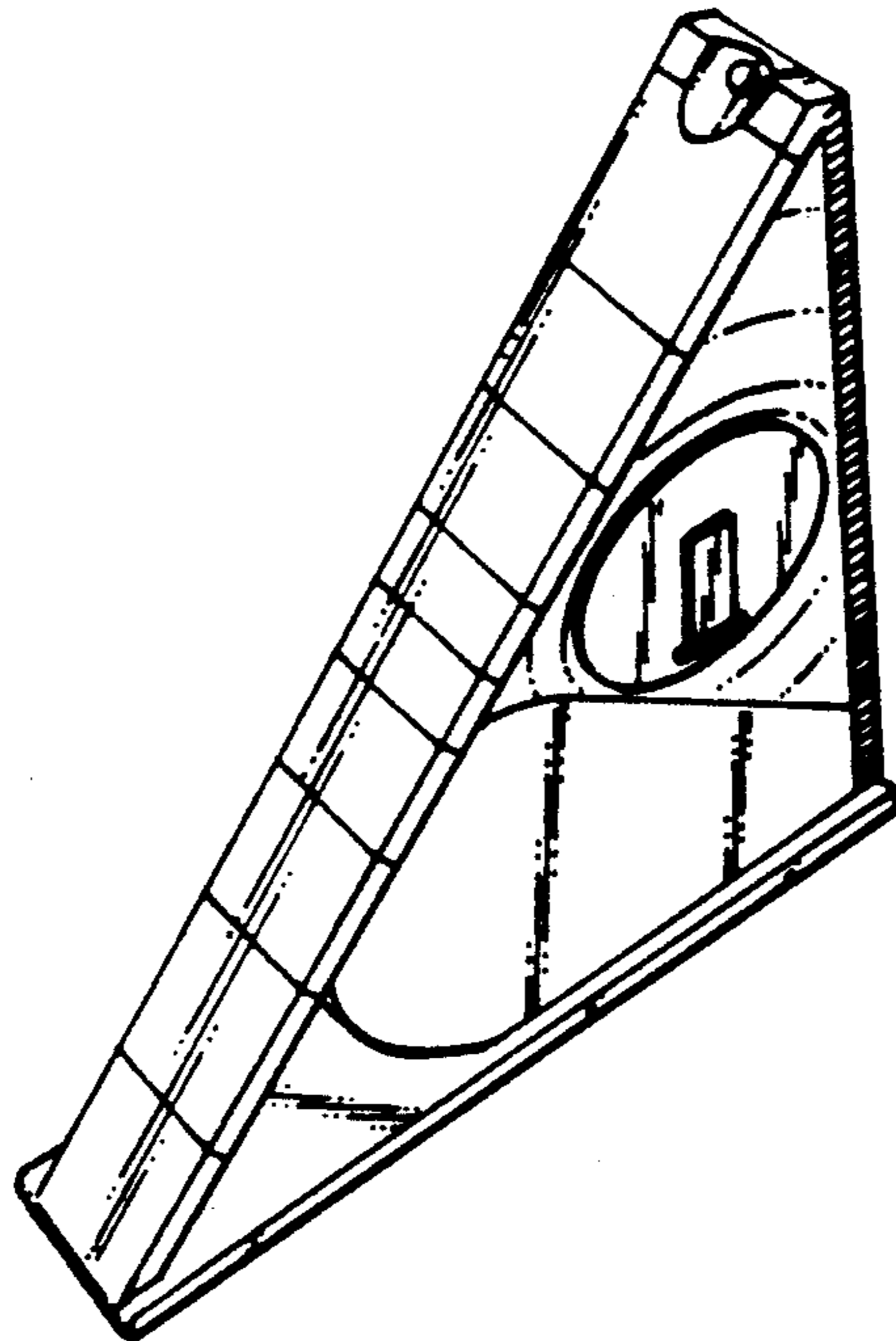

[57] CLAIM

The ornamental design for a combination tape measure and square, as shown and described.

DESCRIPTION

FIG. 1 is a top and front perspective view of a combination tape measure and square showing my new design; FIG. 2 is a top view; FIG. 3 is a front elevational view; FIG. 4 is a right side elevational view; FIG. 5 is a left side elevational view; FIG. 6 is a rear elevational view; FIG. 7 is a bottom plan view; FIG. 8 is a top and front perspective view of a second embodiment showing my new design of FIGS. 1-7, the broken line showing of pencil is for illustrative purposes only and forms no part of the claimed design; and, FIG. 9 is a top and front perspective view thereof, shown with the illustrative pencil omitted for easy of illustration. FIGS. 1, 8 and 9 have been drawn on a reduced scale with respect to FIGS. 2-7.



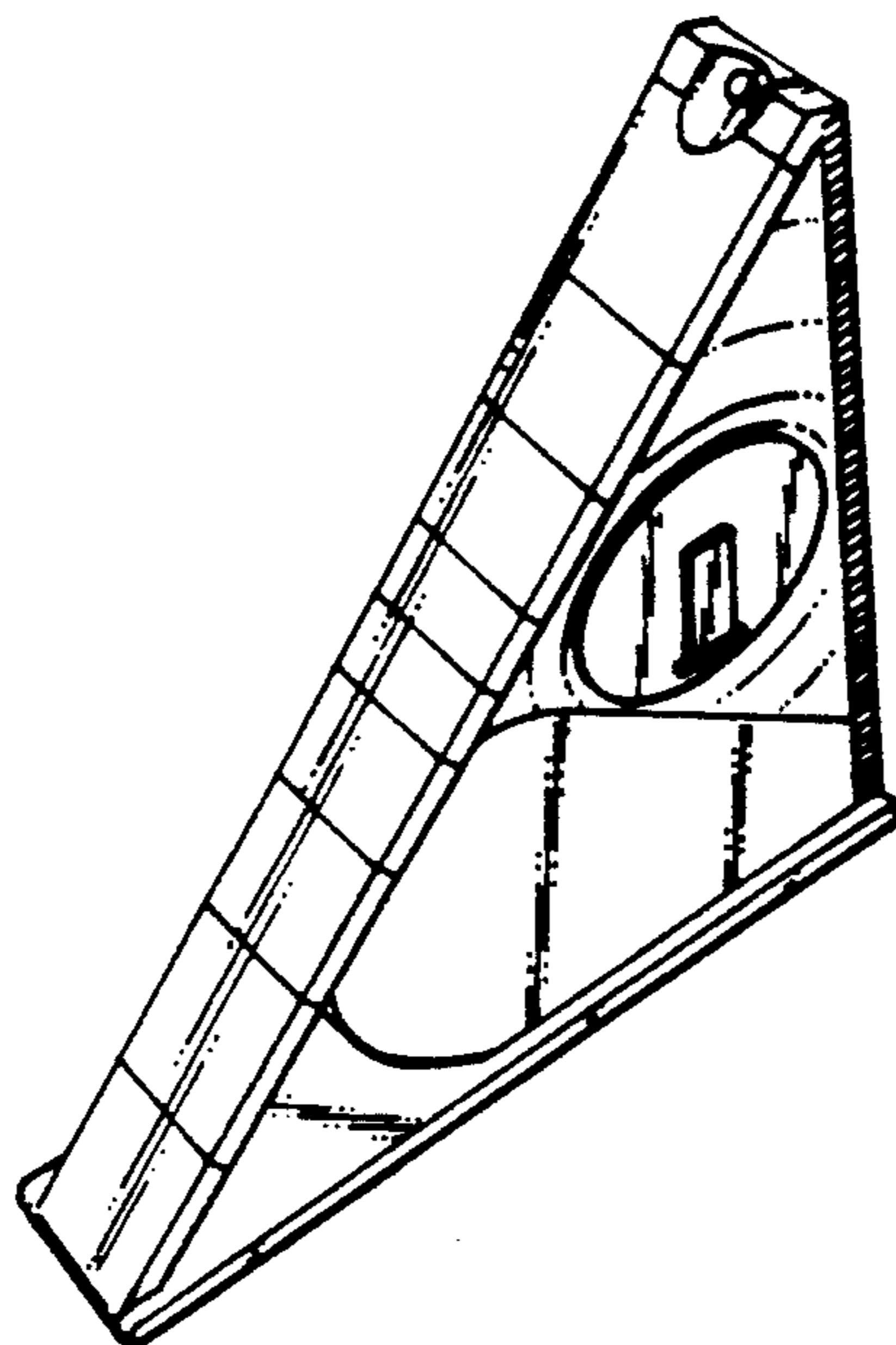

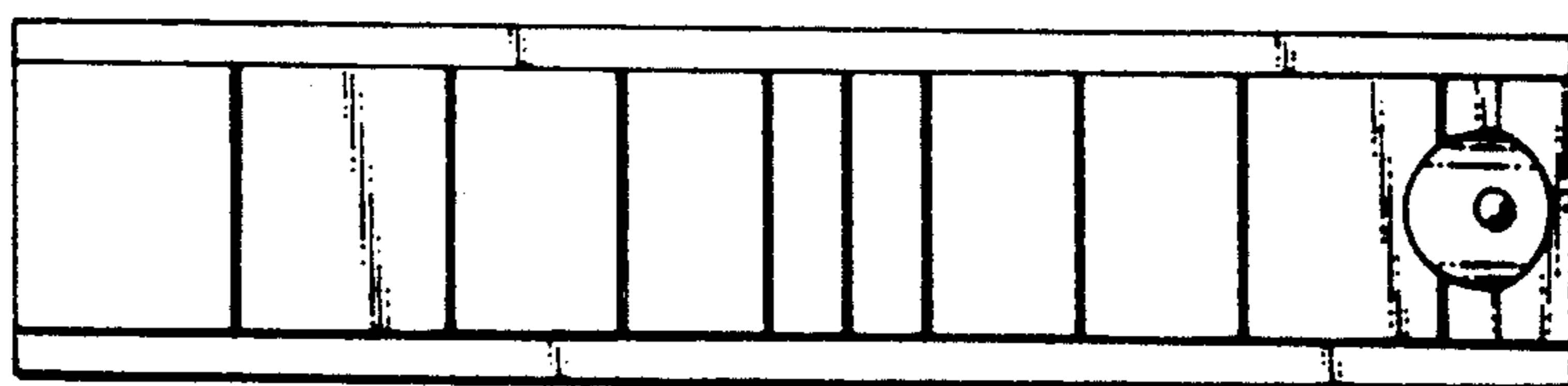

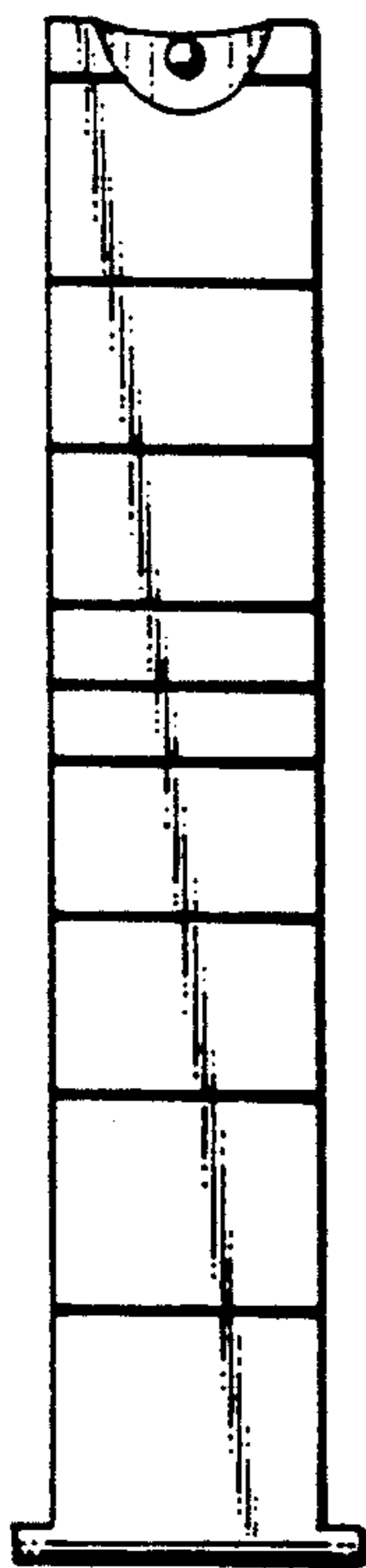

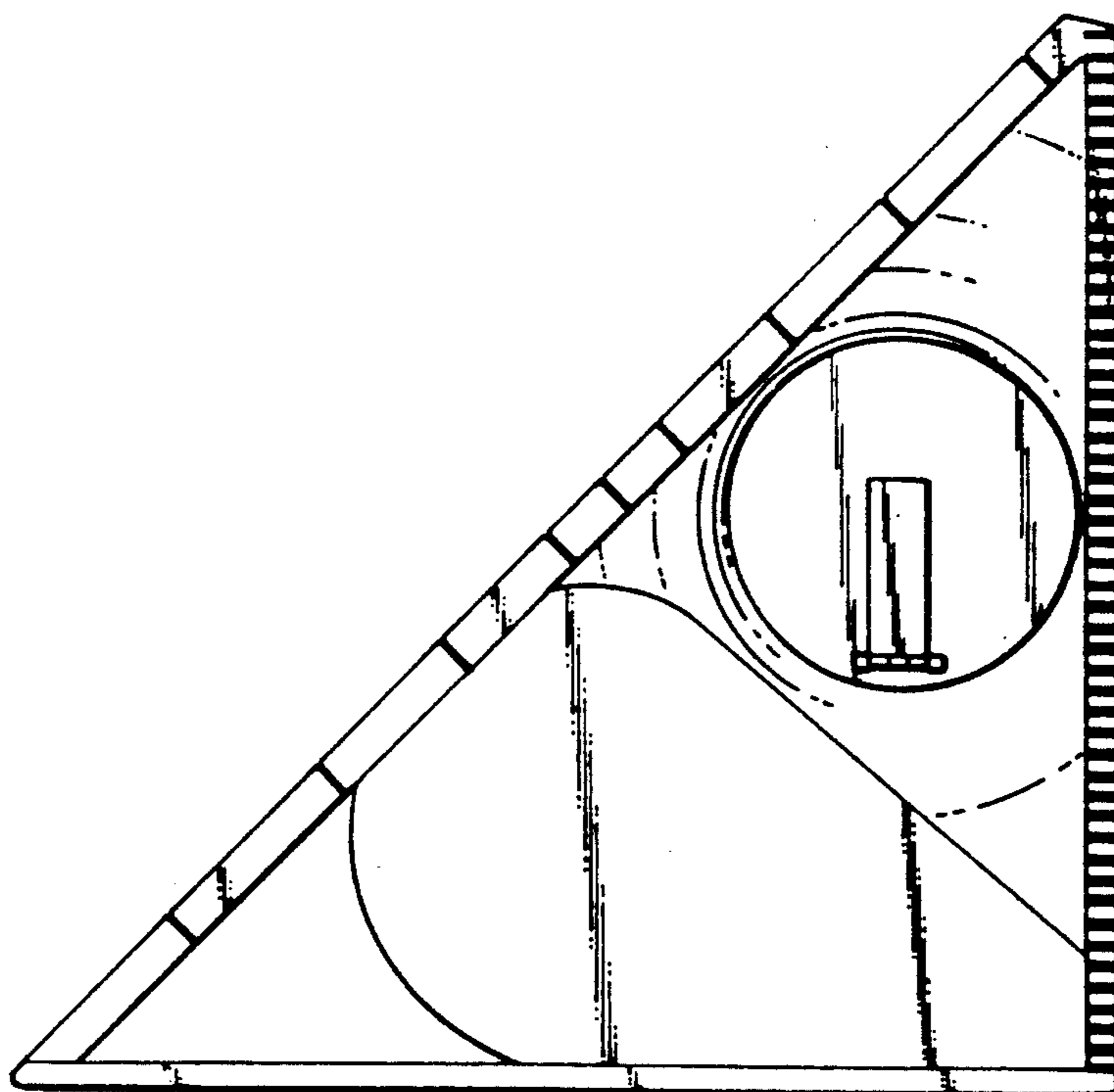

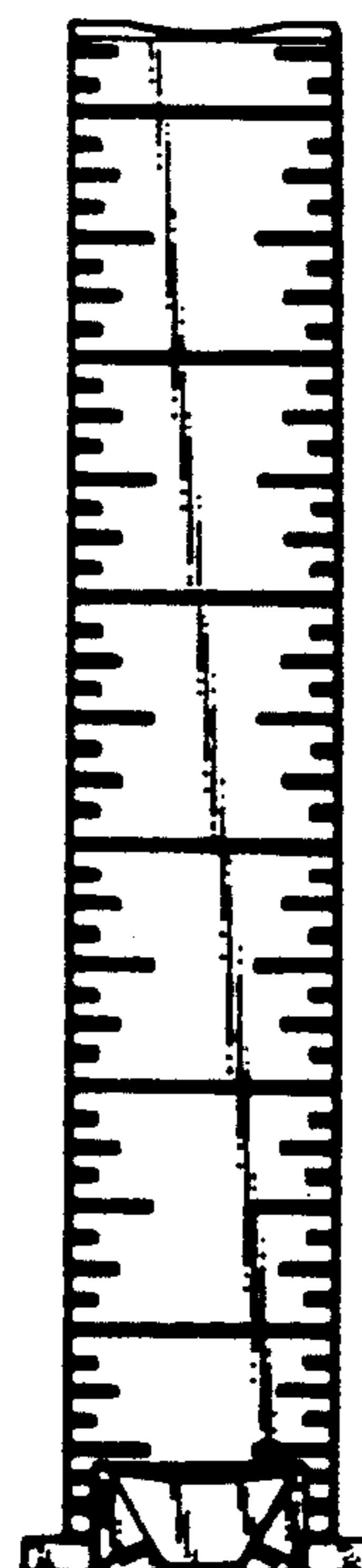

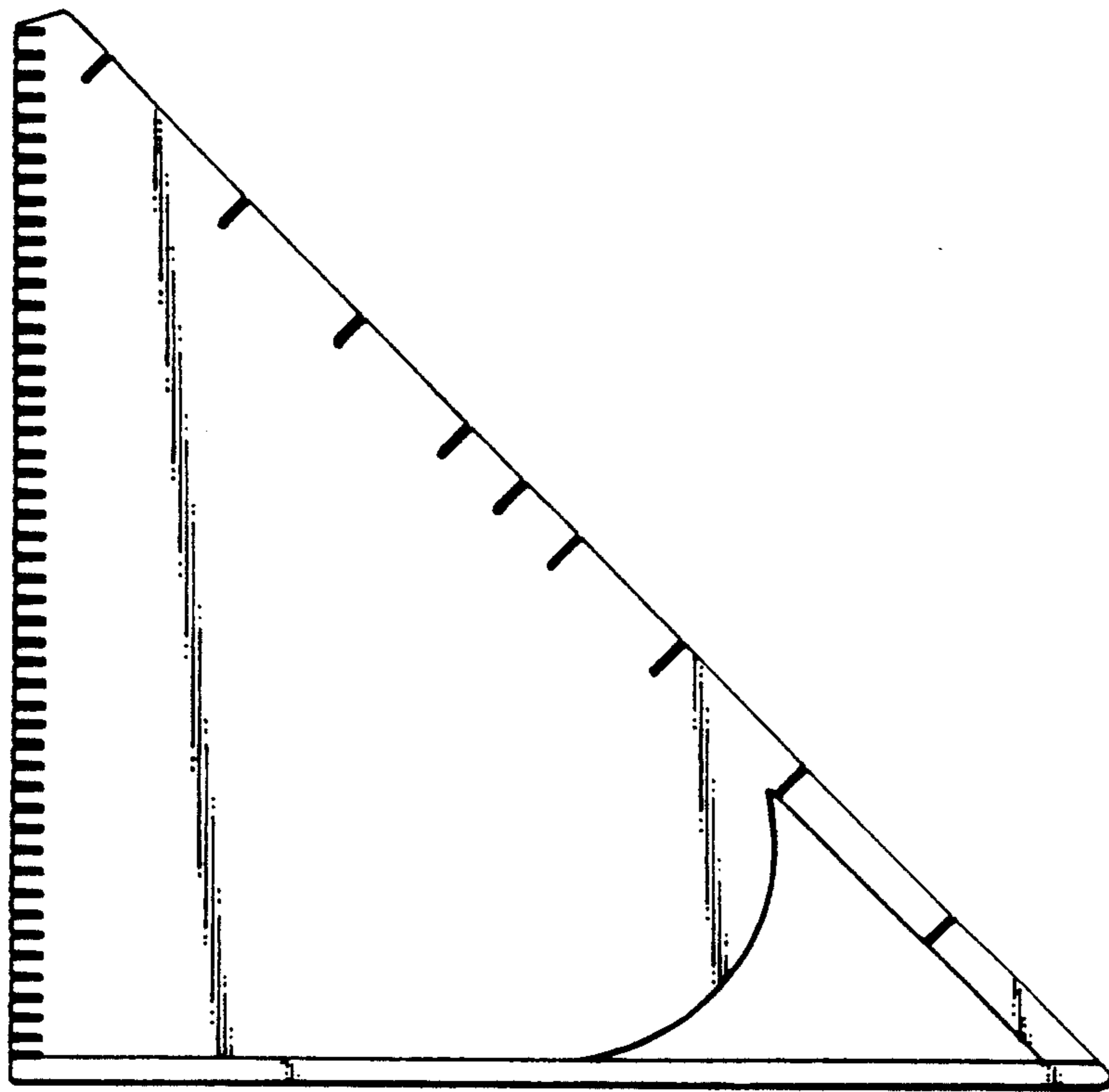

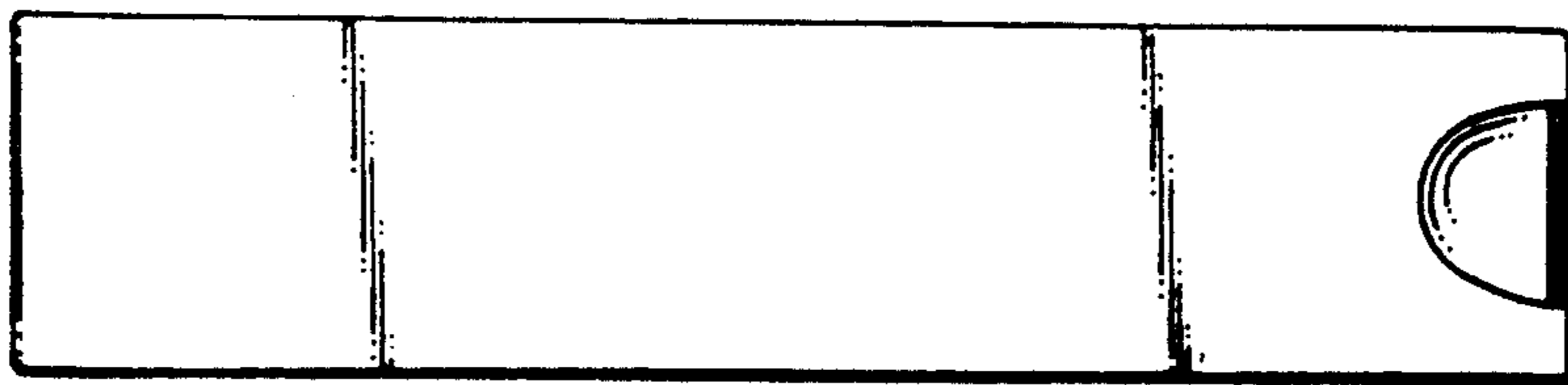

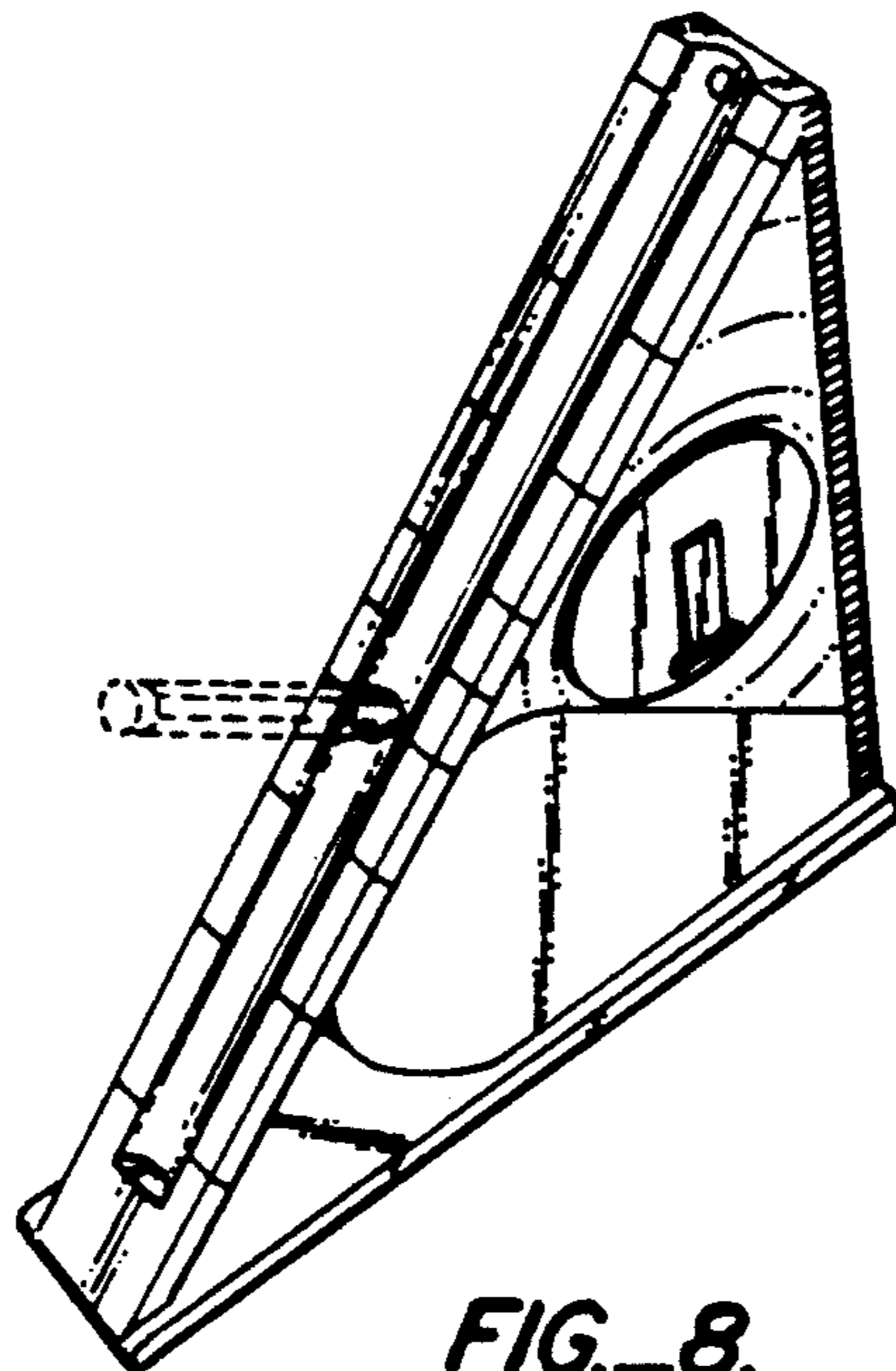

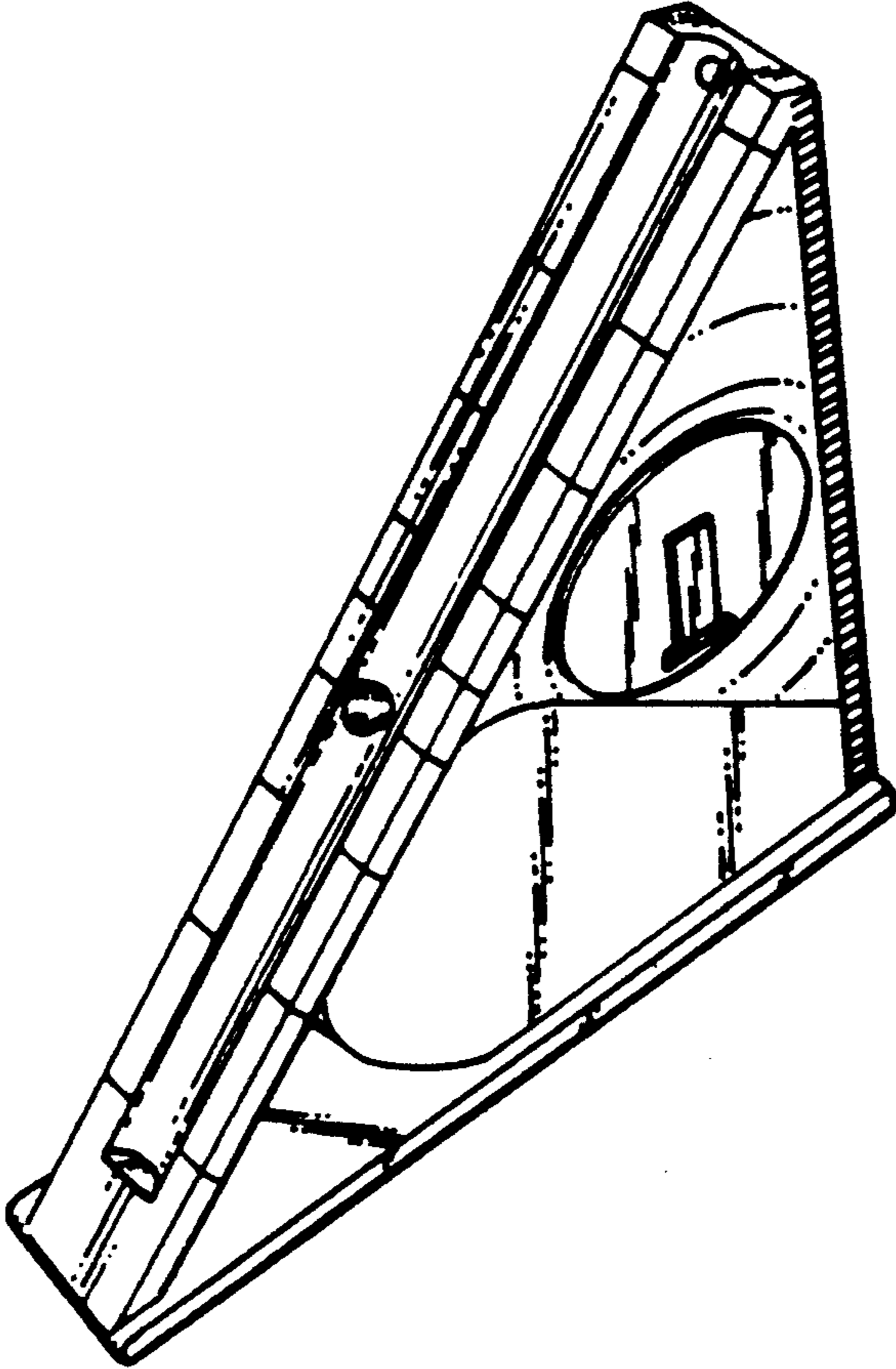
