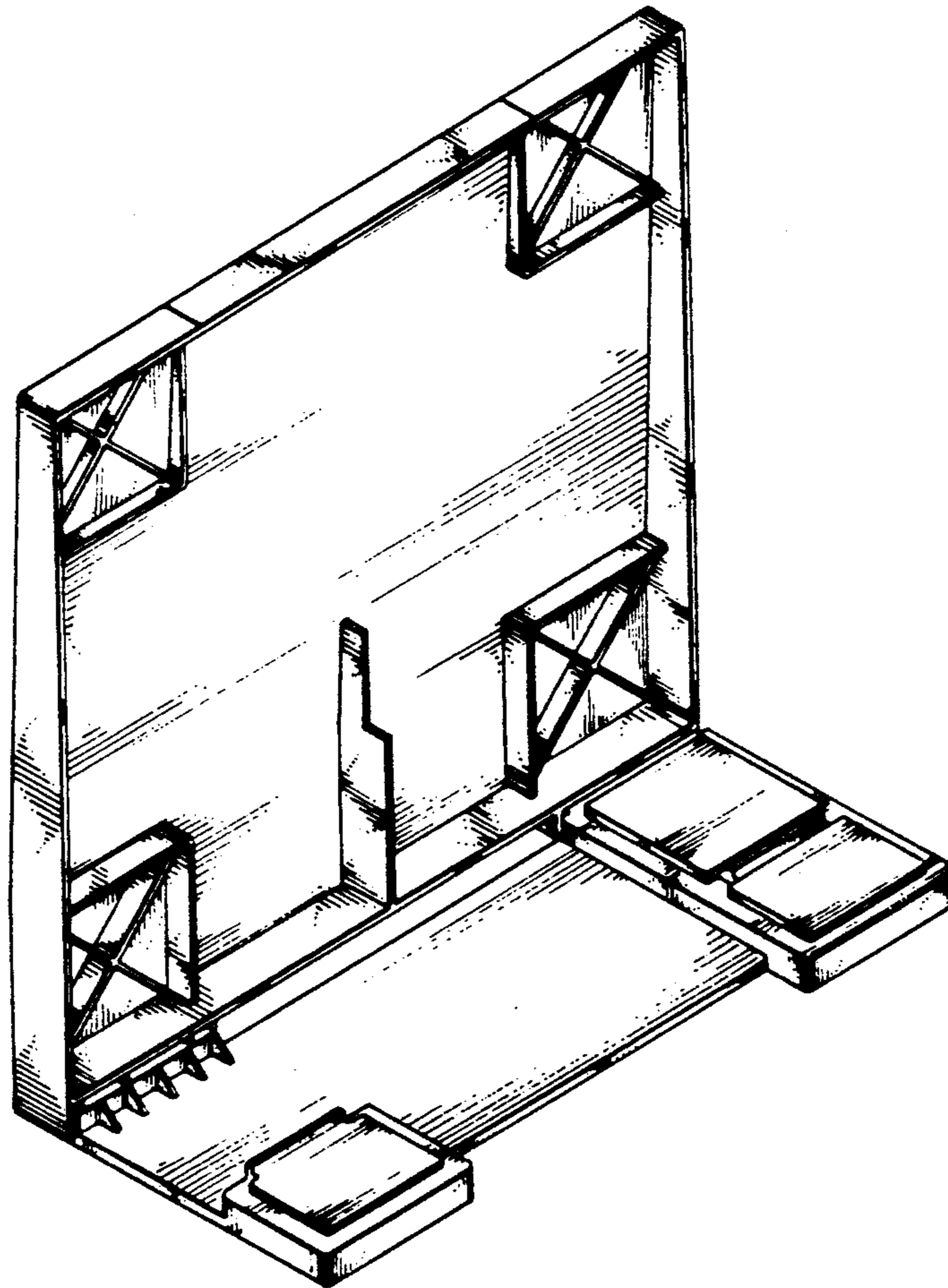
### [57] CLAIM

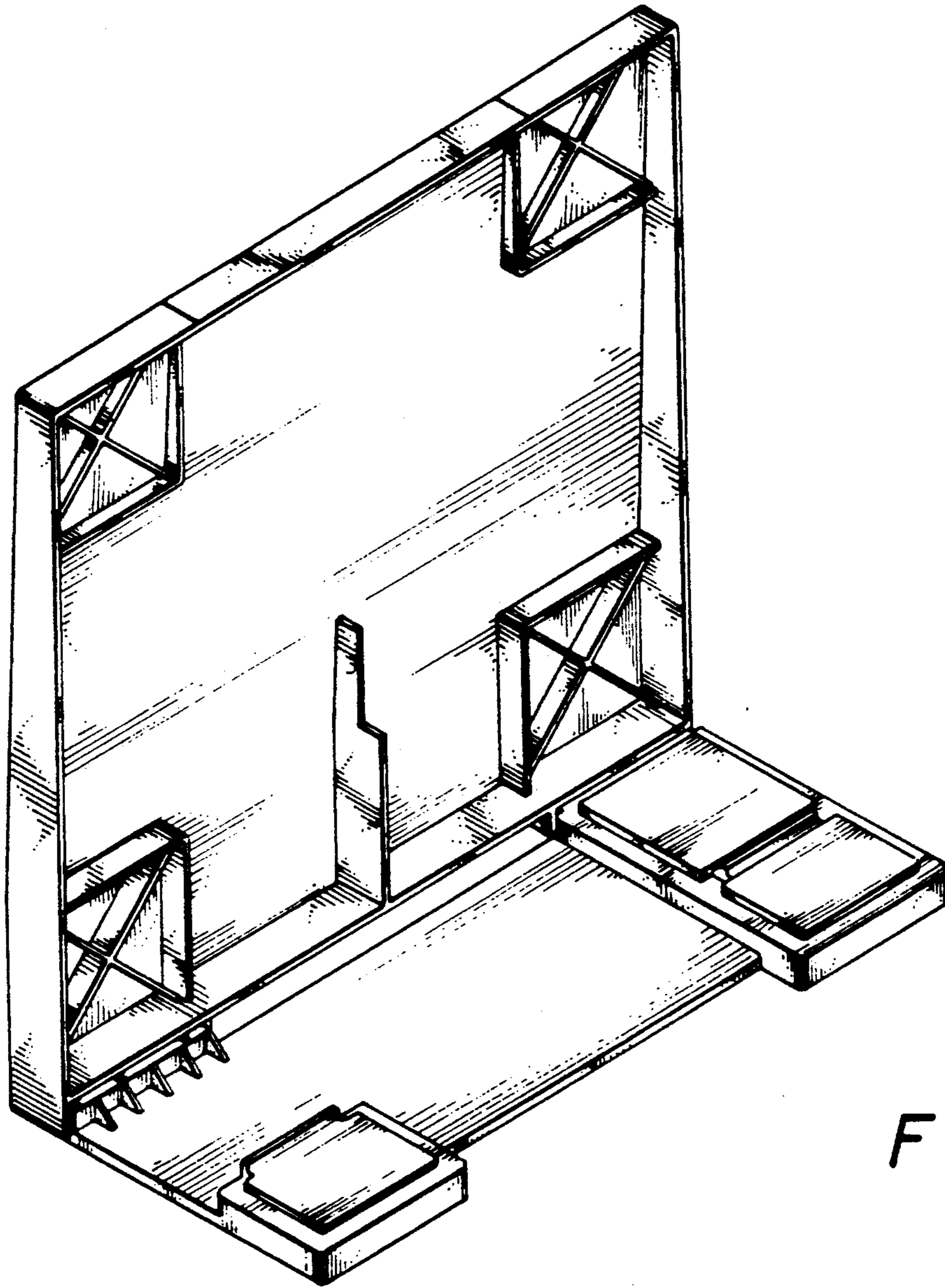
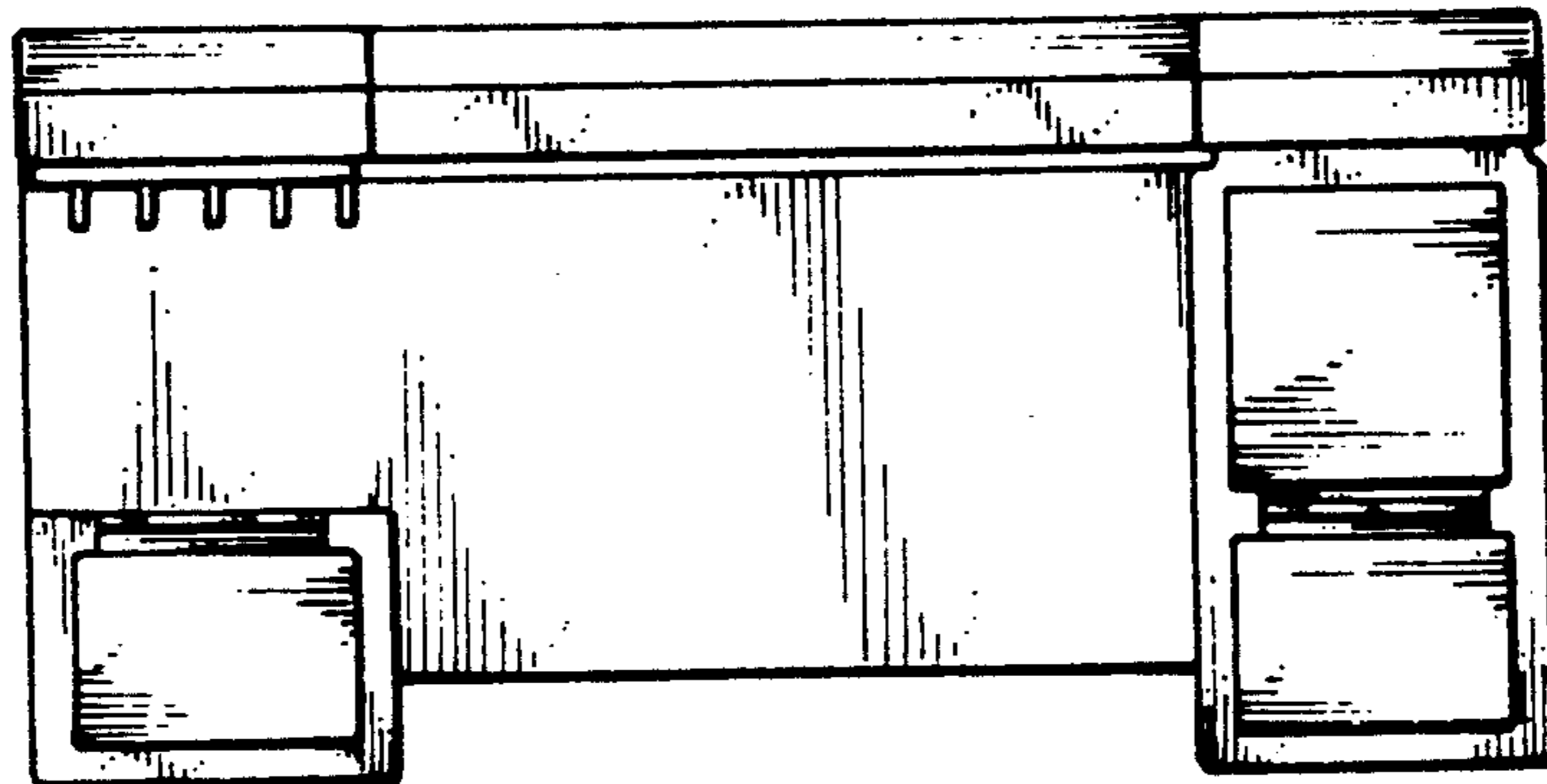

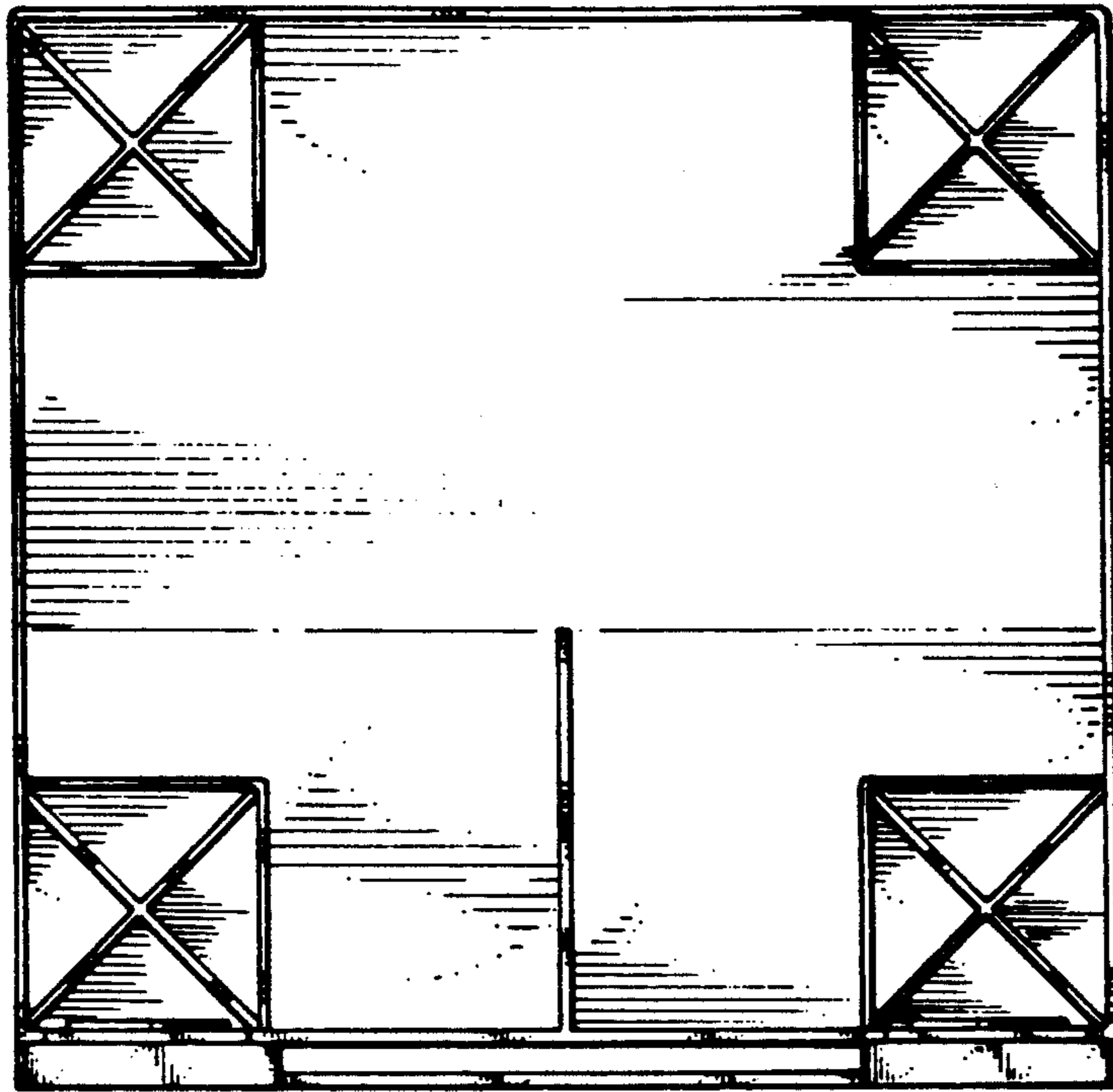

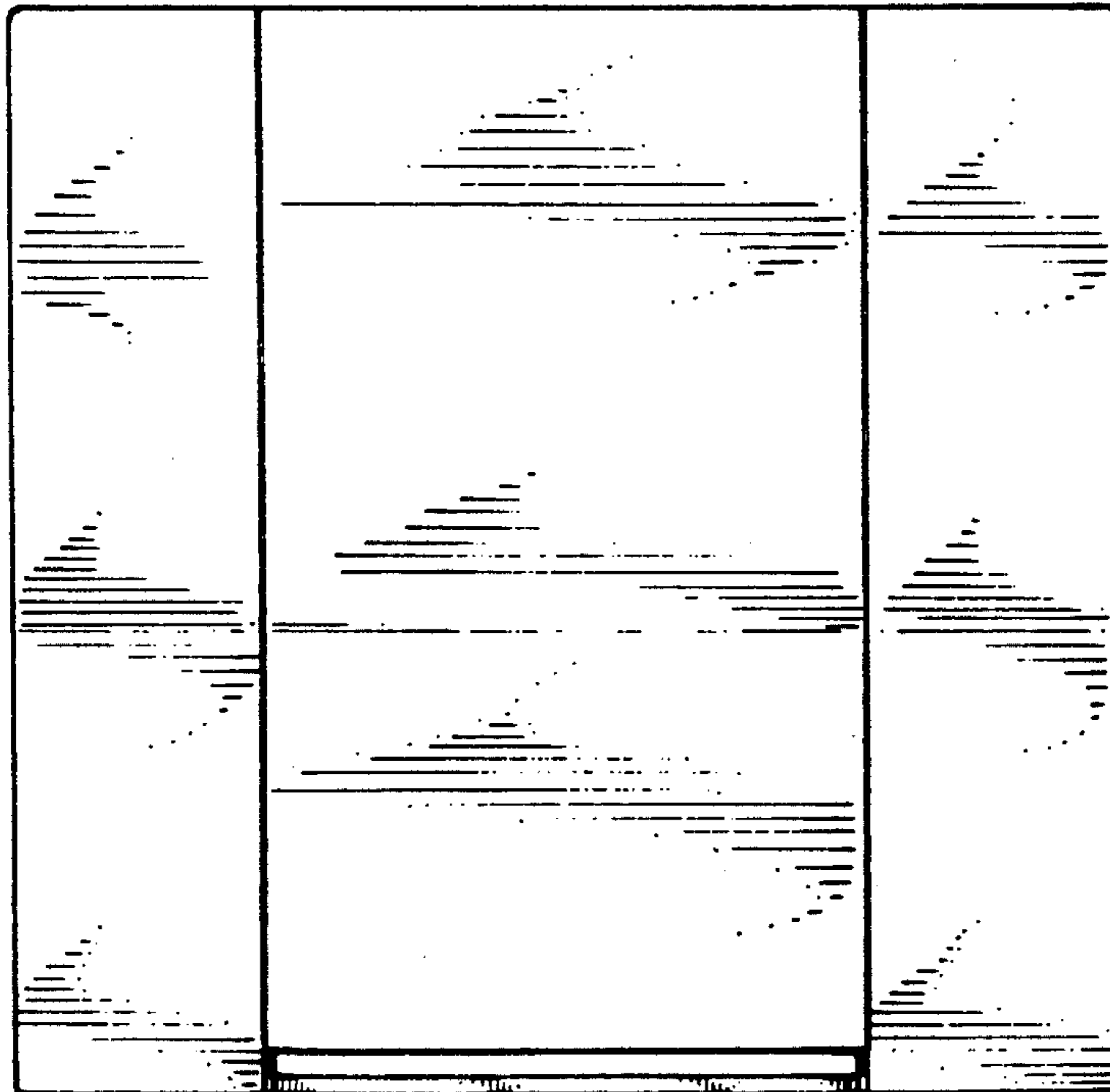
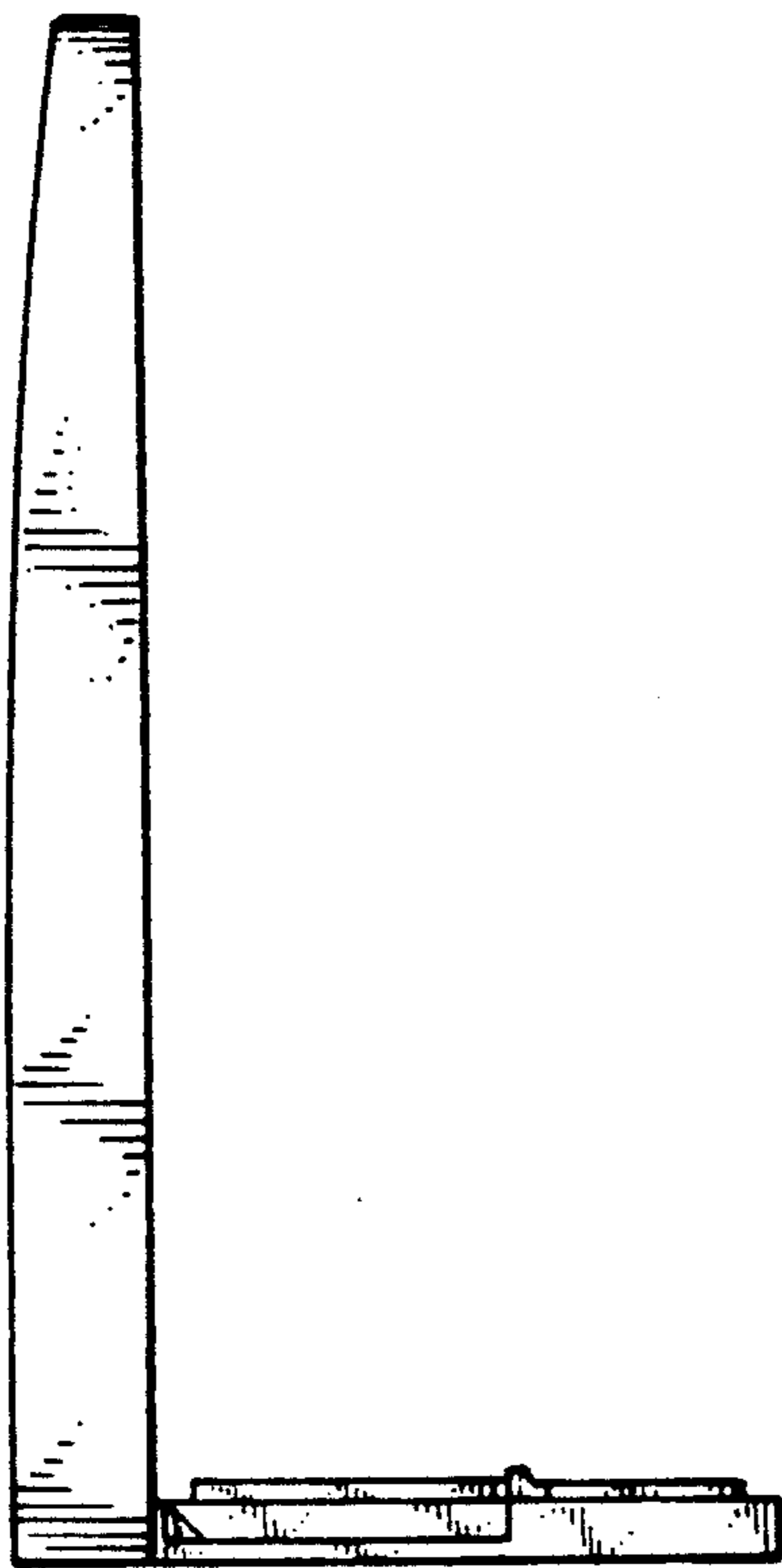
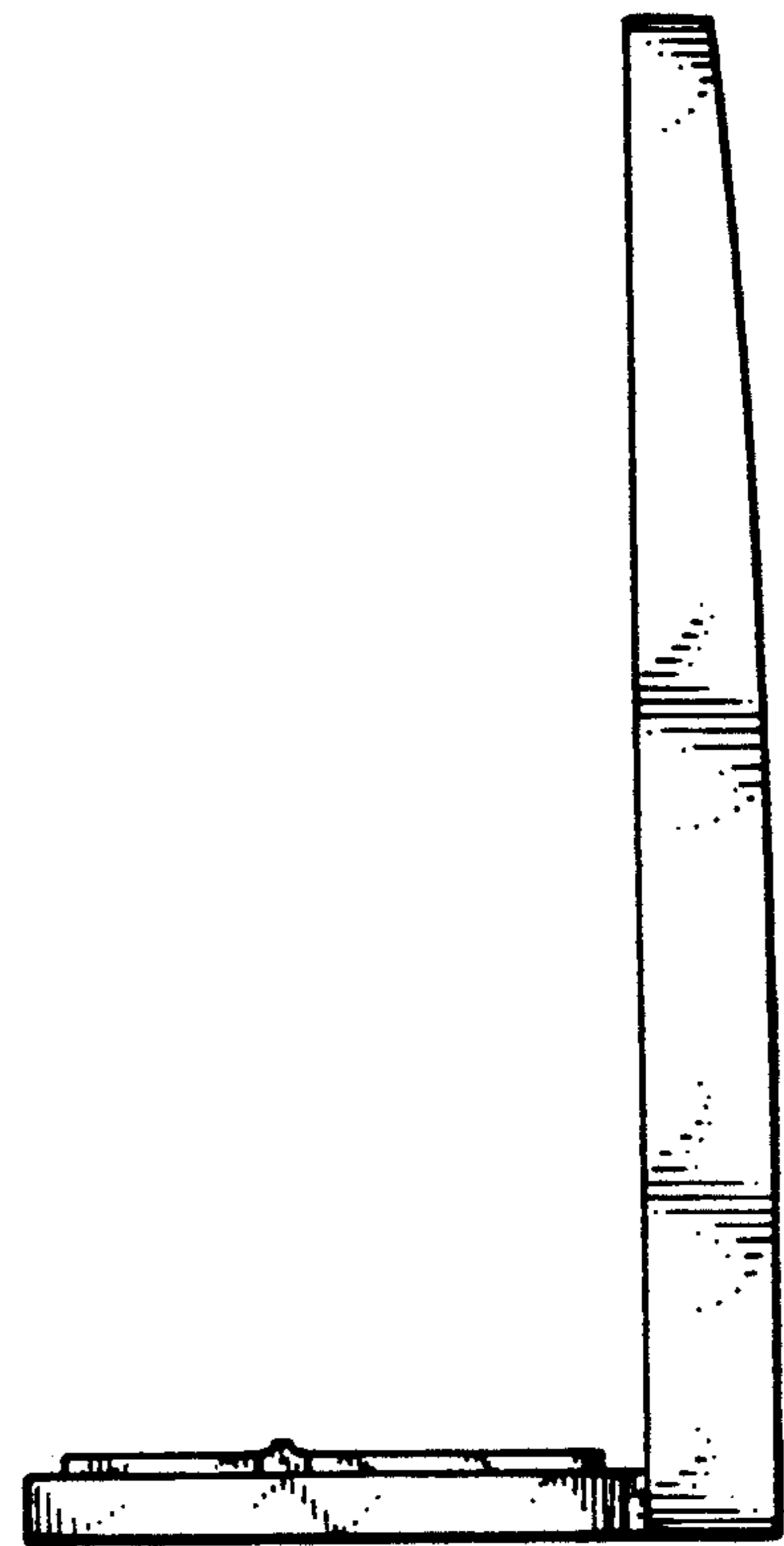


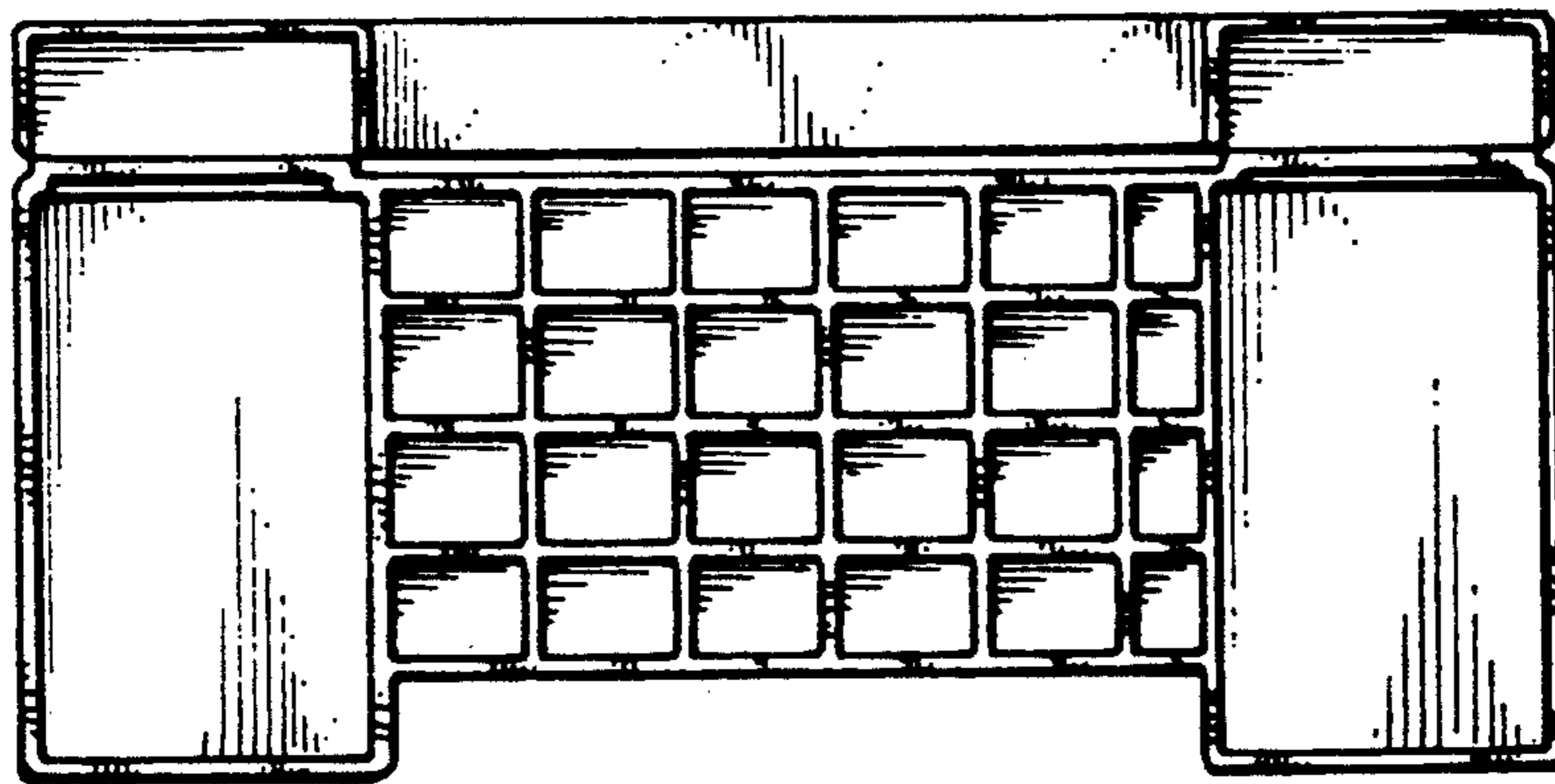
