FIG. 15 is a bottom plan view of FIG. 11;

FIG. 16 is a rear elevational view of a second embodiment of the design shown in FIG. 1;

FIG. 17 is a left side elevational view of FIG. 16, the right side being a mirror image;

FIG. 18 is a top plan view of a third embodiment of the design shown in FIG. 1;

FIG. 19 is a perspective view of FIG. 7;

FIG. 20 is a bottom perspective view of FIG. 11; and,

FIG. 21 is a top perspective view of FIG. 11.

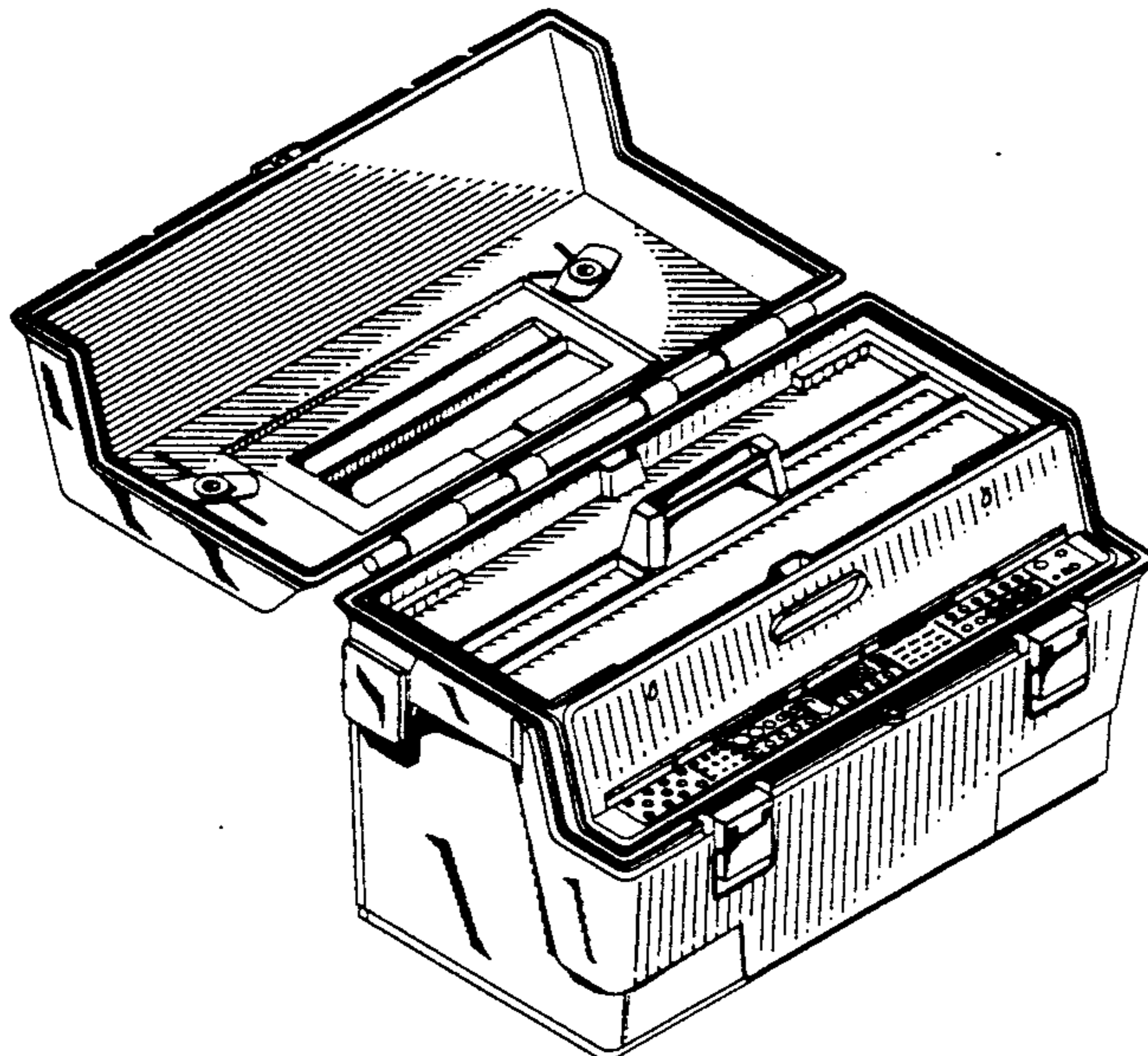

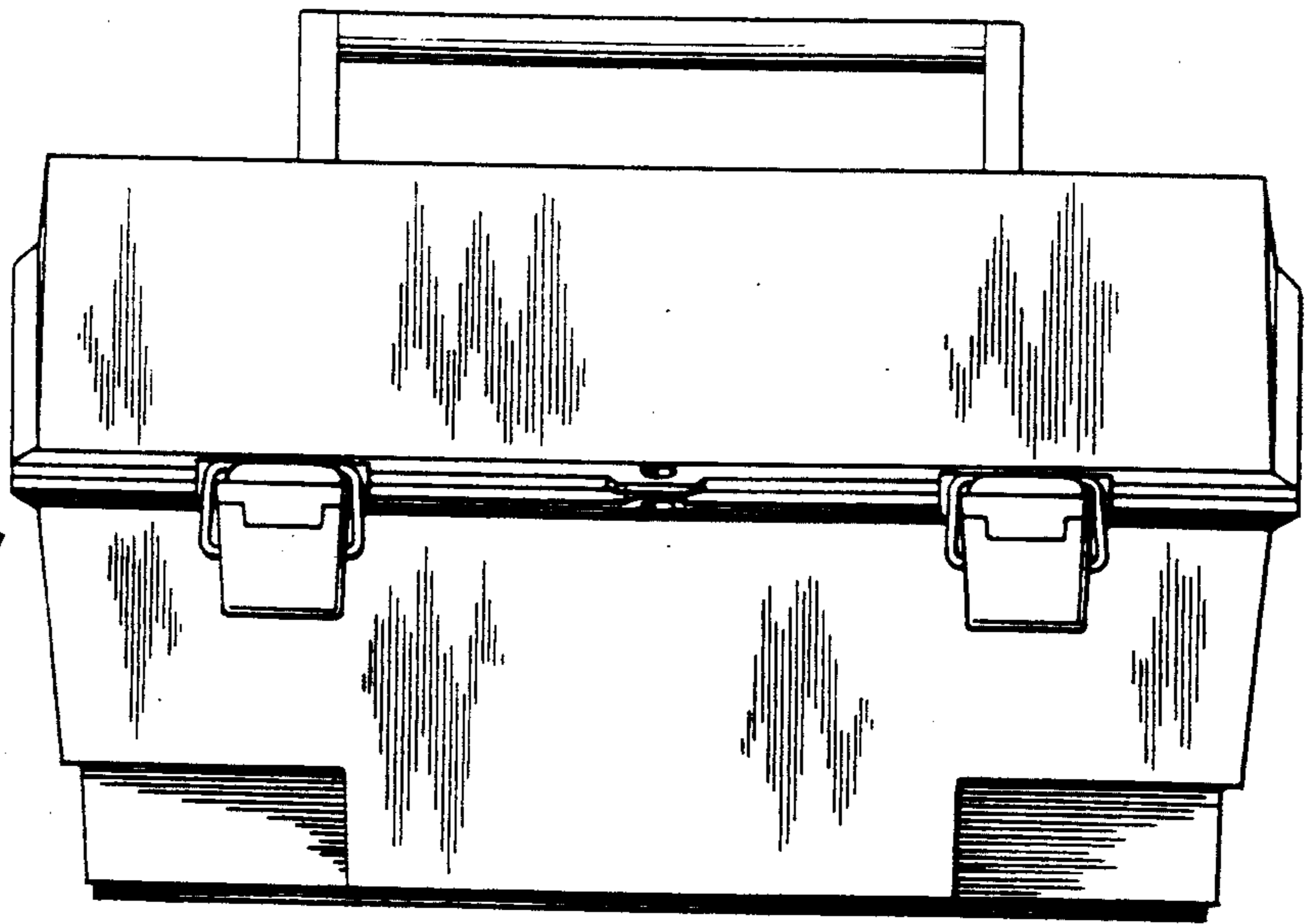

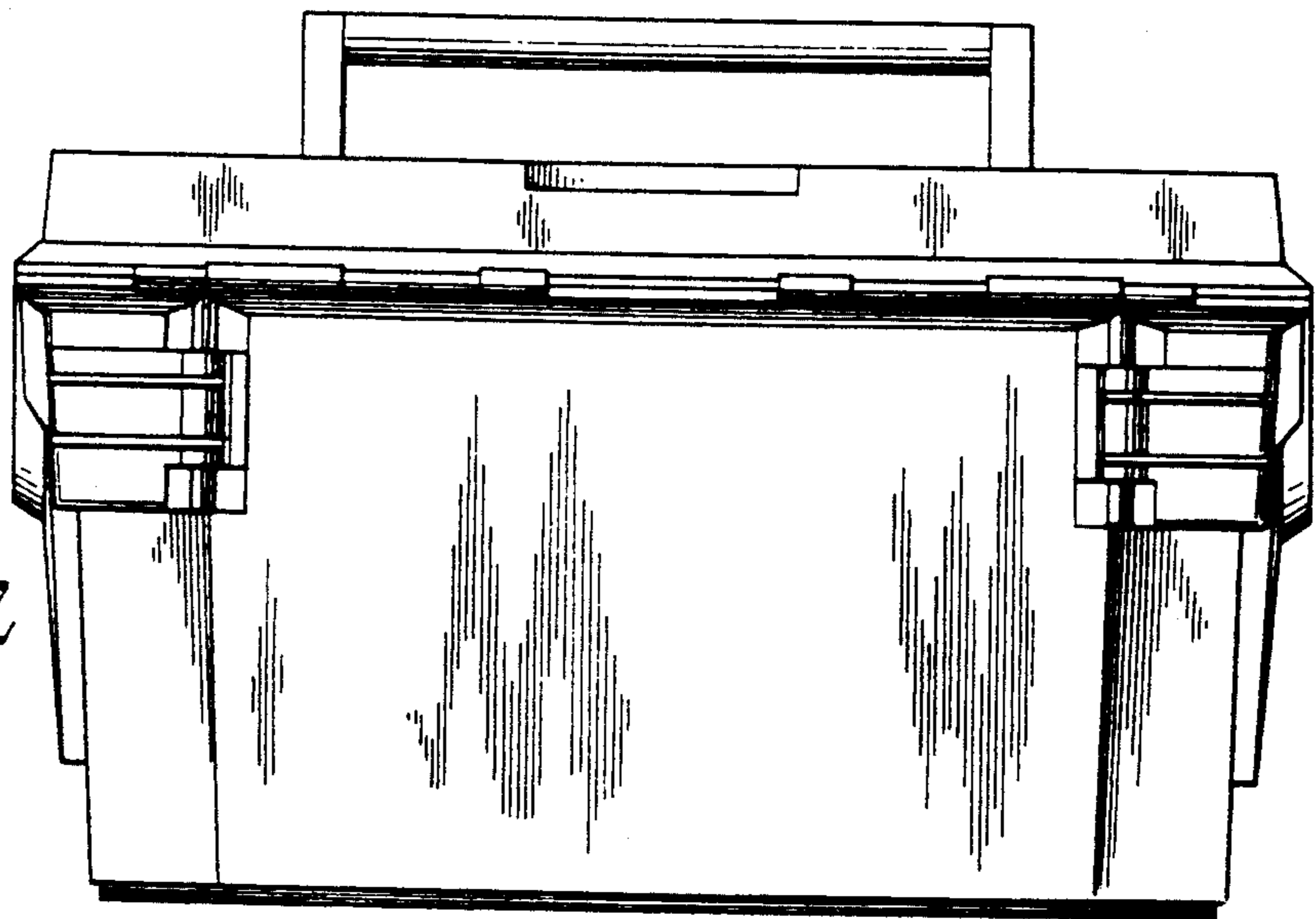

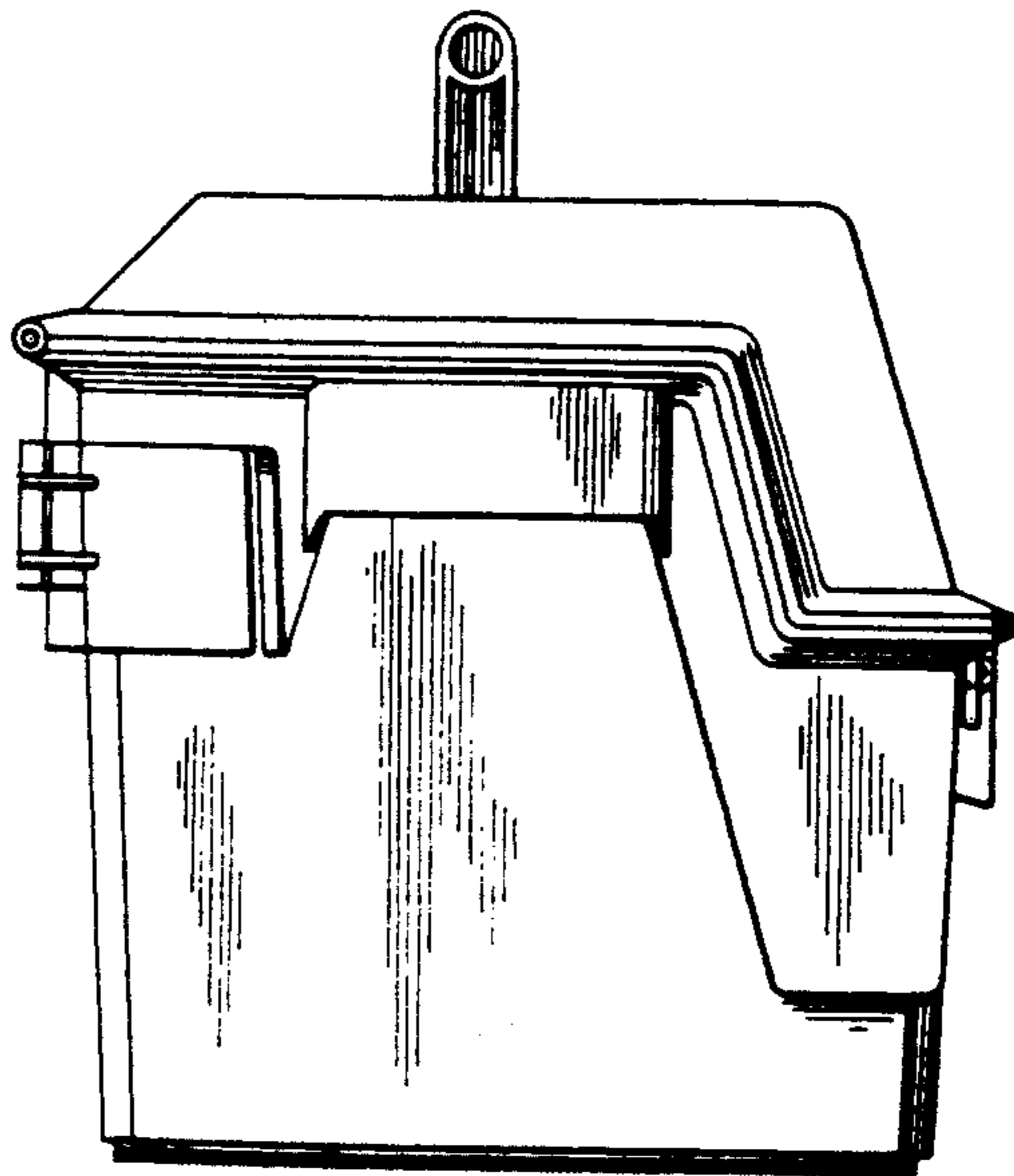

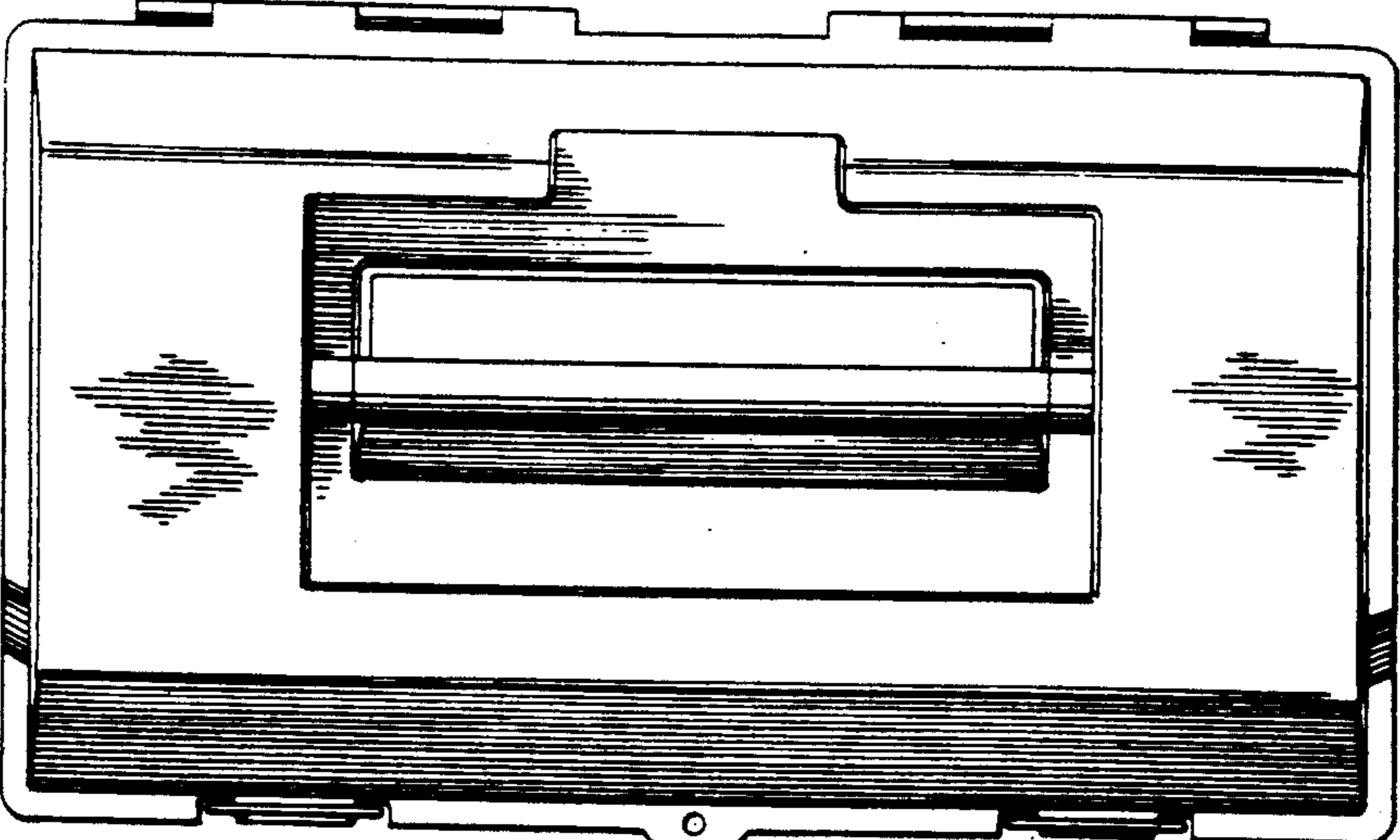

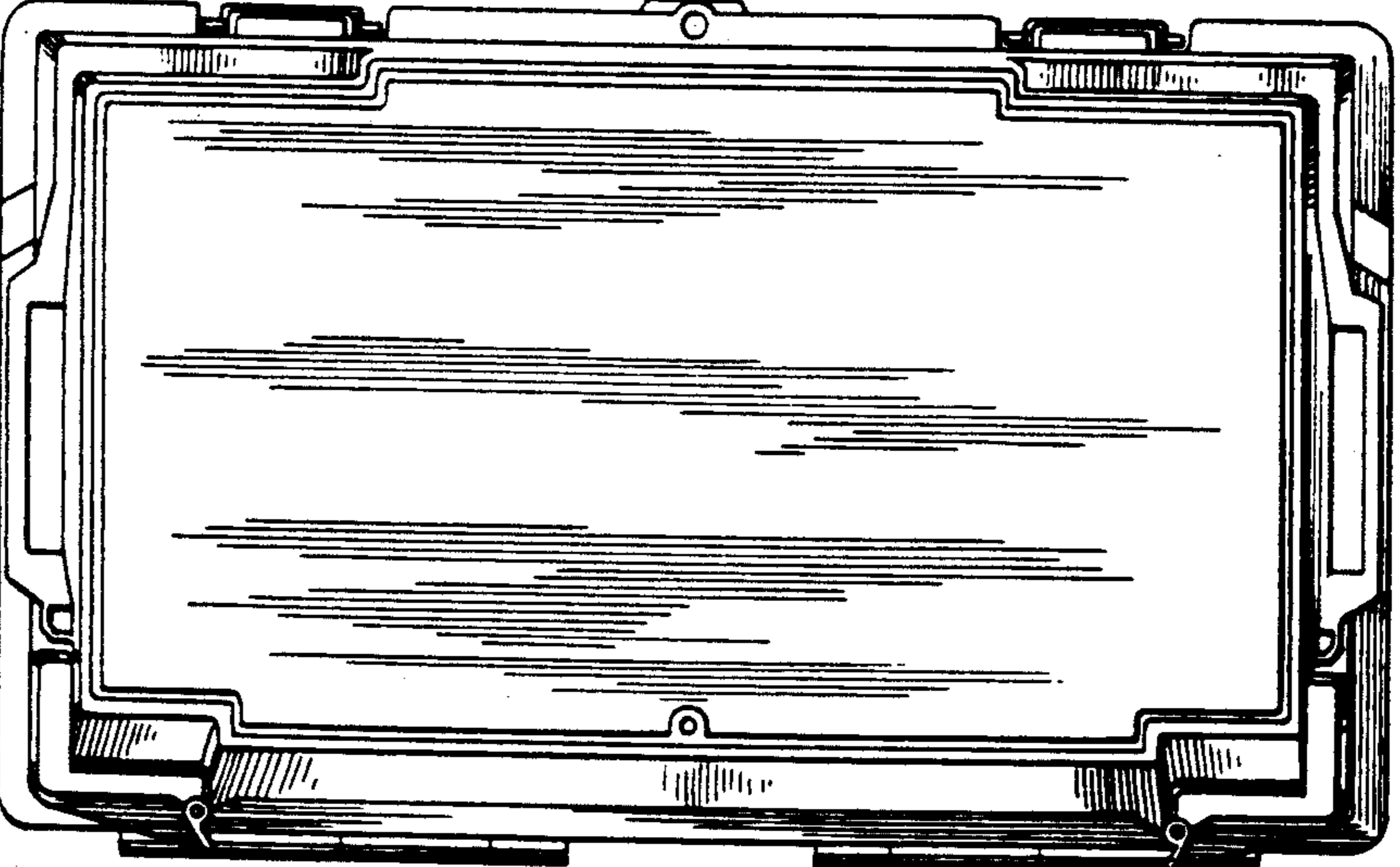

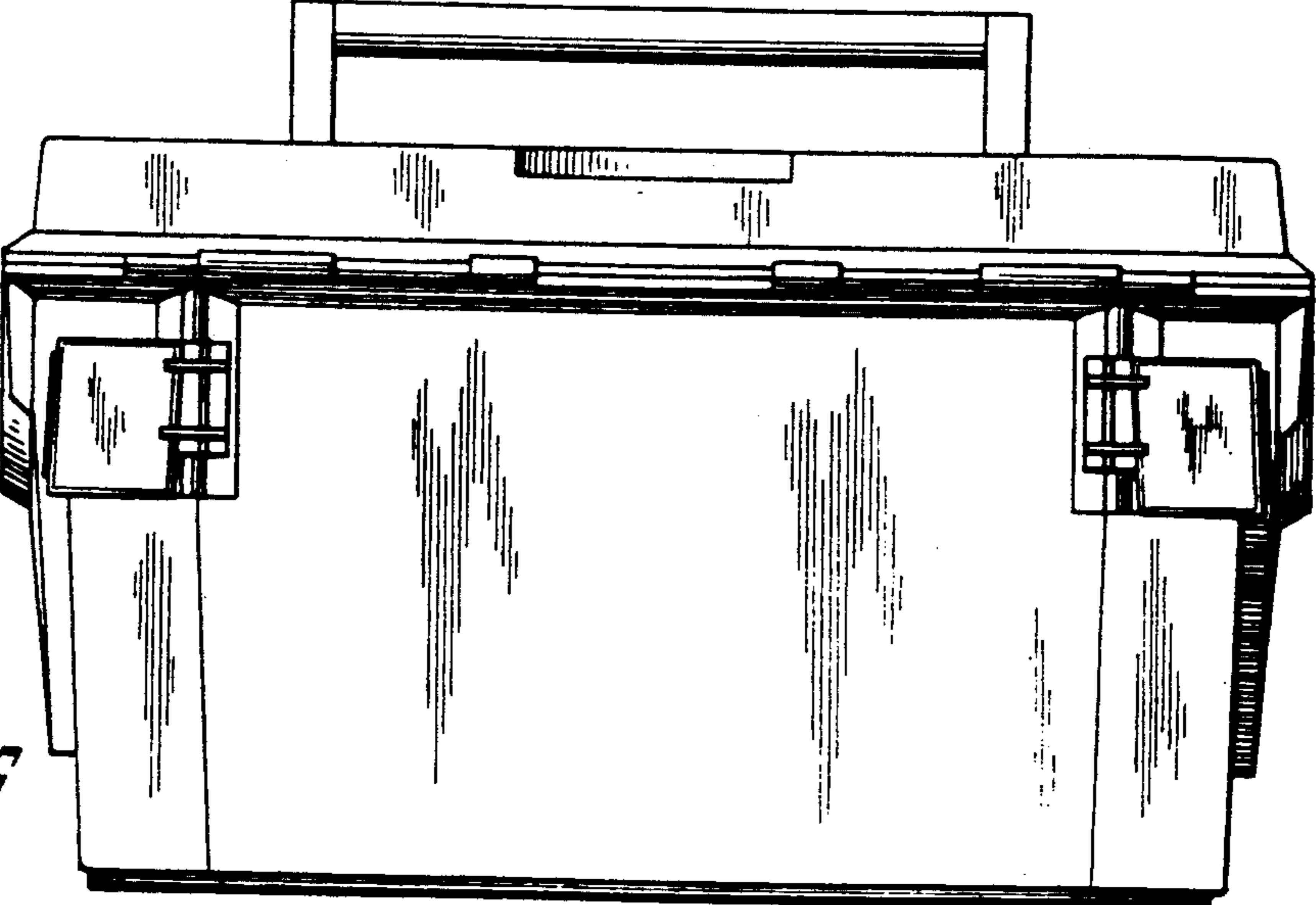

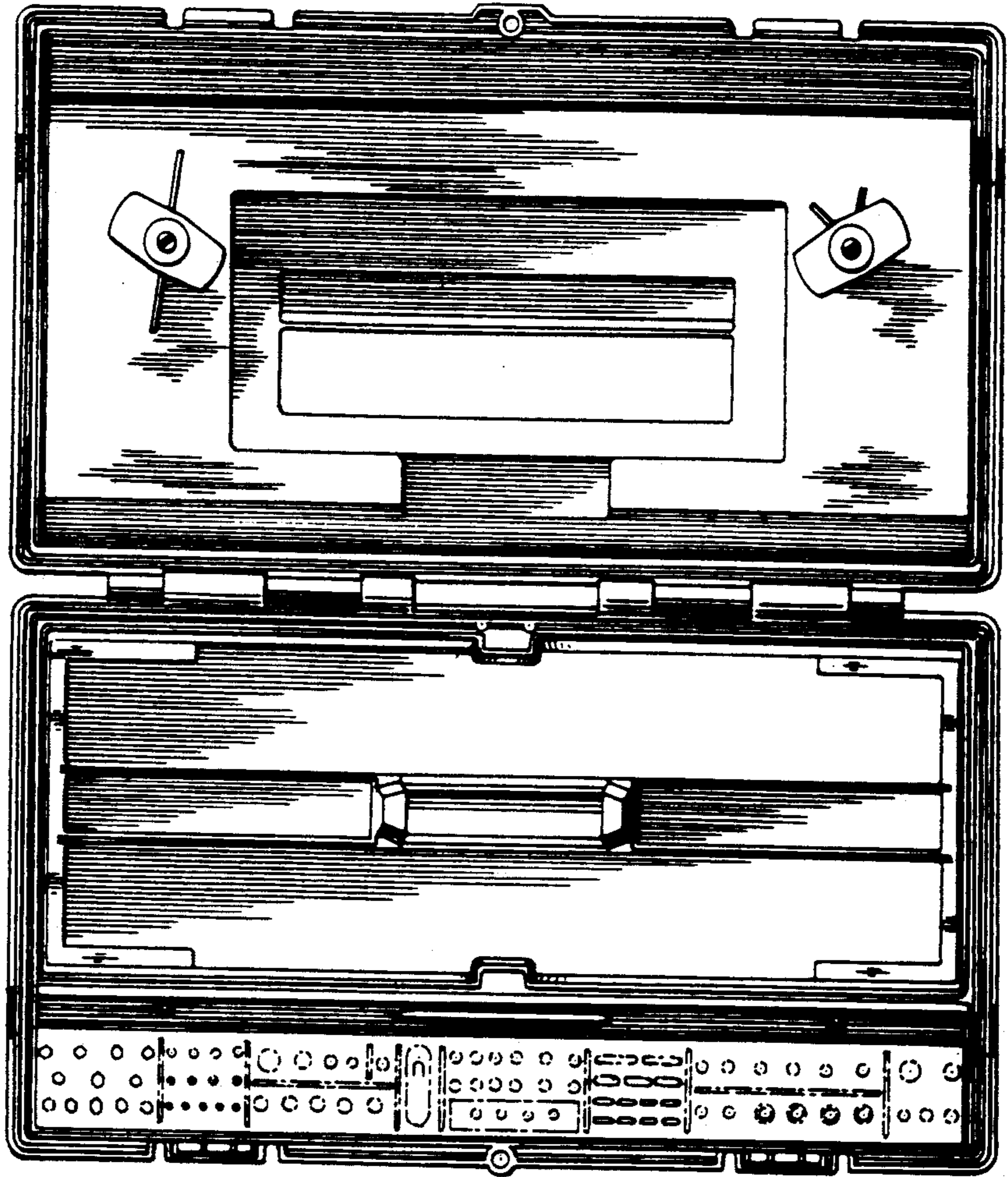
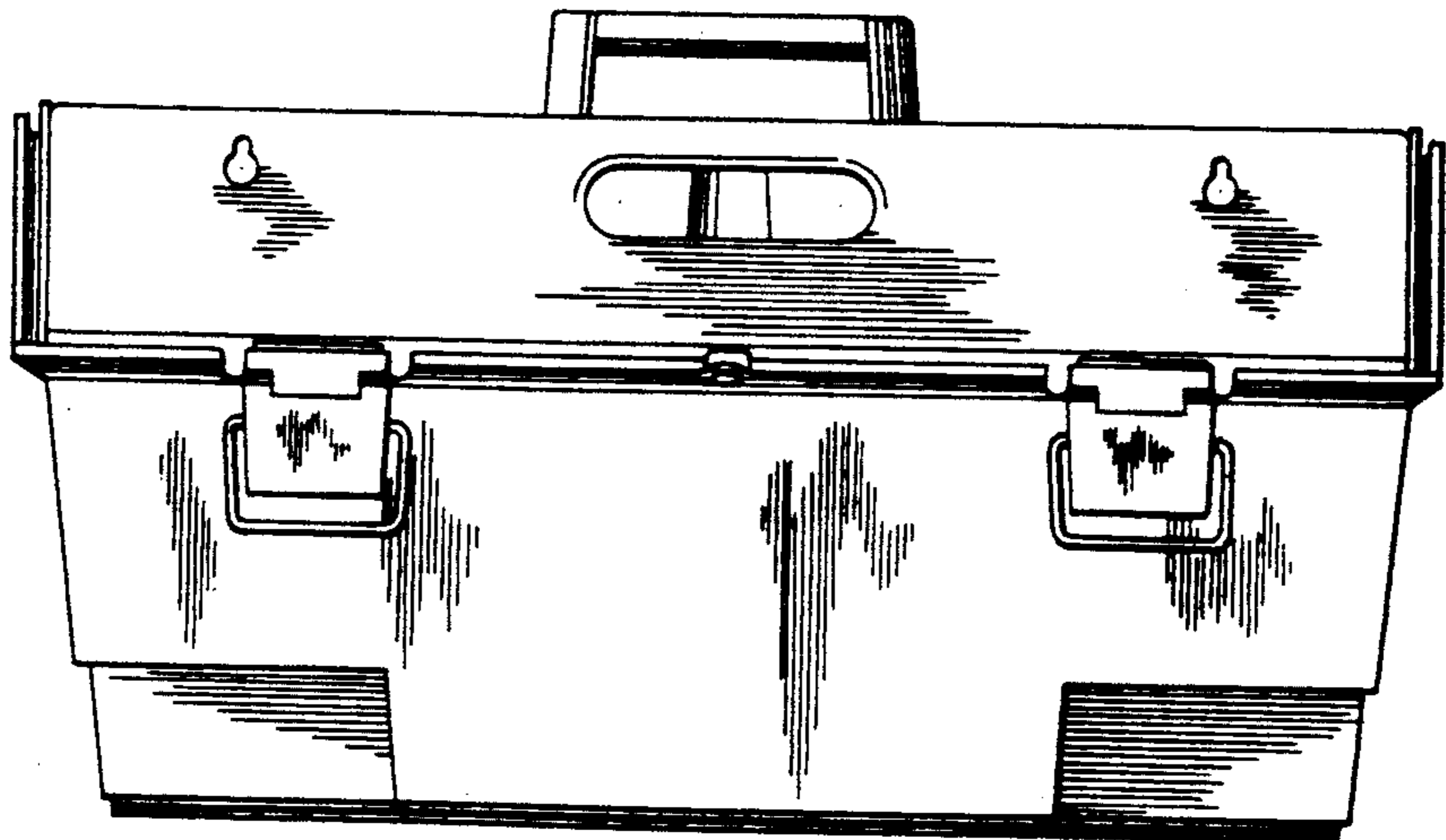

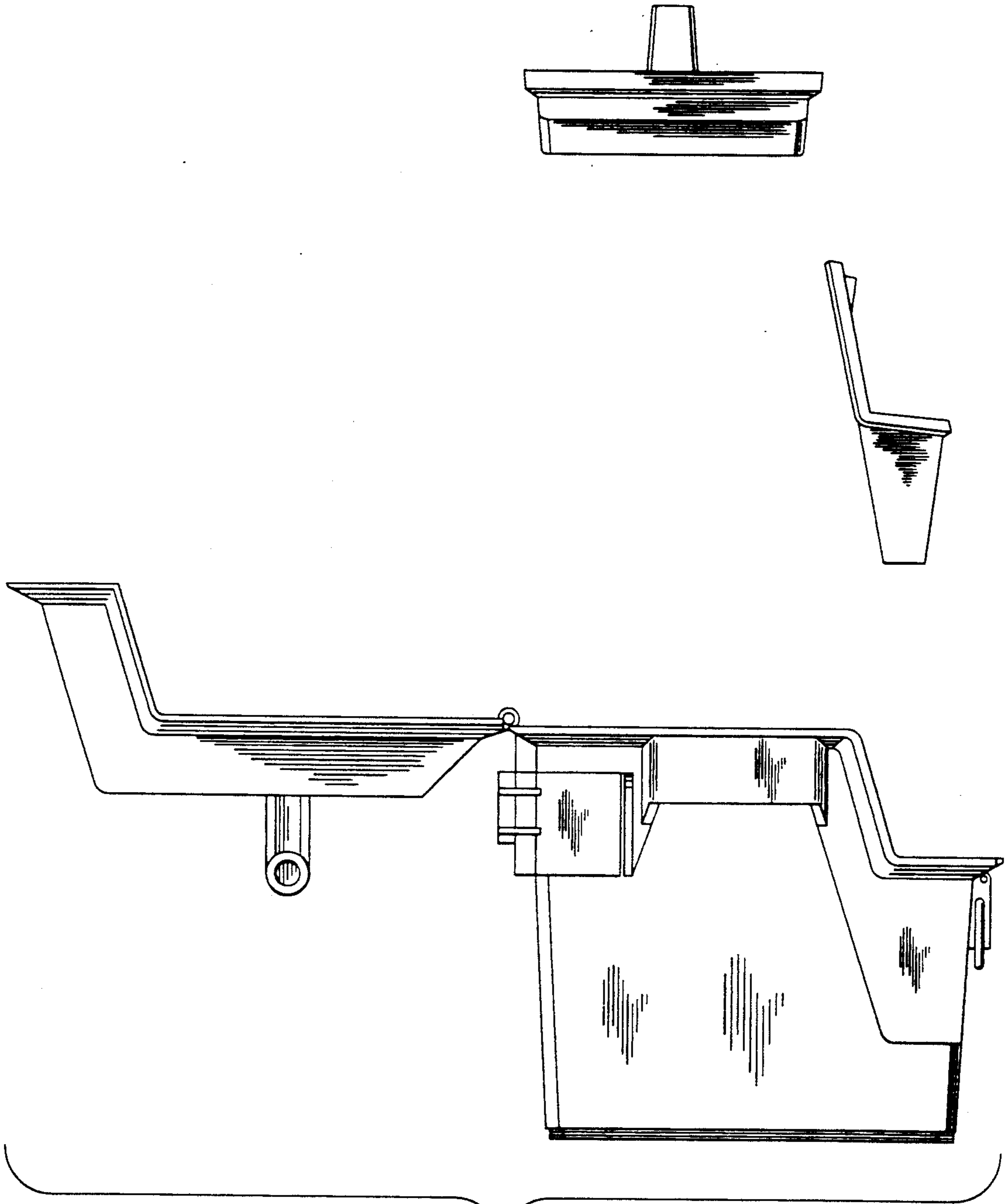

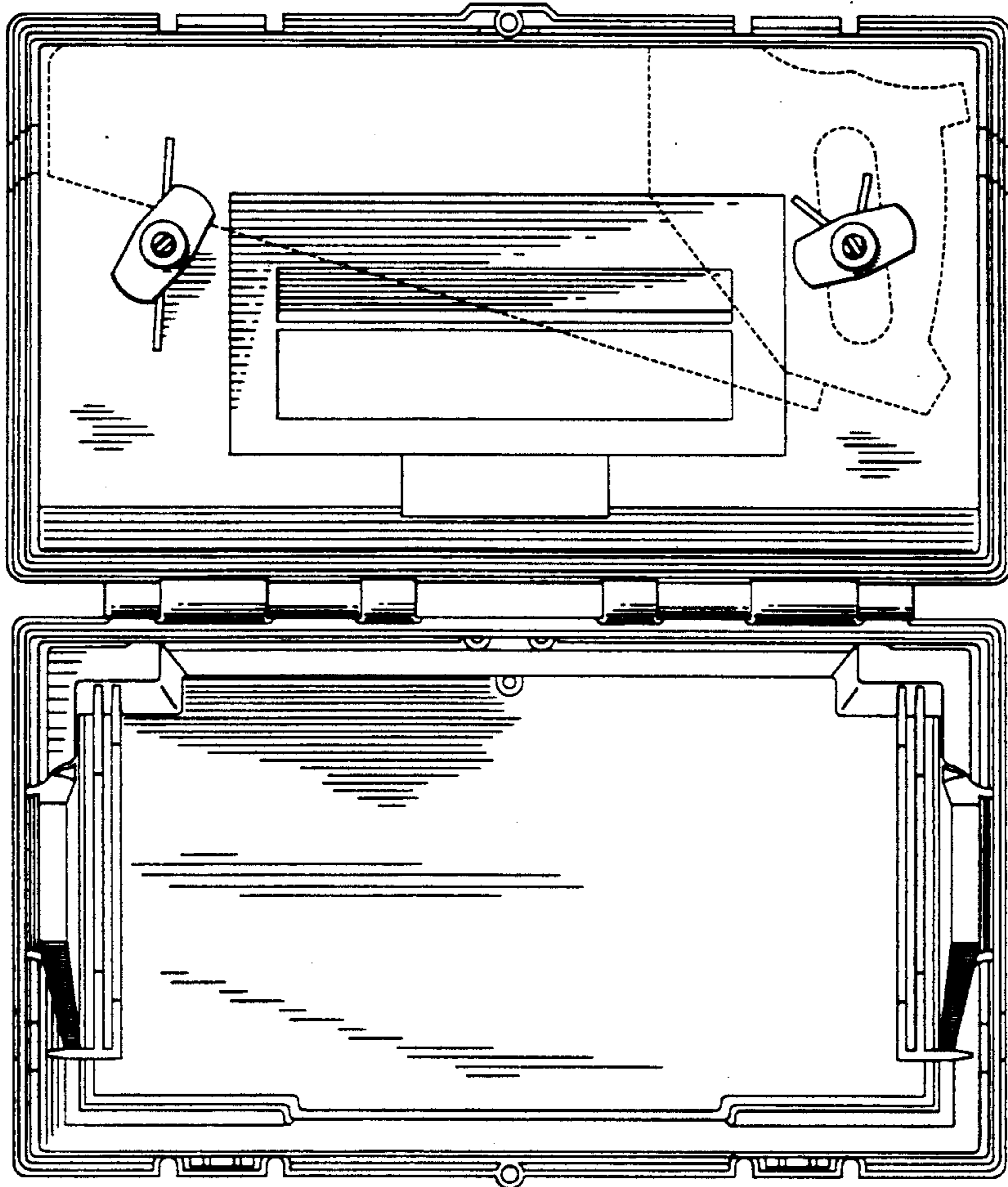
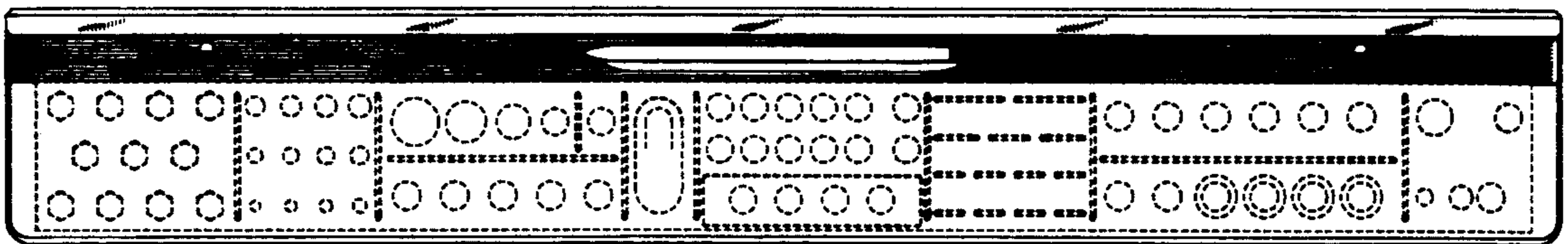

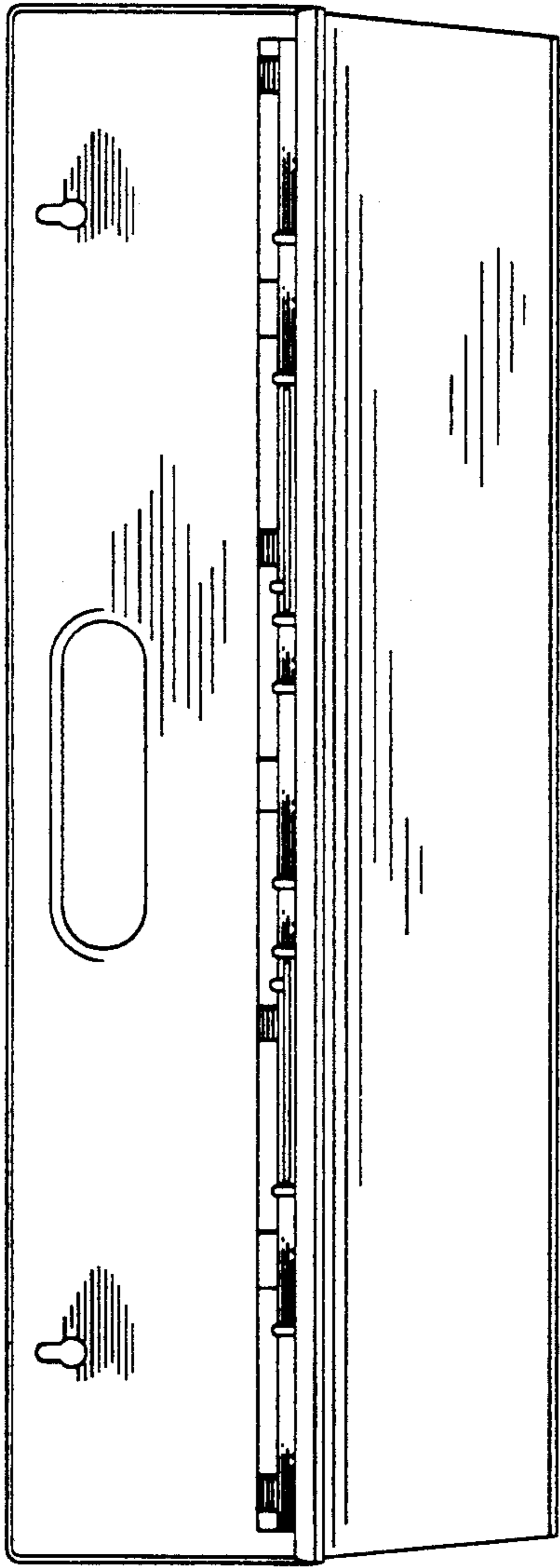

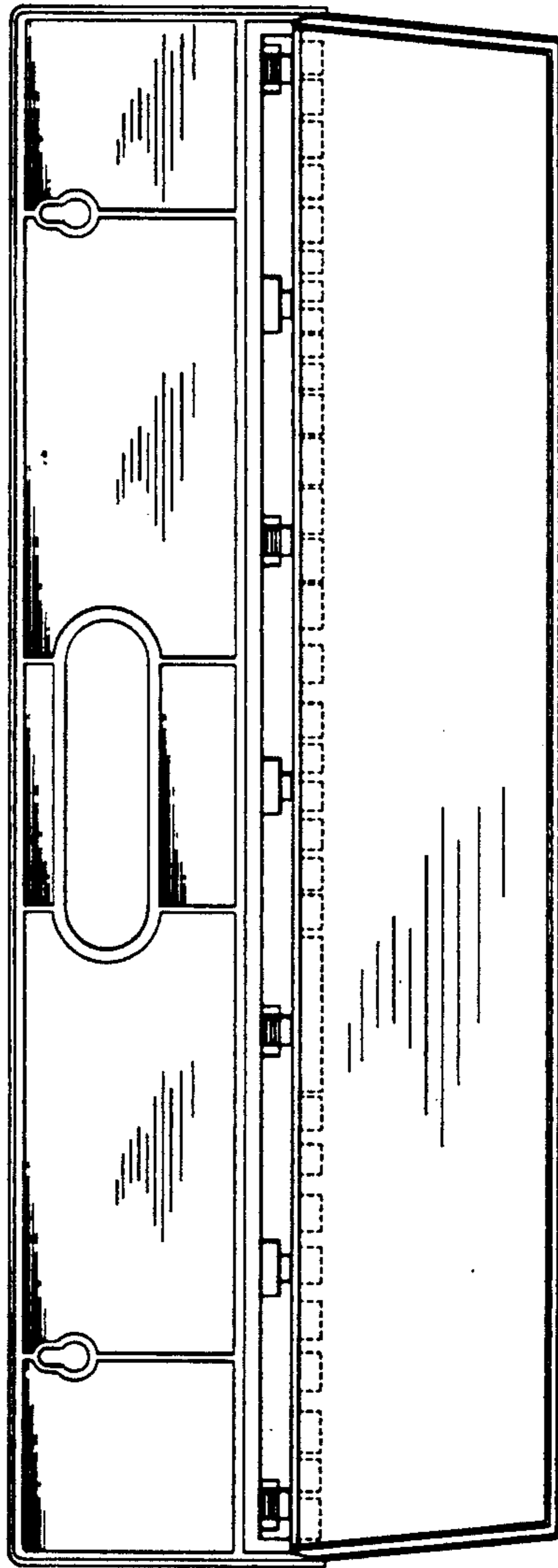

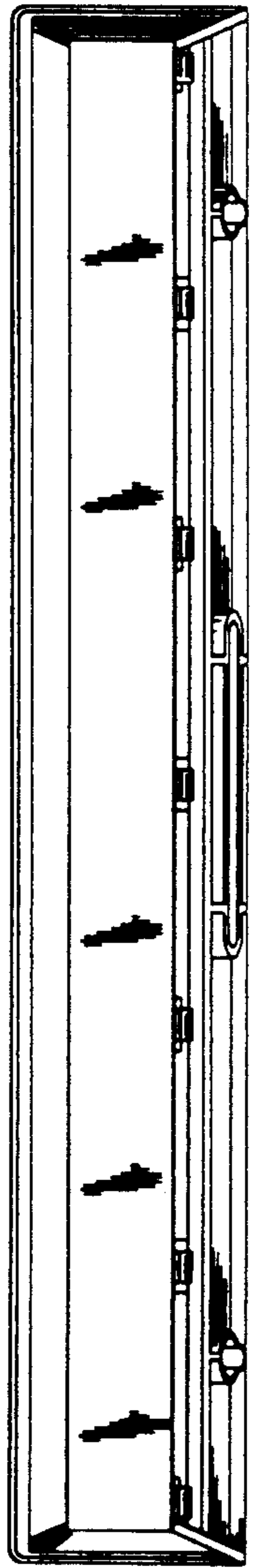

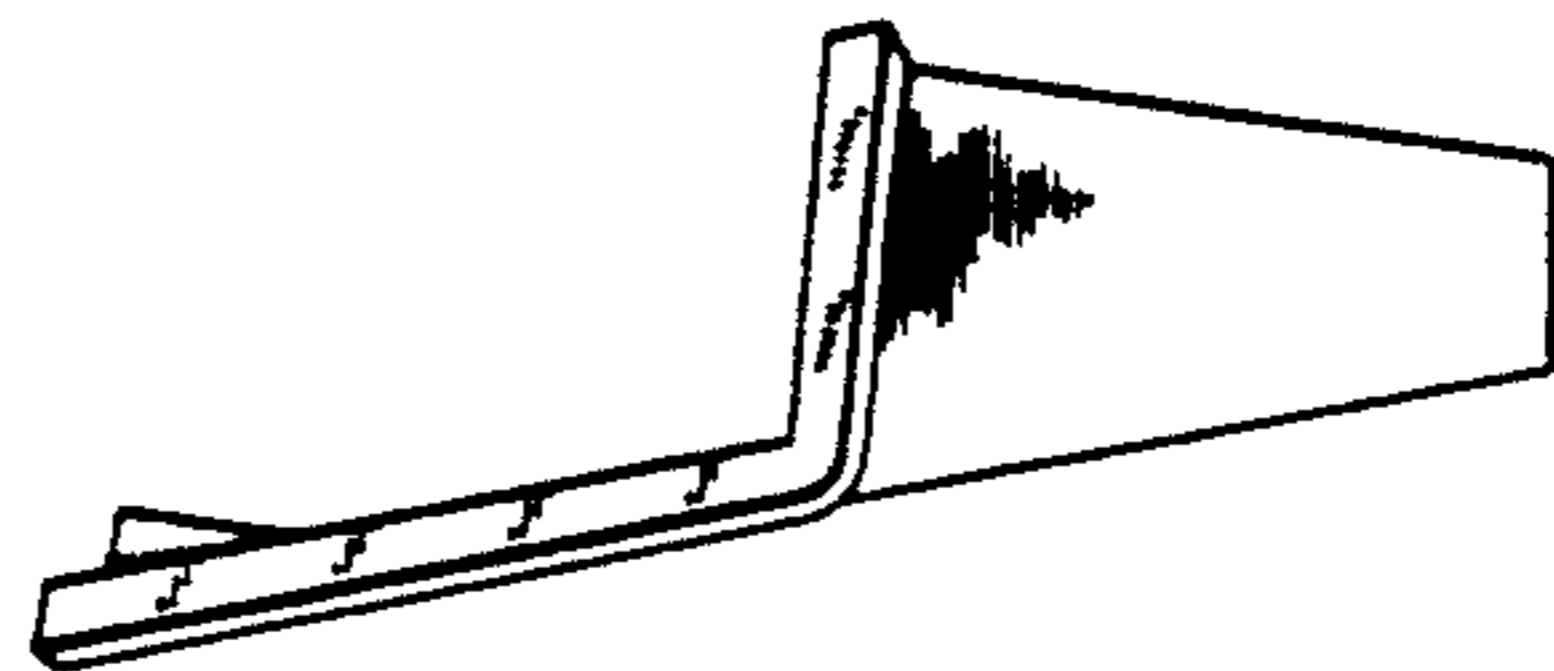

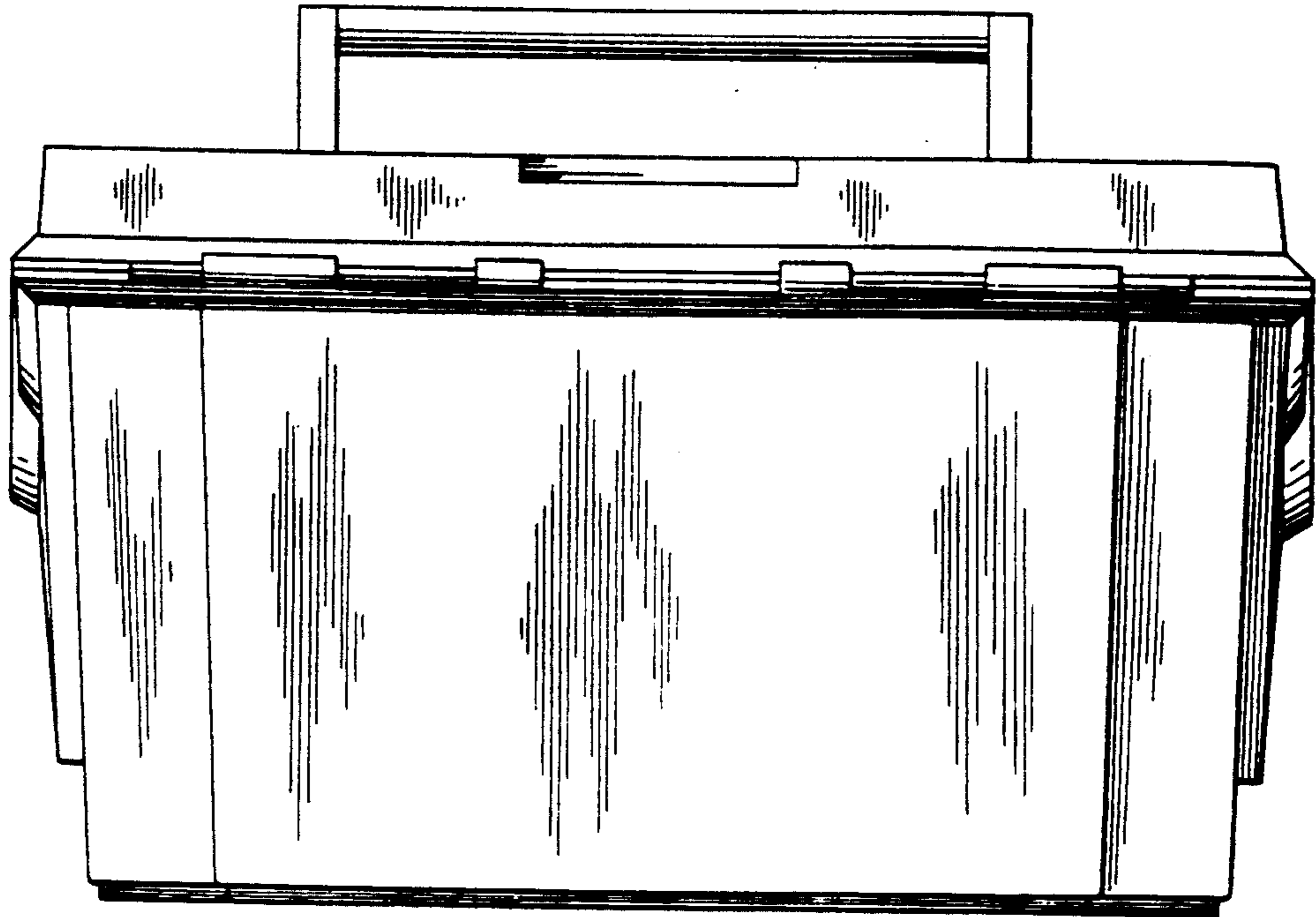
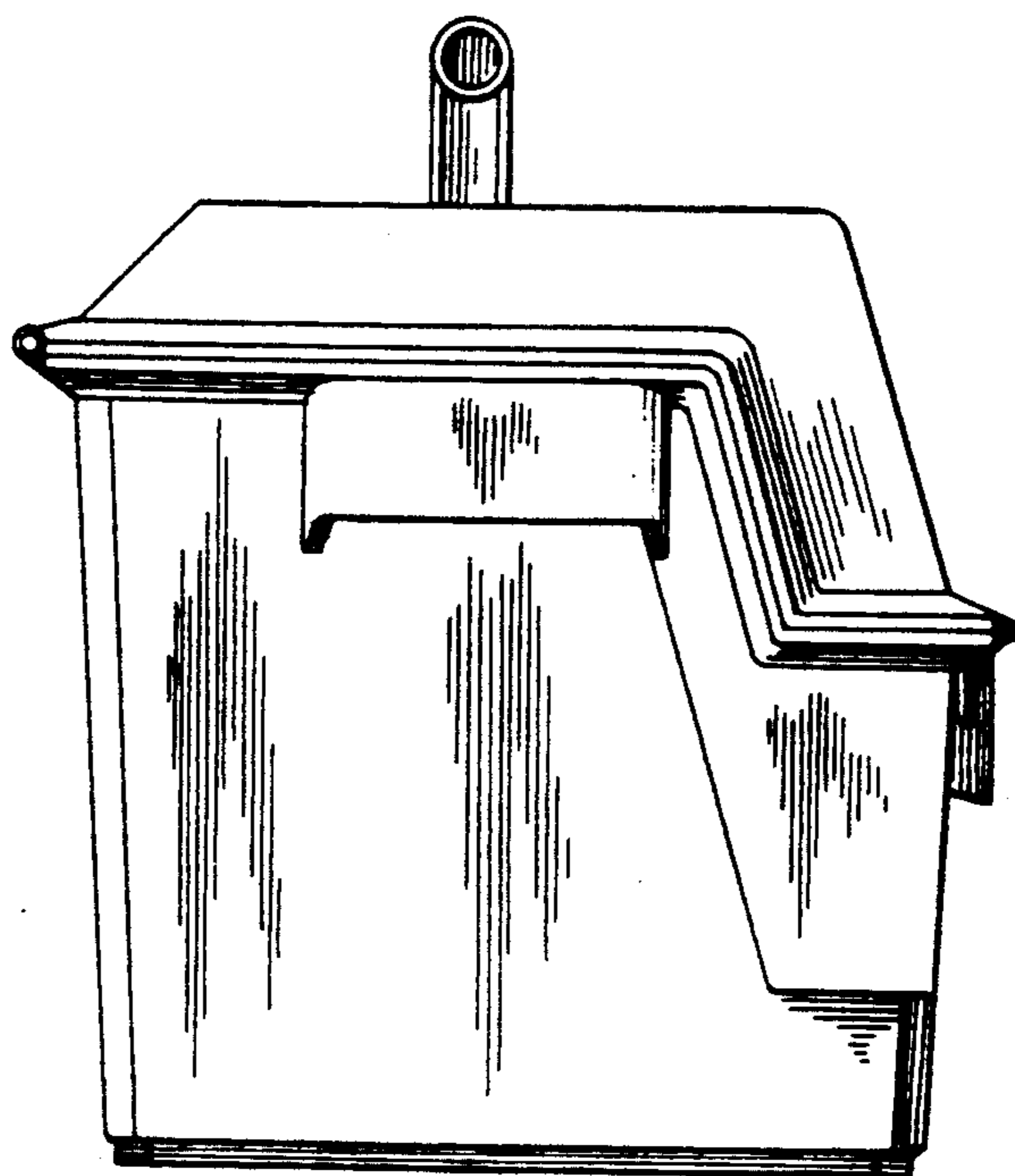

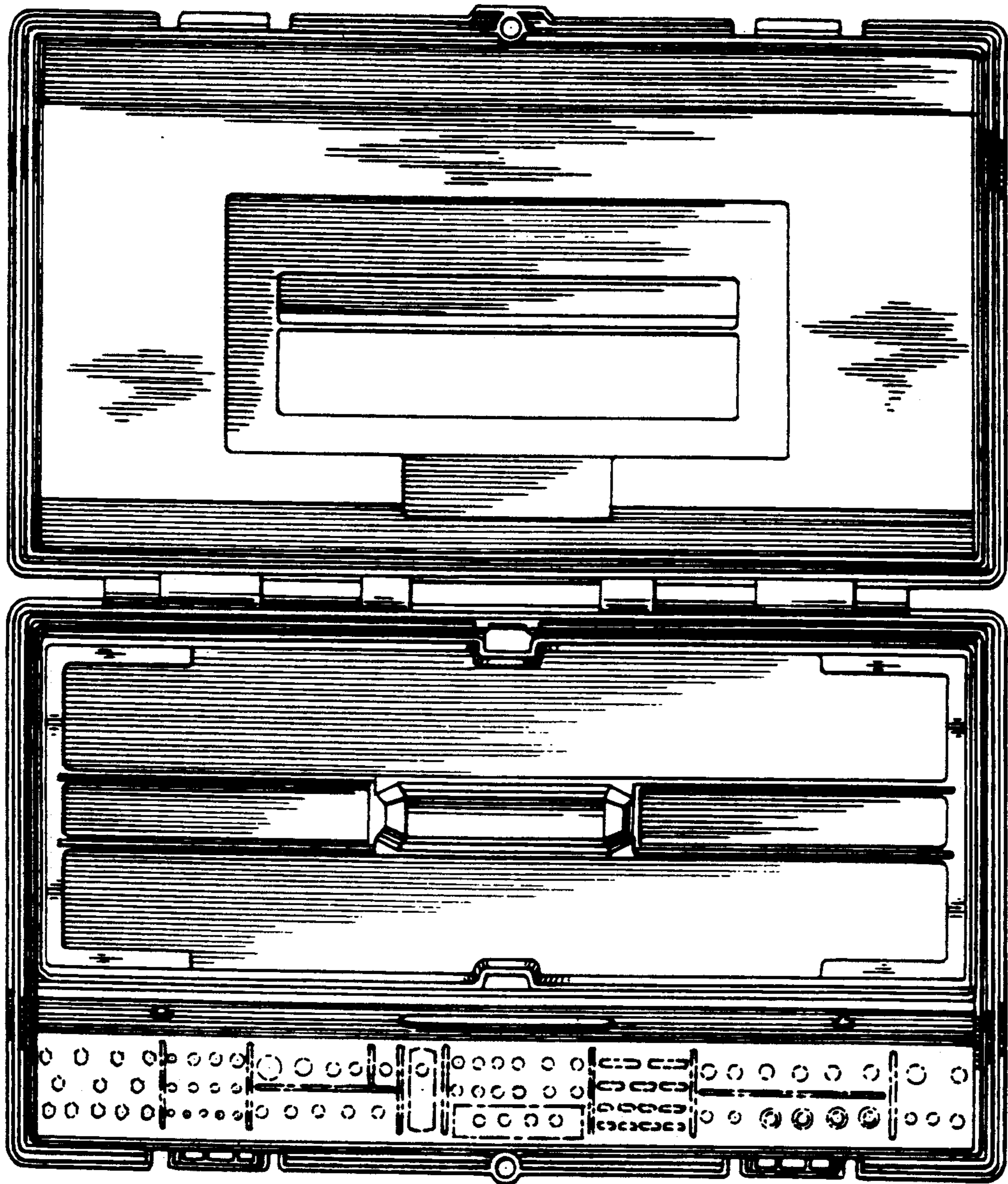
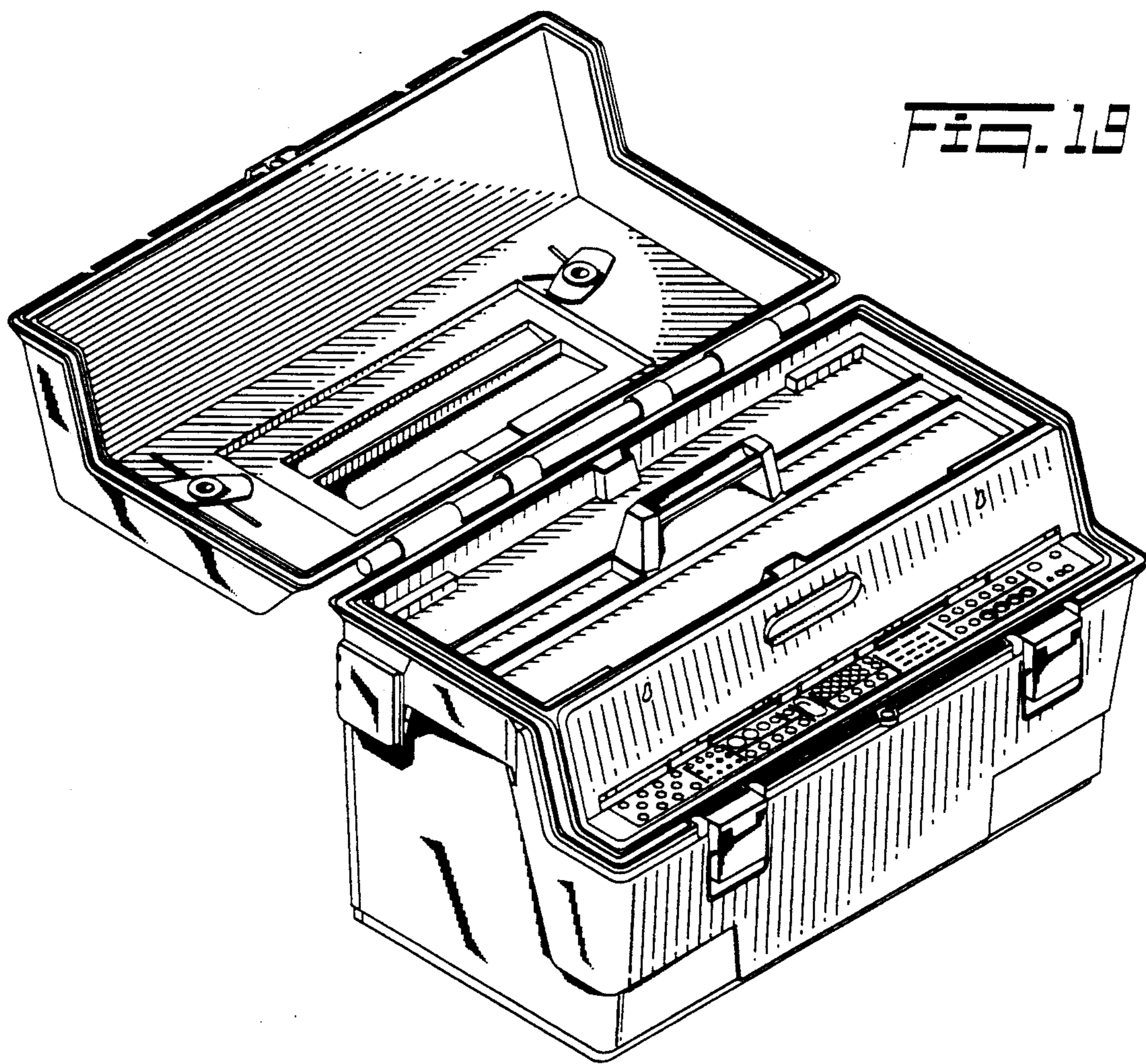

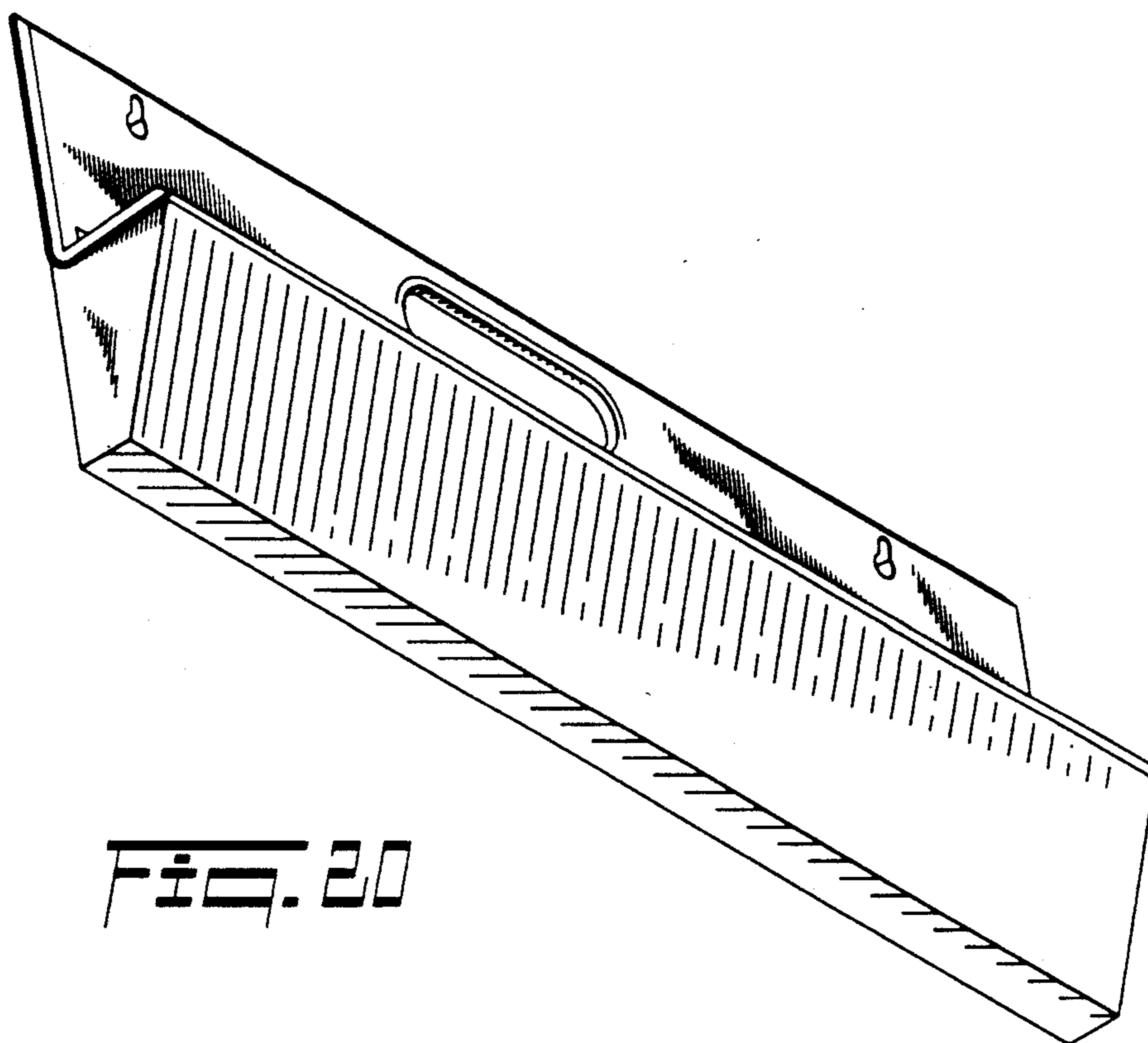
