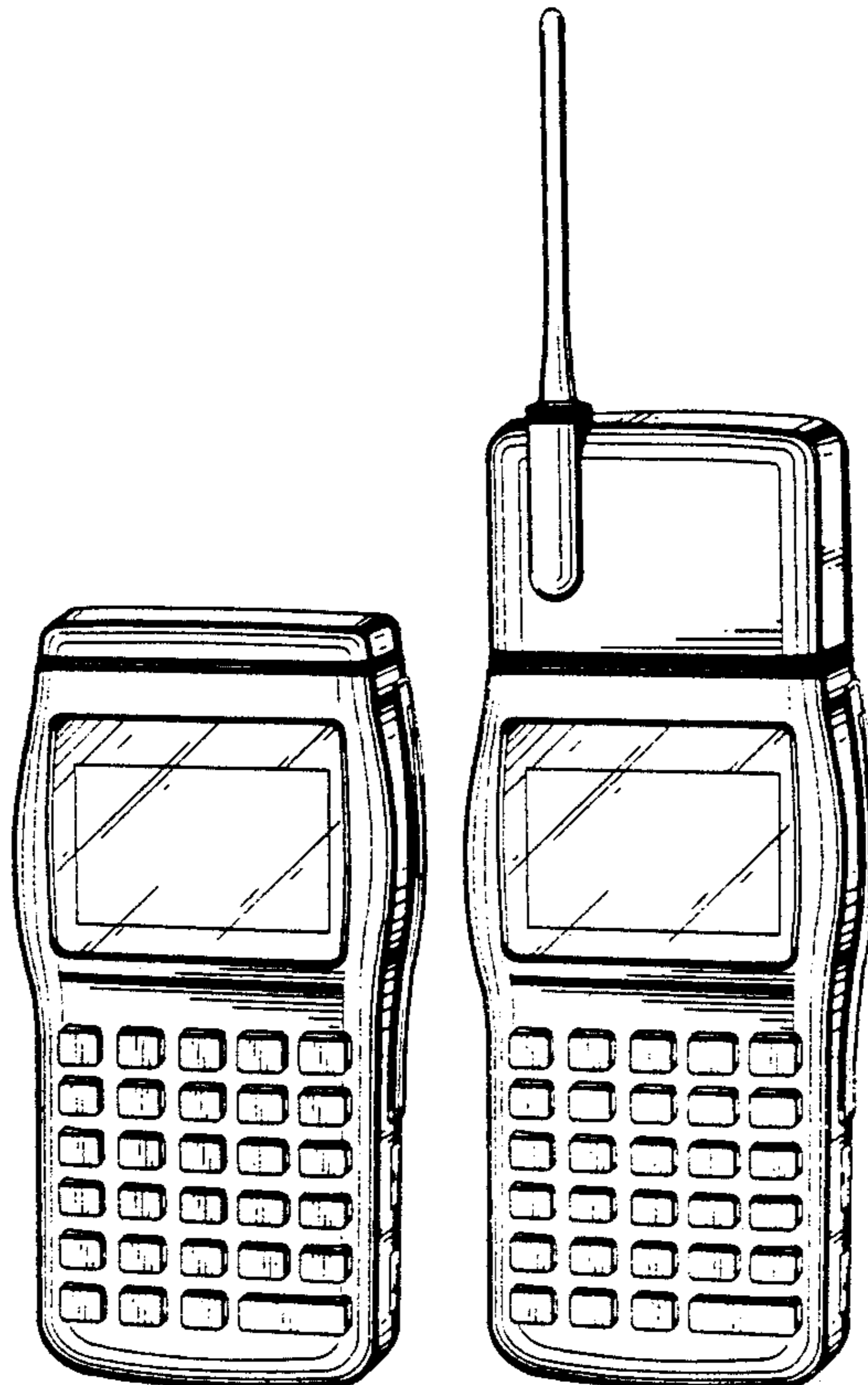
## [57] CLAIM

The ornamental design for a computer input and output terminal, as shown and described.

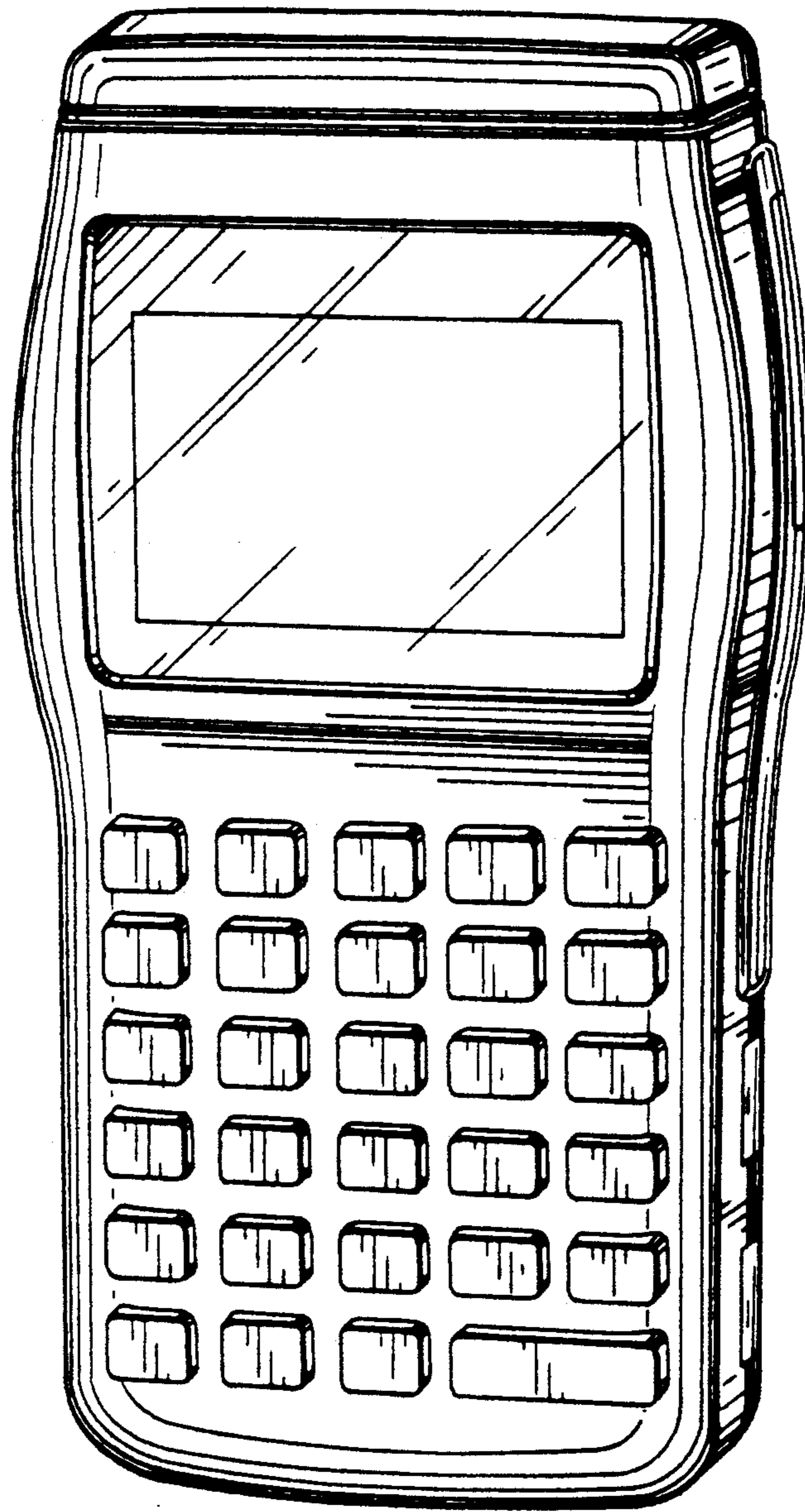
## DESCRIPTION

FIG. 1 is a front right side and rear end perspective view of a computer input and output terminal showing our new design;

 FIG. 19 is a front end elevational view thereof.

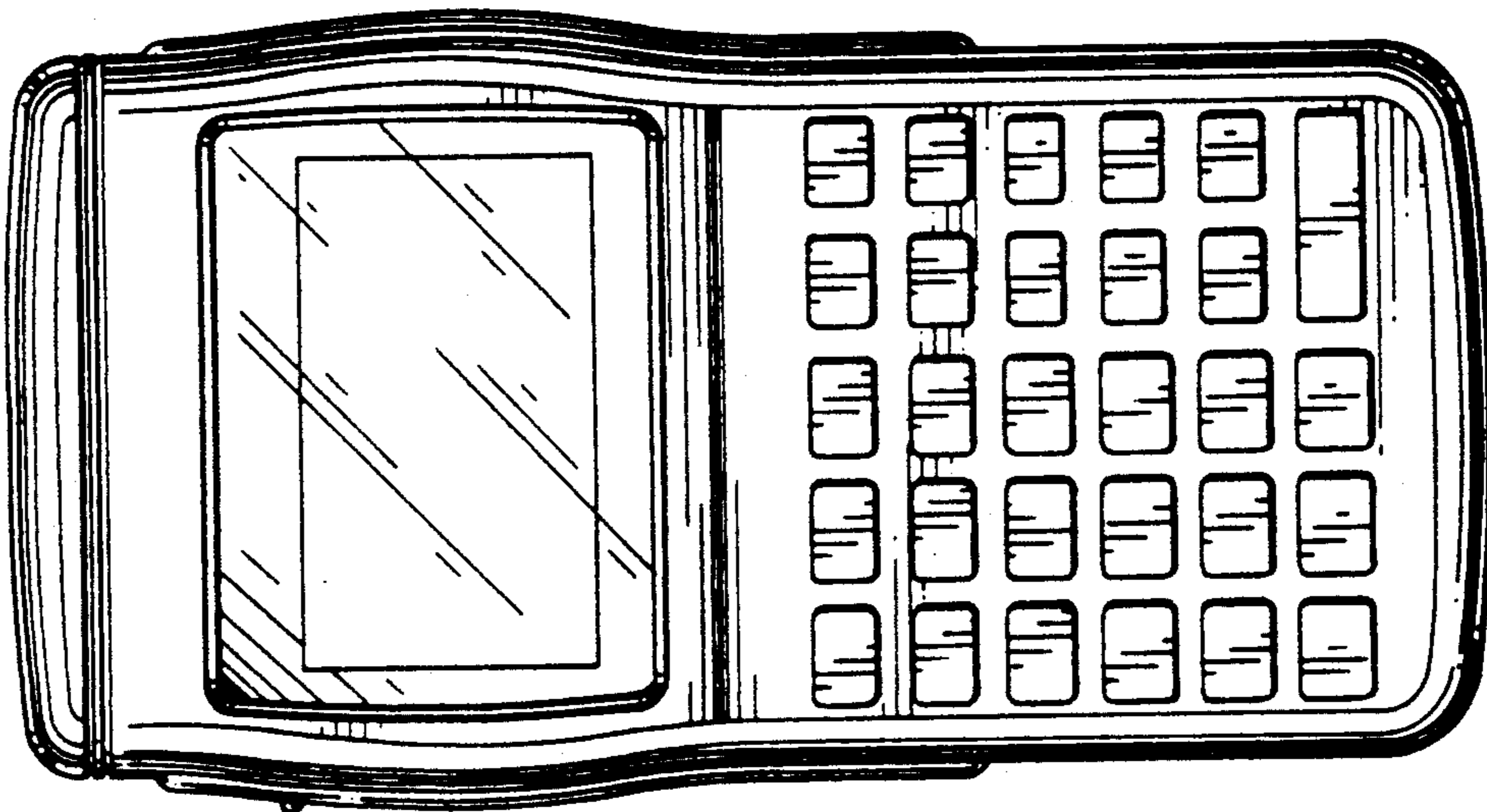
The undisclosed front and rear end elevational views of the second embodiment are identical in appearance to those of the first embodiment.



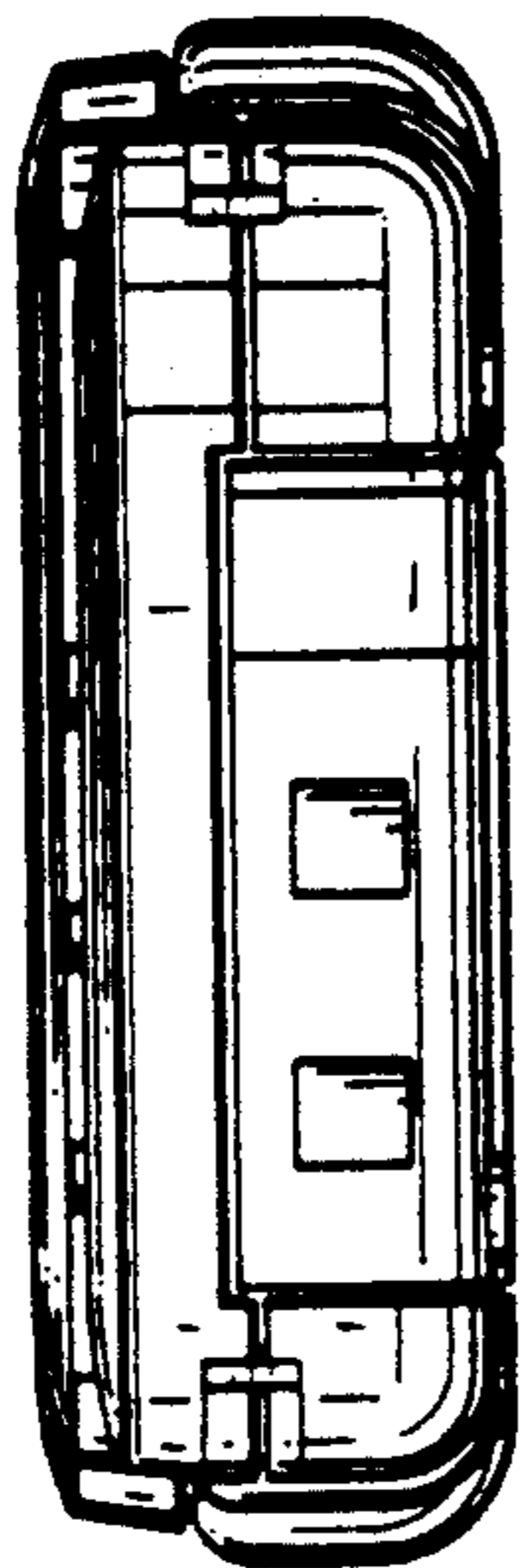

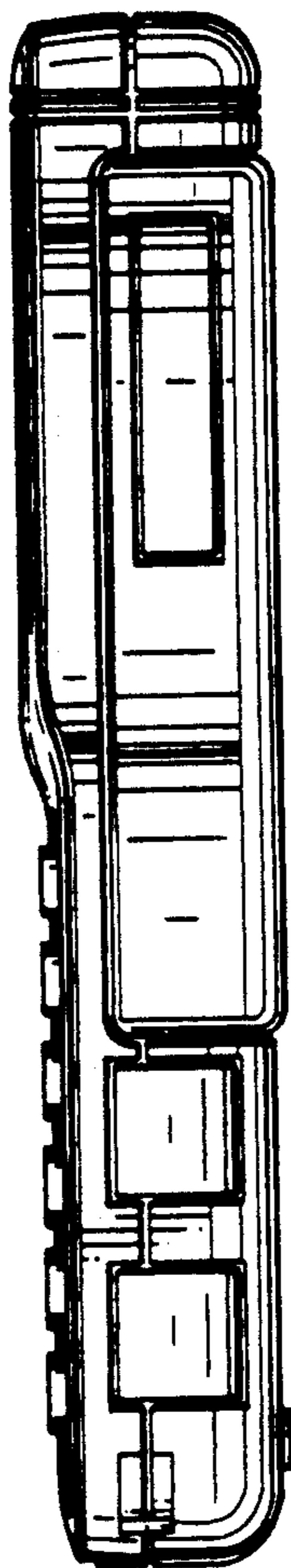

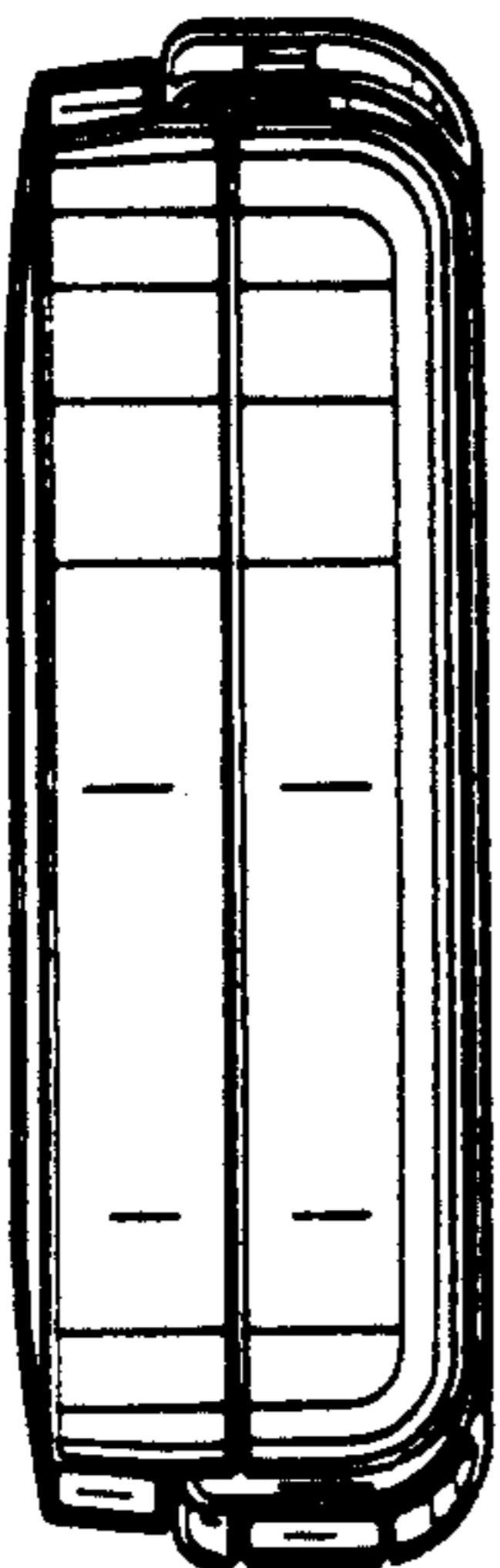

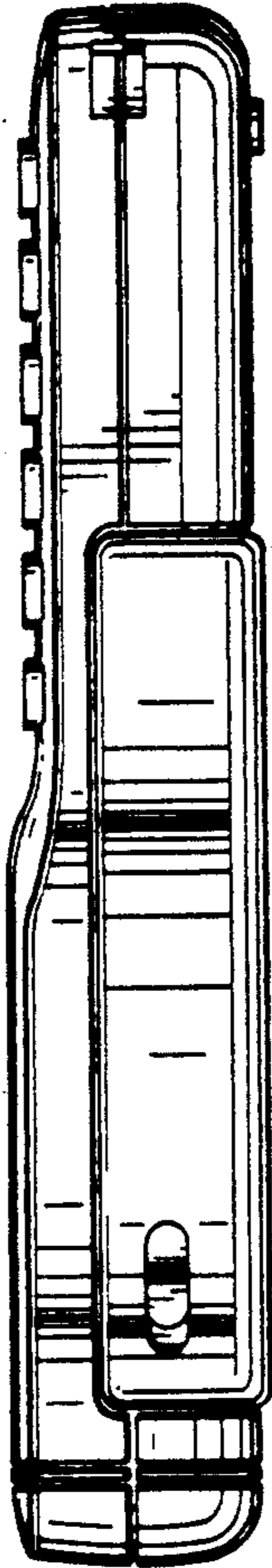

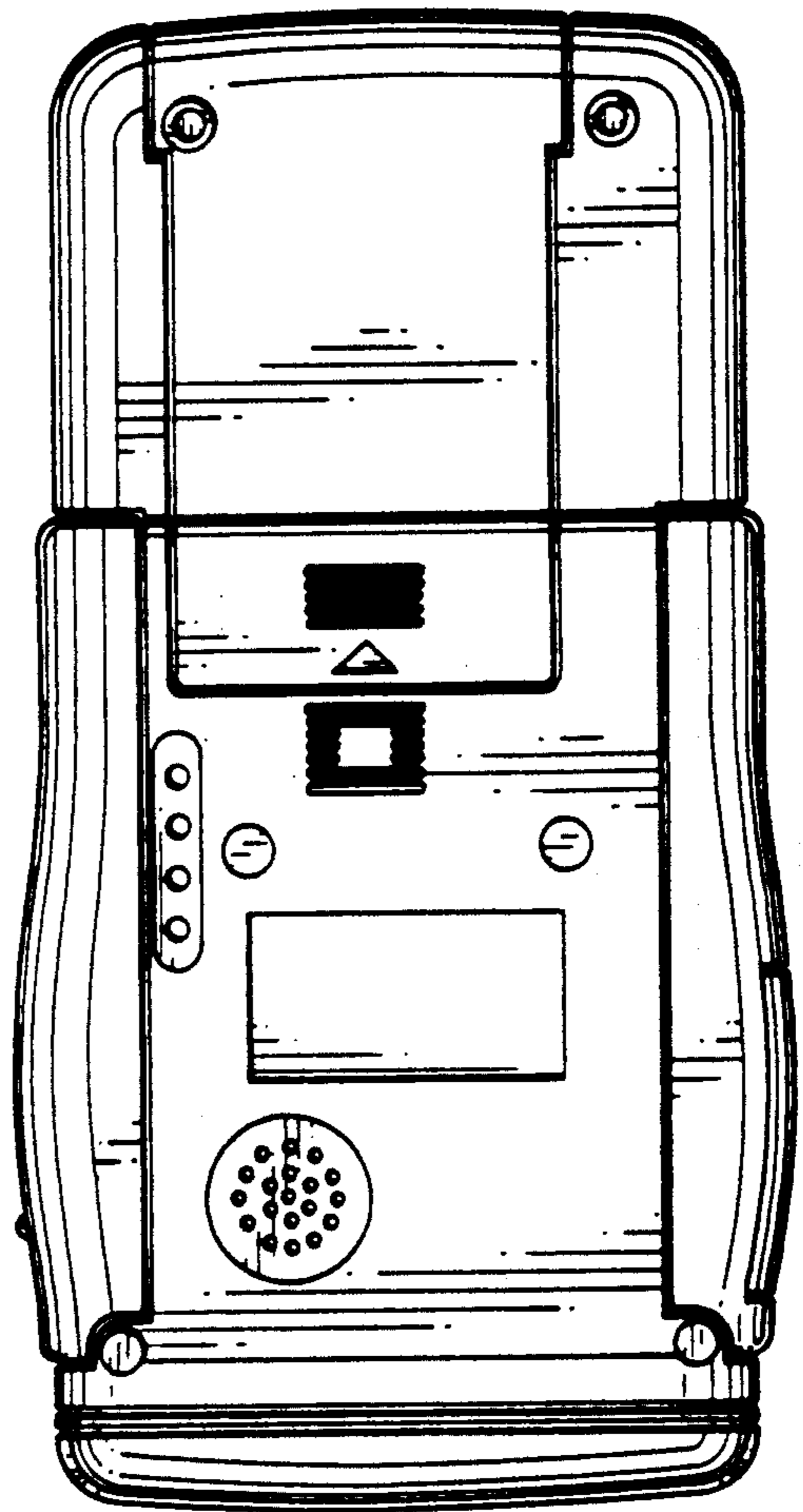

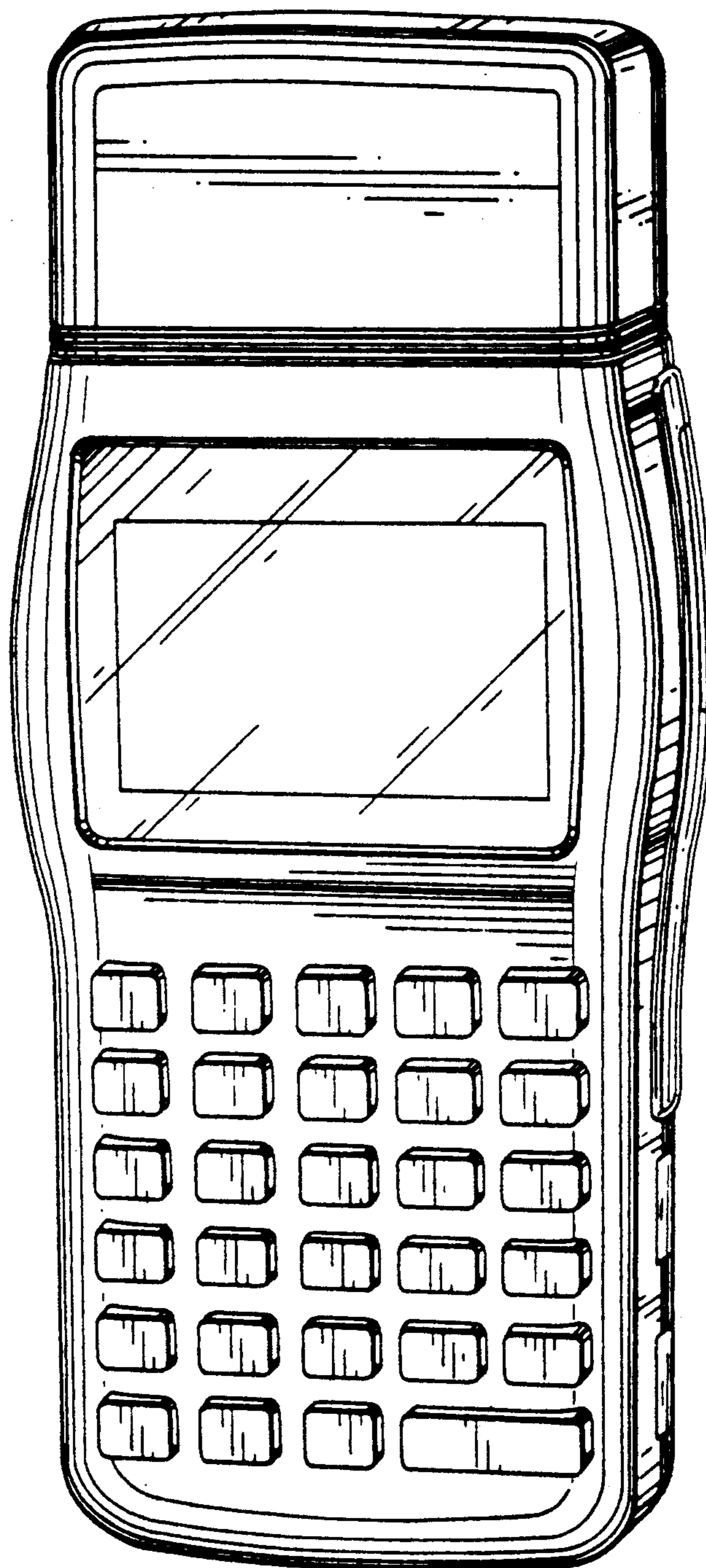

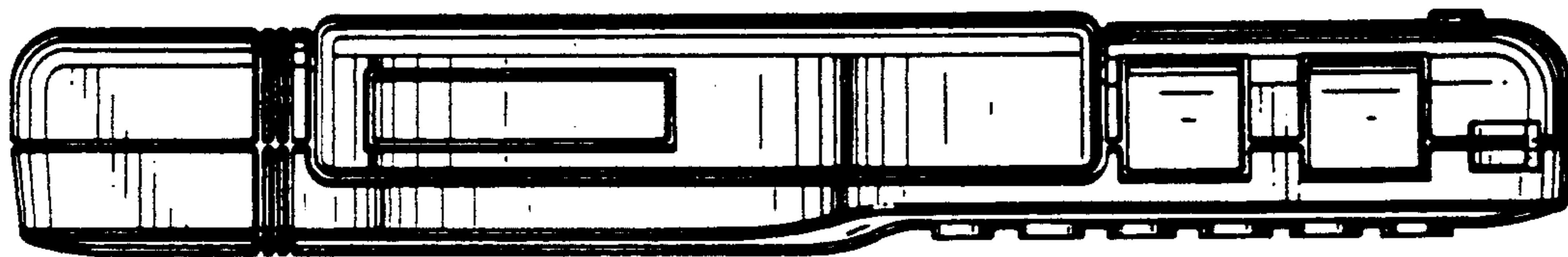

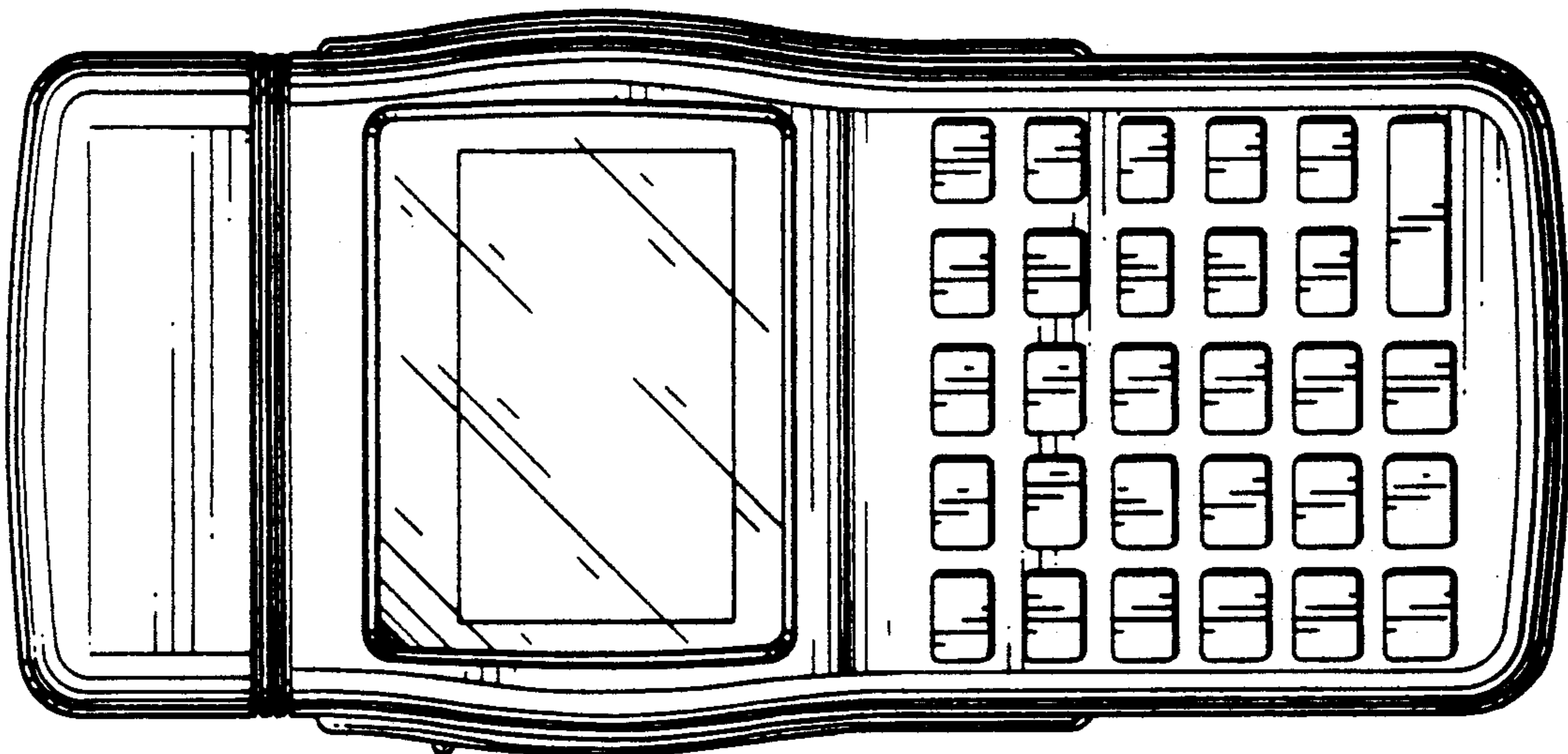

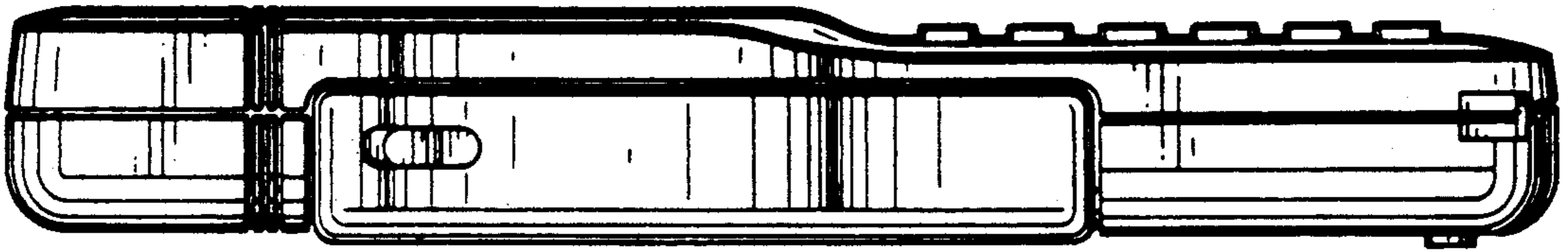

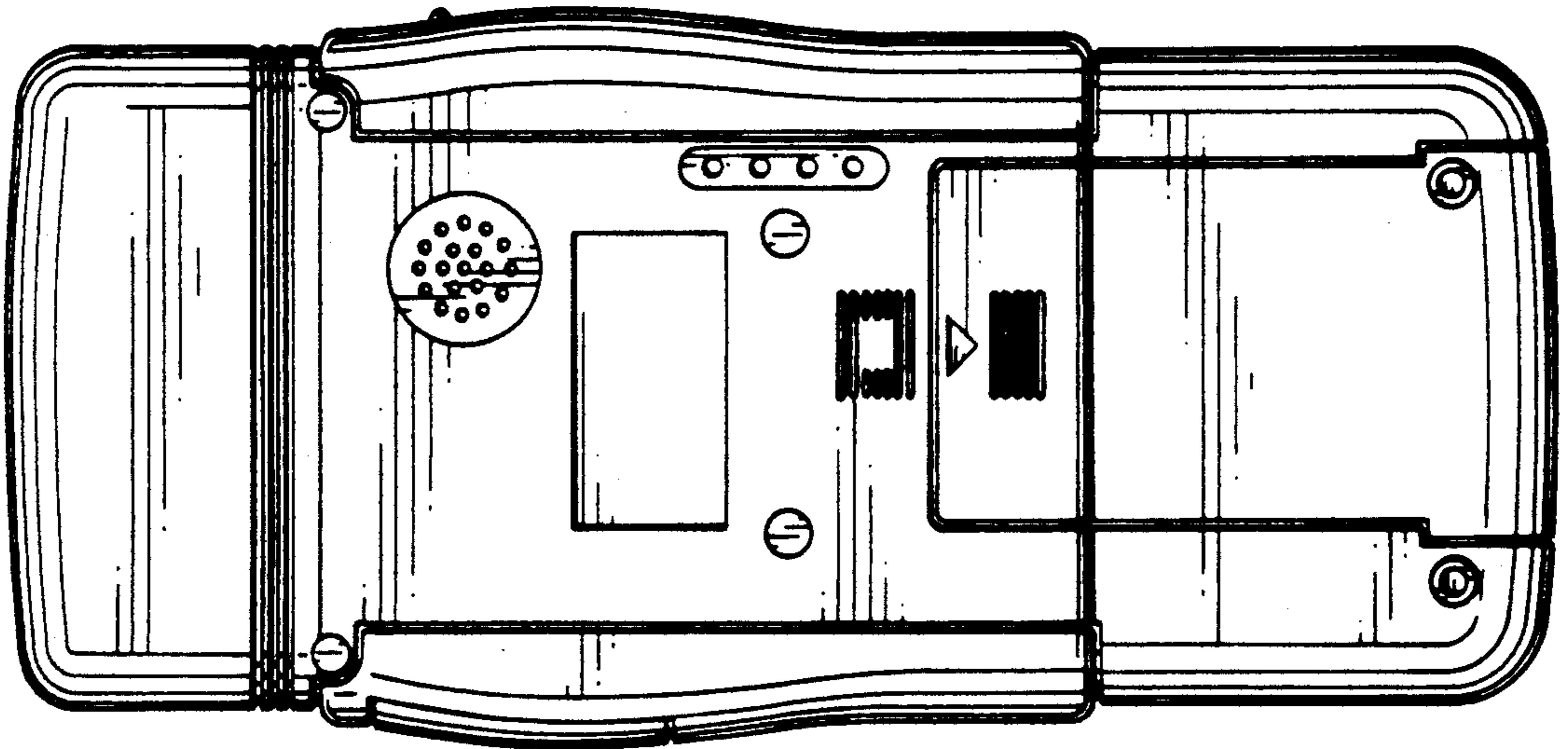

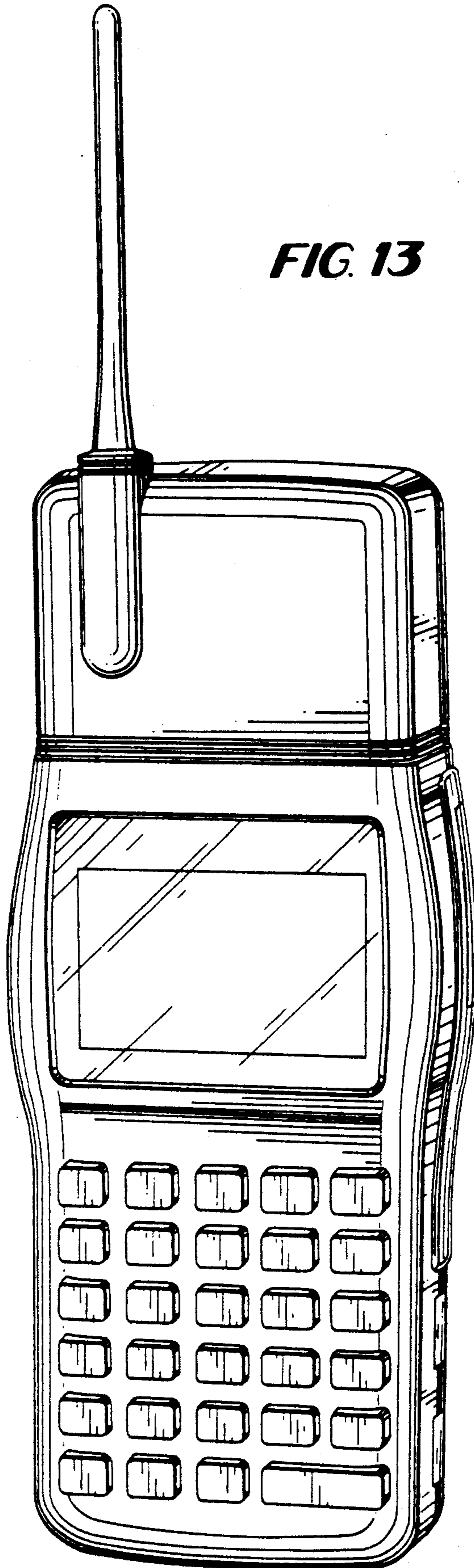

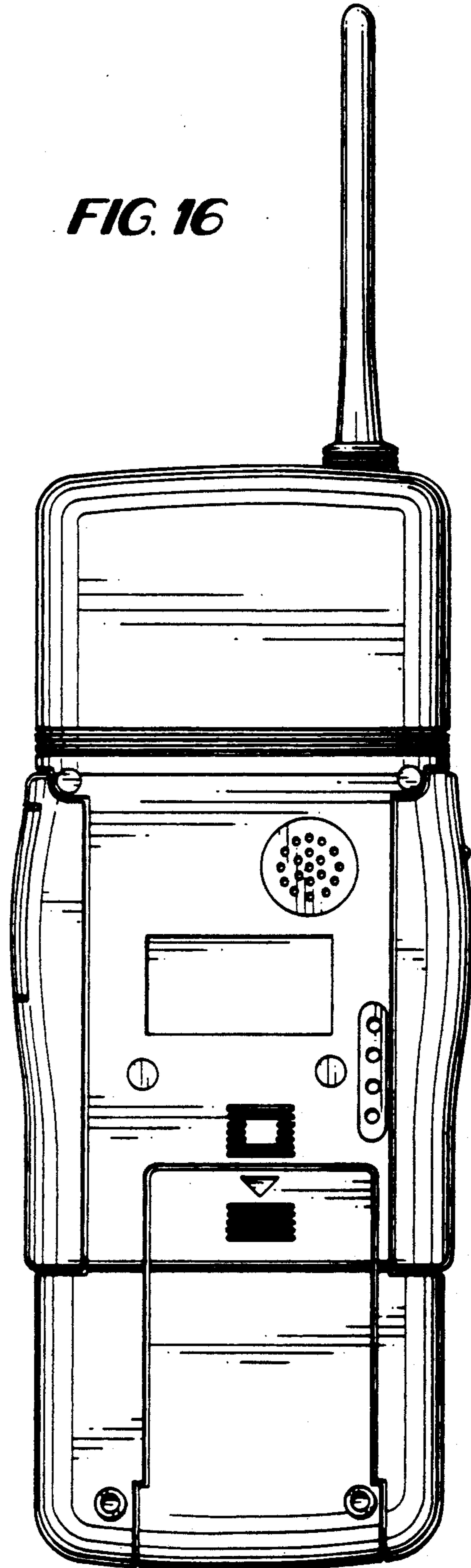
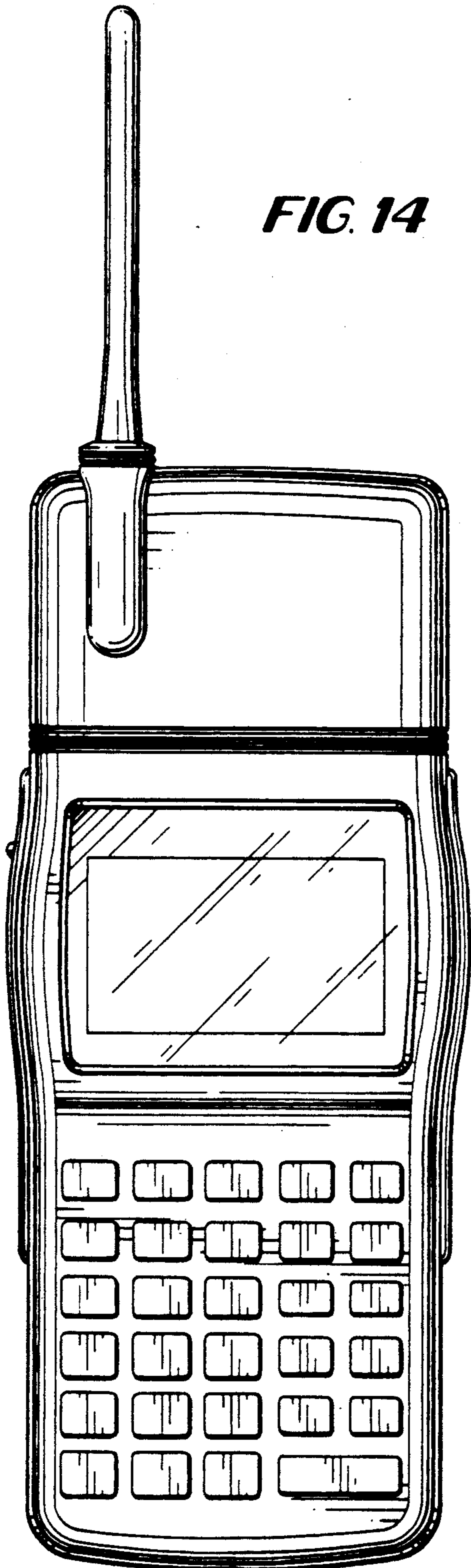

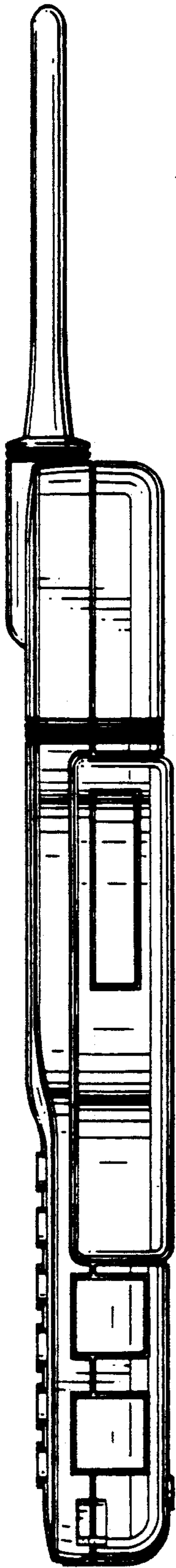

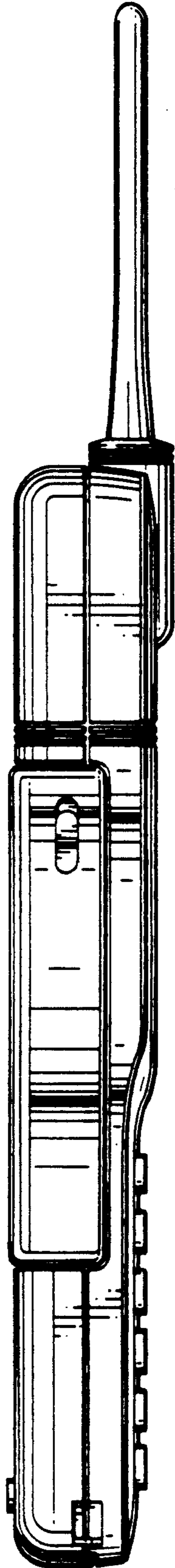
