### [57] CLAIM

The ornamental design for a warm-up suit, as shown and described.

### DESCRIPTION

FIG. 1 is a front elevational view of a warm-up suit showing our new design of conventional thickness; and, FIG. 2 is a rear elevational view thereof.  
 The circular elements down the sides of the article are understood to represent conventional snap closures.

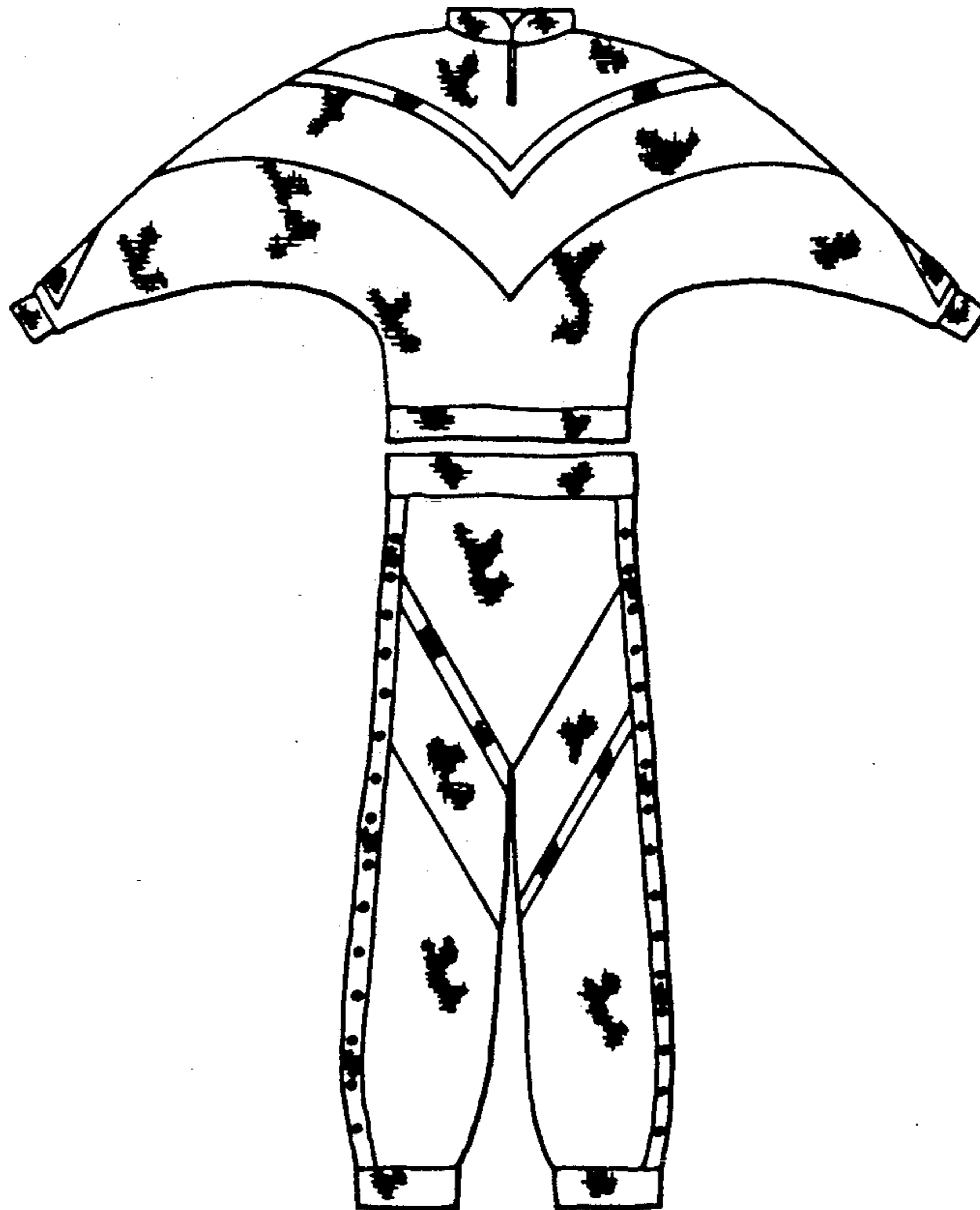

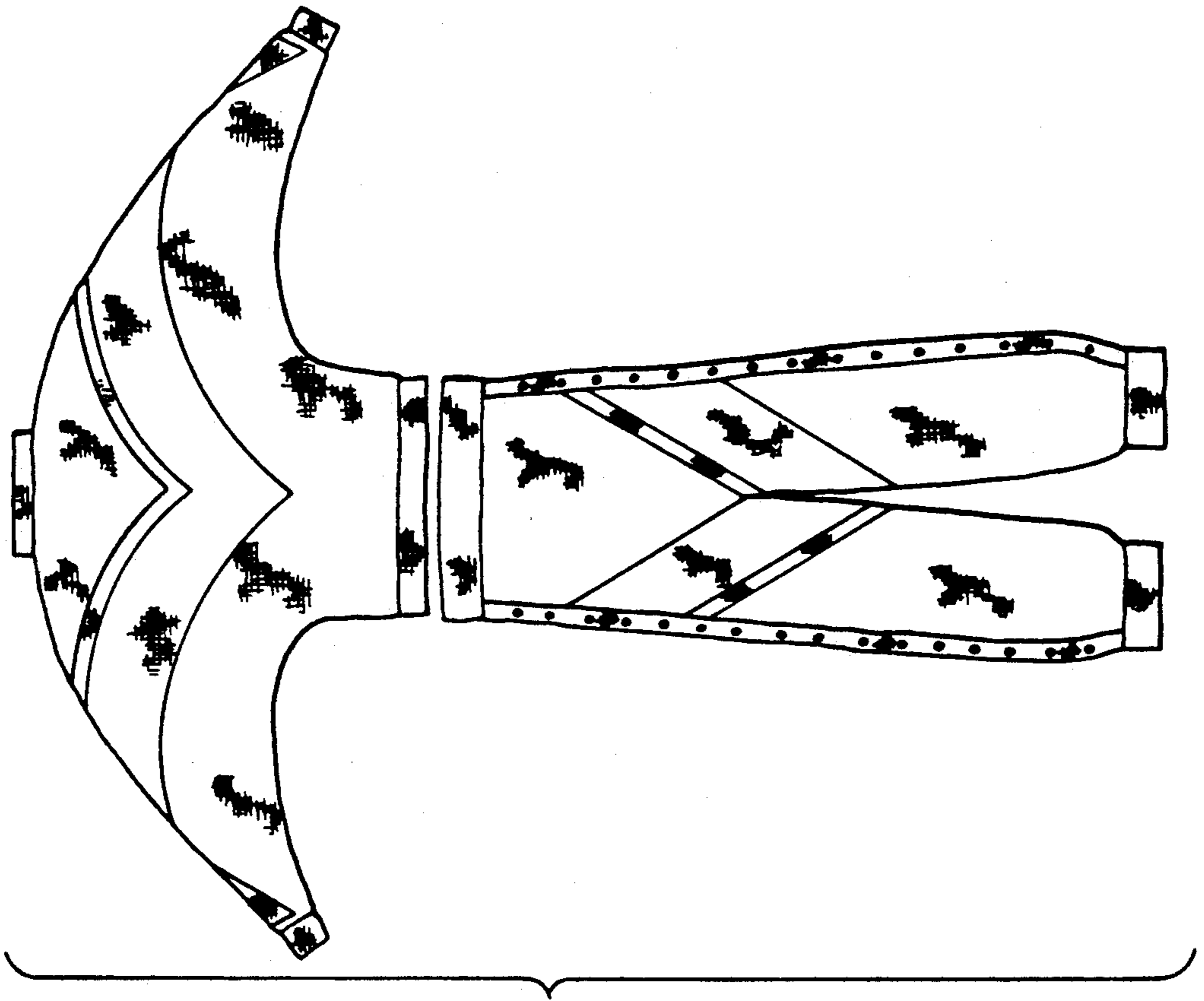
