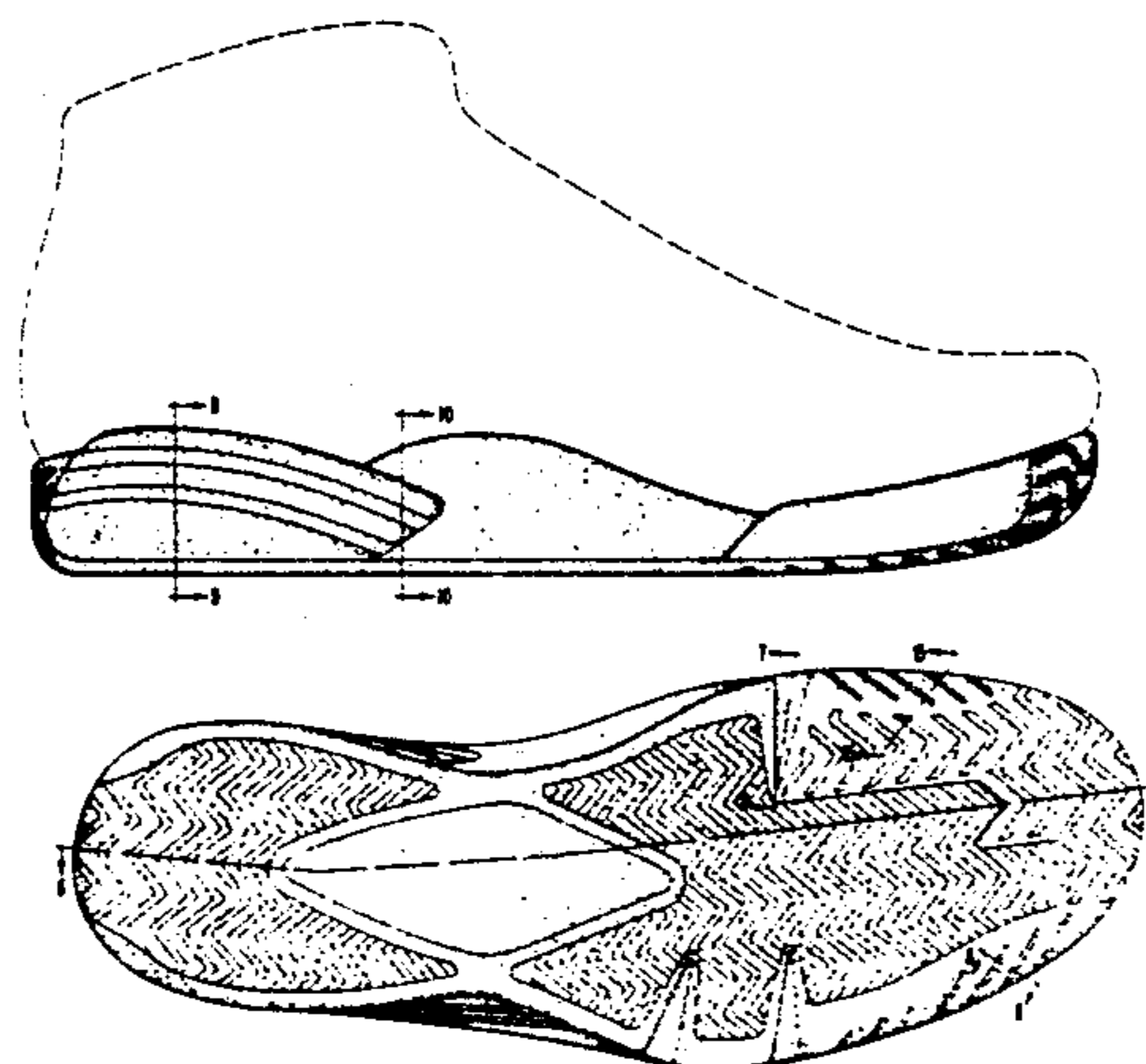

[57] CLAIM

The ornamental design for a shoe sole bottom and side, as shown and described.

DESCRIPTION

FIG. 1 is an elevational view of one side of a shoe sole bottom and side showing our new design;
FIG. 2 is an elevational view of the other side of the shoe sole bottom and side;
FIG. 3 is an elevational view of the front of the shoe sole bottom and side;
FIG. 4 is an elevational view of the rear of the shoe sole bottom and side;
FIG. 5 is a bottom plan view of the shoe sole bottom and side;
FIG. 6 is a cross section taken along line 5-5 of FIG. 5;
FIG. 7 is a cross section taken along line 7-7 of FIG. 5;
FIG. 8 is a cross section taken along line 8-8 of FIG. 5;
FIG. 9 is a cross section taken along line 9-9 of FIG. 1;
FIG. 10 is a cross section taken along line 10-10 of FIG. 1;
FIG. 11 is a cross section taken along line 11-11 of FIG. 2;
FIG. 12 is a cross section taken along line 12-12 of FIG. 2;
FIG. 13 is a cross section taken along line 13-13 of FIG. 2;
FIG. 14 is a cross section taken along line 14-14 of FIG. 4; and,
FIG. 15 is a cross section taken along line 15-15 of FIG. 5.
The broken line showing of the upper in FIGS. 1-4 forms no part of the claimed design.



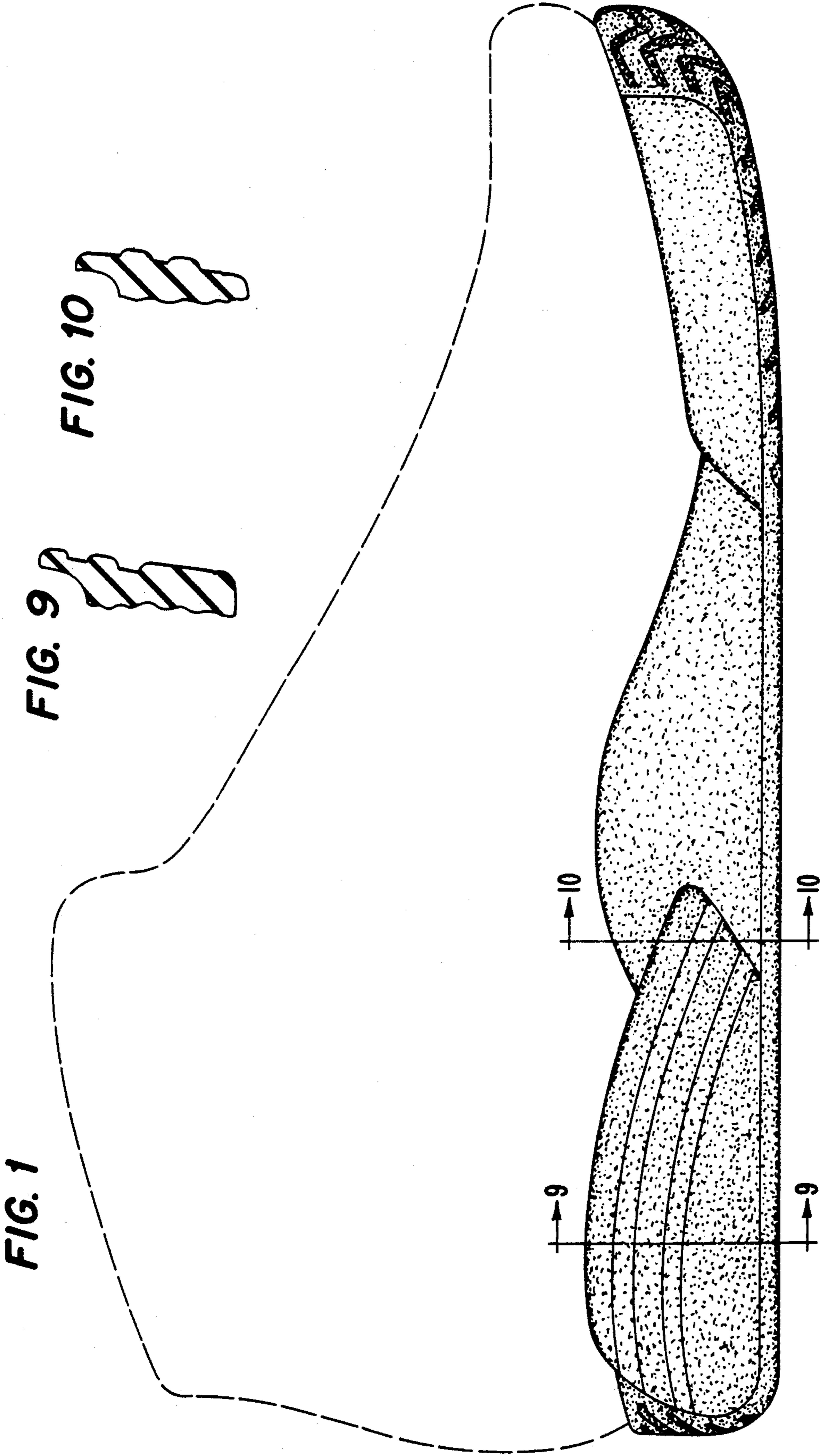

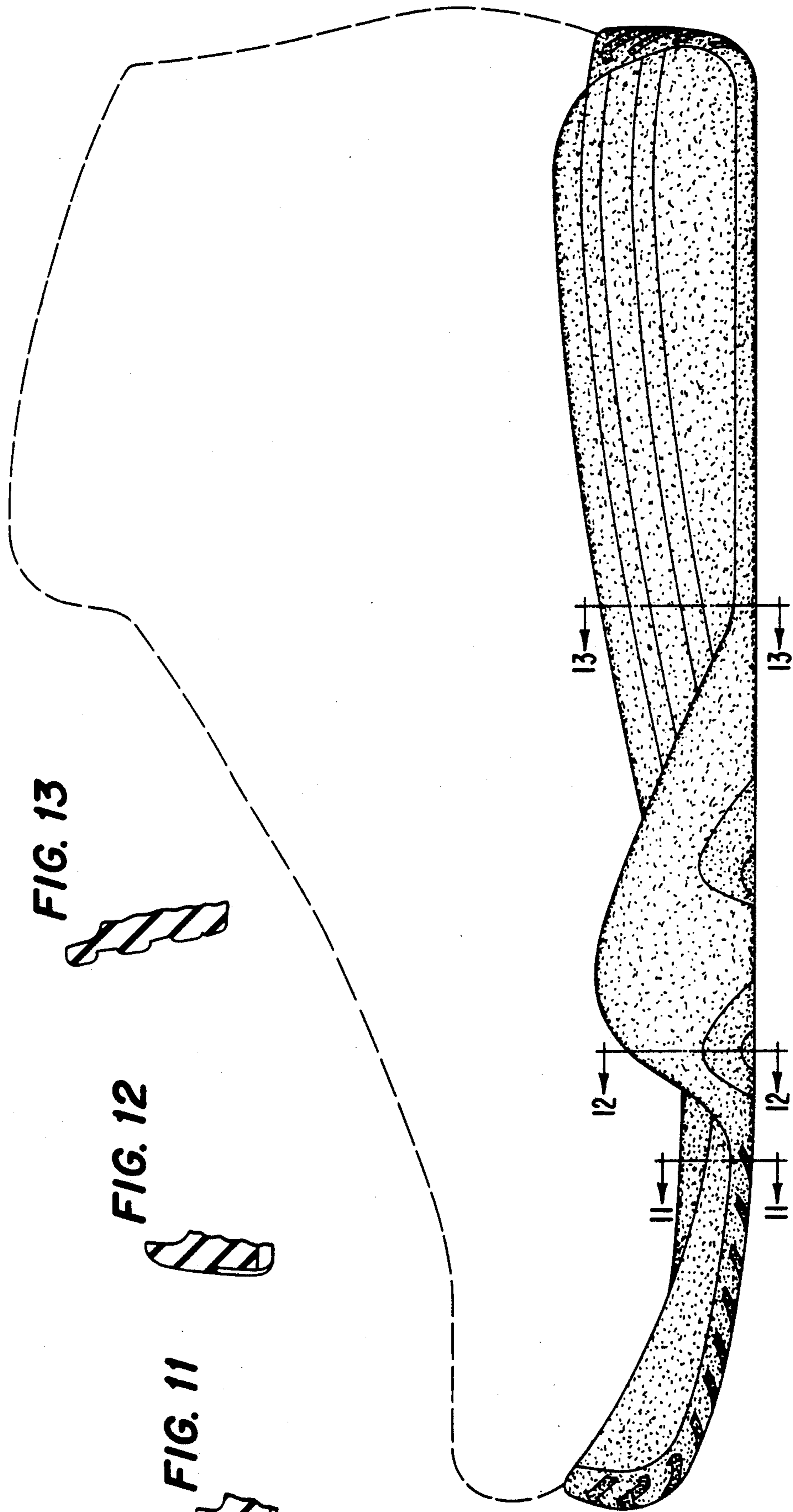

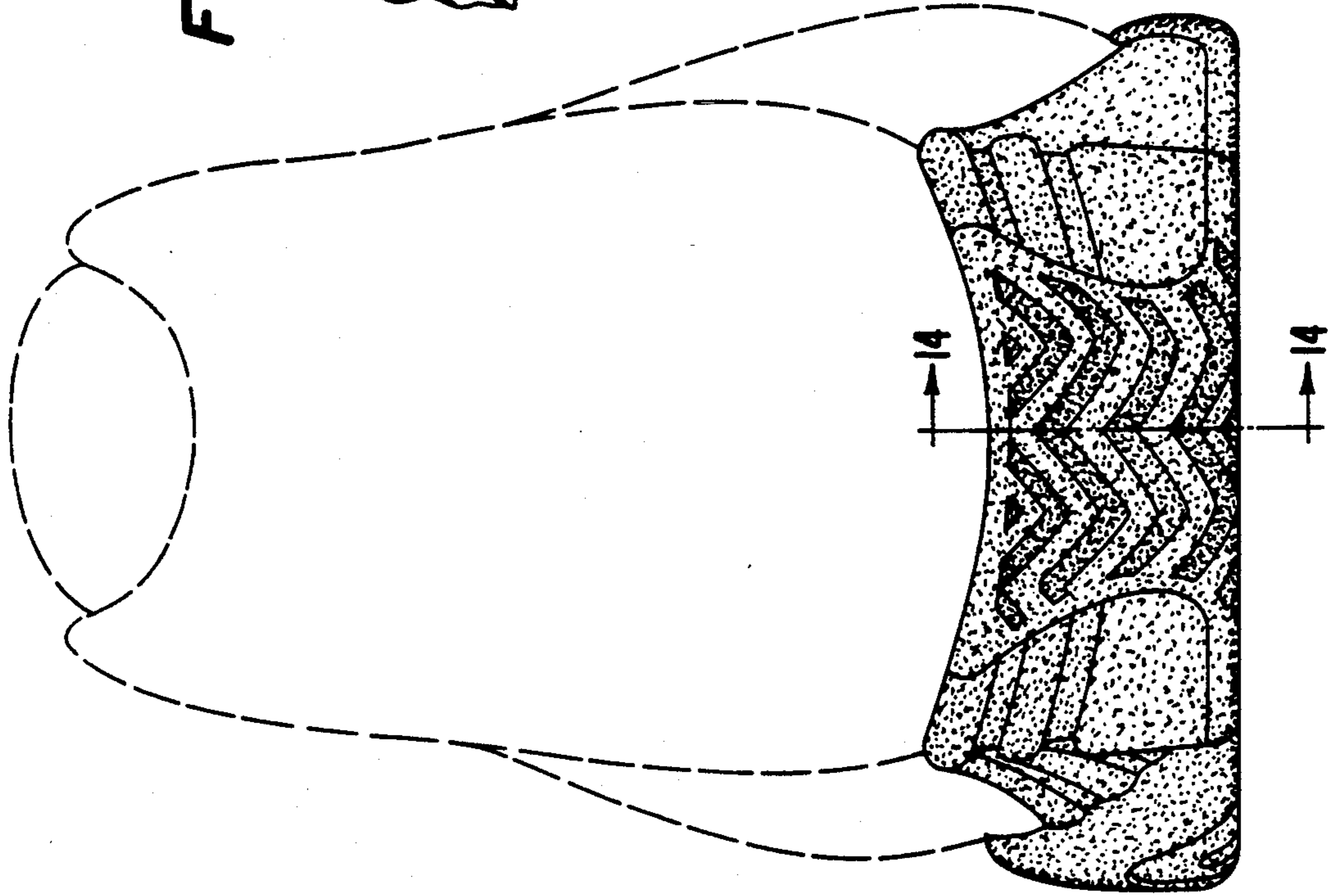
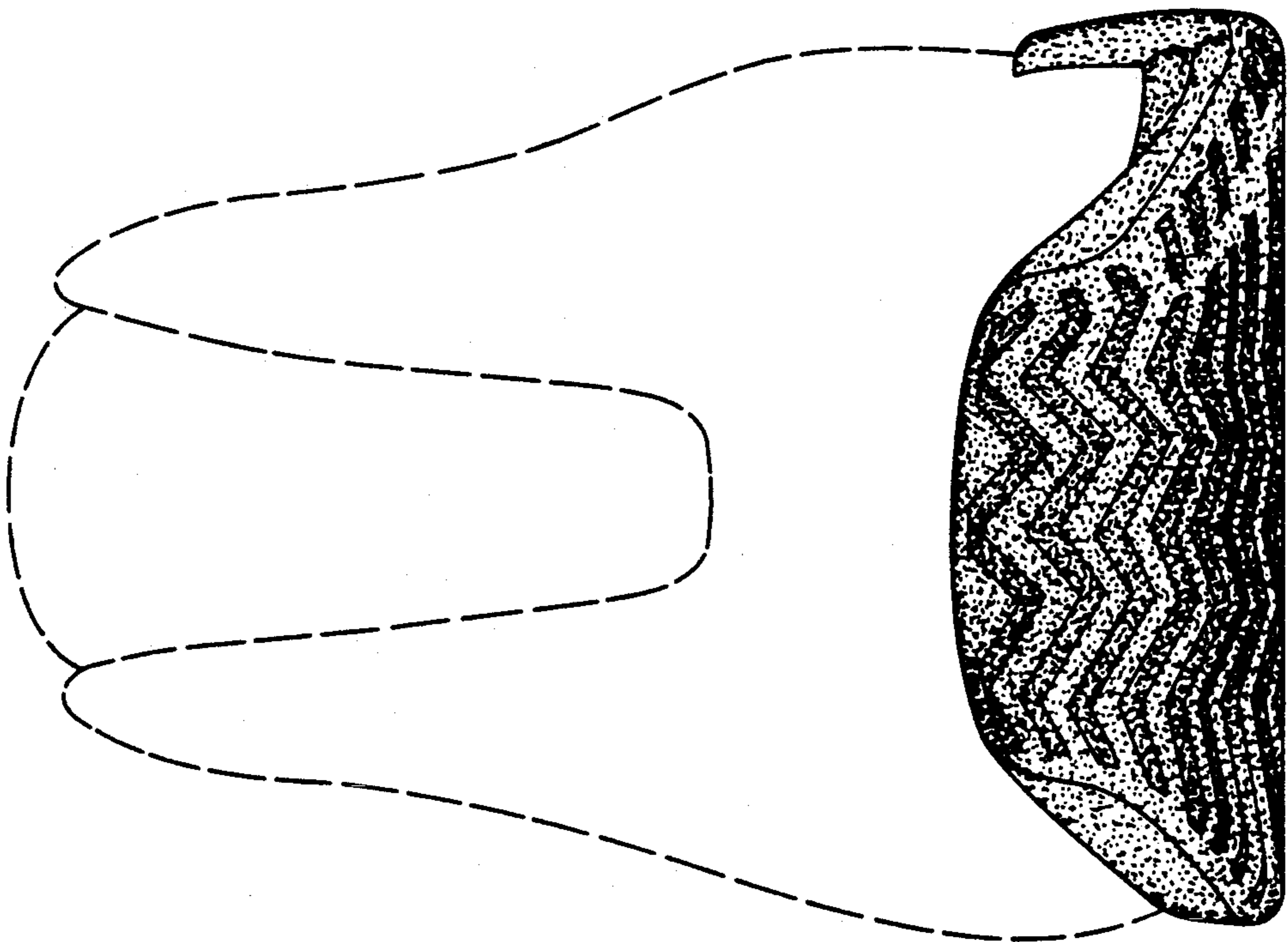

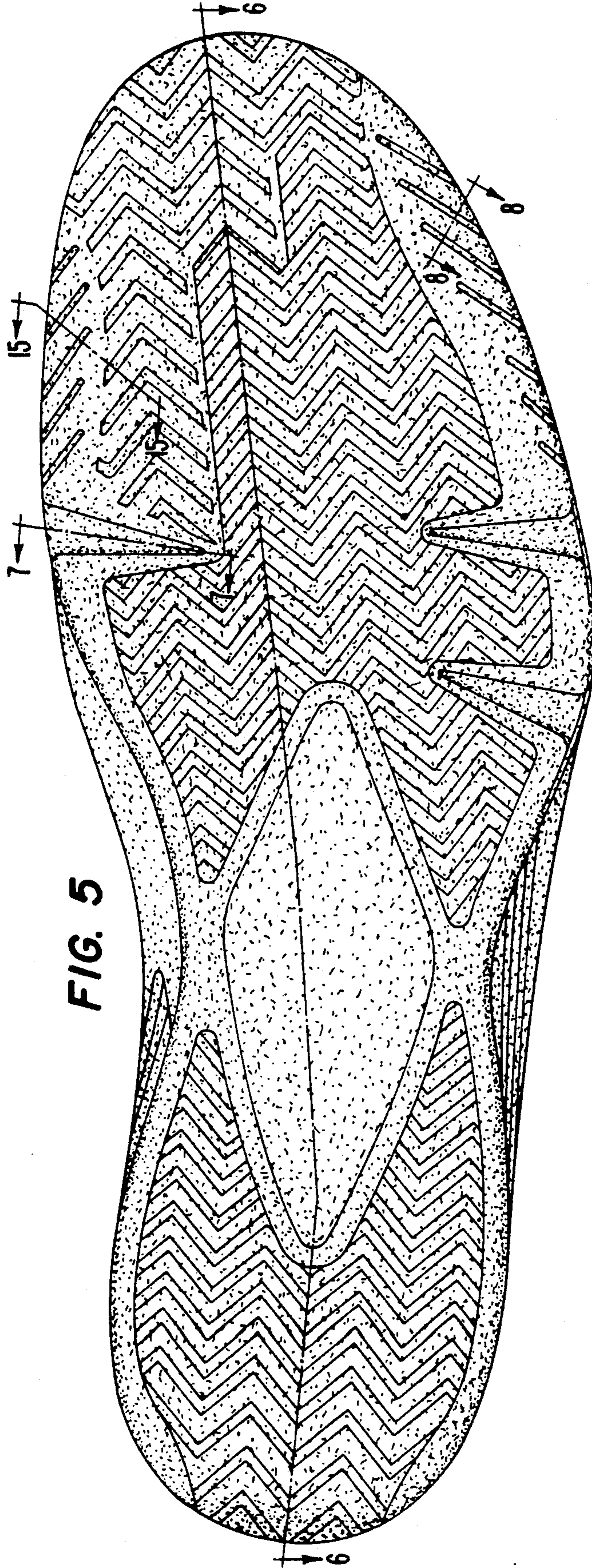
