DESCRIPTION

FIG. 1 is a perspective view of a cassette holder showing my new design;

FIG. 2 is an enlarged fragmentary perspective view thereof;

FIG. 3 is an exploded bottom perspective view thereof, the broken lines indicate environmental structure and form no part of the claimed design;

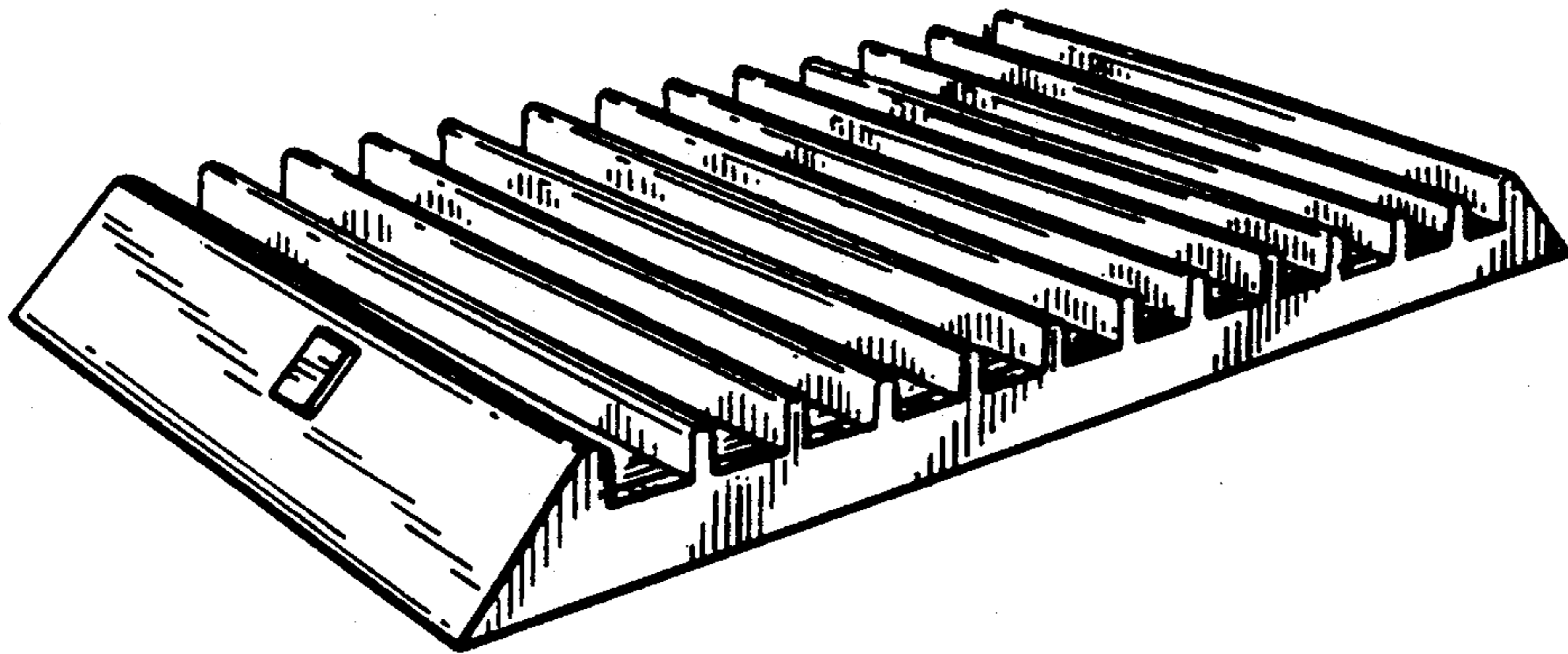
FIG. 4 is a top plan view thereof;

FIG. 8 is a bottom plan view thereof.



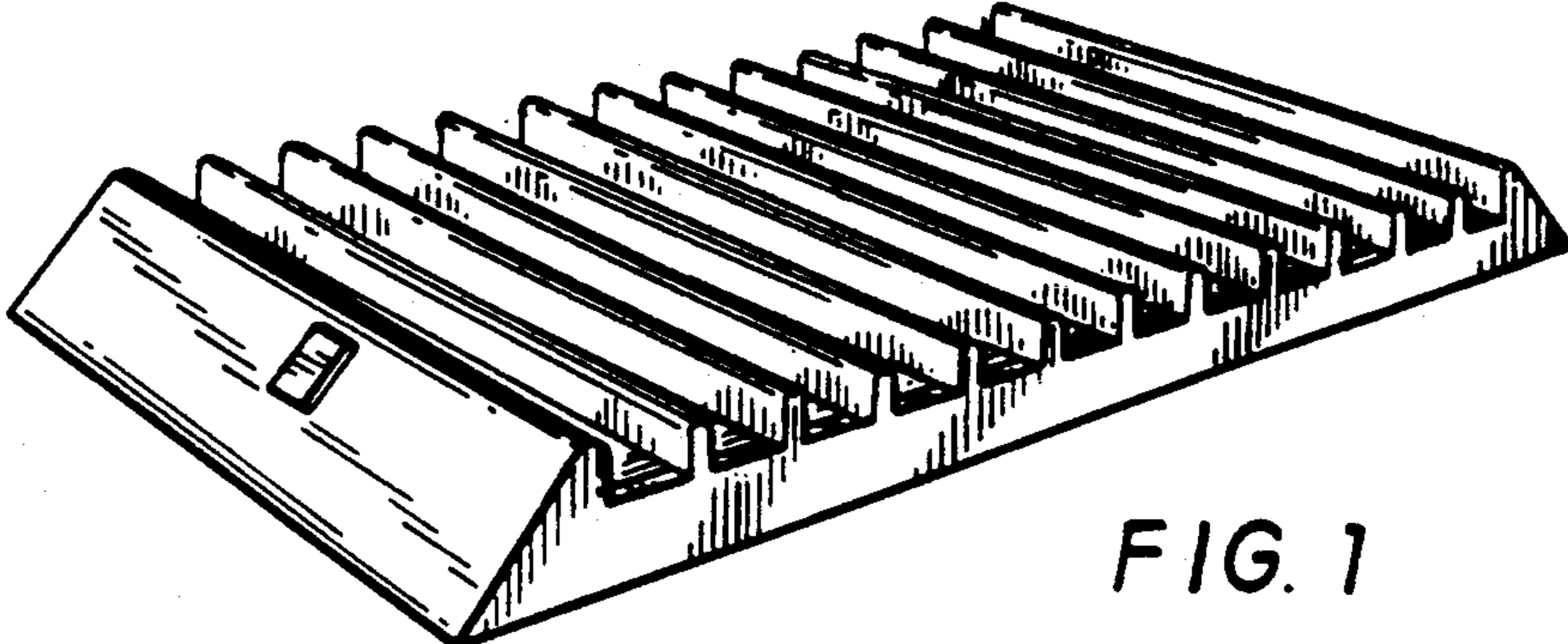

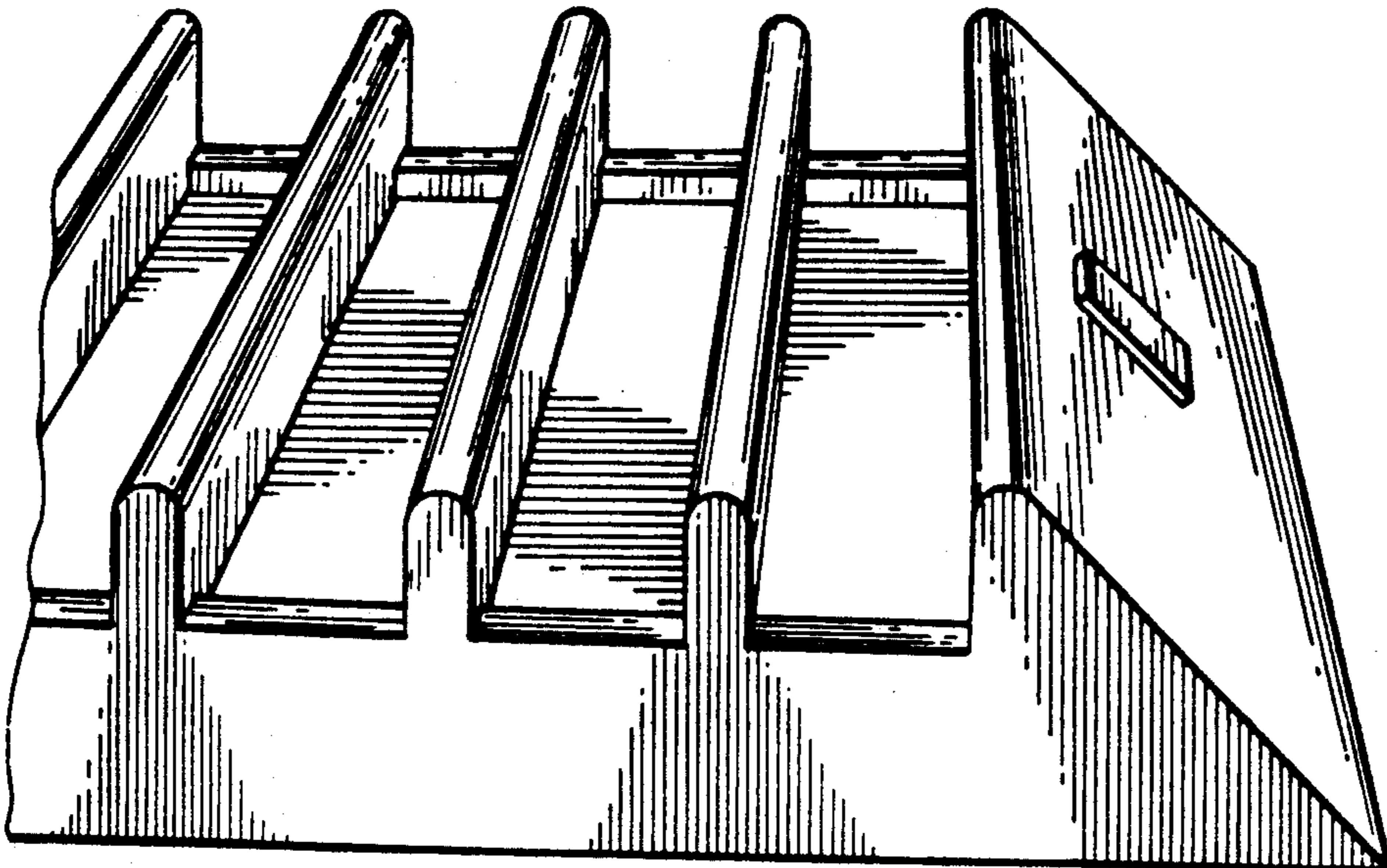

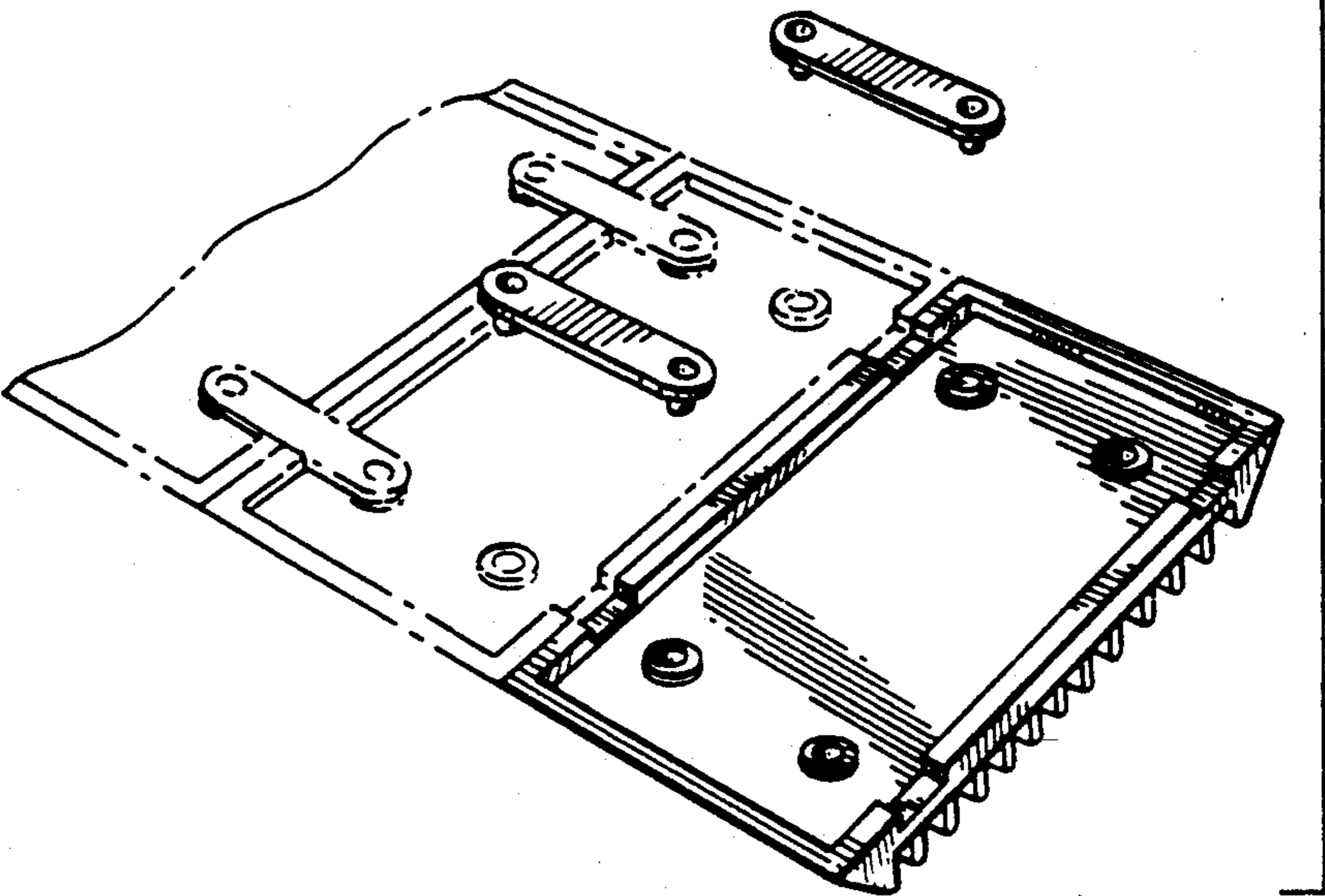

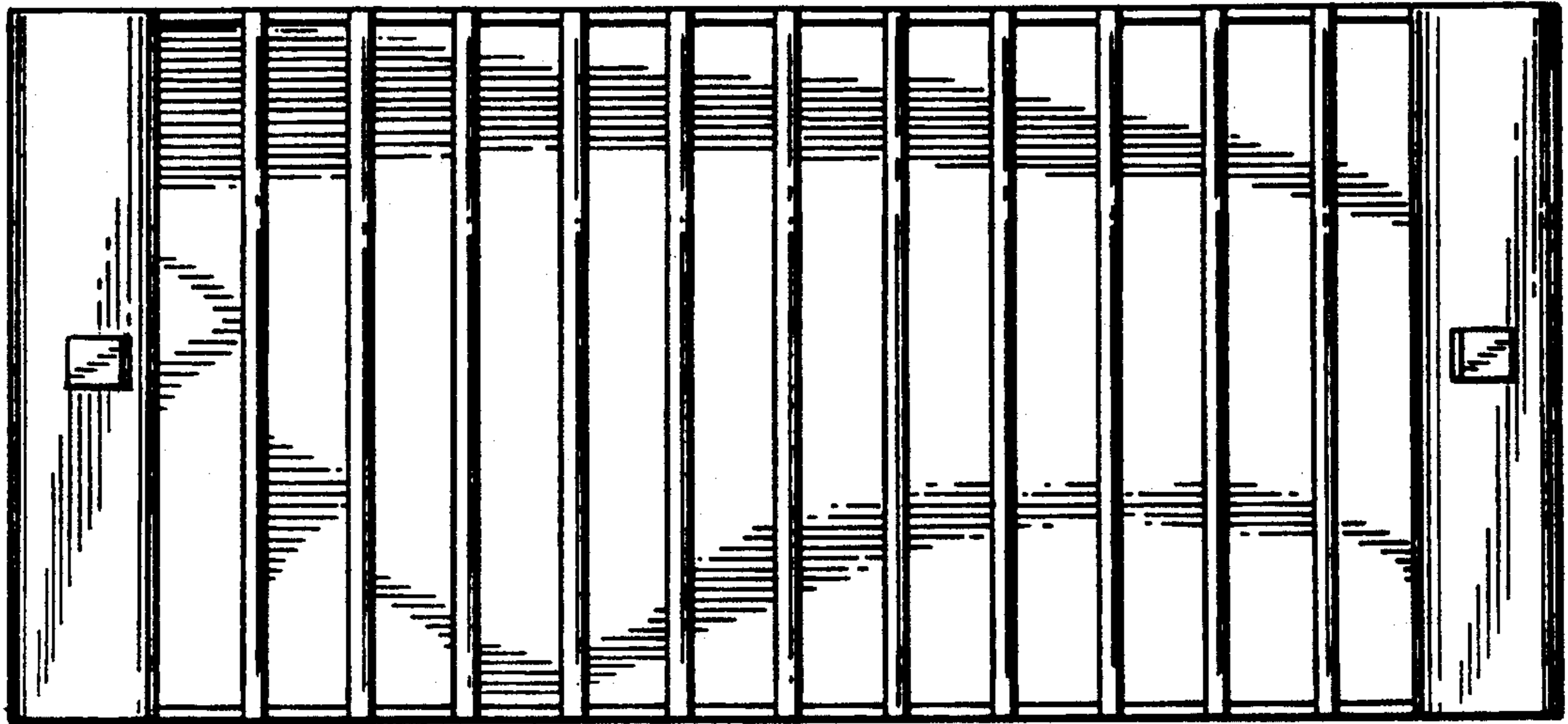

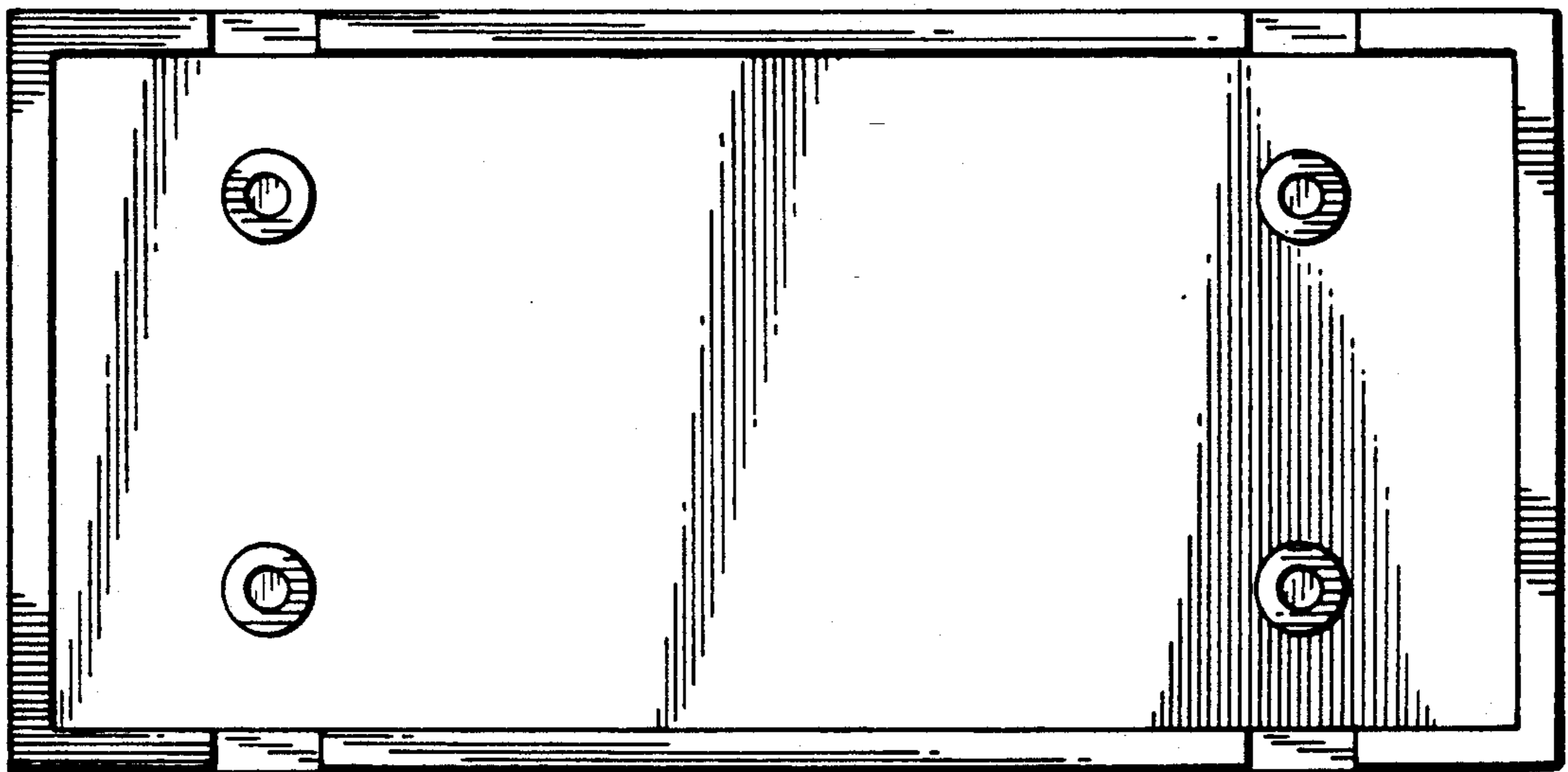
