## [57] CLAIM

The ornamental design for a shoe midsole, as shown and described.

## DESCRIPTION

FIG. 1 is a side elevational view of one side of a shoe midsole showing a first embodiment of my new design; FIG. 2 is a side elevational view of the other side of the shoe midsole shown in FIG. 1;

FIG. 3 is a front elevational view of the shoe midsole shown in FIG. 1;

FIG. 4 is a rear elevational view of the shoe midsole shown in FIG. 1;

FIG. 5 is a cross section of the shoe midsole taken along line 5—5 of FIG. 1;

FIG. 6 is a cross section of the shoe midsole taken along line 6—6 of FIG. 1;

FIG. 7 is a cross section of the shoe midsole taken along line 7—7 of FIG. 1;

FIG. 8 is a cross section of the shoe midsole taken along line 8—8 of FIG. 2;

FIG. 9 is a cross section of the shoe midsole taken along line 9—9 of FIG. 2;


FIG. 10 is a cross sectional view of the shoe midsole taken along line 10—10 of FIG. 1;


FIG. 11 is a side elevational view of a shoe midsole showing a second embodiment of my new design;

FIG. 12 is cross section of the second embodiment of the shoe midsole taken along line 12—12 of FIG. 11; and,

FIG. 13 is side elevational view of the other side of the second embodiment of the shoe midsole in FIG. 11.

The broken lines showing of the shoe upper and shoe bottom are for illustrative purposes only and form no part of the claimed design.










