DESCRIPTION

FIG. 1 is a left-front perspective view of a chair show-
ing our new design;
FIG. 2 is a right side elevational view;
FIG. 3 is a top plan view;
FIG. 4 is a front elevational view;
FIG. 5 is a rear elevational view thereof; and,
FIG. 6 is an enlarged fragmentary front elevational
view of the upper portion of the backrest.

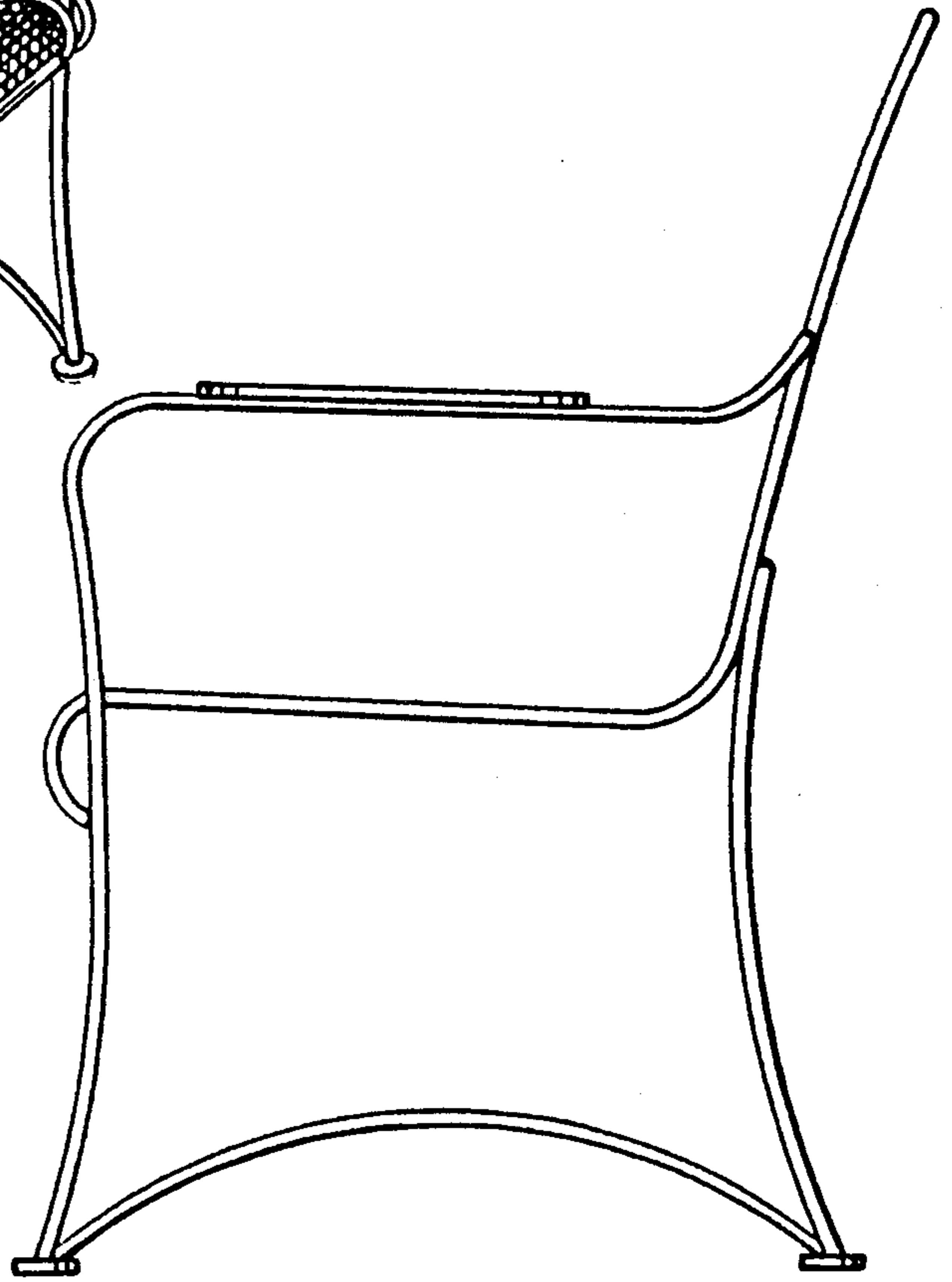

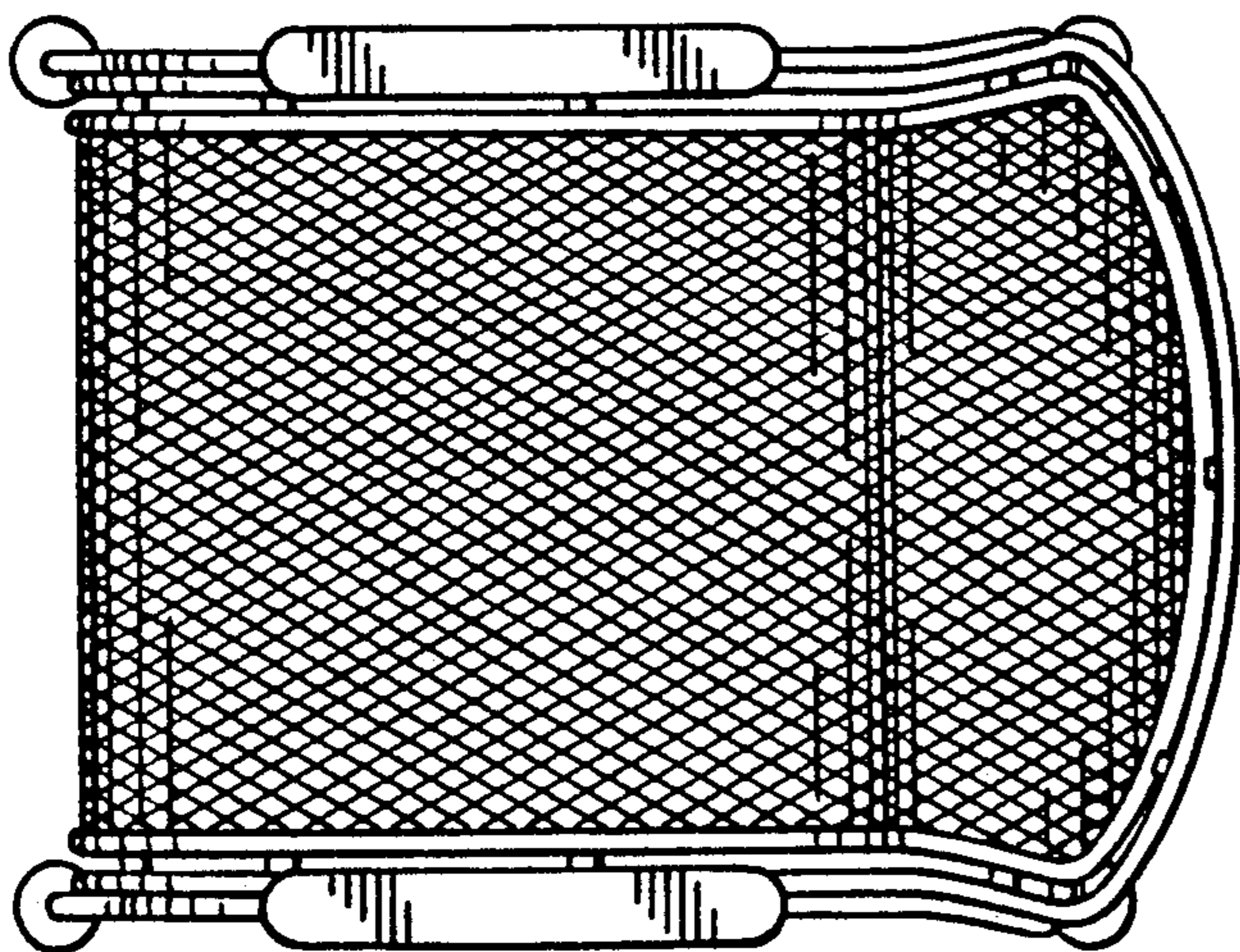

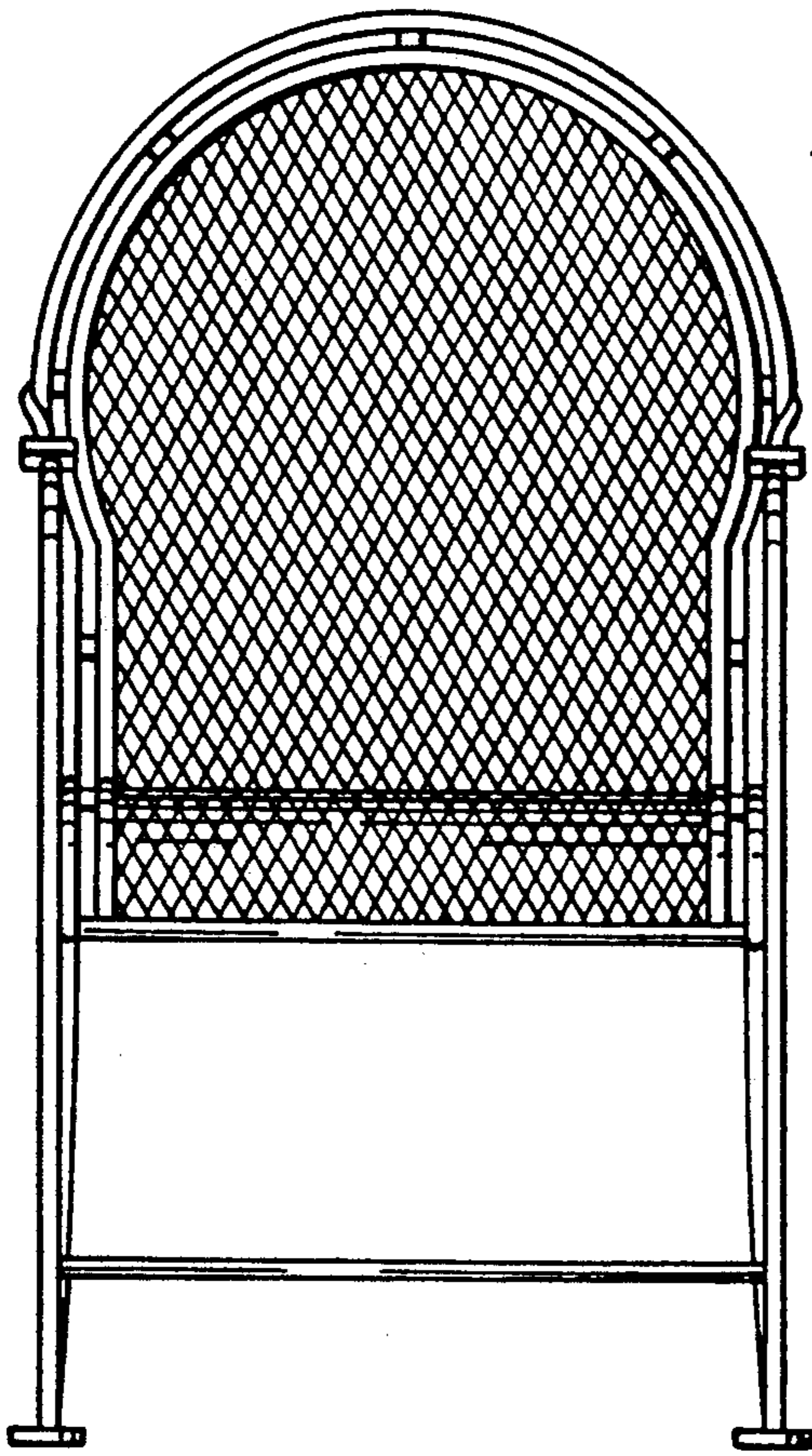

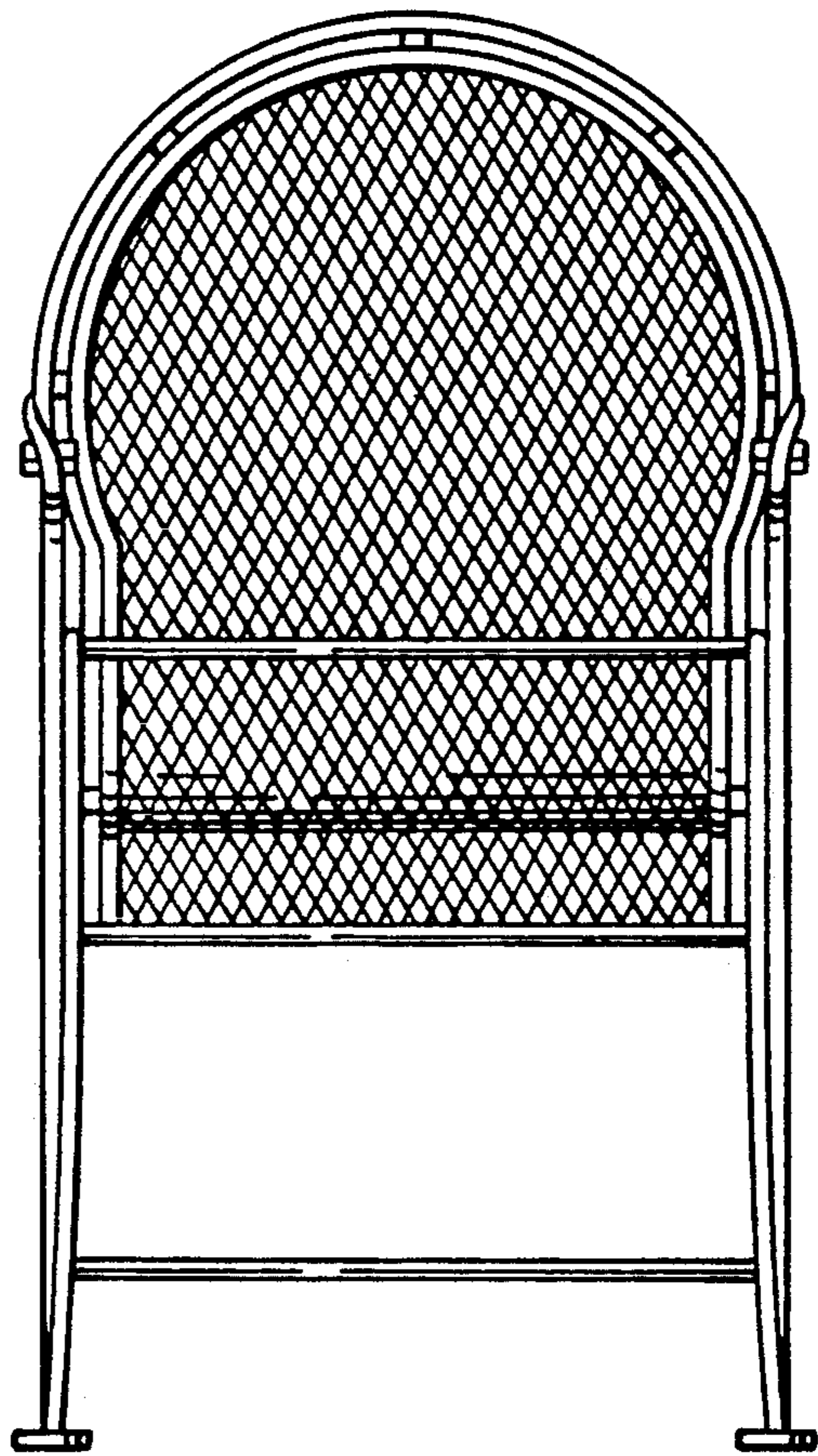

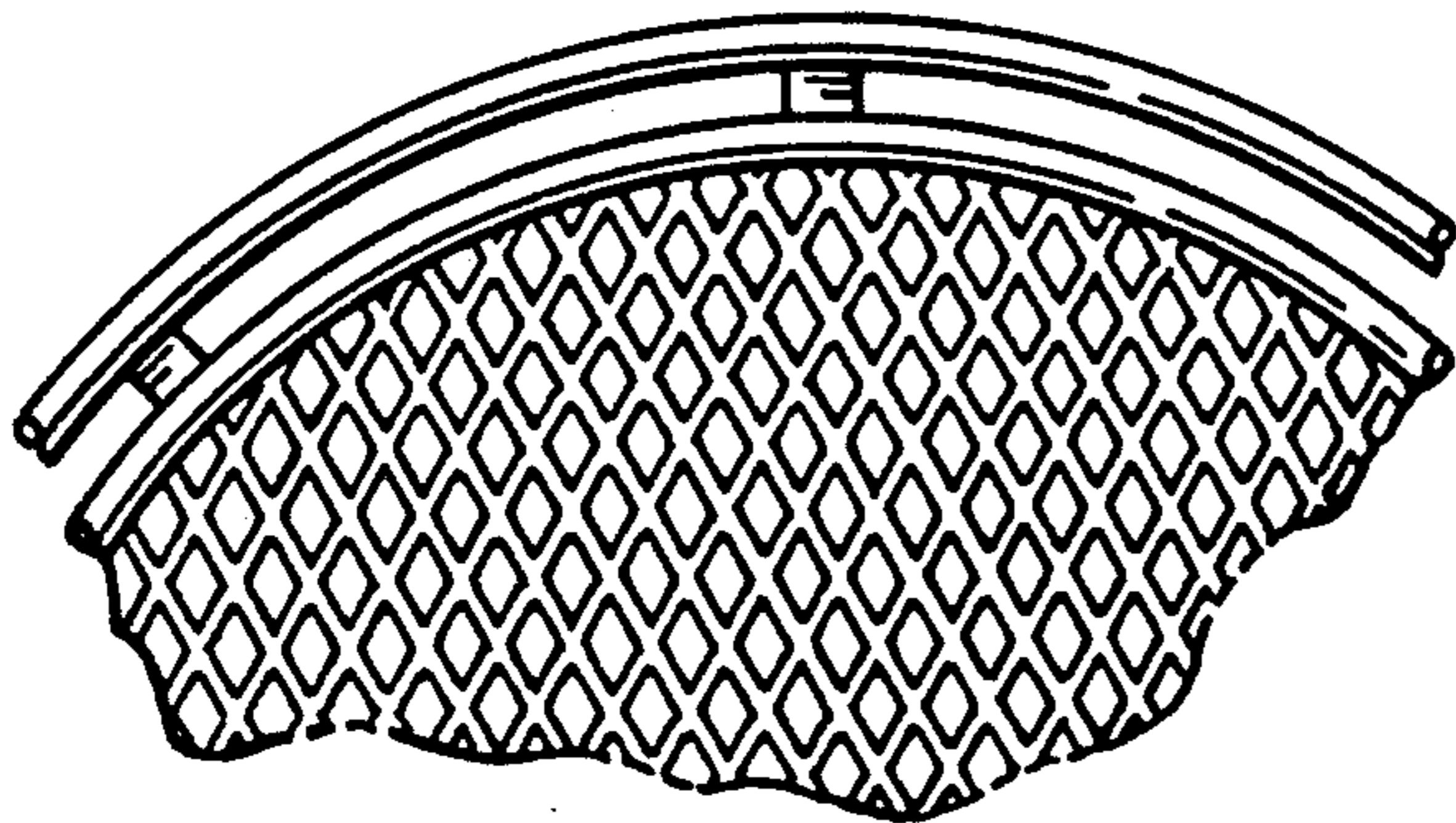
