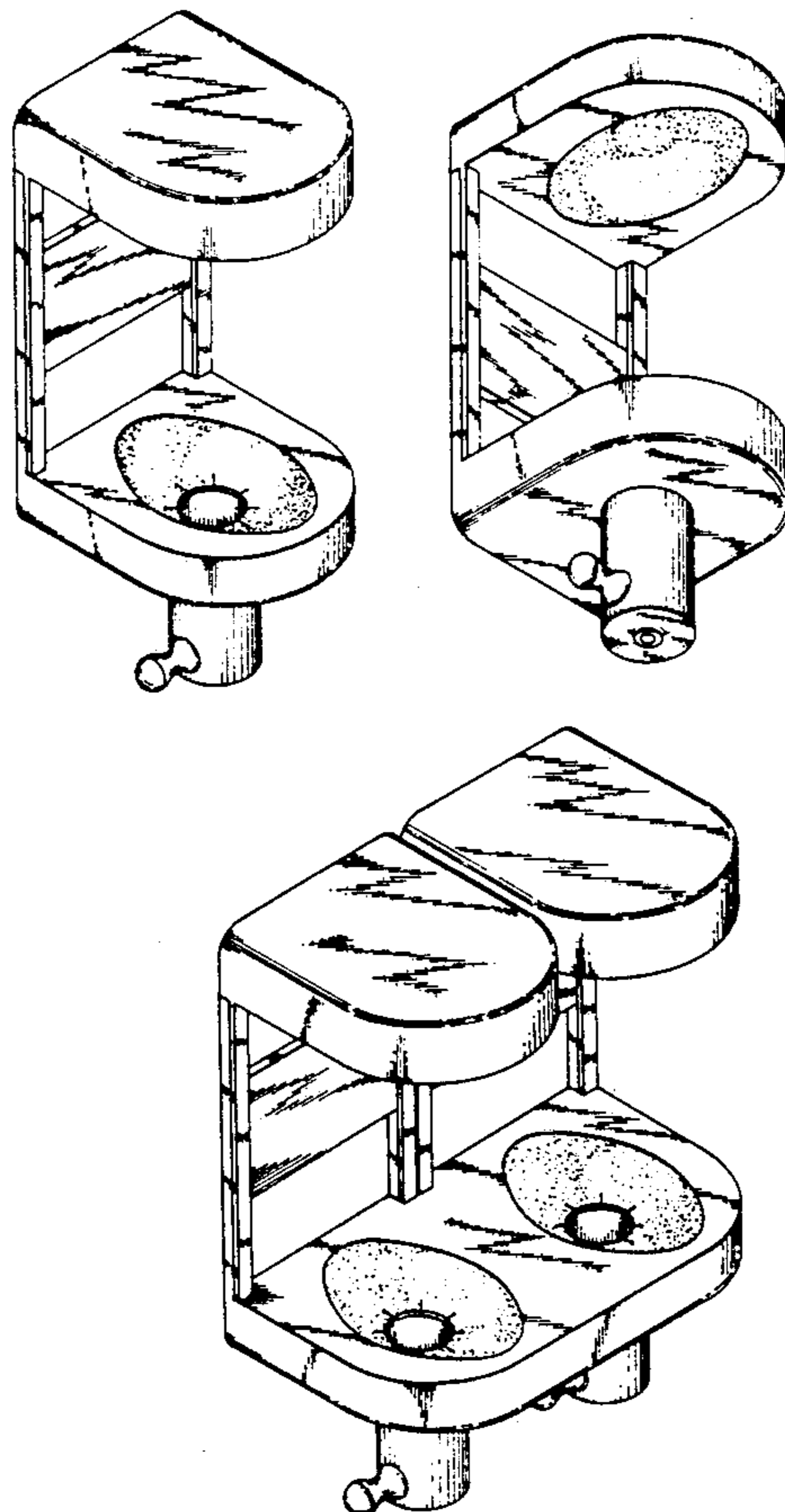

The ornamental design for a shower dispenser for shampoo, as shown and described.



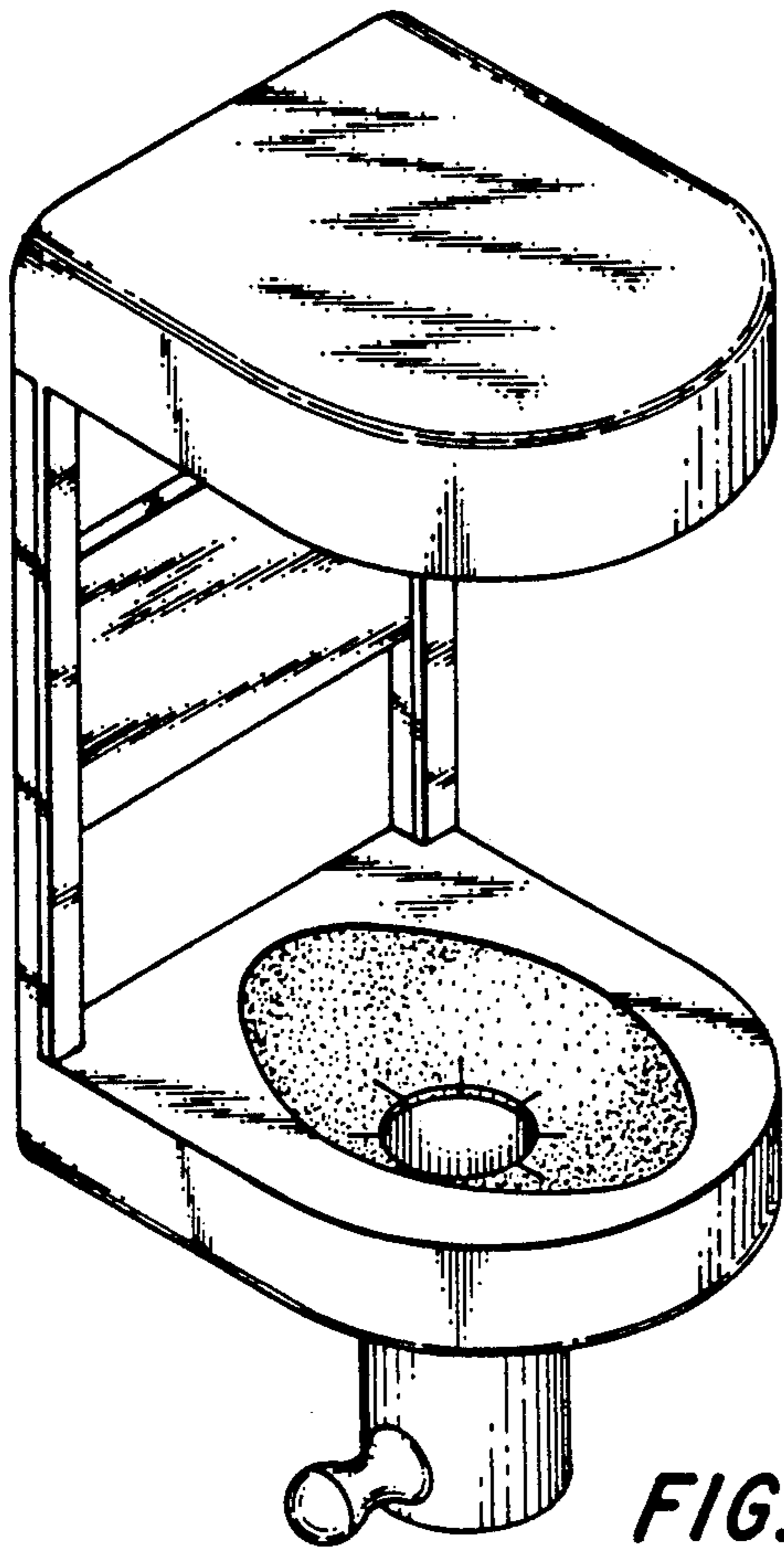

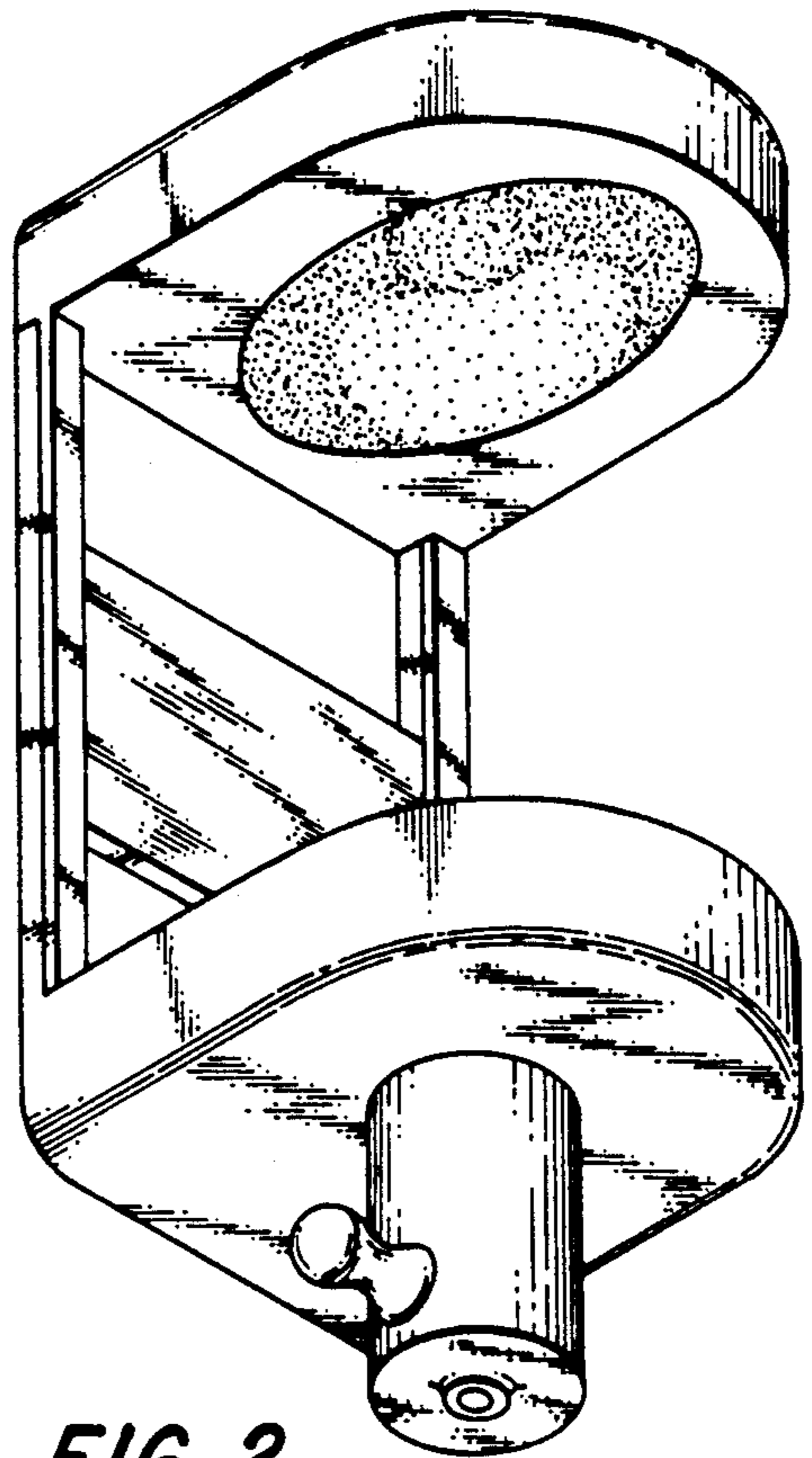

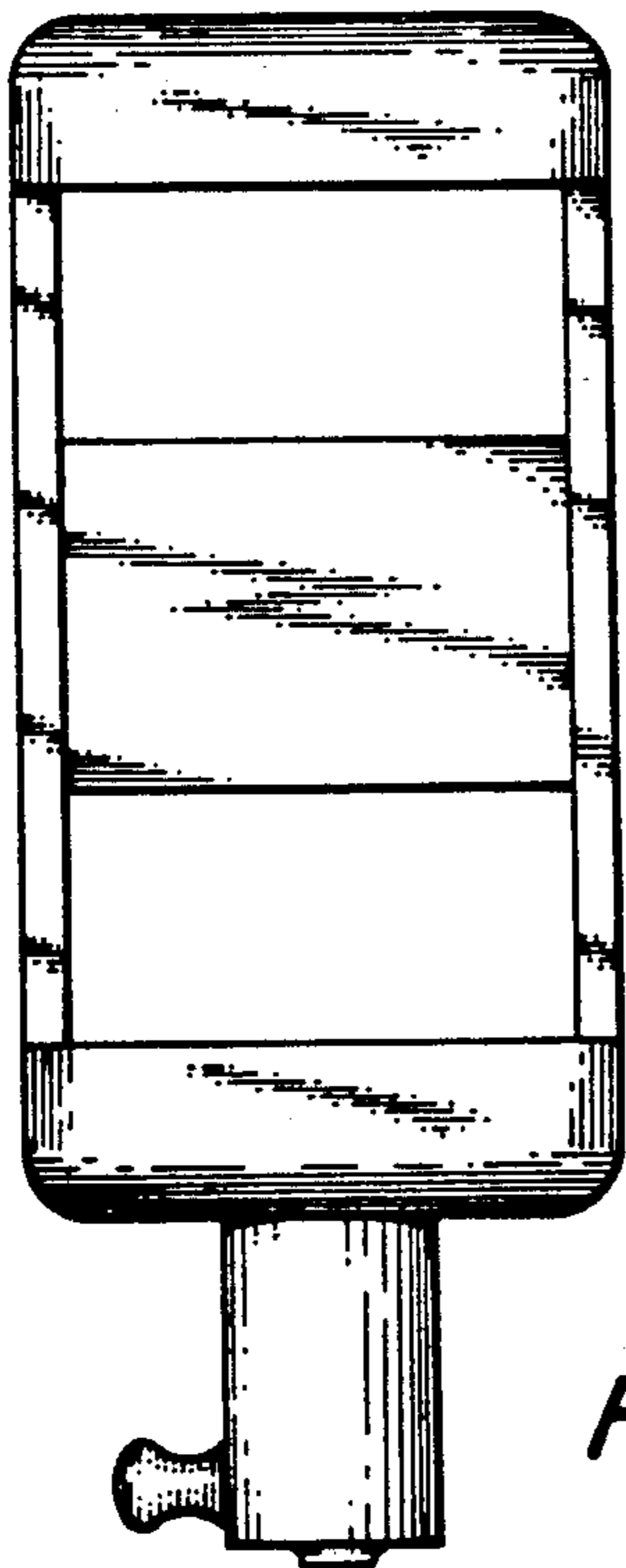

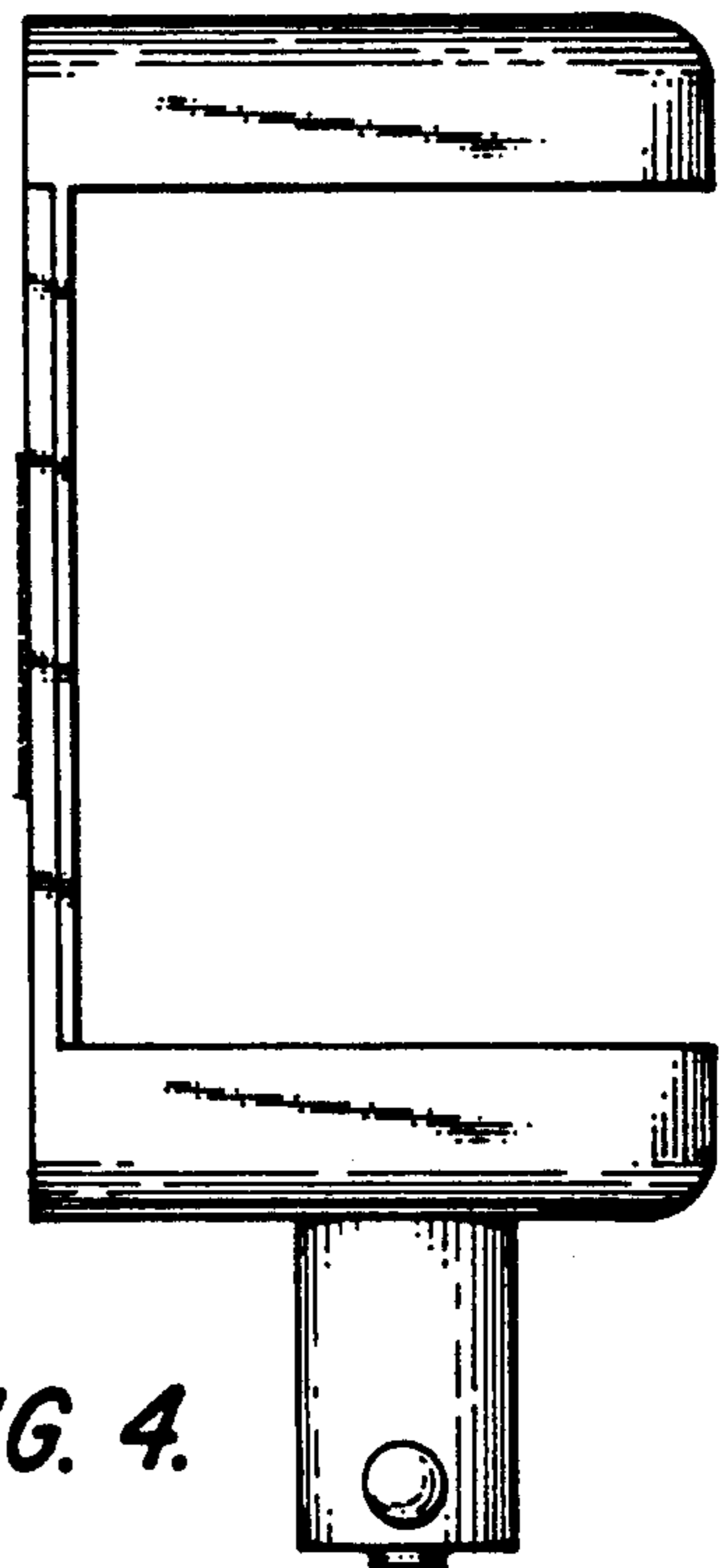

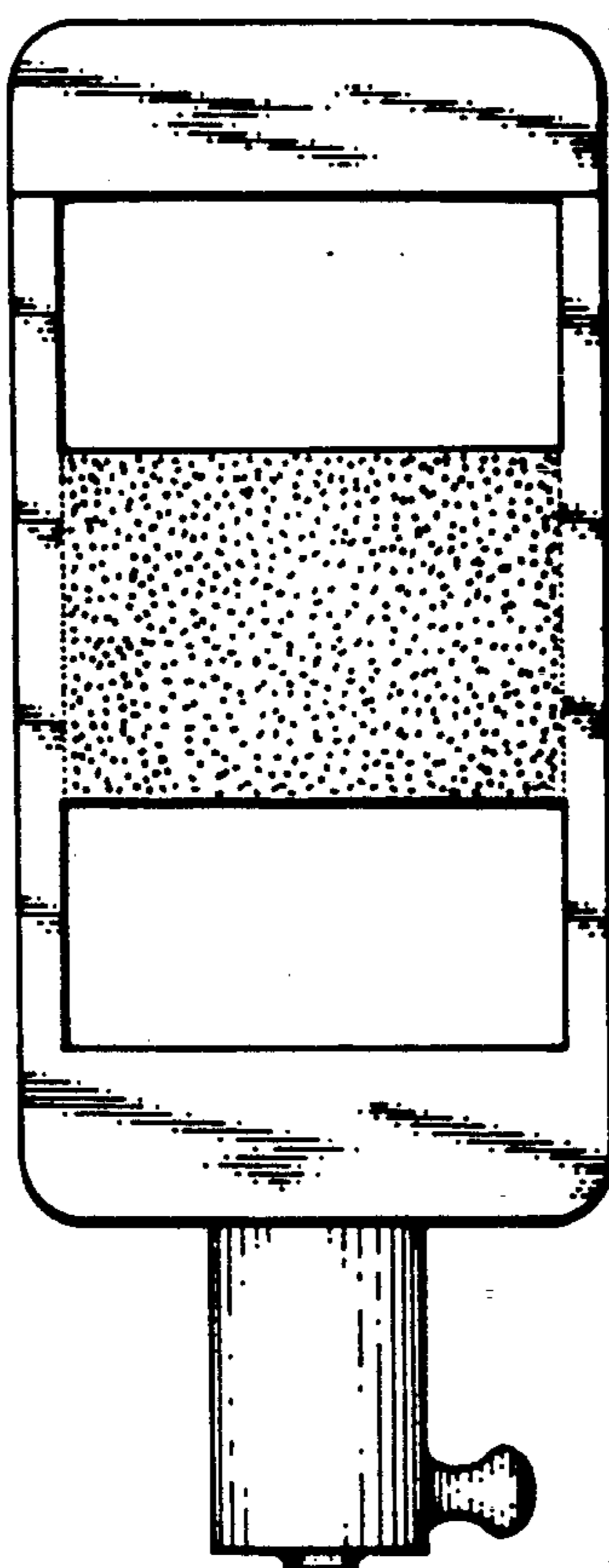

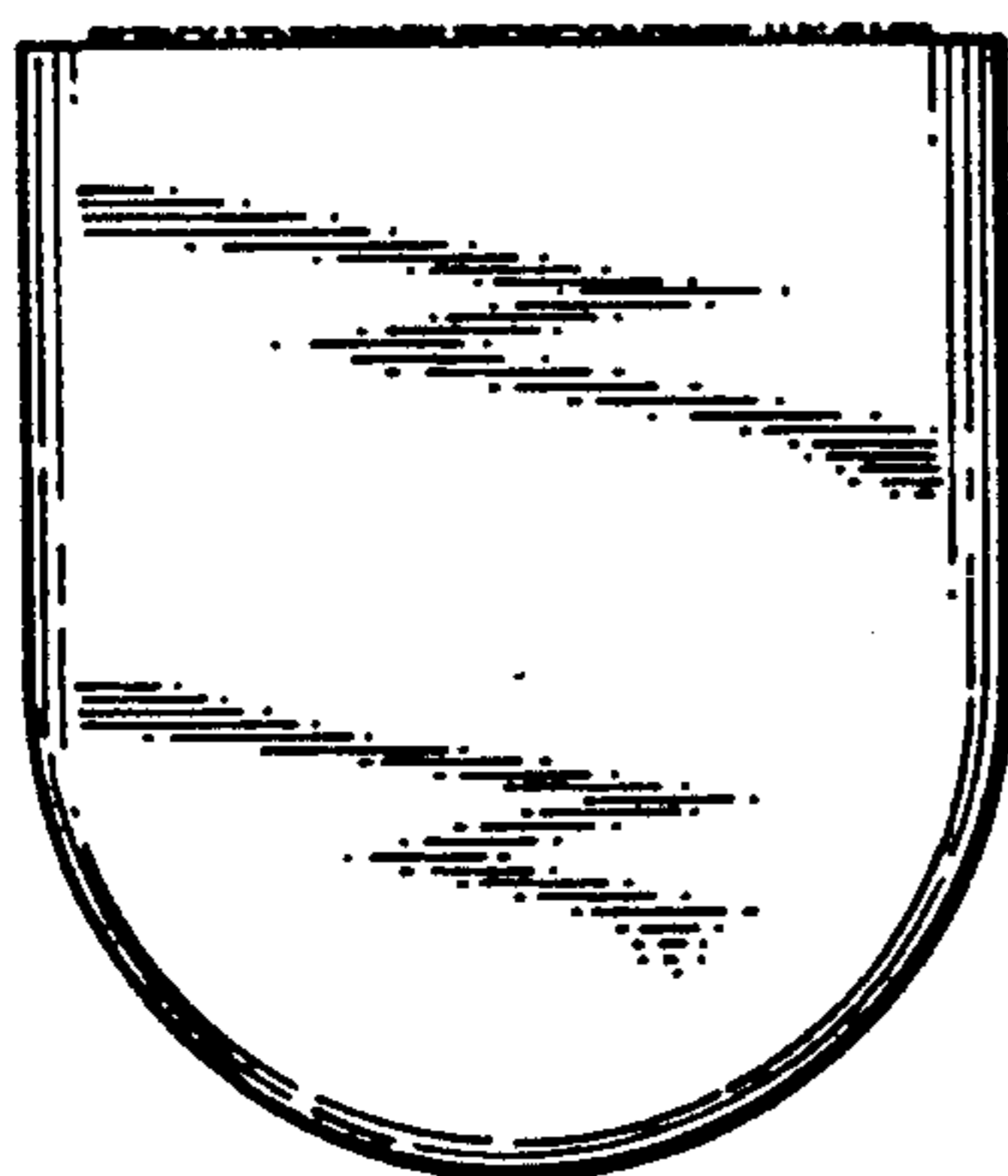

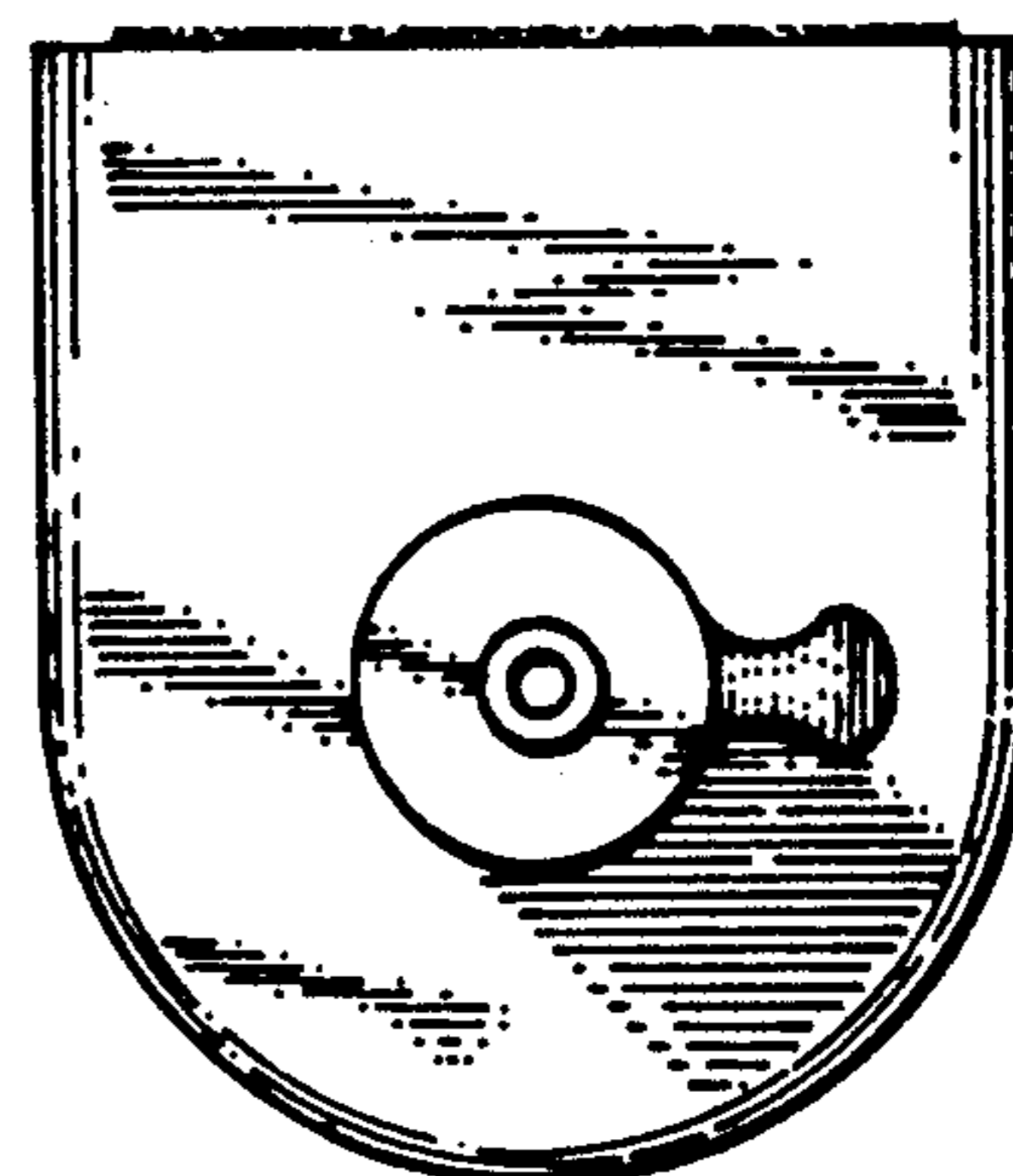

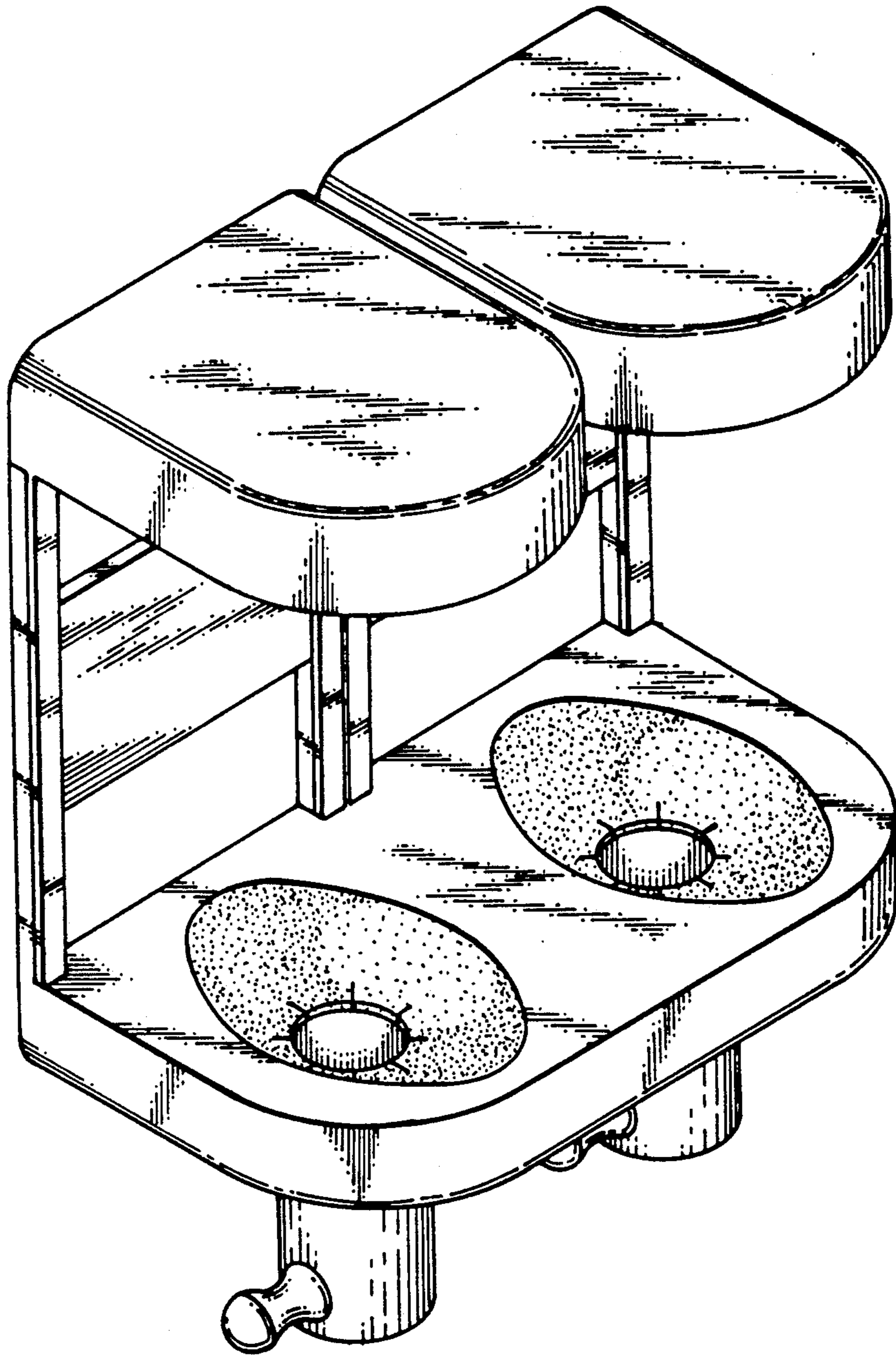

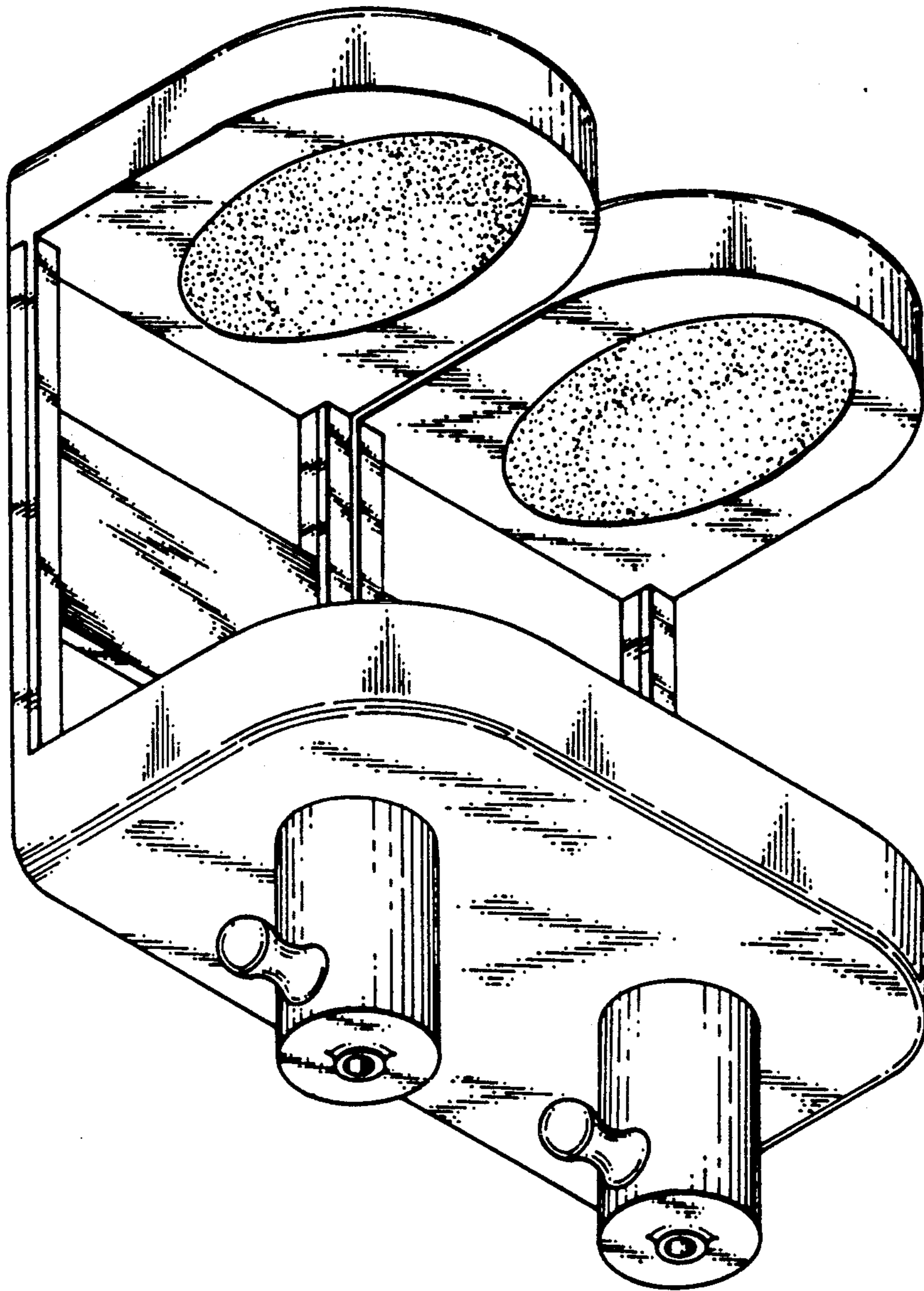

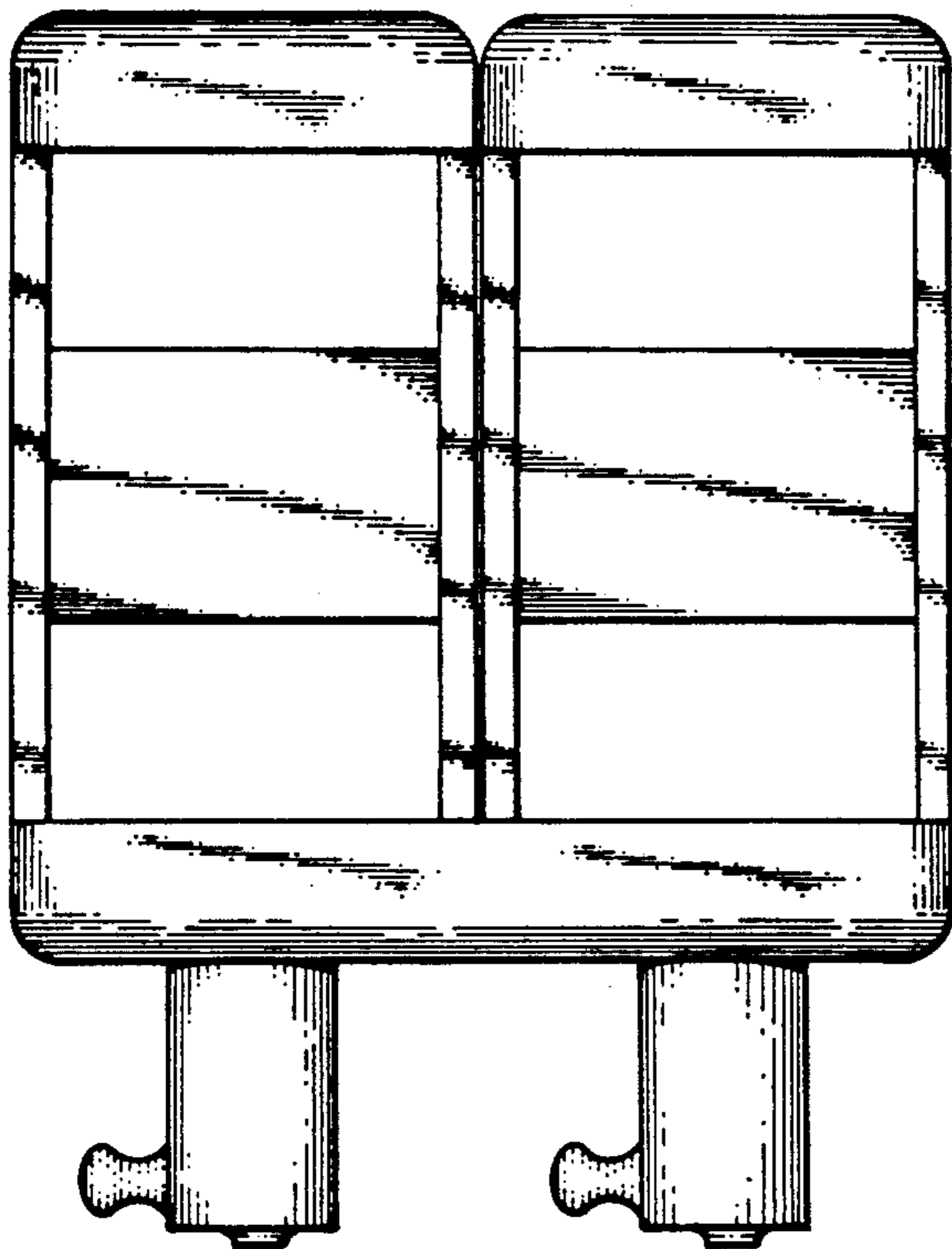

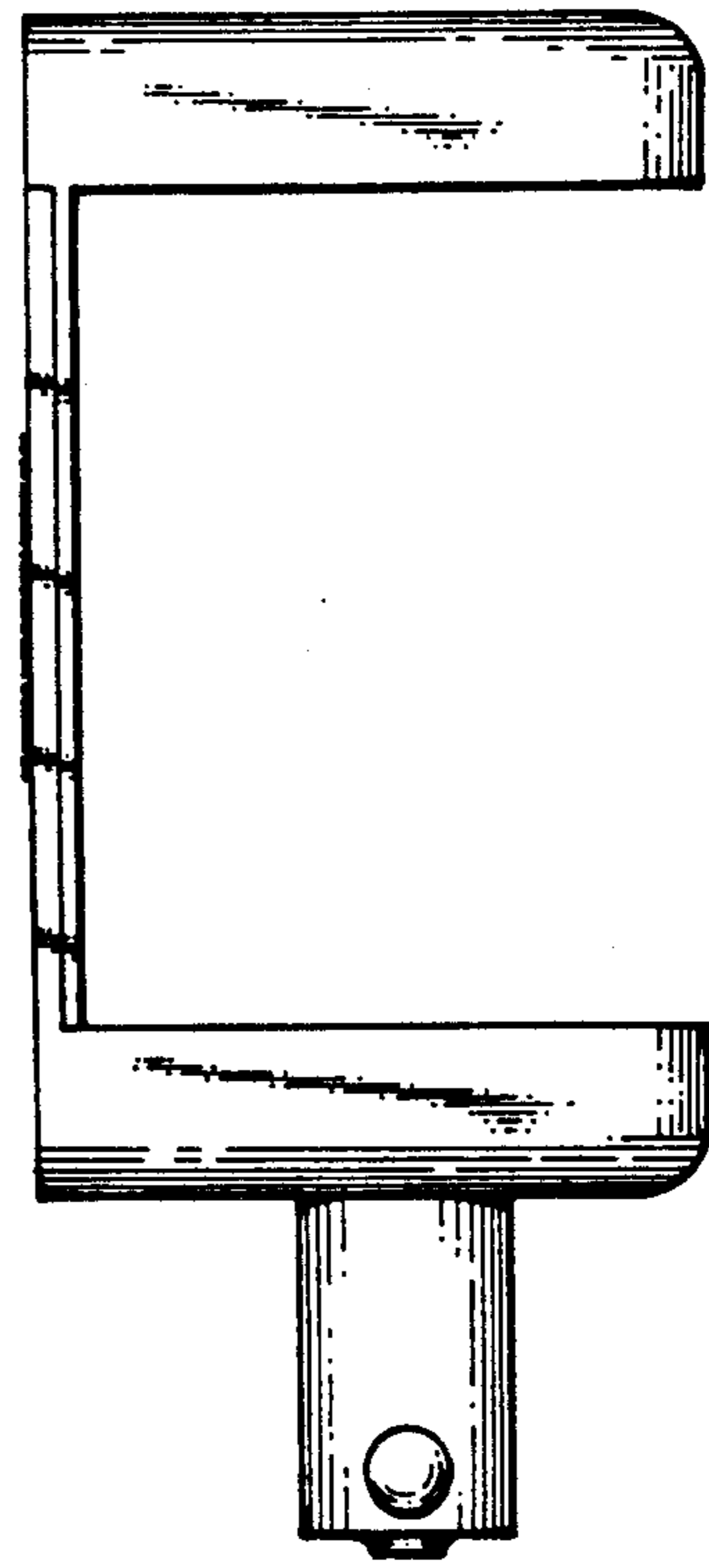

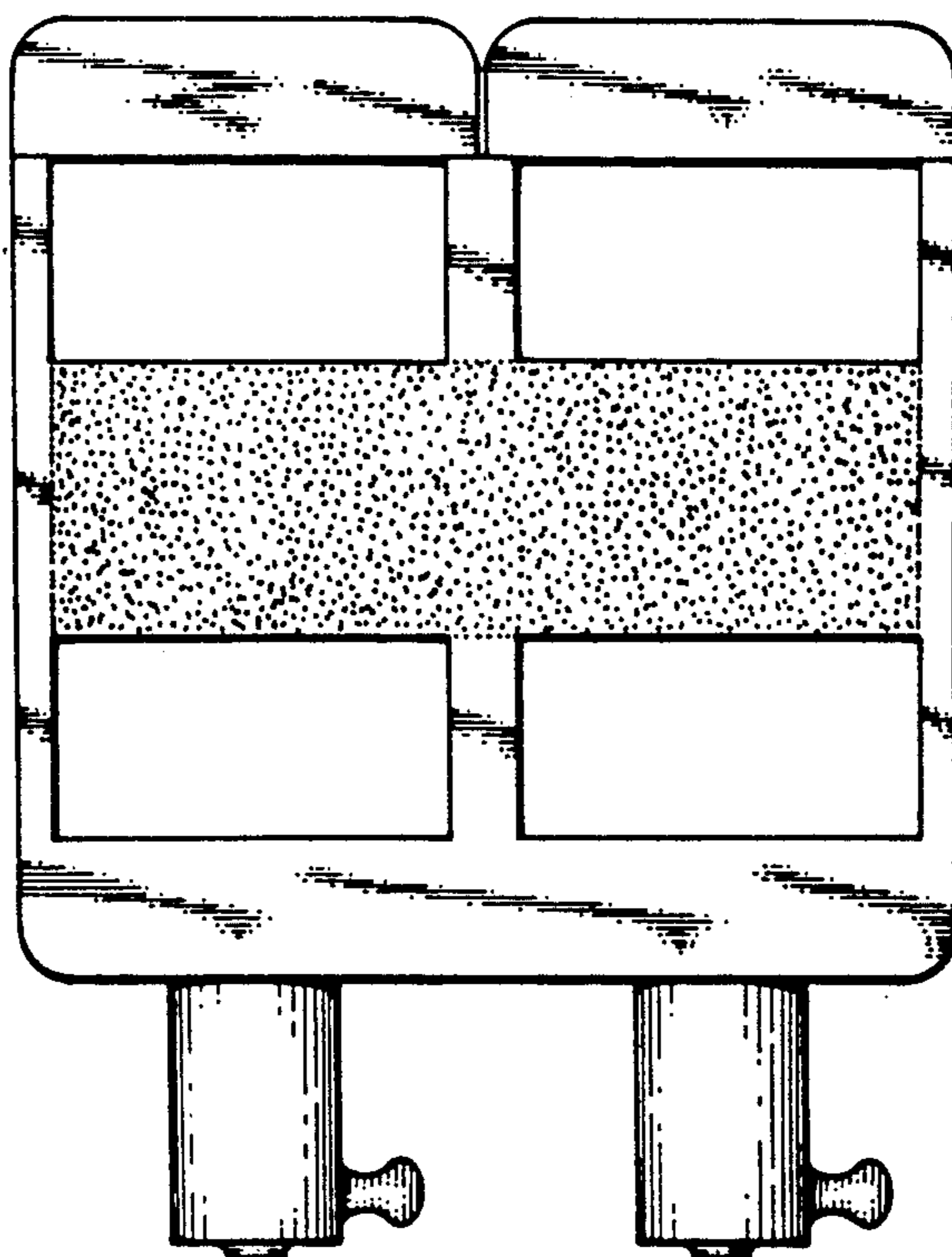

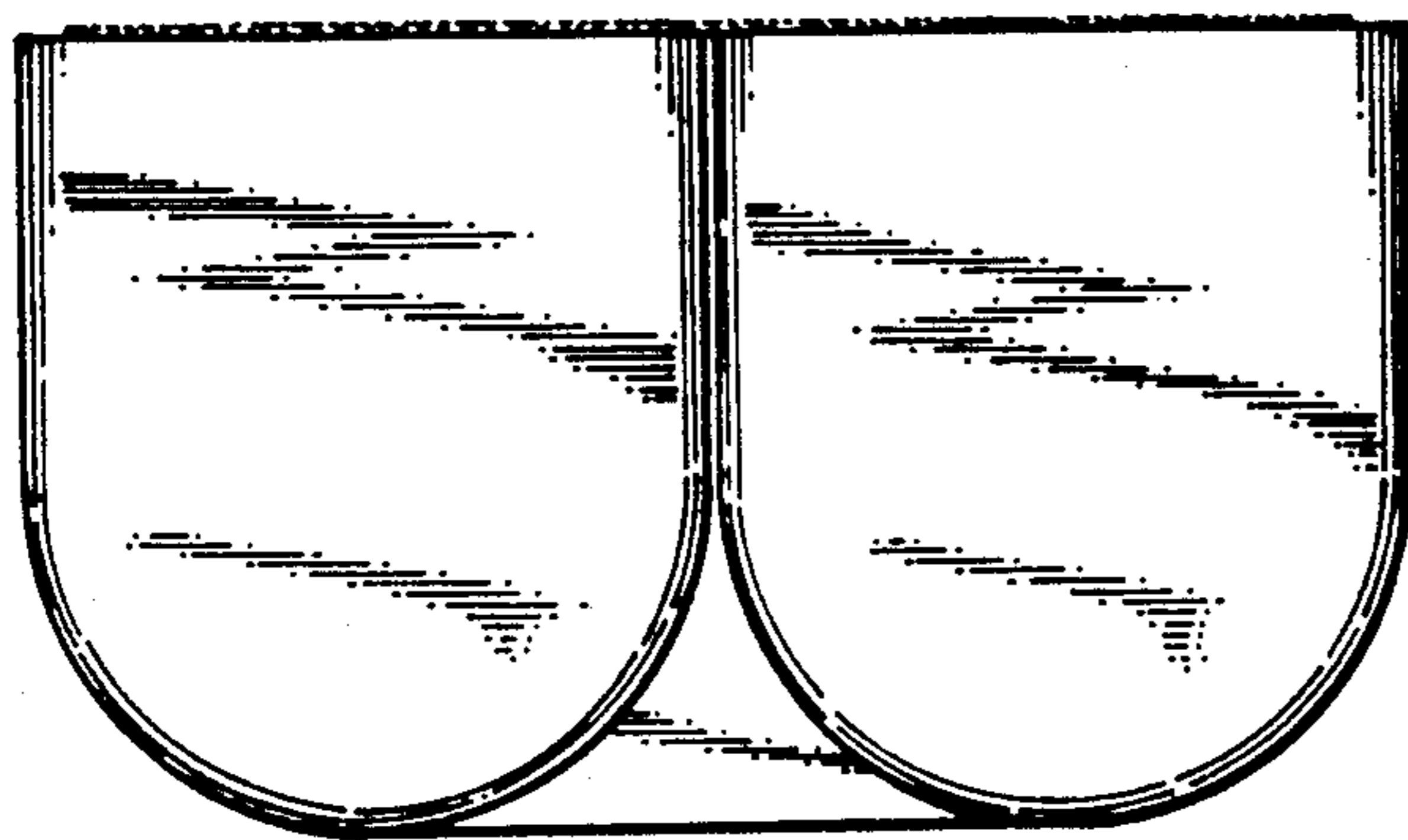

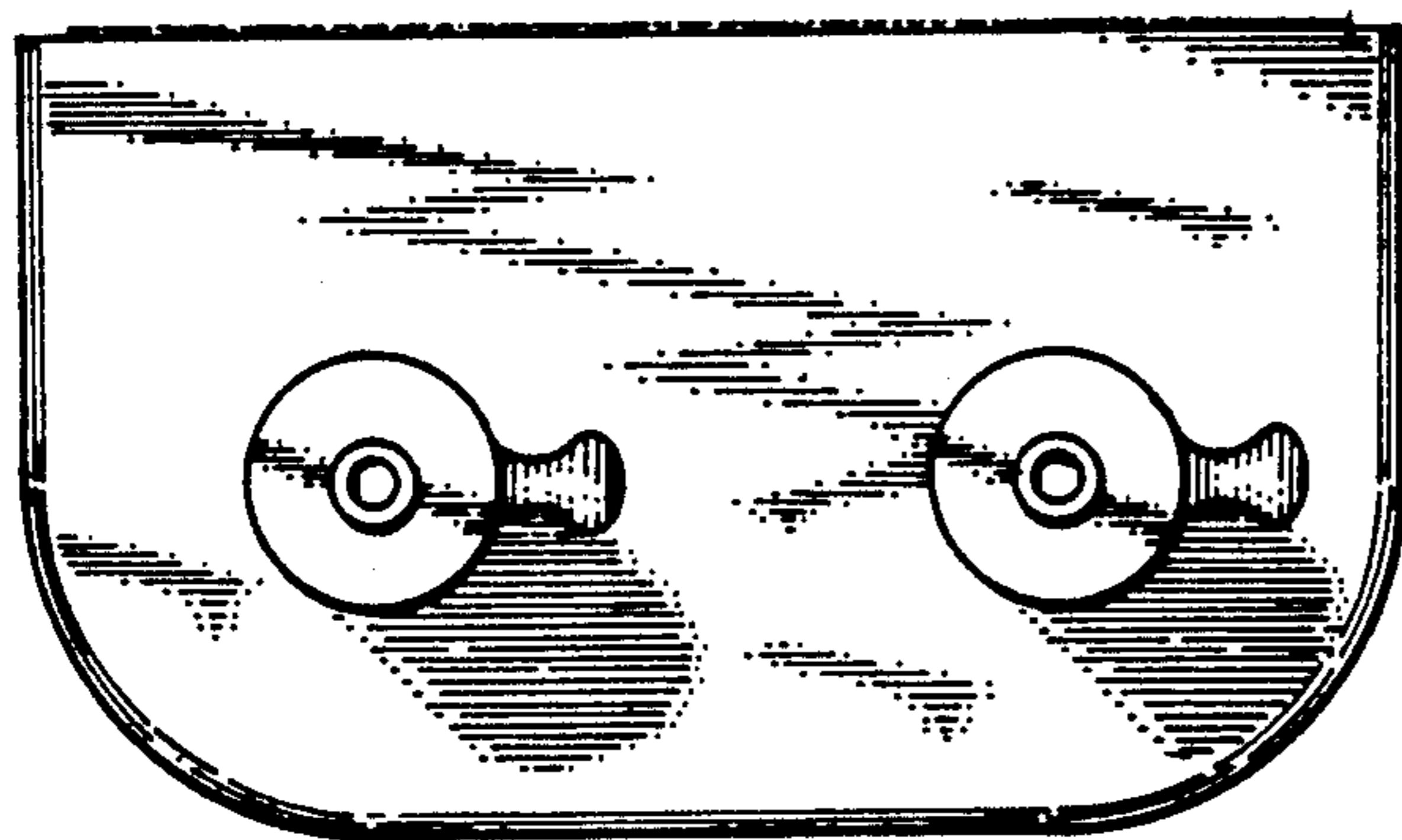

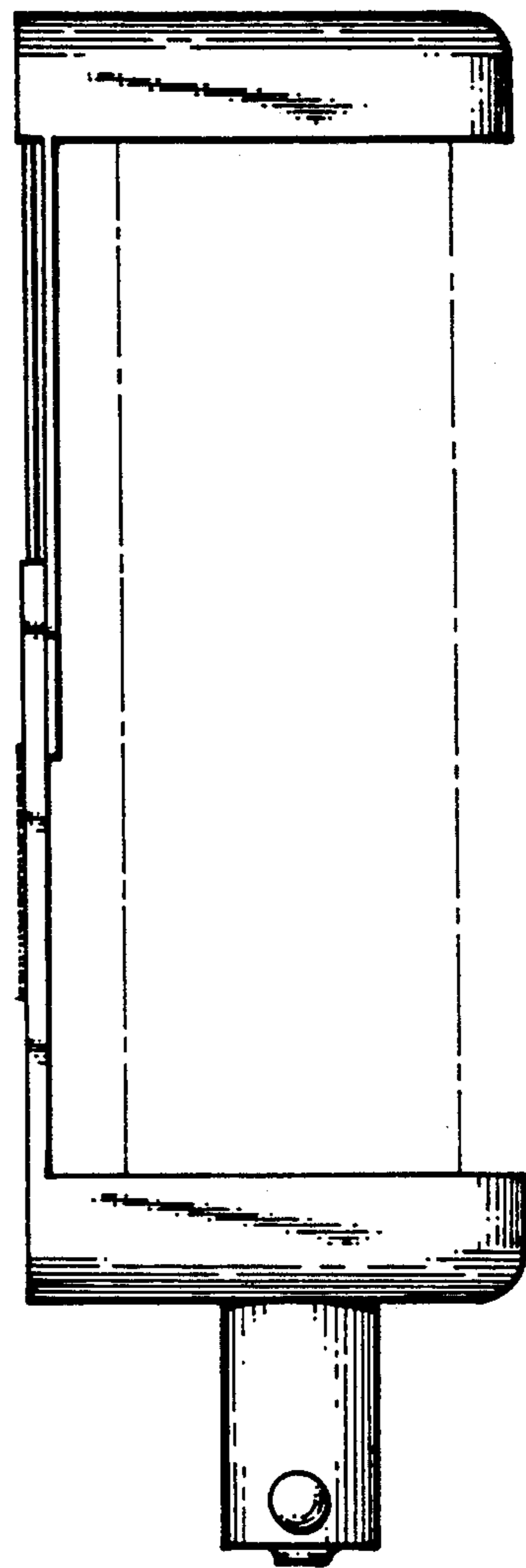
