[57] **CLAIM**

The ornamental design for a divider for bottles or the like, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a divider for bottles or the like showing our new design;  
 FIG. 2 is a top plan view thereof;  
 FIG. 3 is a bottom plan view thereof;  
 FIG. 4 is a front elevation thereof; the rear elevation being a mirror image thereof;  
 FIG. 5 is a left side elevation thereof; the right side elevation being a mirror image thereof;  
 FIG. 6 is a perspective view of a second embodiment of FIG. 1;  
 FIG. 7 is a top plan view of FIG. 6;  
 FIG. 8 is a bottom plan view of FIG. 6.  
 FIG. 9 is a front elevation of FIG. 6; the rear elevational being a mirror image thereof;  
 FIG. 10 is a left side elevation of FIG. 6; the right side elevation being a mirror image thereof;  
 FIG. 11 is a perspective view of a third embodiment of FIG. 1;  
 FIG. 12 is a top plan view of FIG. 11;  
 FIG. 13 is a bottom plan view of FIG. 11;  
 FIG. 14 is a front elevation of FIG. 11; the rear elevation being a mirror image thereof; and,  
 FIG. 15 is a left side elevation of FIG. 11; the right side elevation being a mirror image thereof.

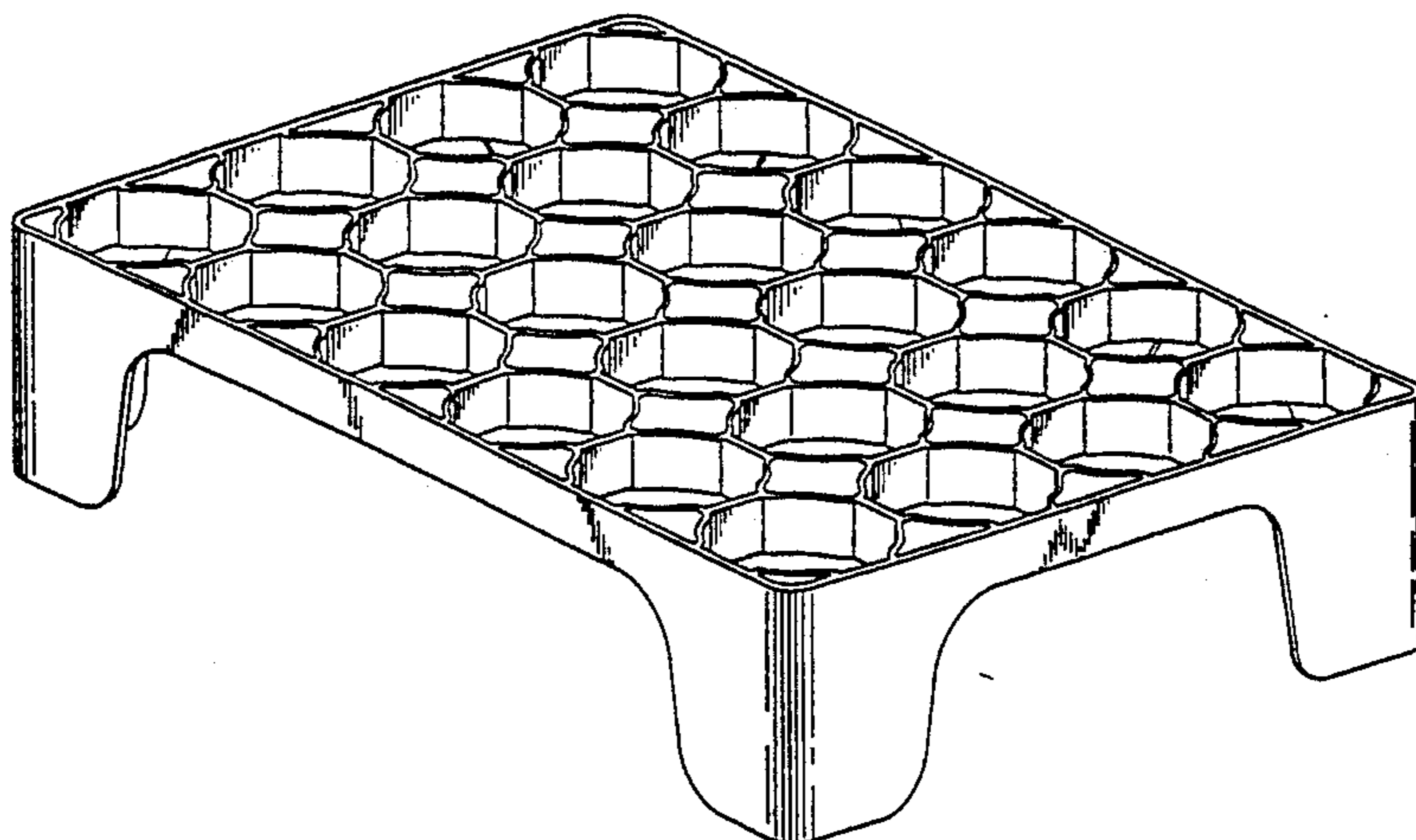

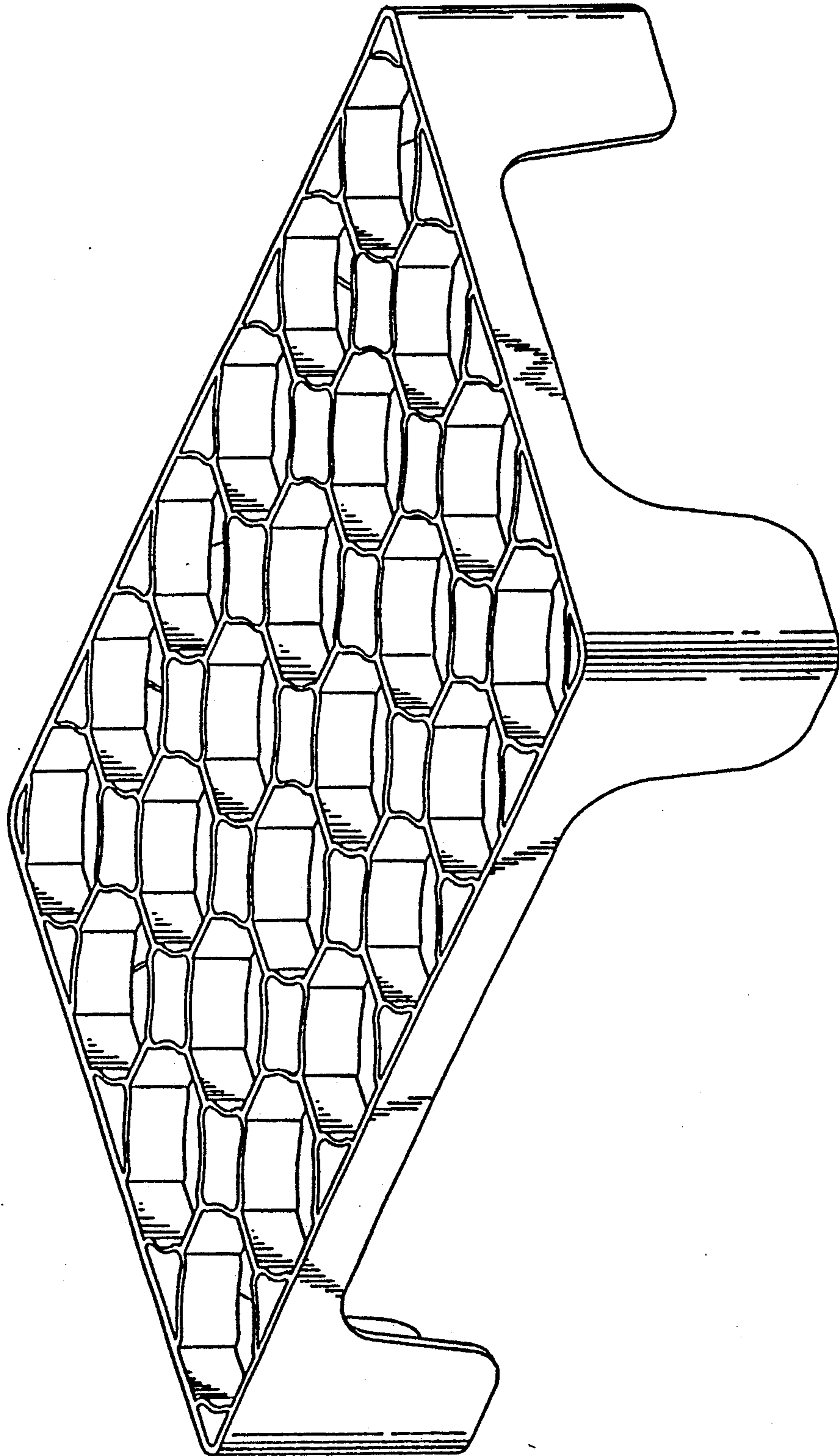

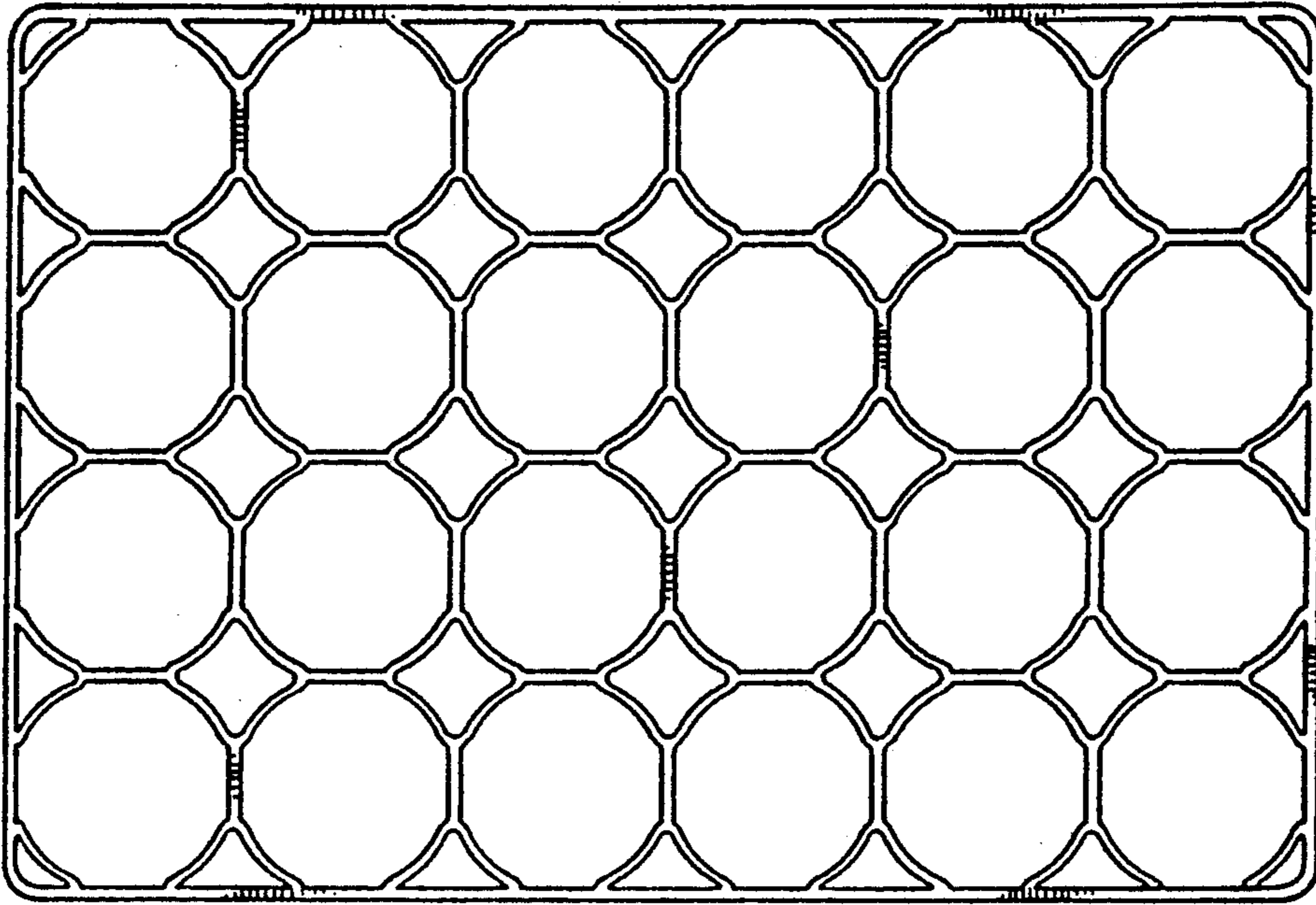

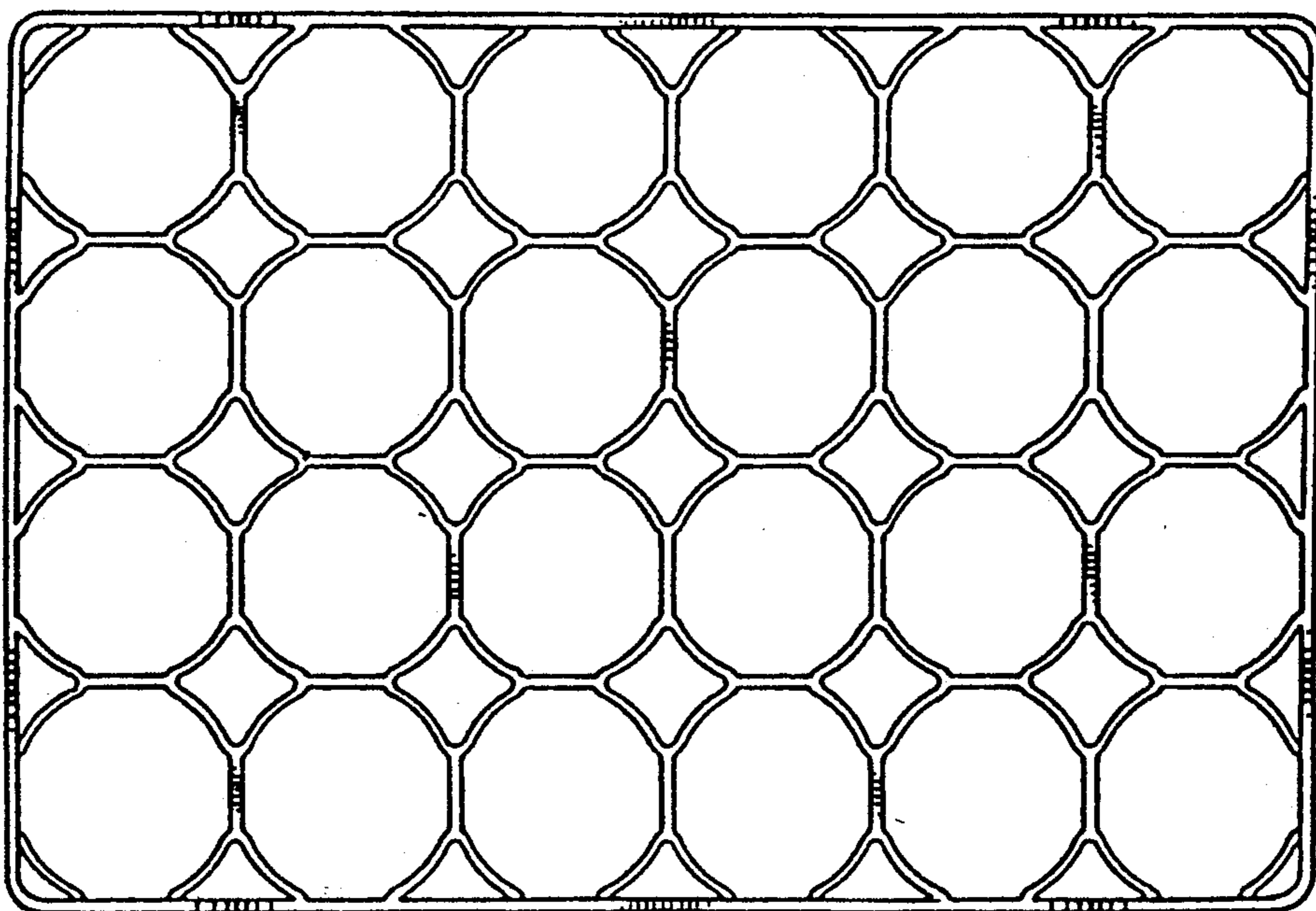

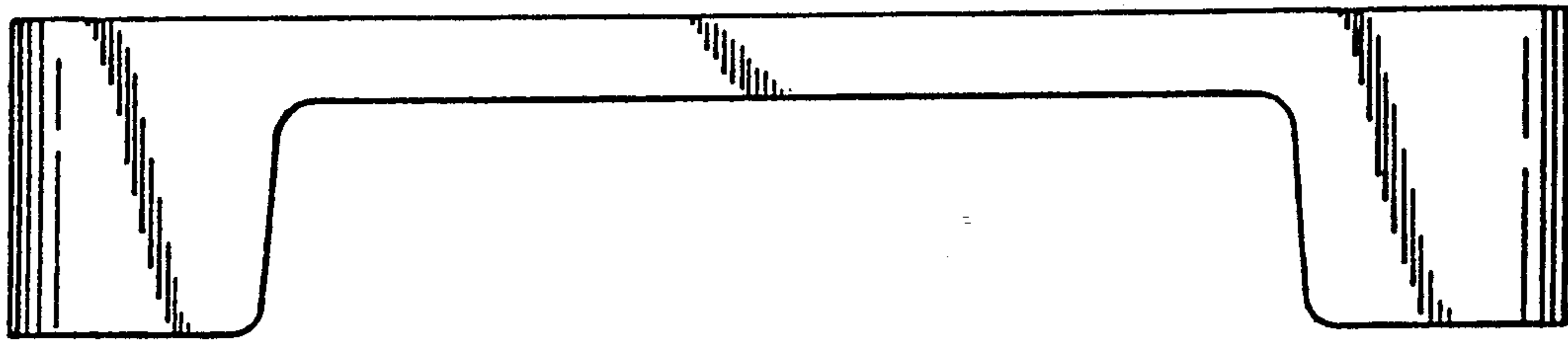

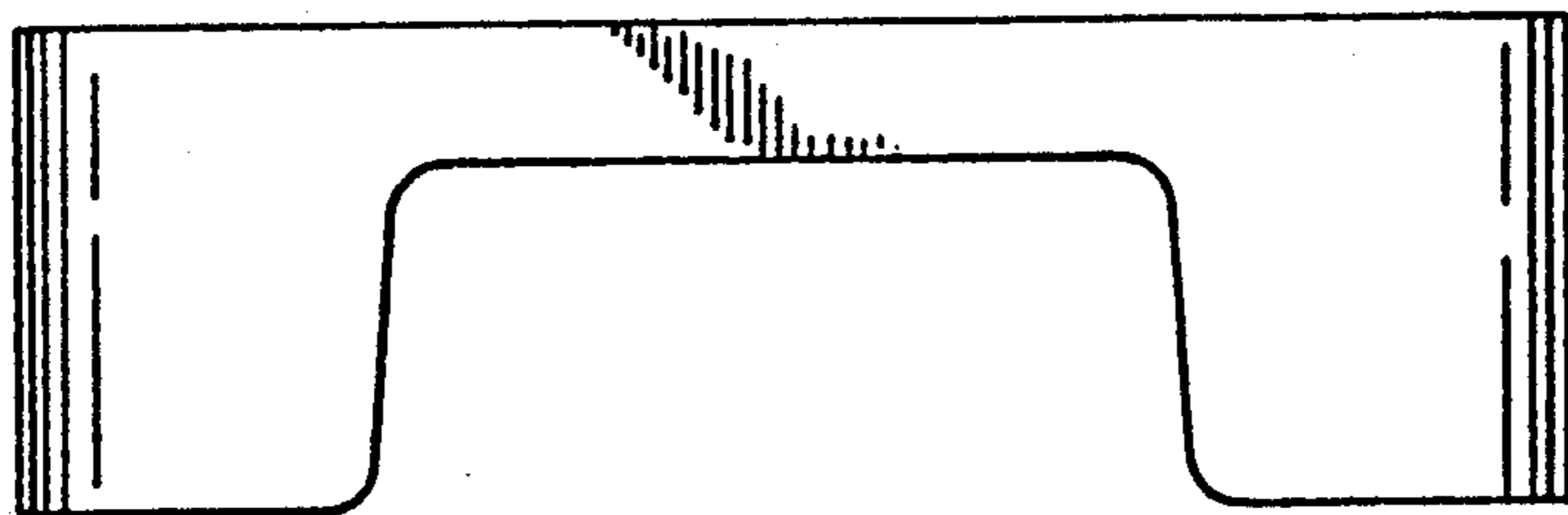

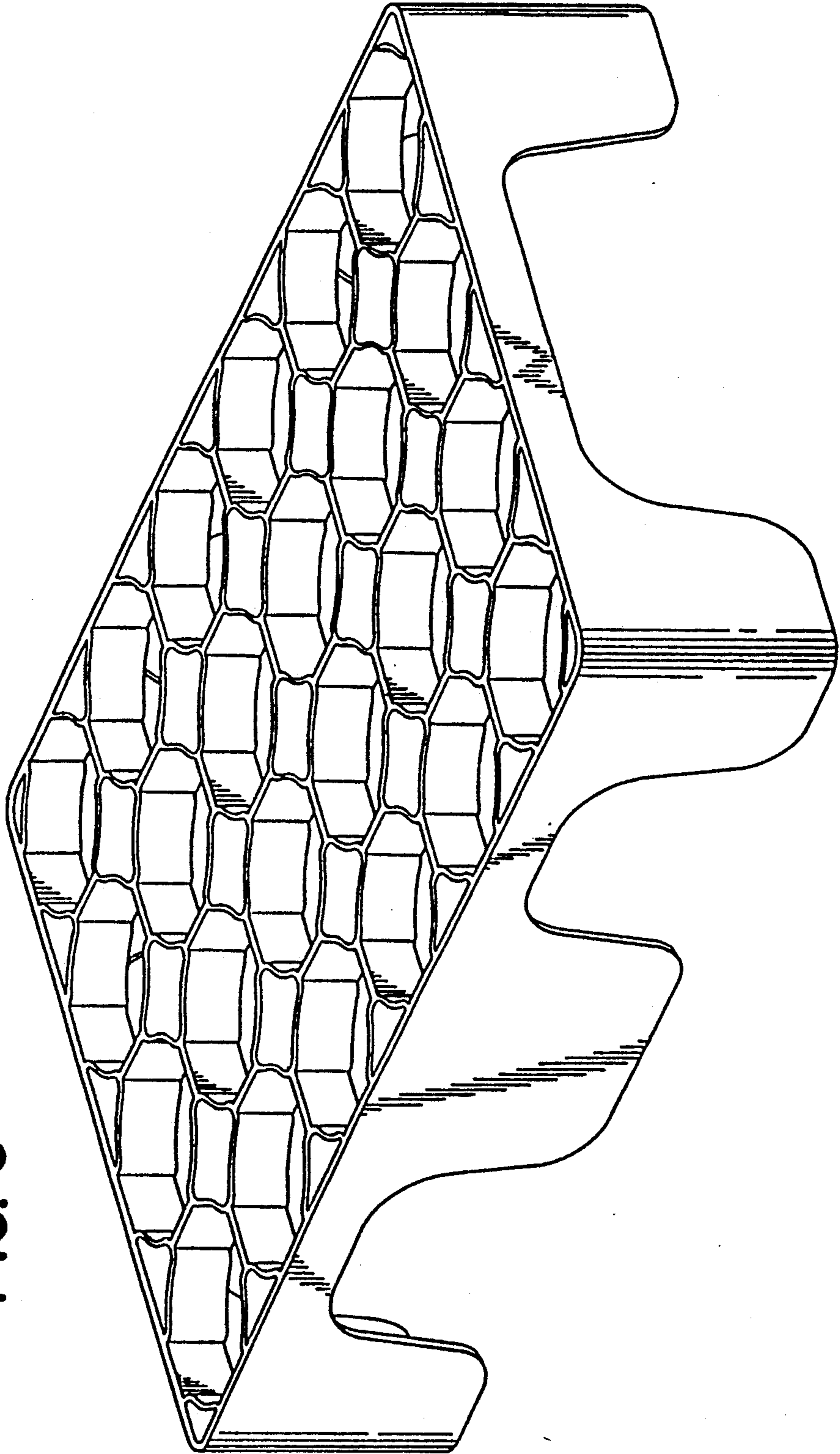

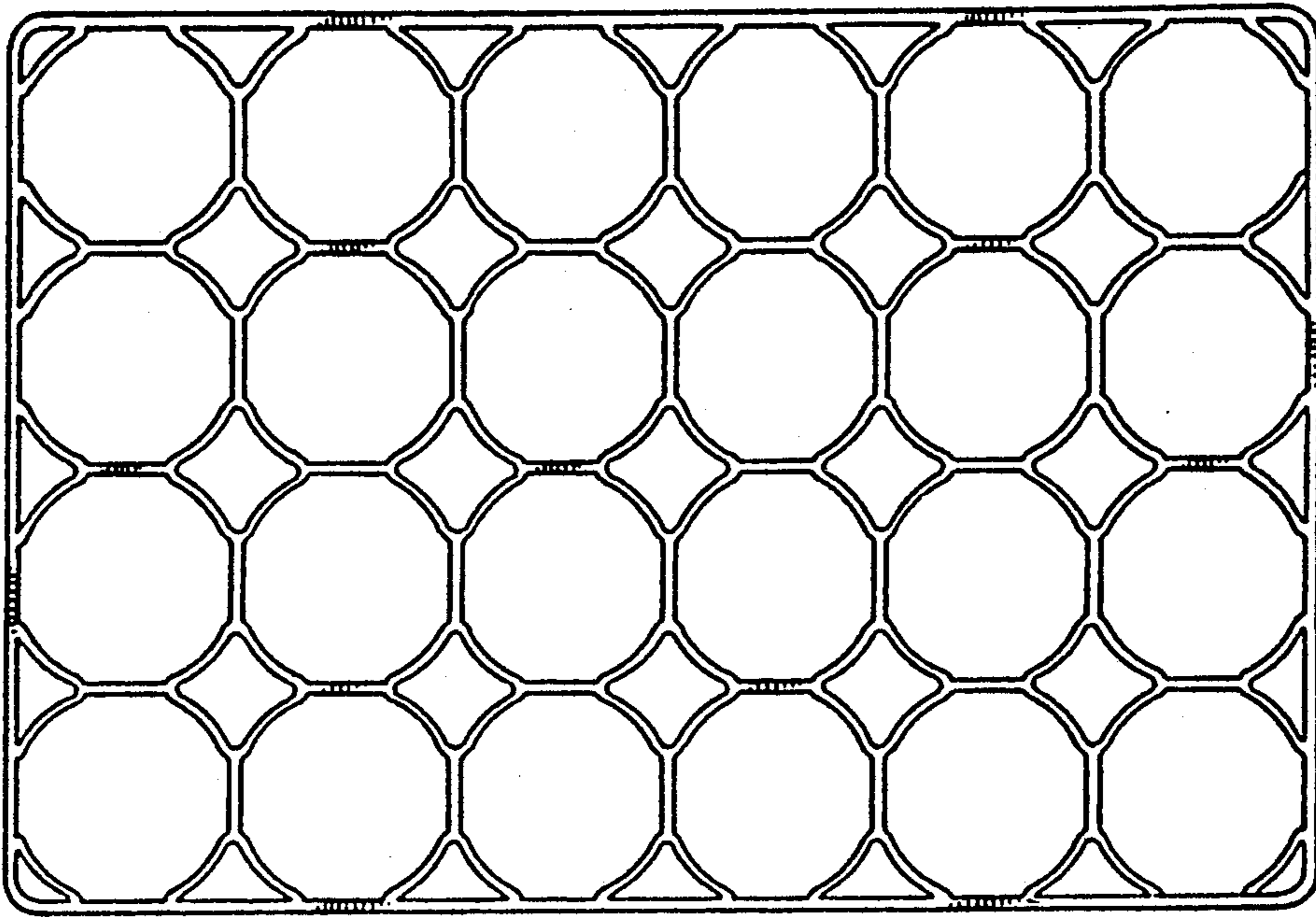

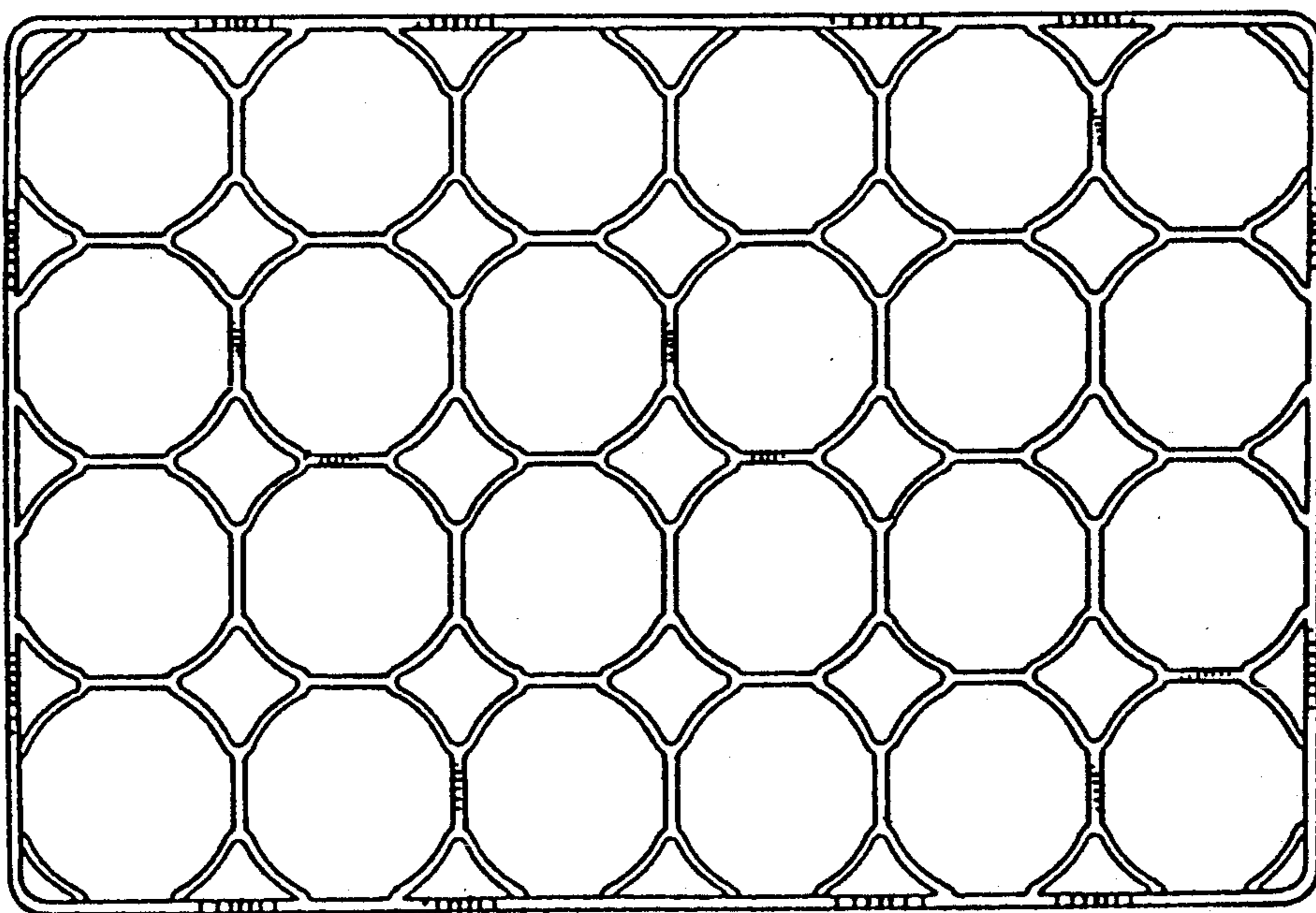

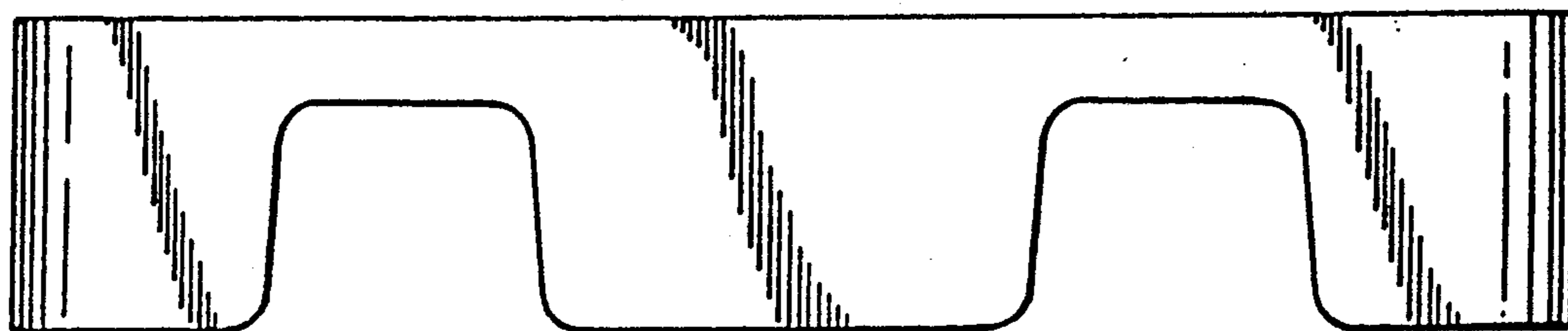

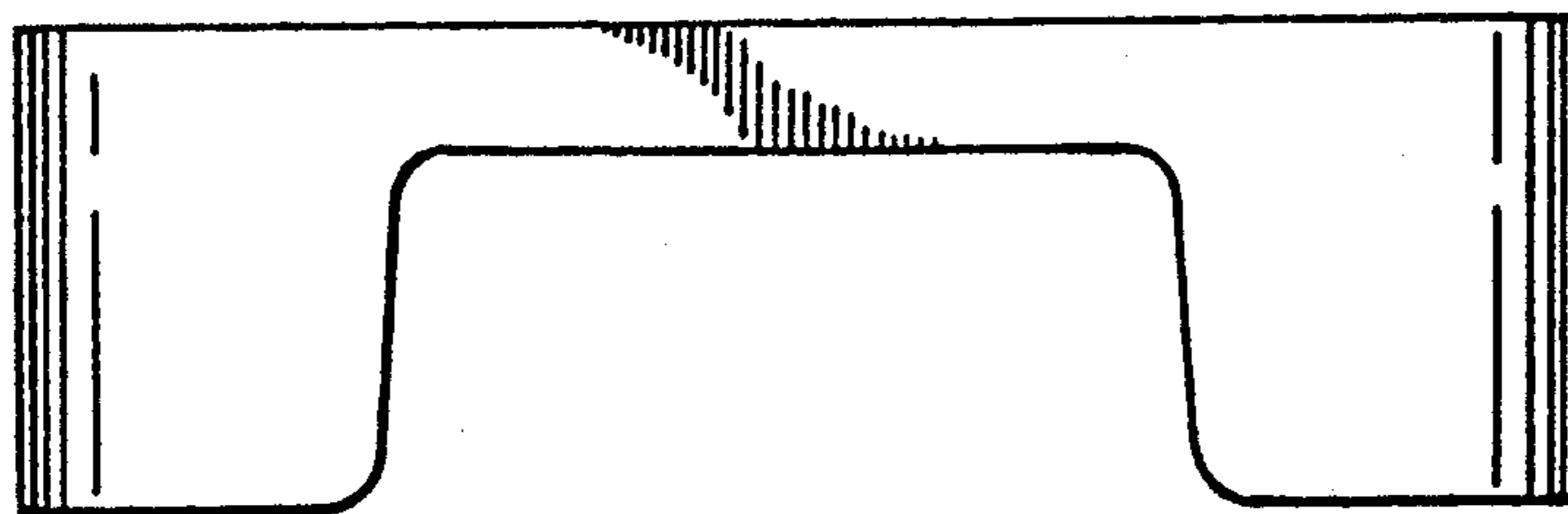

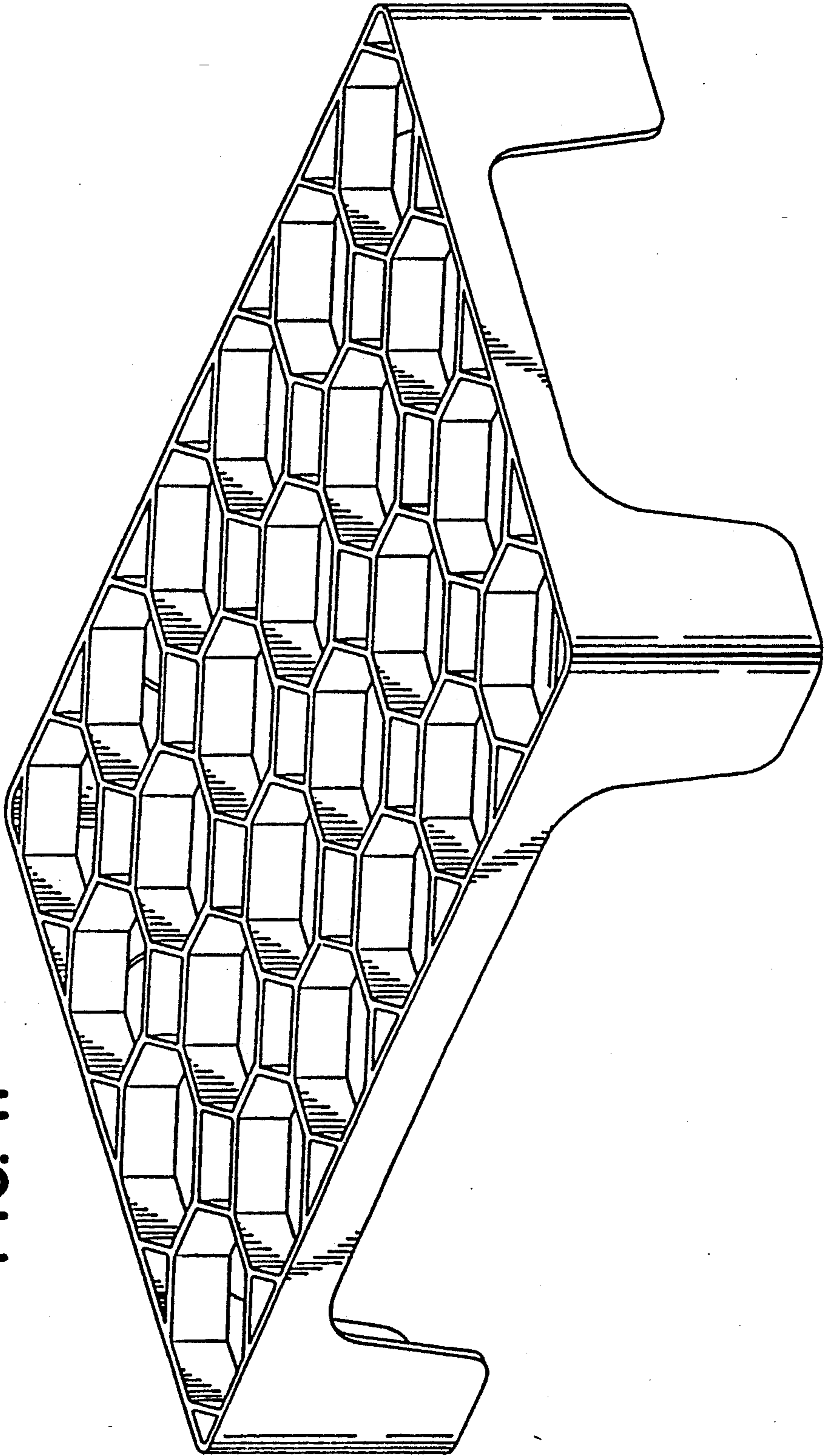

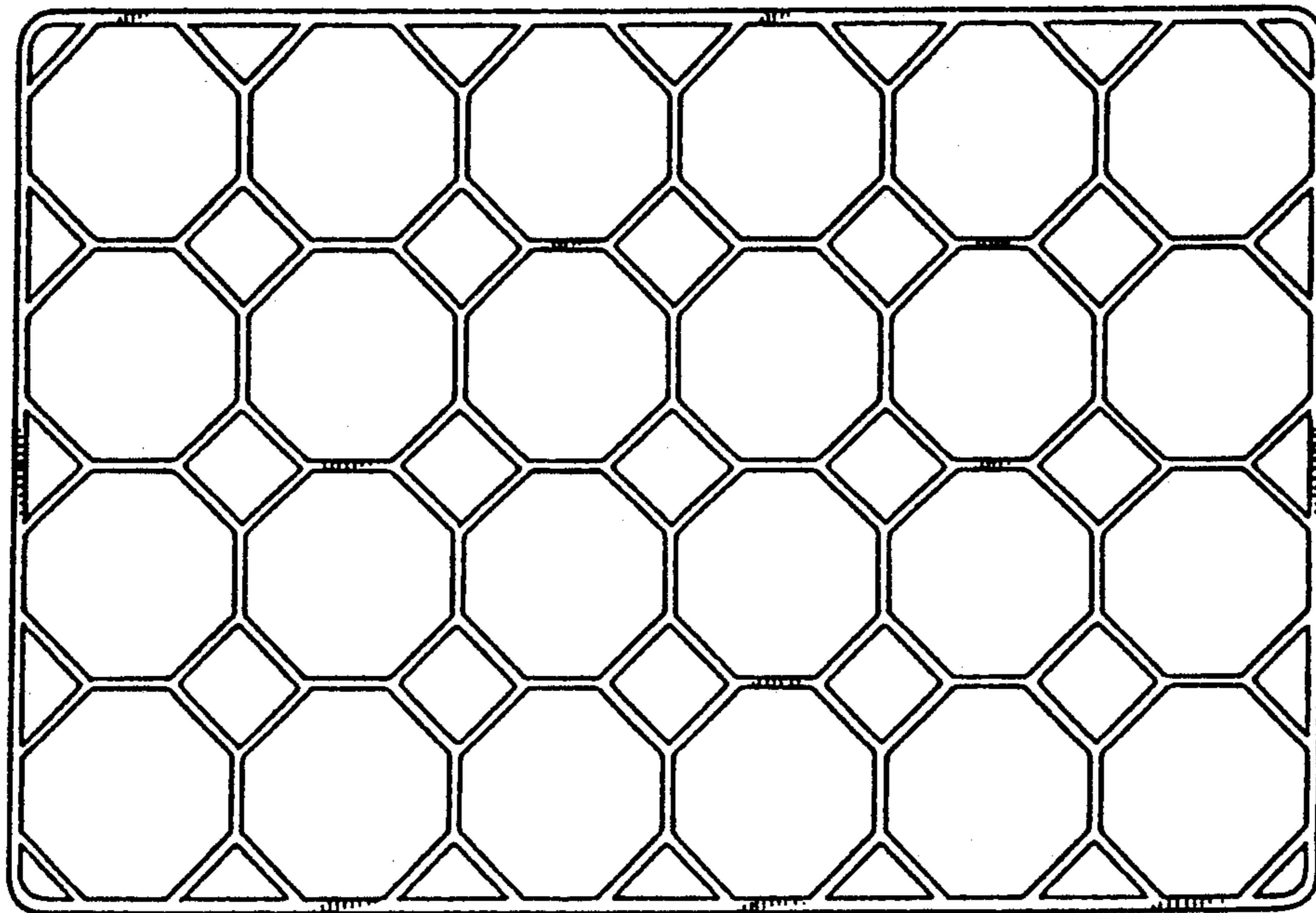

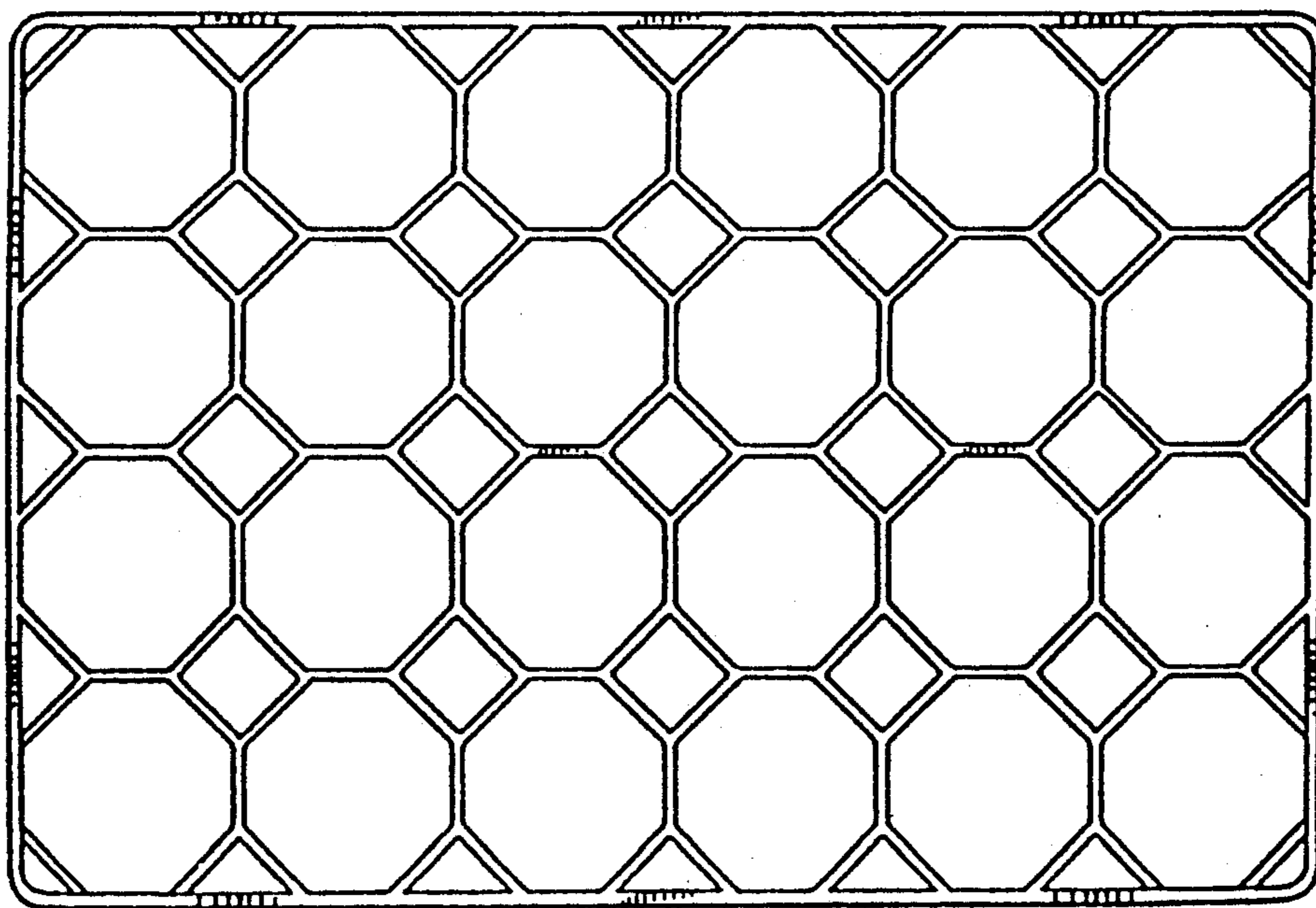

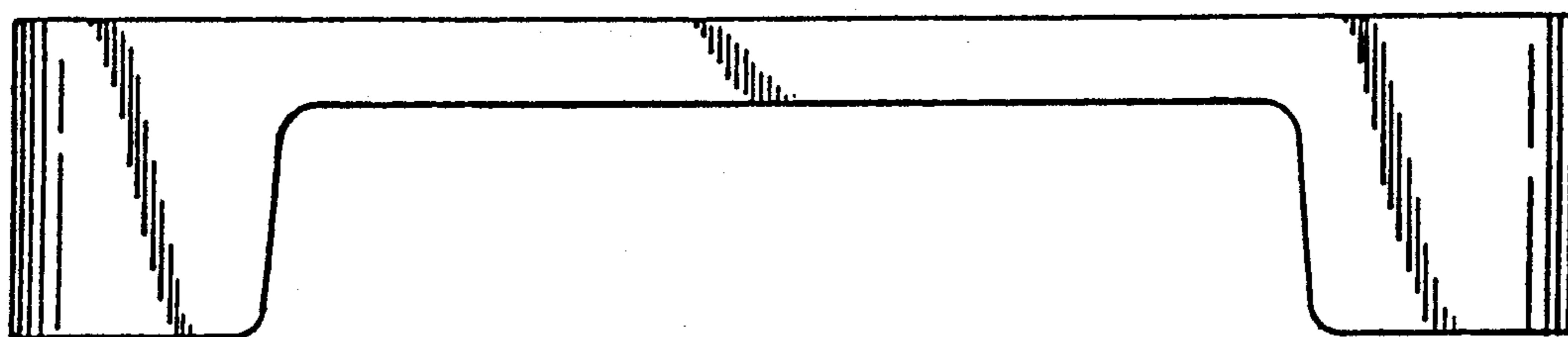
