The ornamental design for a computer cabinet, as shown and described.

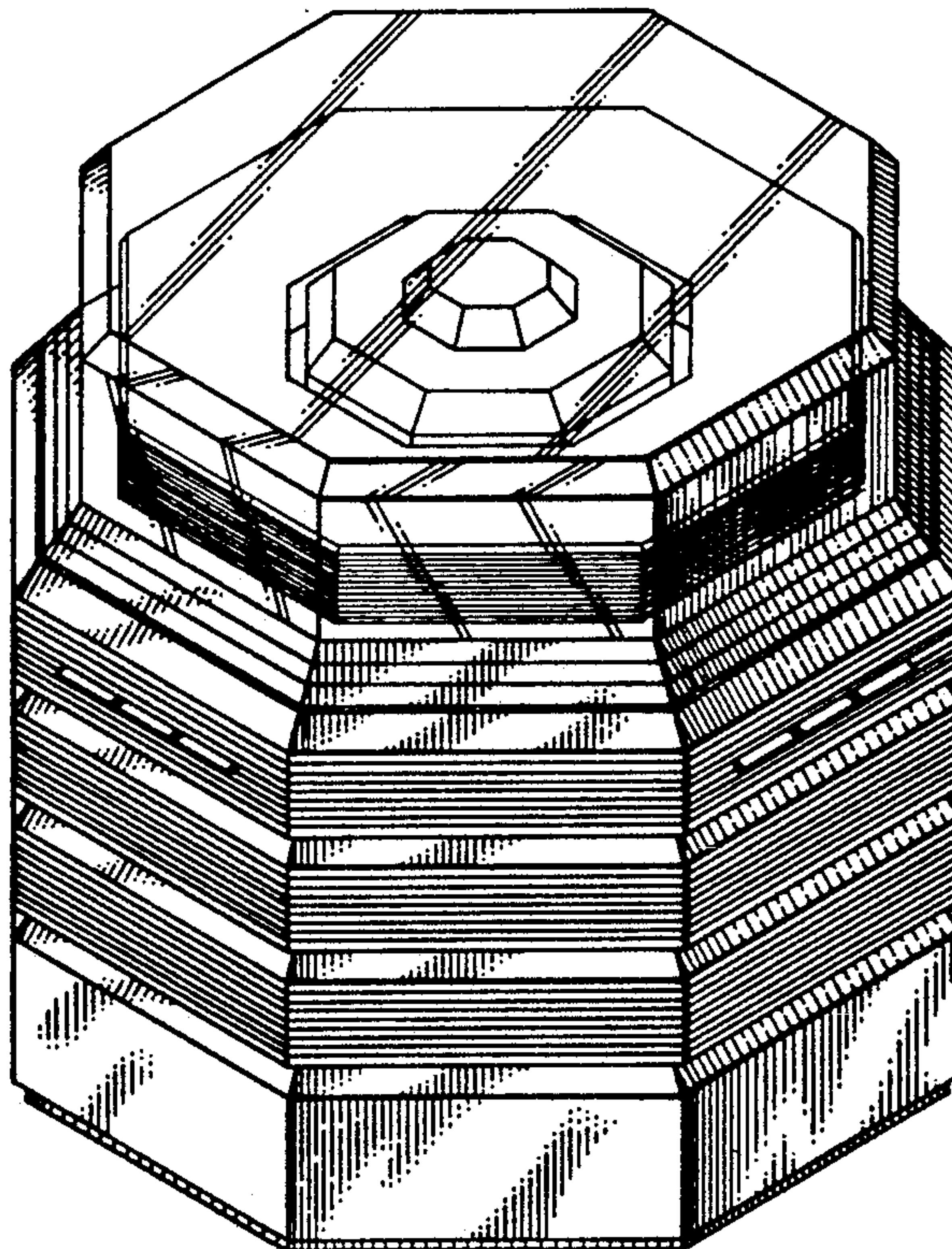
DESCRIPTION

FIG. 4 is a top plan view thereof.



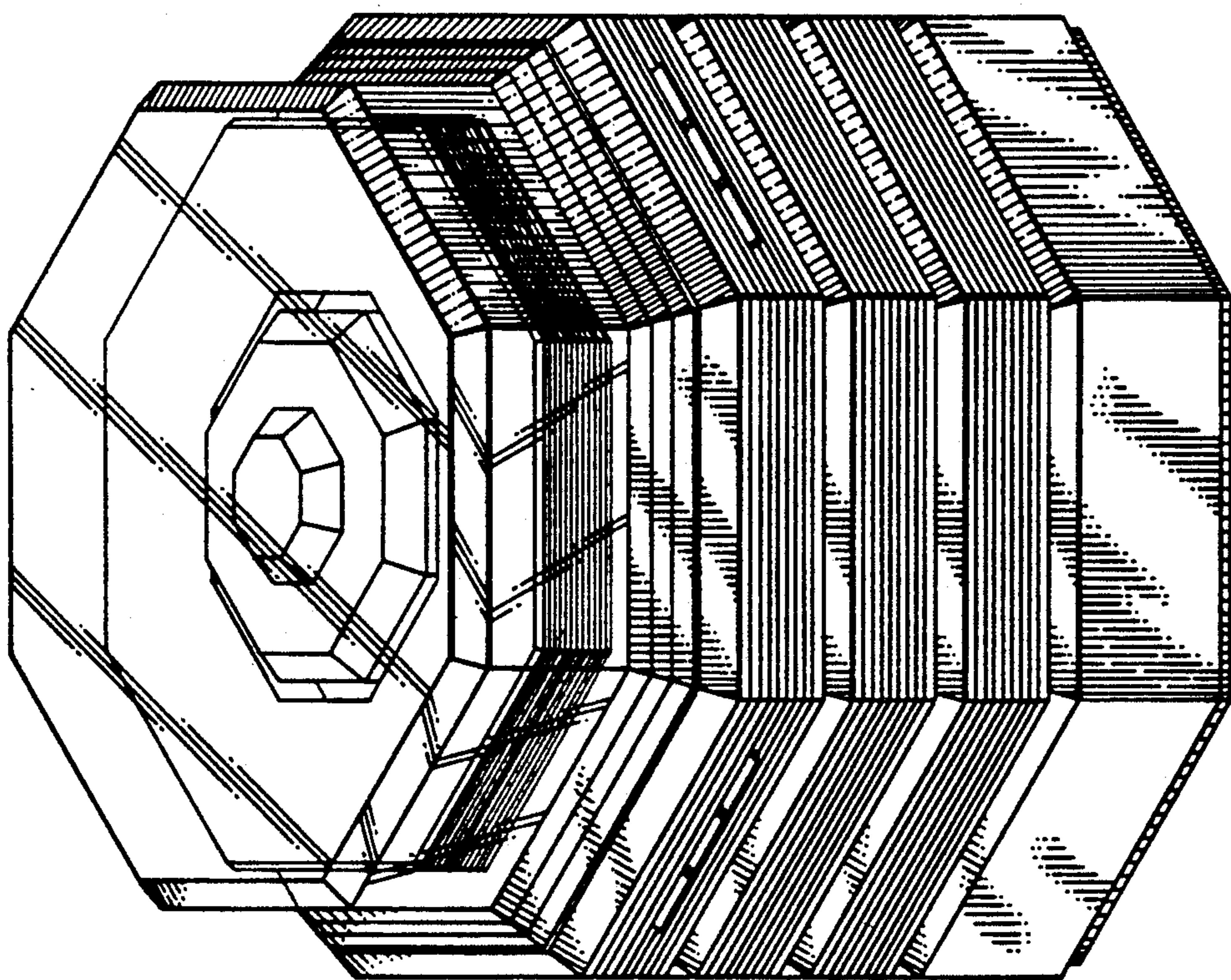

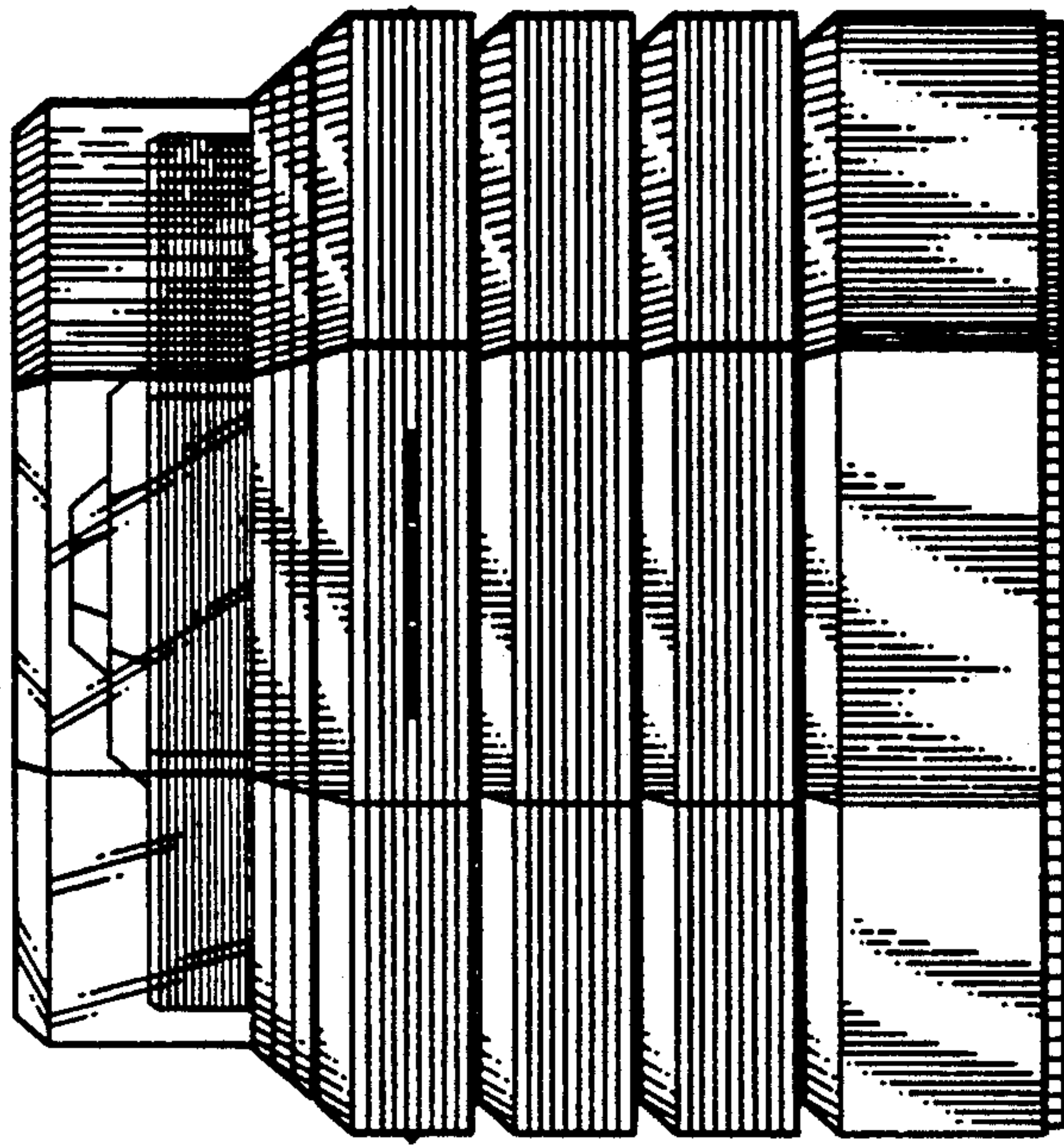

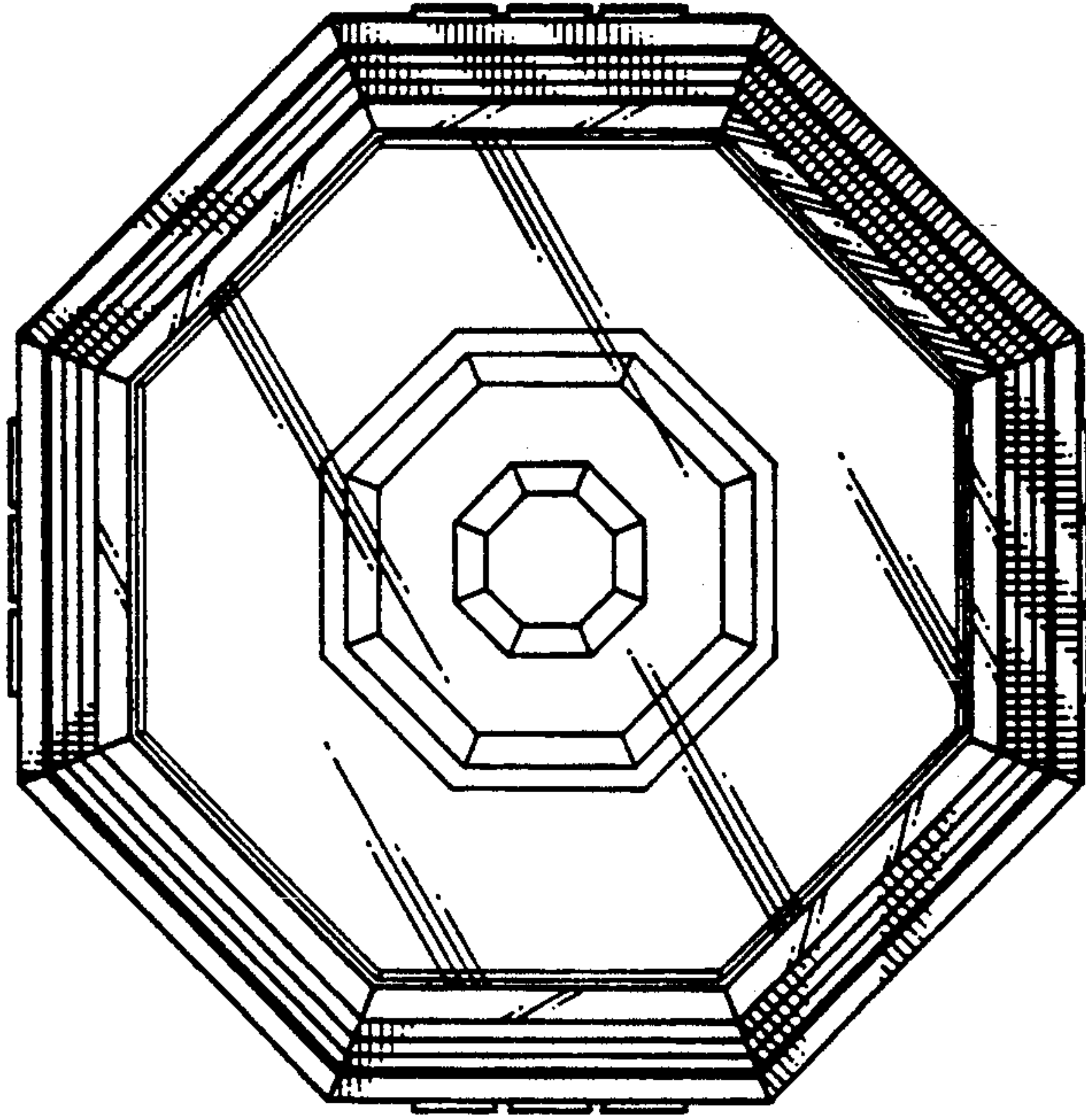

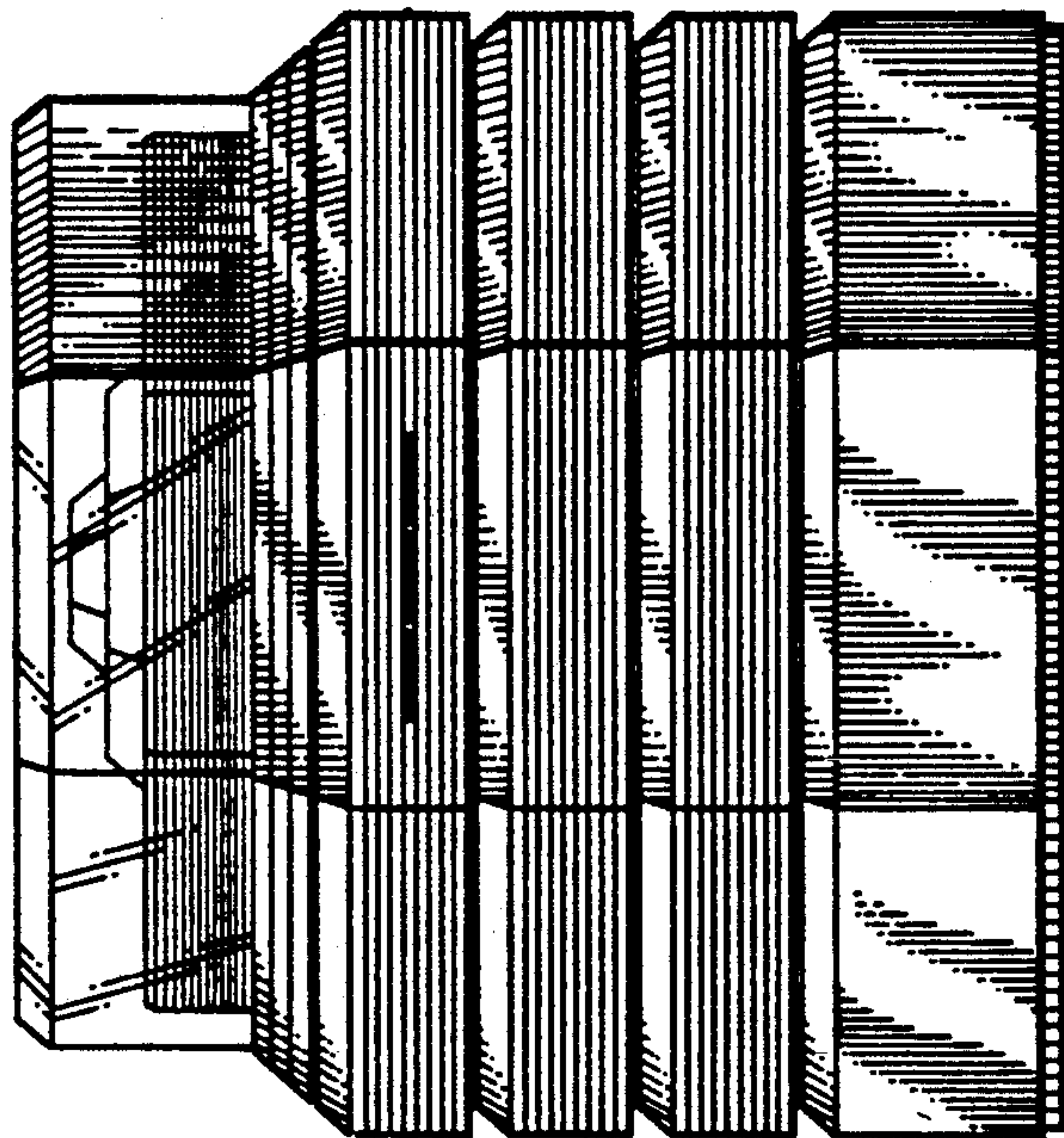
