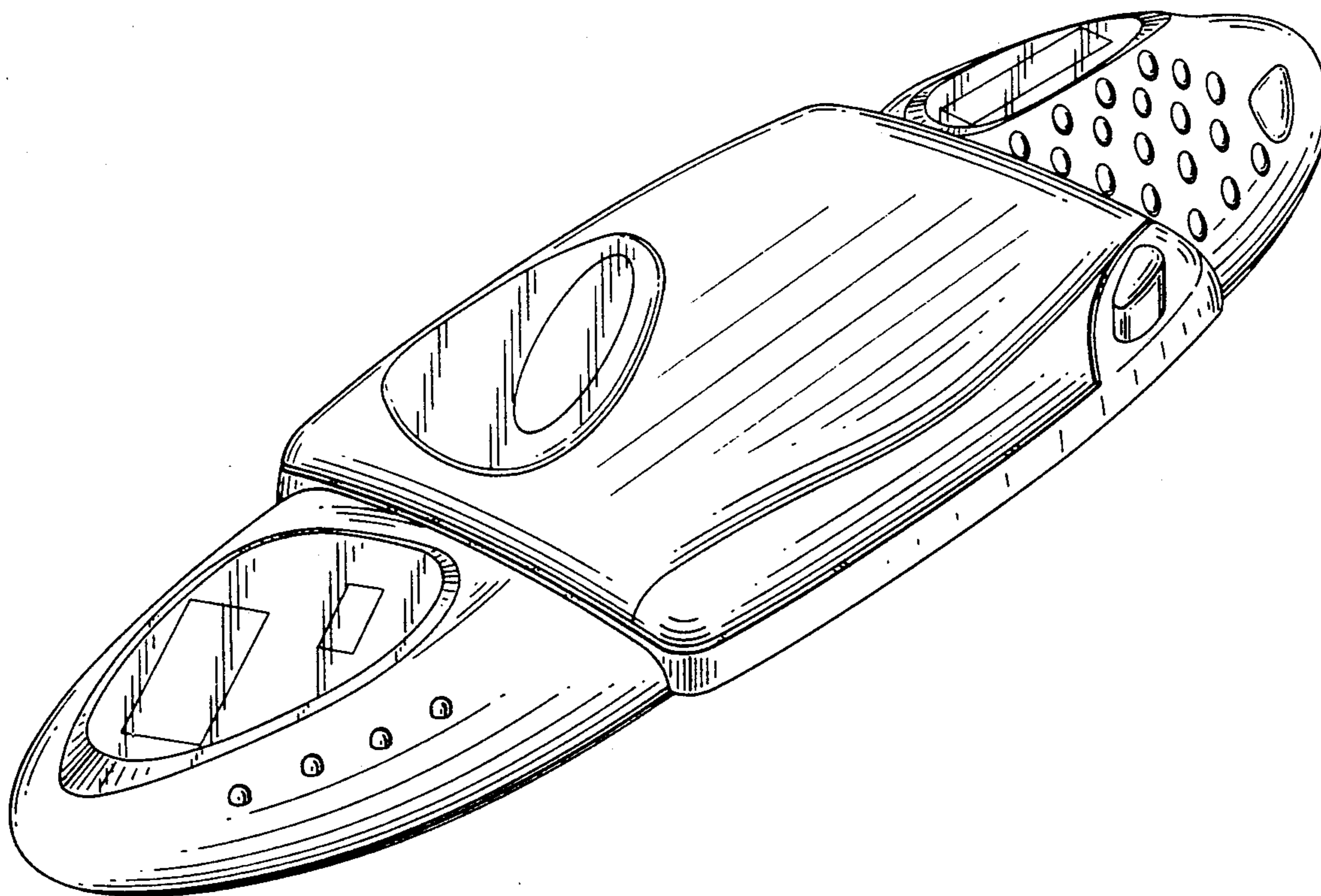

[57] **CLAIM**

The ornamental design for a combined desk accessory holder, clock and calculator, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a combined desk accessory holder, clock and calculator showing my new design; FIG. 2 is a bottom plan view; FIG. 3 is a front elevational view; FIG. 4 is a rear elevational view; FIG. 5 is a right side elevational view; FIG. 6 is a left side elevational view; and, FIG. 7 is a top, left front perspective view thereof.



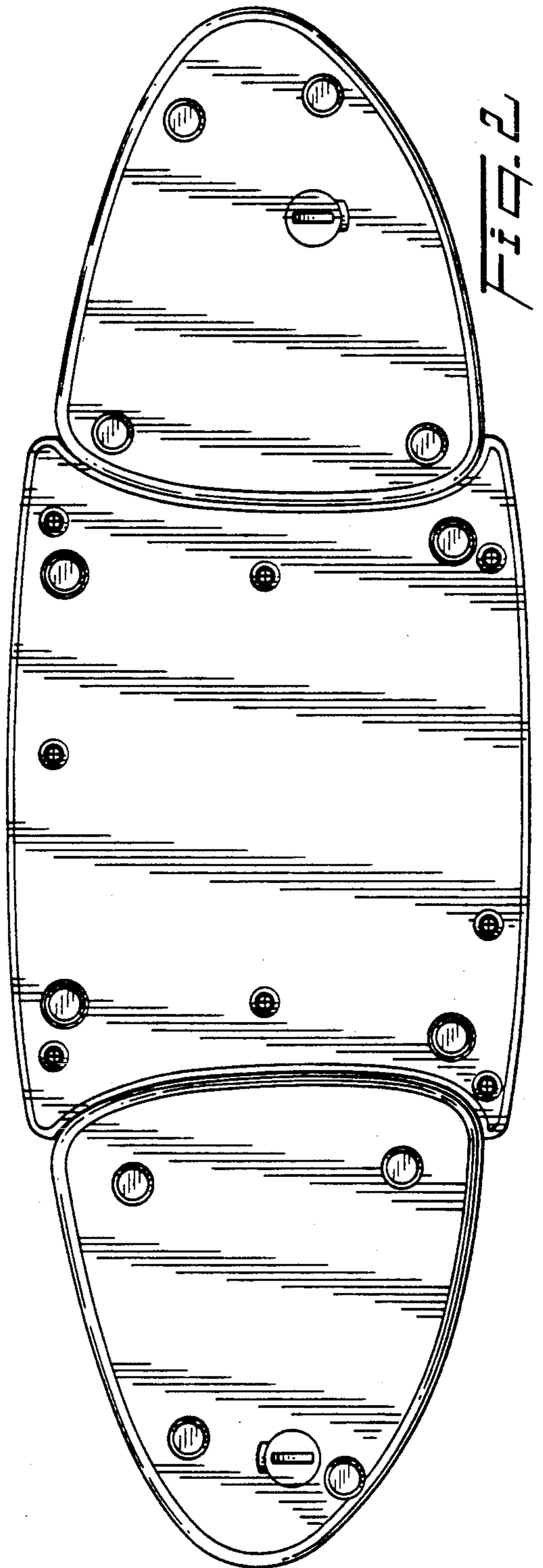
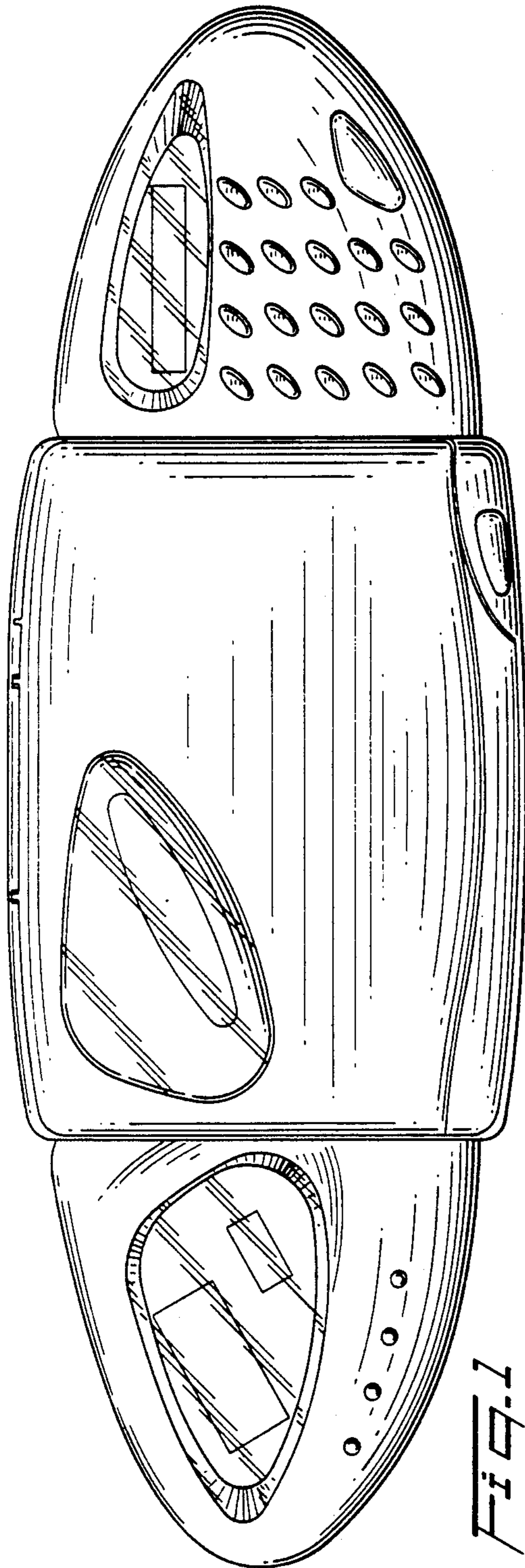

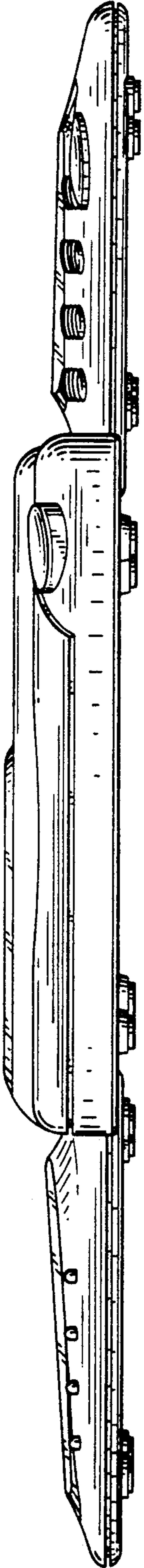

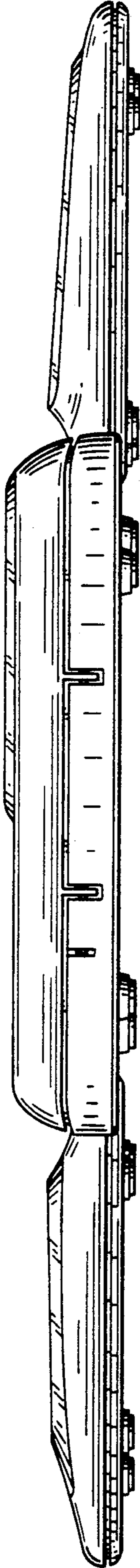

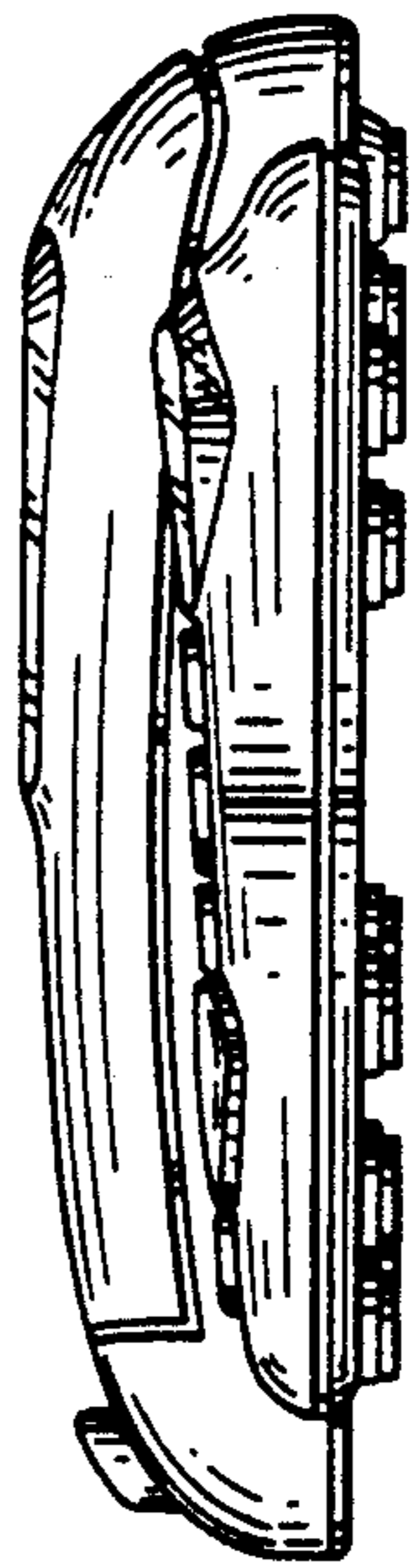

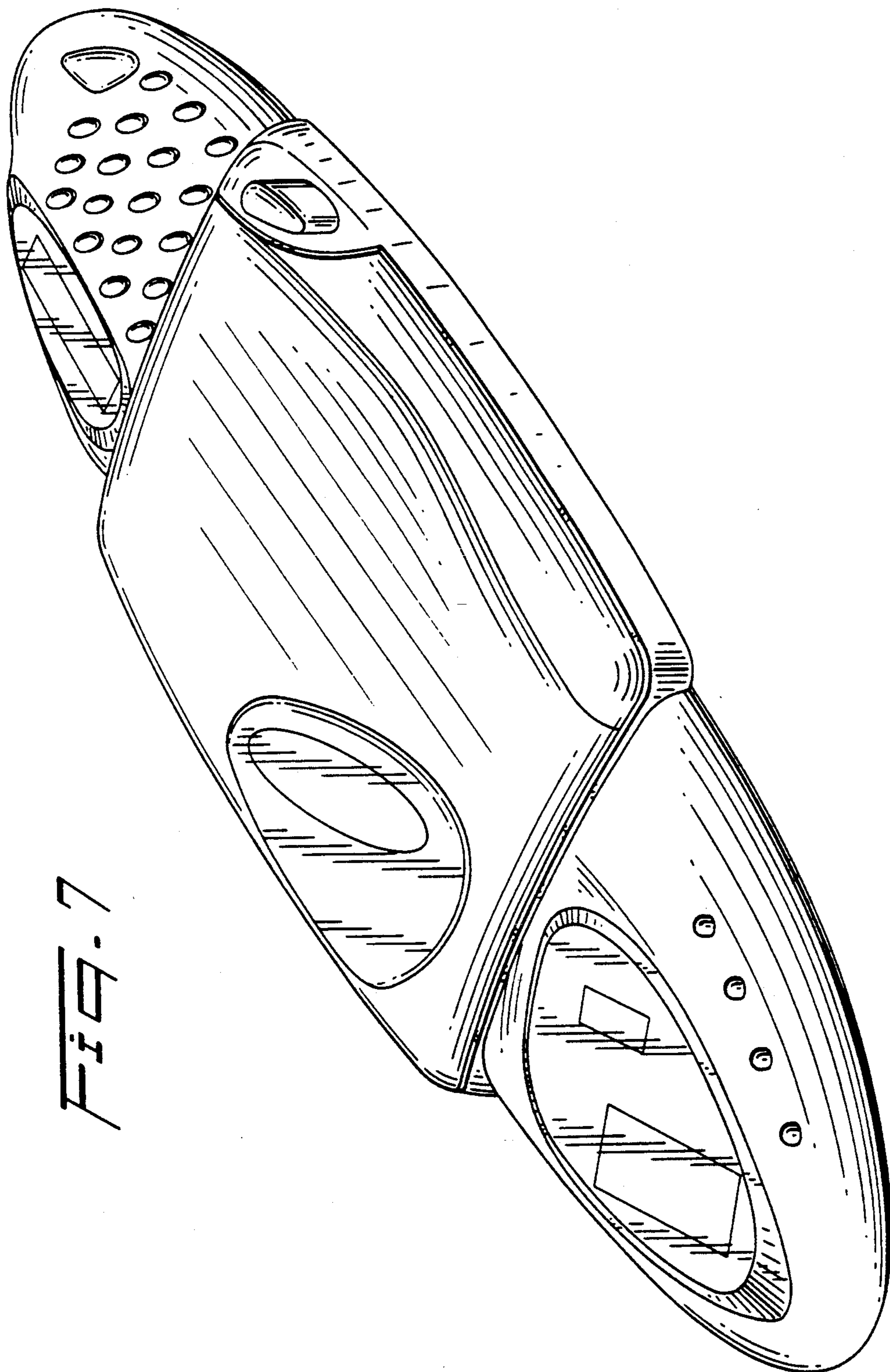
