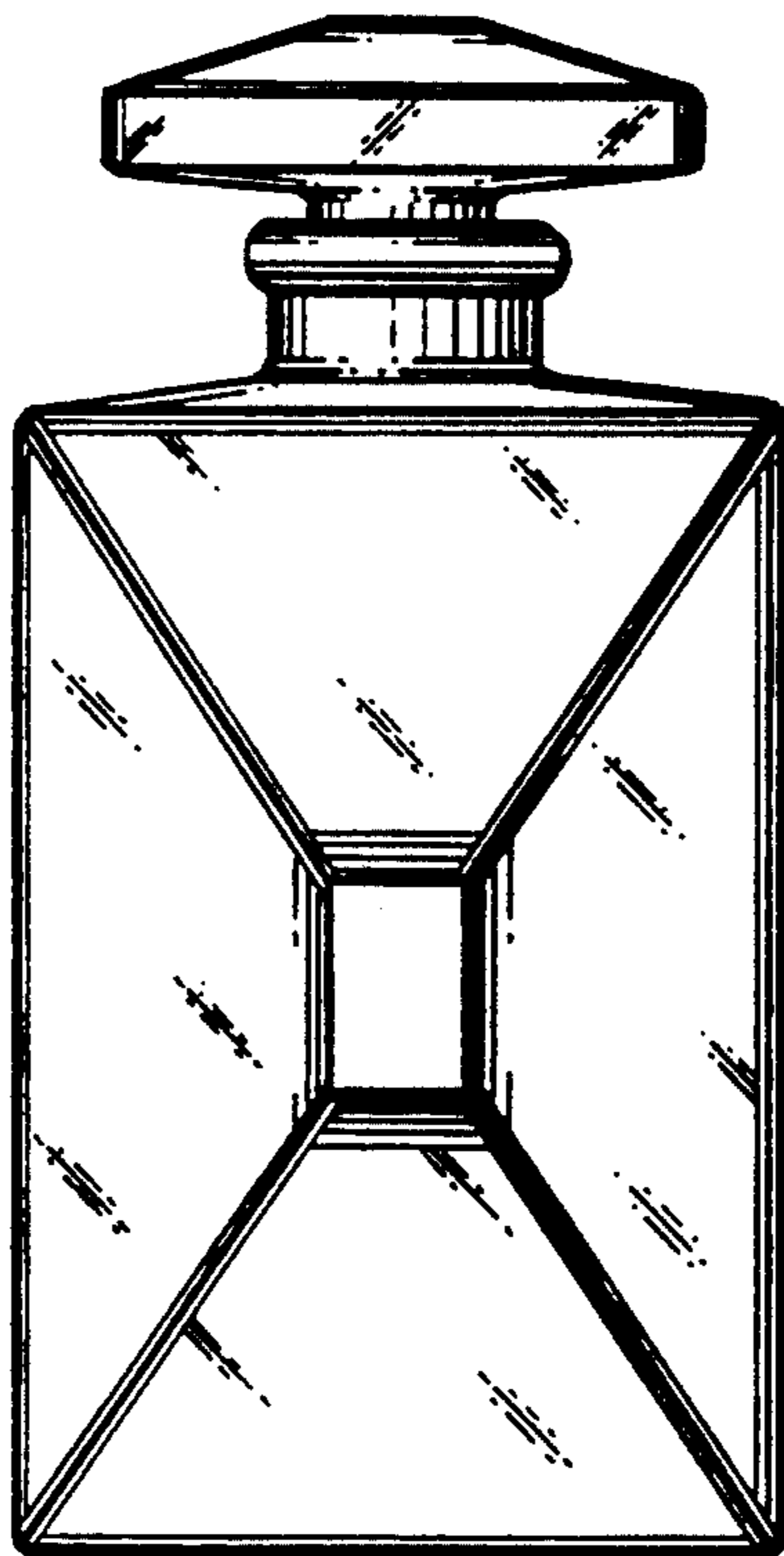

[57] **CLAIM**

The ornamental design for a combined bottle and stopper, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a combined bottle and stopper showing our new design; FIG. 2 is a front elevational view thereof, the rear elevational view is the same; FIG. 3 is a top plan view thereof; FIG. 4 is a side elevational view thereof, the opposite side is the same; and, FIG. 5 is a bottom plan view thereof.



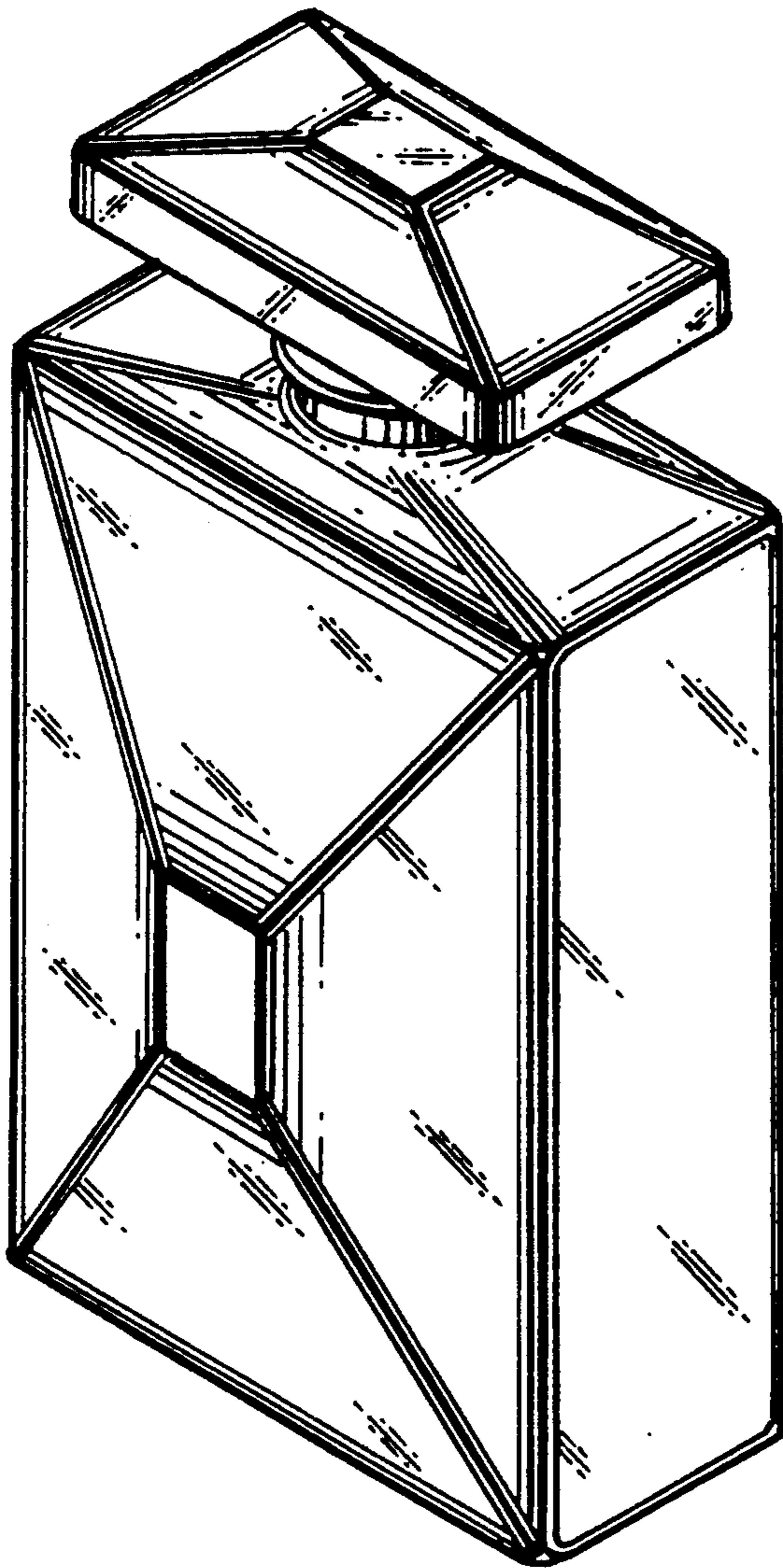

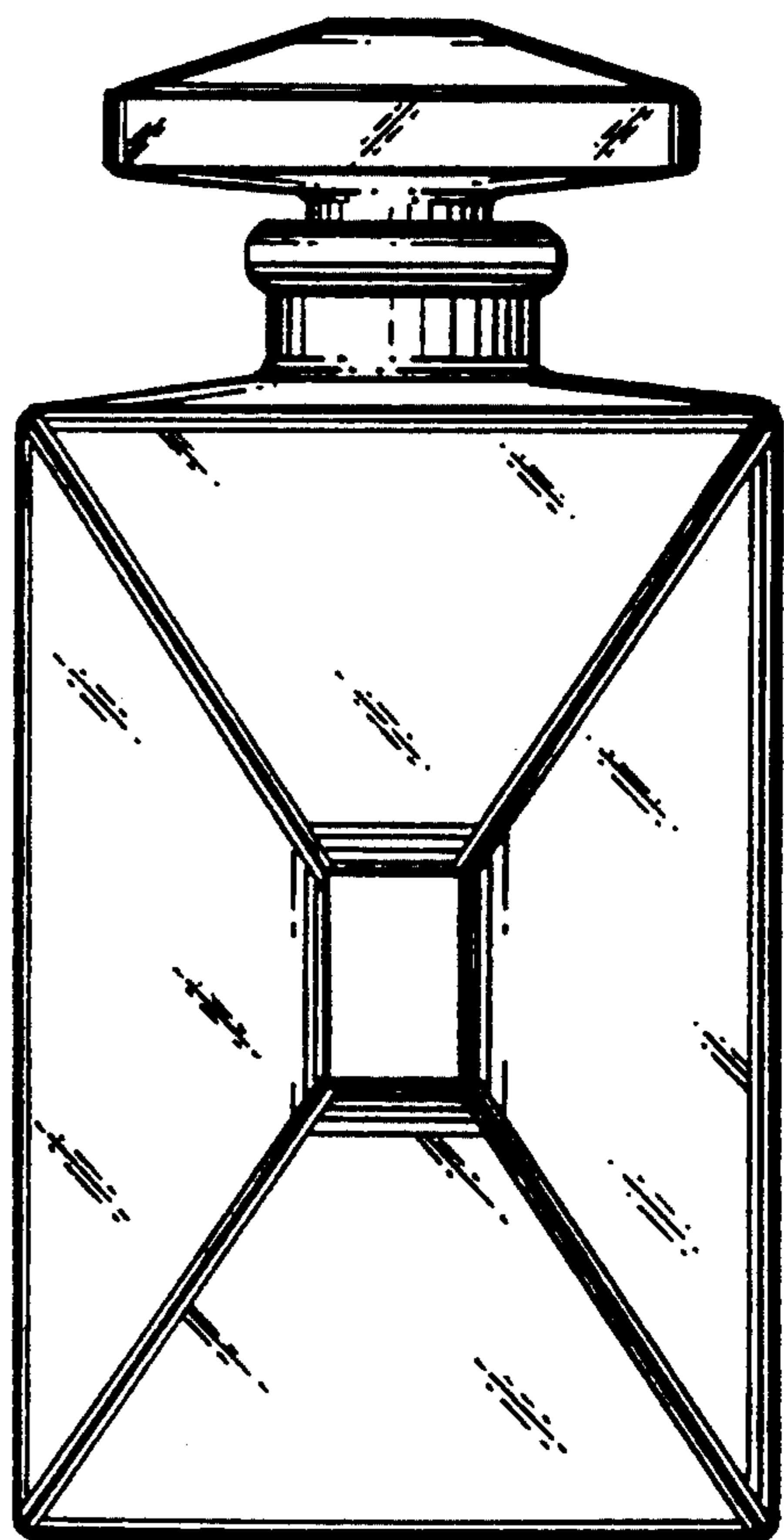

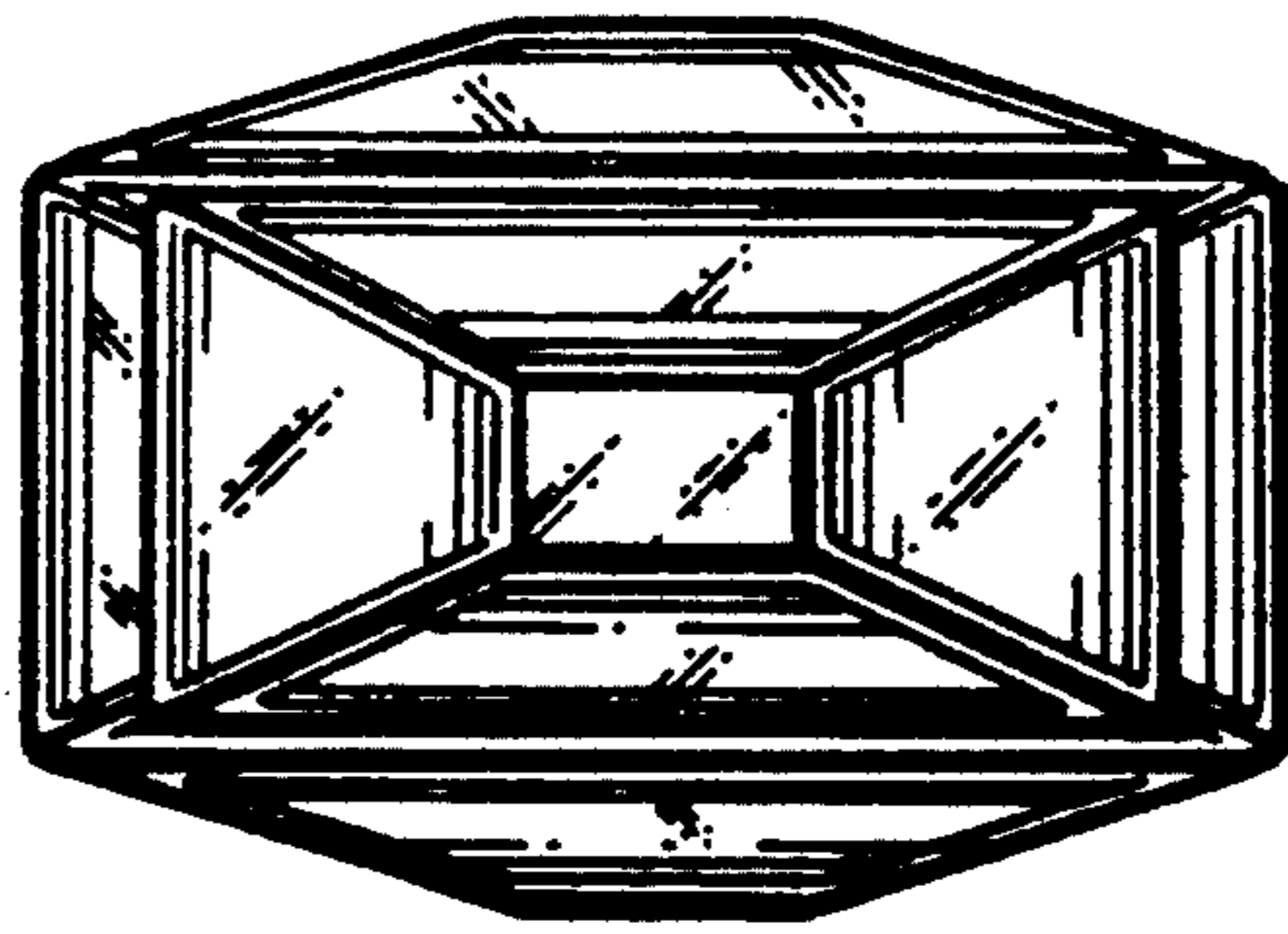

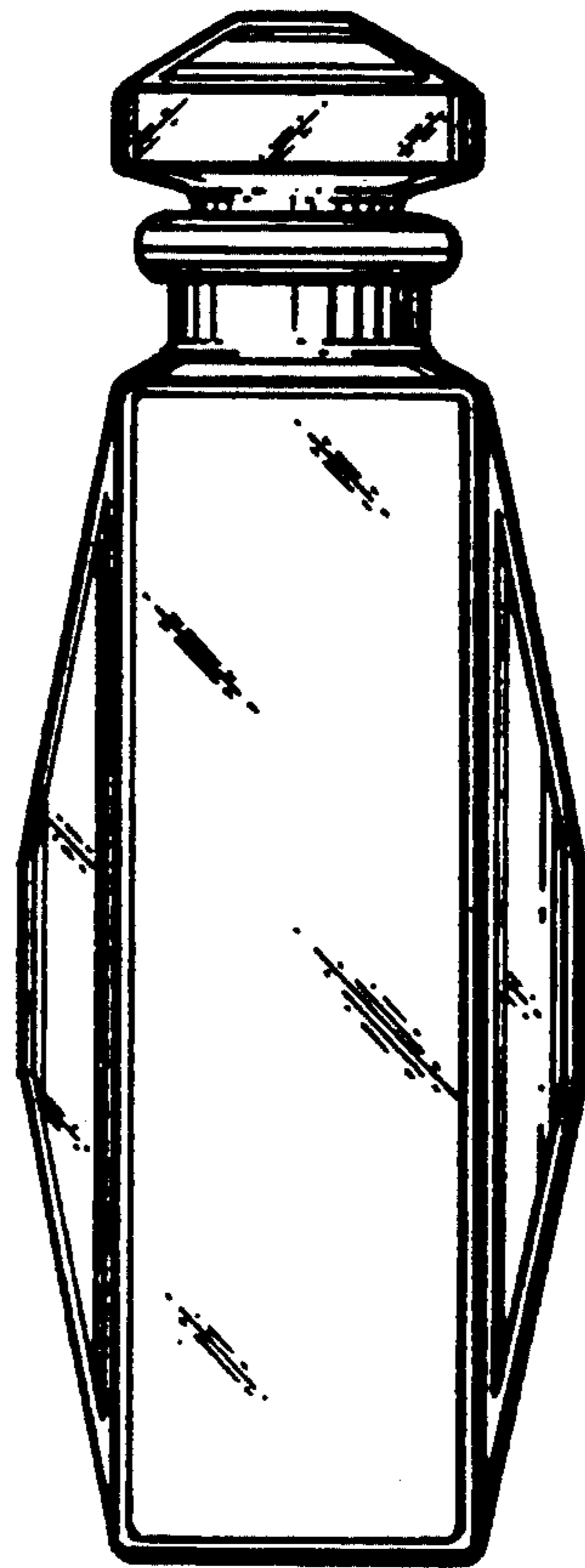
