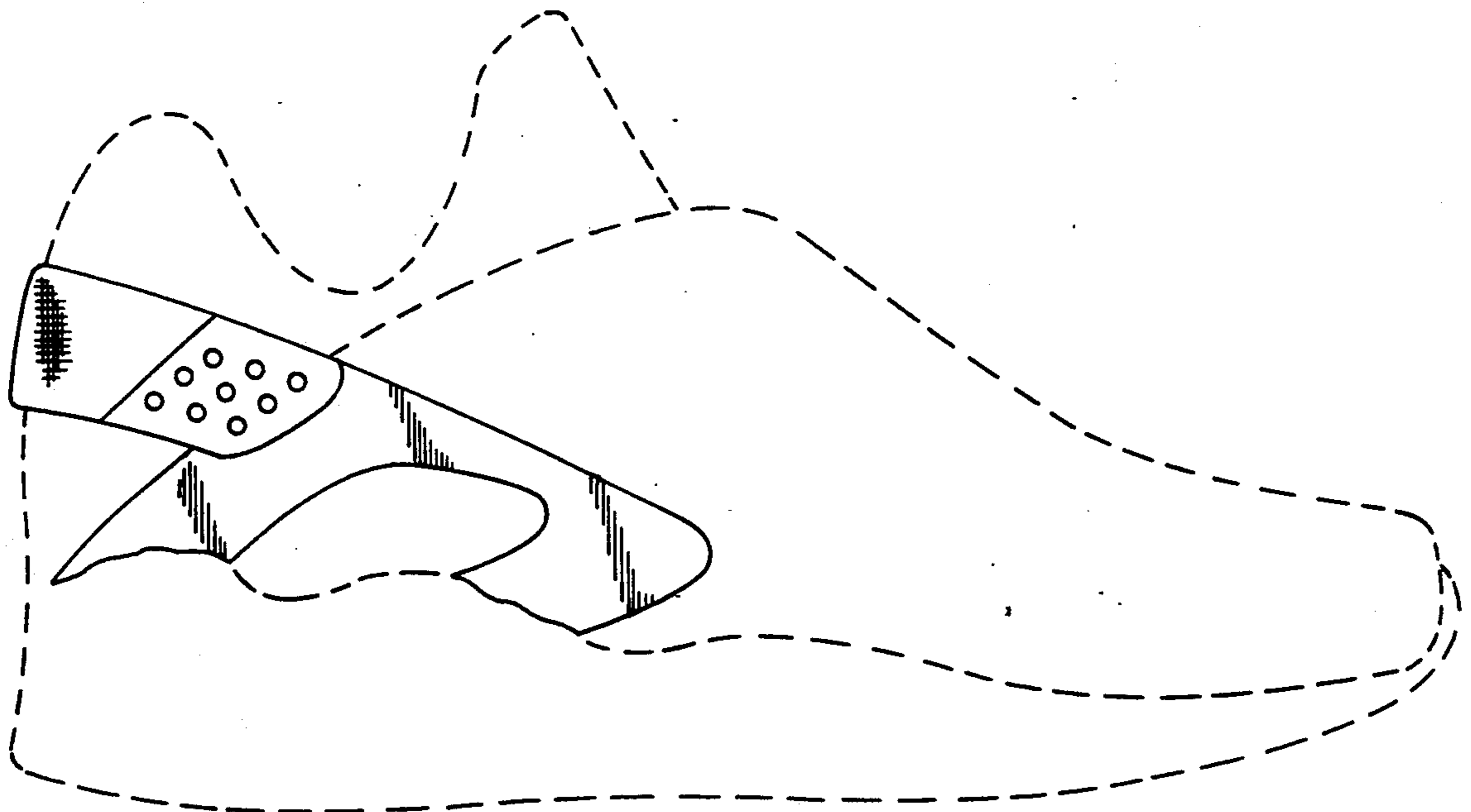

[57] CLAIM

The ornamental design for a heel element of a shoe upper, as shown and described.

DESCRIPTION

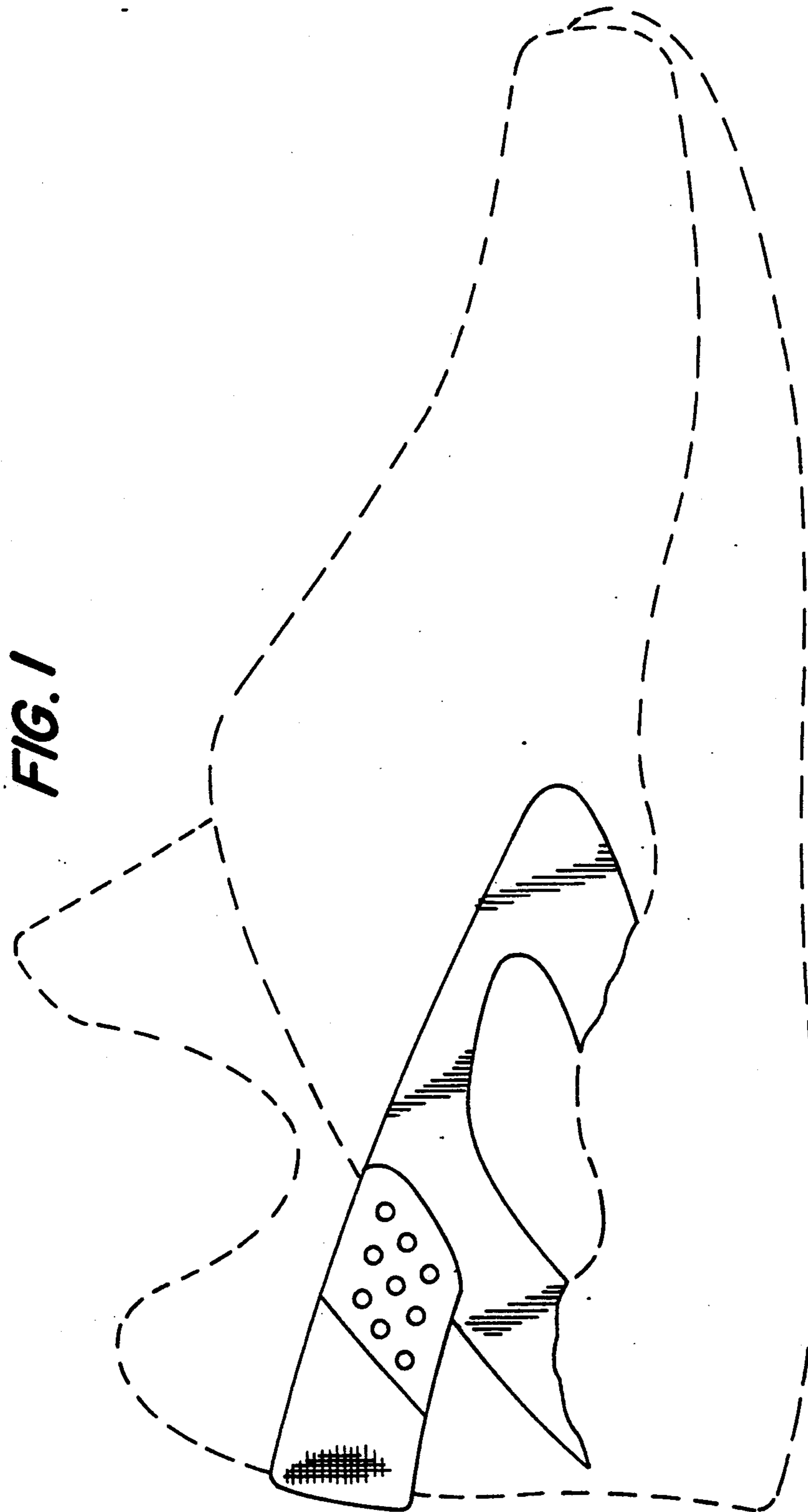

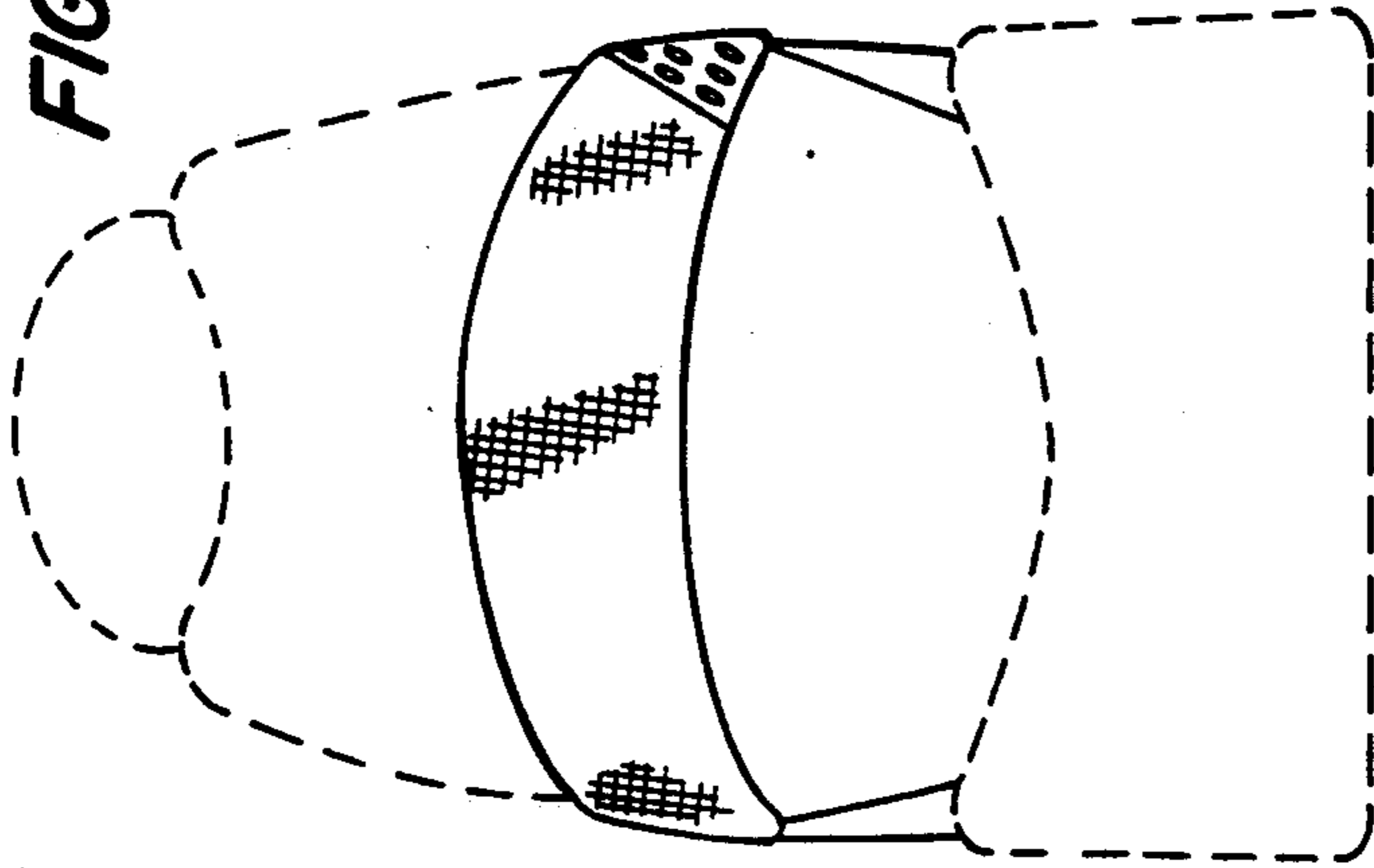

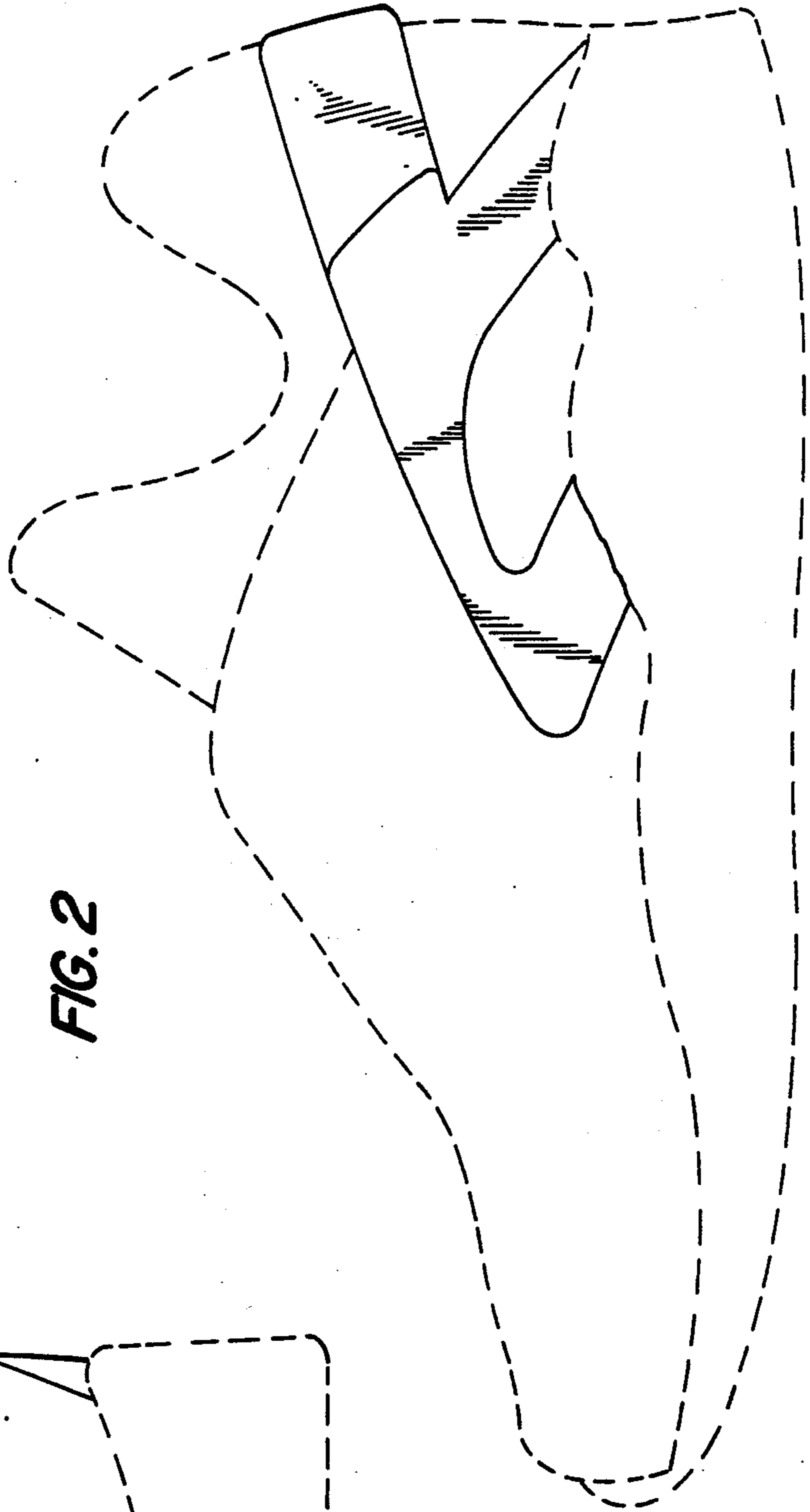
