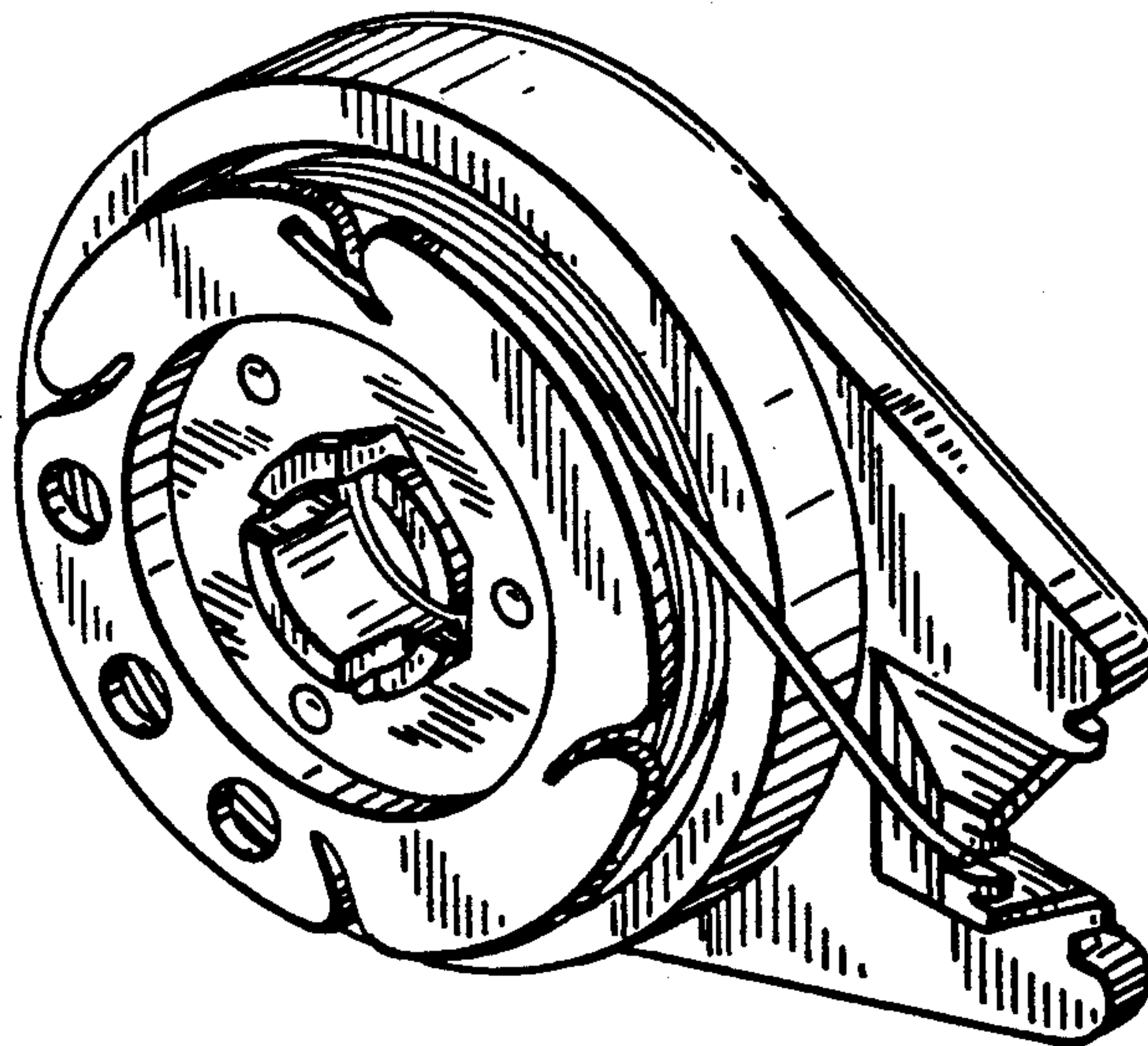

[57] CLAIM

The ornamental design for a suture dispenser, as shown
and described.

DESCRIPTION

FIG. 1 is a perspective view of a suture dispenser show-
ing our new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a right side elevational view thereof, the left
side elevational view being identical thereto;
FIG. 4 is a front end elevational view thereof;
FIG. 5 is a rear end elevational view thereof; and,
FIG. 6 is a bottom plan view thereof.



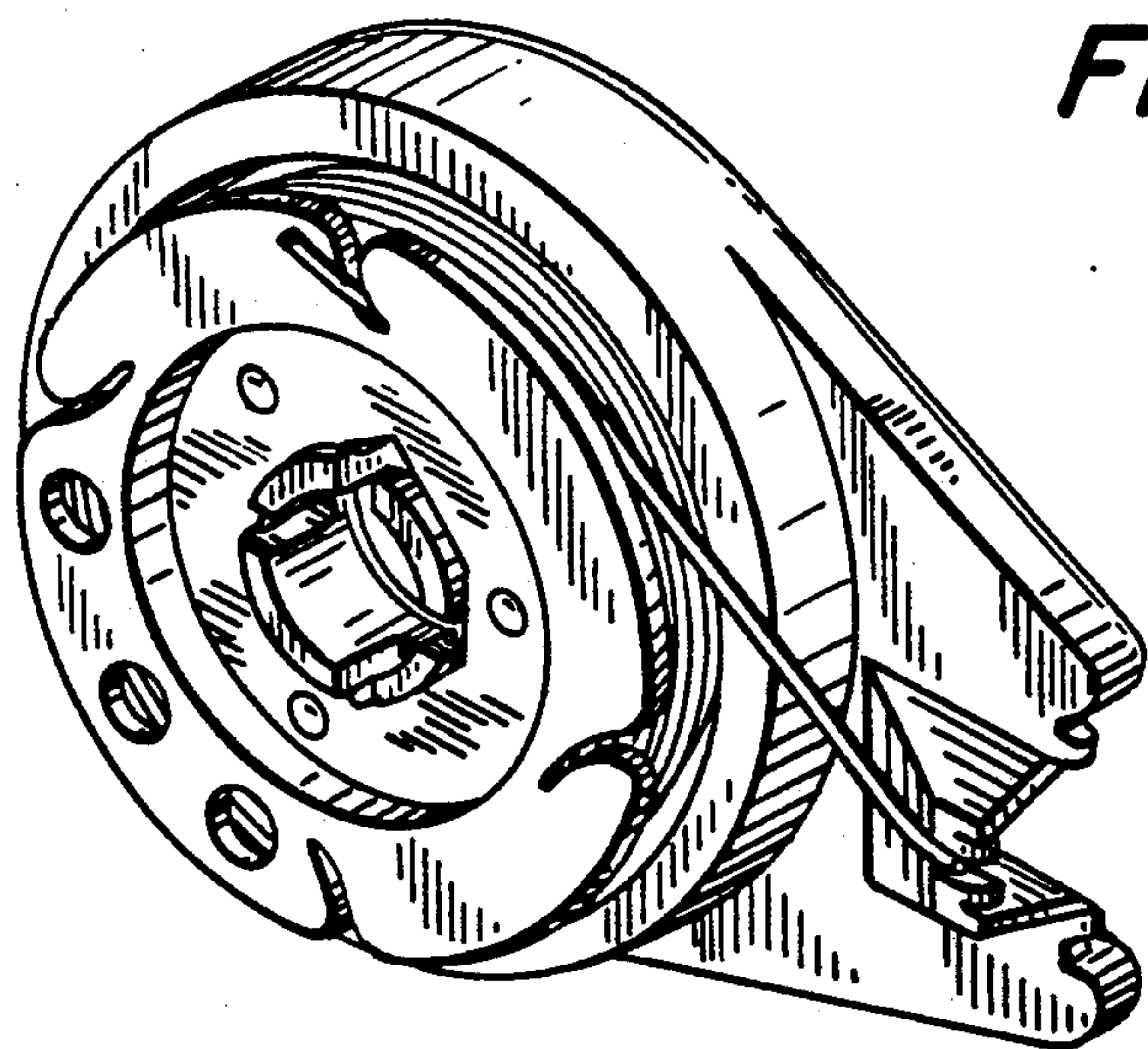

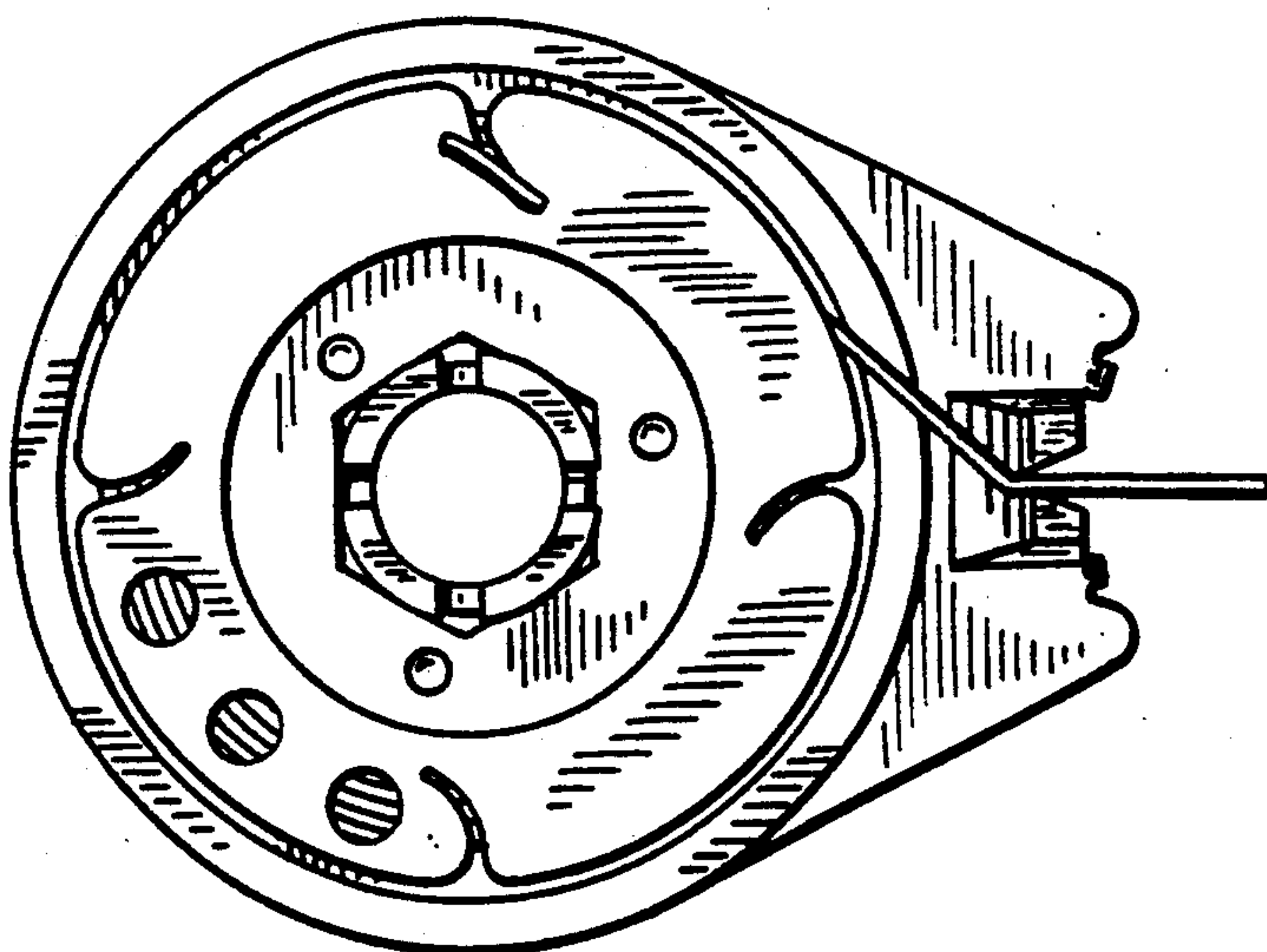

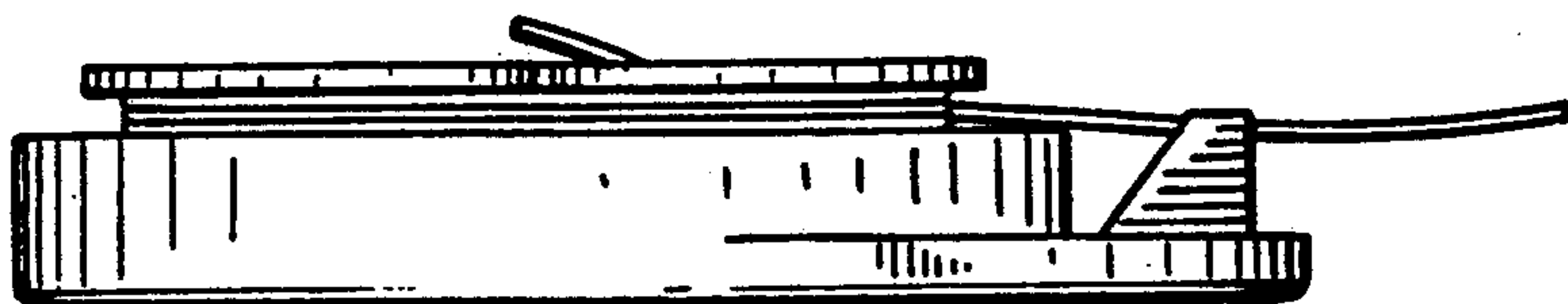

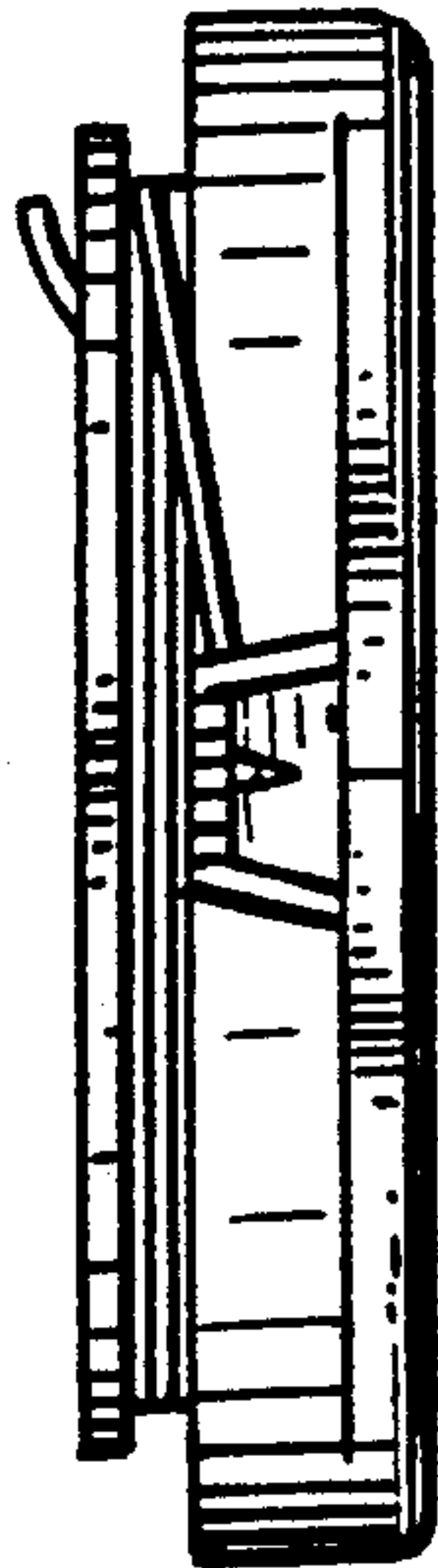

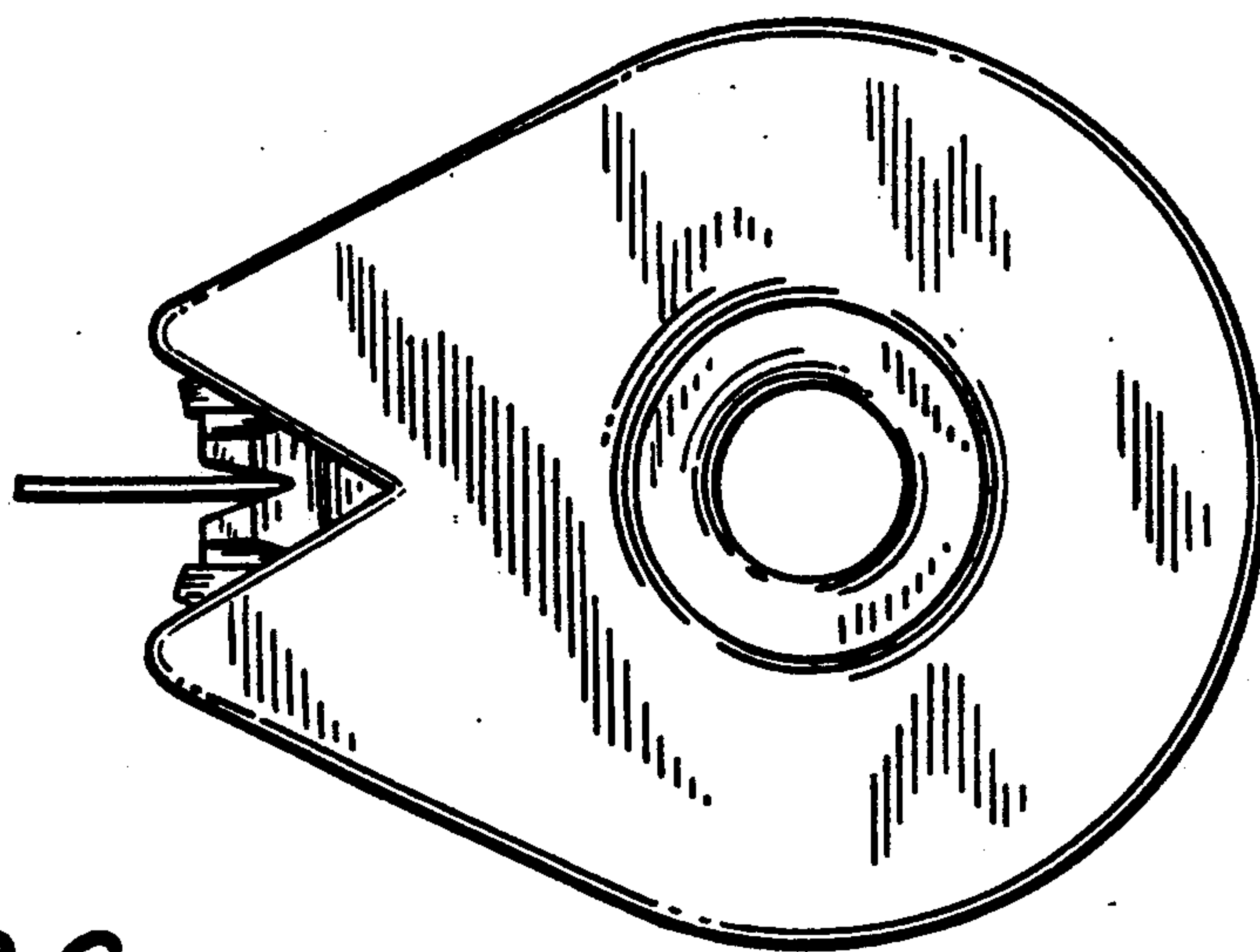
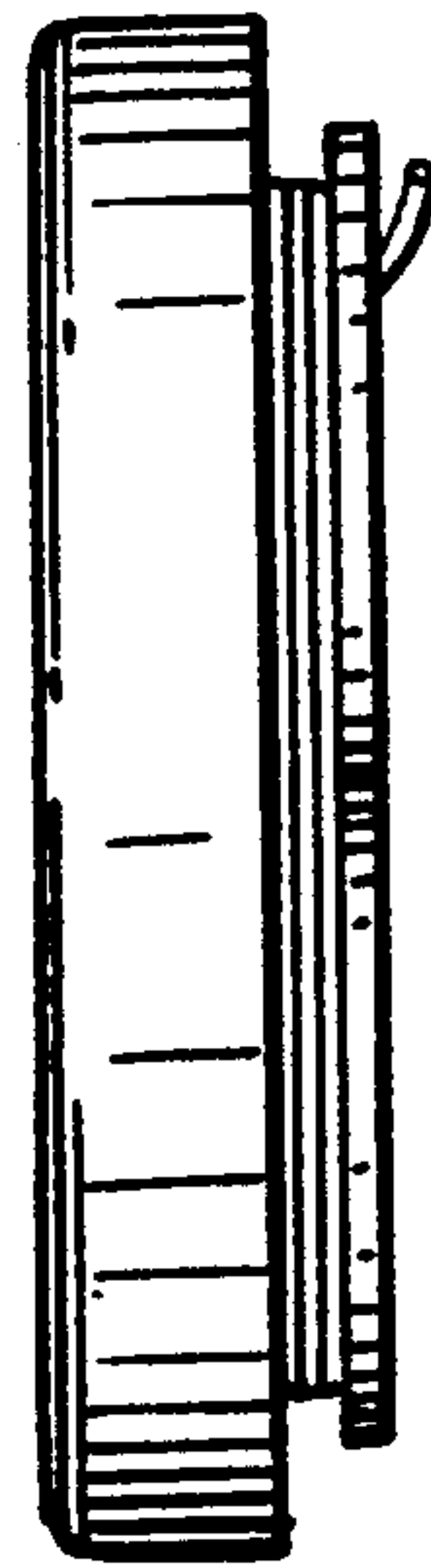
