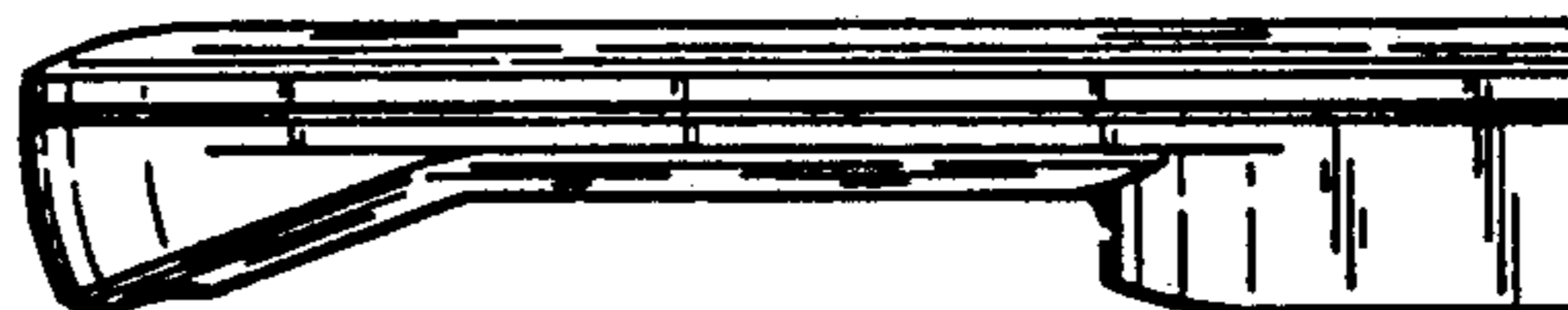
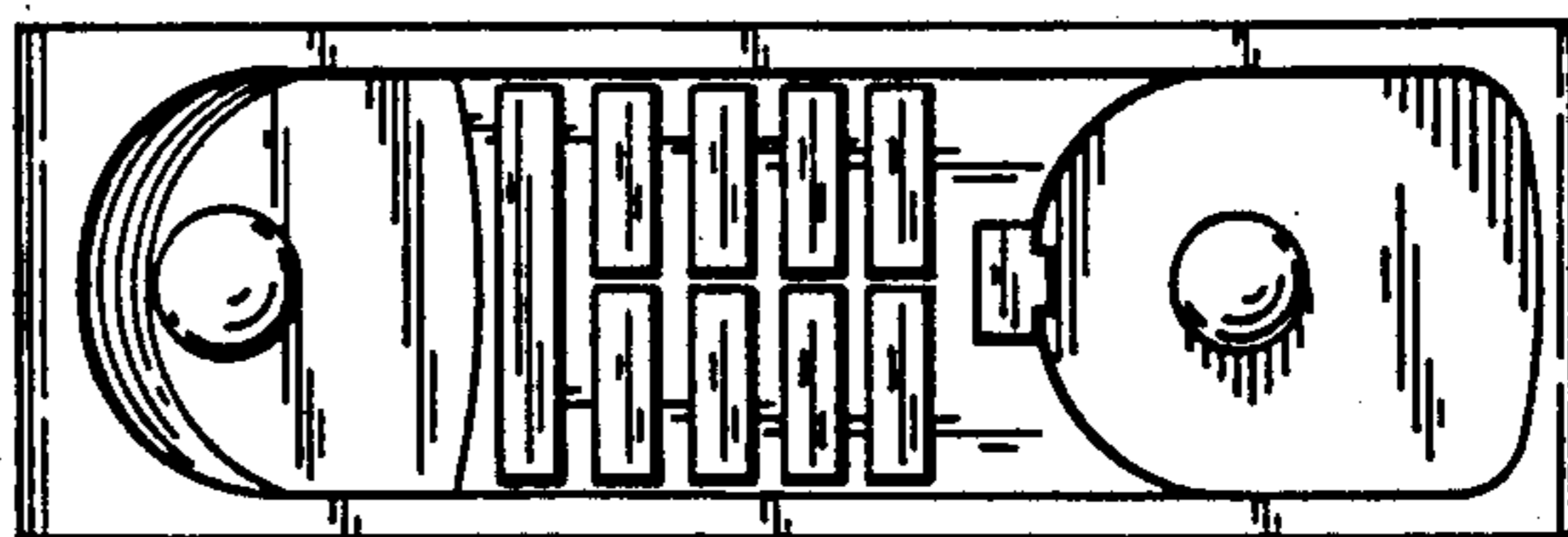
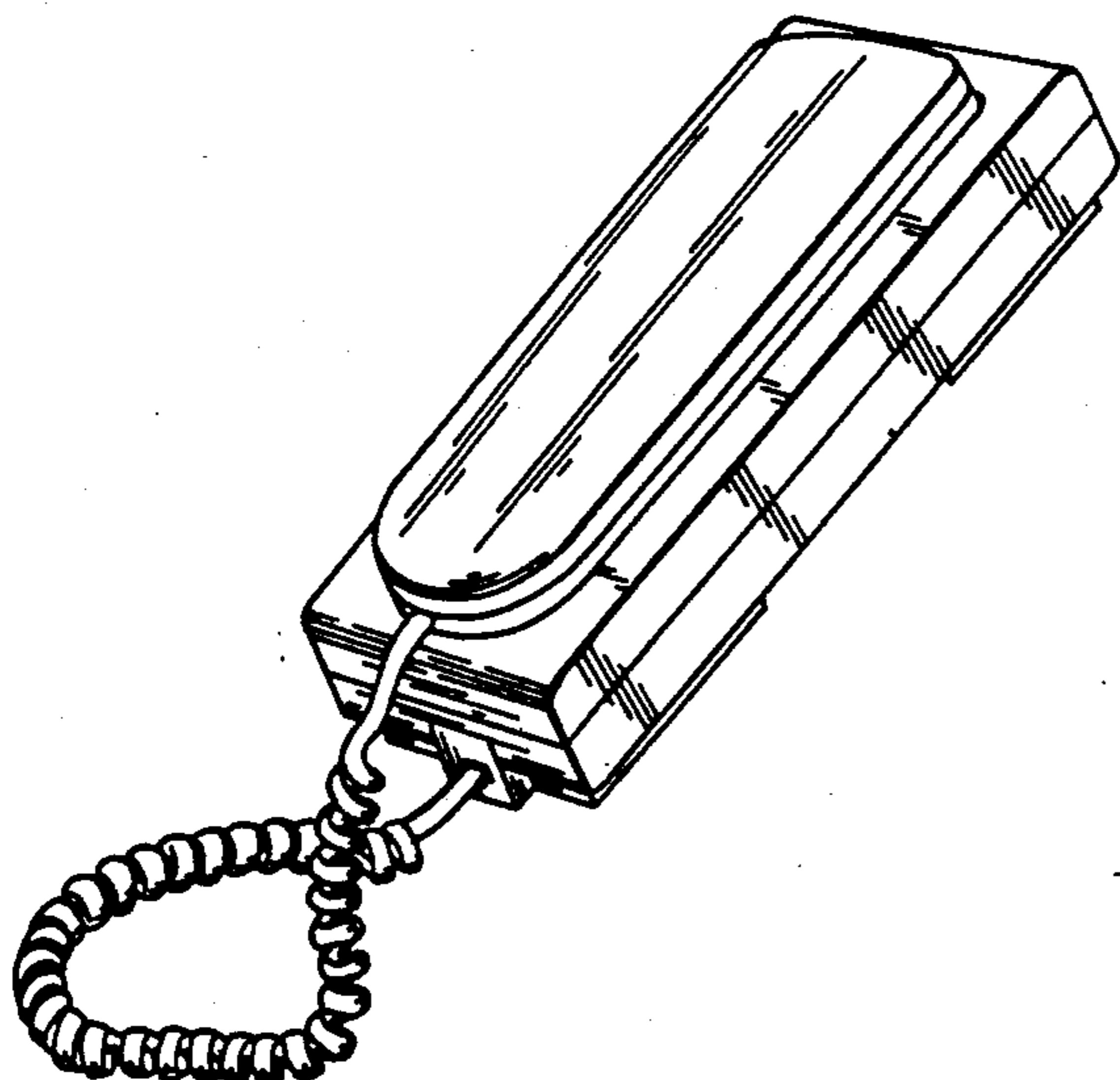

[57] CLAIM

The ornamental design for a telephone set, as shown and described.

DESCRIPTION

FIG. 1 is a rear, top and right side perspective view of a telephone set;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a side elevational view thereof;
 FIG. 4 is the side opposite the view of FIG. 3;
 FIG. 5 is a bottom plan view thereof;
 FIG. 6 is a rear elevational view thereof;
 FIG. 7 is a rear elevational view thereof;
 FIG. 8 is a top plan view of the base of the telephone set;
 FIG. 9 is a side elevational view of the handset component of the telephone set shown in FIGS. 1 and 9 thereof;
 FIG. 10 is a bottom plan view of the handset component shown in FIG. 1;
 FIG. 11 is an rear end elevational view of the handset component thereof;
 FIG. 12 is a front end elevational view of the handset component thereof;
 FIG. 13 is a left side, top and front perspective view thereof; and,
 FIG. 14 is a front, bottom and left side perspective view thereof.



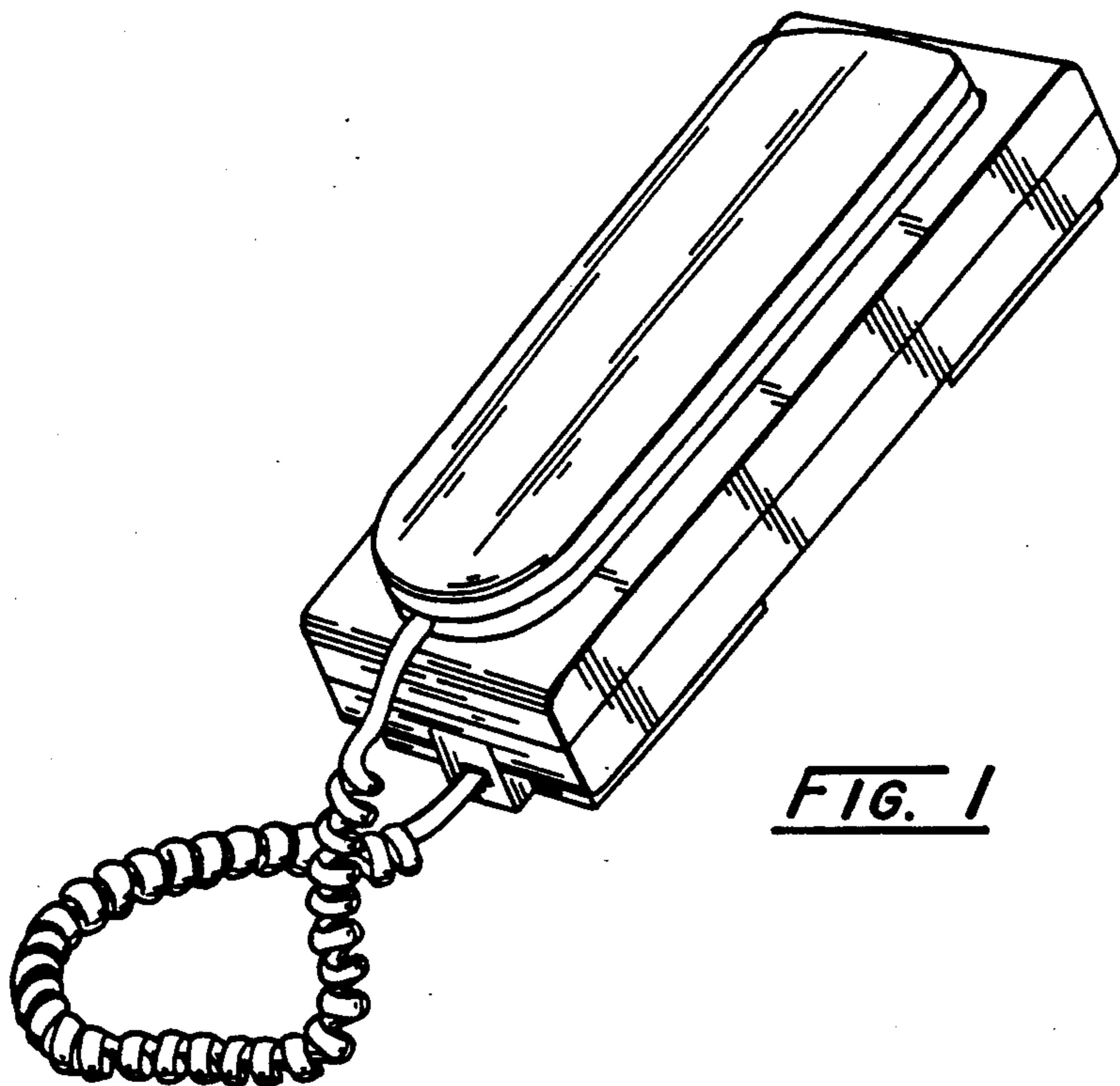

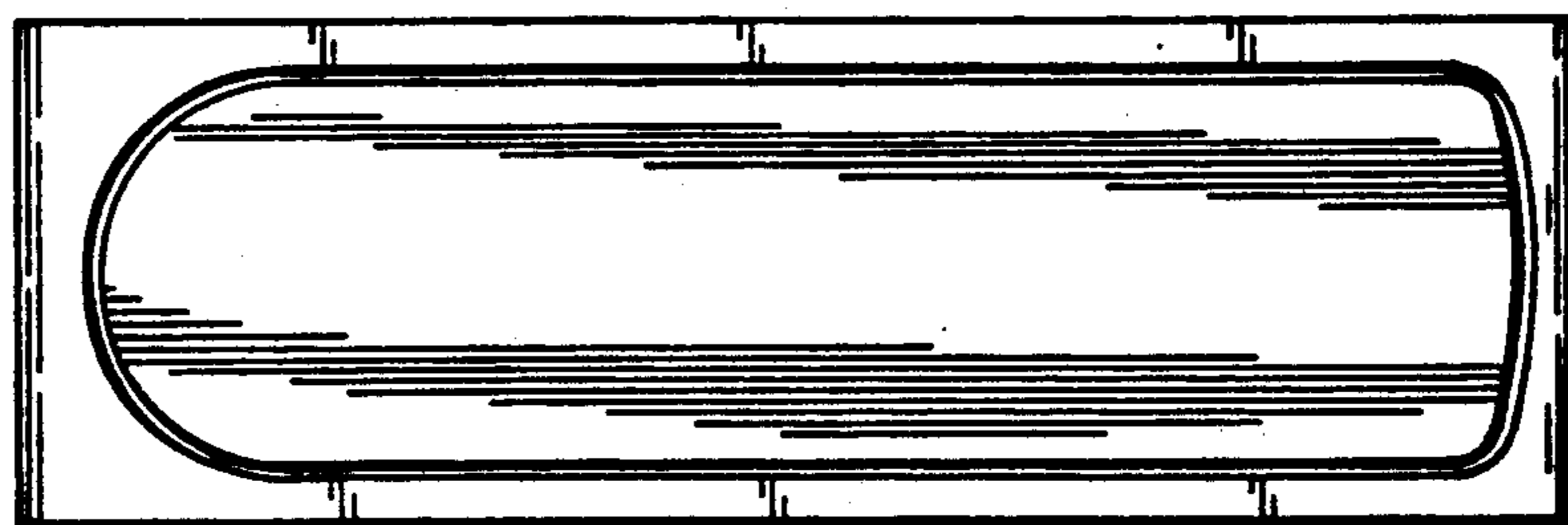

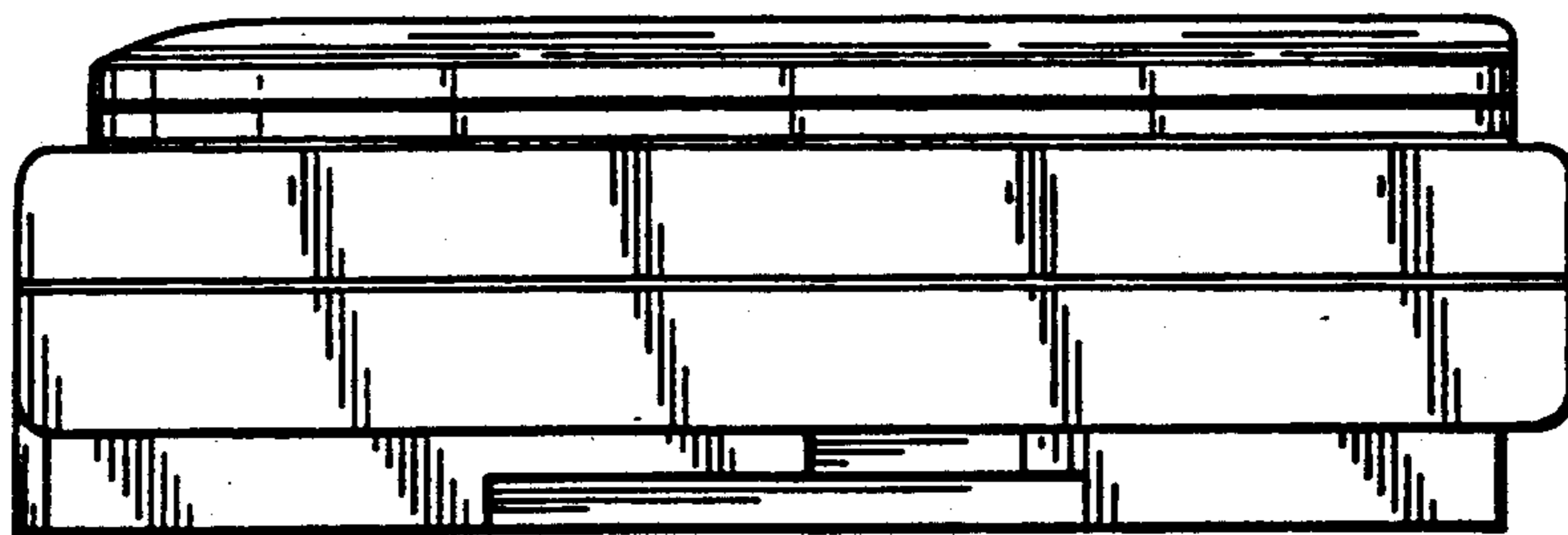

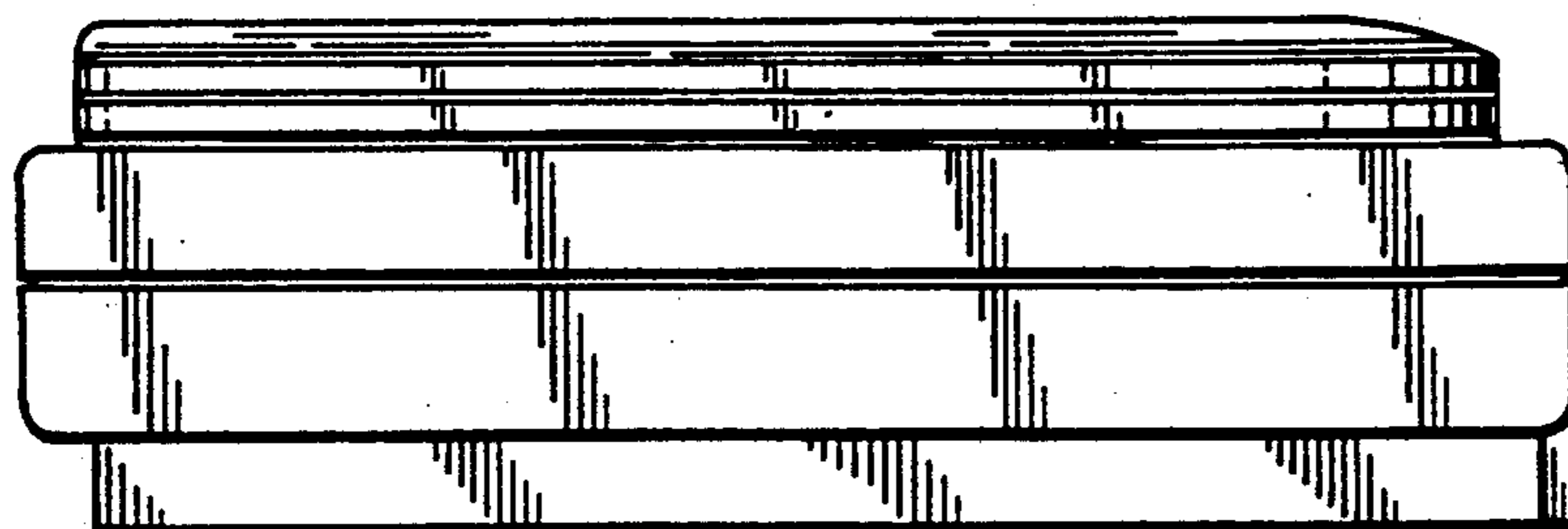

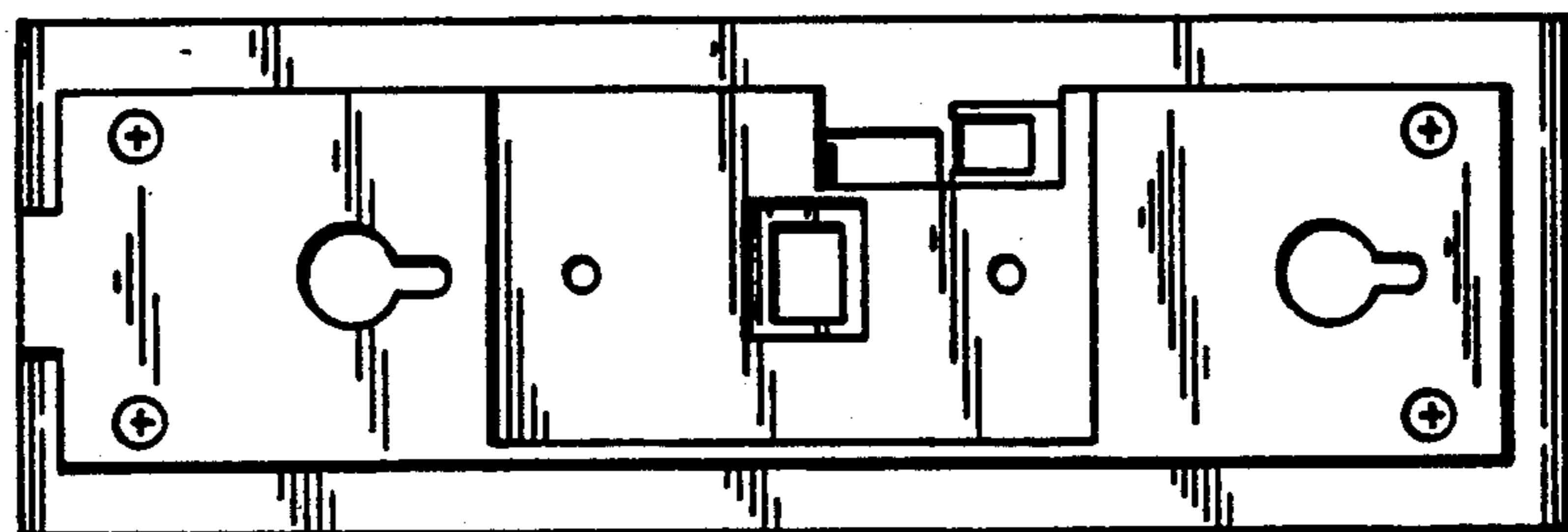

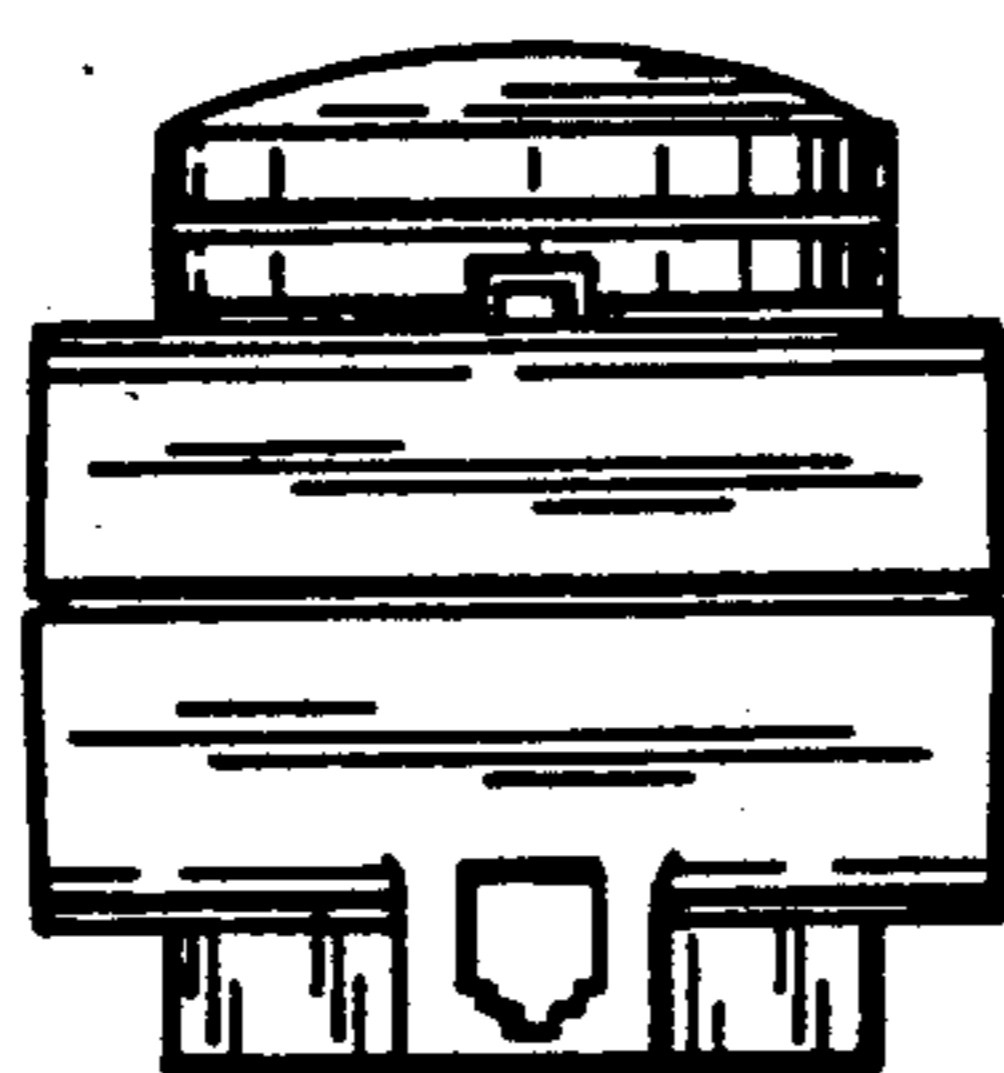

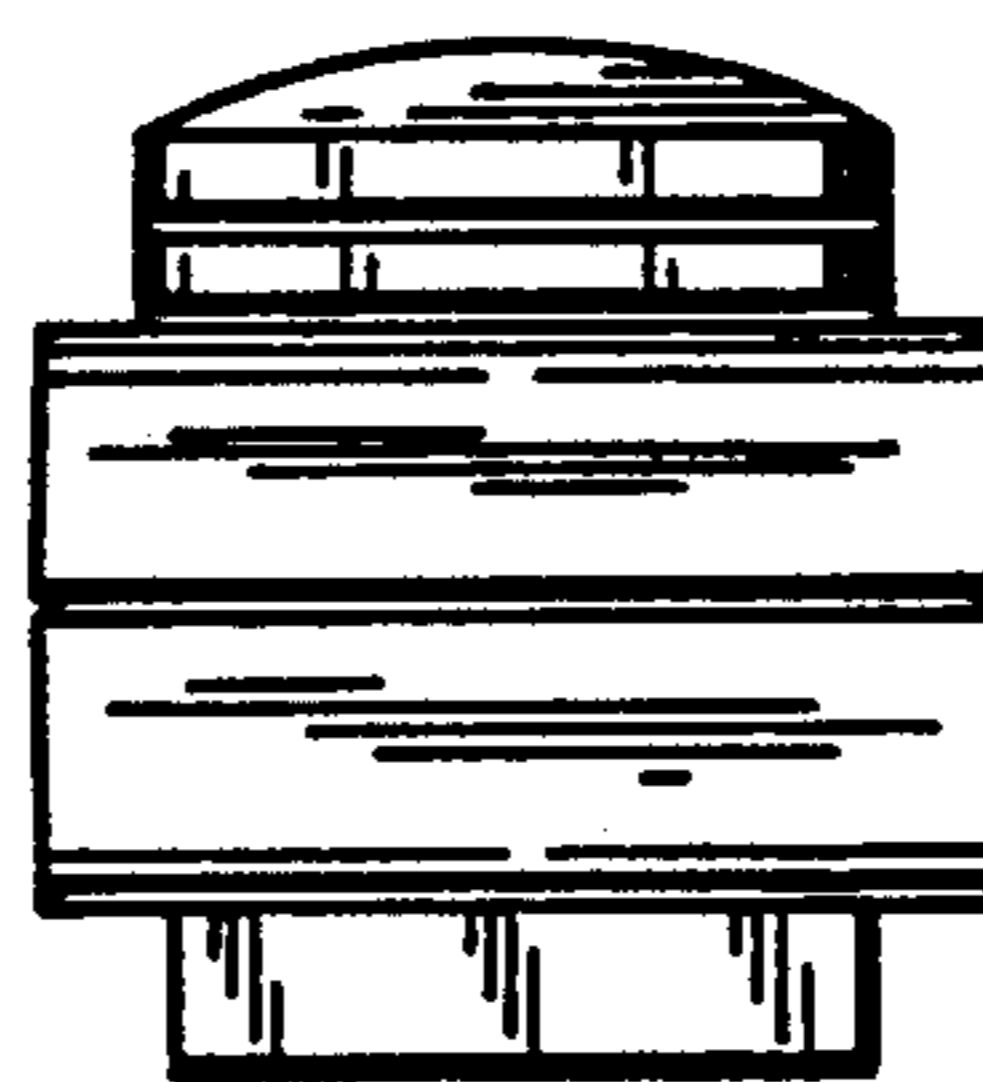

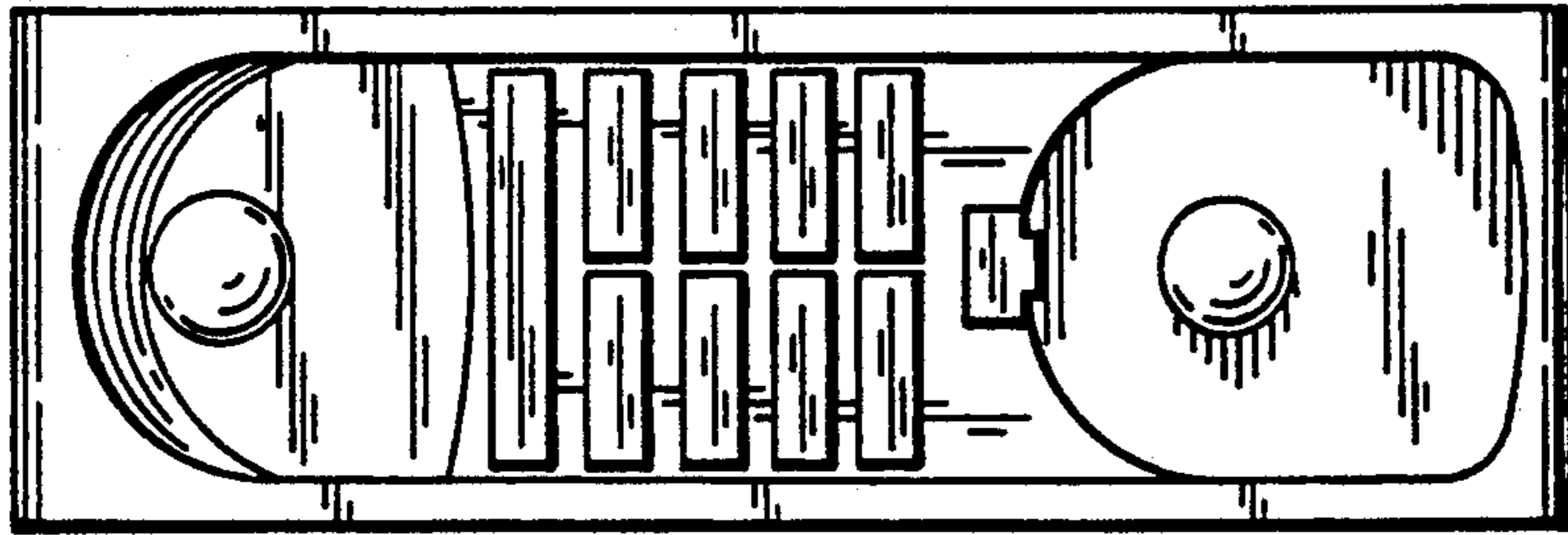

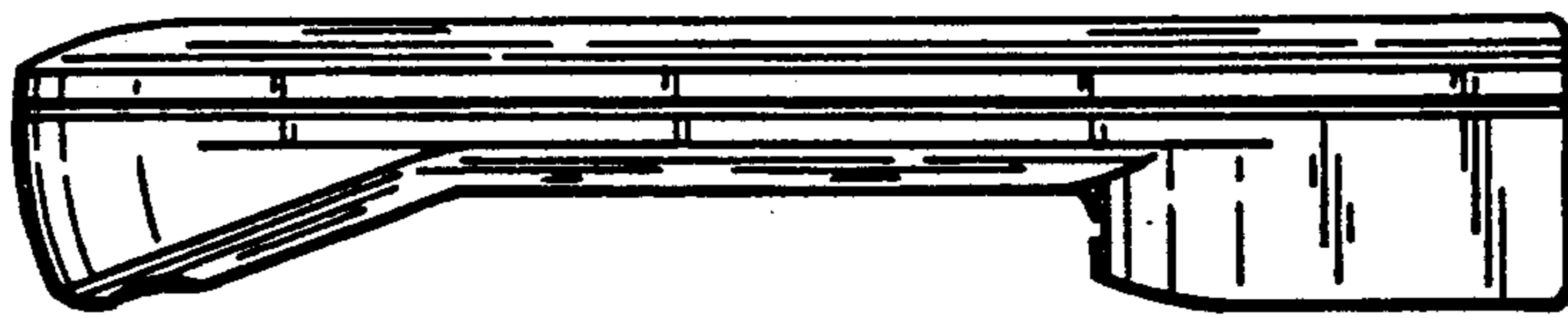

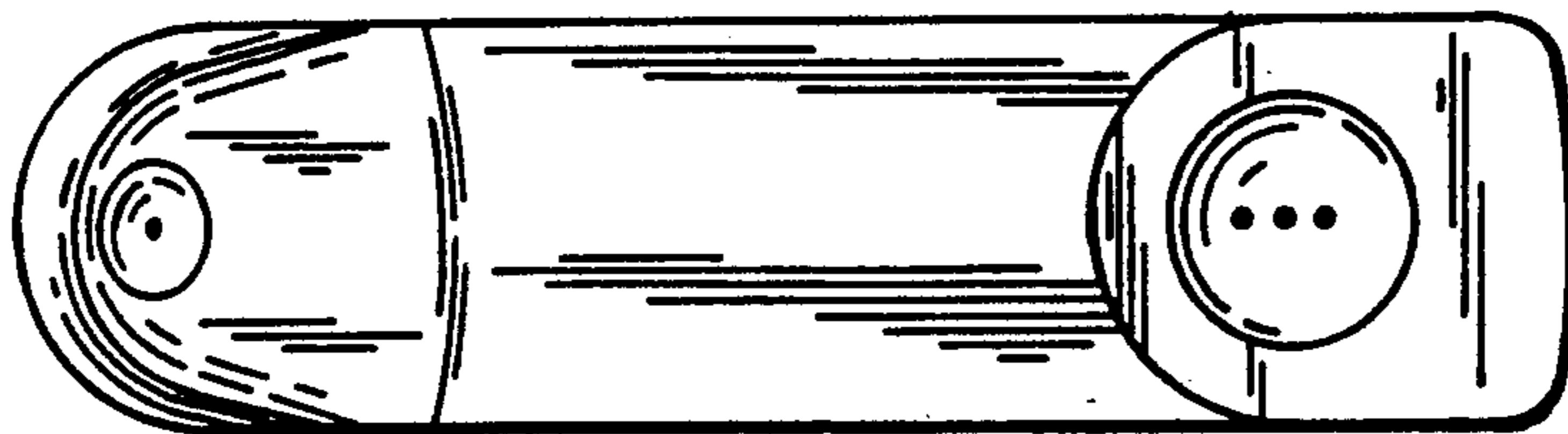

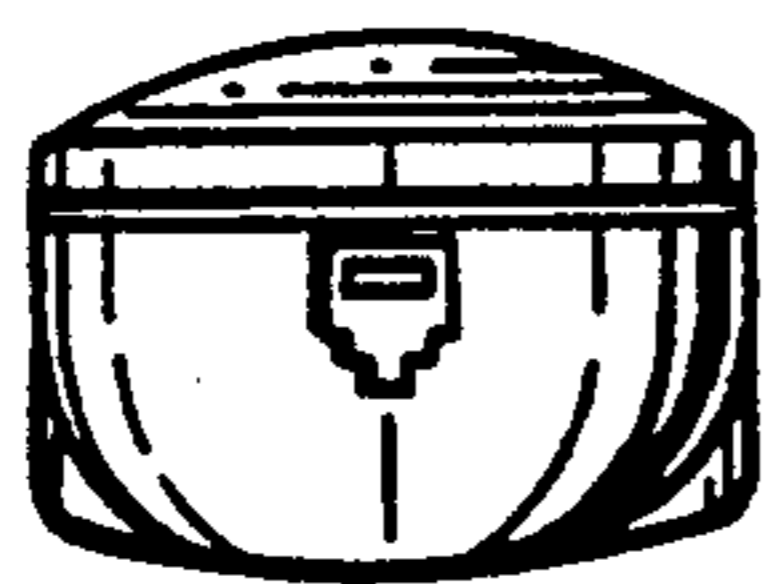

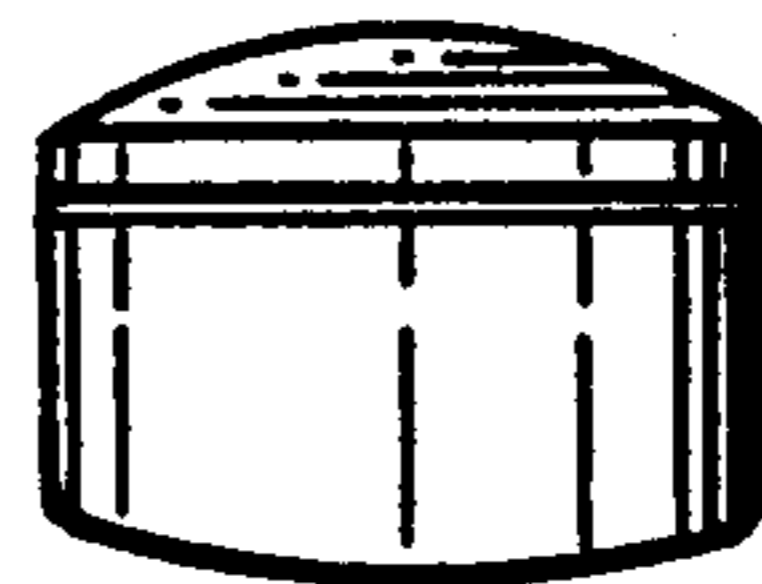

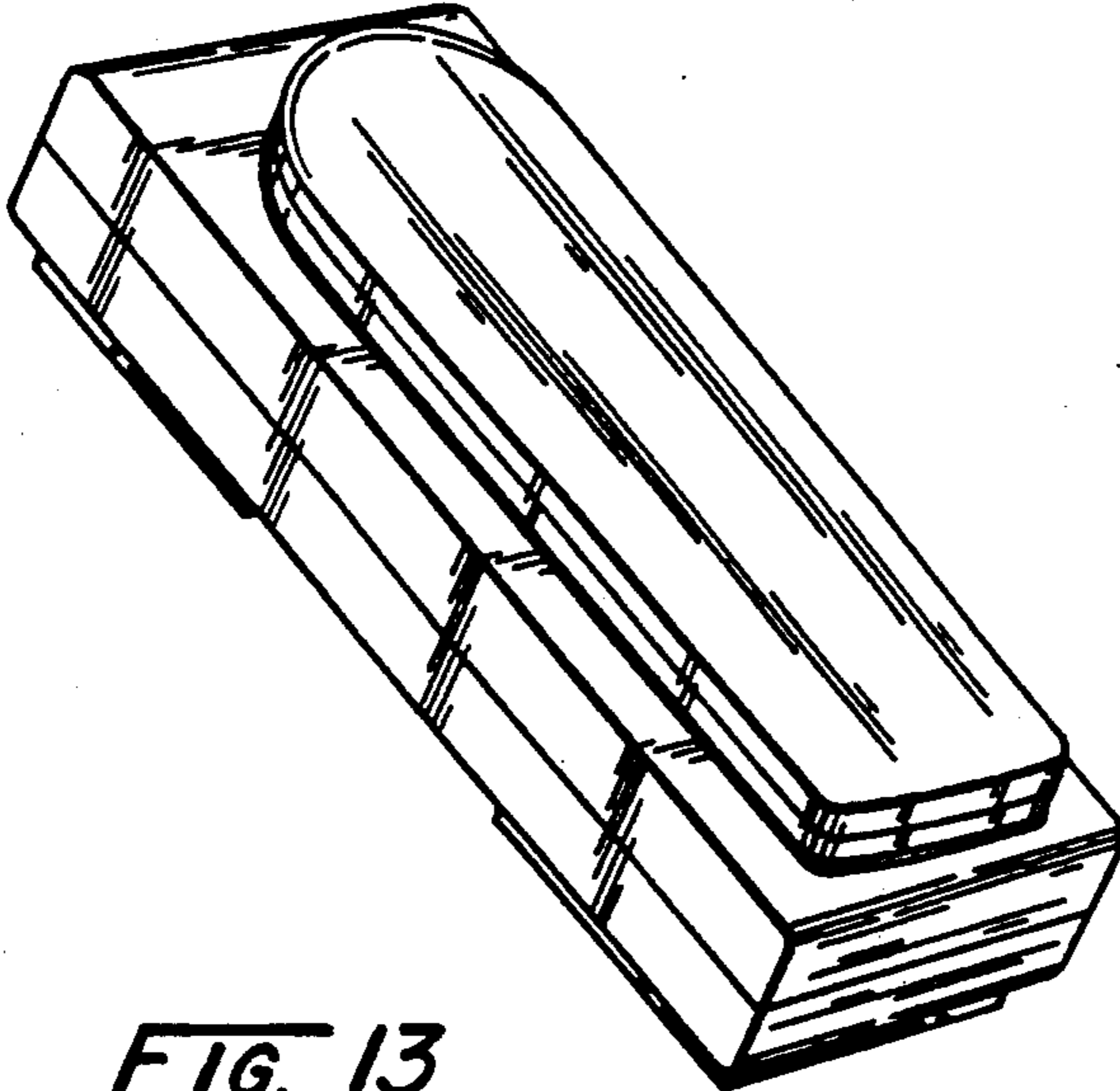

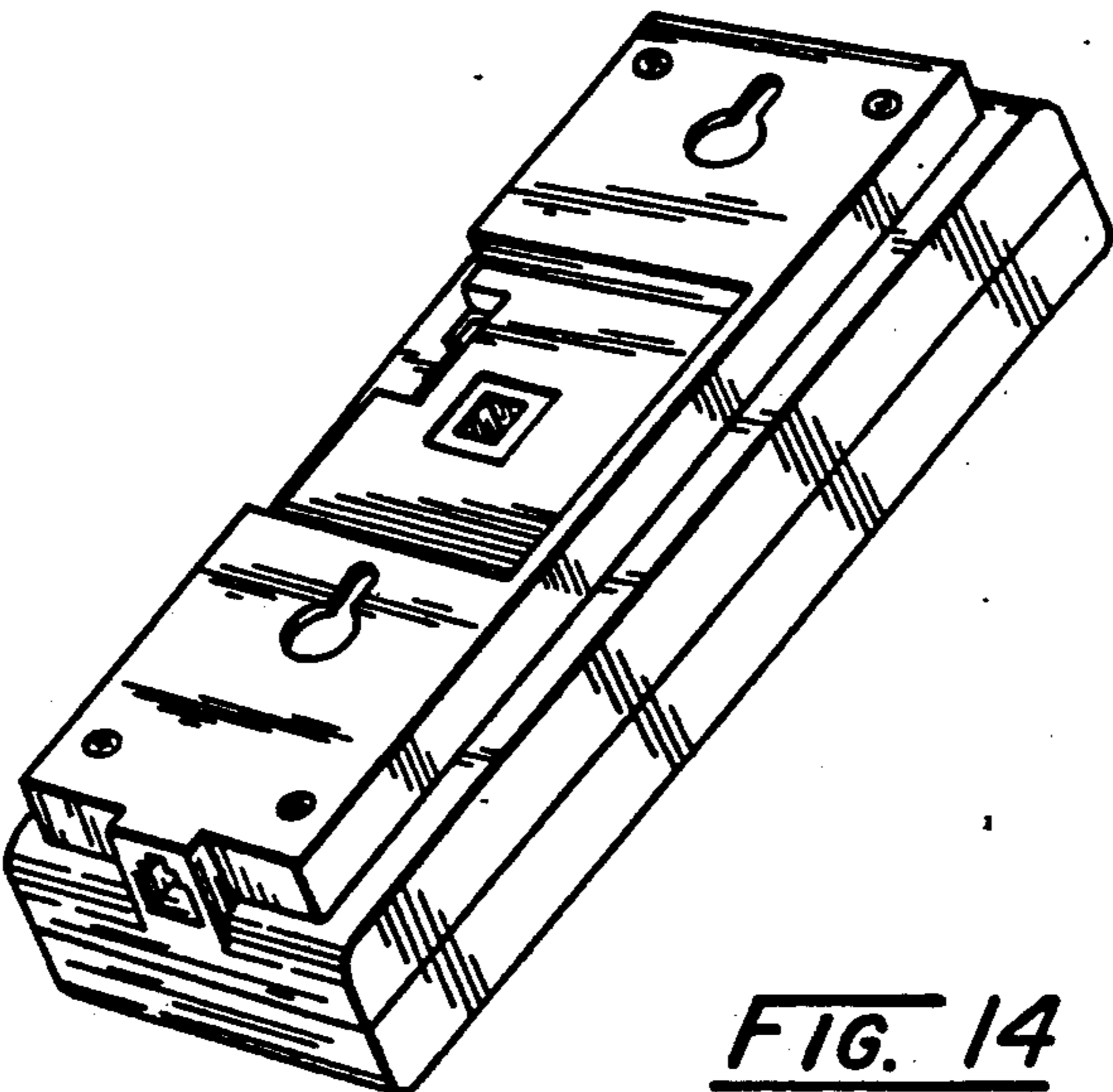
