## DESCRIPTION

FIG. 1 is a front, top and right side perspective view of  
a telephone set showing my new design in cradled rela-  
tionship;

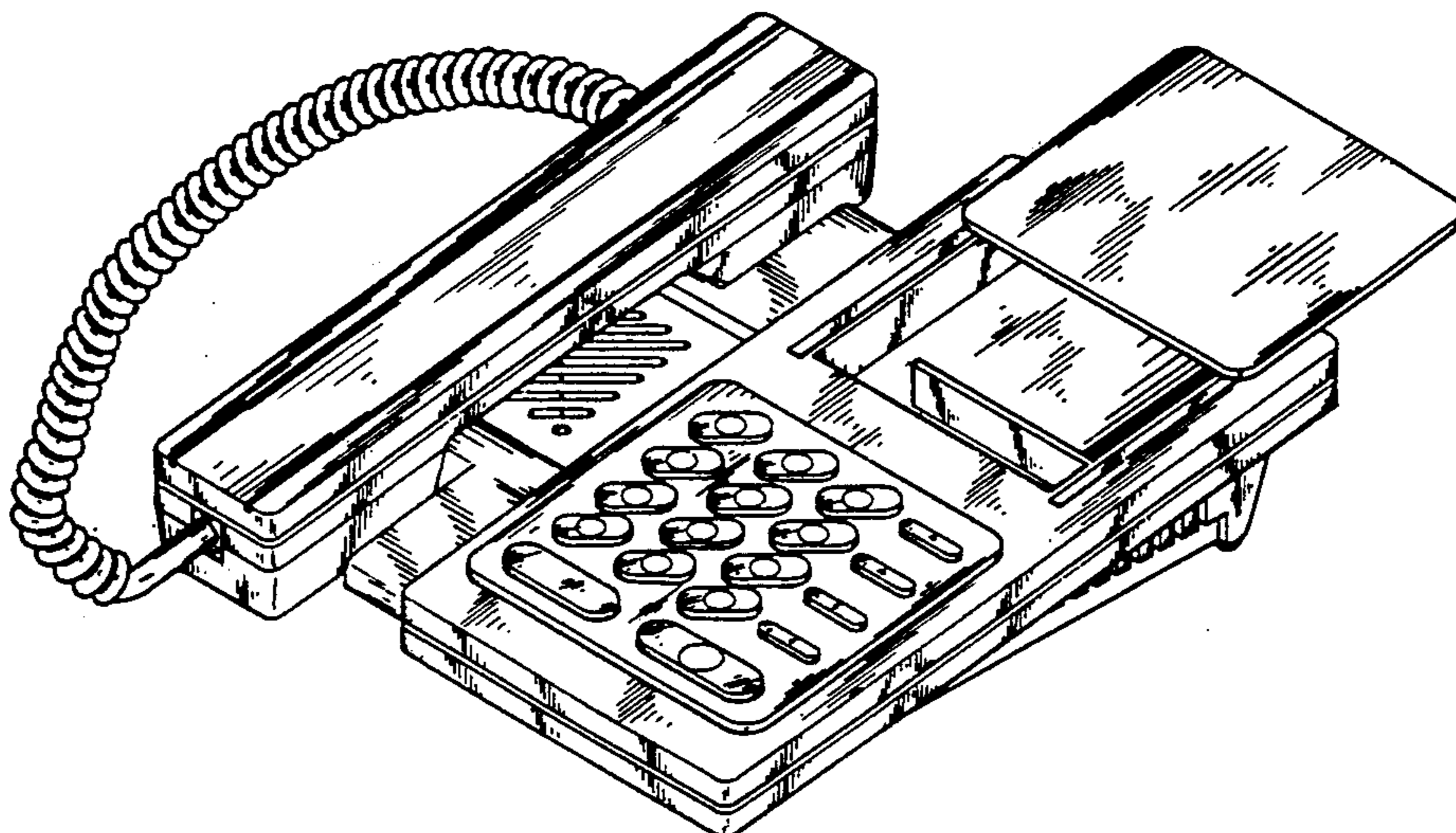
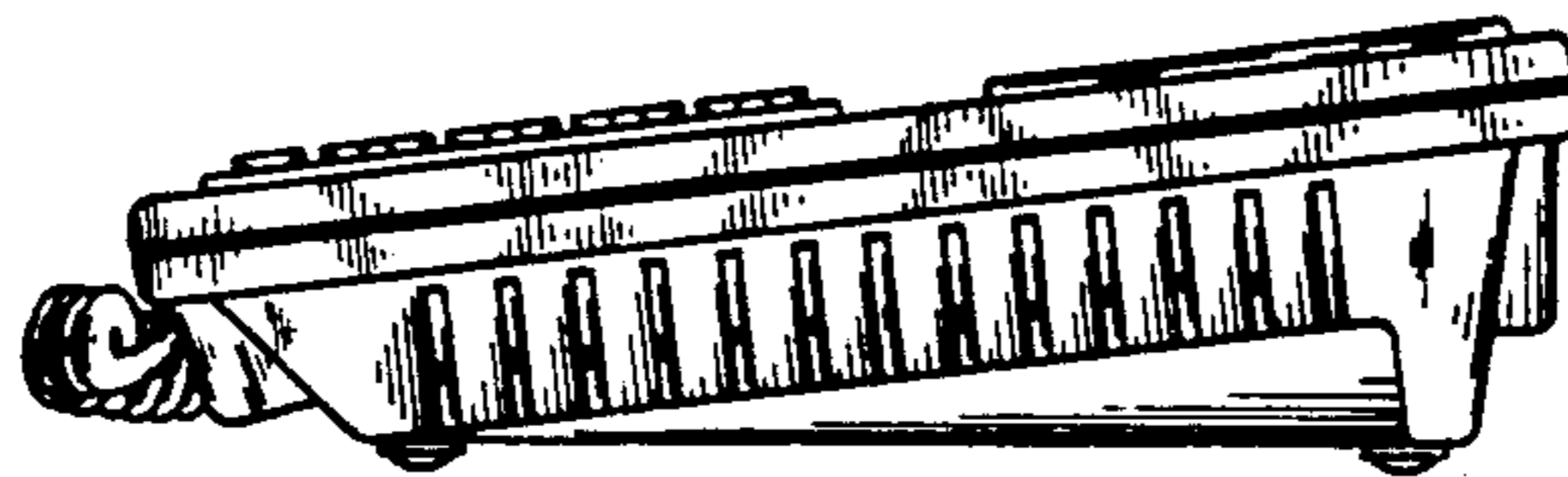
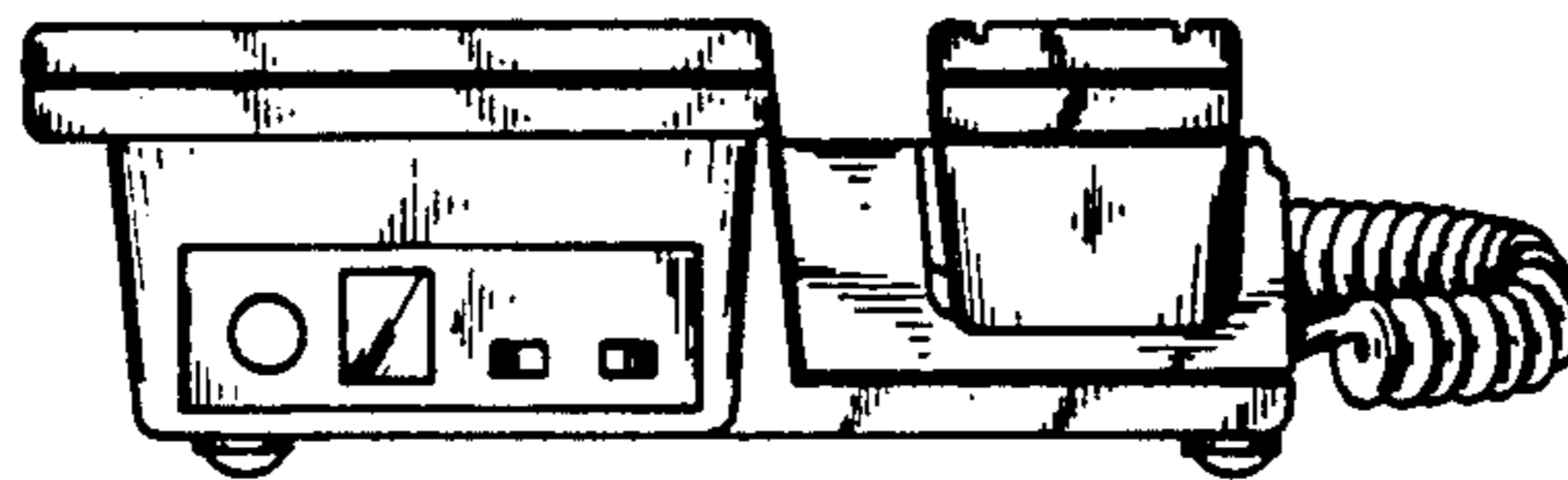
FIG. 2 is a top view thereof;

FIGS. 3 and 4 are respectively front and rear end eleva-  
tional views thereof;

FIG. 5 is a bottom plan view of the cradled set shown  
in FIG. 1;

tional views thereof; and,

FIG. 8 is a front, top and rightside perspective view of  
the set with the cover unit adjacent the key pad slidably  
displaced to disclose a storage cavity.



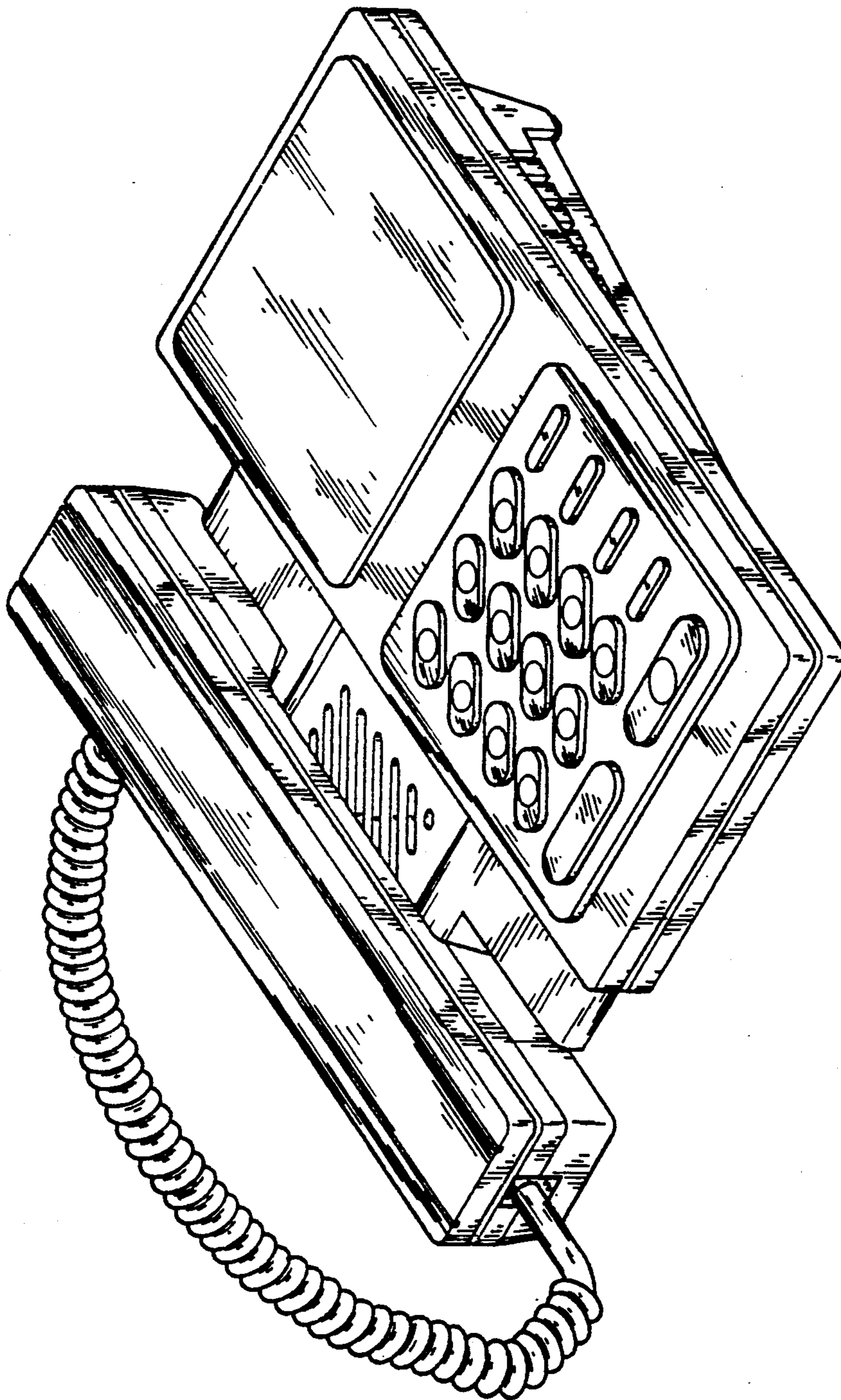

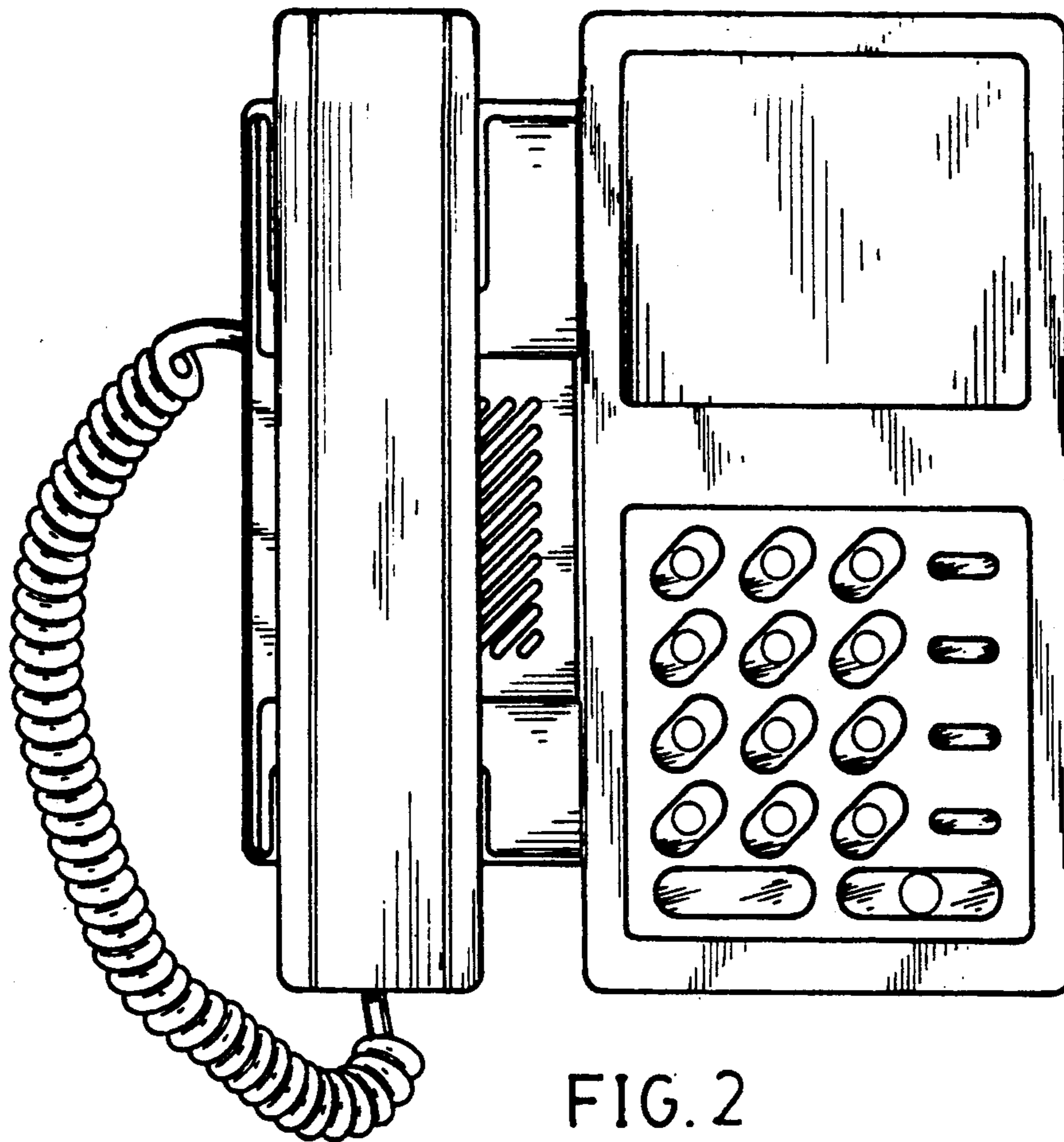

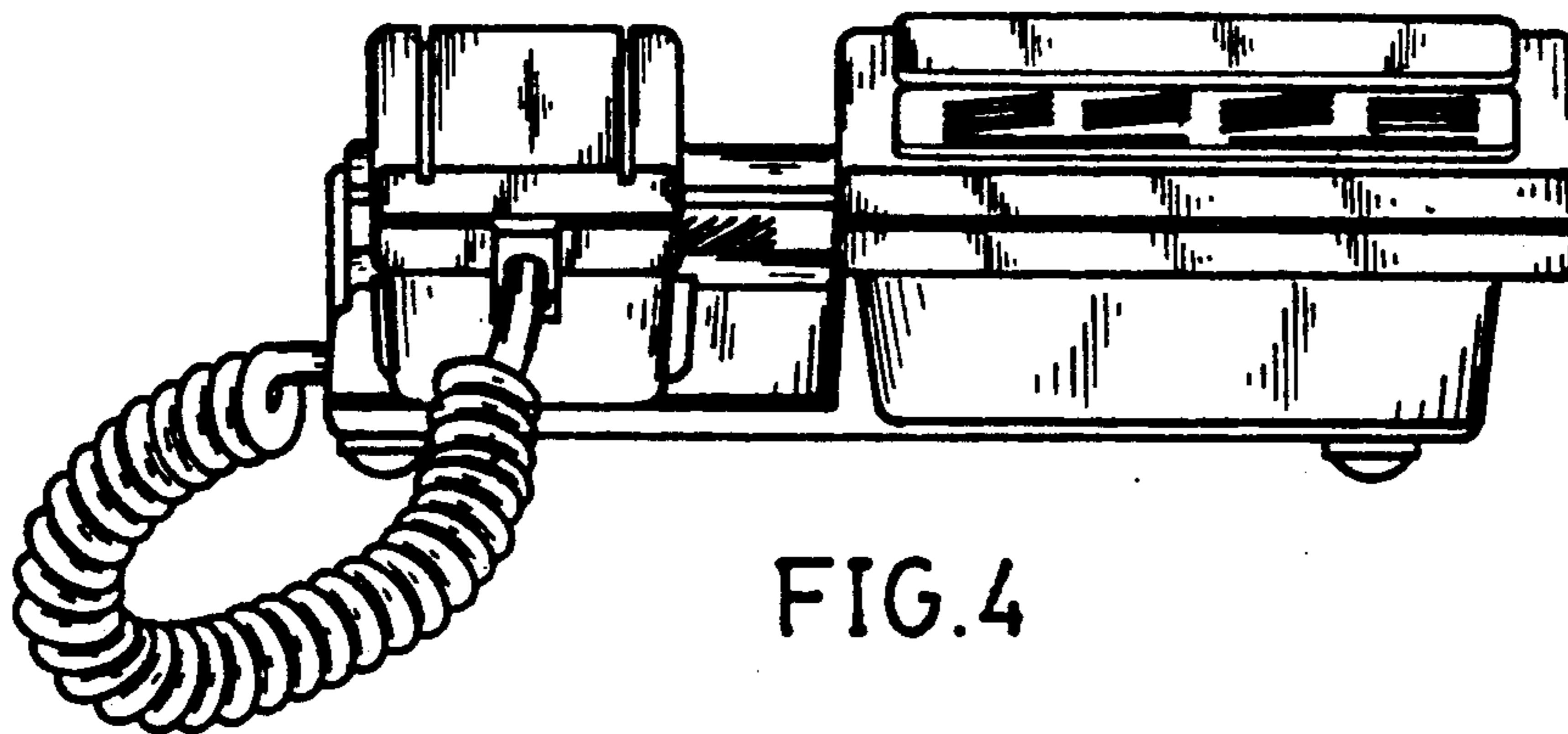

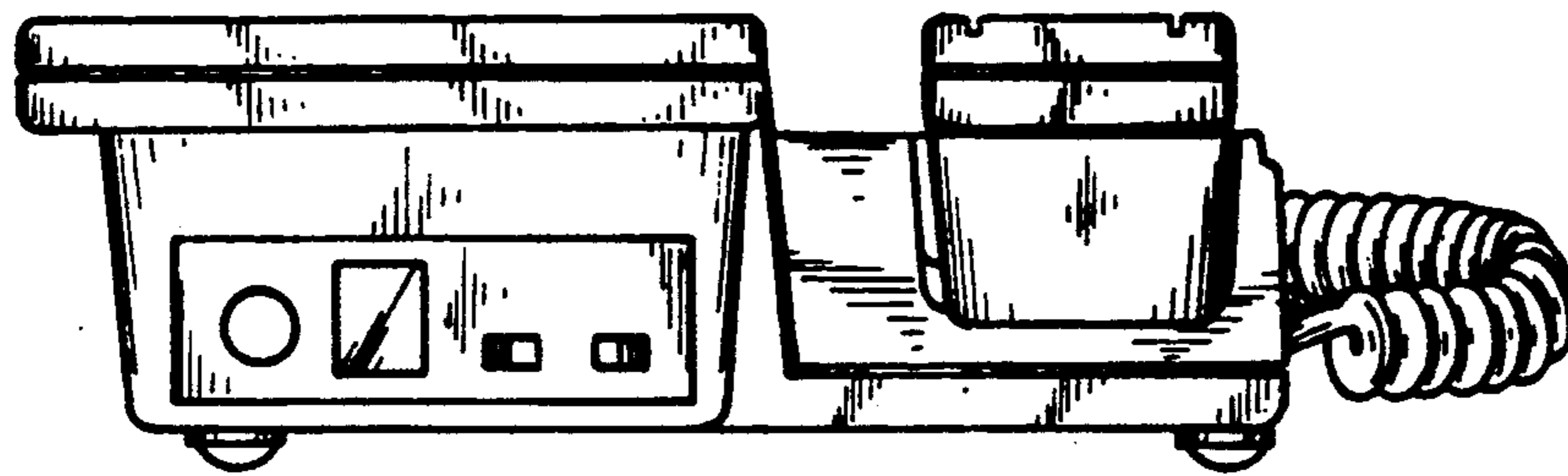

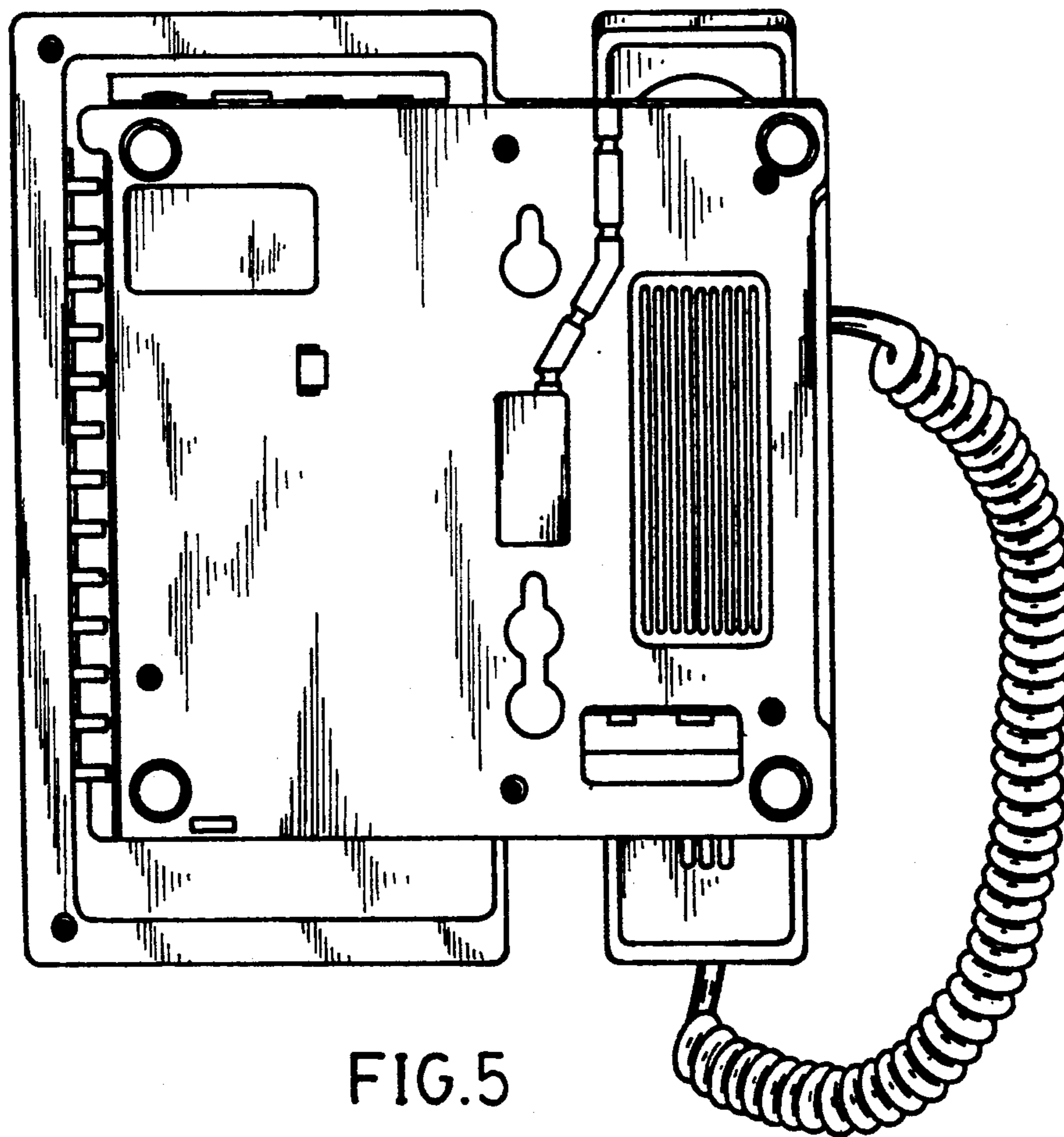

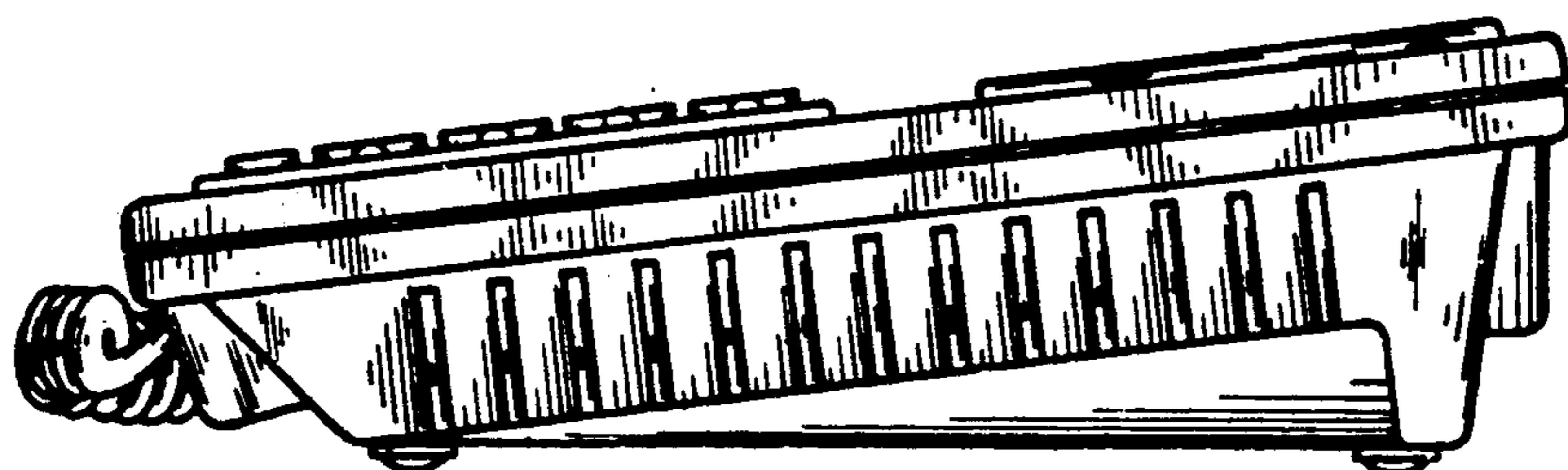

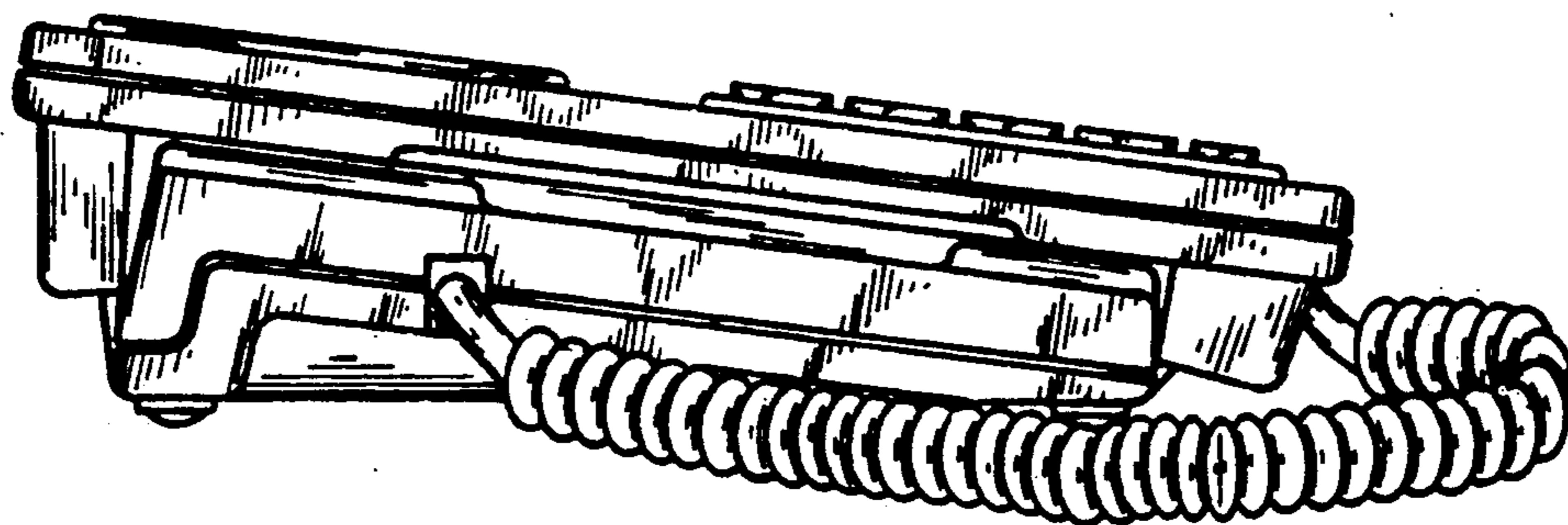

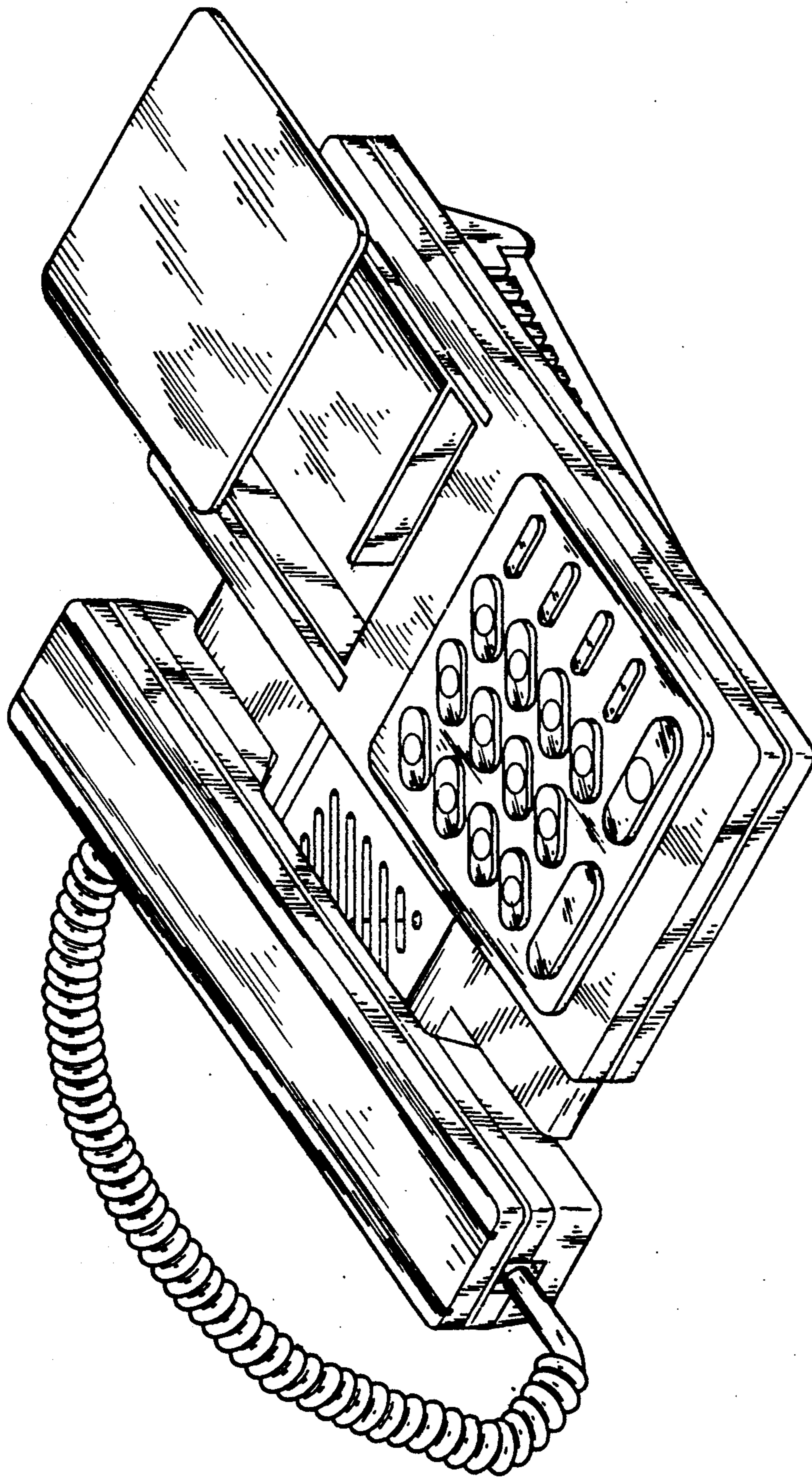
