The ornamental design for a foldable sanitary toilet seat protection cover, as shown and described.

DESCRIPTION

FIG. 1 is a top, right side and front perspective view of a foldable sanitary toilet seat protection cover, showing my new design;

FIG. 2 is a bottom, left side and rear perspective view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a left side elevational view thereof;

FIG. 6 is a front elevational view thereof;

FIG. 7 is a right side elevational view thereof;

FIG. 8 is a rear elevational view thereof;

FIG. 9 is an enlarged cross sectional view of a portion of a foldable sanitary toilet seat protection cover, taken along lines 9—9 of FIG. 1;

FIG. 10 shows a top, front and right side perspective view thereof in a partially folded condition;

FIG. 11 shows a top, front and right side perspective view thereof in a more folded condition; and,

FIG. 12 shows a top, front and right side perspective view thereof in completely folded and stowable condition.

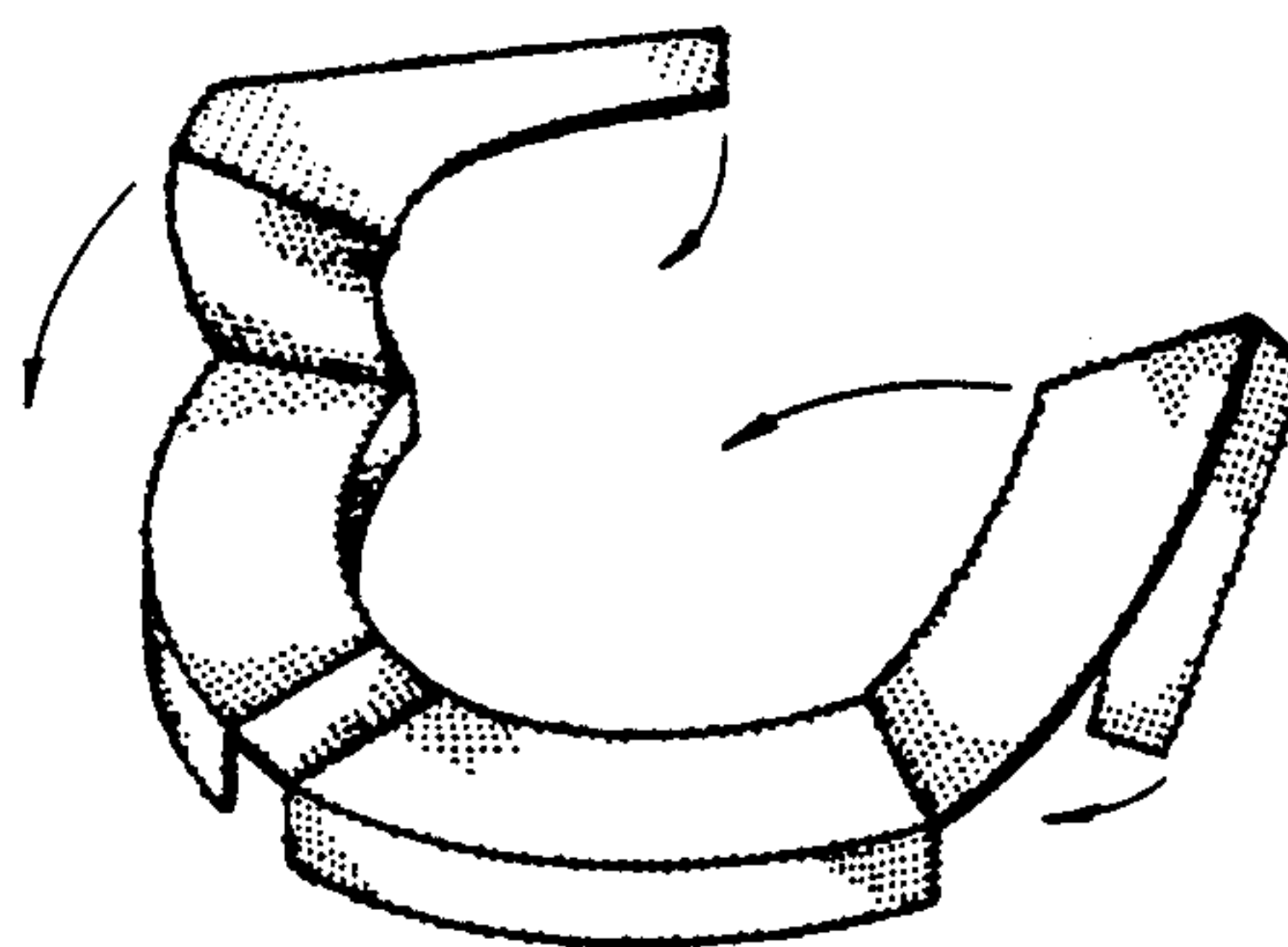
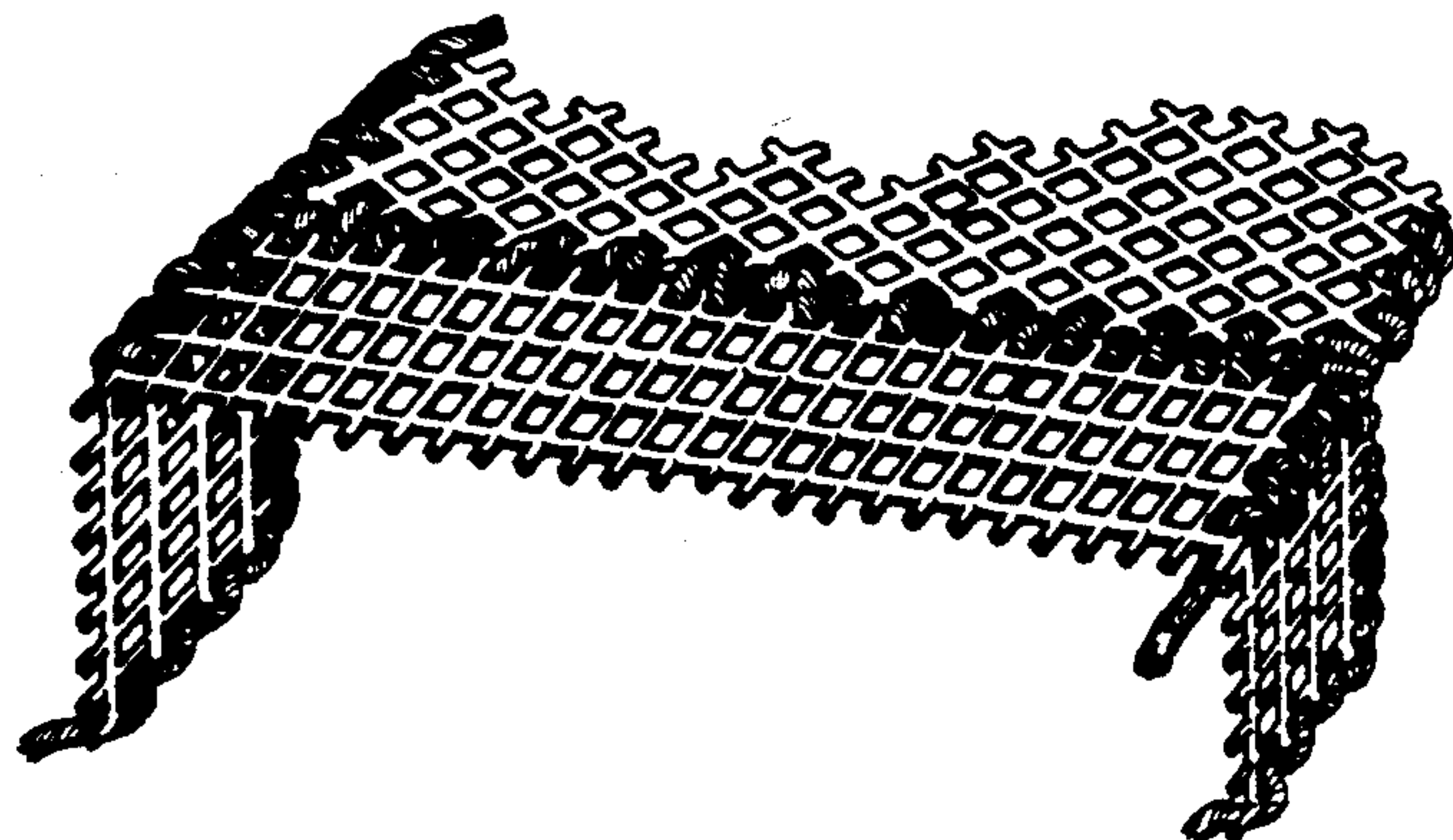
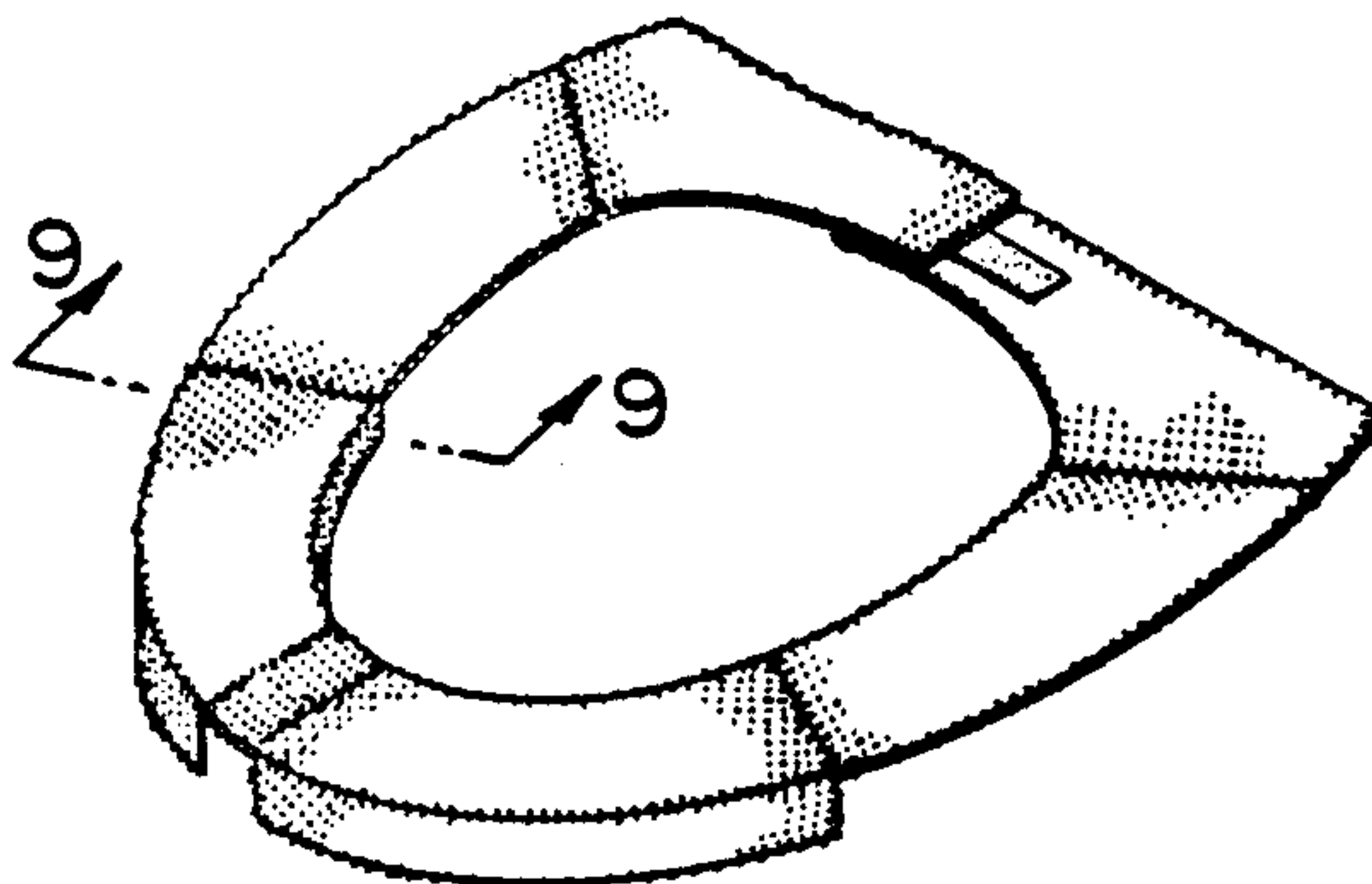

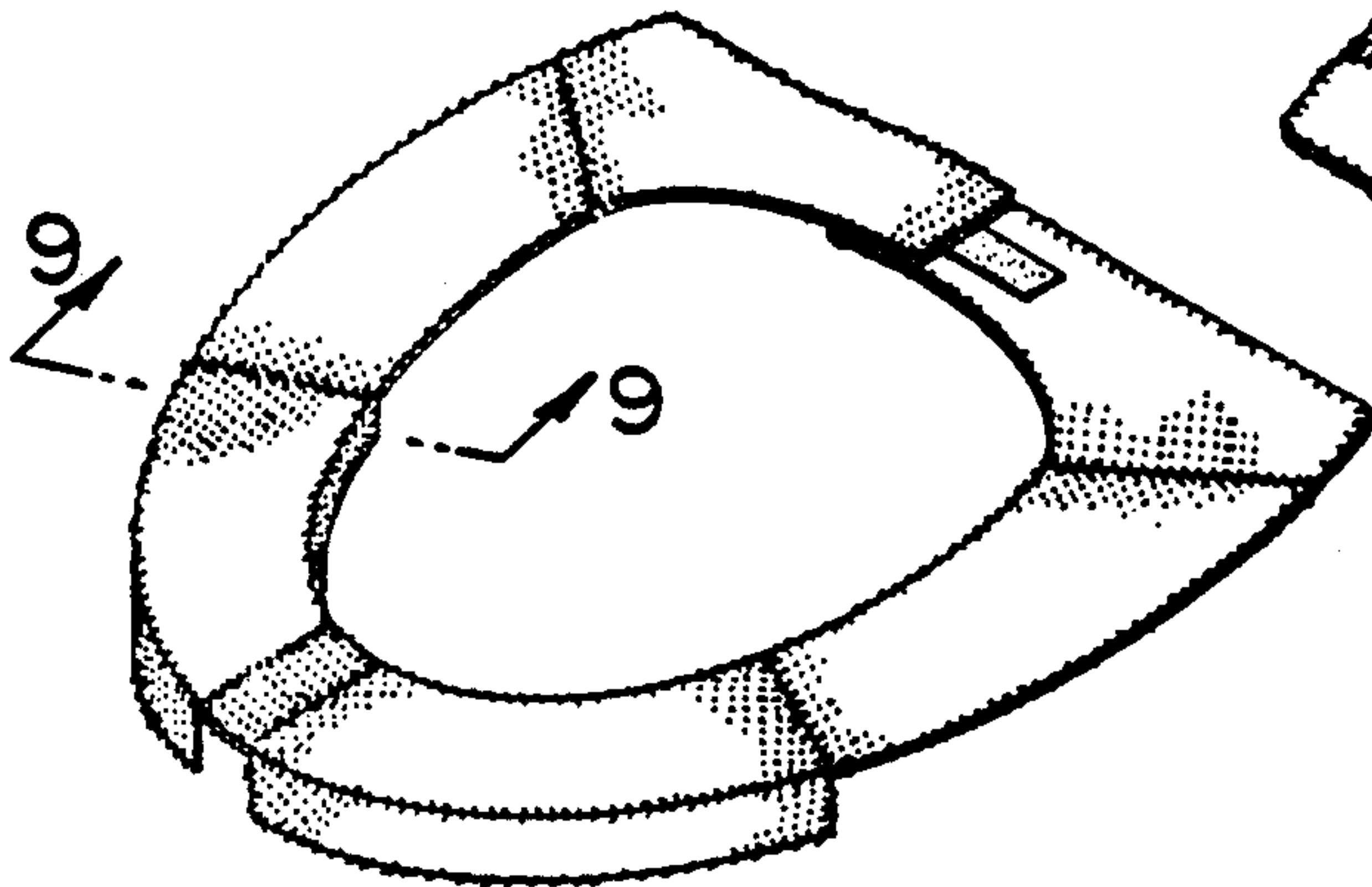

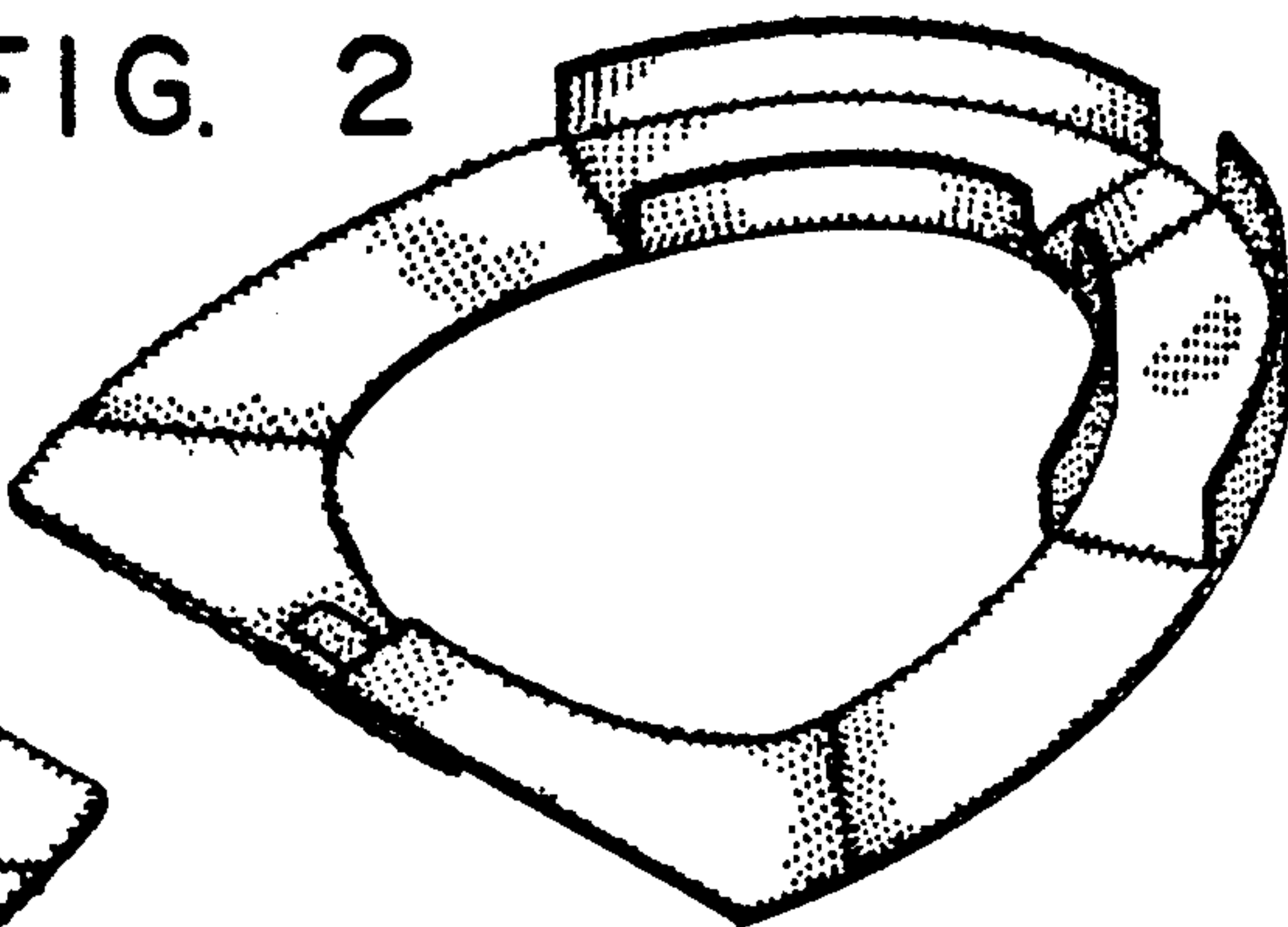

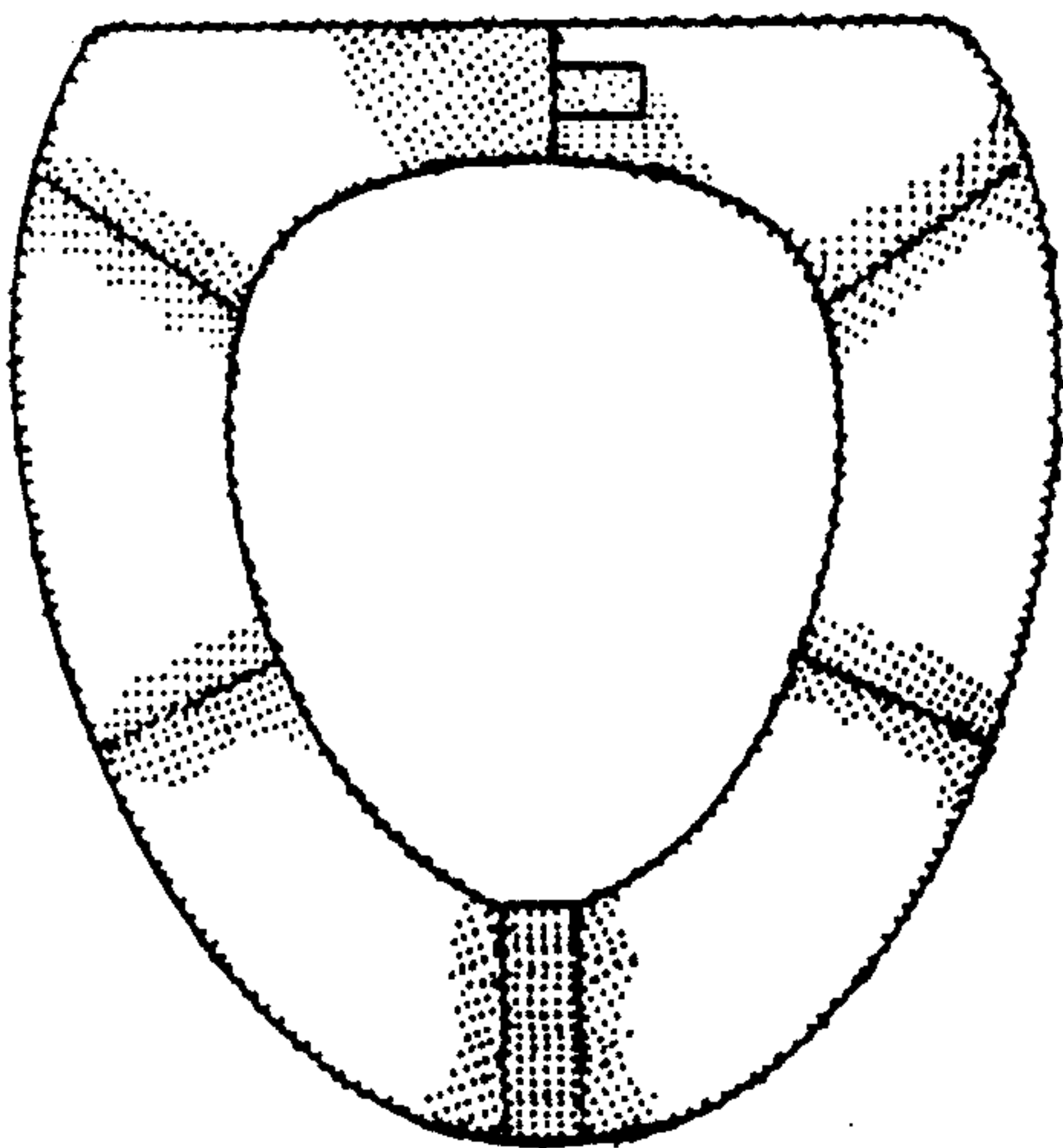

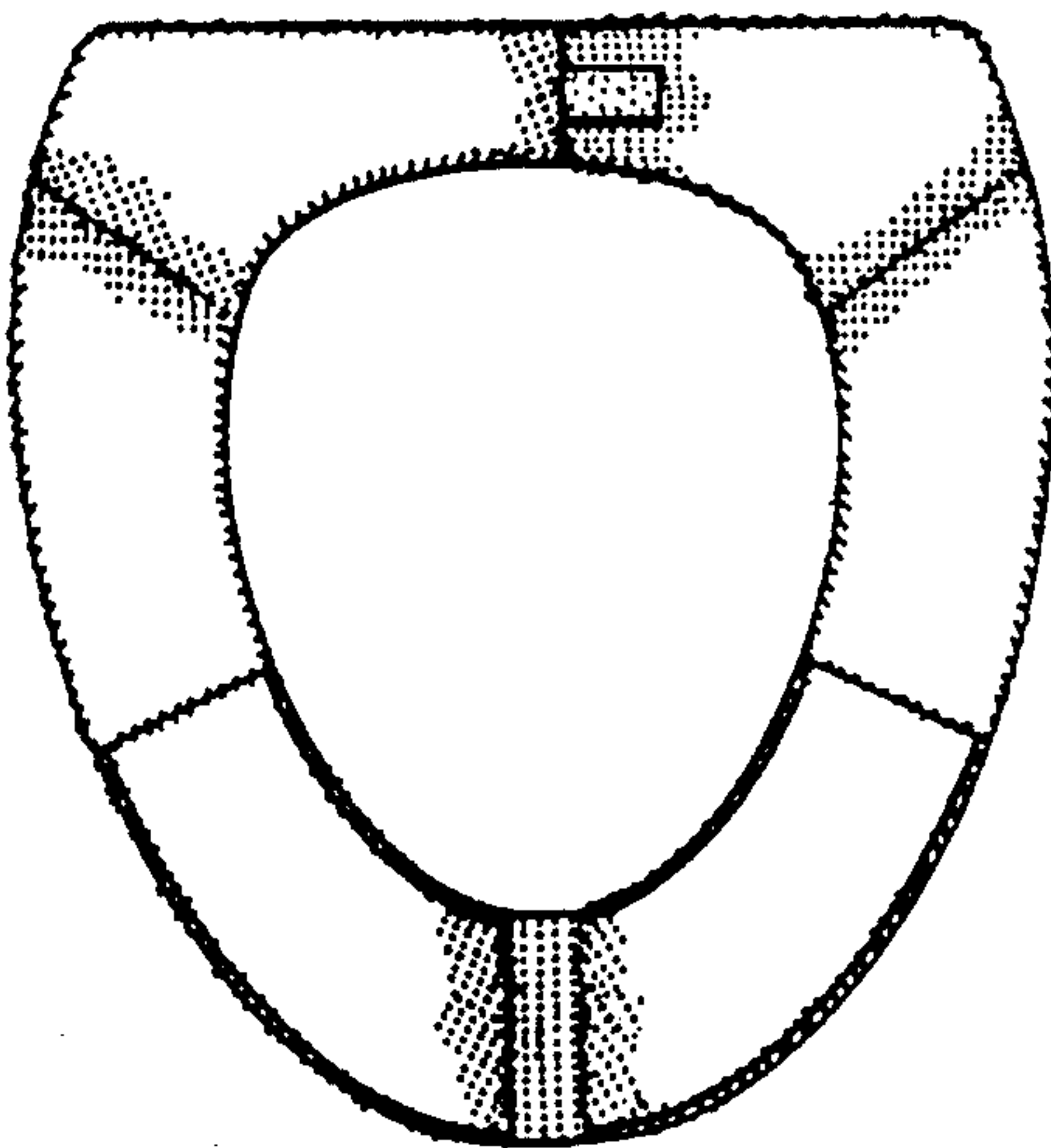

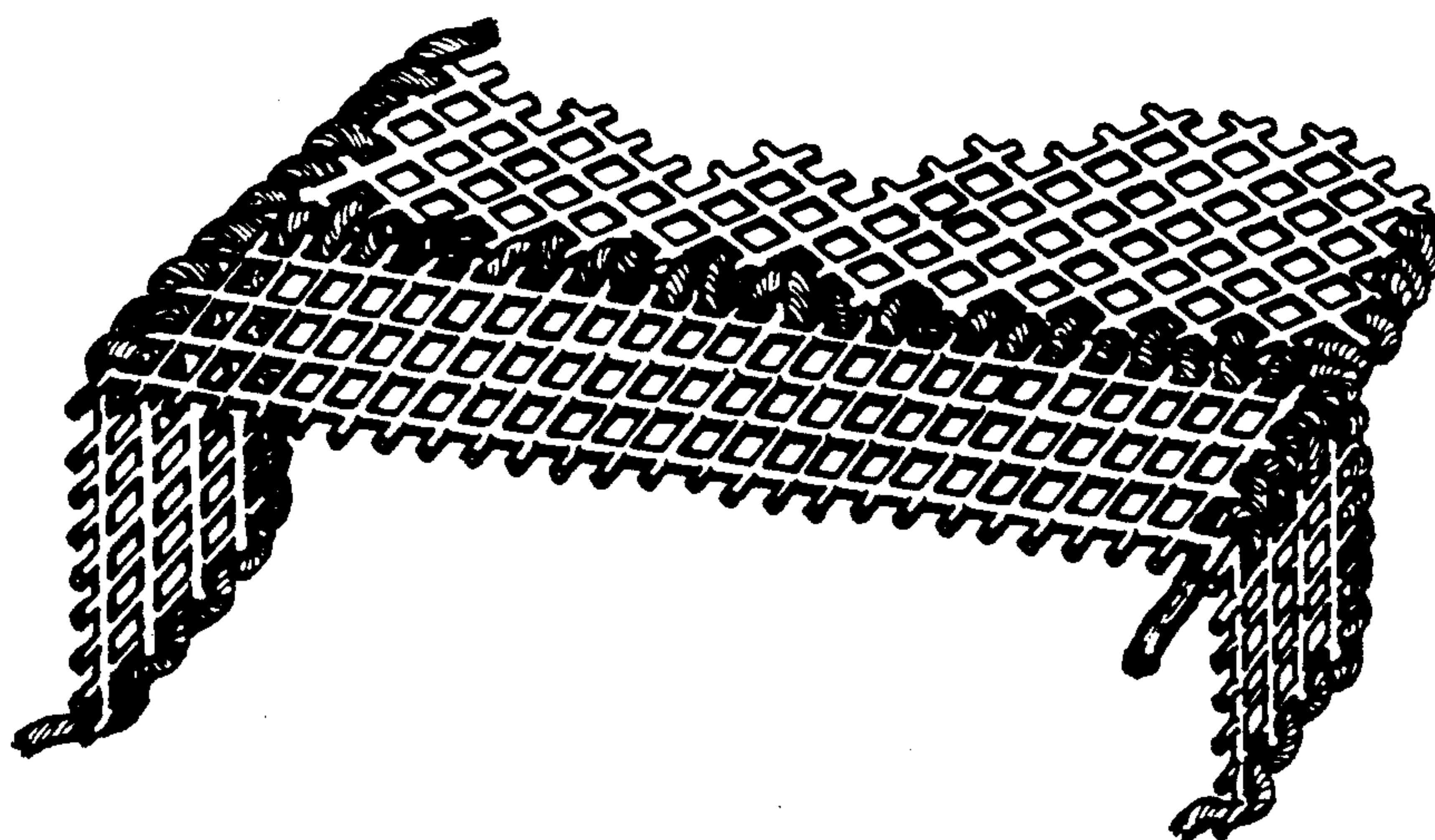

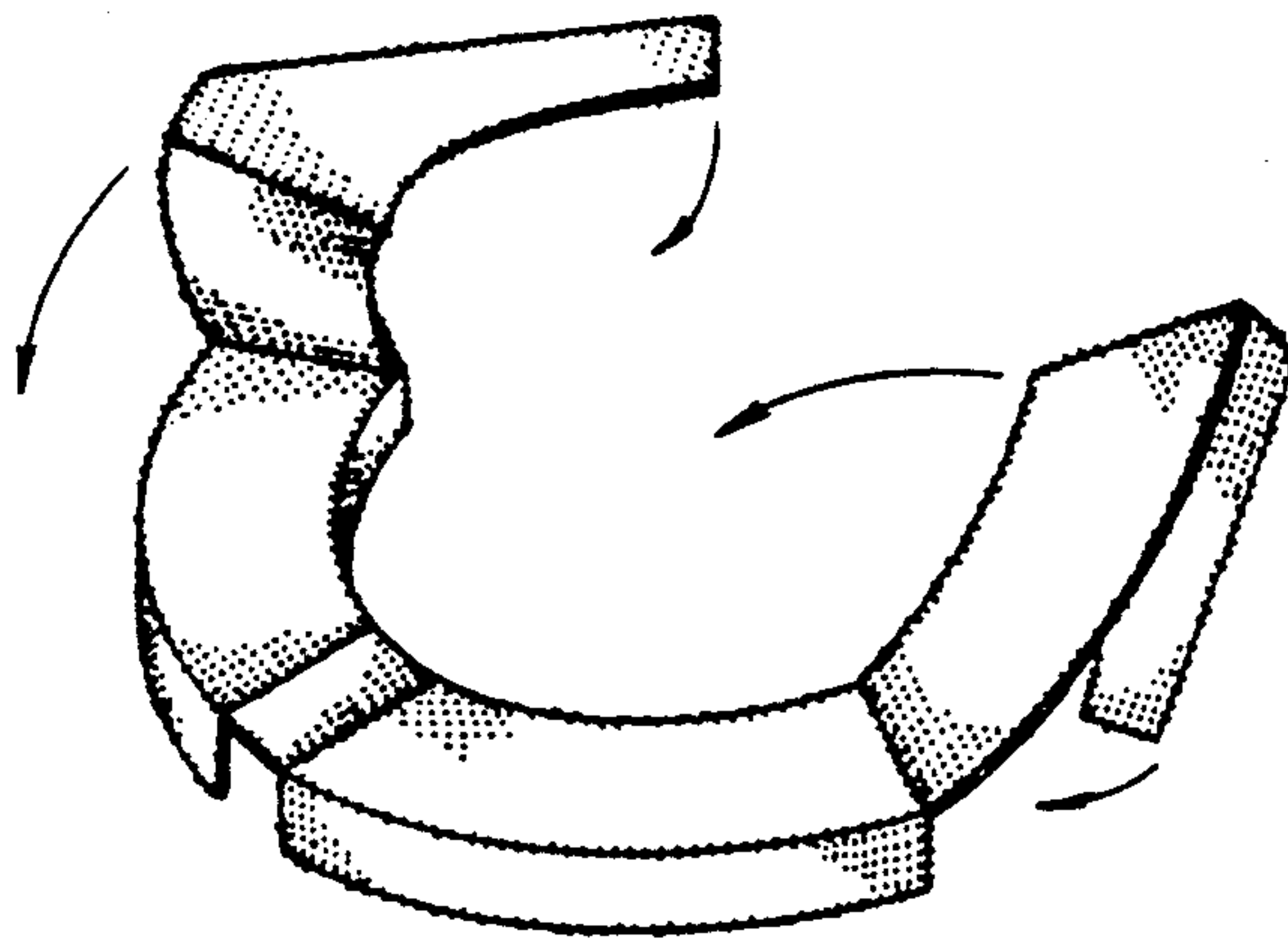

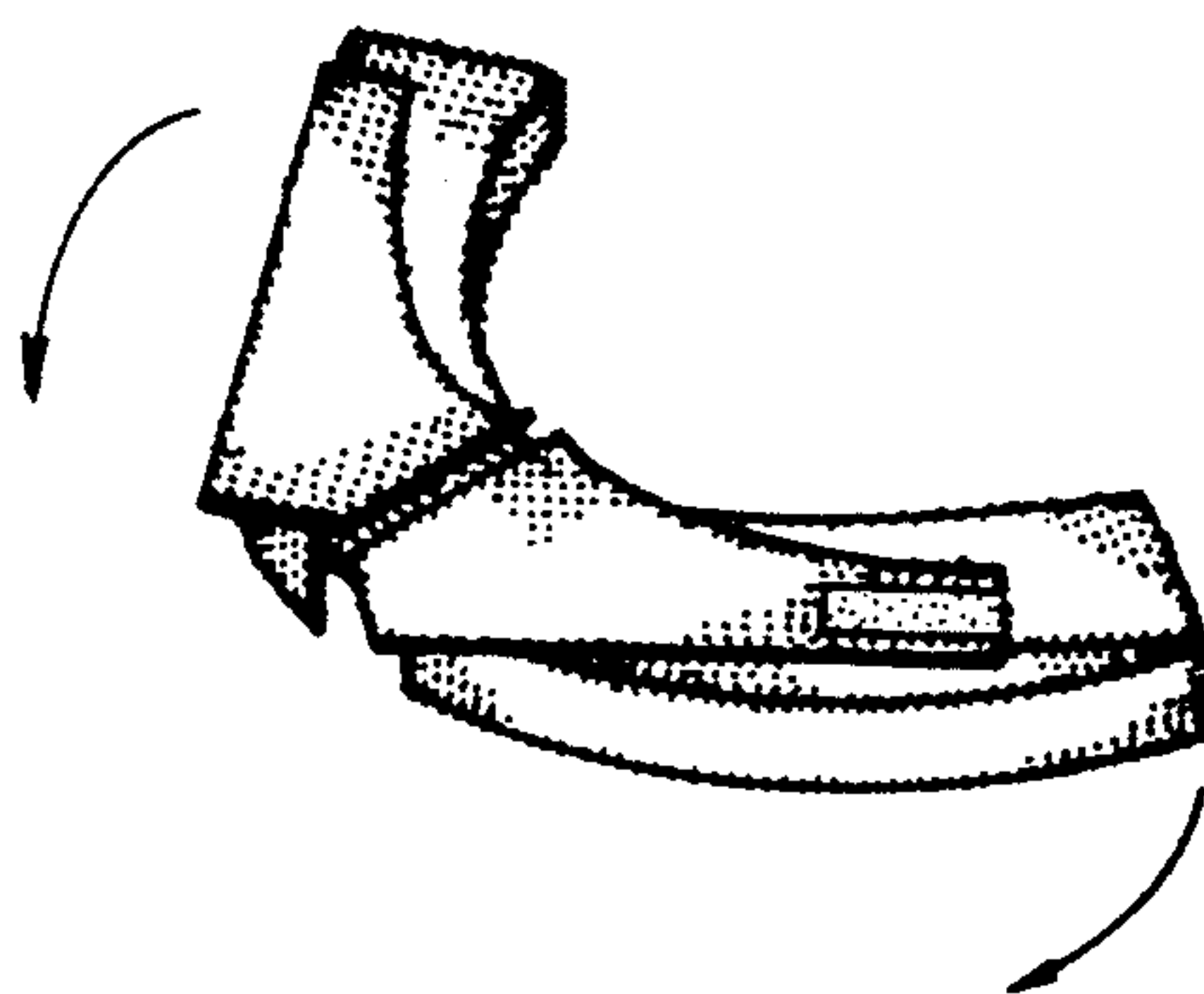
