[57] **CLAIM**

The ornamental design for a combined sterilizing container and strainer inserts, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a combined sterilizing container and strainer inserts showing my new design in disassembled condition;

FIG. 2 is a top plan view of the receptacle thereof in assembled condition;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a right side elevational view thereof the left side elevational view being a mirror image thereto;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a cross-sectional view thereof taken along the line 7—7 of FIG. 2;

FIG. 8 is a top plan view of the larger strainer insert;

FIG. 9 is a rear elevational view thereof;

FIG. 10 is front elevational view thereof;

FIG. 11 is a right side elevational view thereof, the left side elevational view being a mirror image thereto;

FIG. 12 is a bottom plan view thereof;

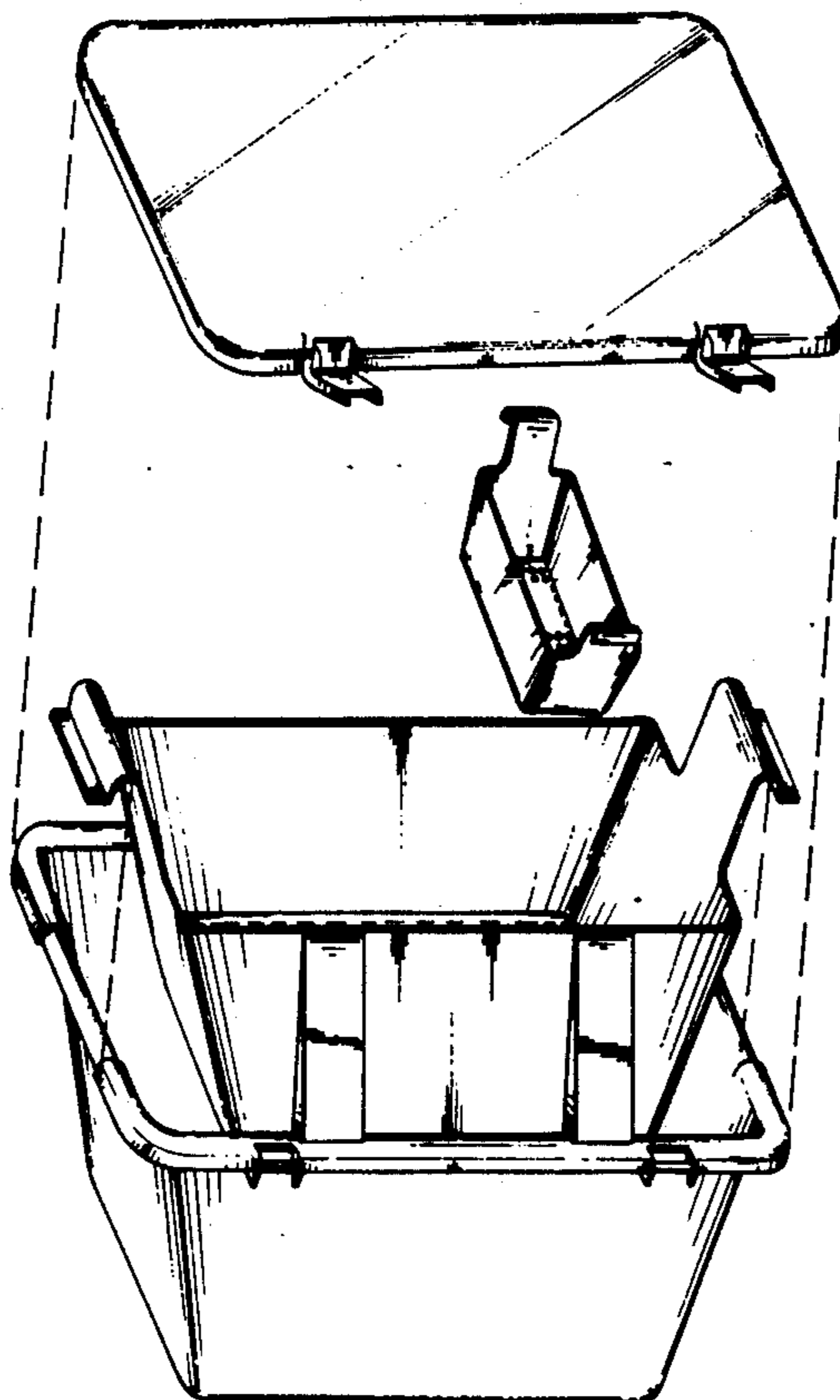
FIG. 13 is a top plan view of the smaller insert;

FIG. 14 is a front elevational view thereof, the rear side elevational view being a mirror image thereto;

FIG. 15 is a right side elevational view thereof, the left side elevational view being a mirror image thereto;

FIG. 17 is a cross-sectional view thereof taken along the line 17—17 of FIG. 2.



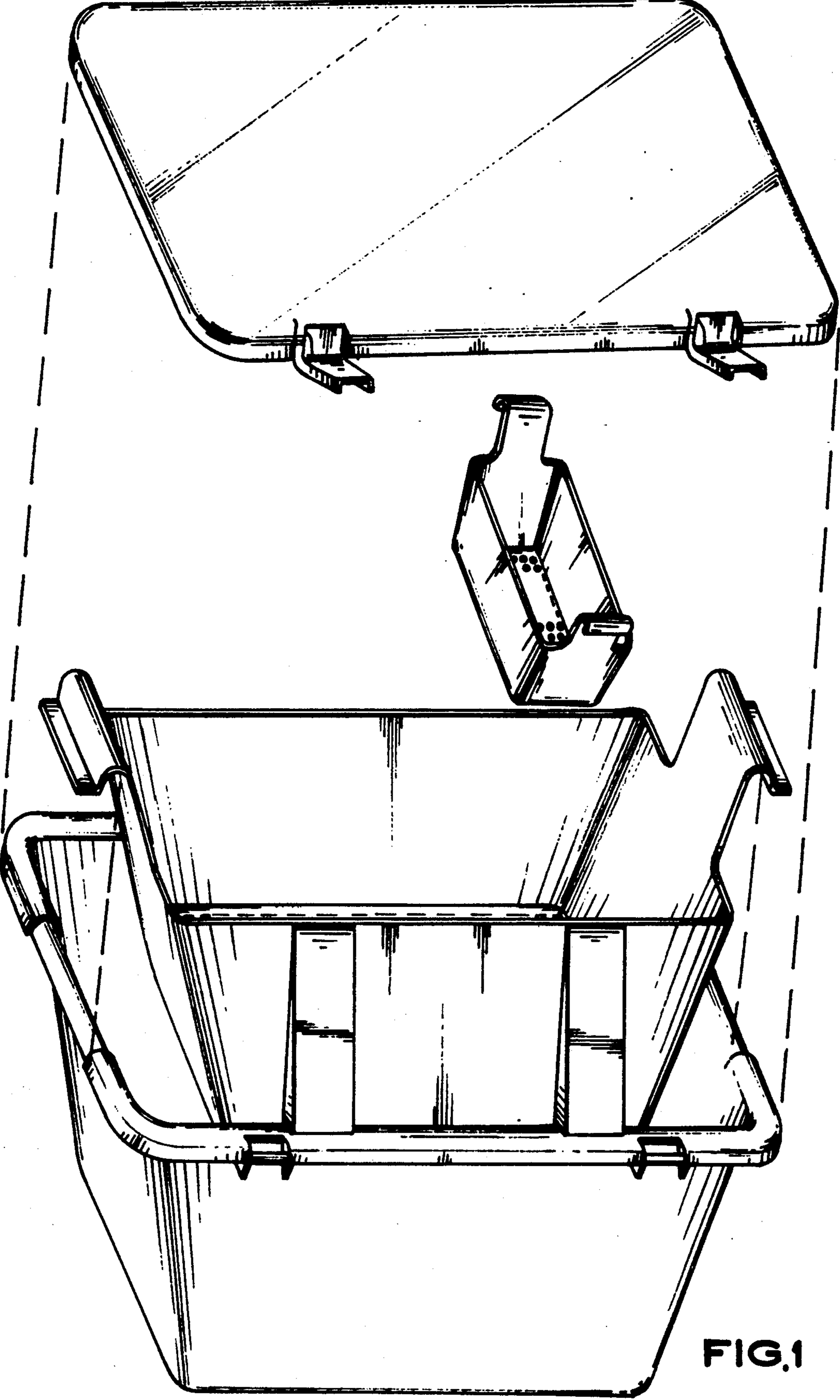

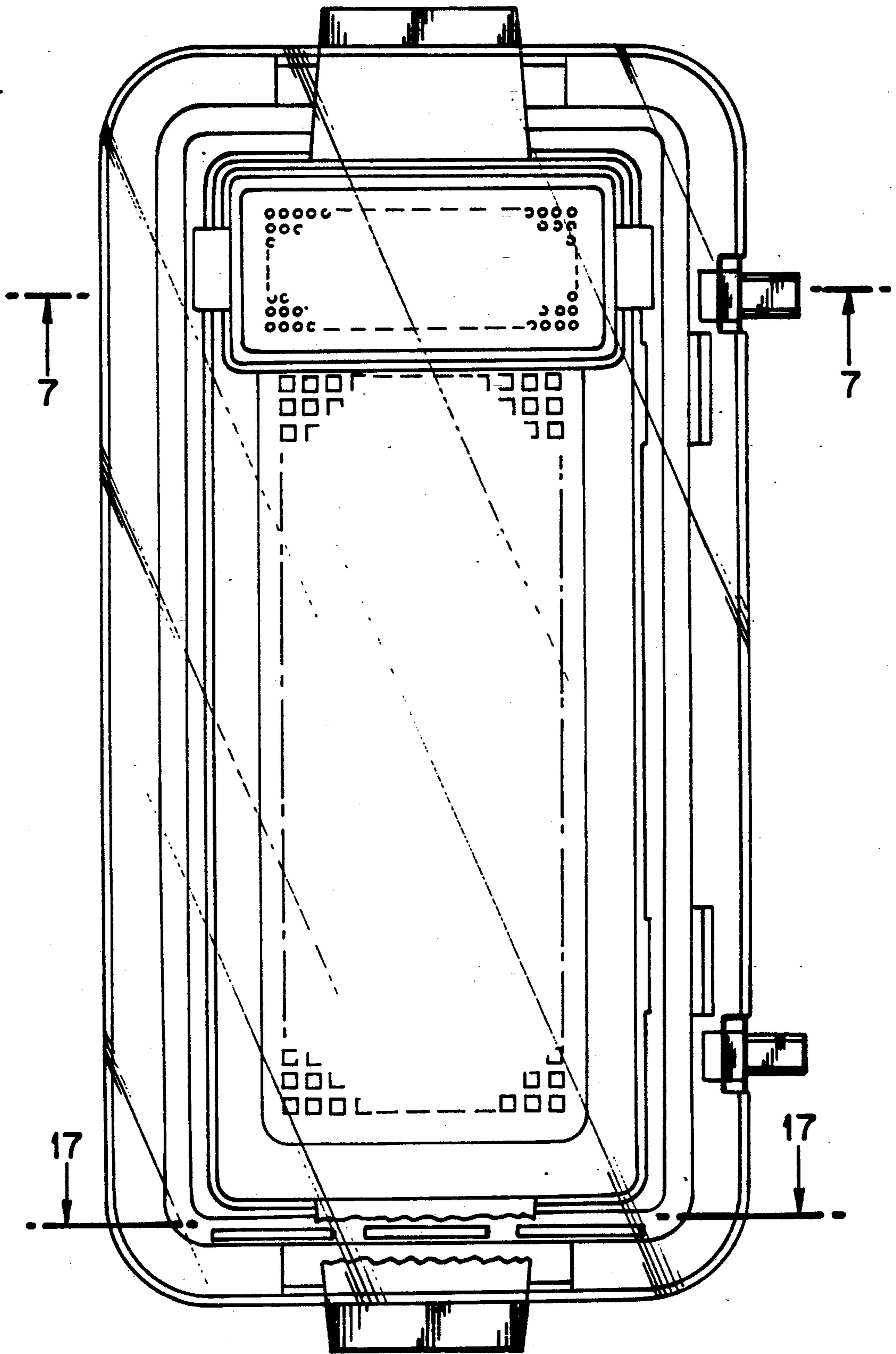

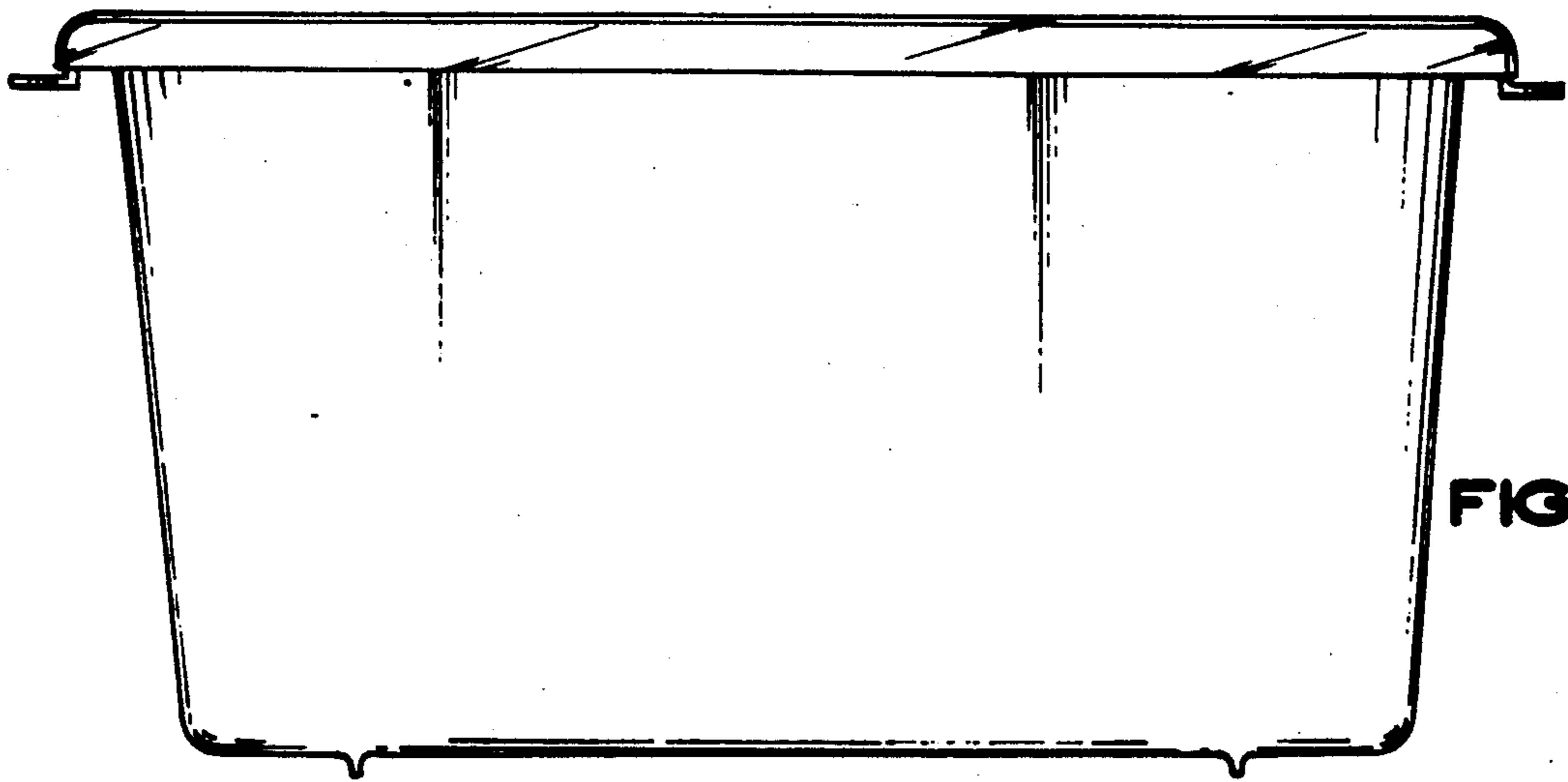

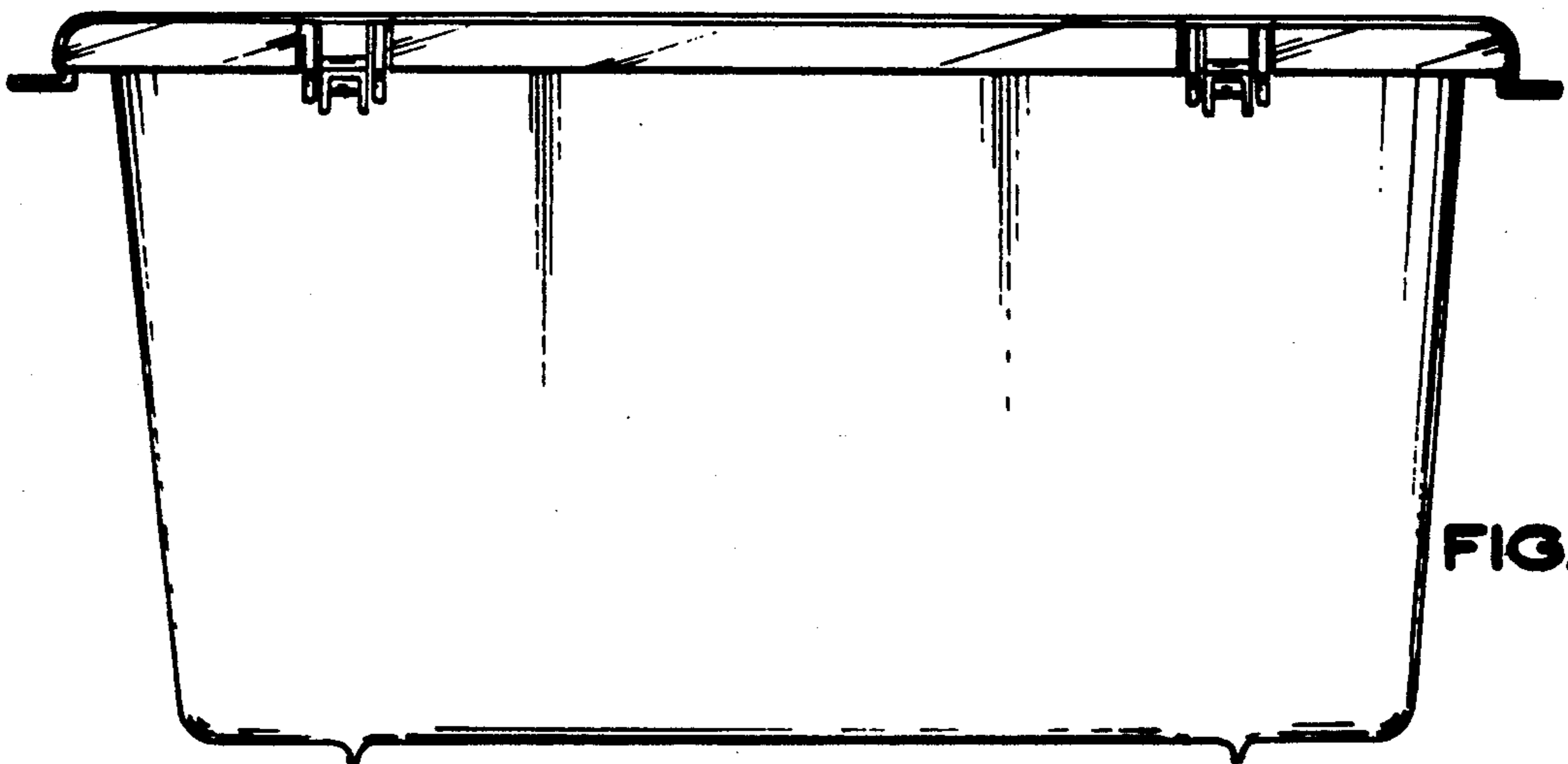

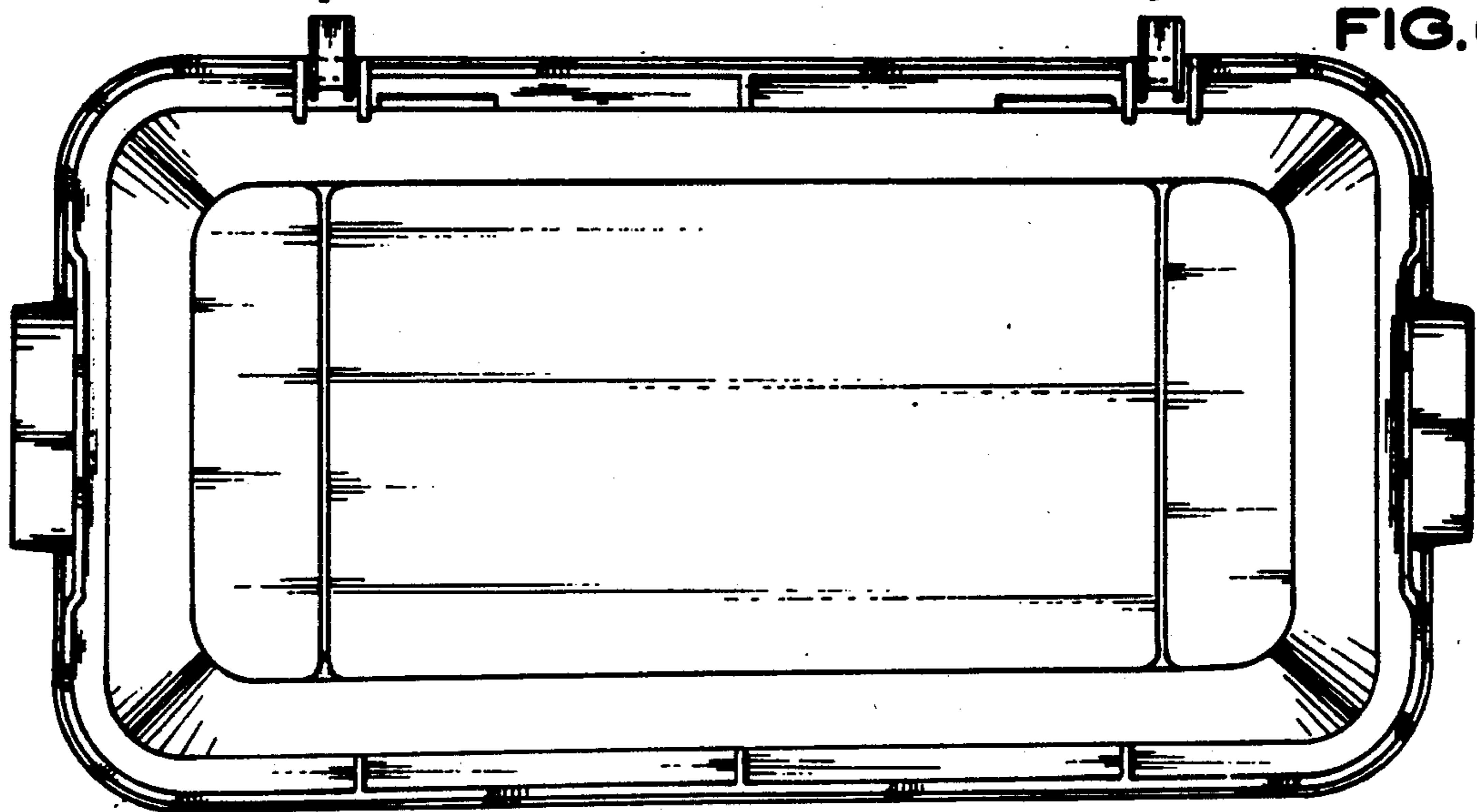

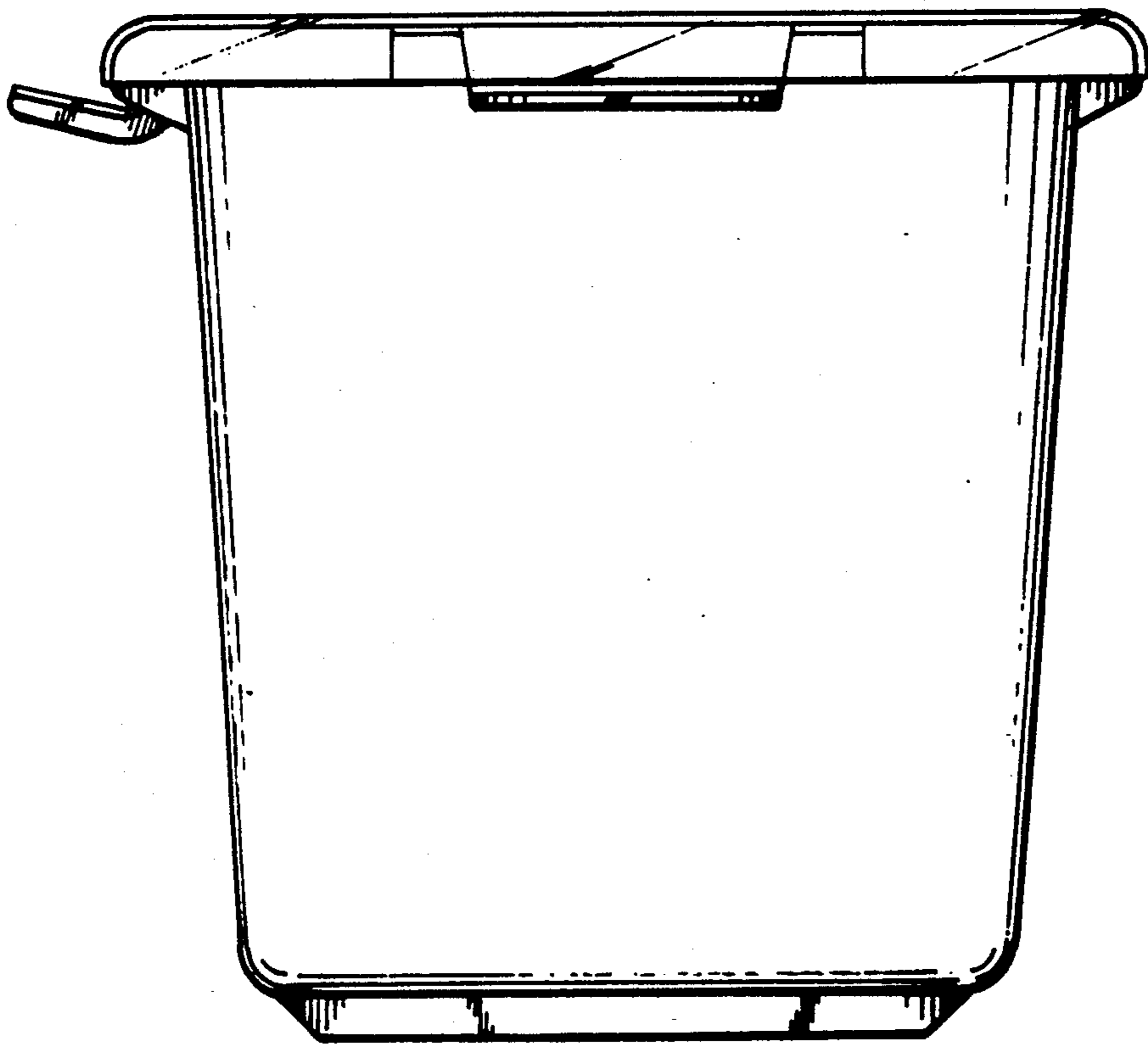

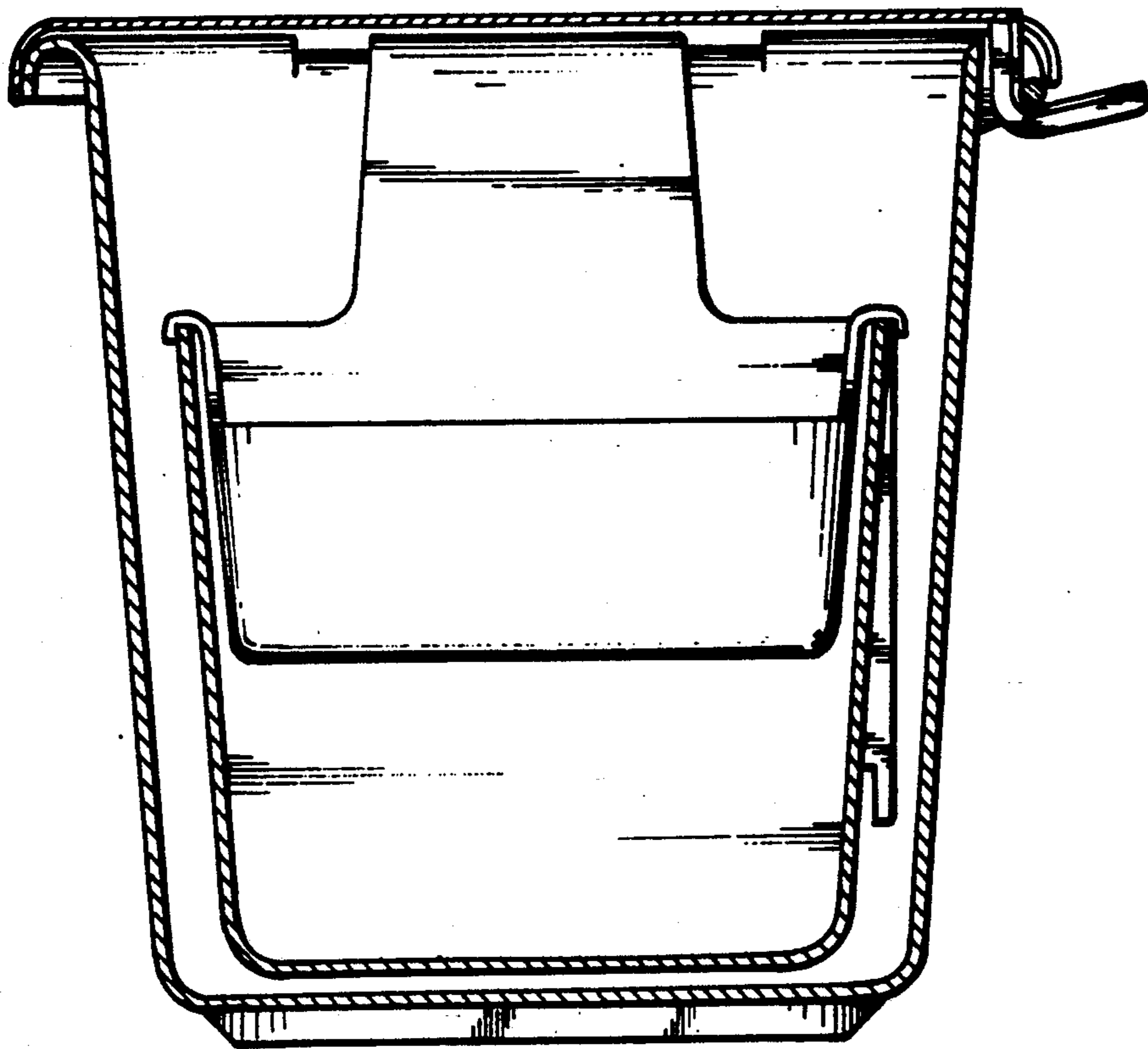

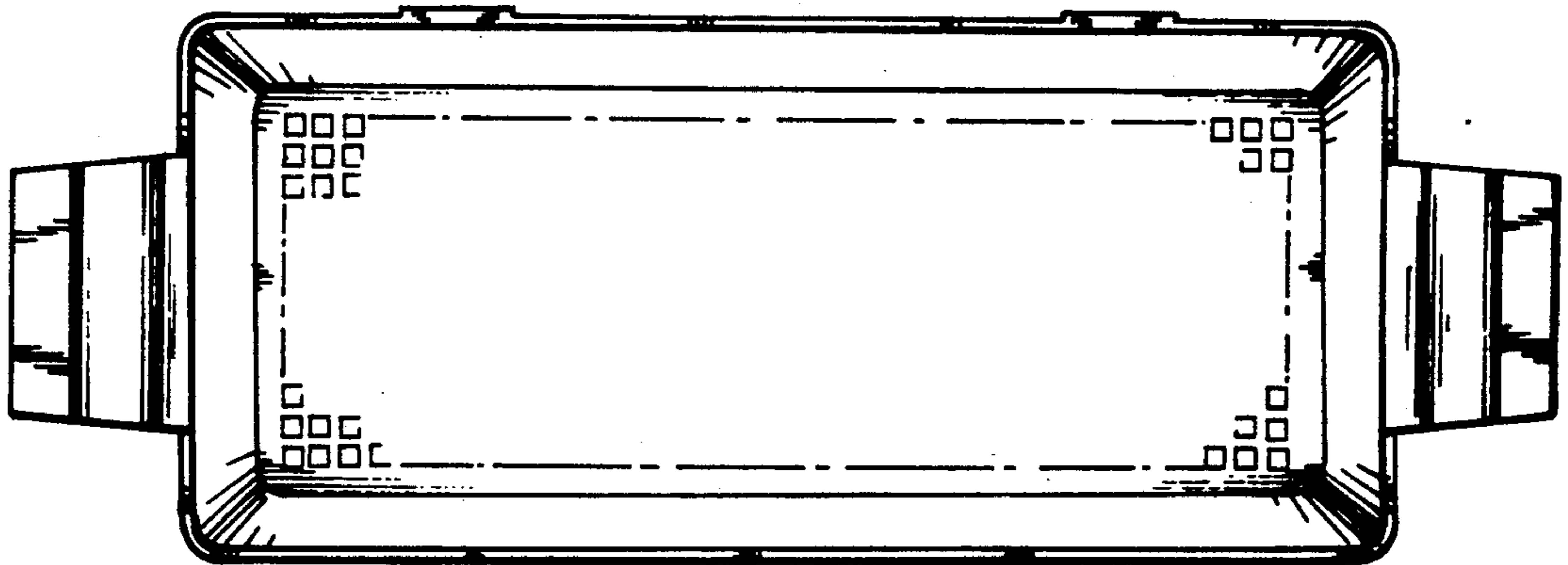
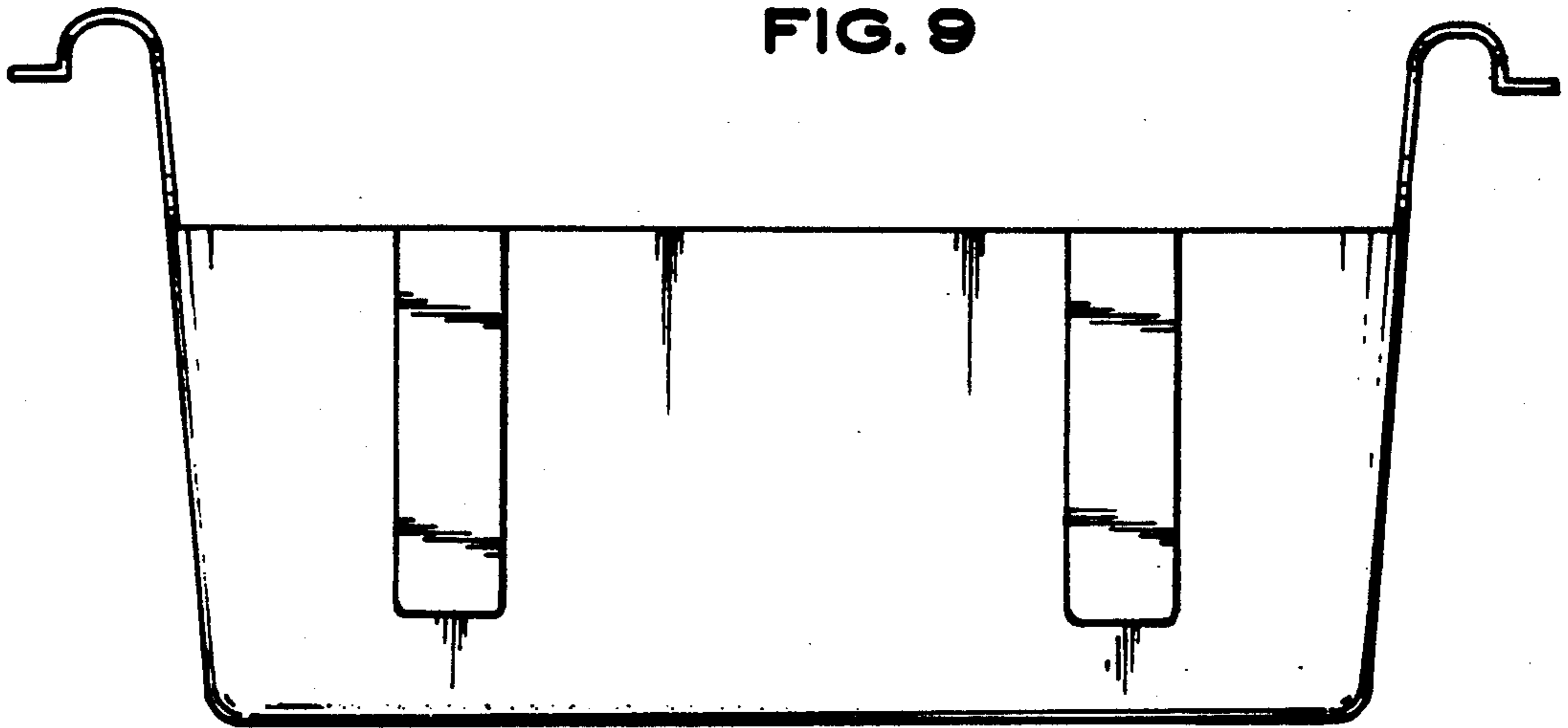

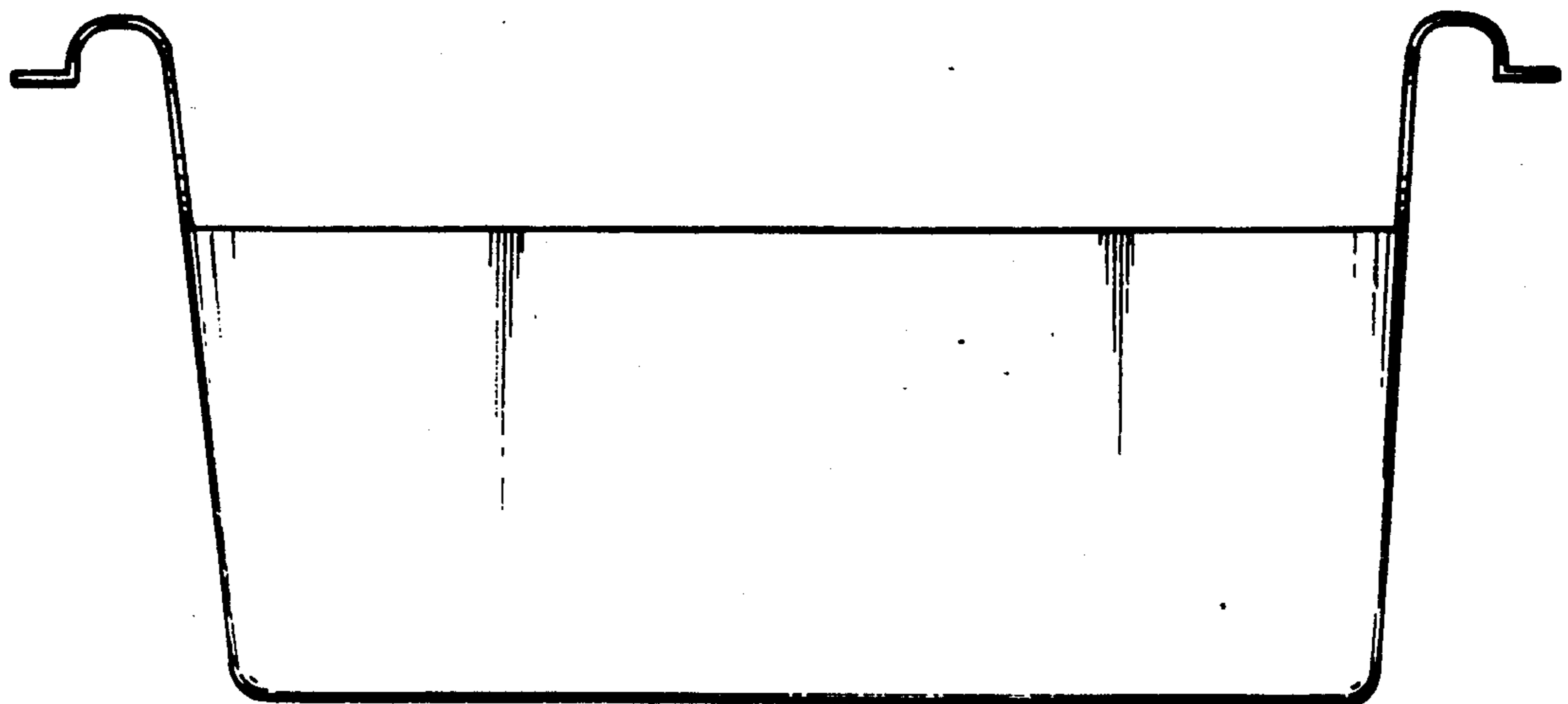

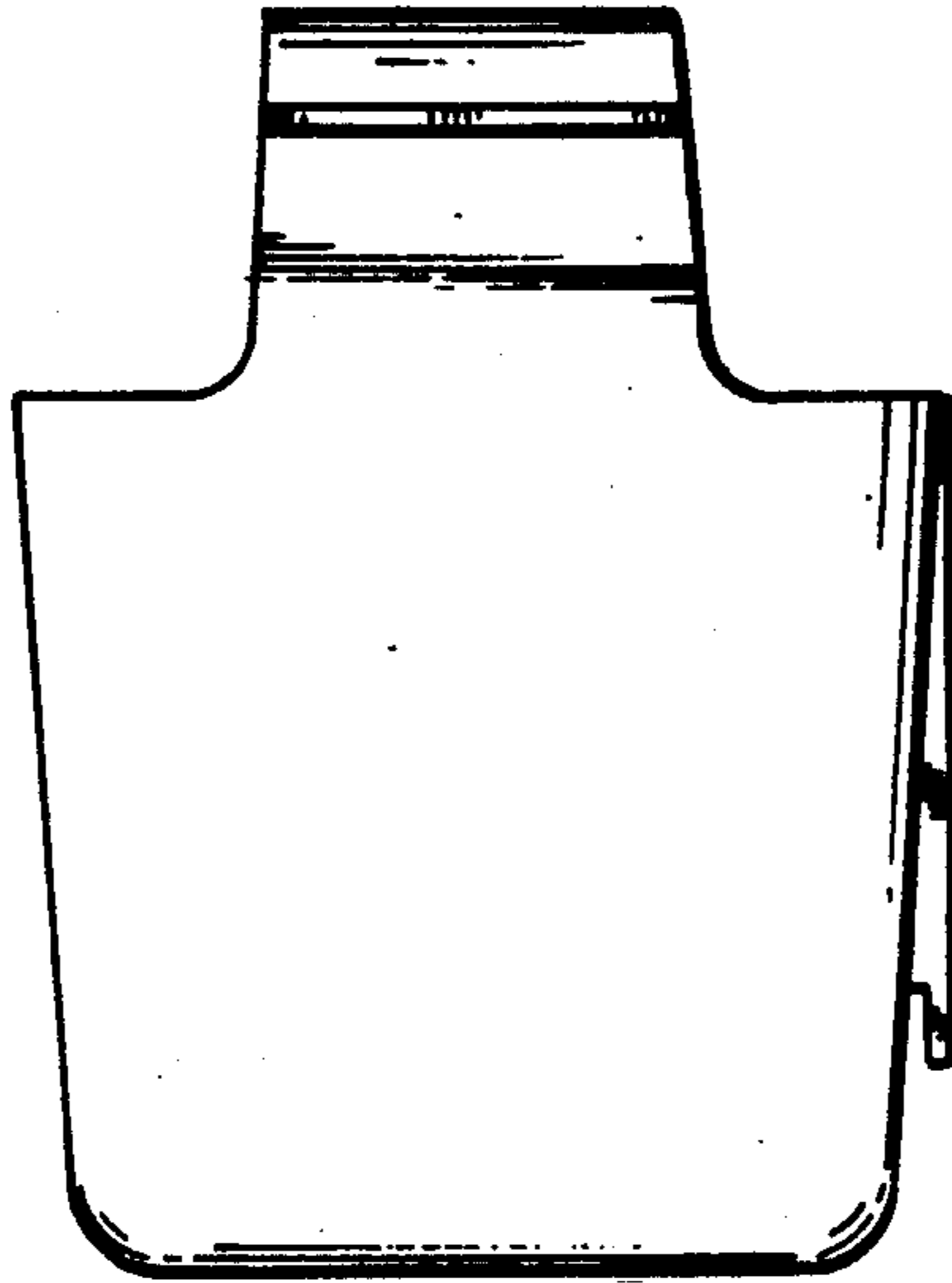

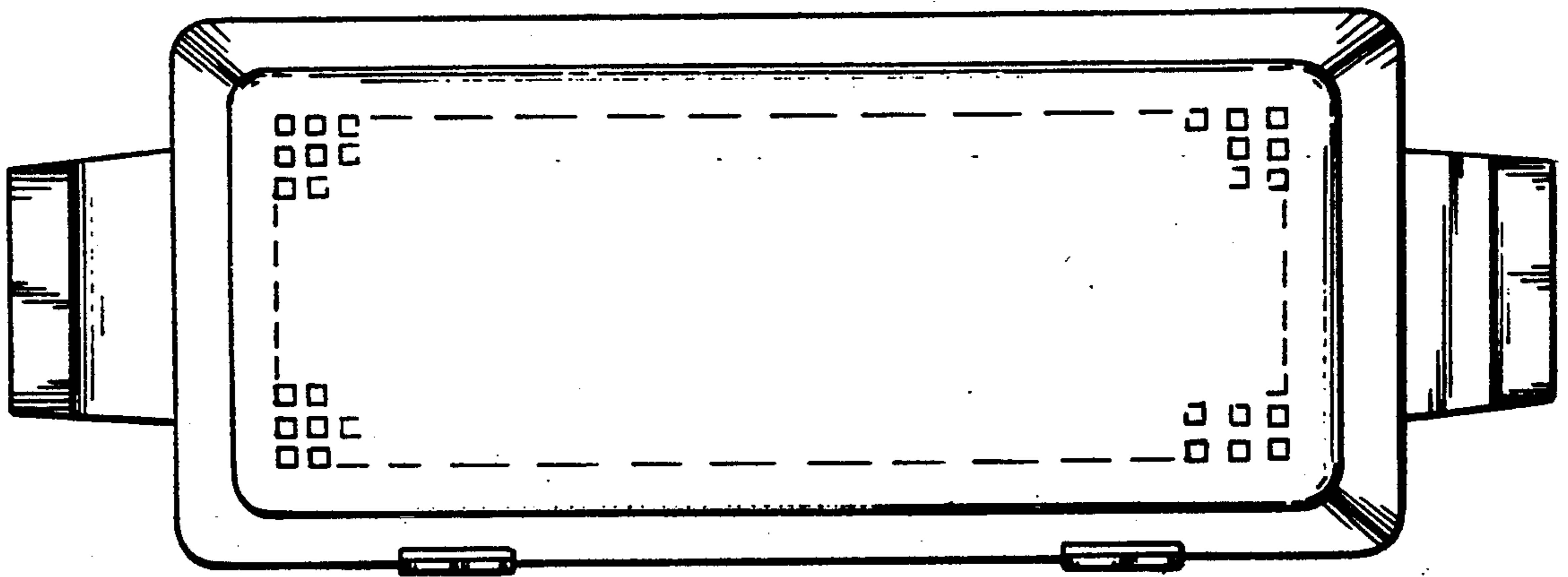

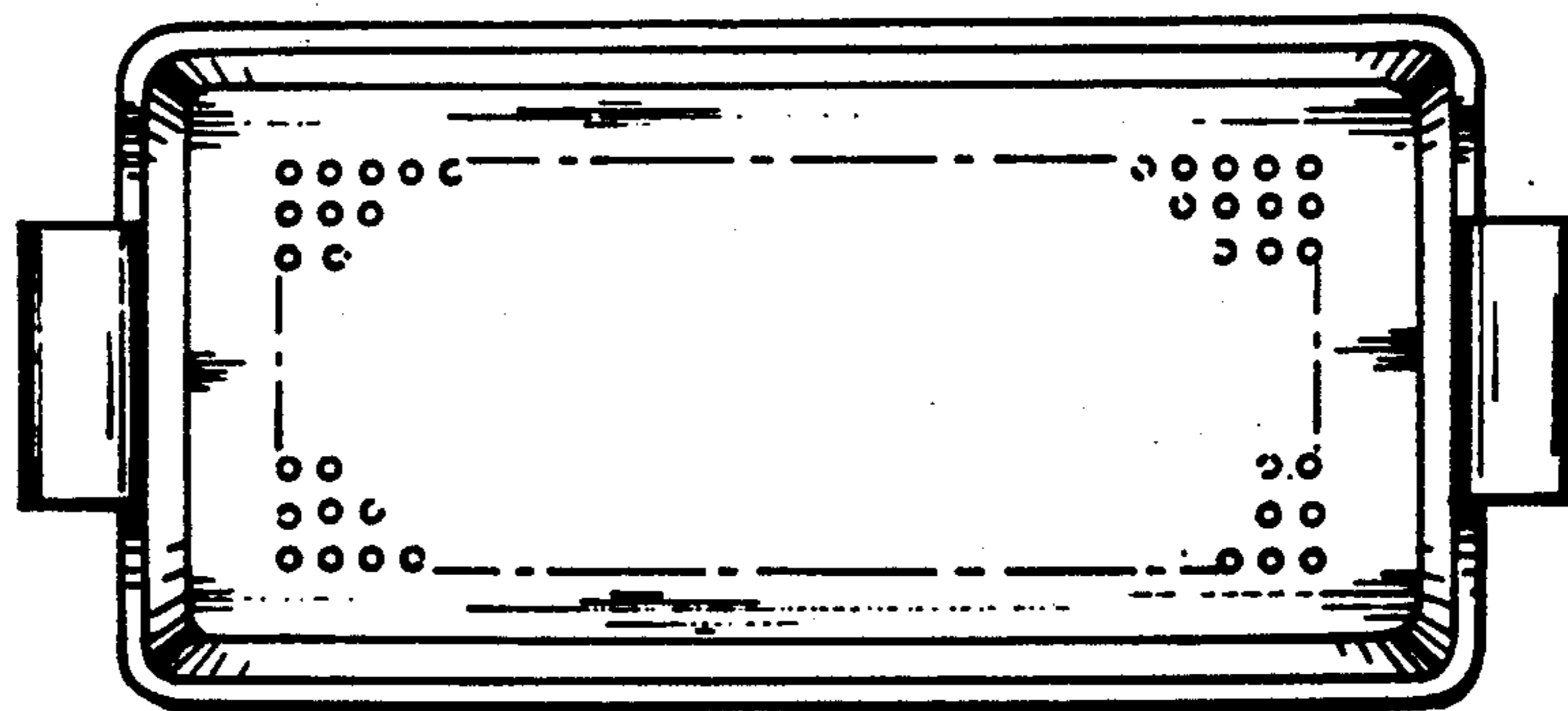

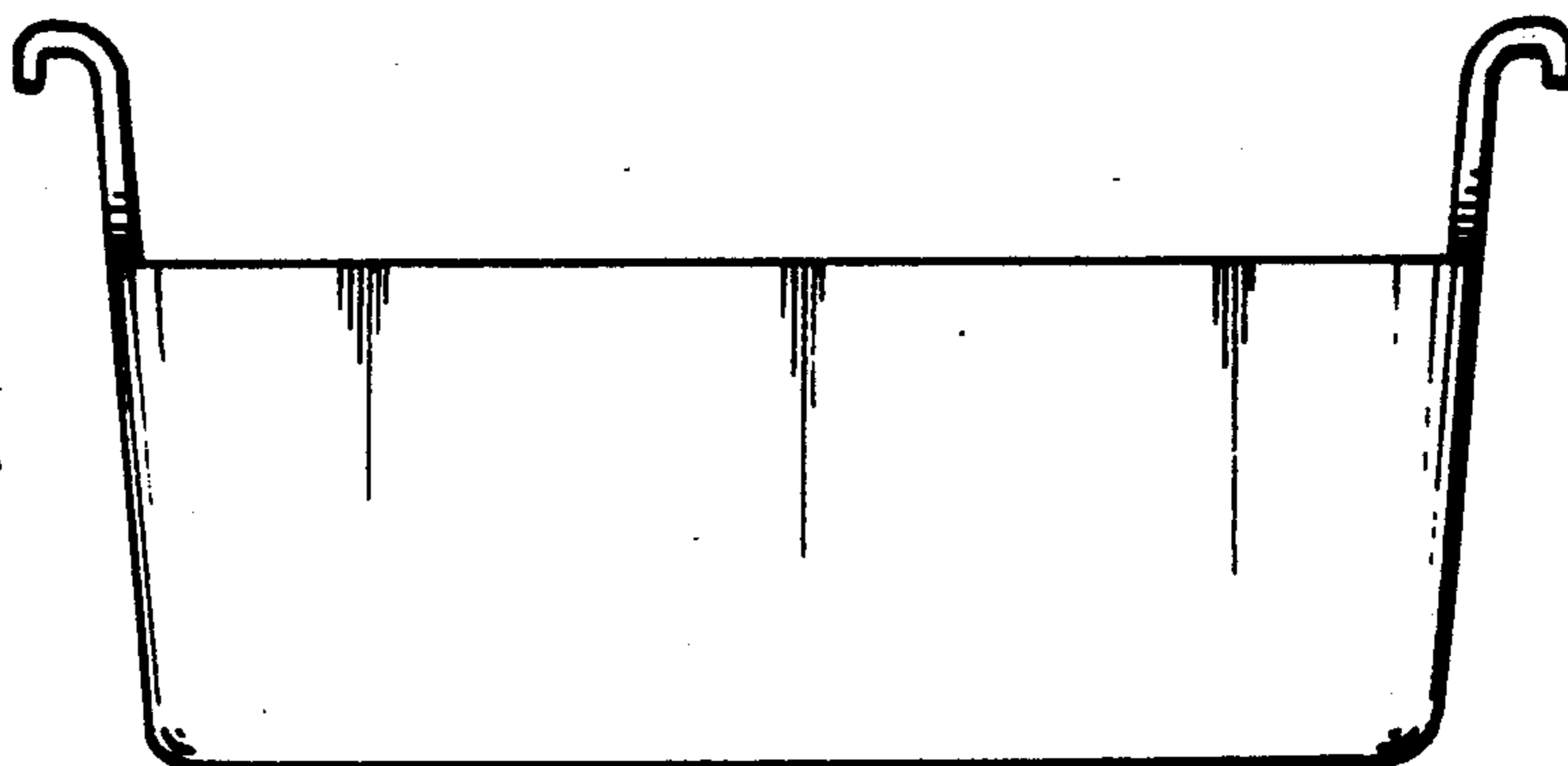

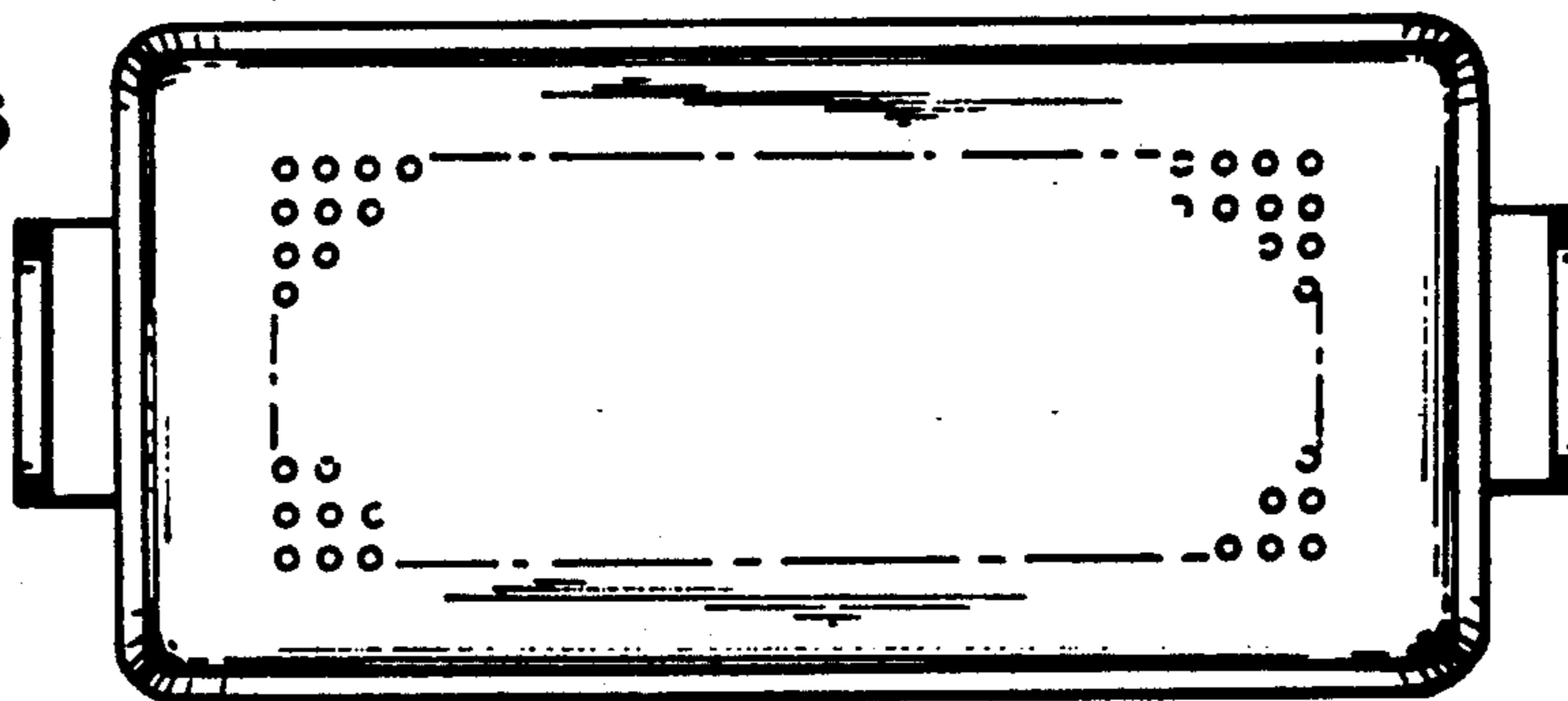
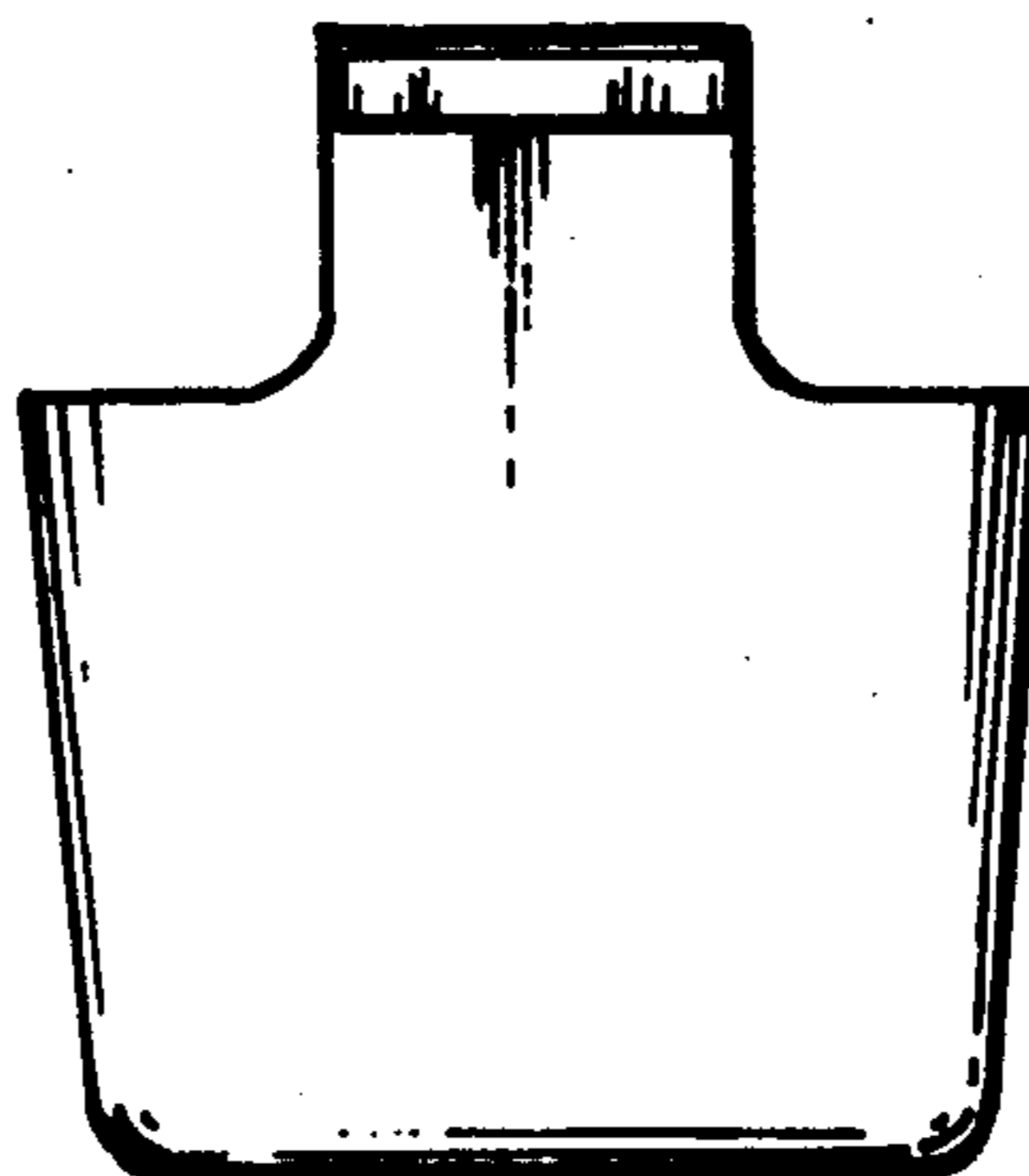

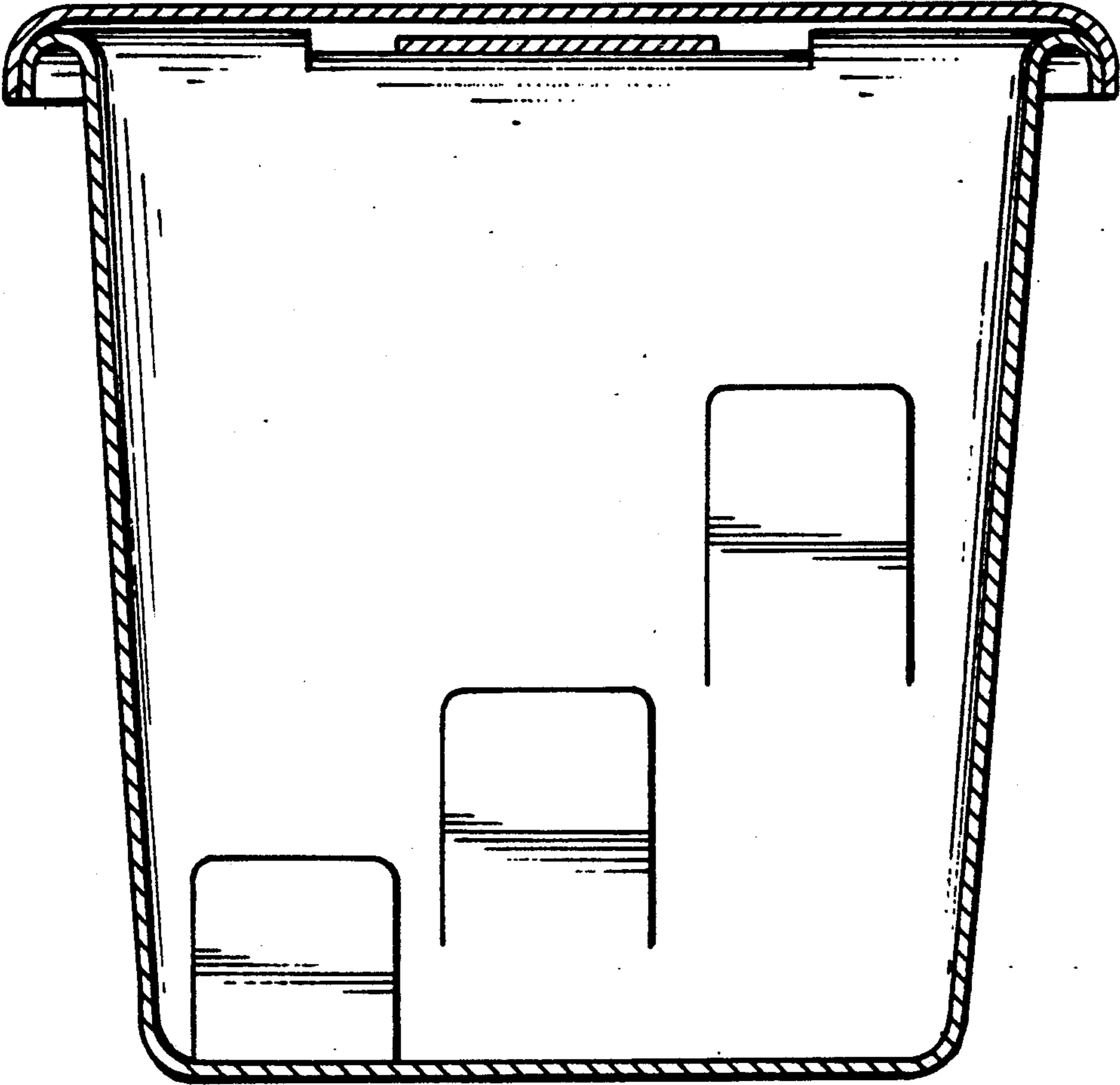
