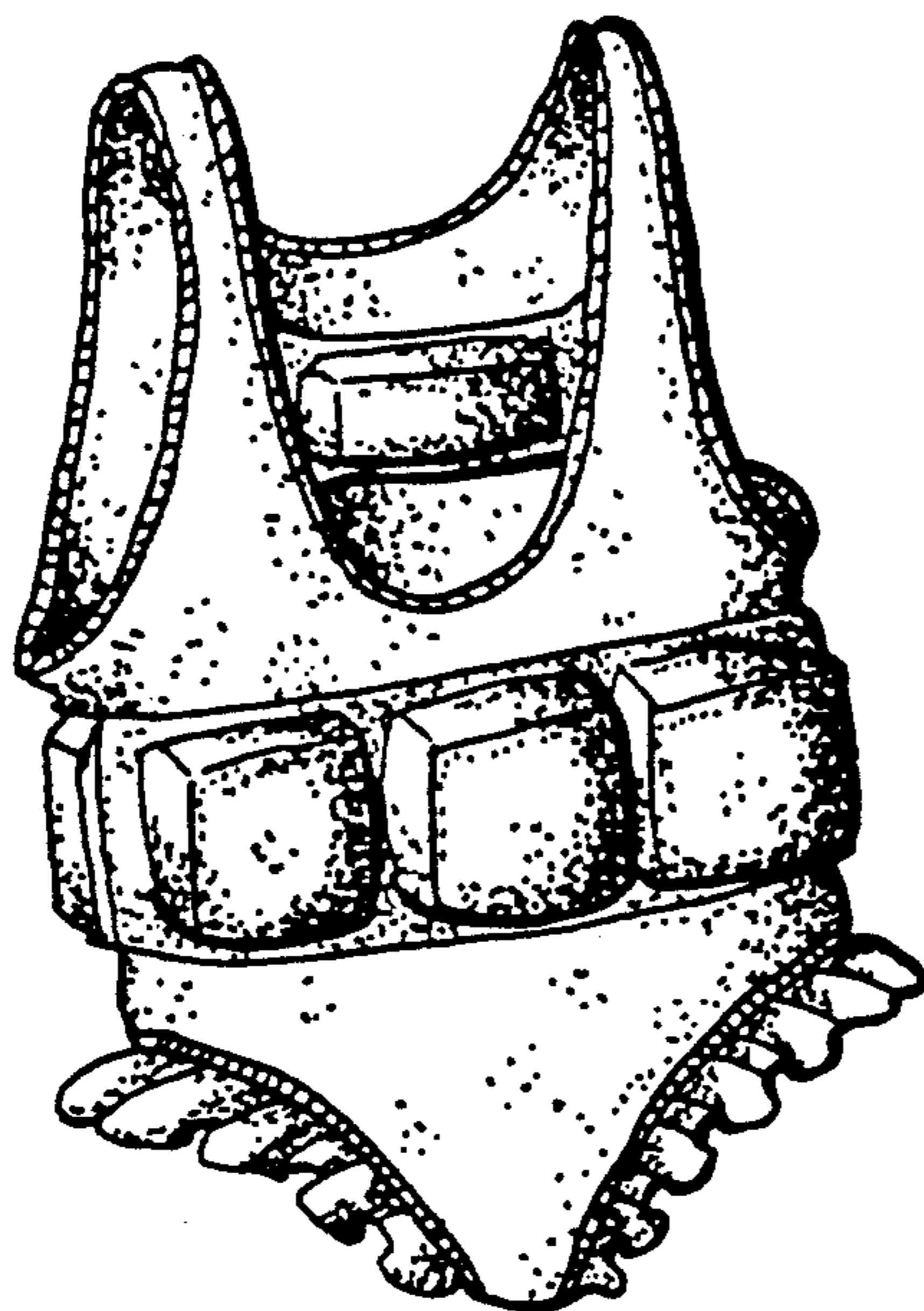

[57] **CLAIM**

The ornamental design for a flotation swimsuit, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a flotation swimsuit showing my new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a right side elevational view thereof, the left side being a mirror image;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is a perspective view of an alternate embodiment;
 FIG. 8 is a front elevational view of FIG. 7;
 FIG. 9 is a right side elevational view of FIG. 7, the left side being a mirror image;
 FIG. 10 is a rear elevational view of FIG. 7;
 FIG. 11 is a top plan view of FIG. 7; and,
 FIG. 12 is a bottom plan view of FIG. 7.



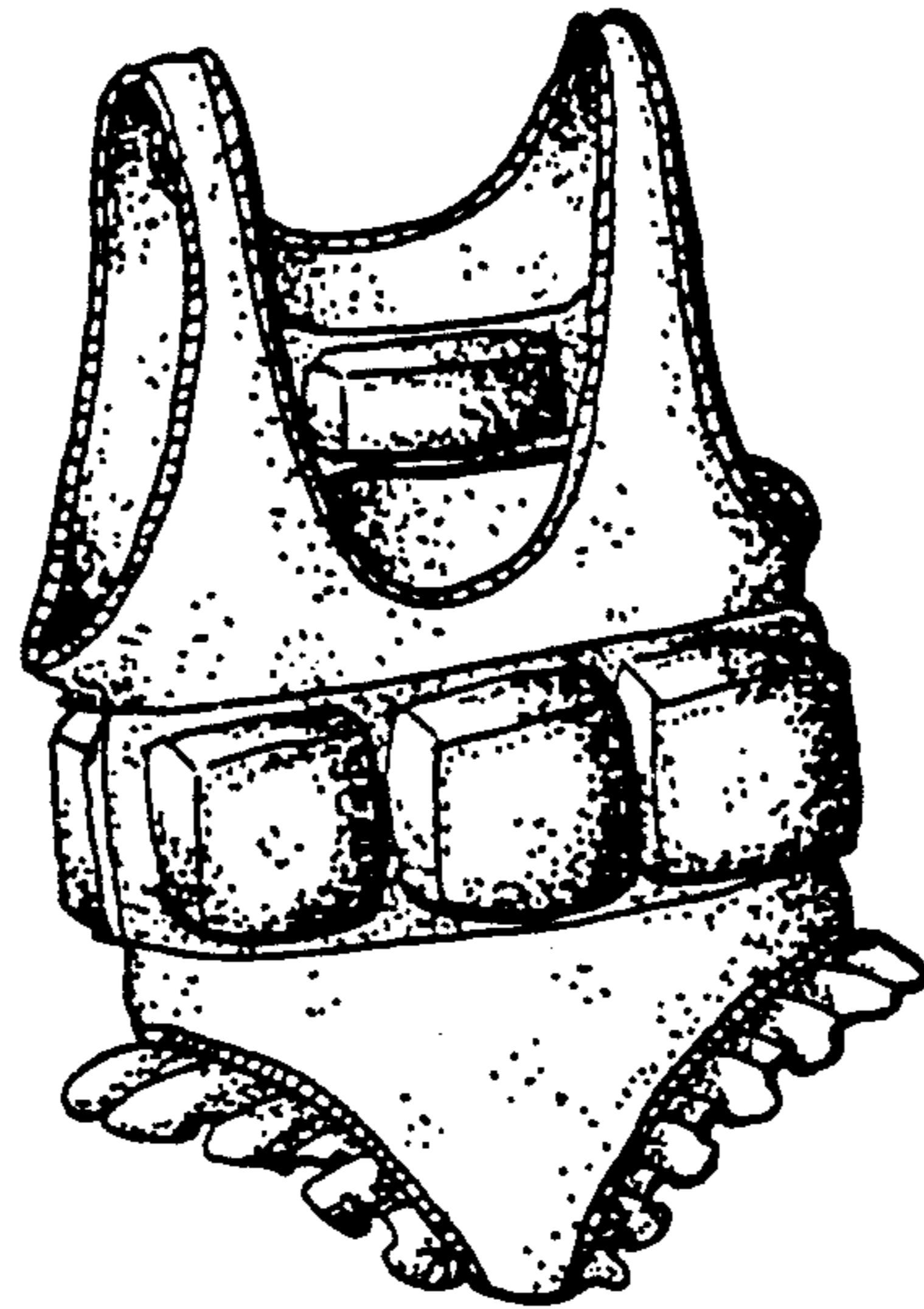

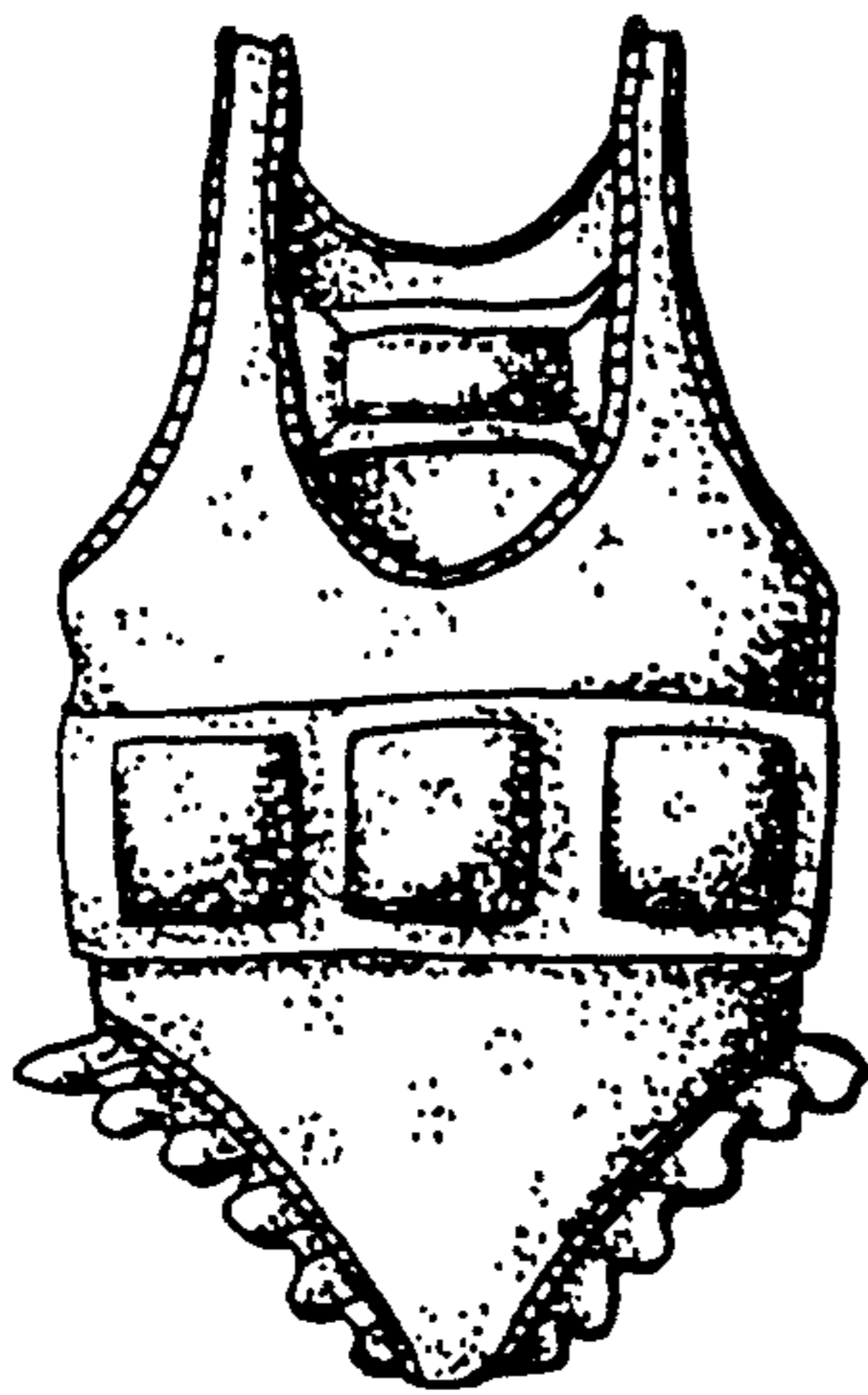

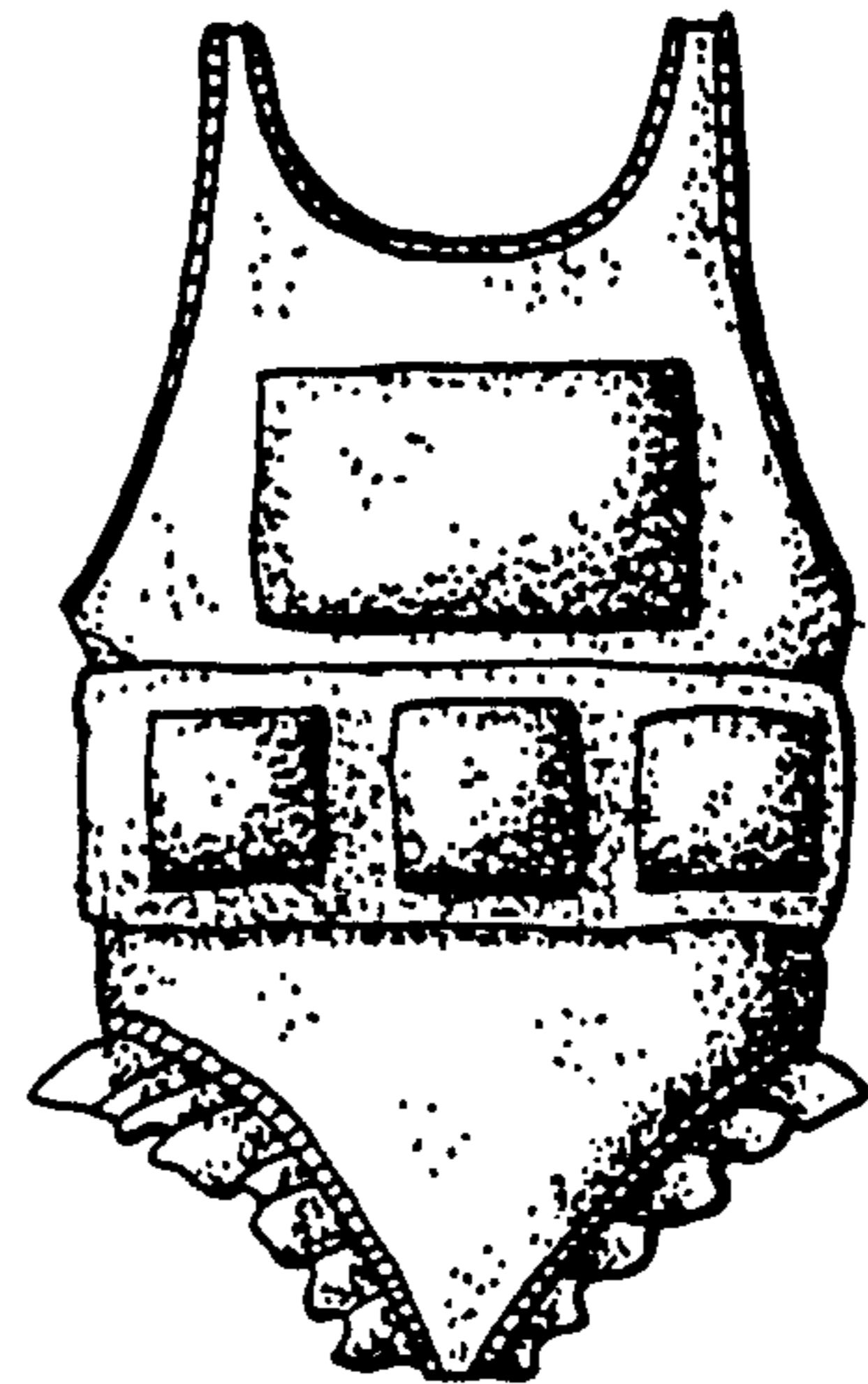

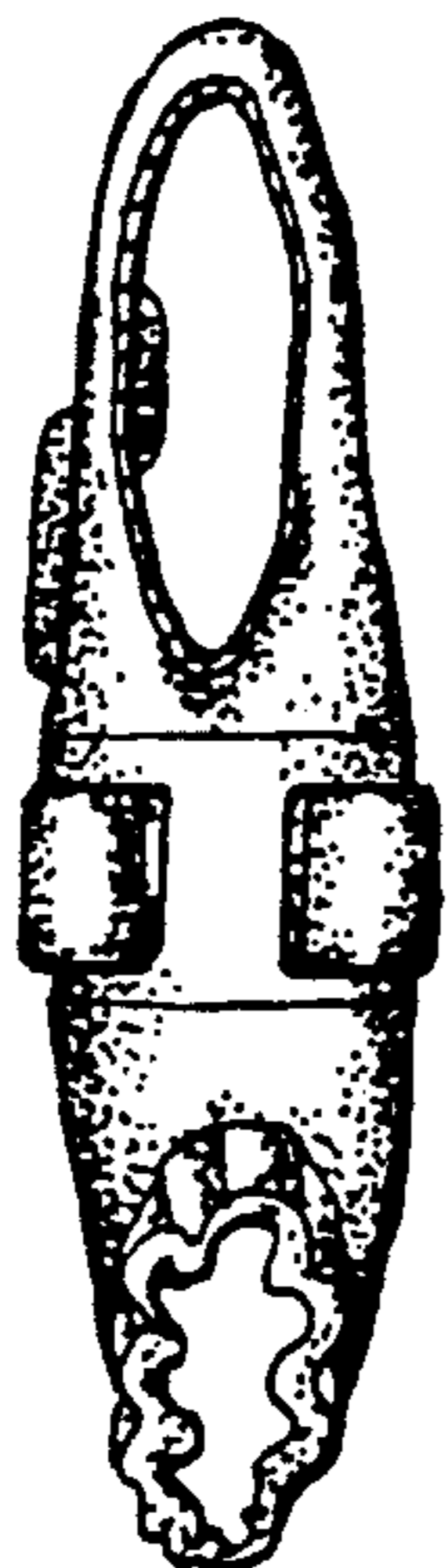

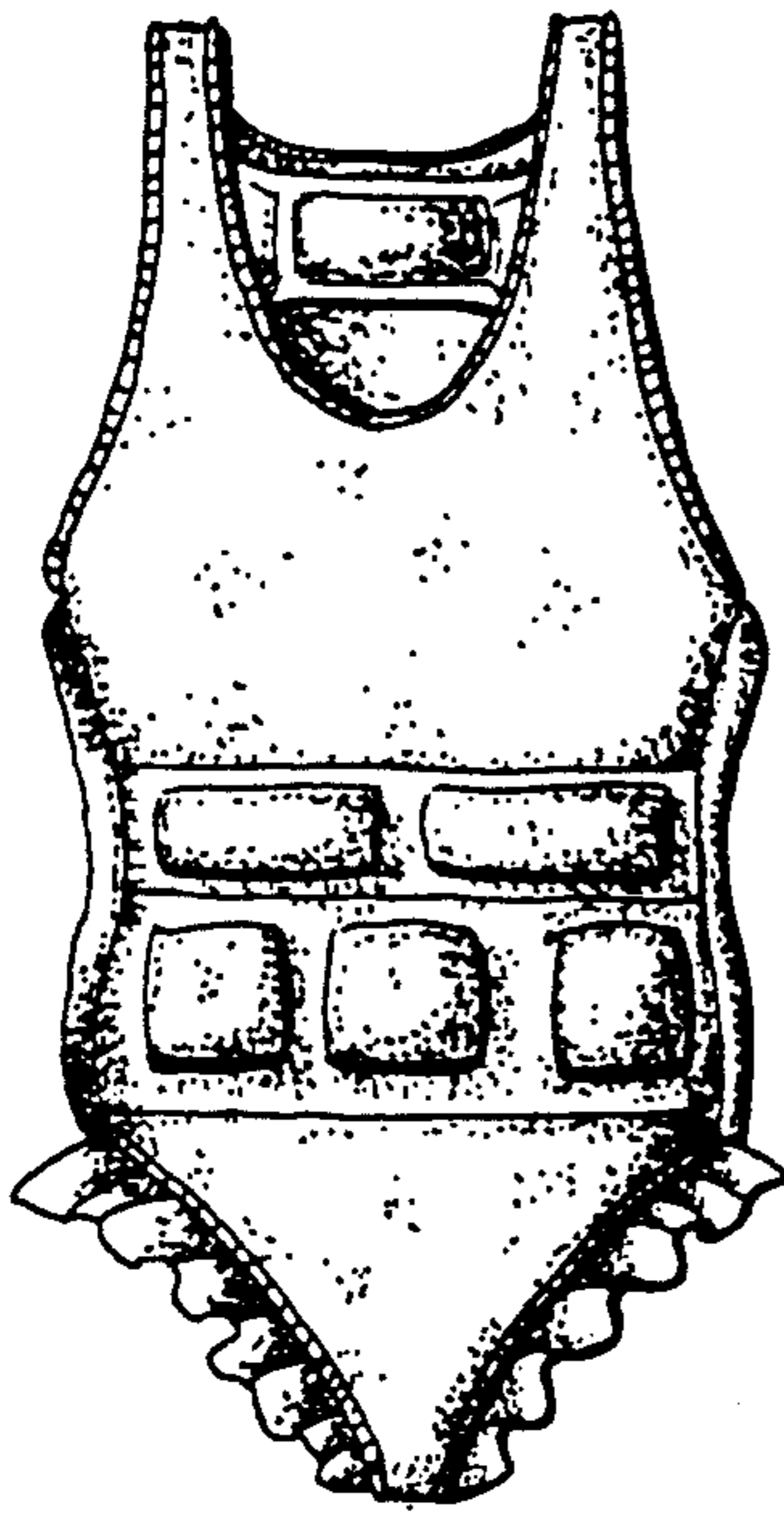

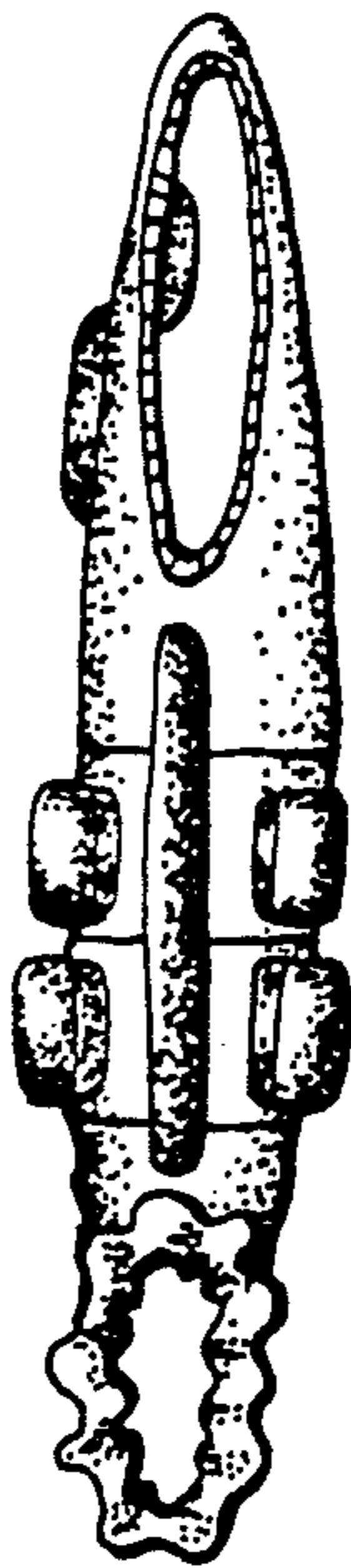

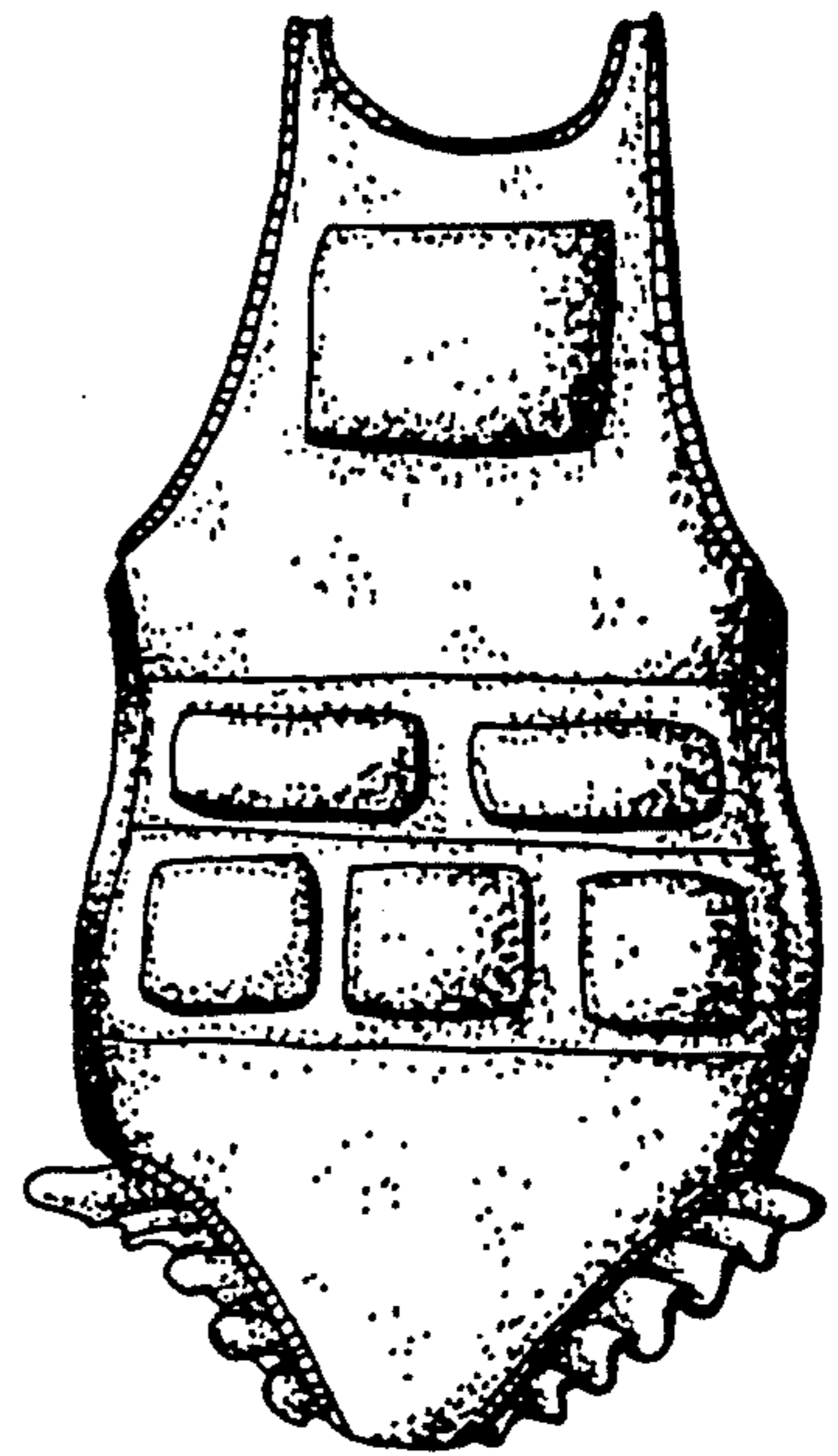
