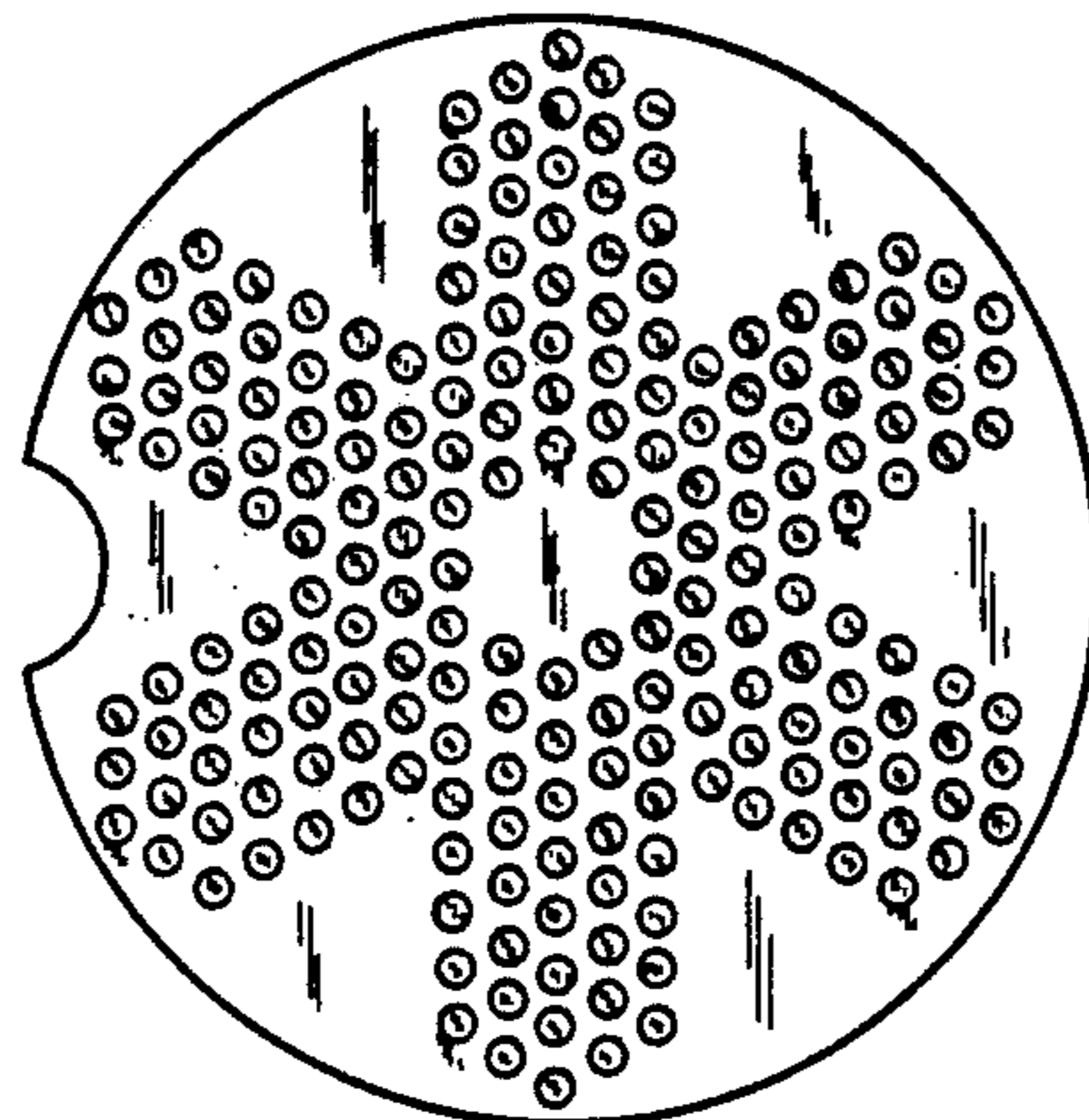
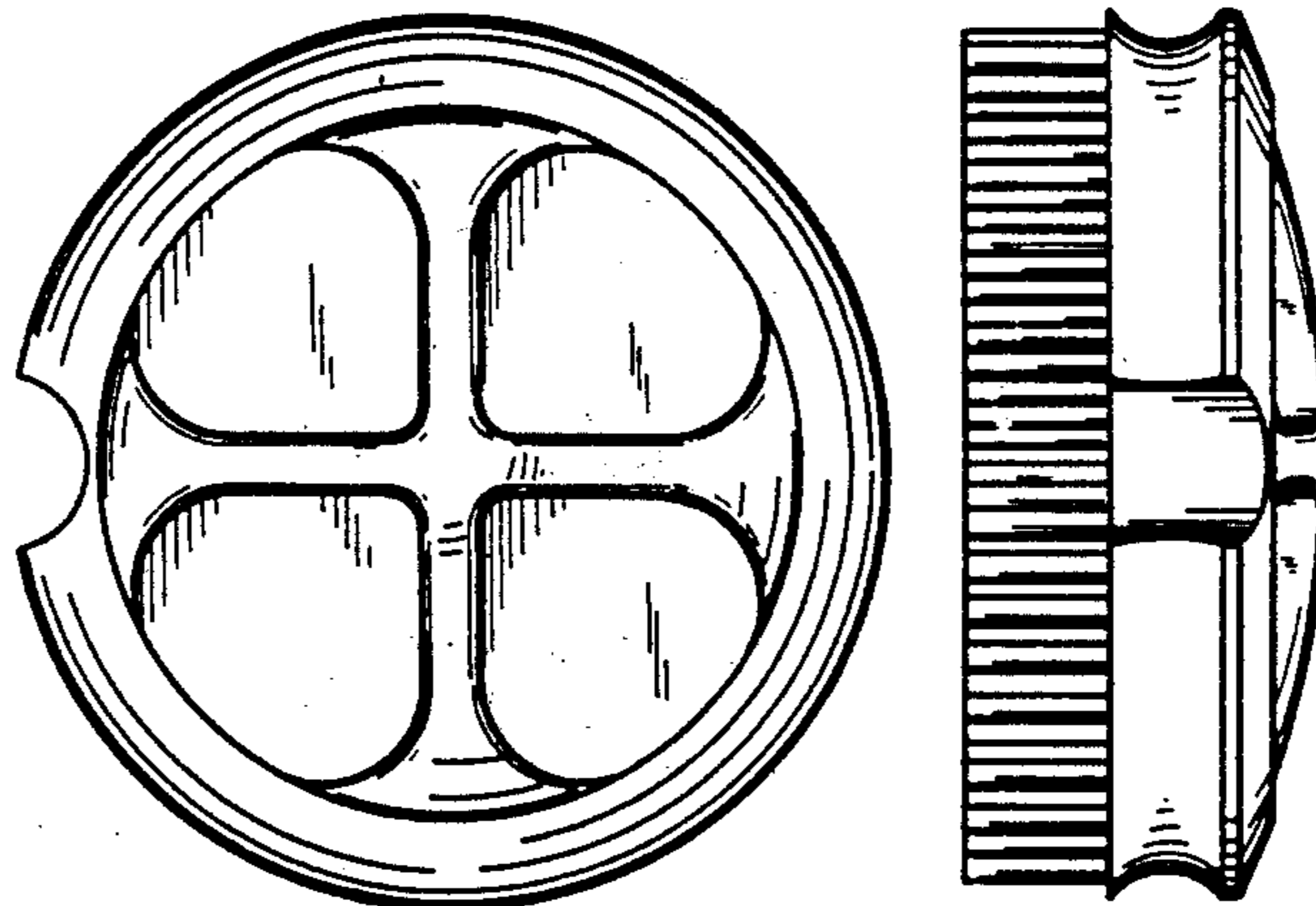

[57] CLAIM

The ornamental design for a brush for grooming animals, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a brush for grooming animals showing our new design;
FIG. 2 is a left side elevational view thereof;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is a front elevational view thereof, the rear being a mirror image; and,
FIG. 5 is a bottom plan view thereof.



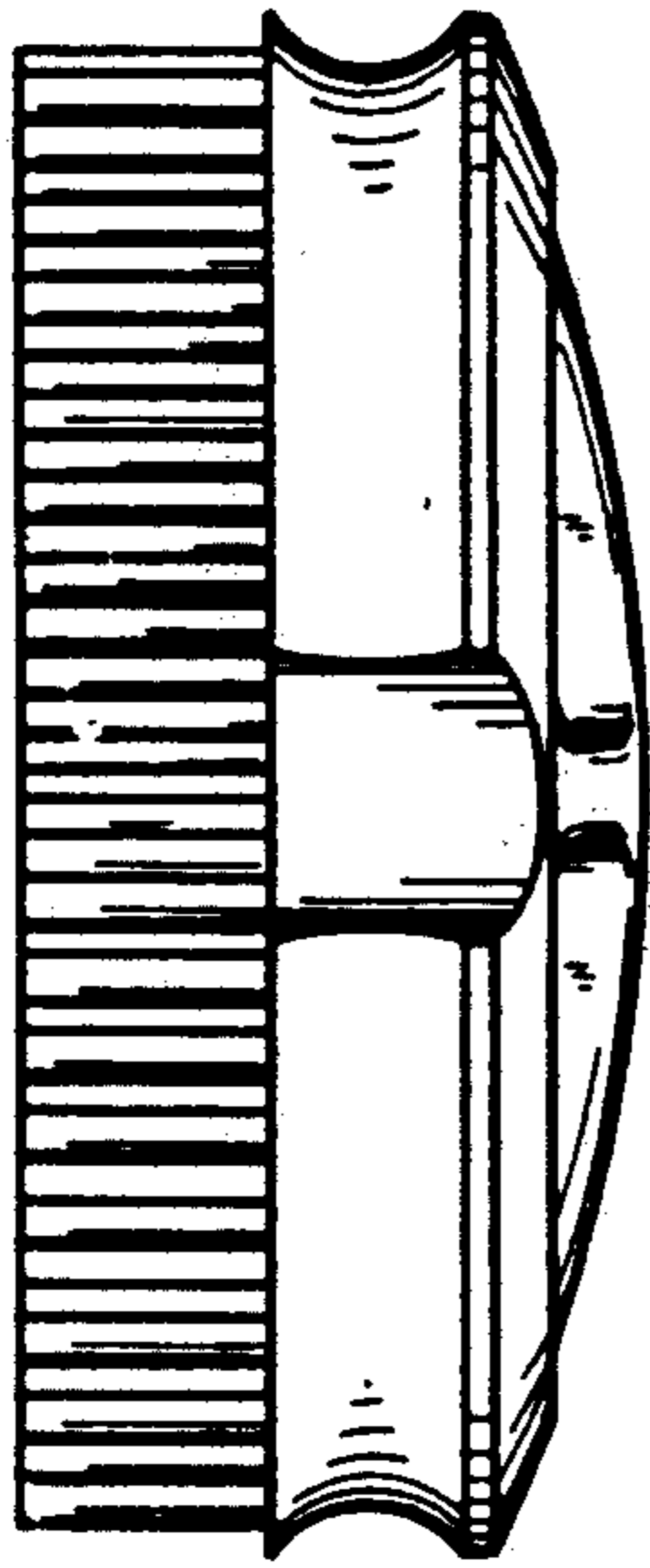

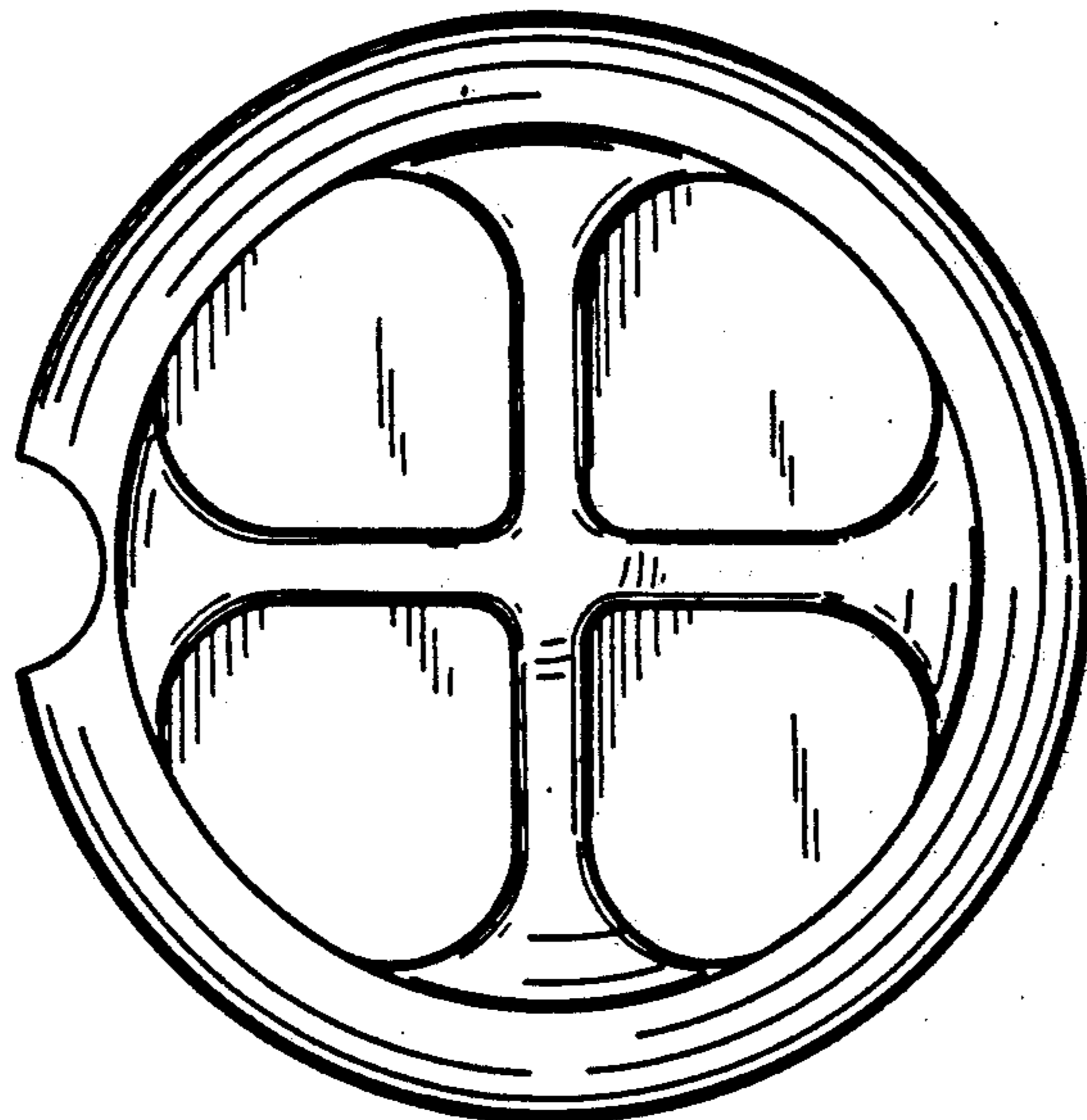

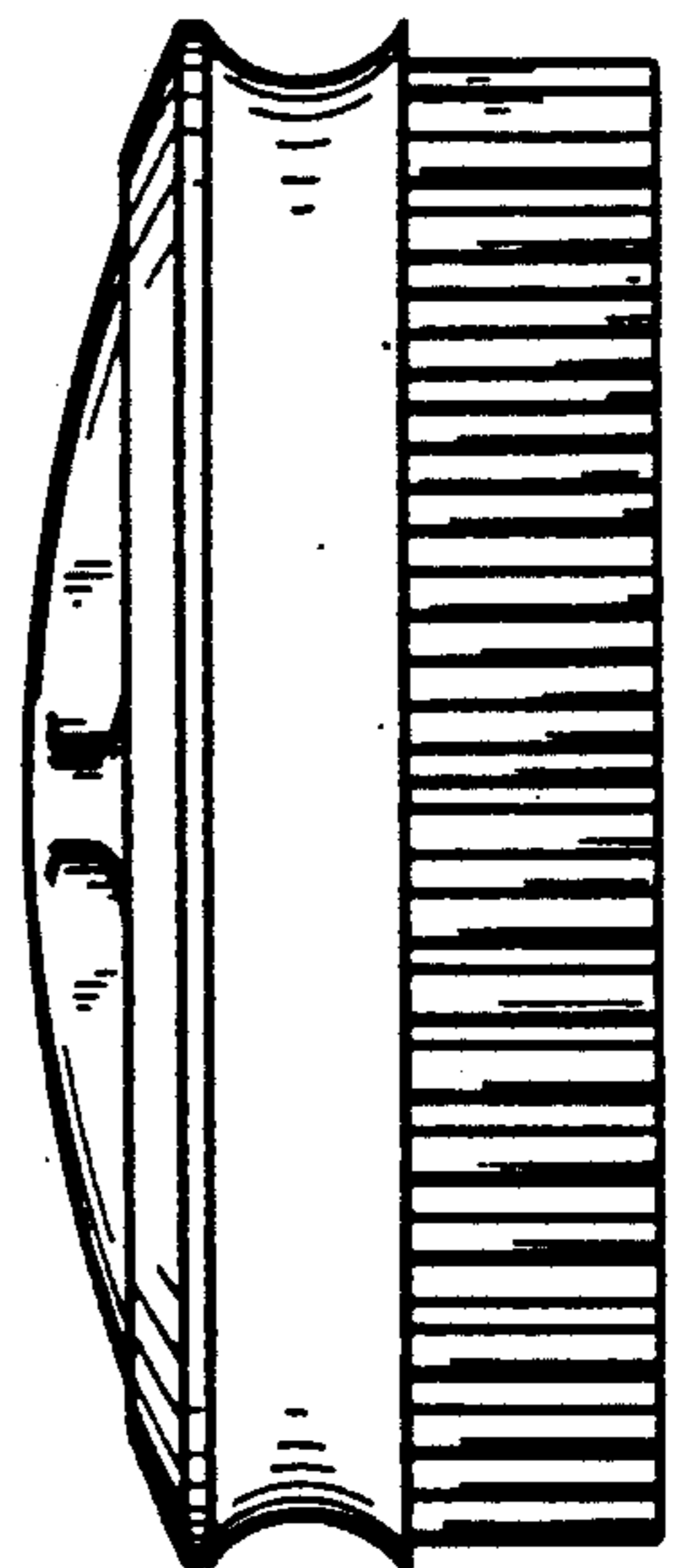

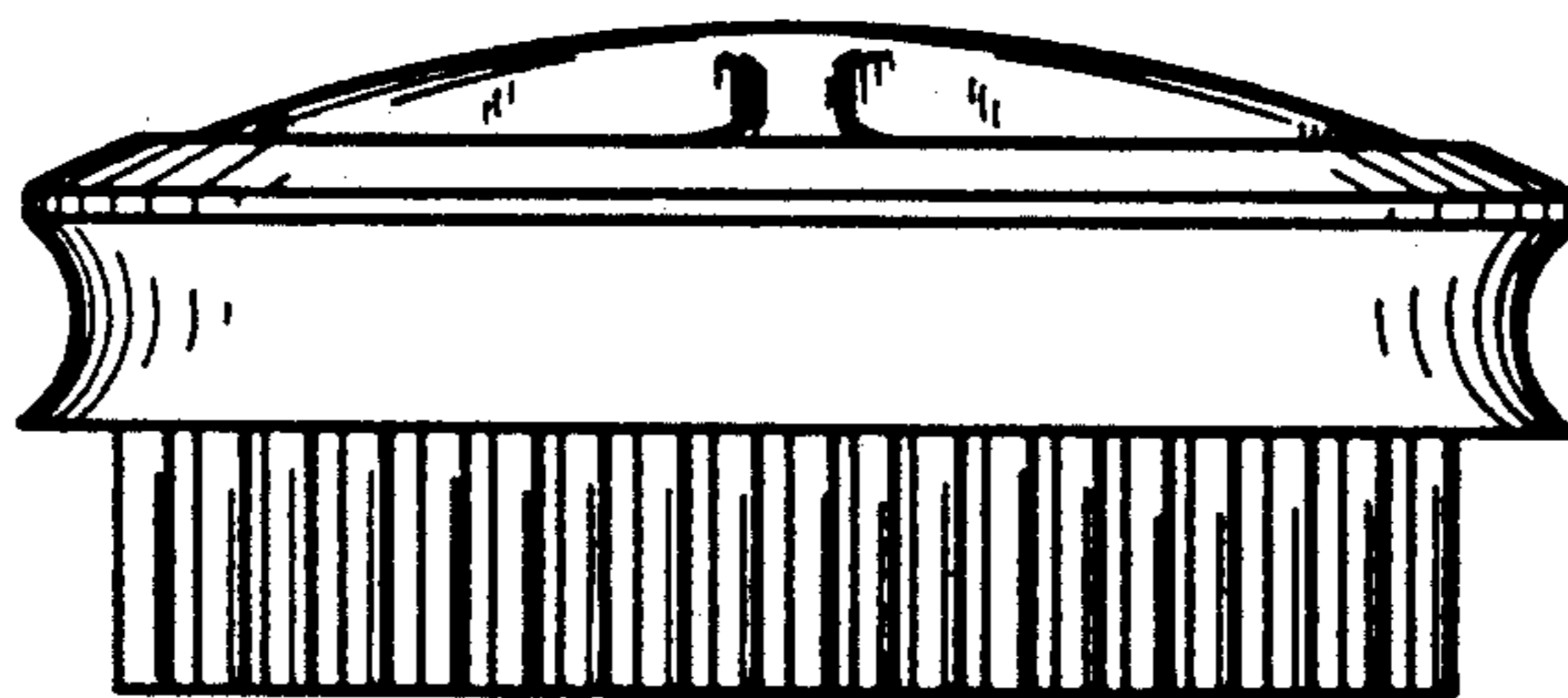

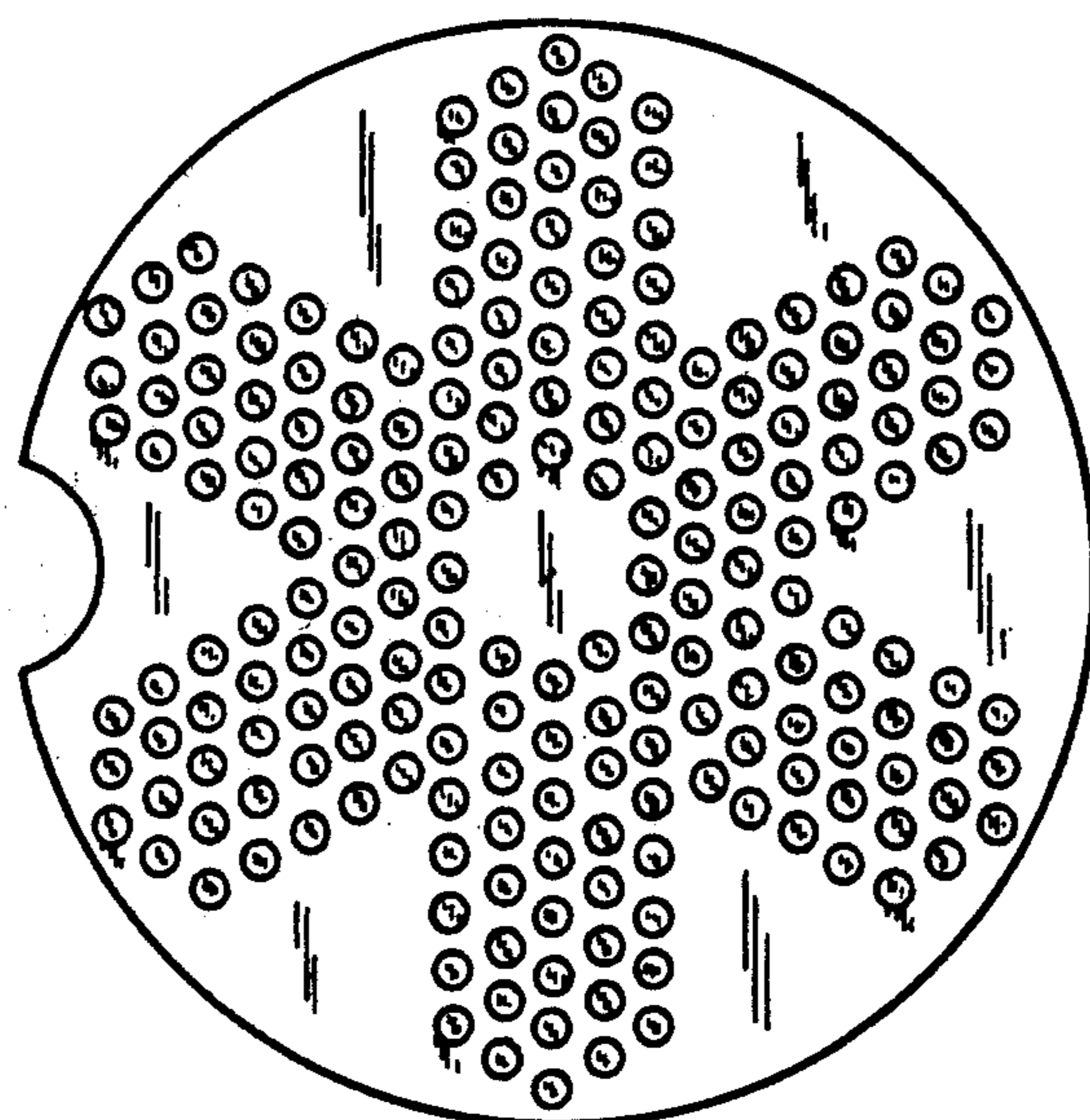
