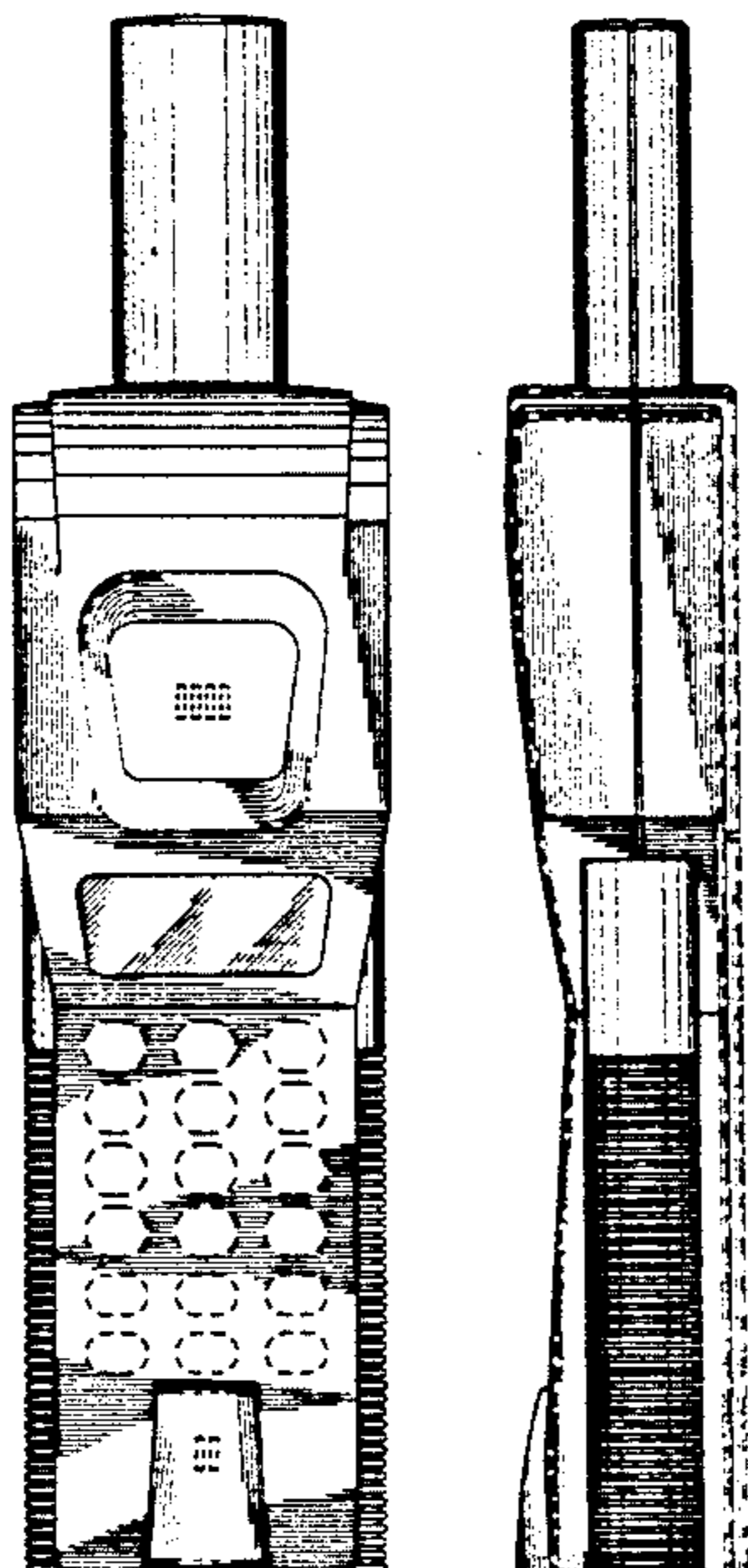

[57] **CLAIM**

The ornamental design for a housing for a portable handset telephone, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a housing for a portable handset telephone showing our new design; FIG. 2 is a rear elevational view thereof; FIG. 3 is a left elevational view thereof; FIG. 4 is a right elevational view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; and, FIG. 7 is a vertical cross-section of FIG. 1. Broken line matter showing in FIGS. 1, 2, 4, and 6 is used for illustrative purposes only and forms no part of the claimed design.



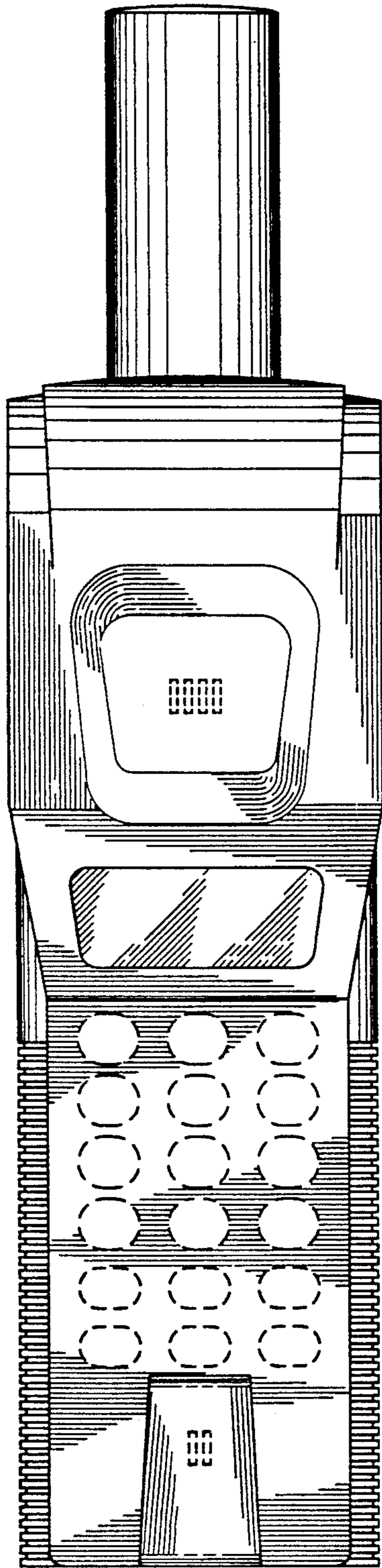

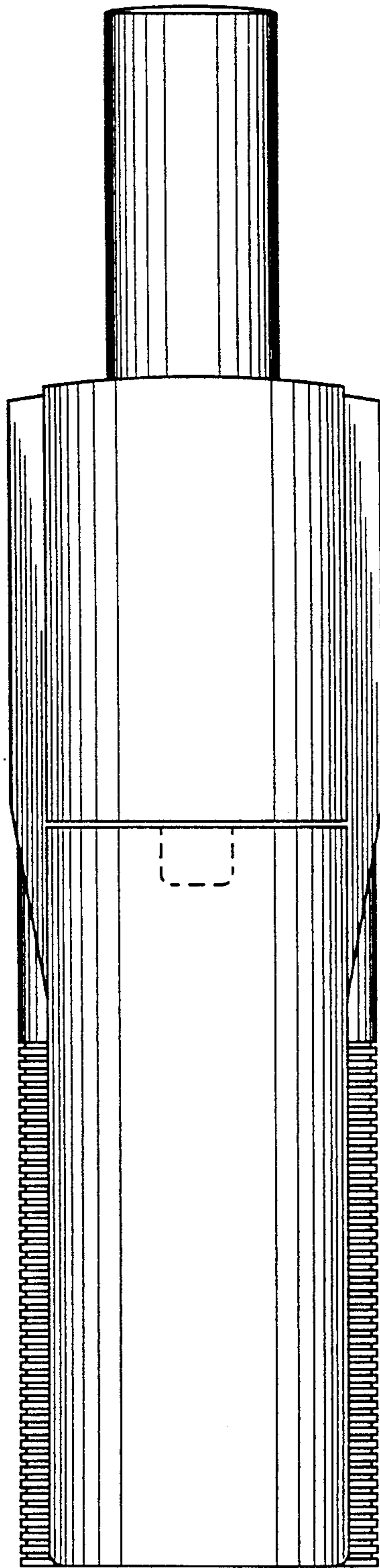

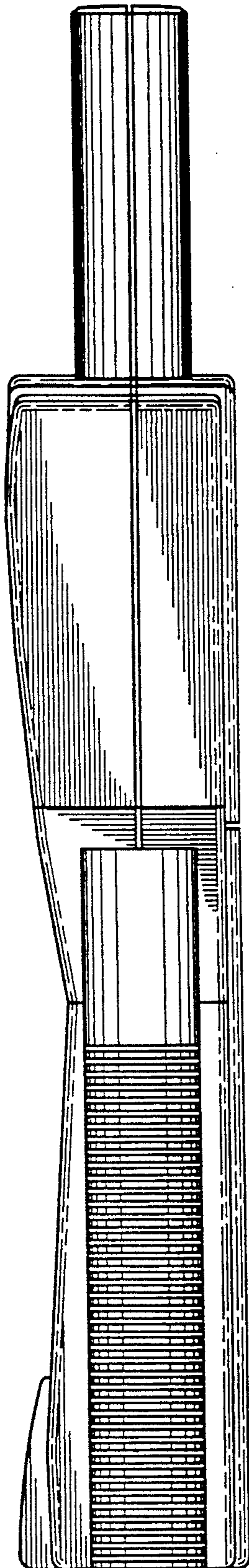
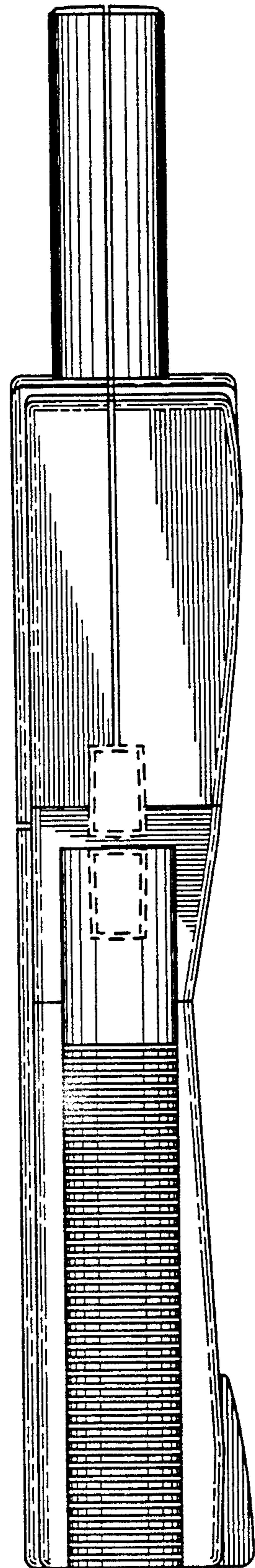

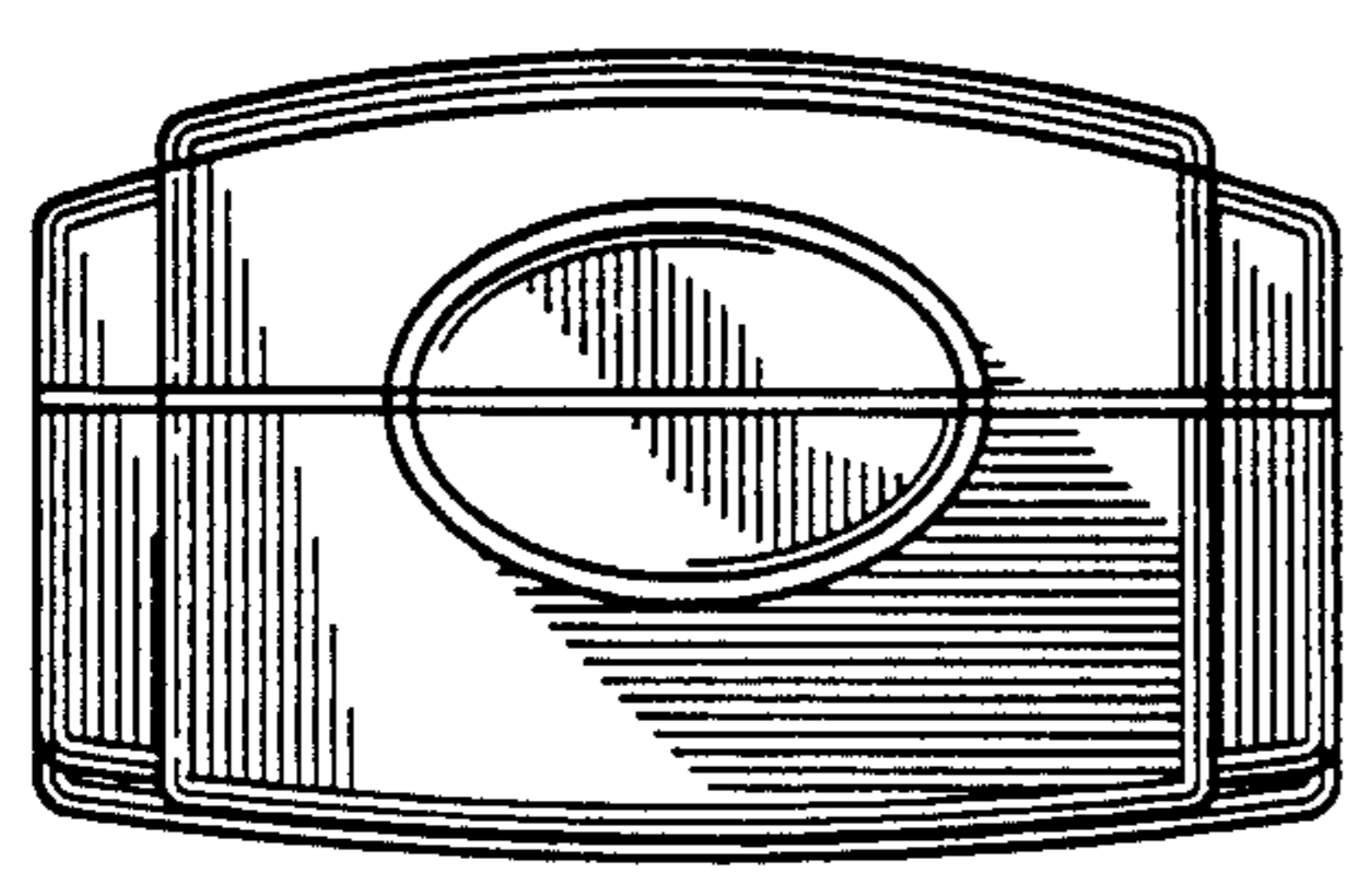

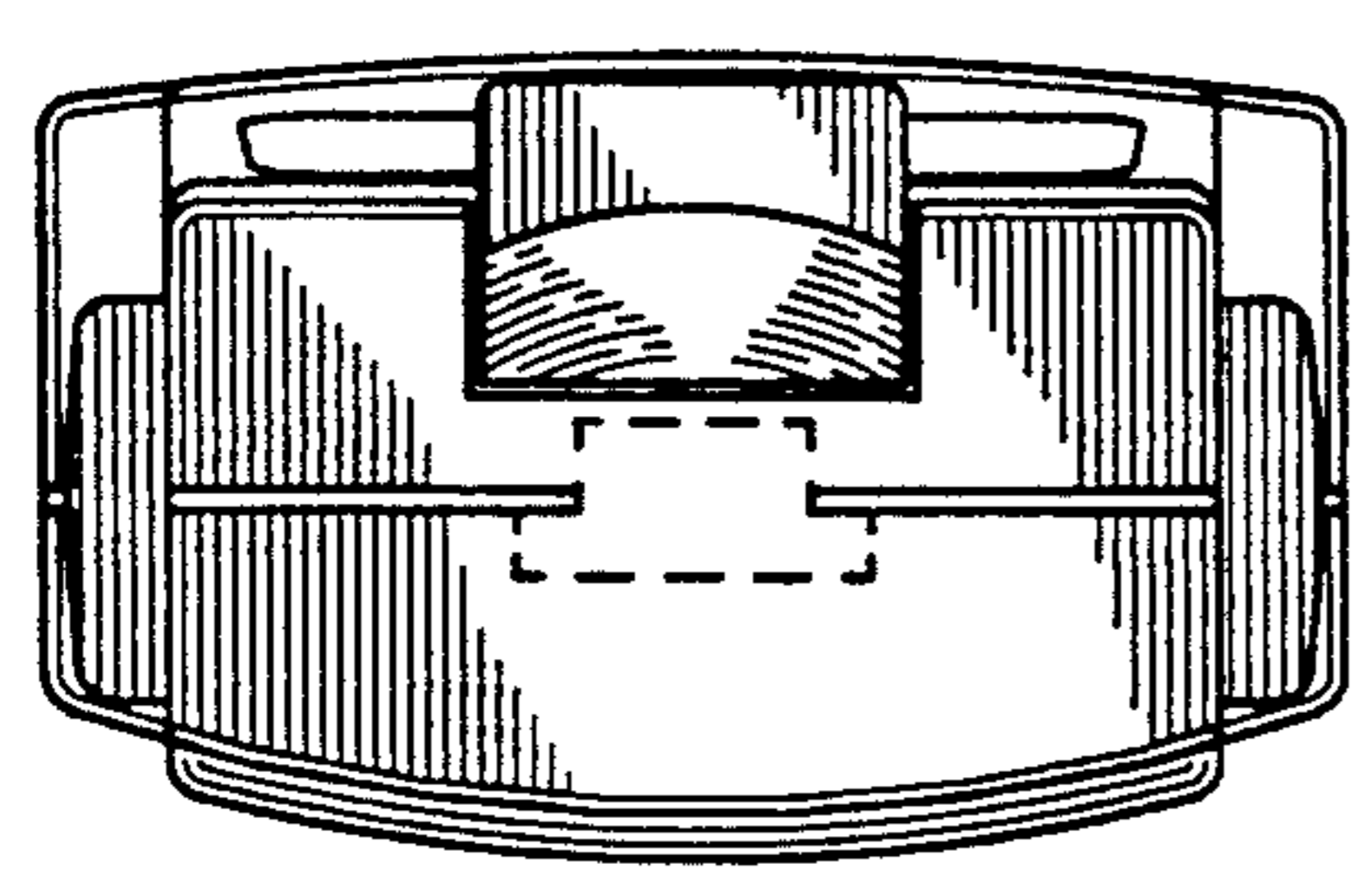

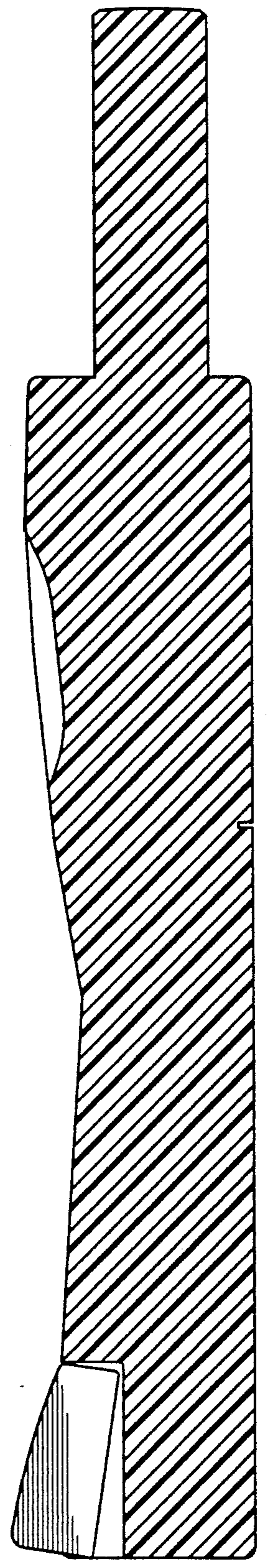
