FIG. 5 is a bottom plan view thereof;

FIG. 6 is a slightly enlarged right side elevation view thereof with the front piece removed showing internal structure for clarity of illustration;

FIG. 7 is a front elevation view of FIG. 6;

FIG. 8 is a perspective view showing the front and right side of FIG. 6 with the right interior lobe removed for clarity of illustration; and,

FIG. 9 is a rear perspective view of the front piece thereof shown separately for clarity of illustration.

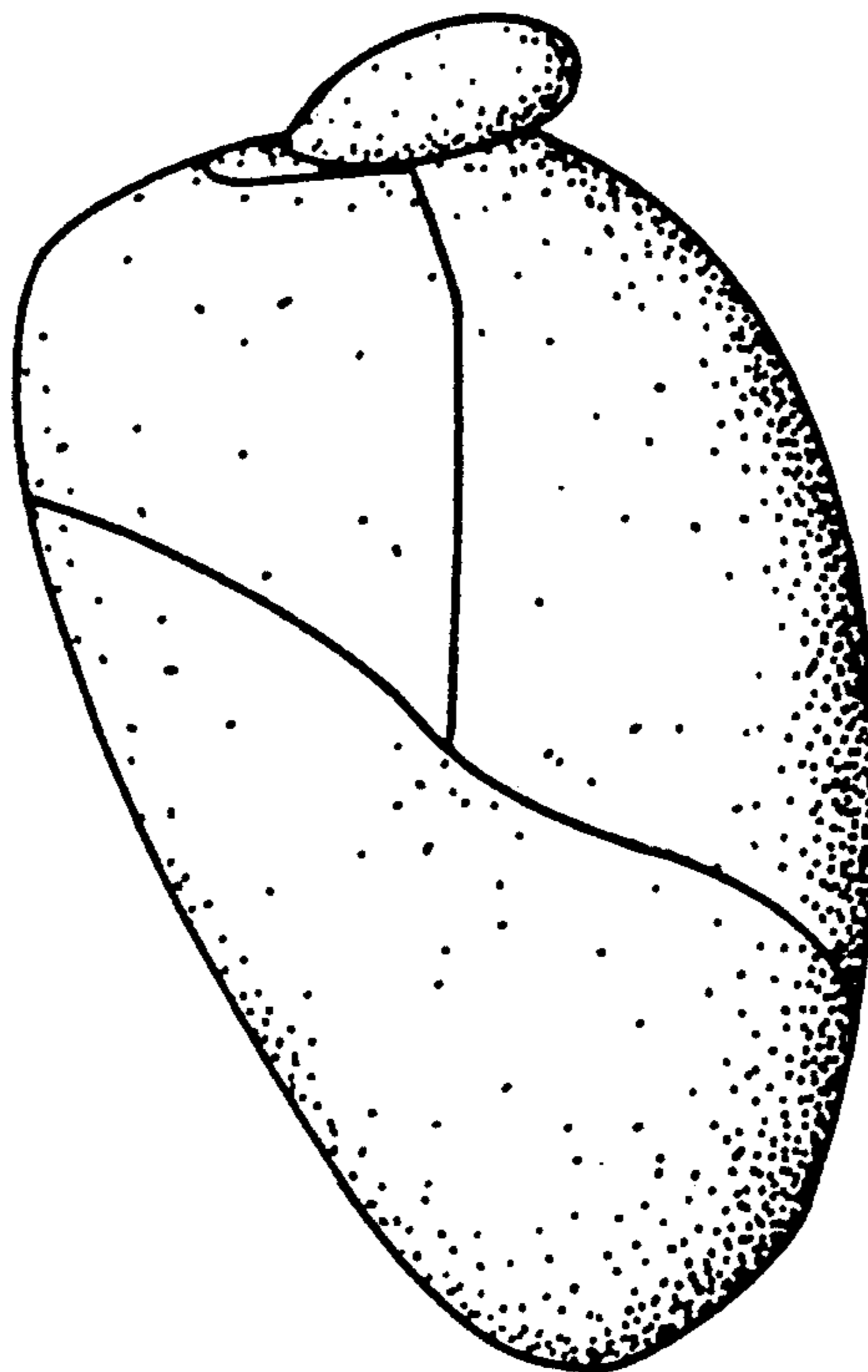

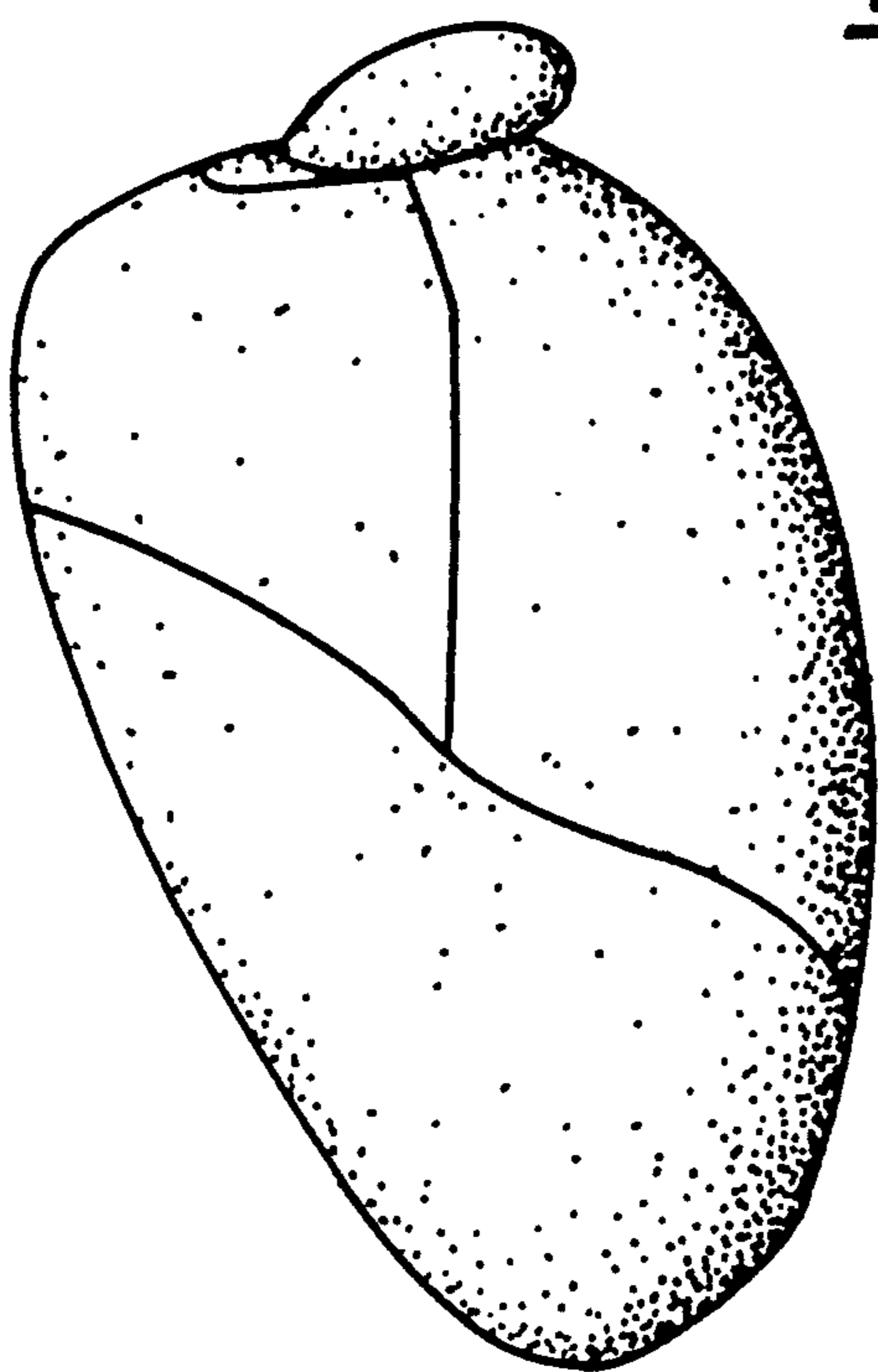
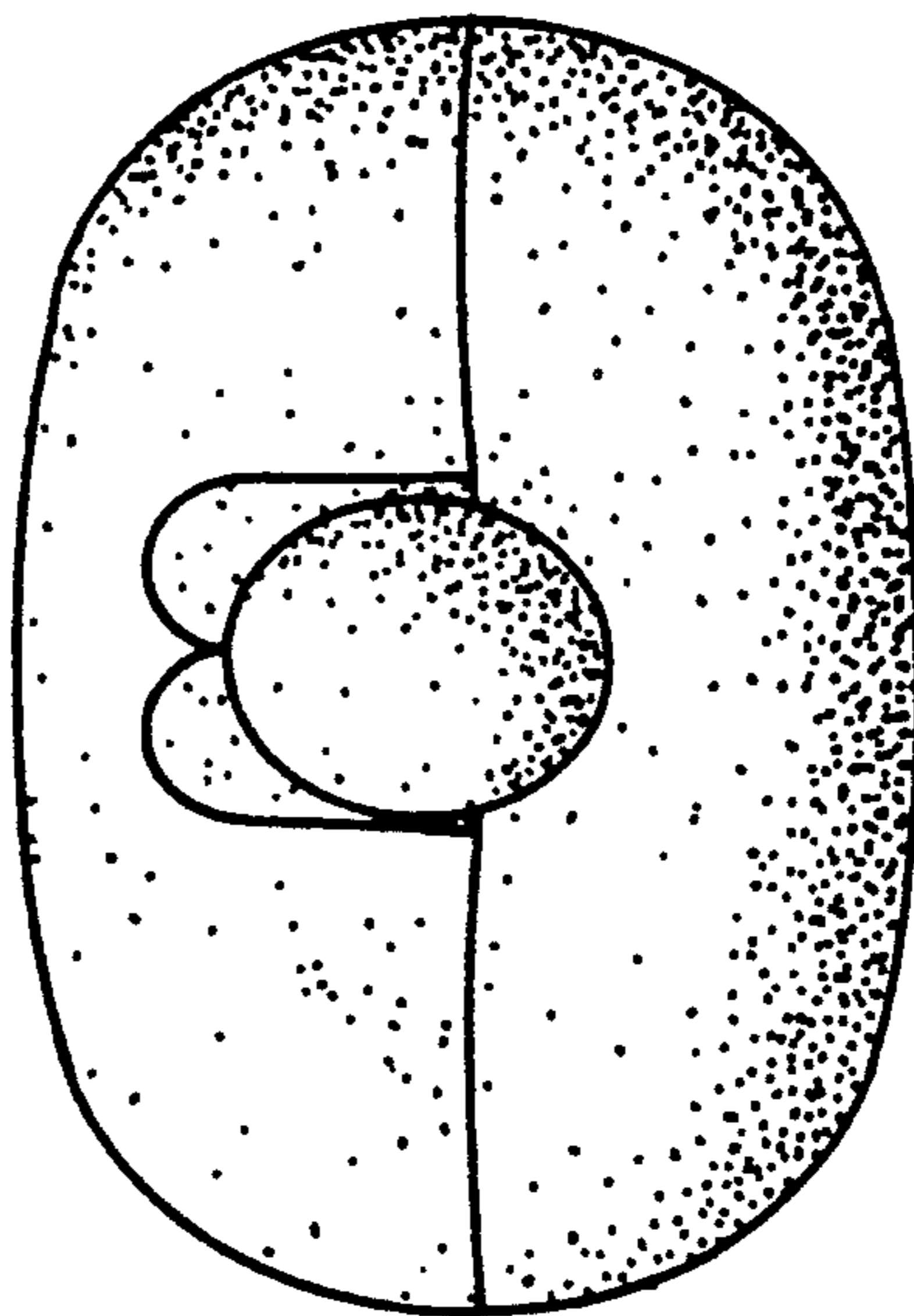

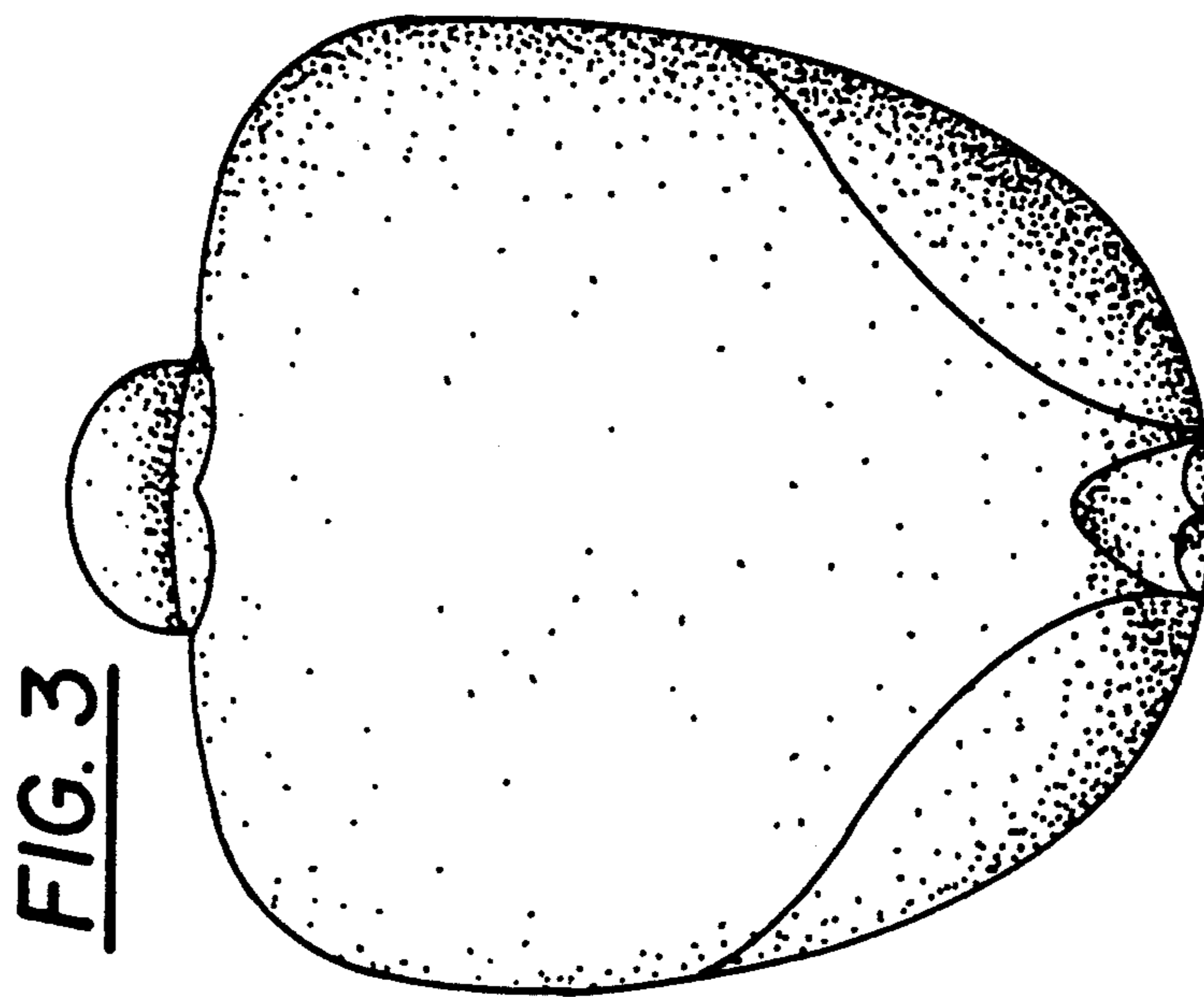

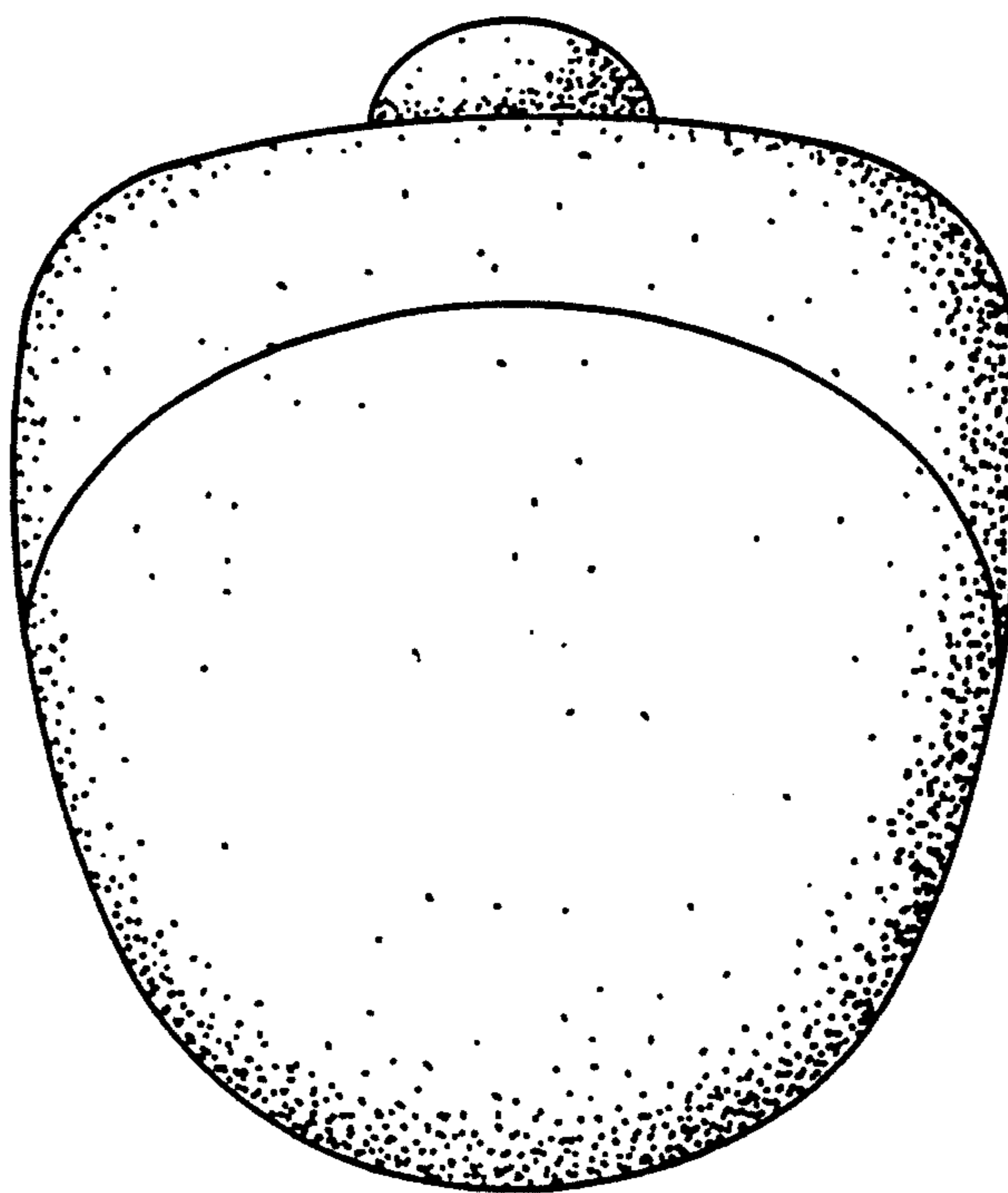

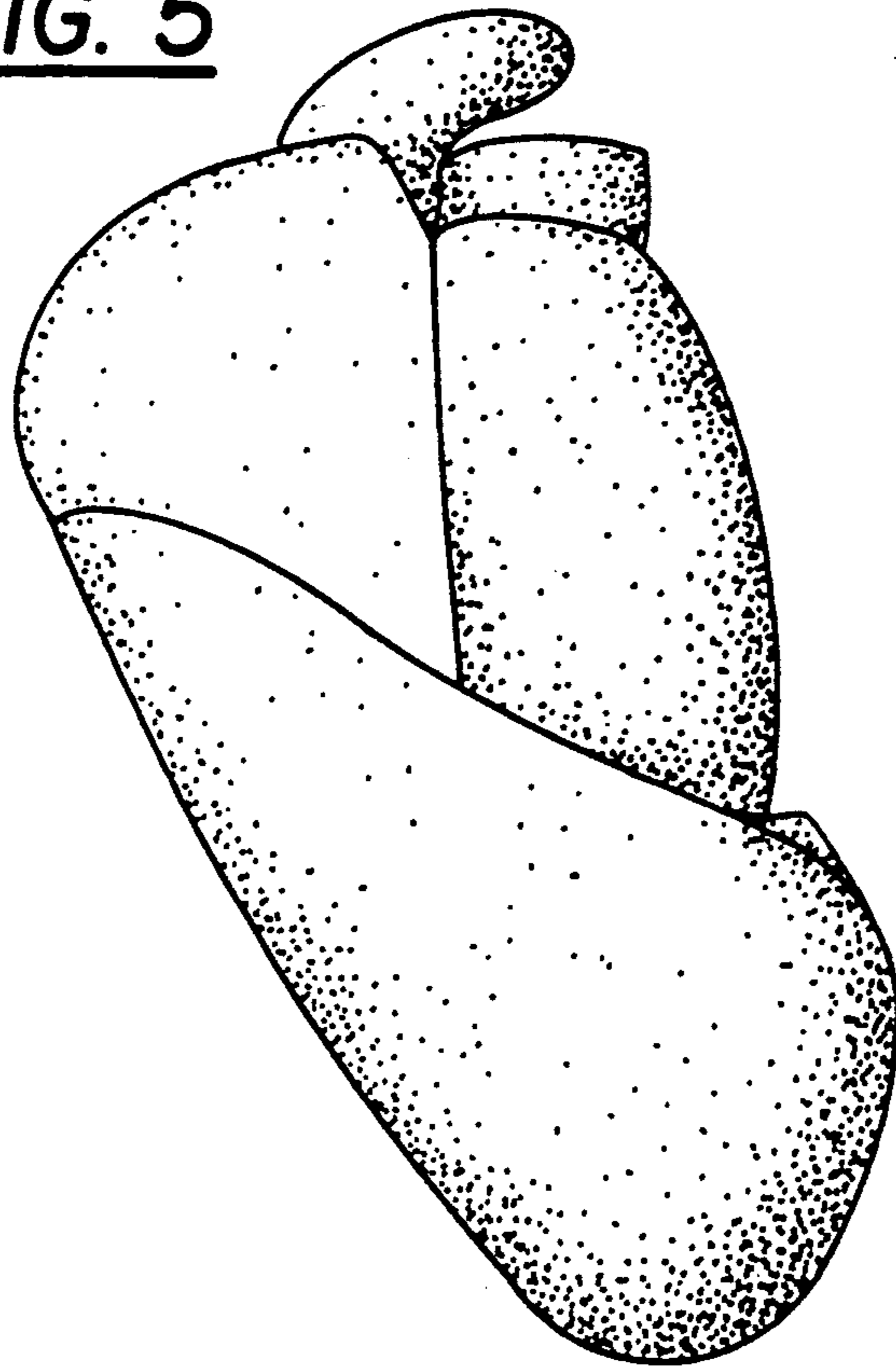

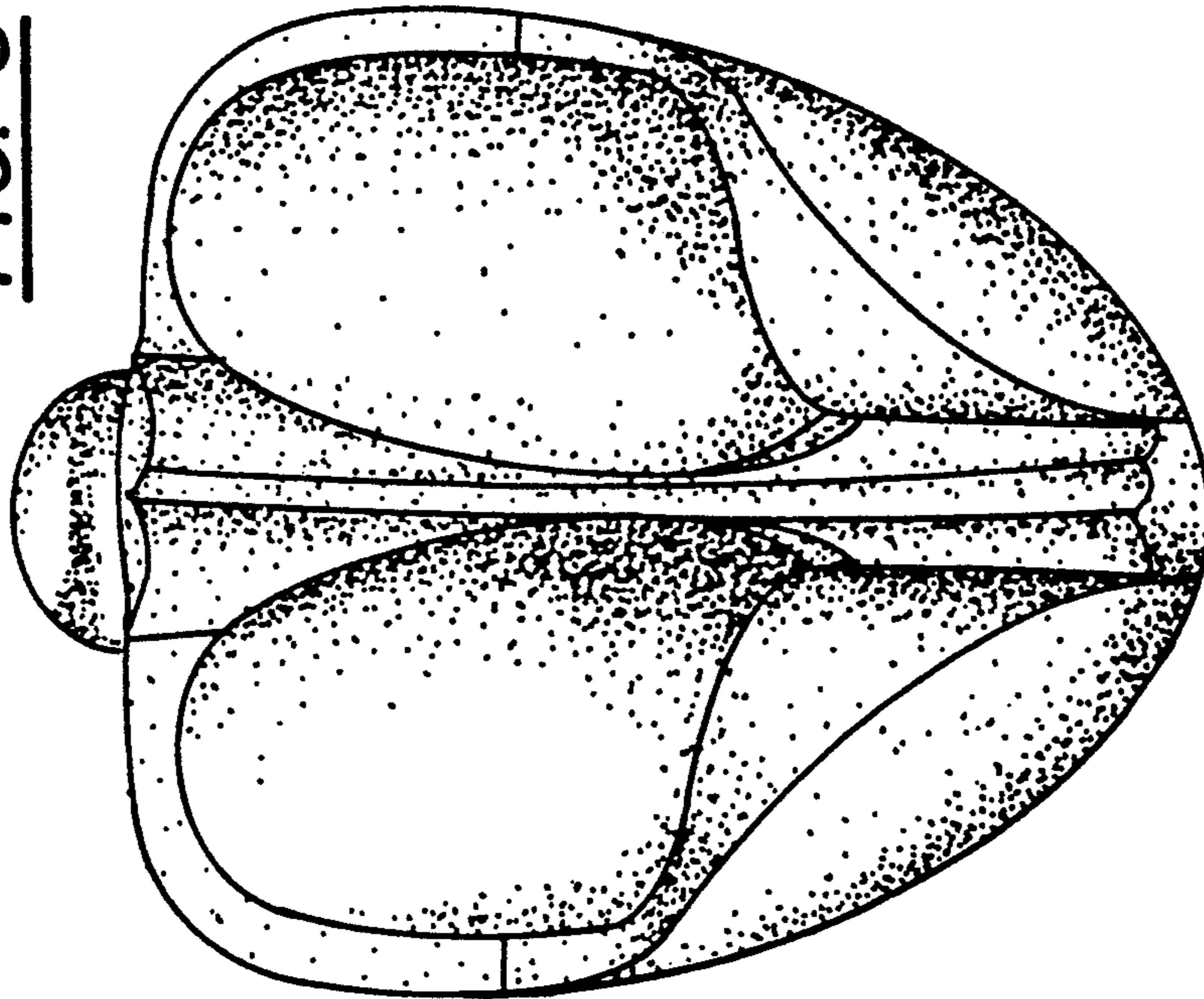

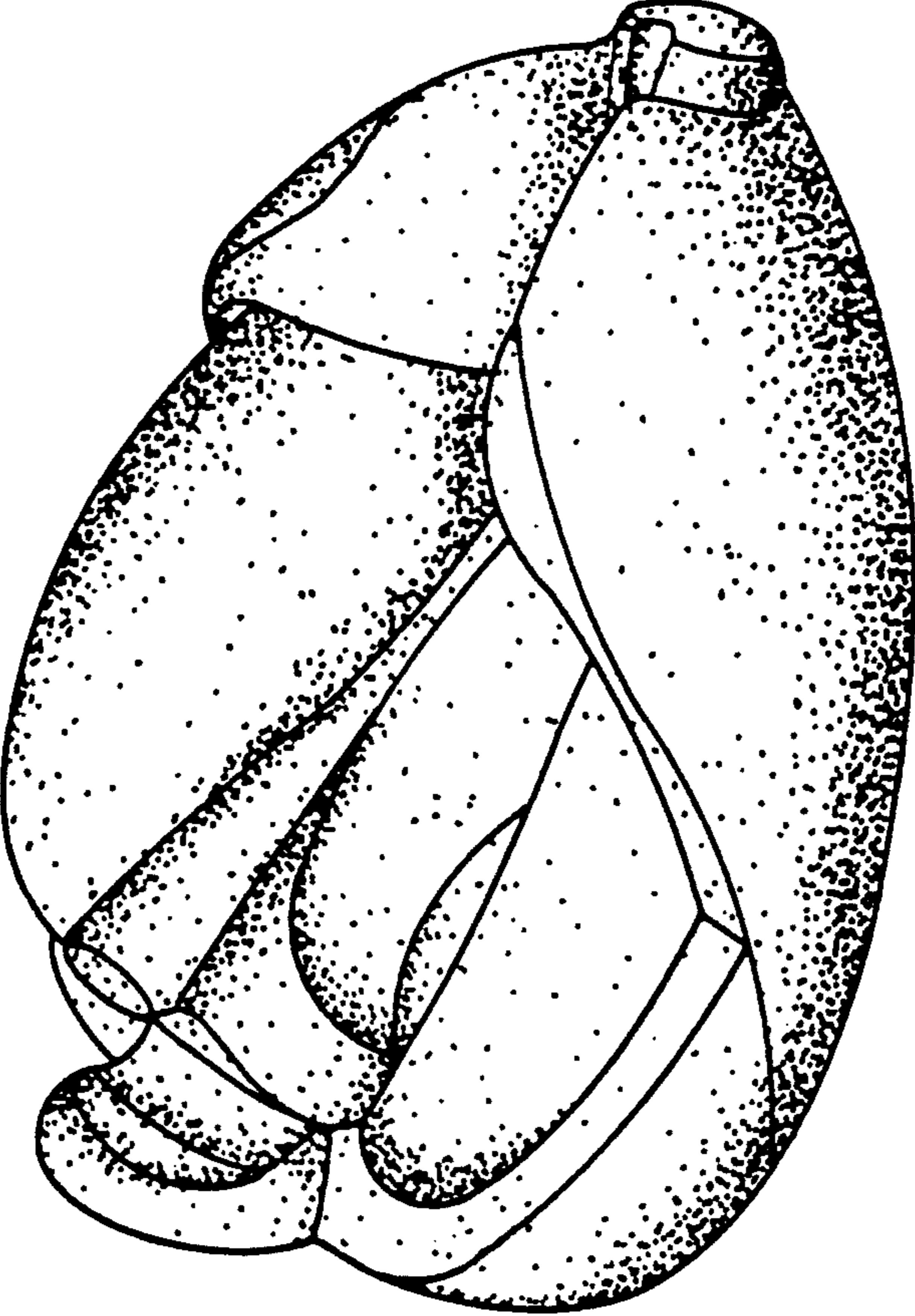
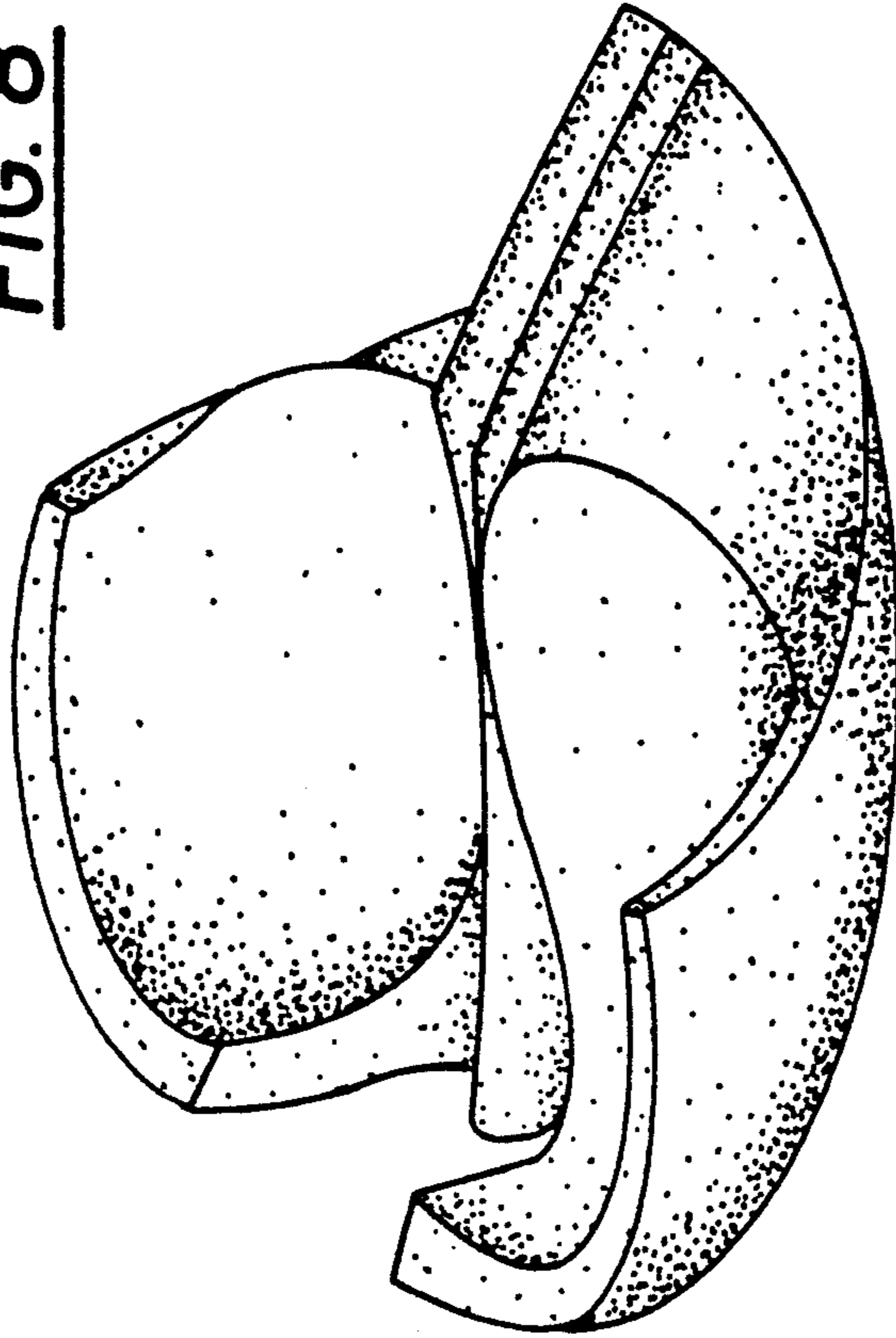
