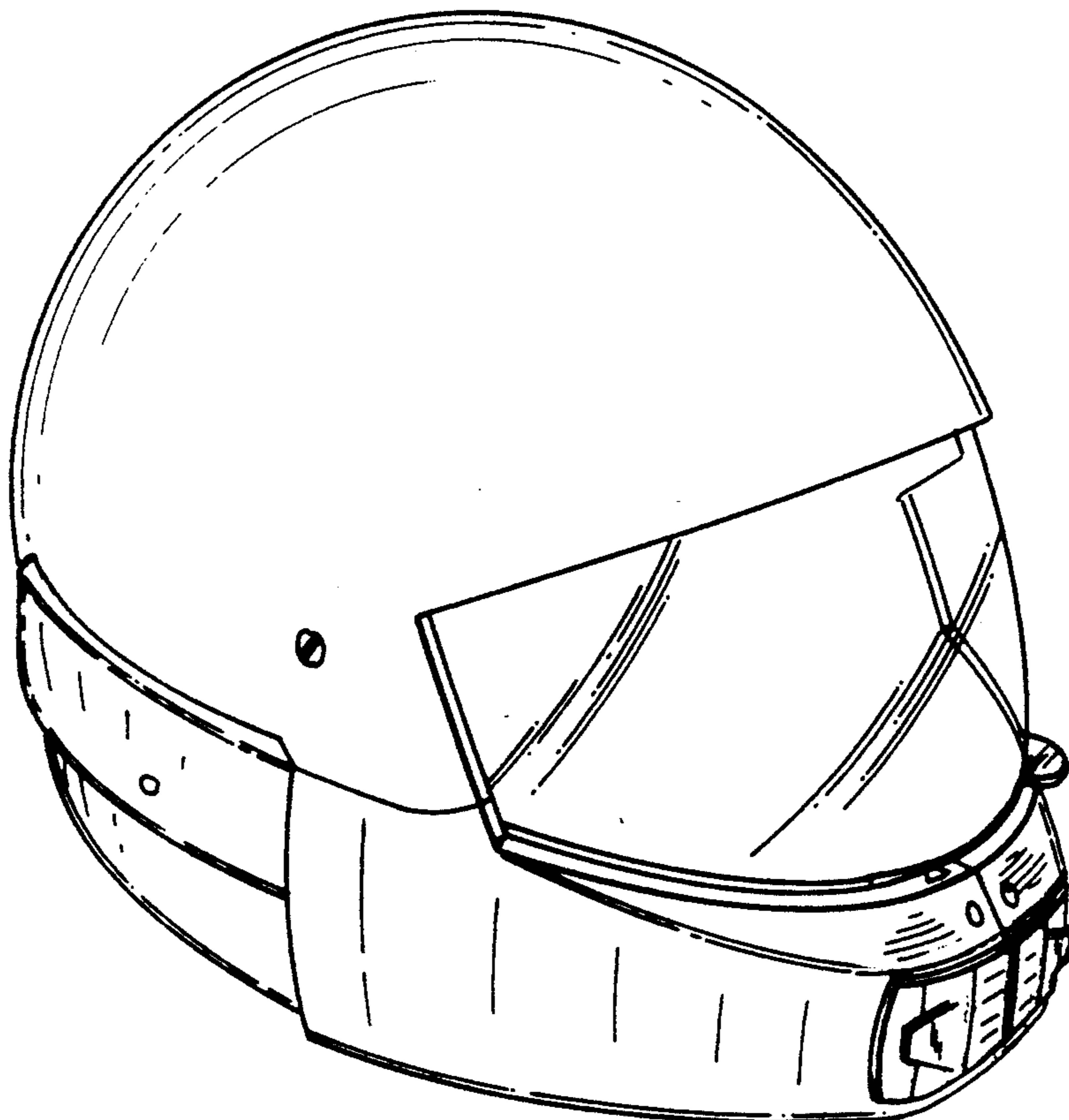

[57] **CLAIM**

The ornamental design for a motorcycle helmet, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and left side perspective view of a motorcycle helmet showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a perspective view thereof with the chin piece in an open position and the visor raised; FIG. 9 is a front elevational view thereof; FIG. 10 is a left side elevational view thereof; FIG. 11 is a right side elevational view thereof; FIG. 12 is a rear elevational view thereof; FIG. 13 is a top plan view thereof; FIG. 14 is a bottom perspective view thereof; FIG. 15 is a perspective view thereof with the chin piece in an open position and the visor lowered; and, FIG. 16 is a perspective view thereof with the chin piece in a closed position and the visor raised.



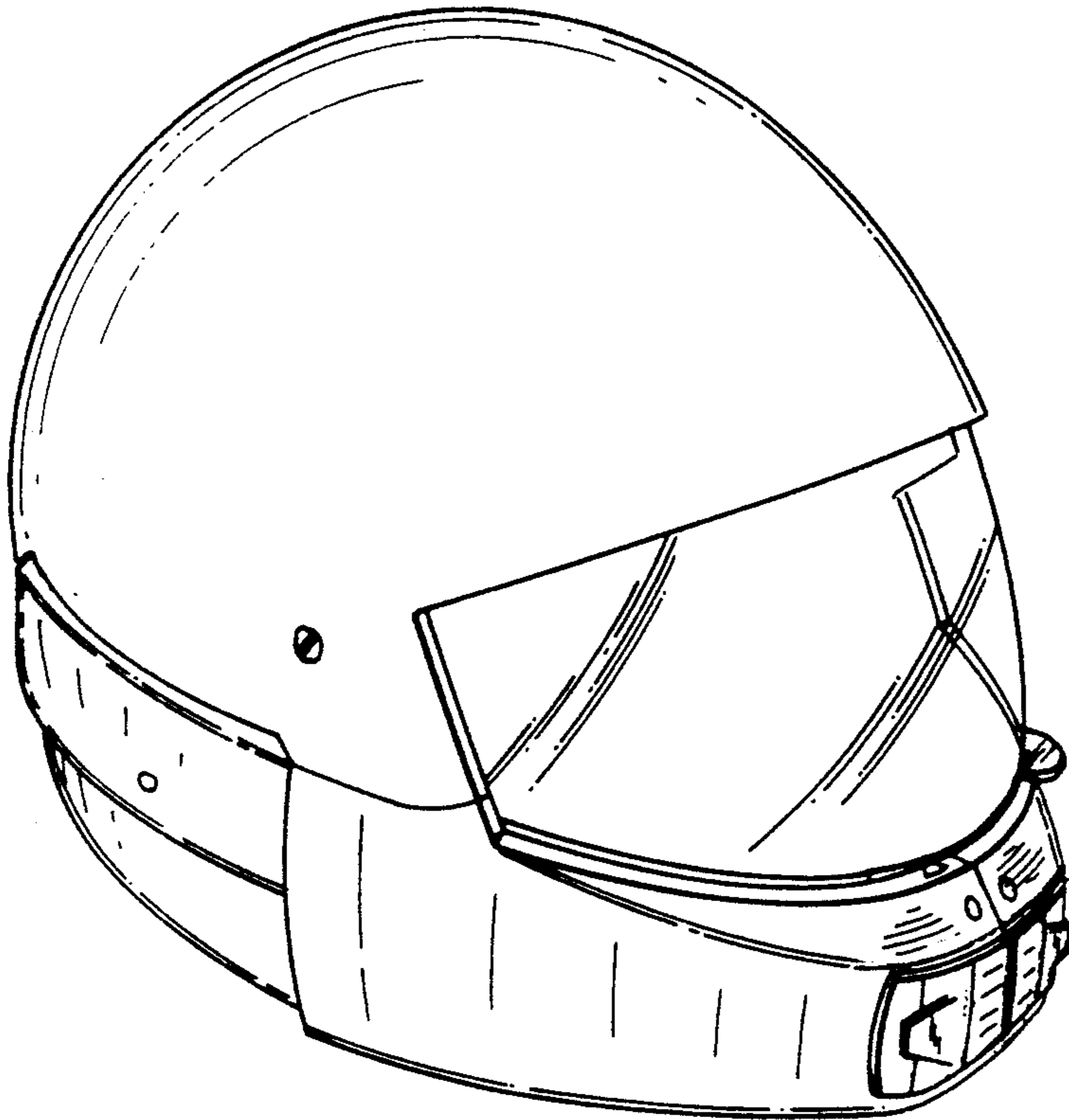
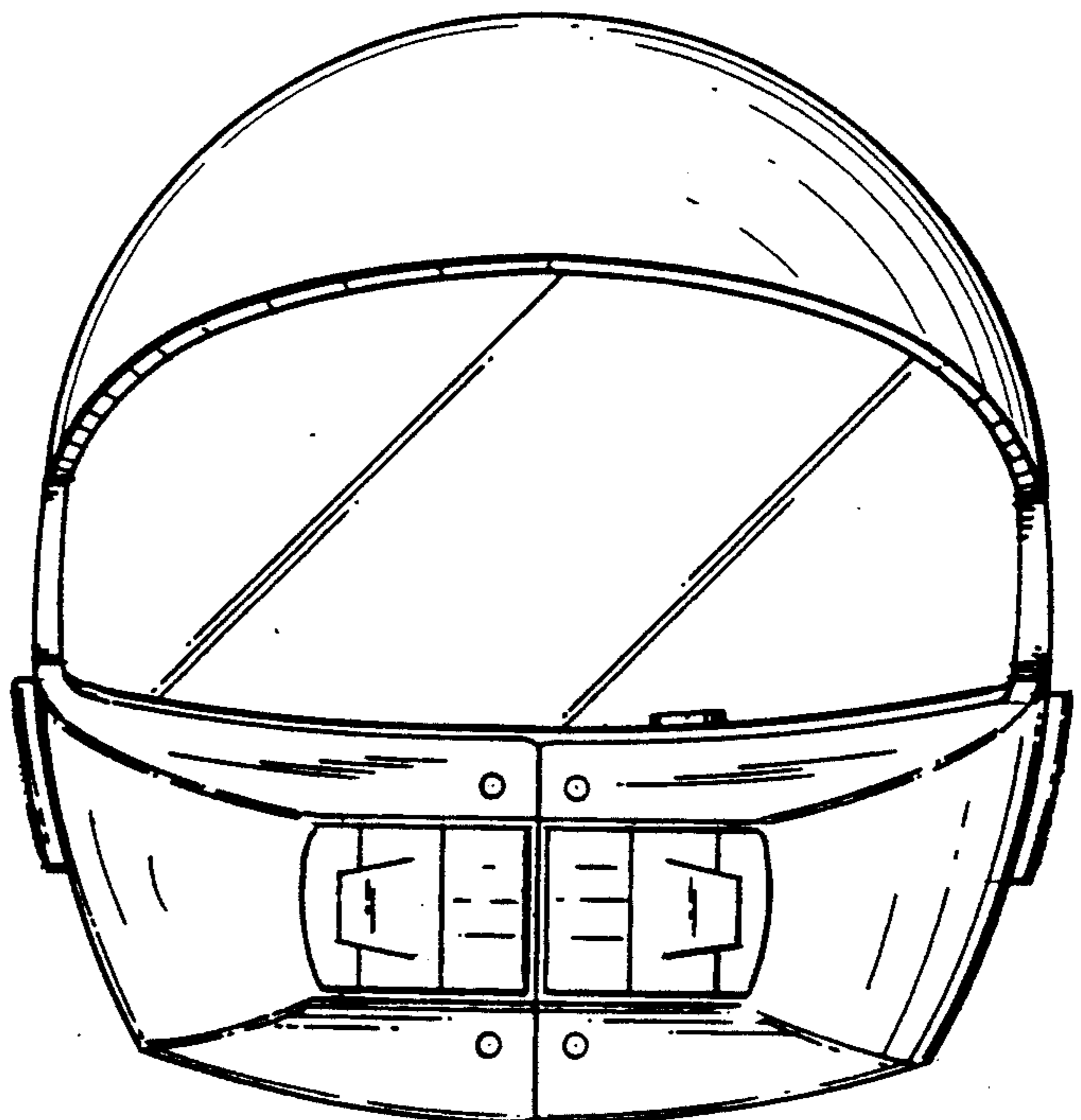

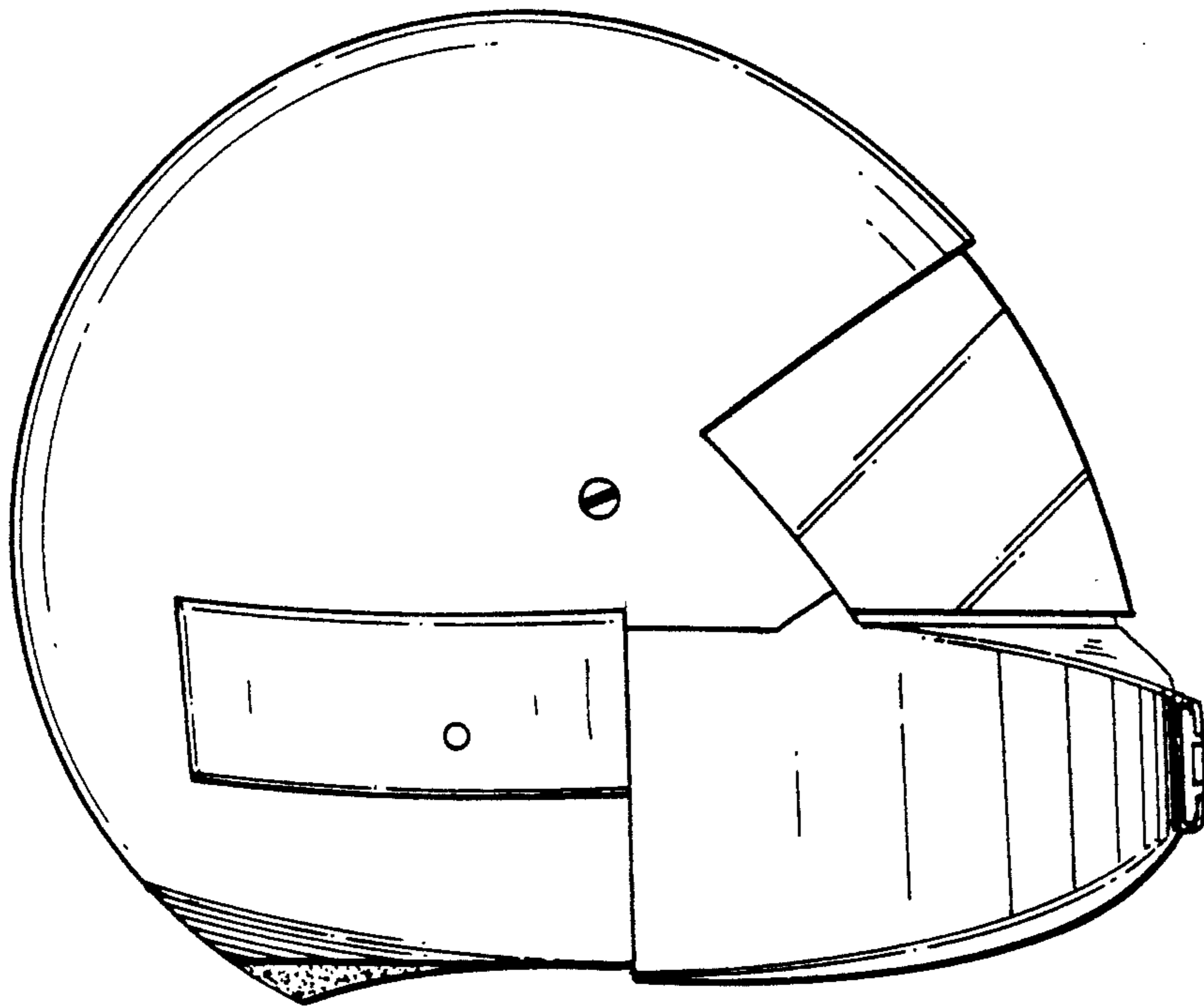
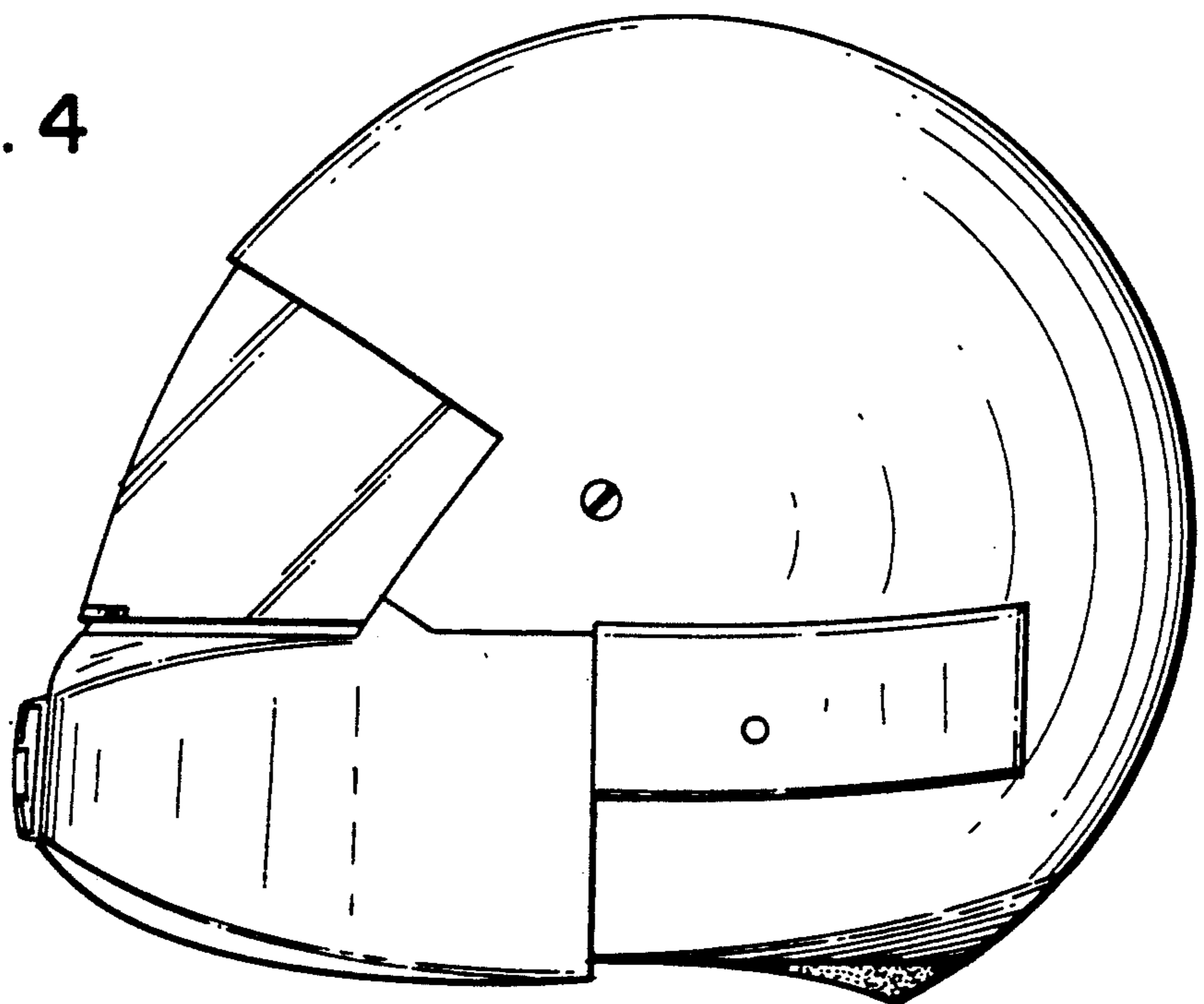

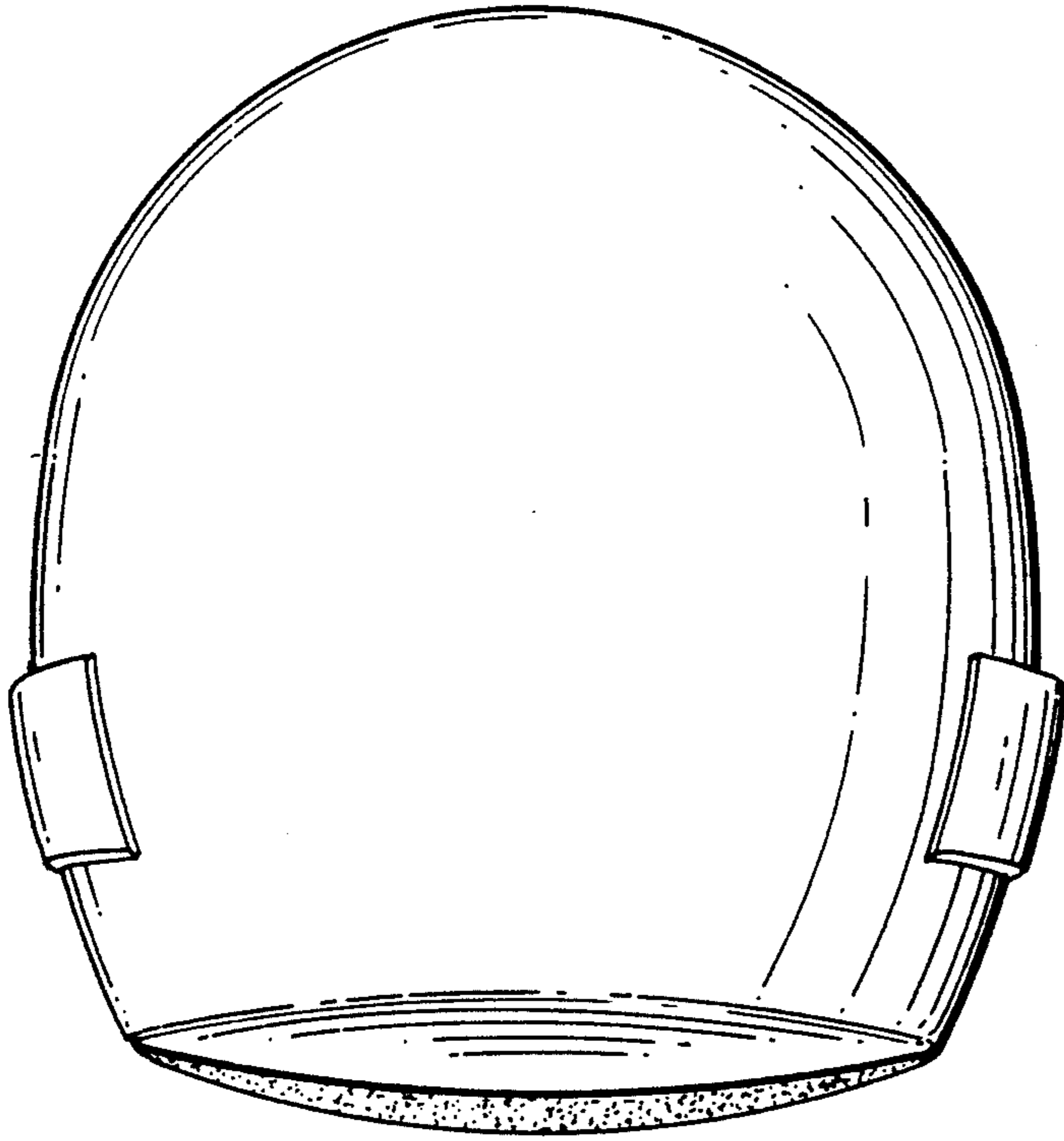
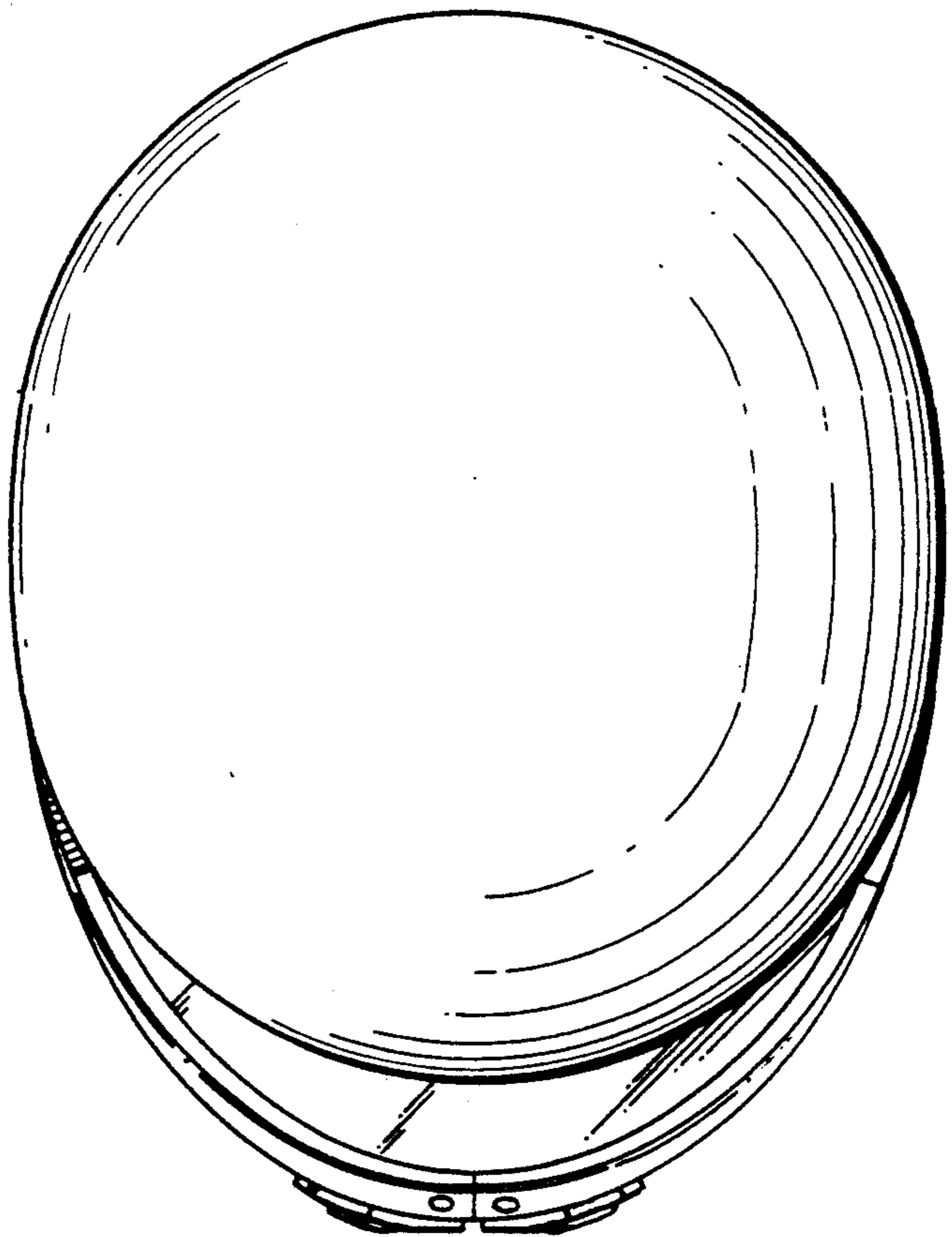

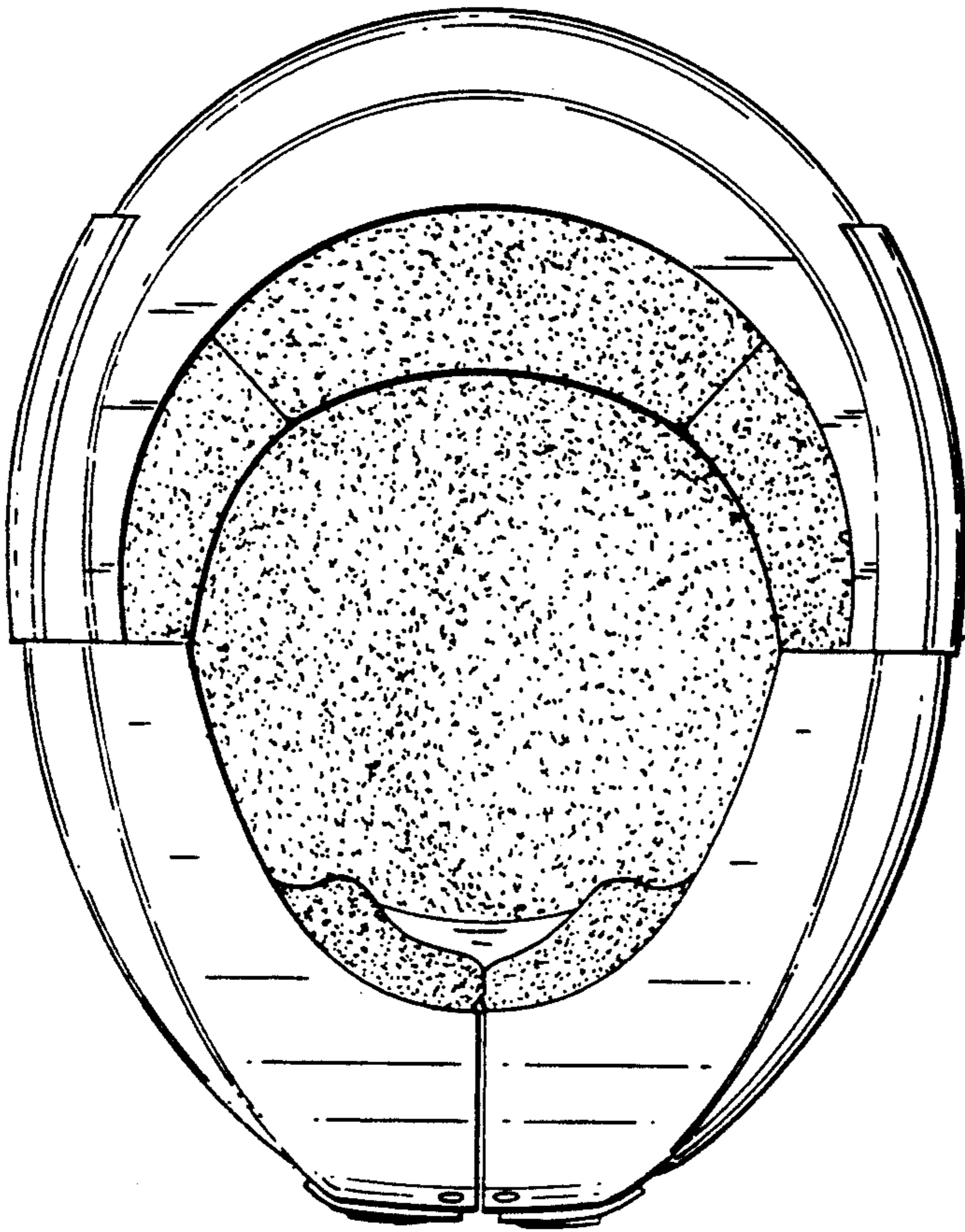
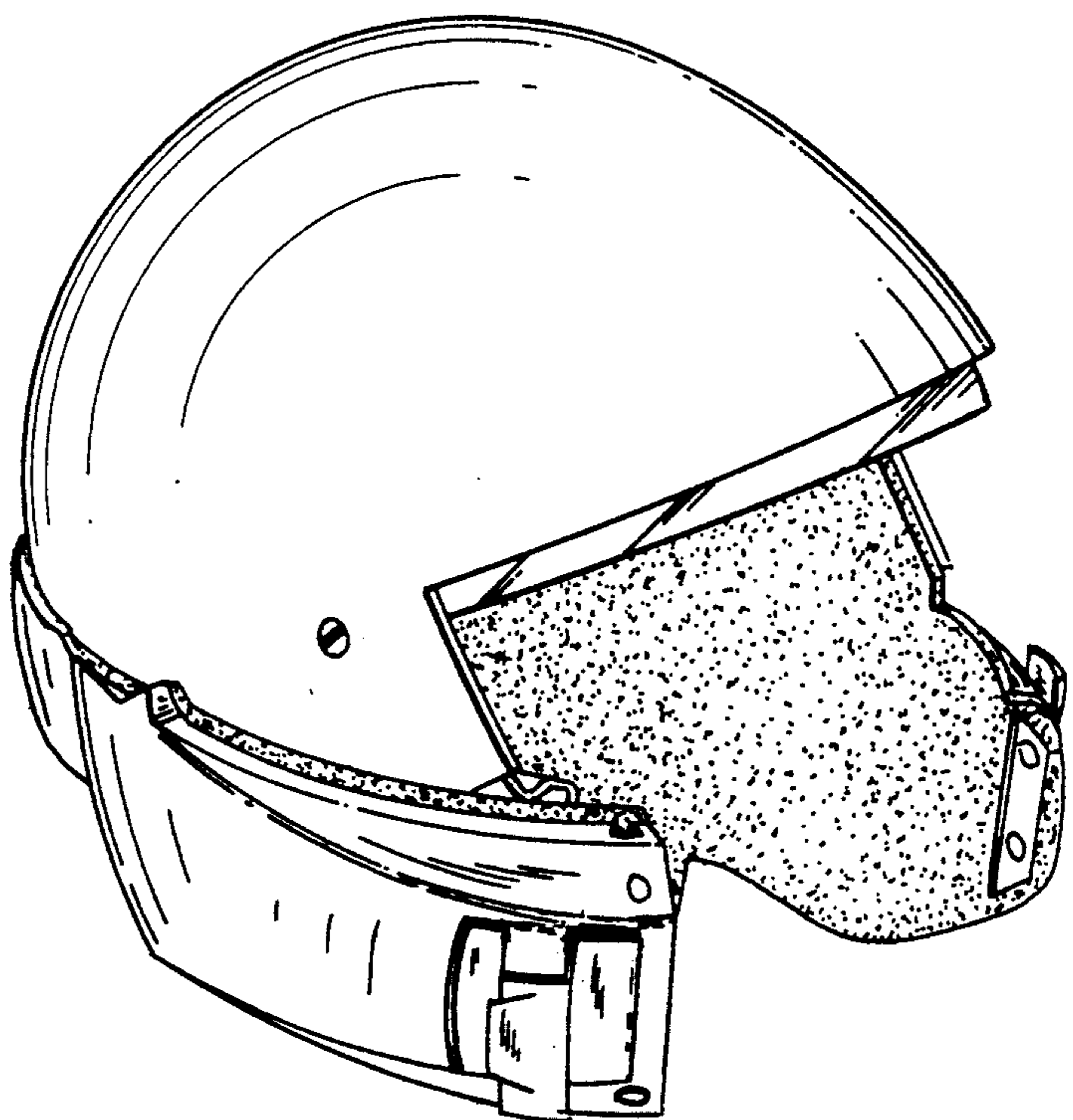

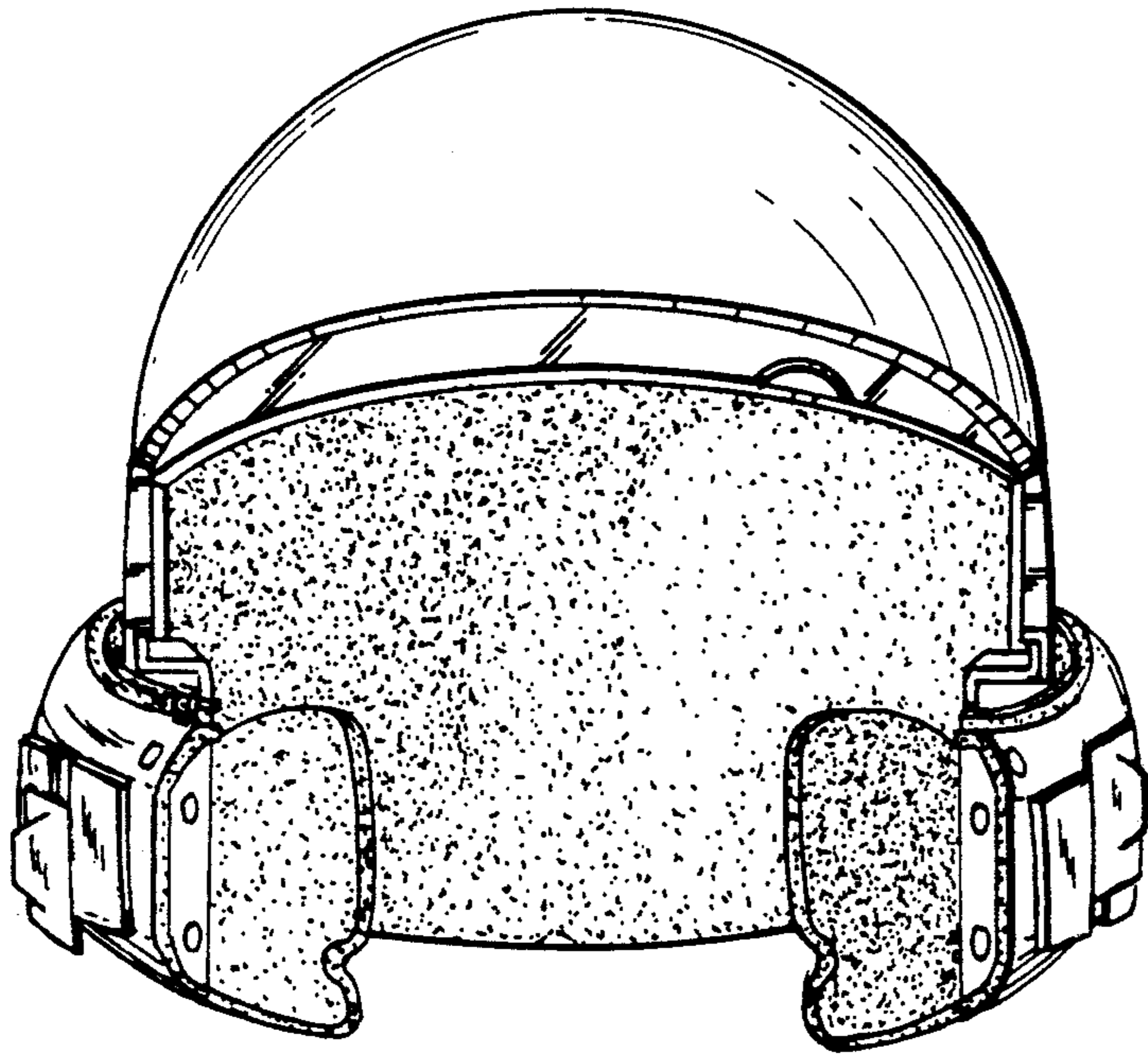
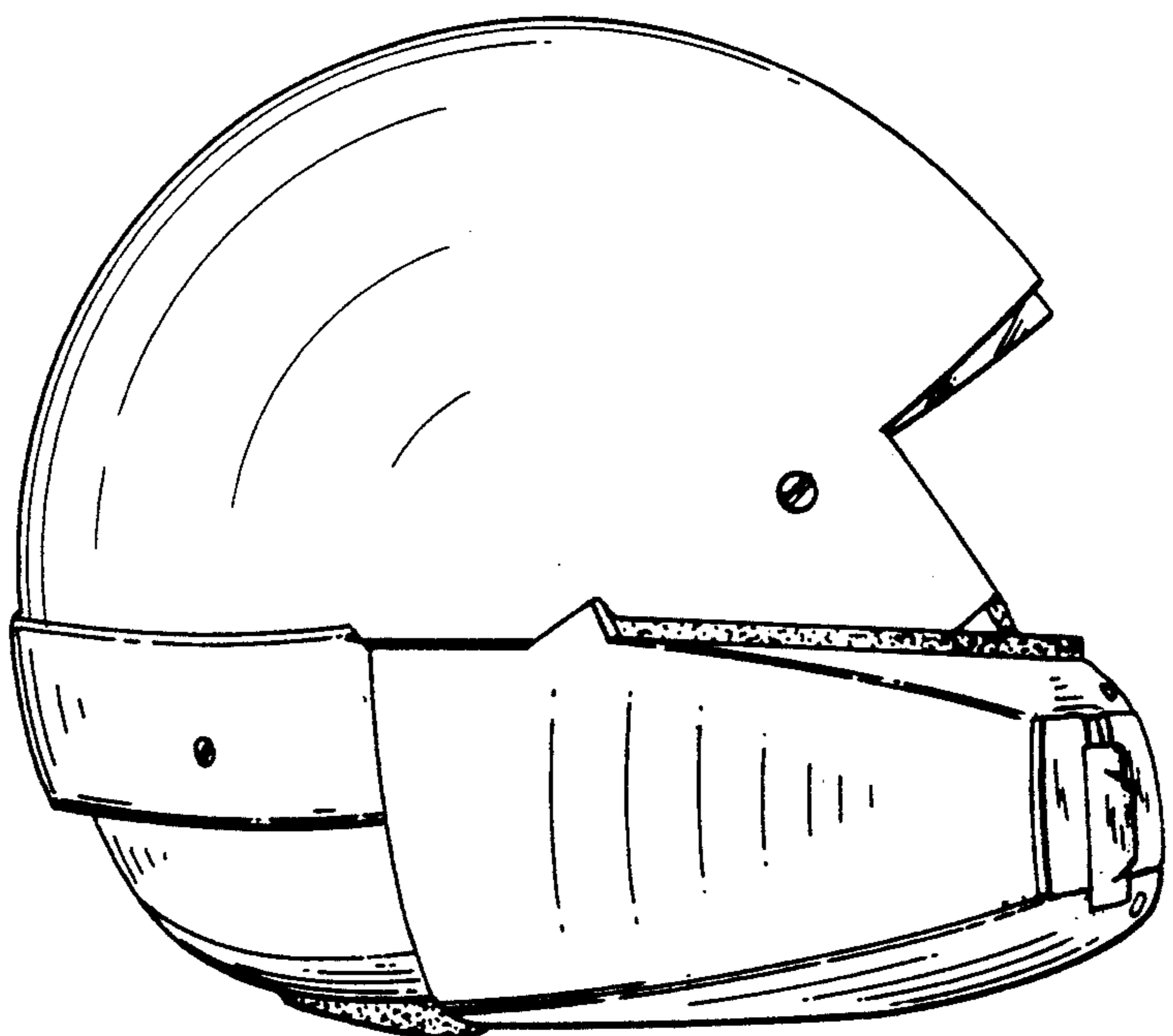

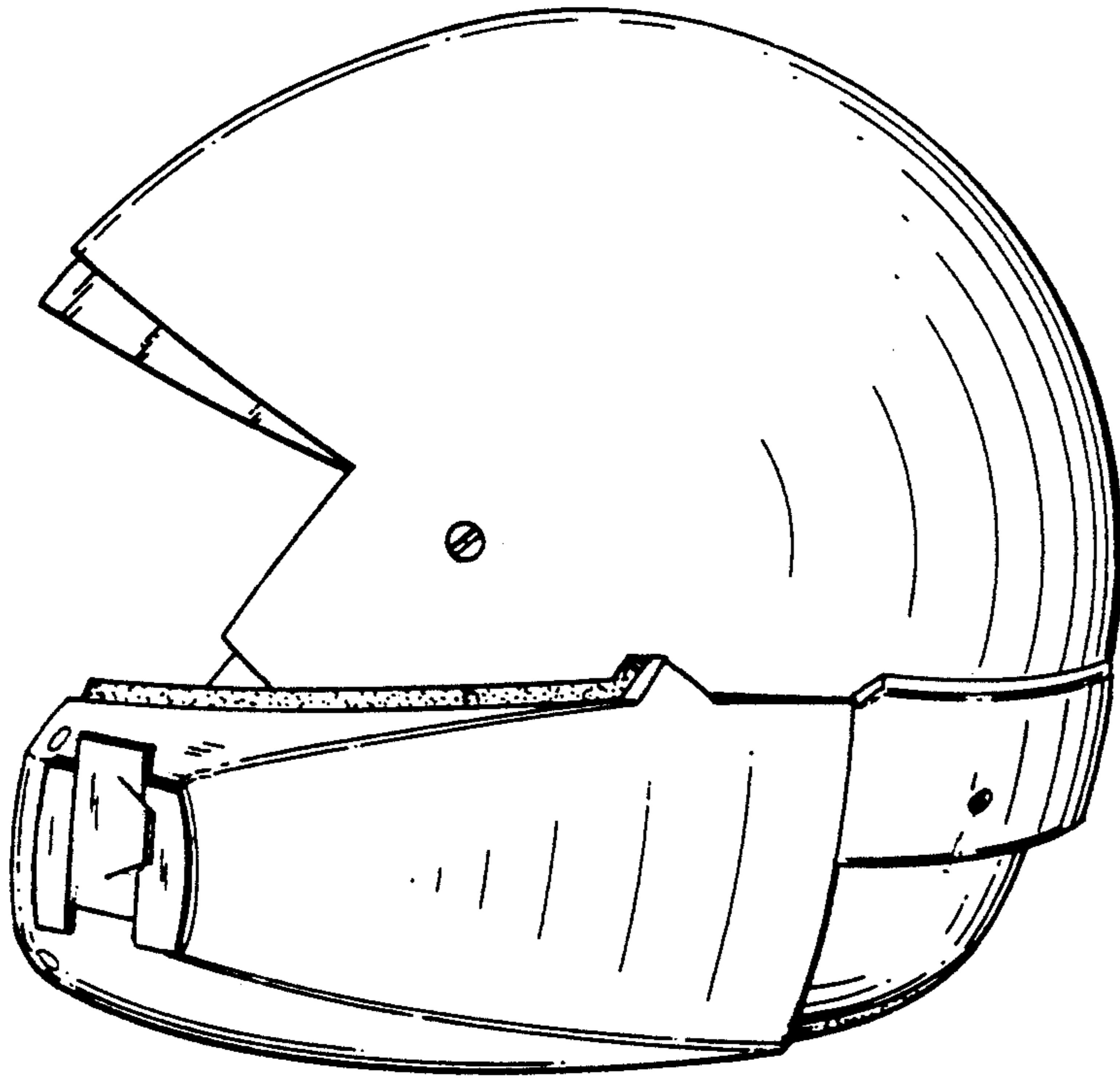
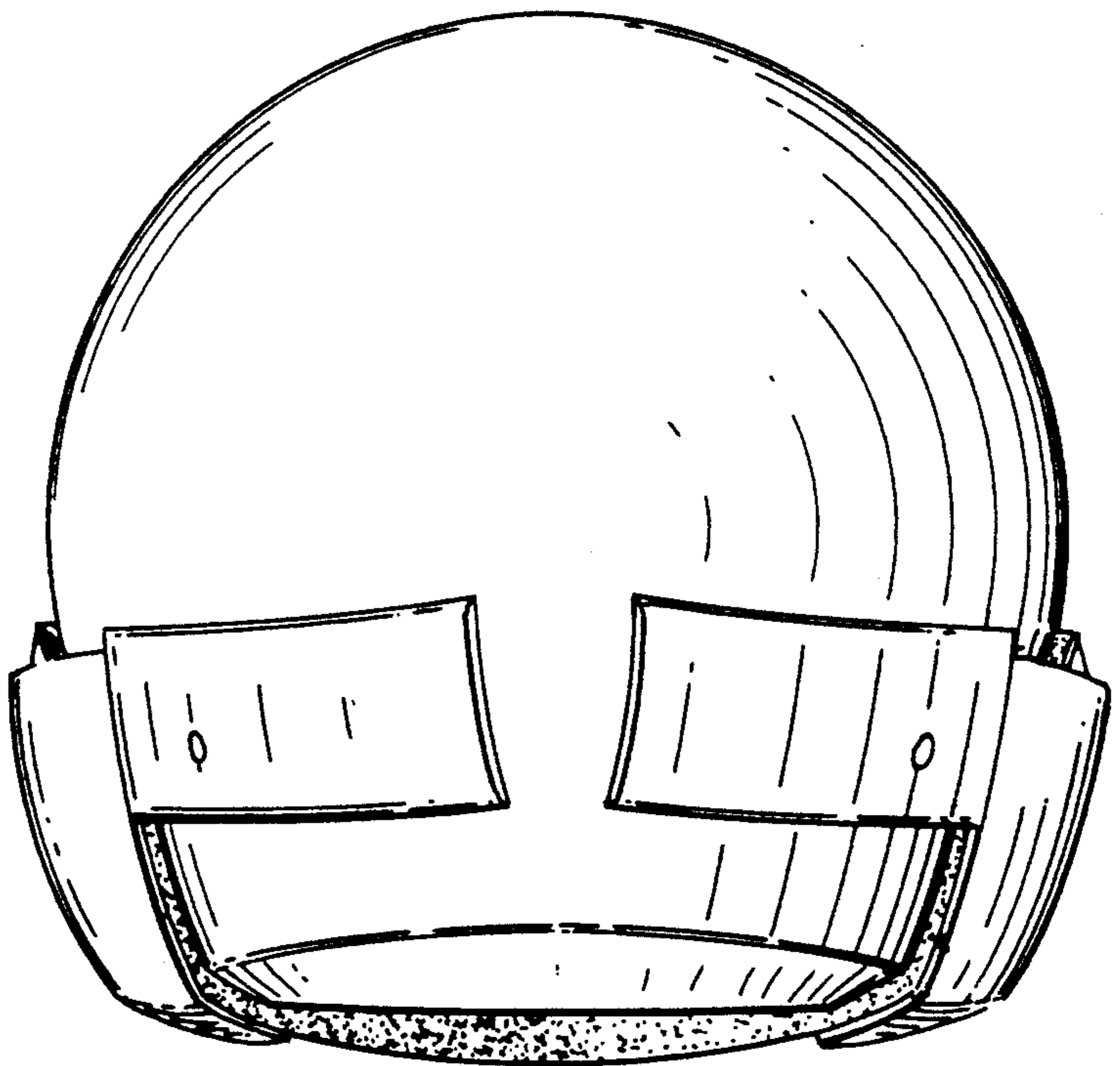

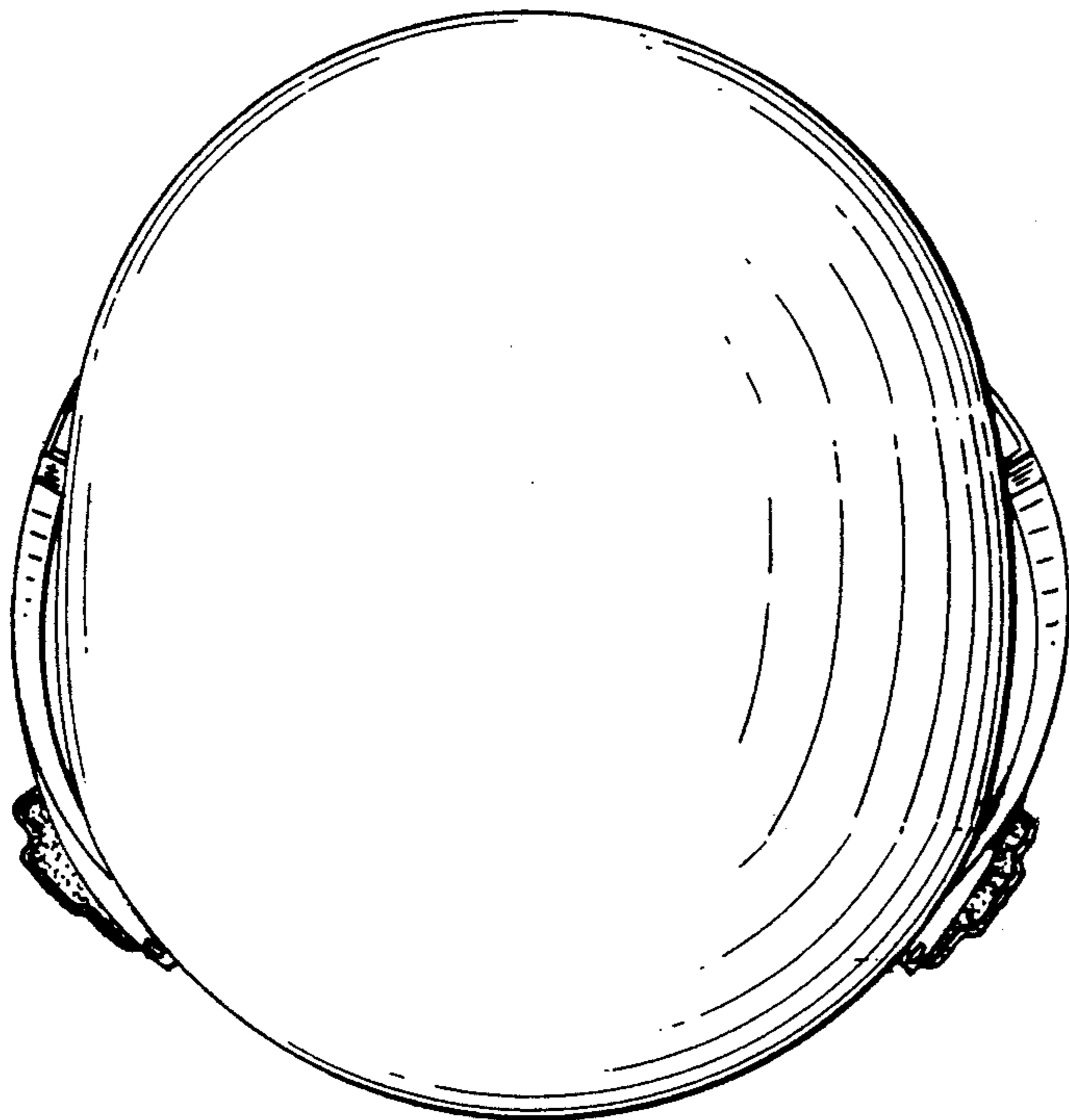
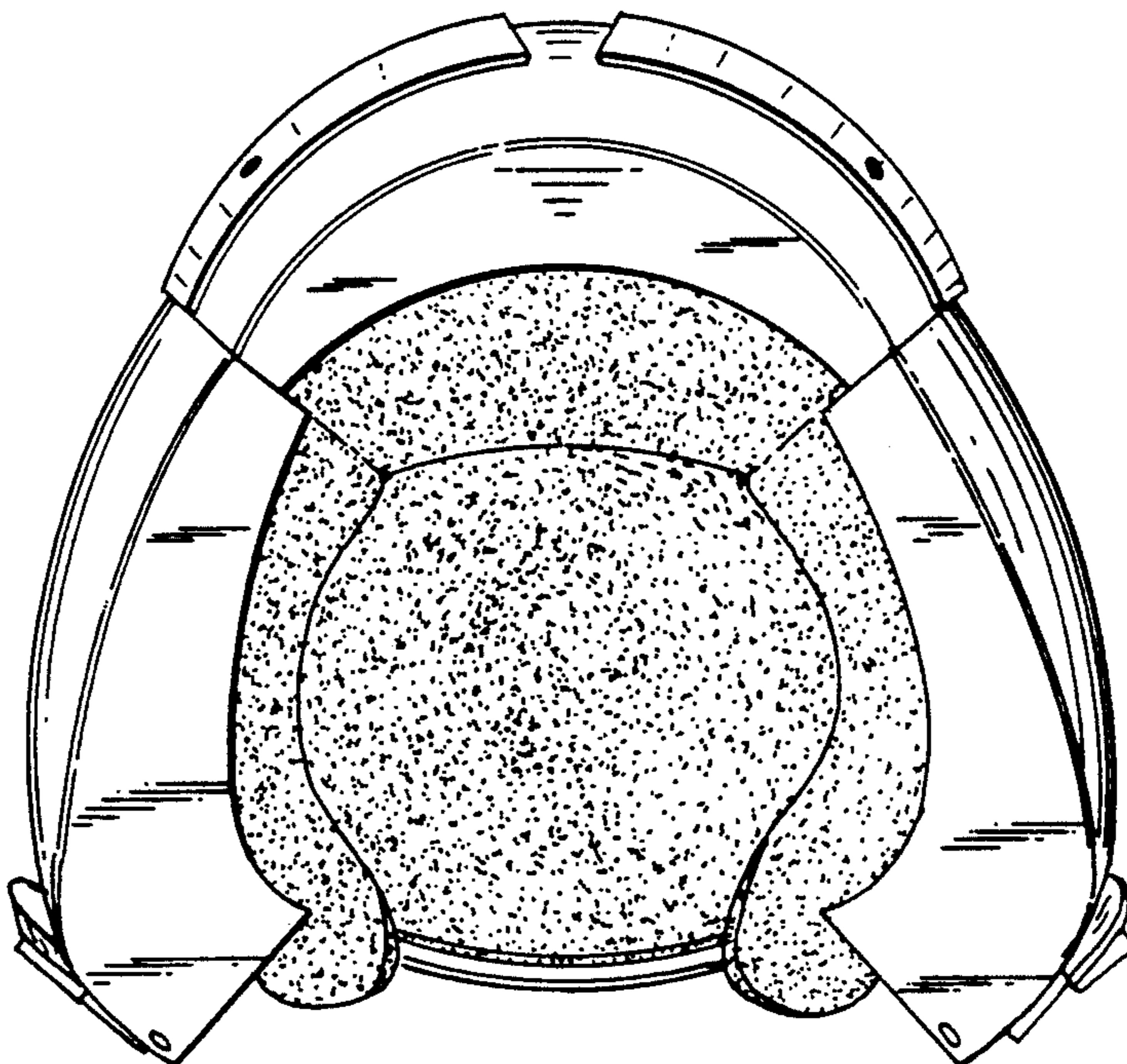

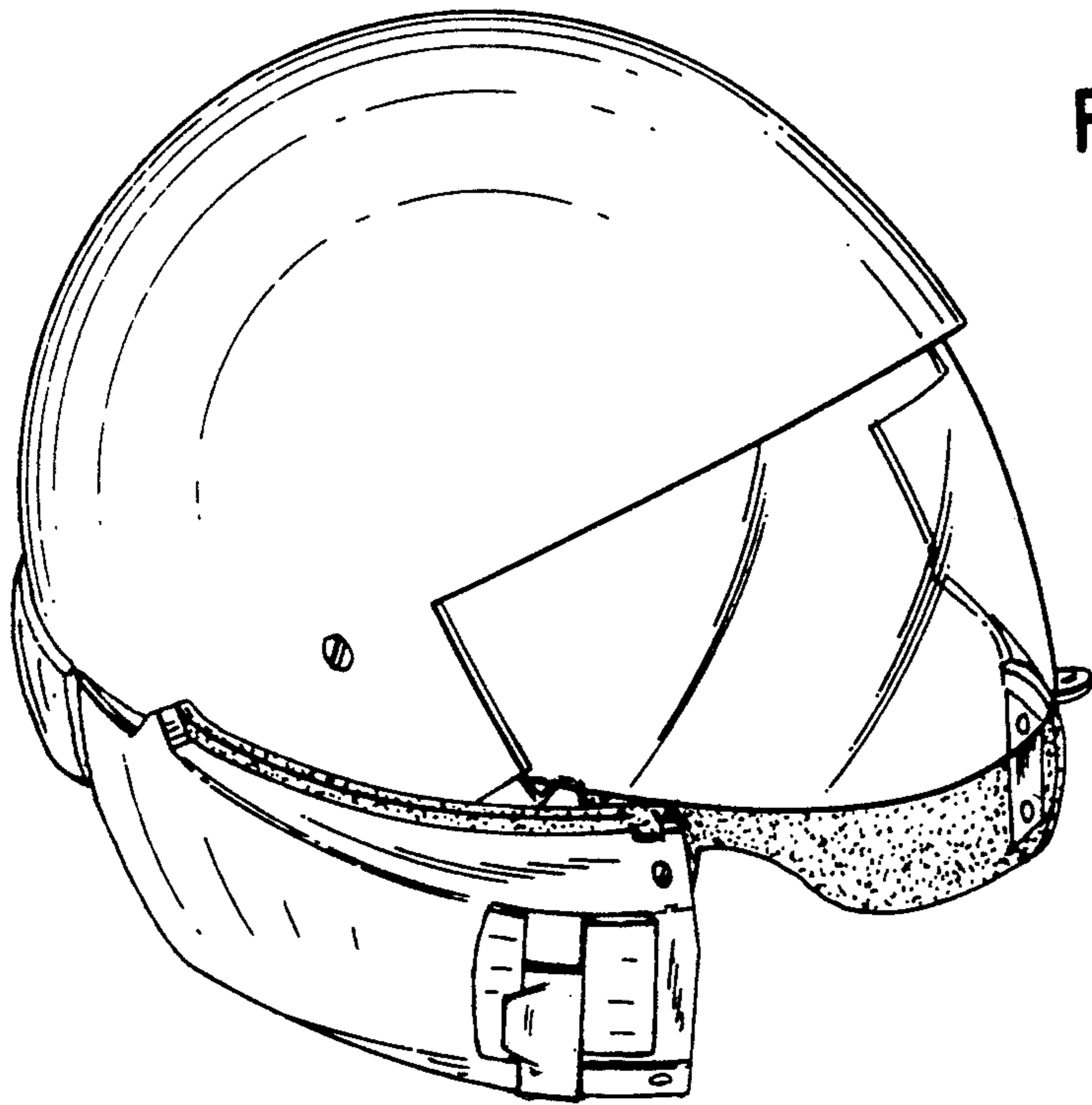
