### DESCRIPTION

FIG. 1 is a side elevational view of a sanitary garment for animals showing my new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a top plan view of a second embodiment of FIG. 1;  
FIG. 4 is a rear elevational view of FIGS. 1 and 3;  
FIG. 5 is a side elevational view of FIGS. 1 and 3, the opposite side being a mirror image of the side shown;  
FIG. 6 is a front elevational view of FIGS. 1 and 3; and,  
FIG. 7 is a bottom plan view of FIGS. 1 and 3.

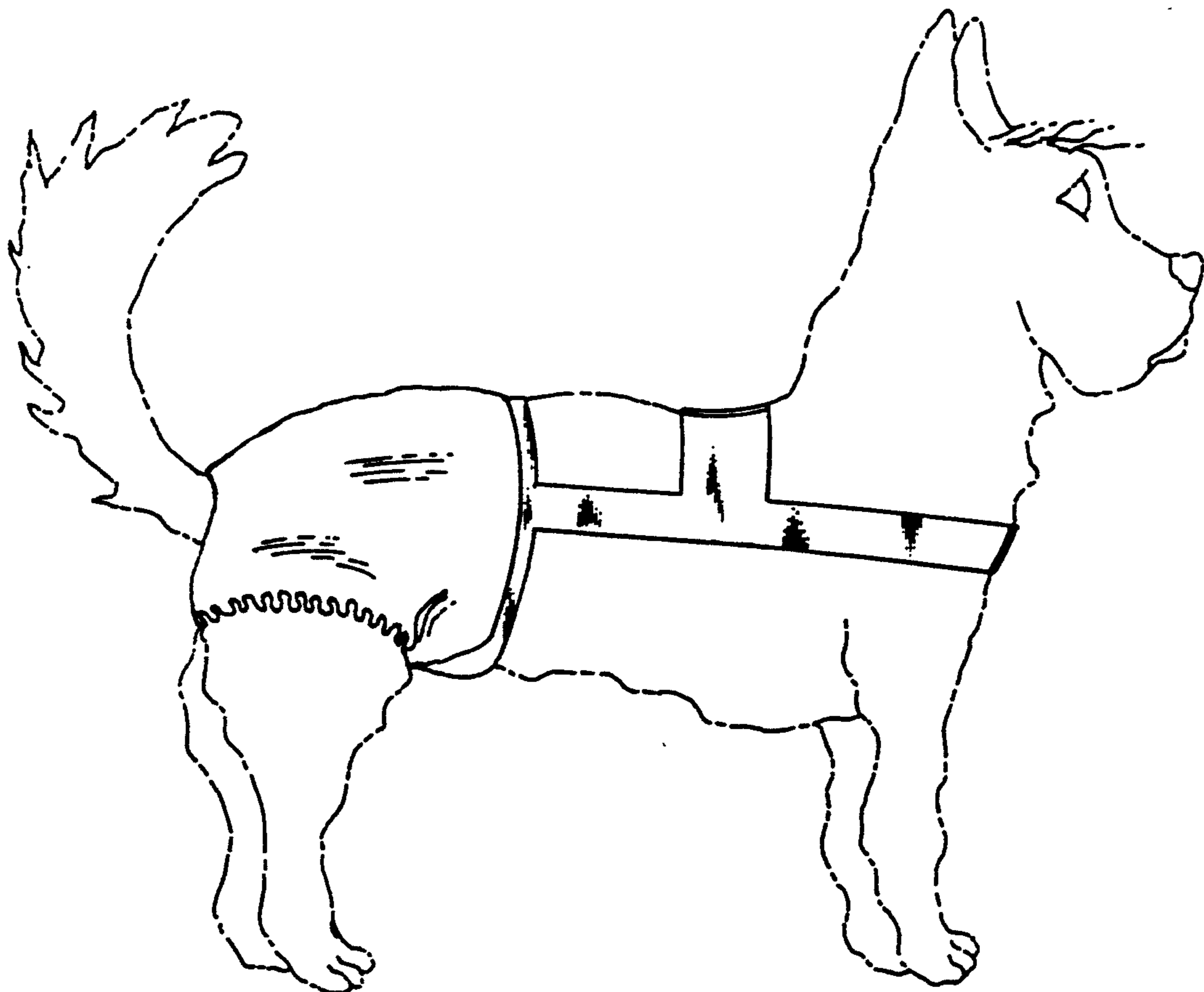
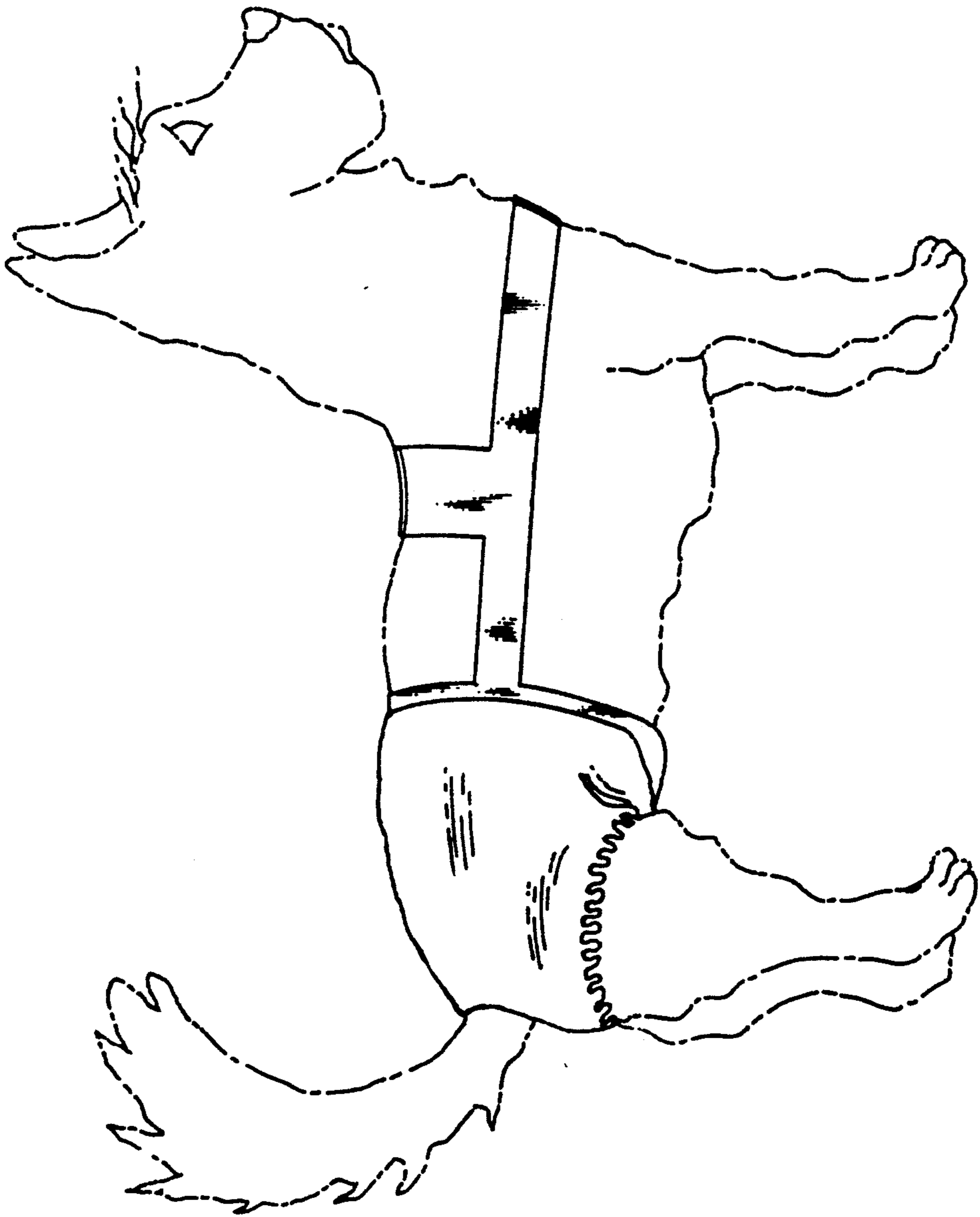

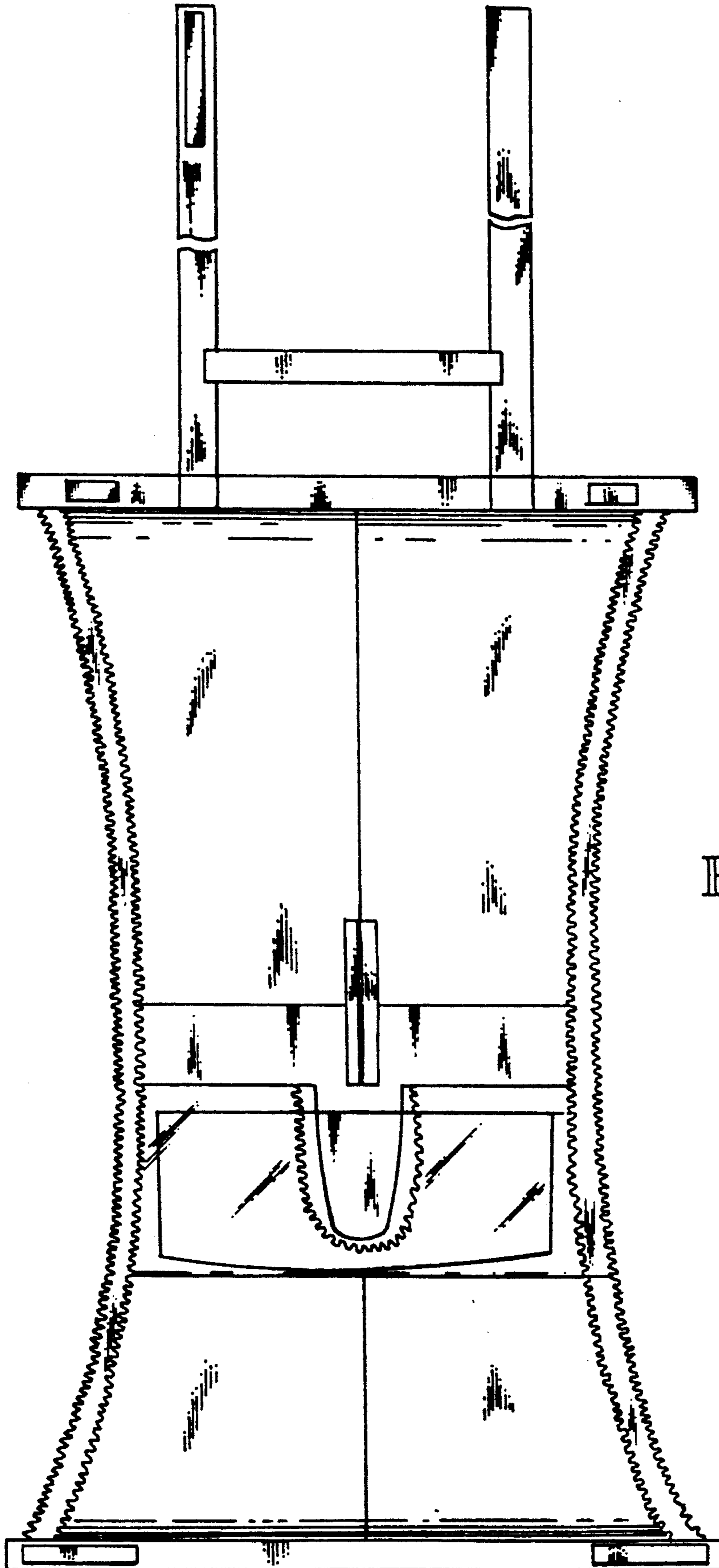

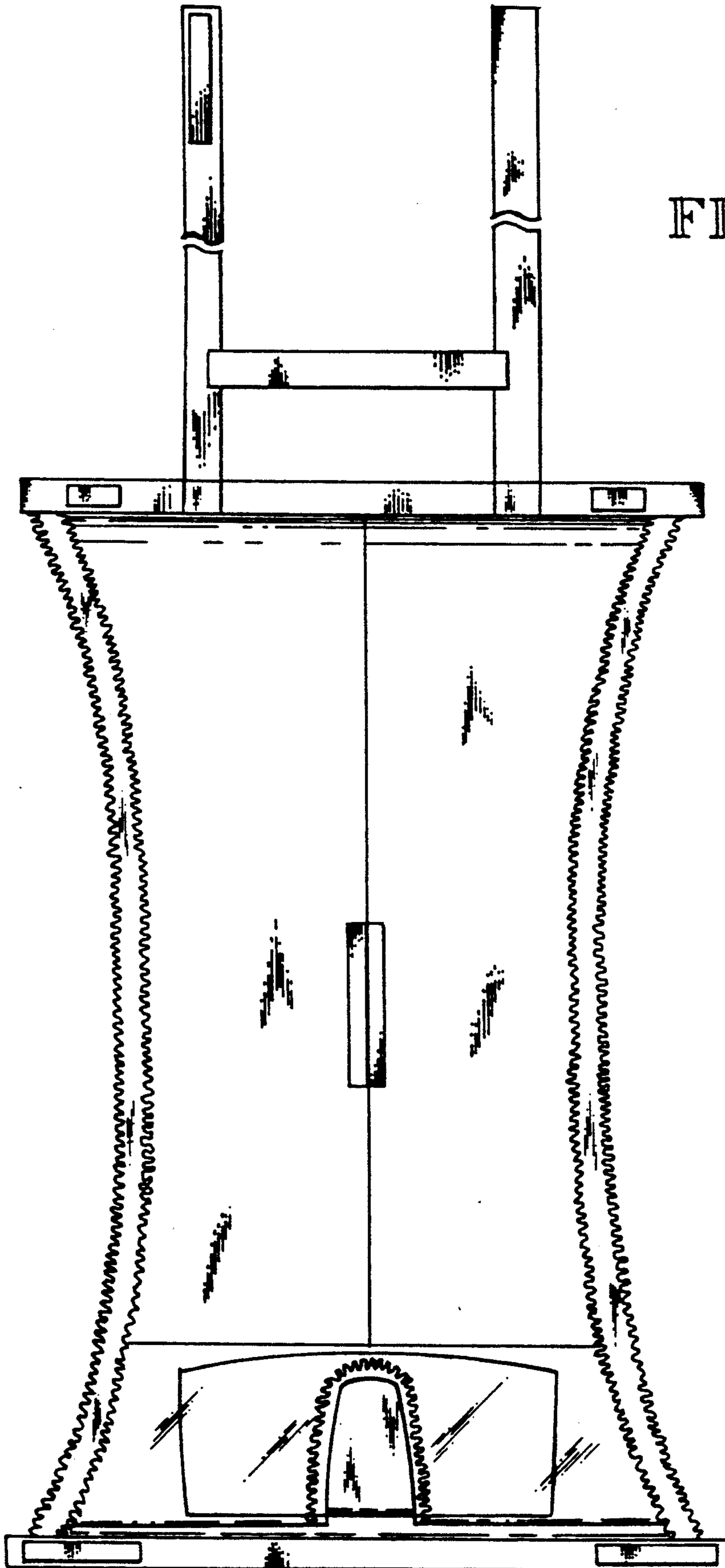

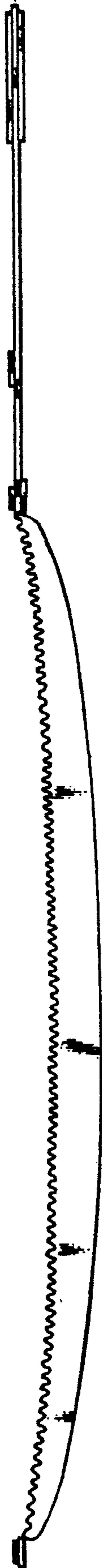

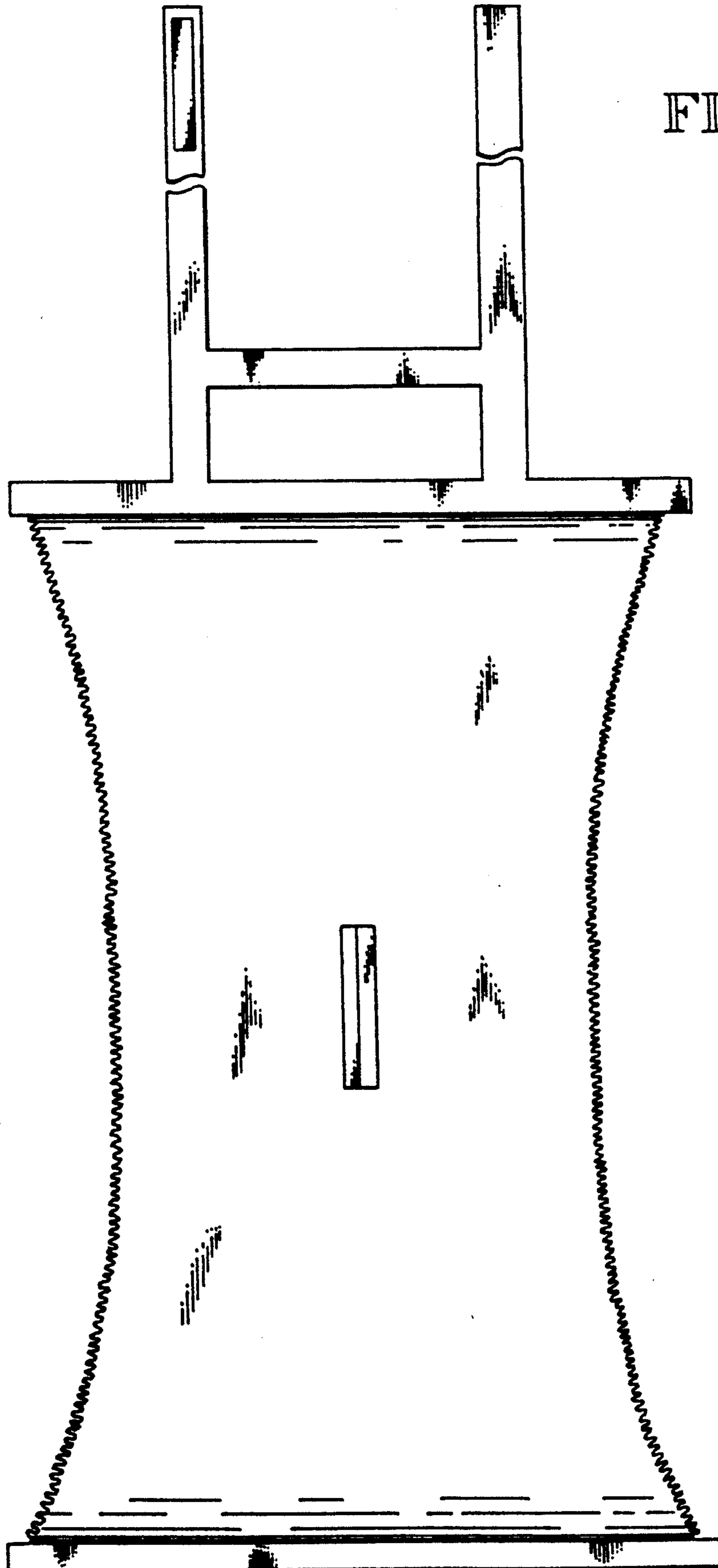
