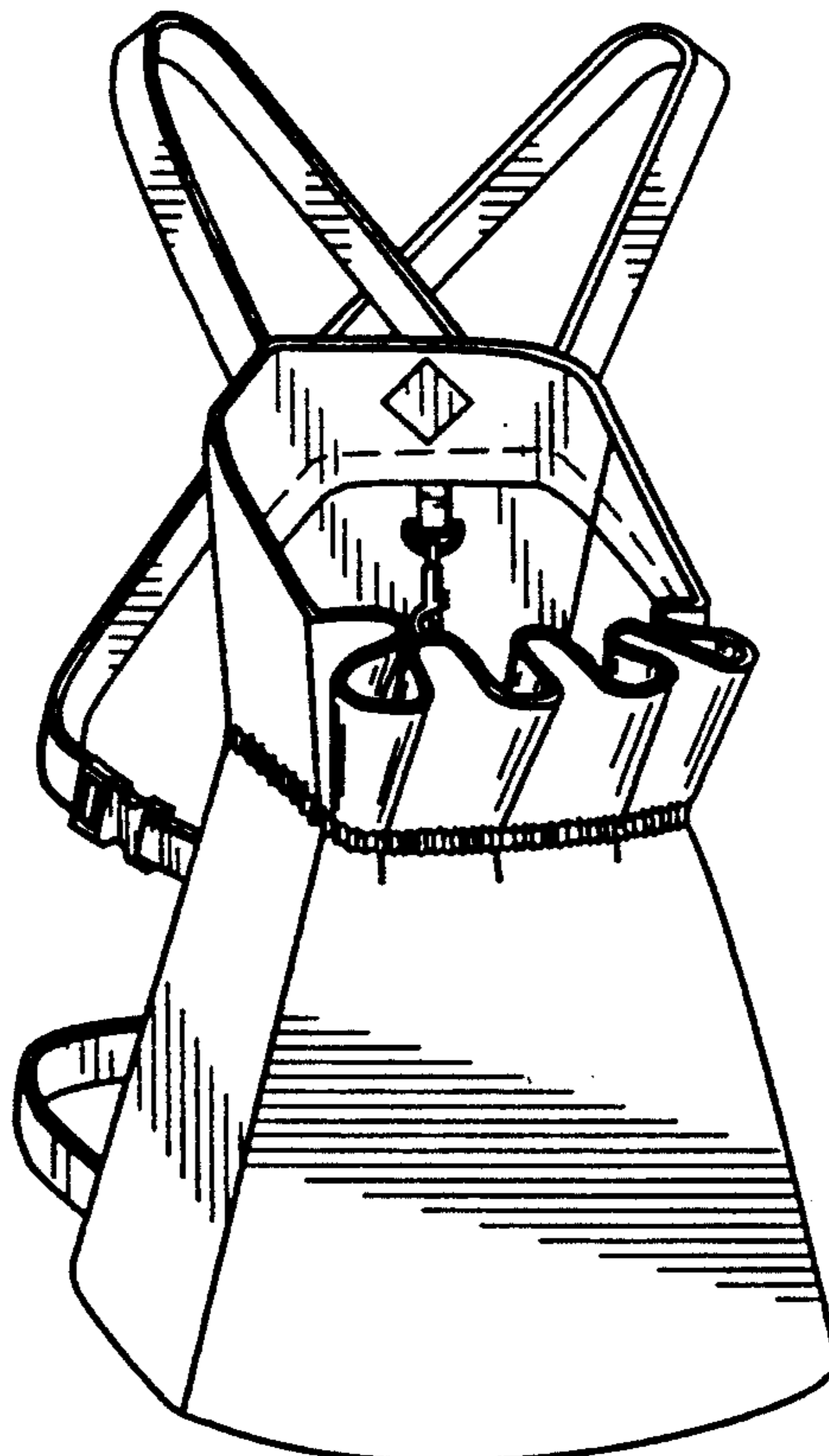

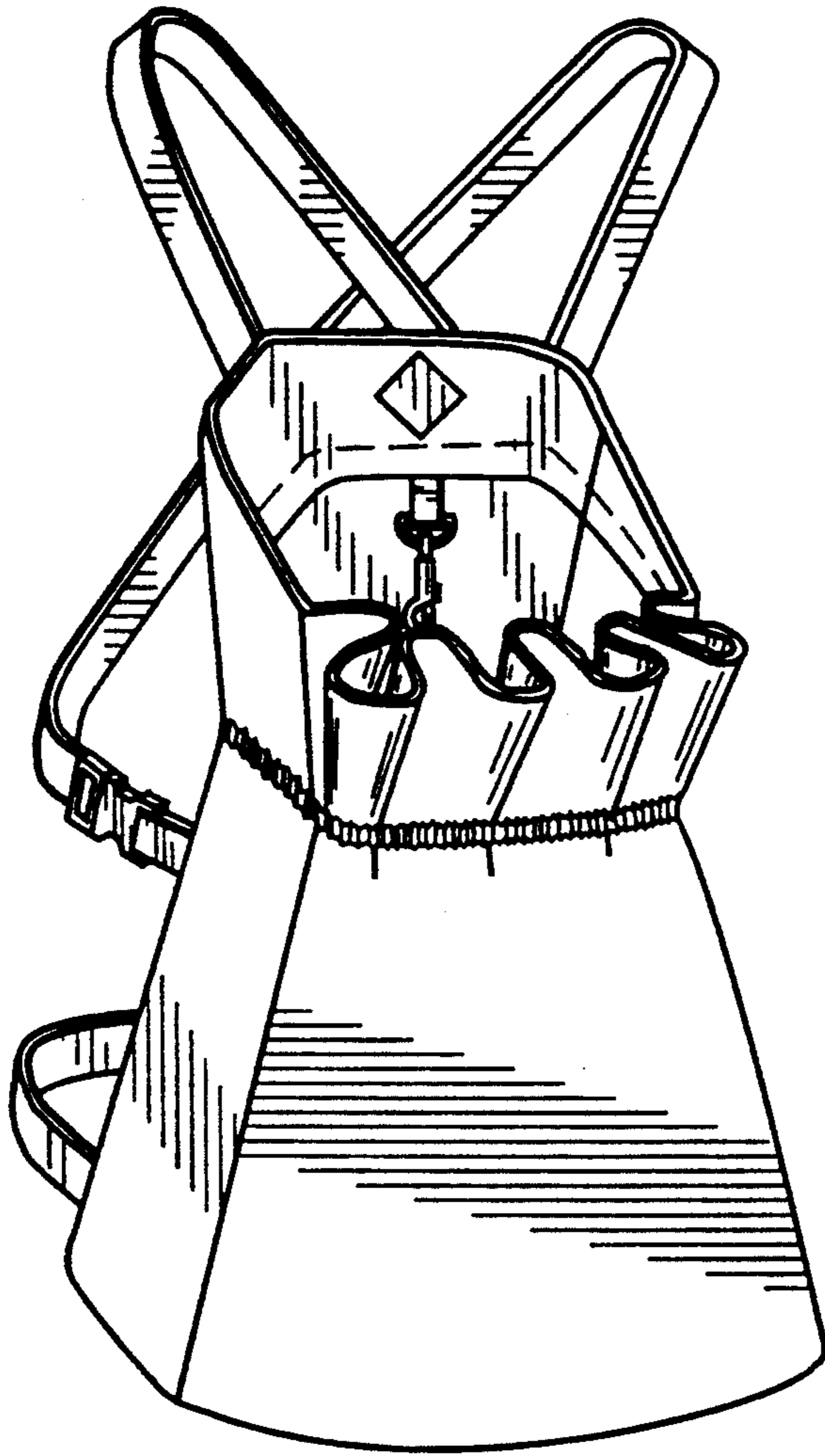
[57] **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a pet carrier showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a right side elevational view thereof;

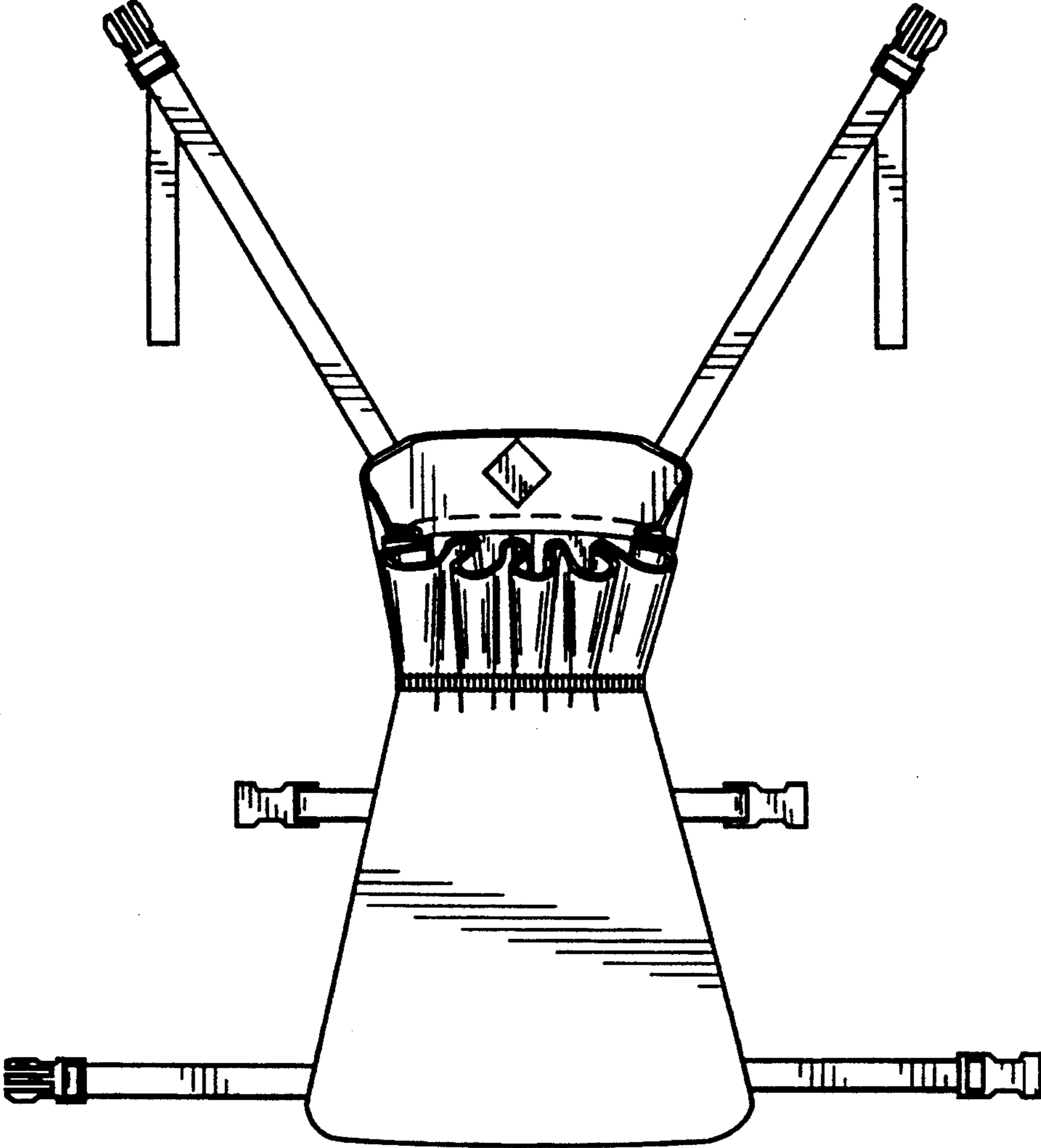
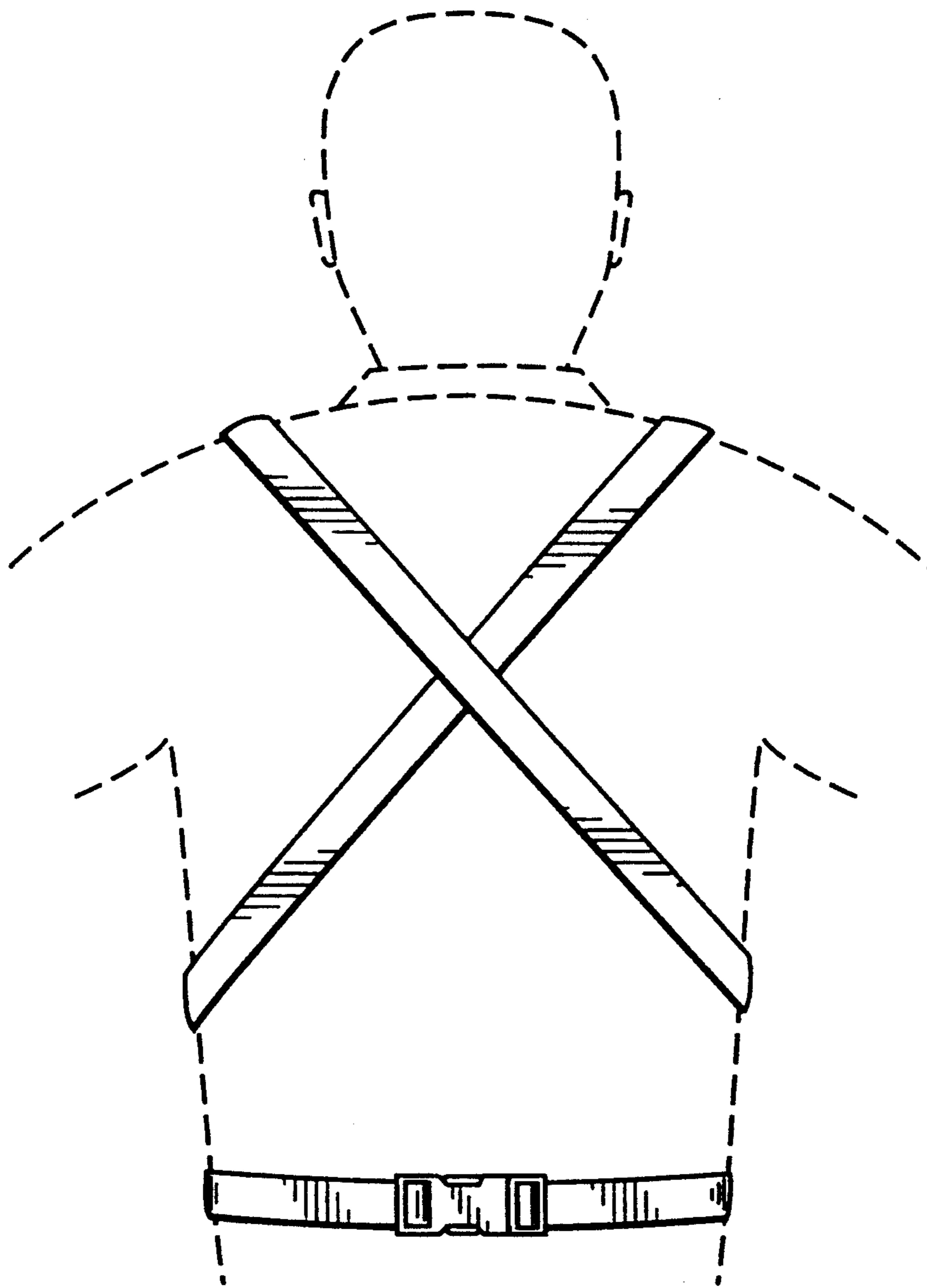
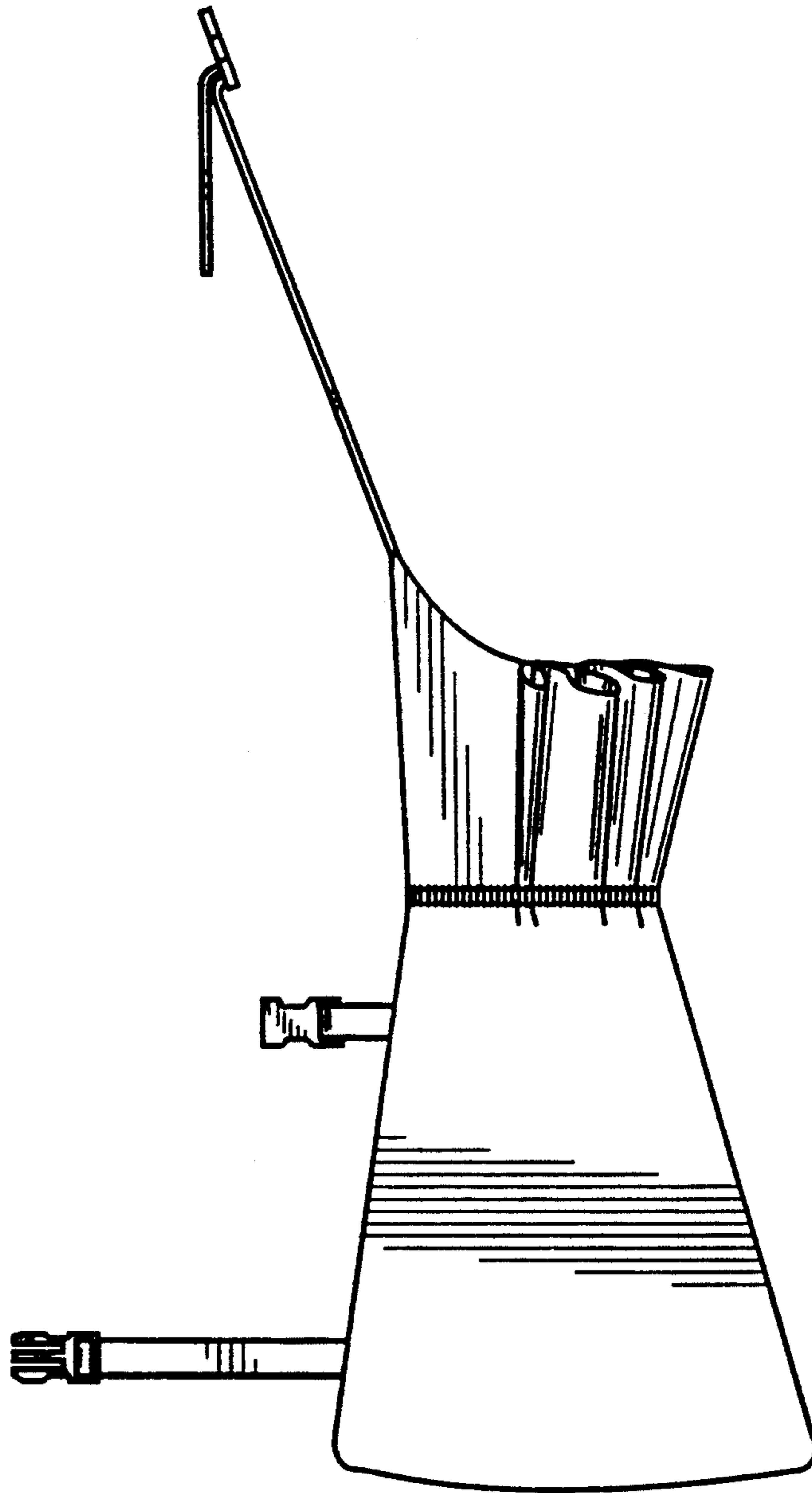


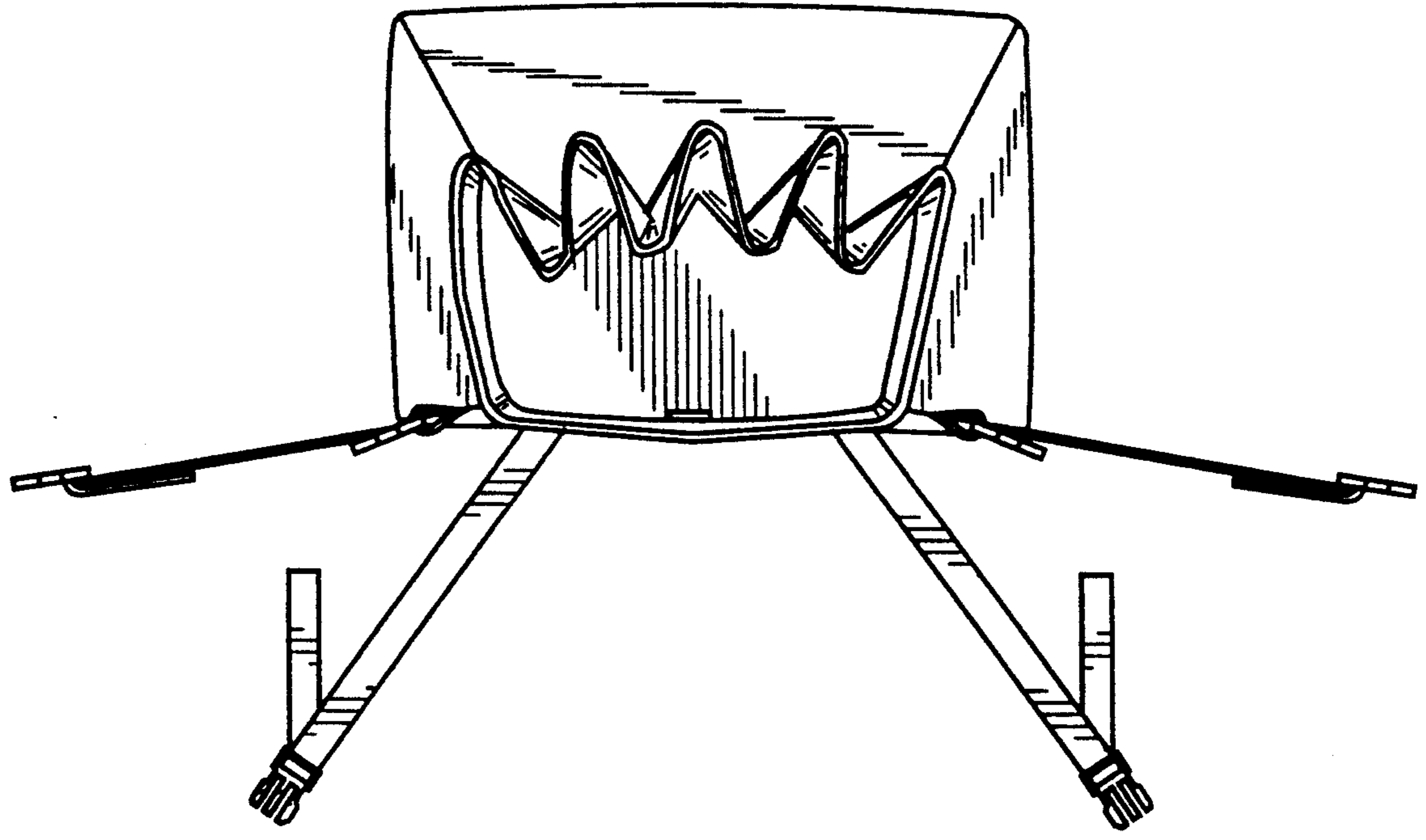

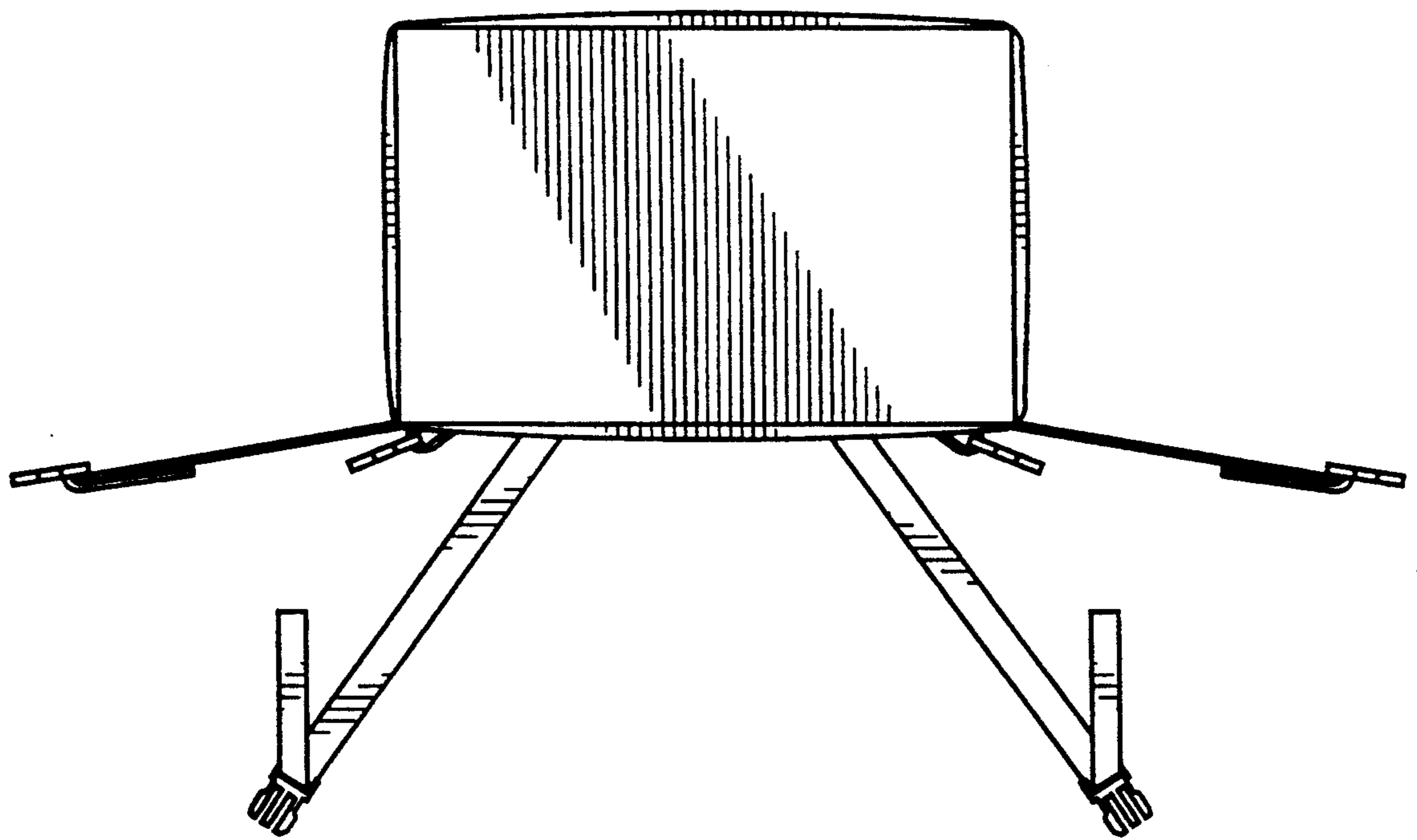

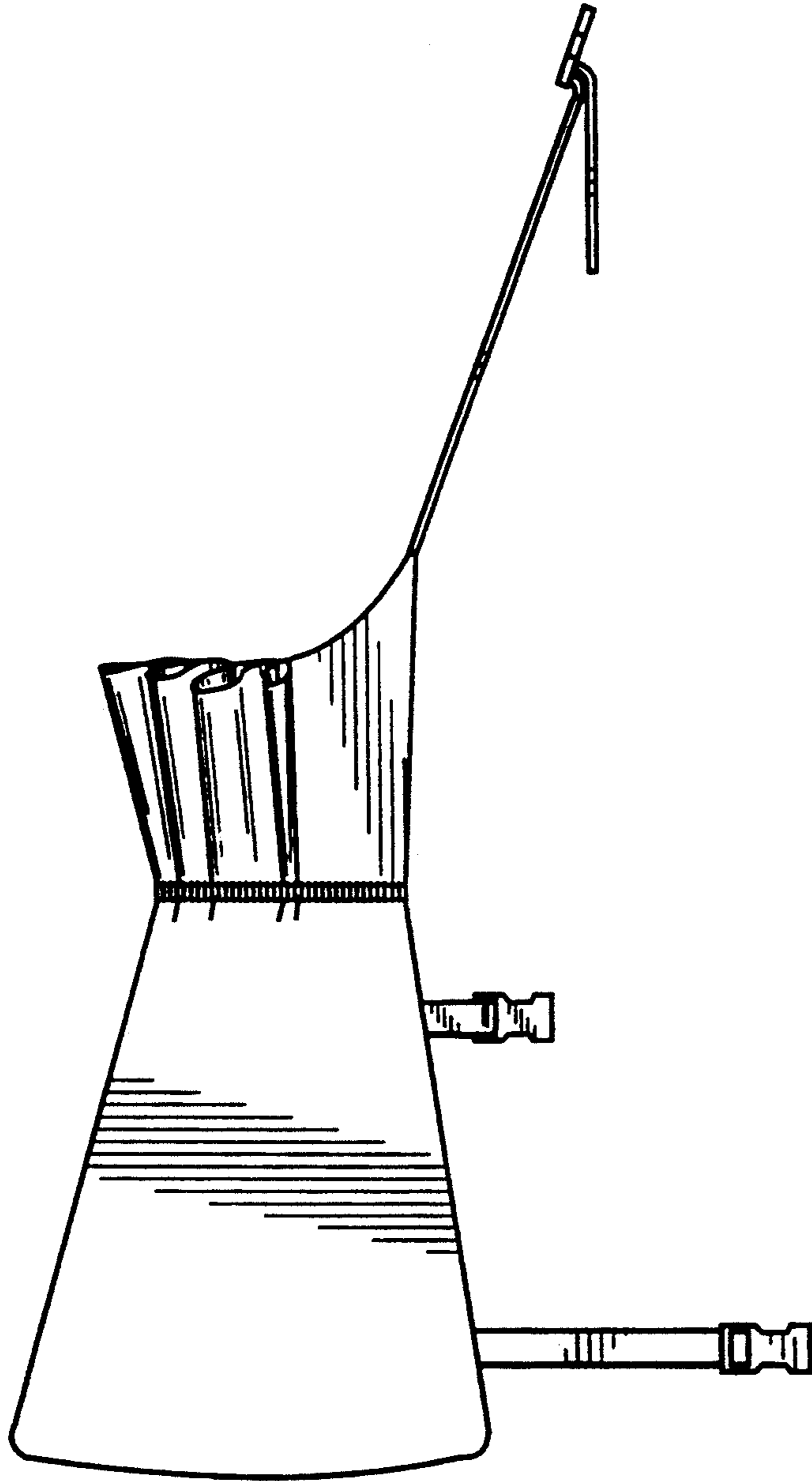
