[57] **CLAIM**

The ornamental design for a combined vacuum cleaner hose rack and tool storage, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a combined vacuum cleaner hose rack and tool storage showing our new preferred design;
 FIG. 2 is a rear elevational view thereof;
 FIG. 3 is an enlarged front elevational view thereof with the vacuum cleaner upper portion removed;
 FIG. 4 is an enlarged rear elevational view thereof with the vacuum cleaner upper portion removed;
 FIG. 5 is an enlarged left side elevational view thereof;
 FIG. 6 is an enlarged right side elevational view thereof;
 FIG. 7 is an enlarged top plan view thereof with the vacuum cleaner upper portion removed;
 FIG. 8 is an enlarged bottom plan view thereof with the vacuum cleaner upper portion removed;
 FIG. 9 is an enlarged left side elevational view of a second embodiment thereof;
 FIG. 10 is a front elevational view thereof;
 FIG. 11 is a rear elevational view thereof;
 FIG. 12 is a top plan view thereof; and,
 FIG. 13 is a bottom plan view thereof.

The undisclosed right side elevational view of the second embodiment is shown in FIG. 6. The parts shown in broken lines in FIGS. 1-4, 7, 8 and 10-13 are shown for illustrative purposes only and form no part of the claimed design.

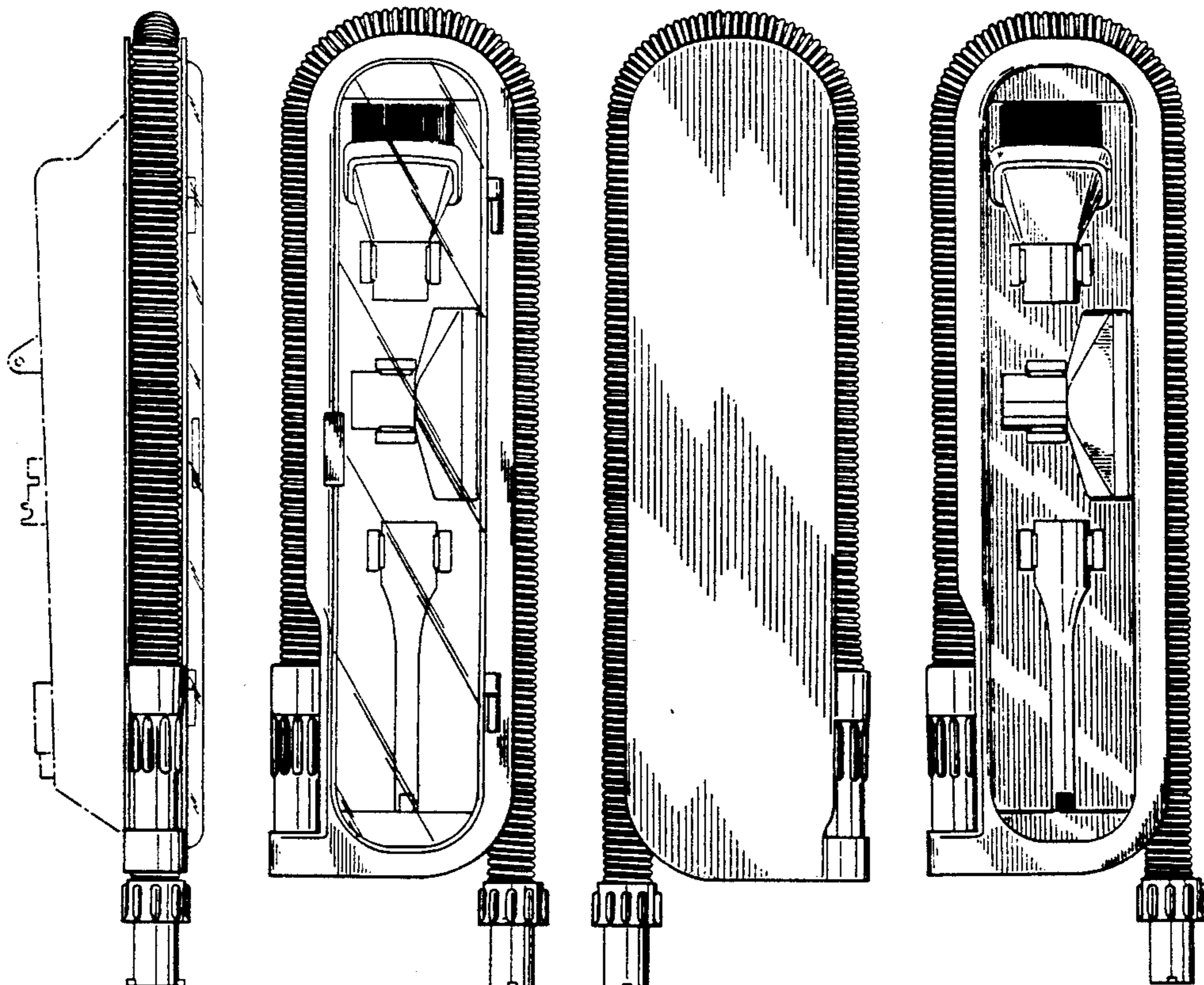

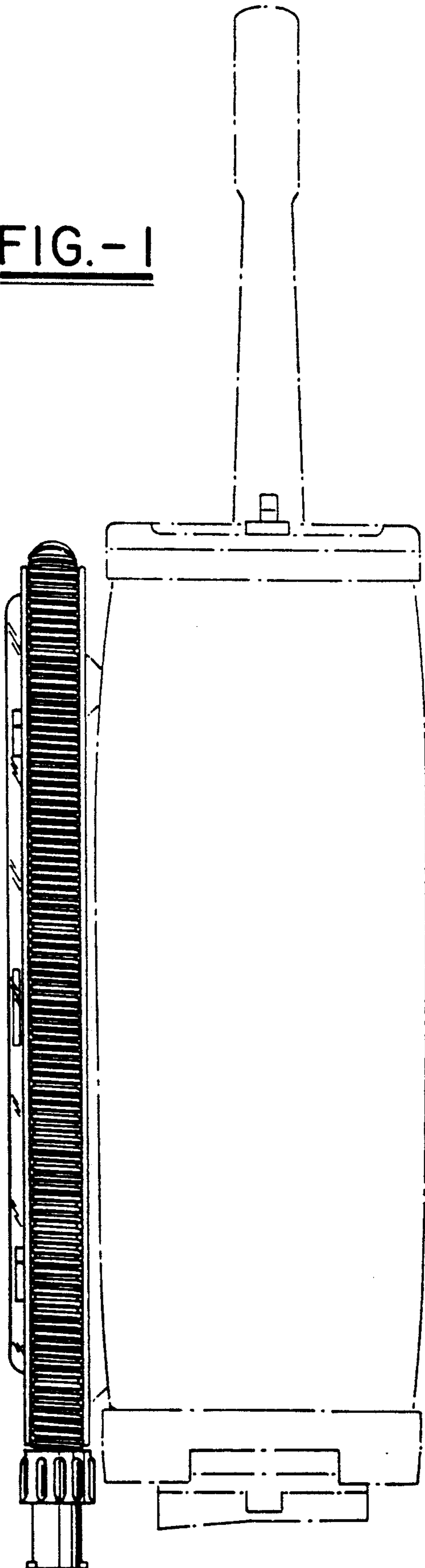
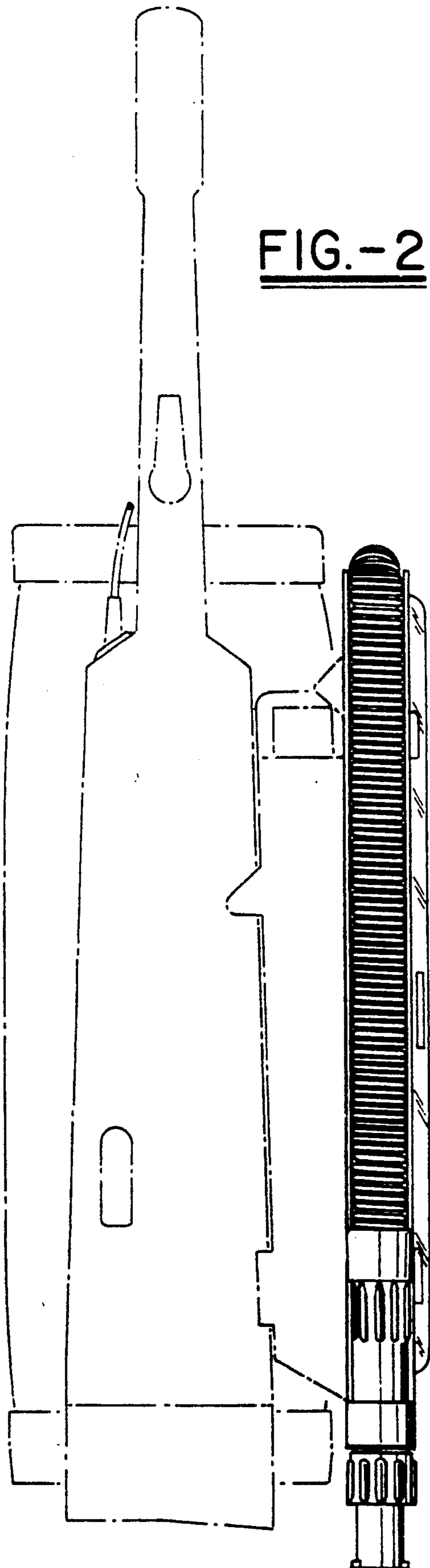

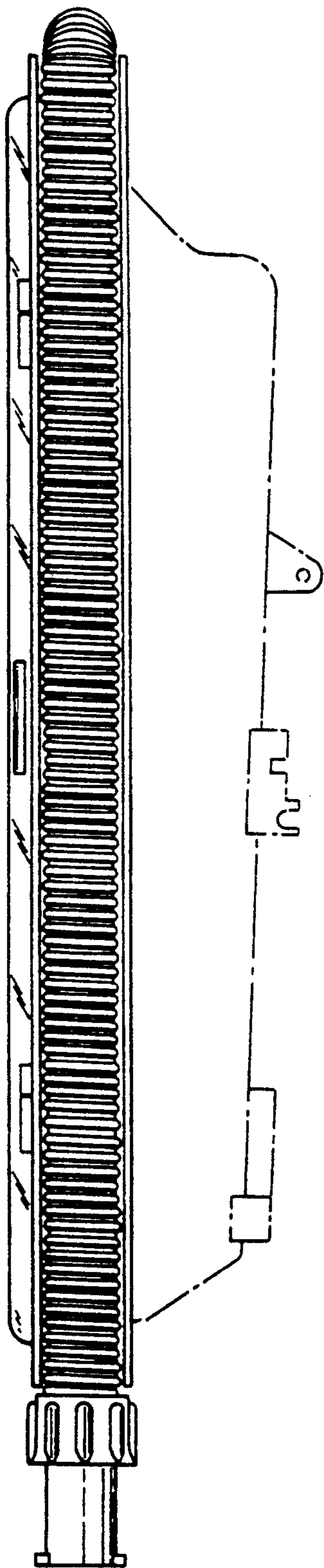

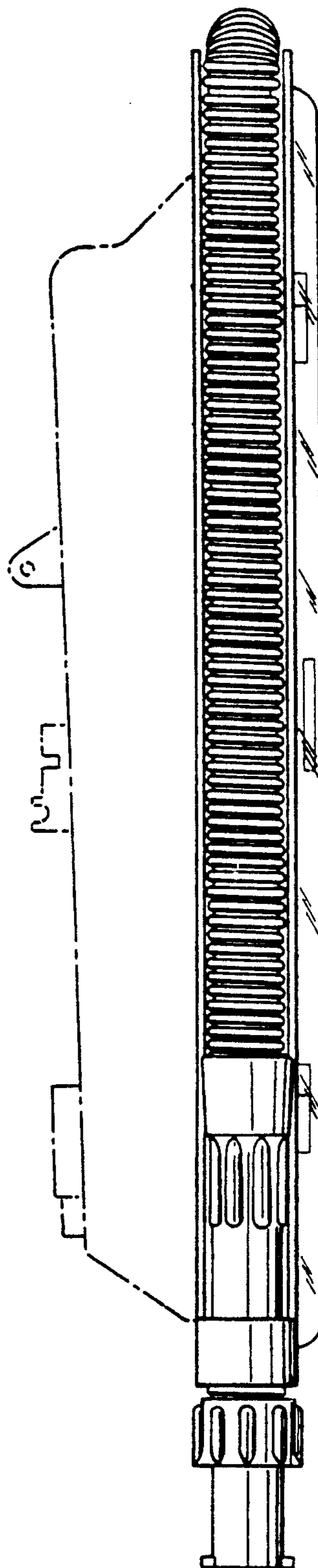

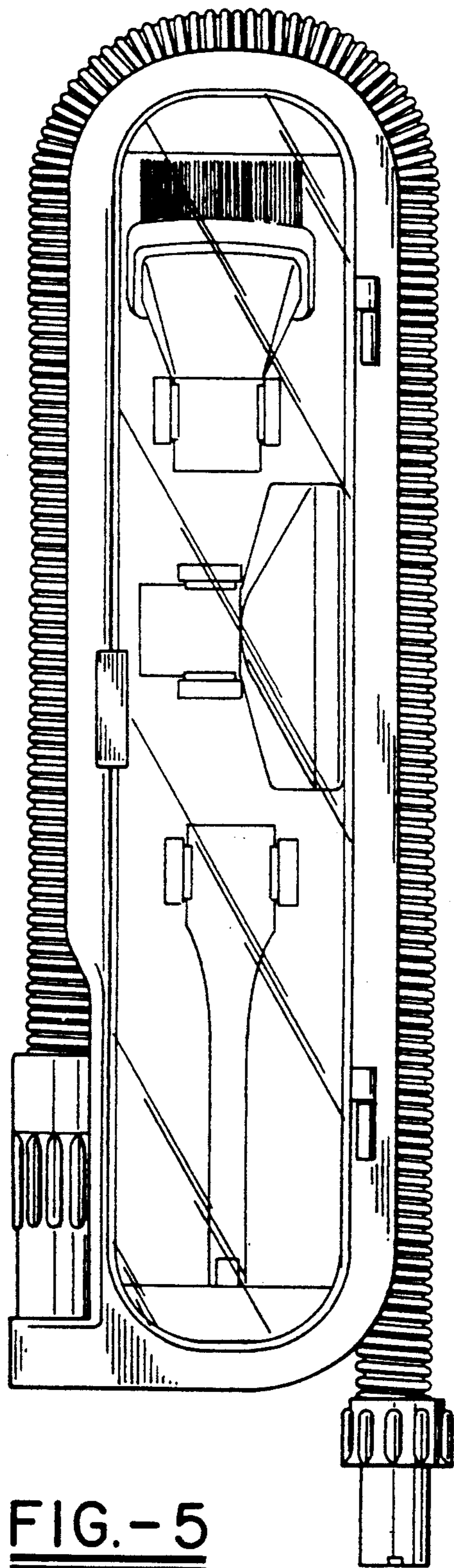

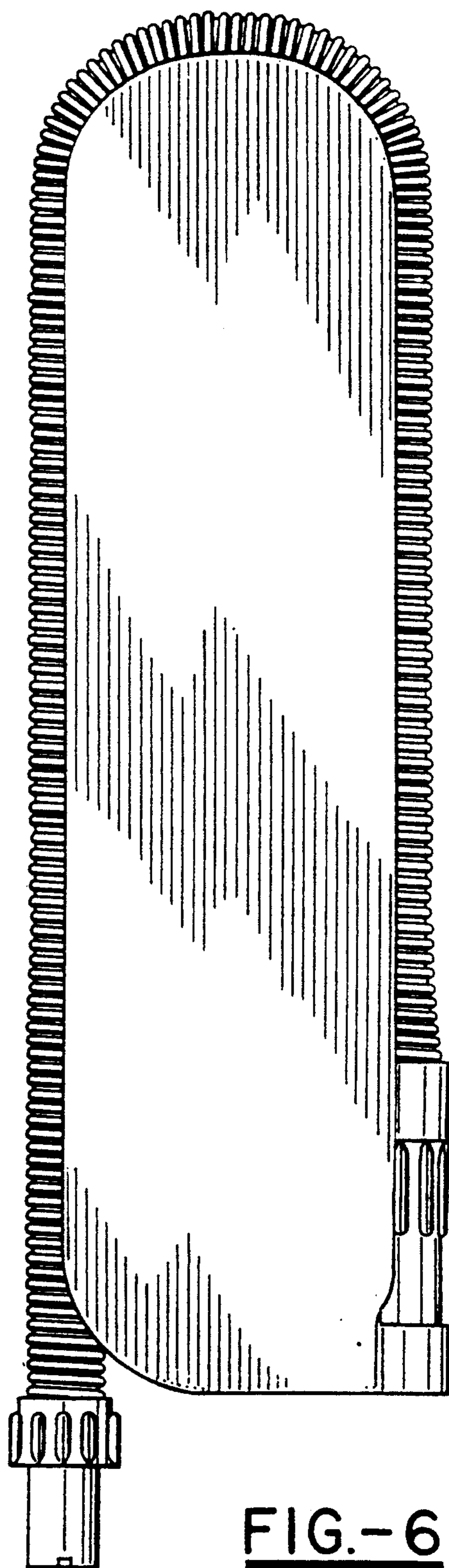

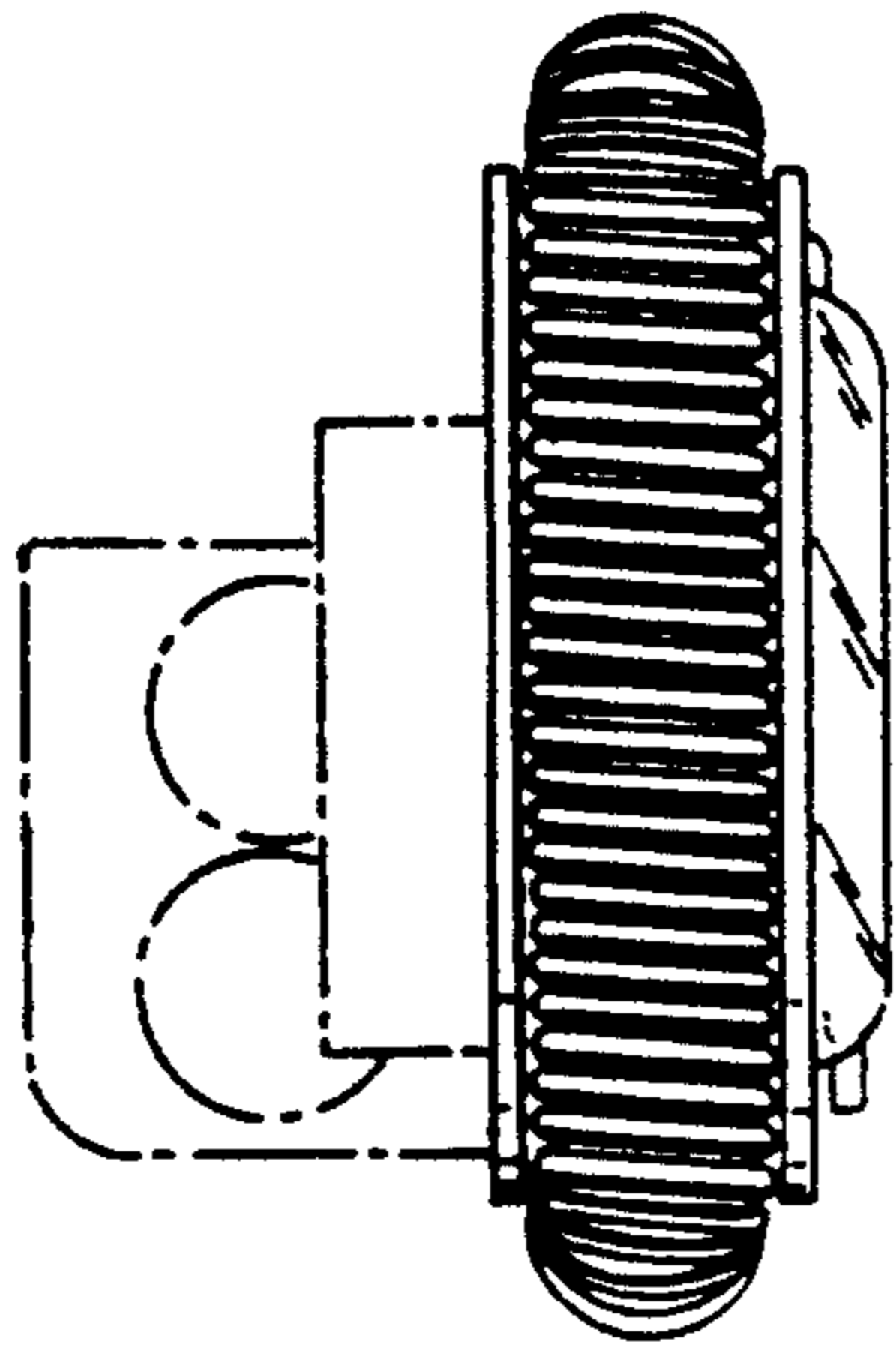

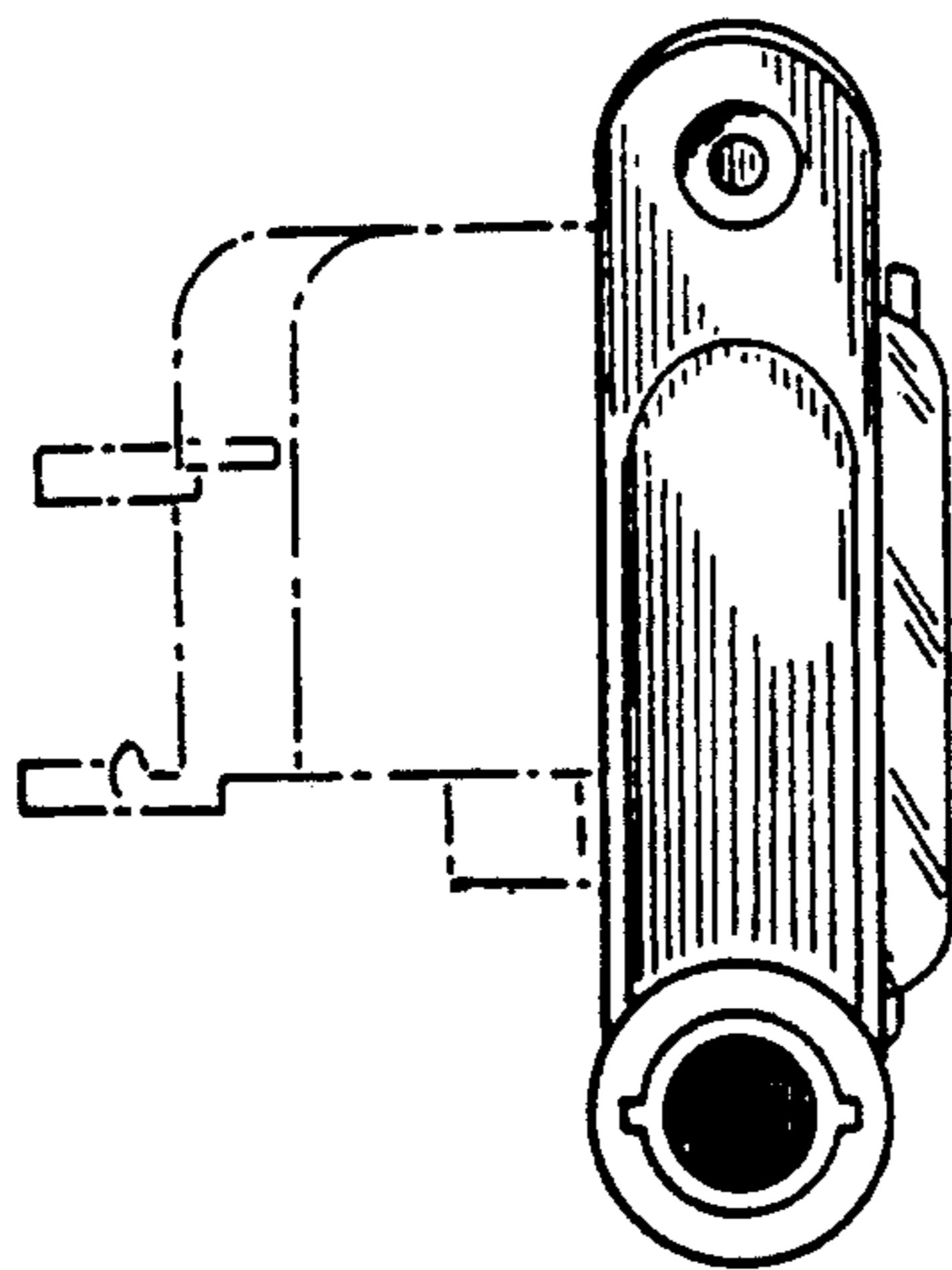

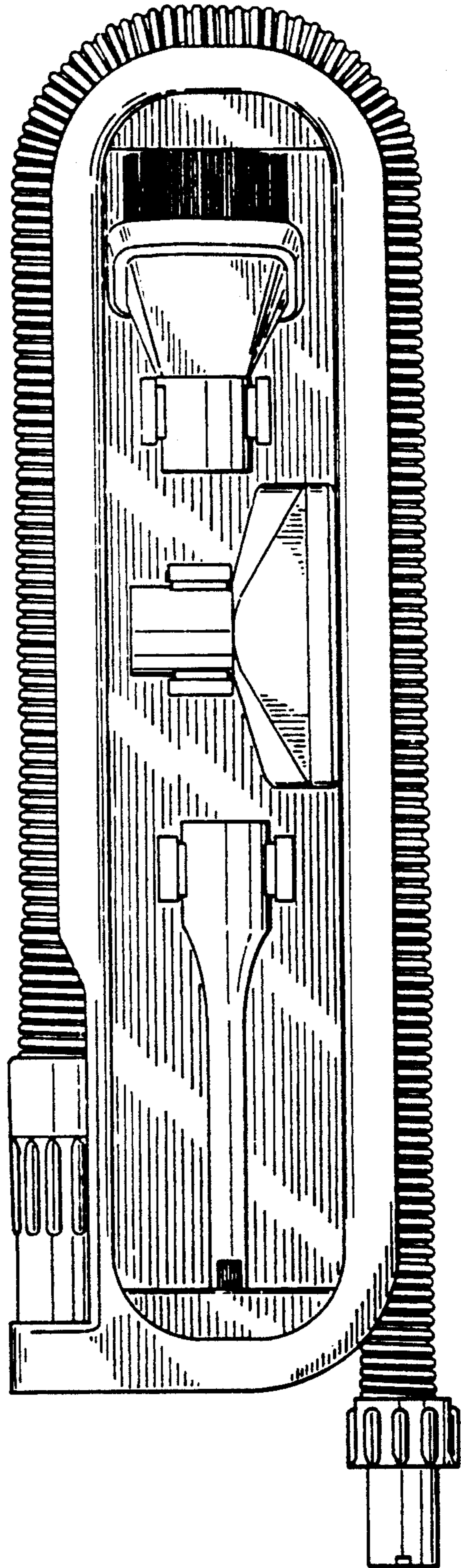
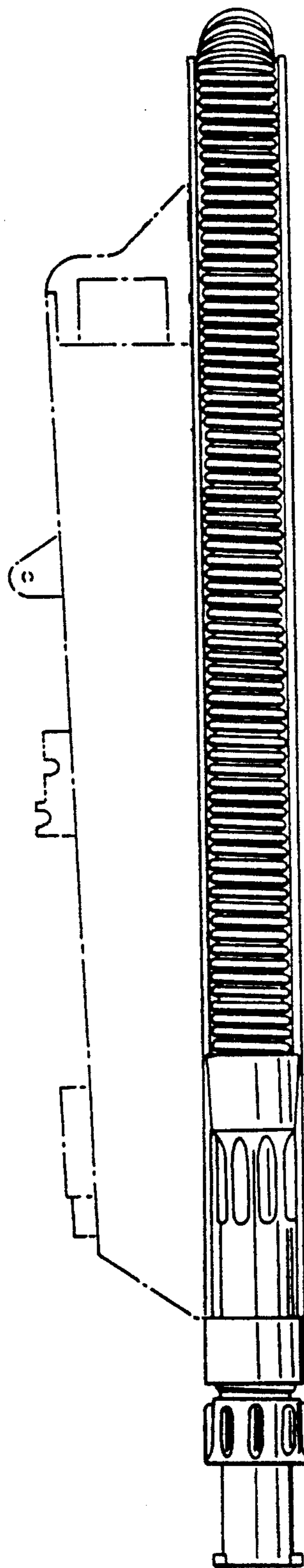
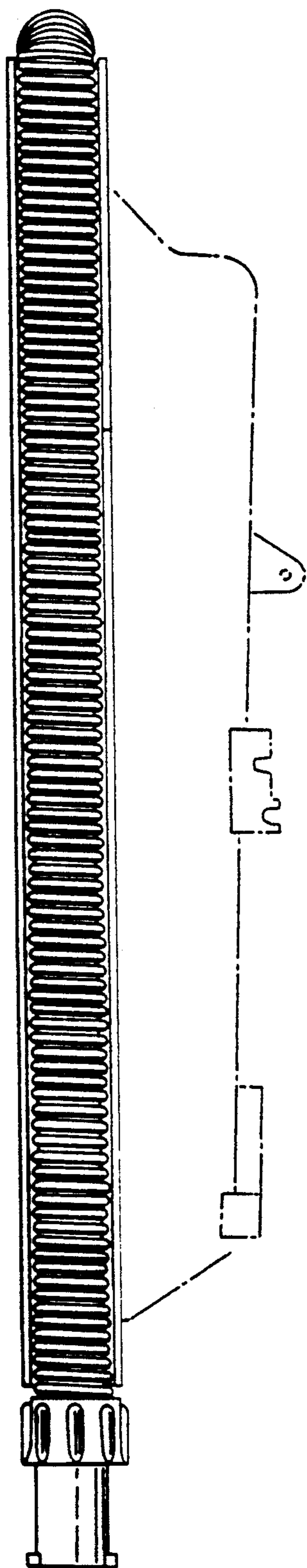

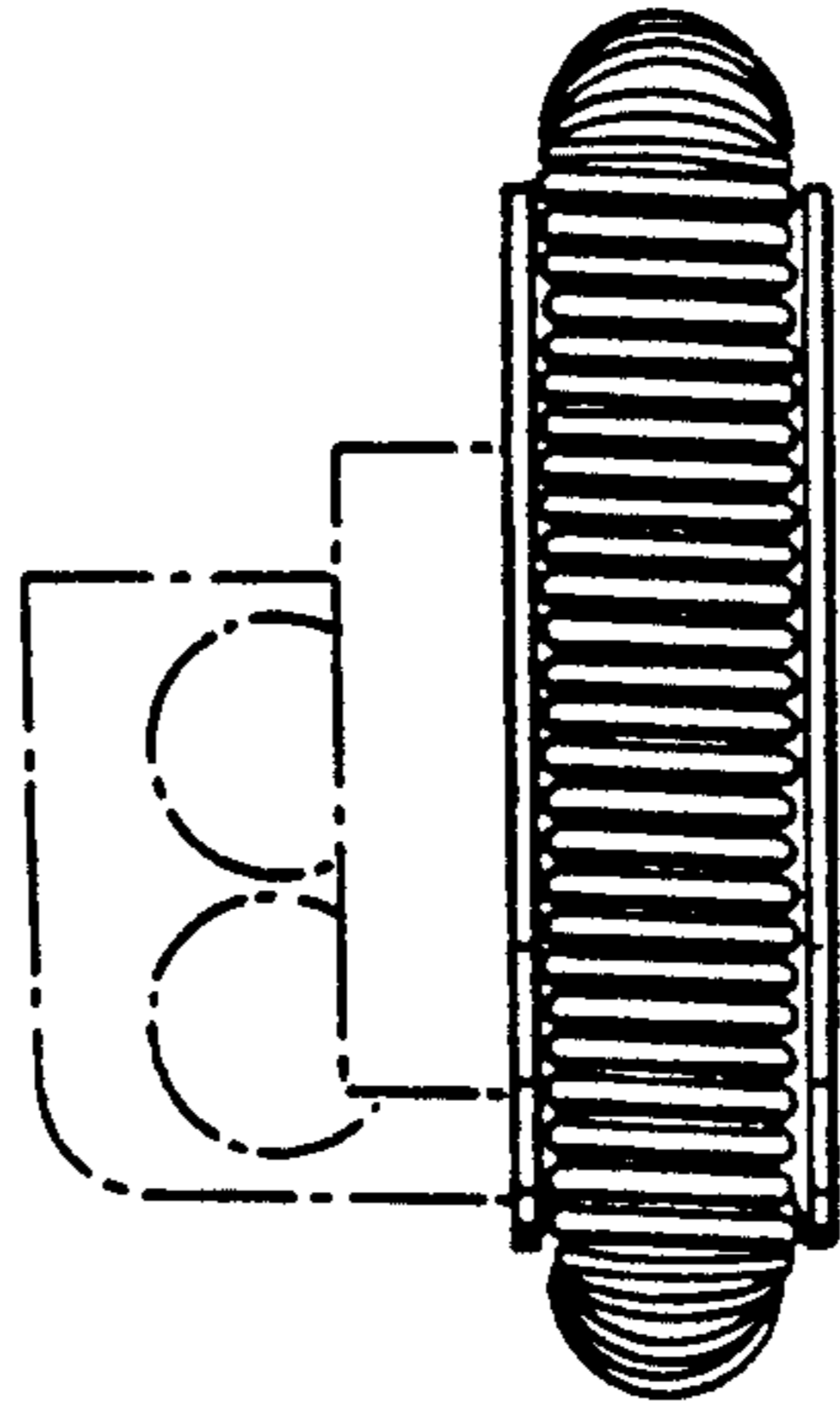

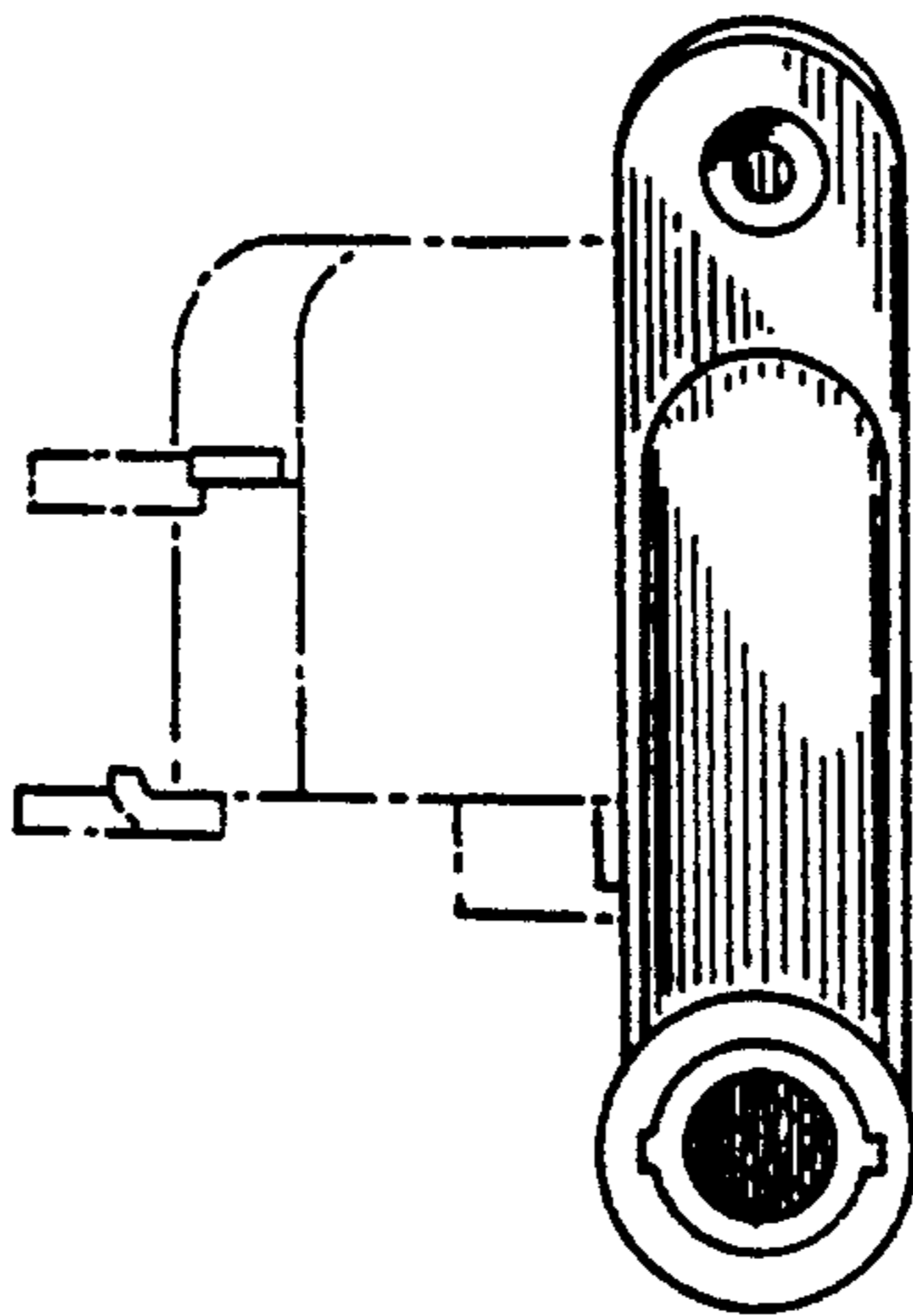
