The ornamental design for an element of a shoe sole, as shown and described.

### DESCRIPTION

FIG. 1 is a left side elevational view of an element of a shoe sole showing our new design; FIG. 2 is a right side elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a front elevational view thereof; and FIG. 6 is a rear elevational view thereof.

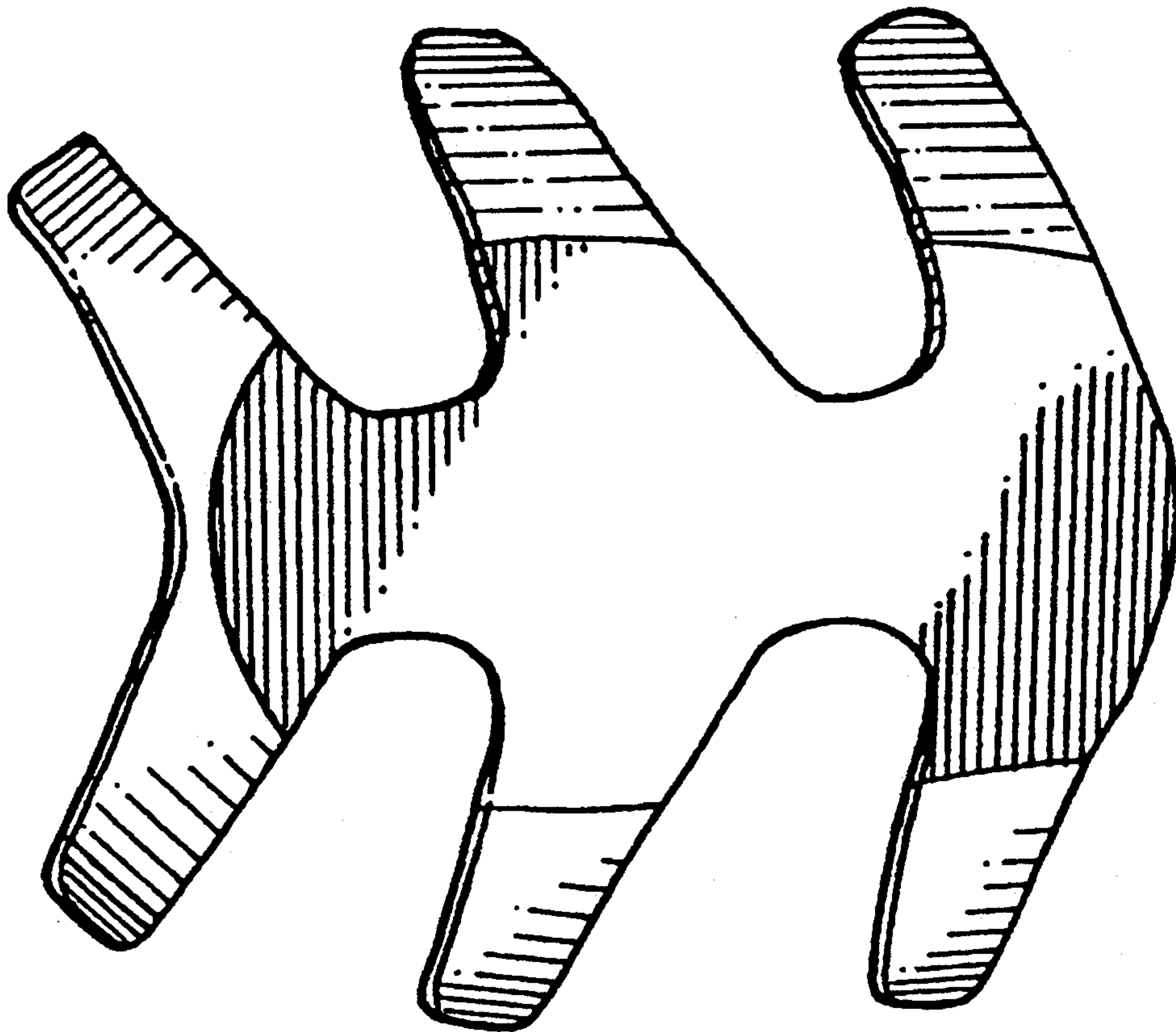

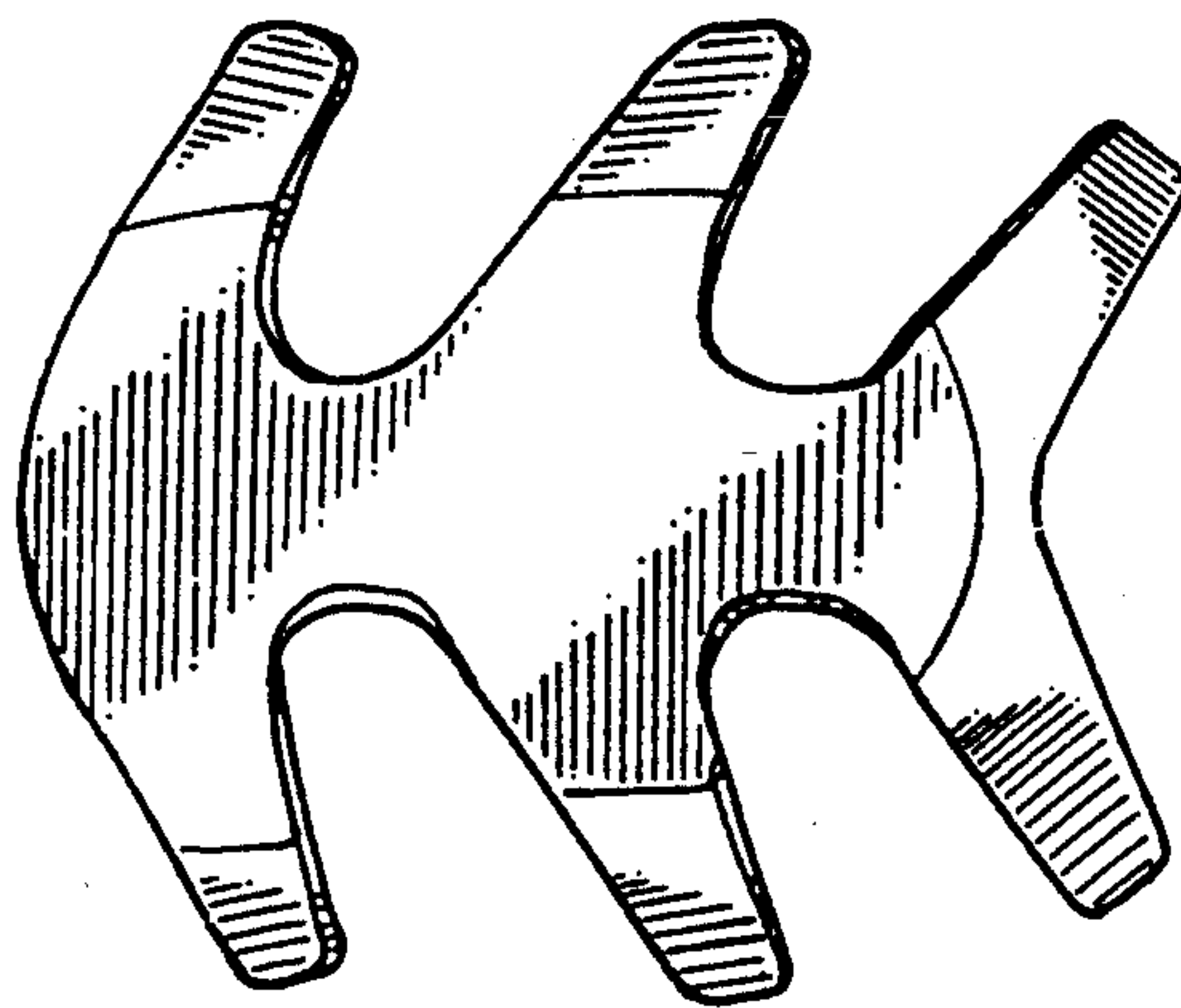

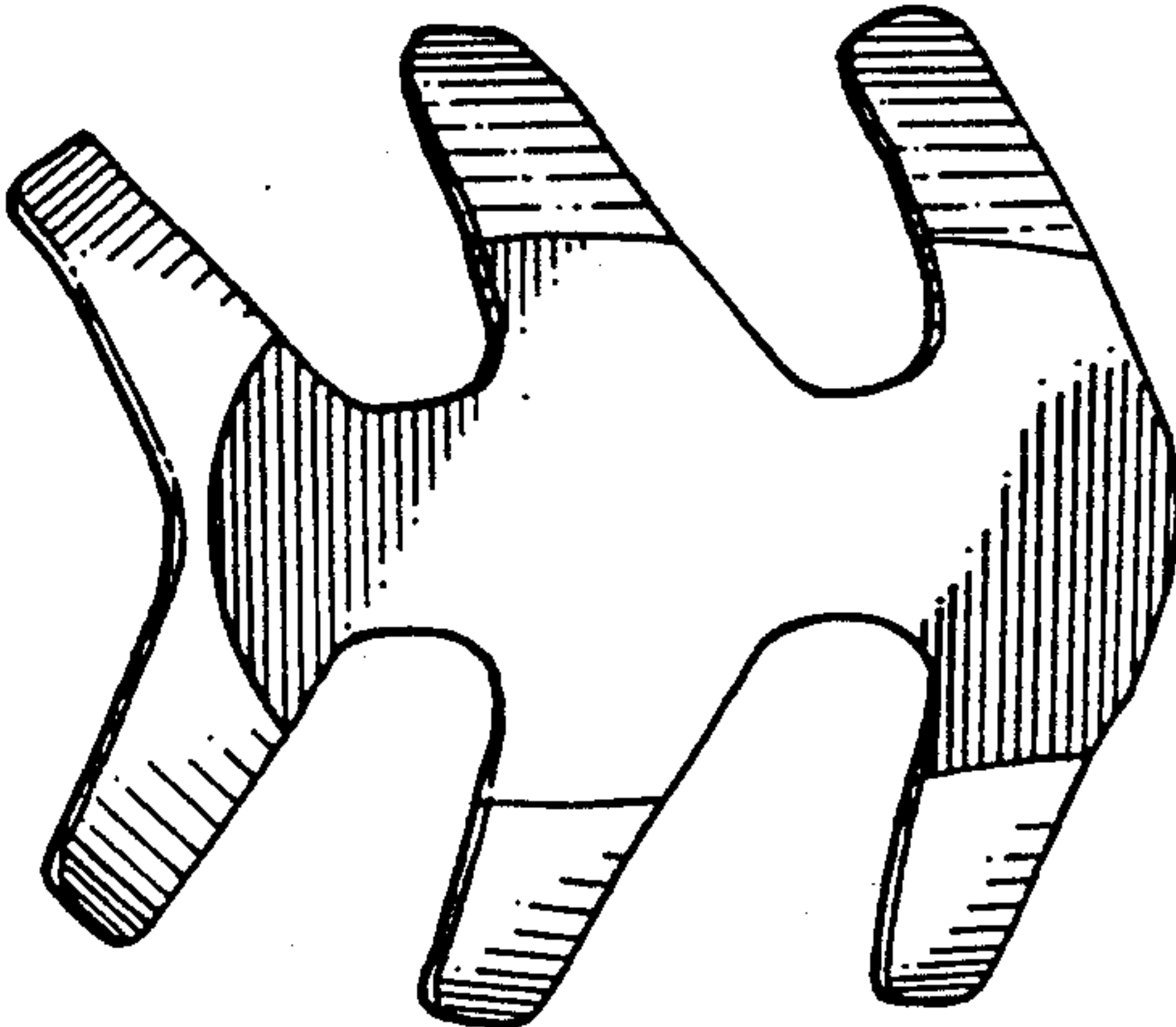

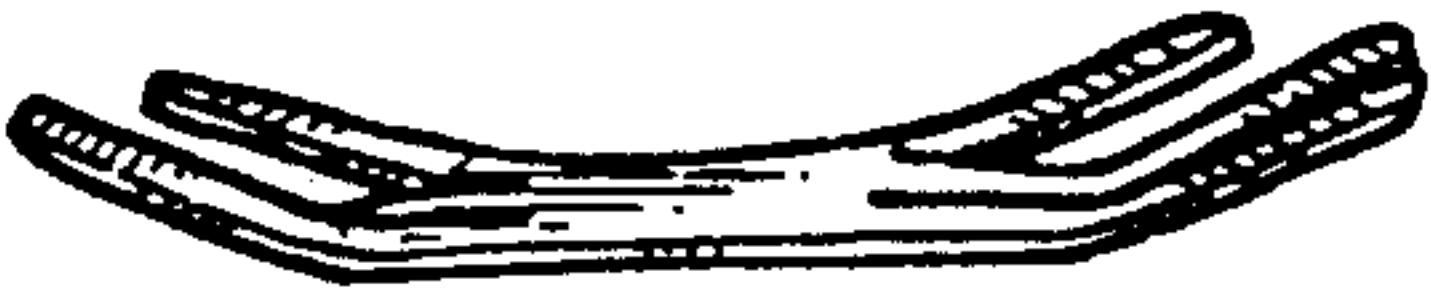
