## [57] CLAIM

The ornamental design for a shoe midsole periphery, as shown and described.

## DESCRIPTION

FIG. 1 is a side elevational view of a shoe midsole periphery showing my new design;  
 FIG. 2 is a side elevational view of the other side of the shoe midsole periphery shown in FIG. 1;  
 FIG. 3 is a front elevational view of the shoe midsole periphery shown in FIG. 1;  
 FIG. 4 is a rear elevational view of the shoe midsole periphery shown in FIG. 1;  
 FIG. 5 is a cross sectional view of the shoe midsole periphery taken along line 5—5 of FIG. 1;  
 FIG. 6 is a cross section of the shoe midsole periphery taken along line 6—6 of FIG. 1;  
 FIG. 7 is a cross section of the shoe midsole periphery taken along line 7—7 of FIG. 1;  
 FIG. 8 is a cross section of the shoe midsole periphery taken along line 8—8 of FIG. 1; and,  
 FIG. 9 is a cross section of the shoe midsole periphery taken along line 9—9 of FIG. 2.  
 The broken line showing of a shoe upper and a shoe bottom in FIGS. 1, 2, 3 and 4 are for illustrative purposes and form no part of the claimed design.

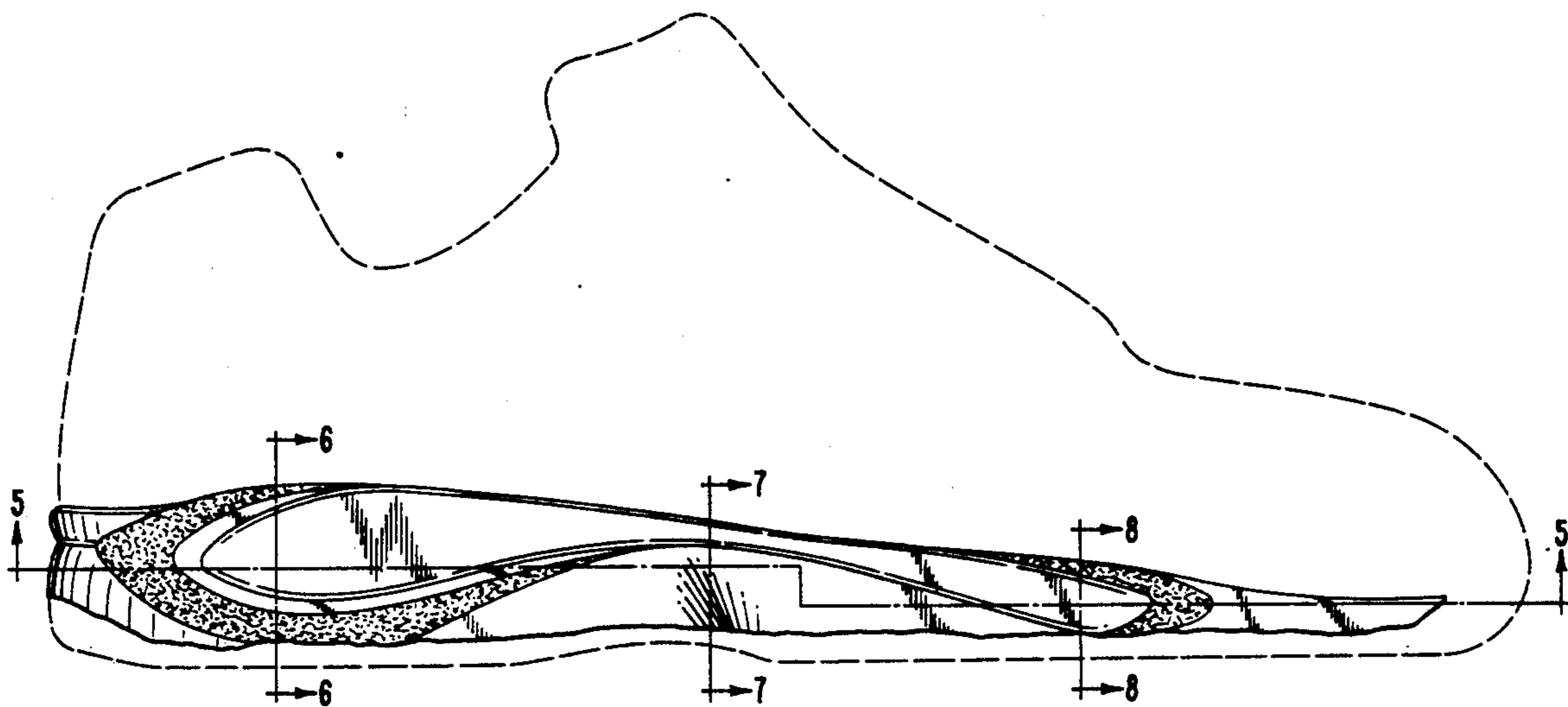
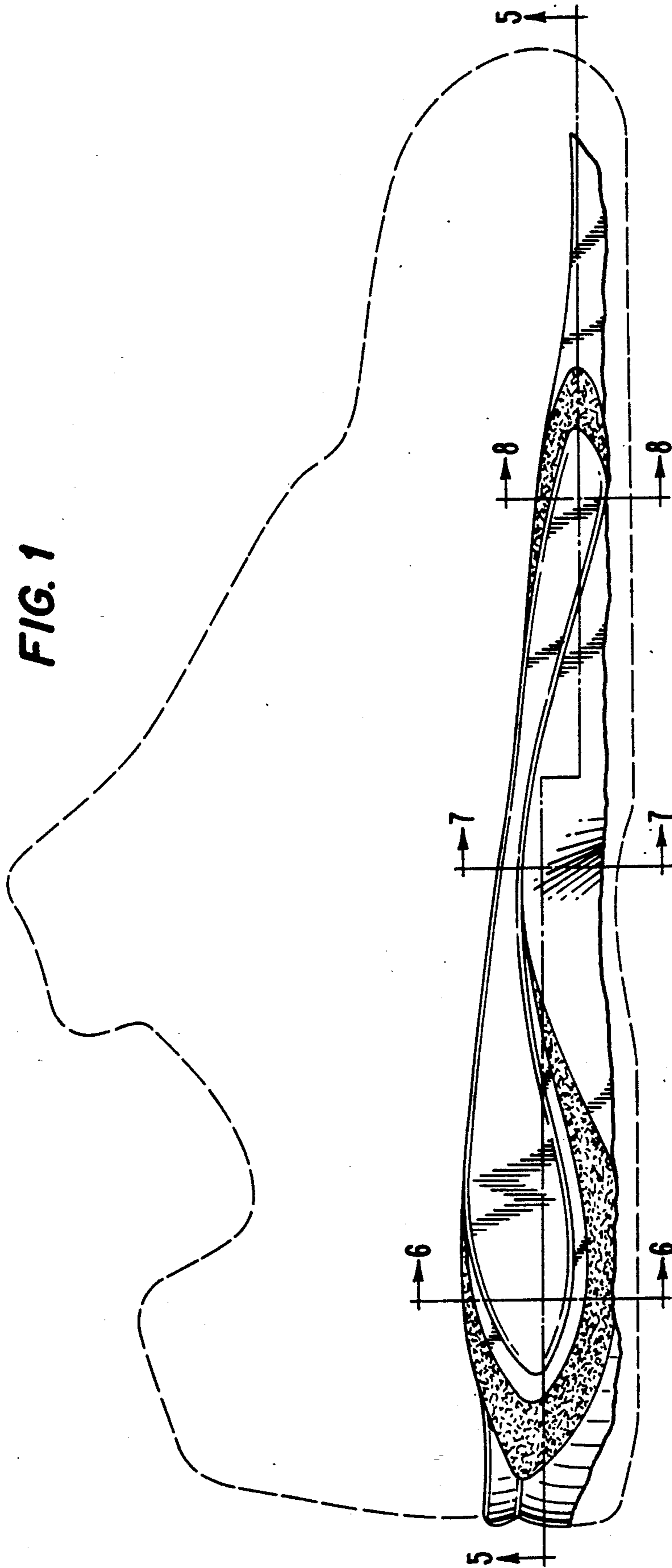

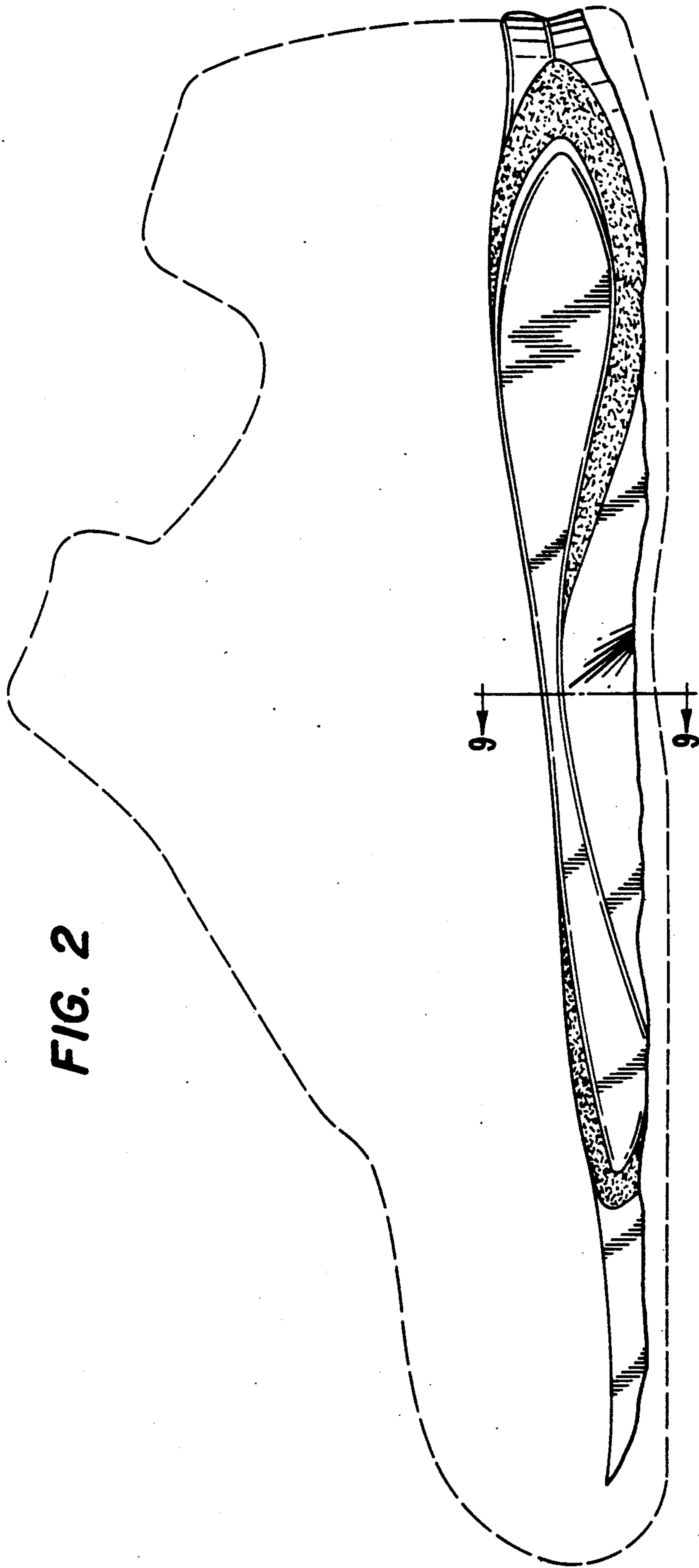
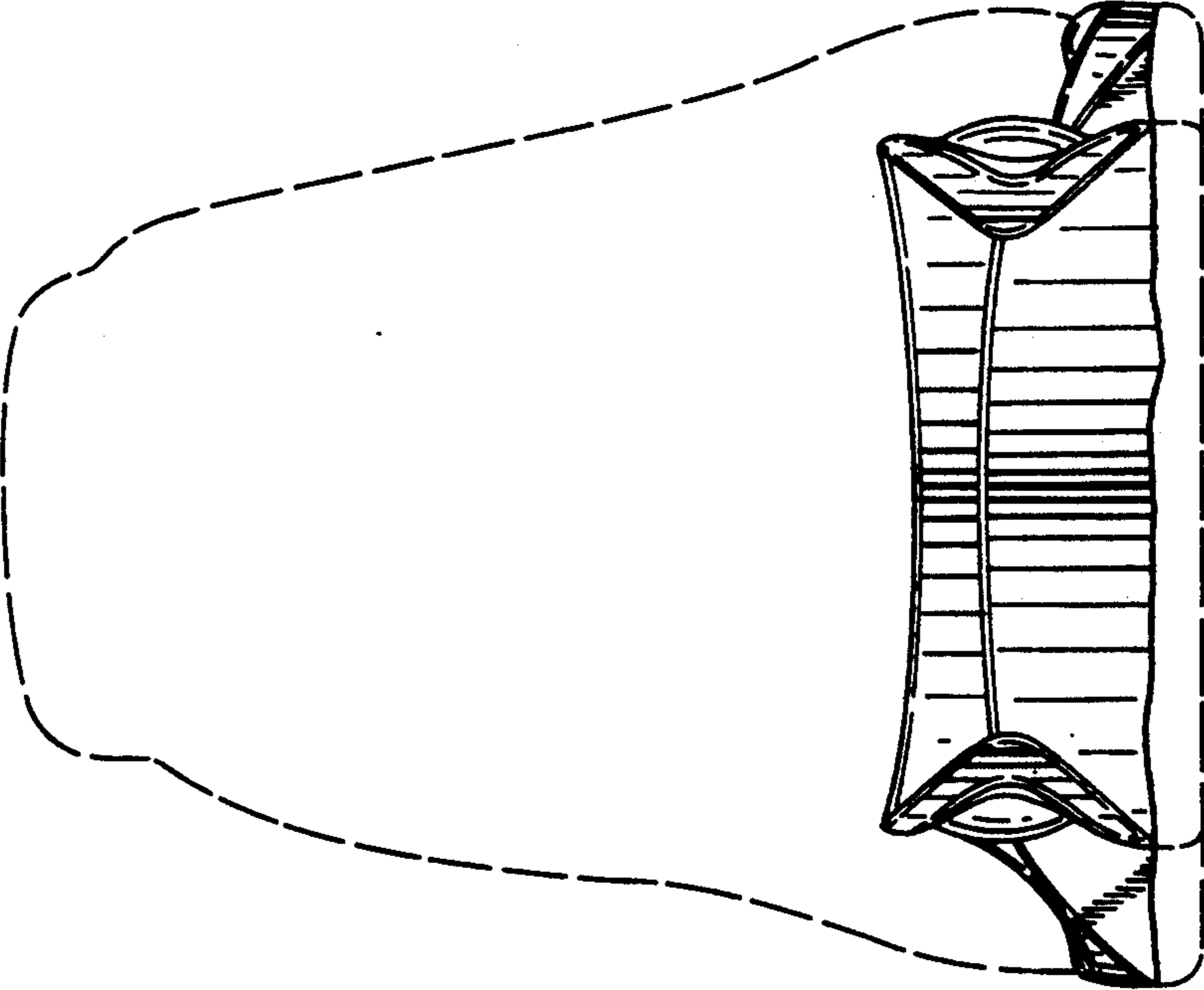

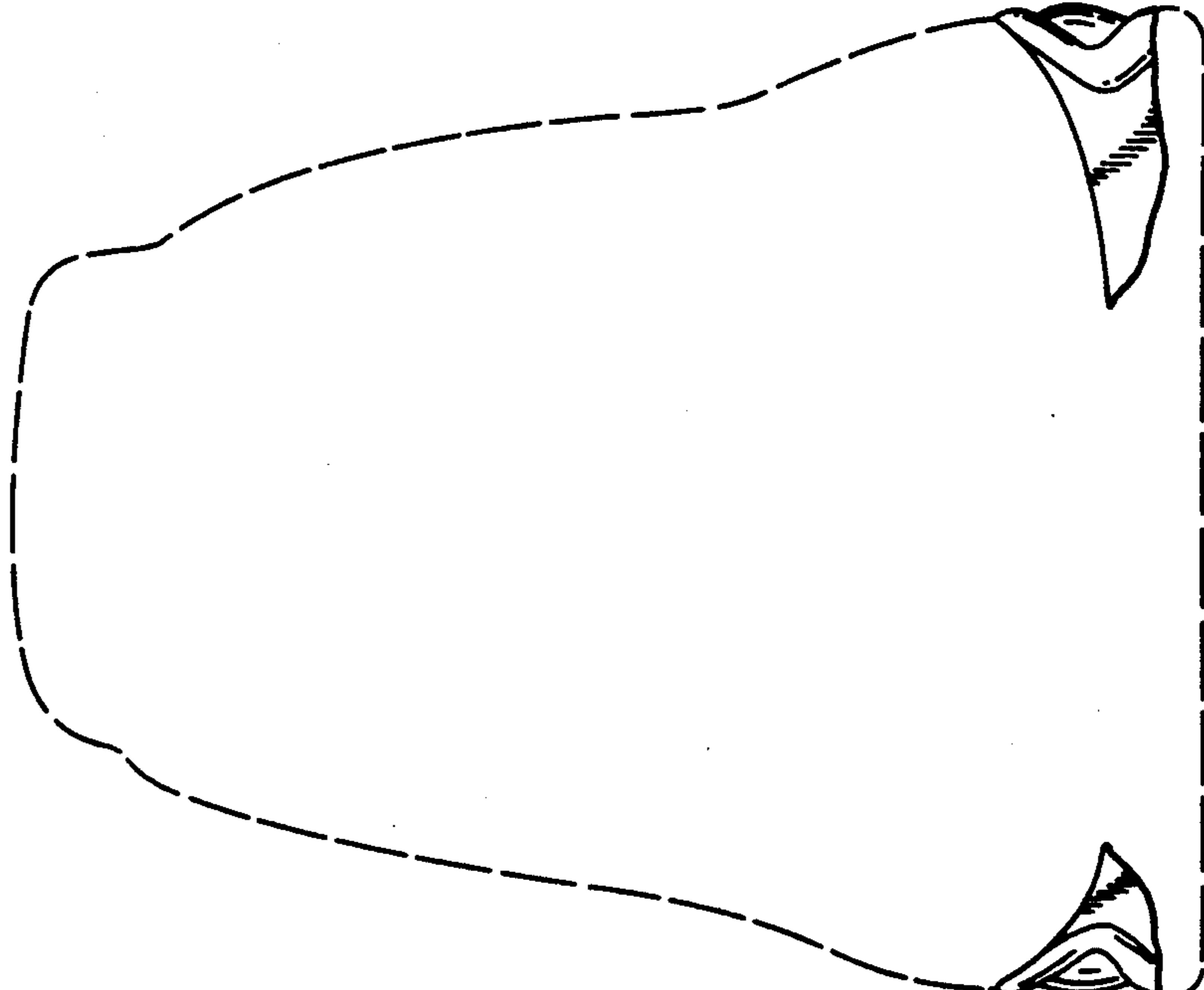

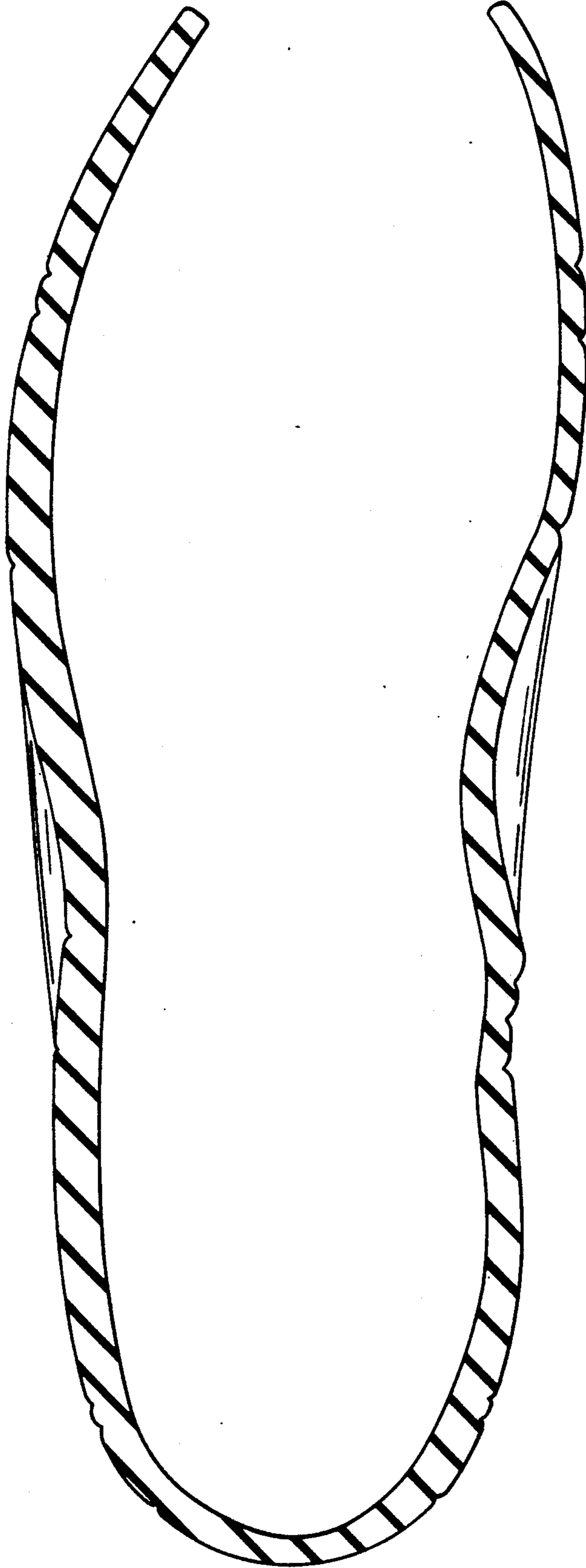

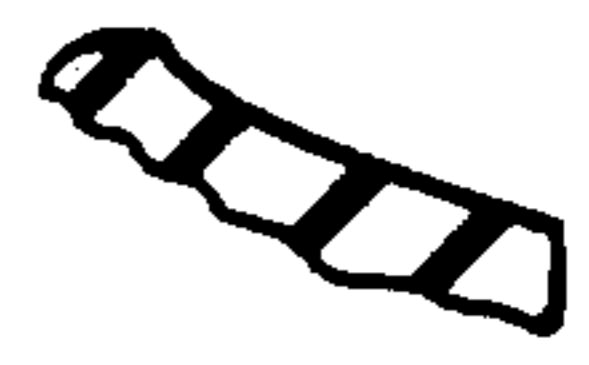
