[57] CLAIM

The ornamental design for a case for audio tape cassettes, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a case for audio tape cassettes, showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a left side elevational view thereof; FIG. 7 is a right side elevational view thereof; FIG. 8 is a perspective view thereof, being shown in an open position; FIG. 9 is a perspective view of an alternate embodiment of the design shown in FIG. 1; FIG. 10 is a front elevational view of FIG. 9; FIG. 11 is a rear elevational view of FIG. 9; FIG. 12 is a top plan view of FIG. 9; FIG. 13 is a bottom plan view of FIG. 9; FIG. 14 is a left side elevational view of FIG. 9; FIG. 15 is a right side elevational view of FIG. 9; and, FIG. 16 is a perspective view of FIG. 9 being shown in an open position.

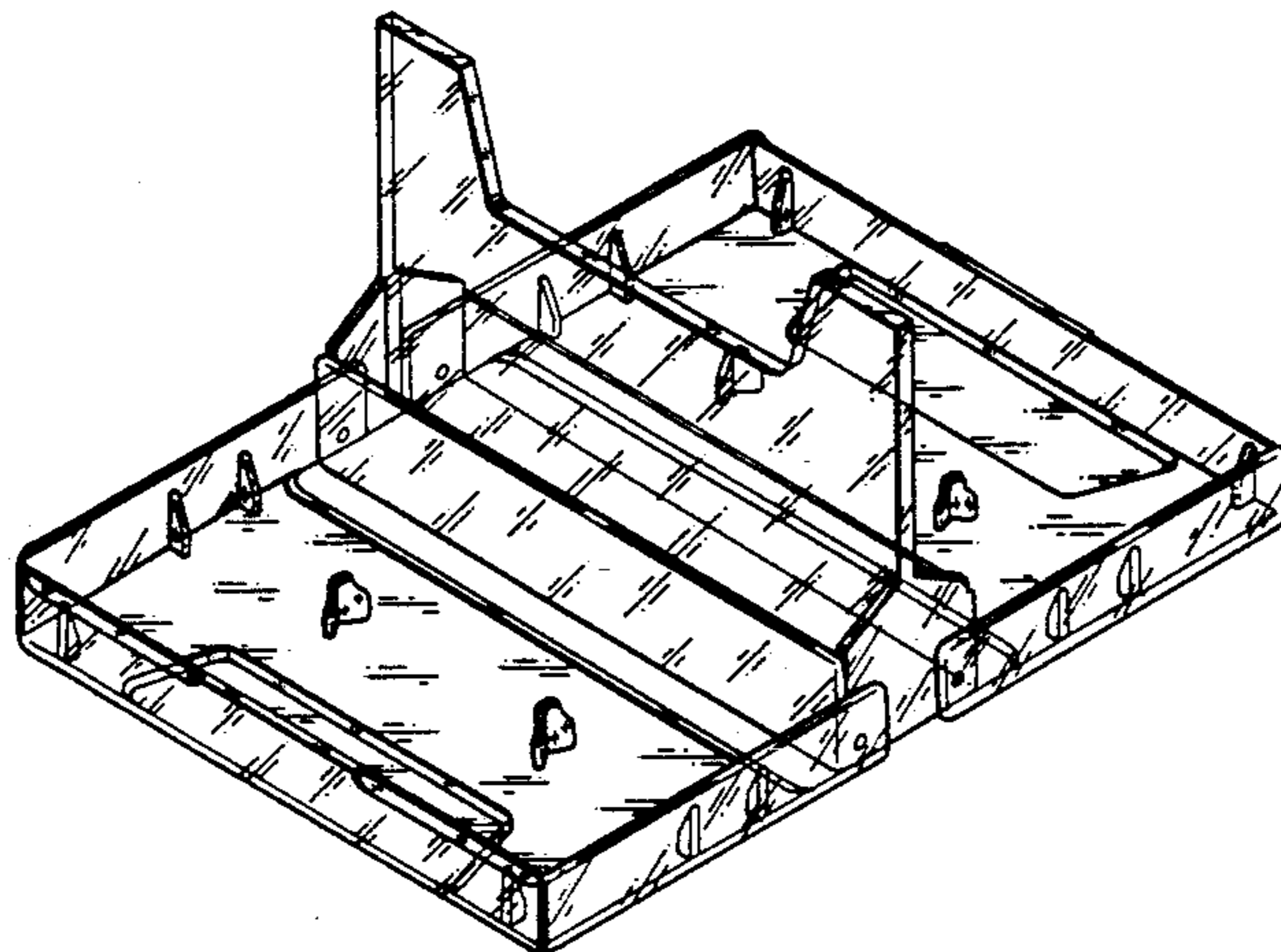
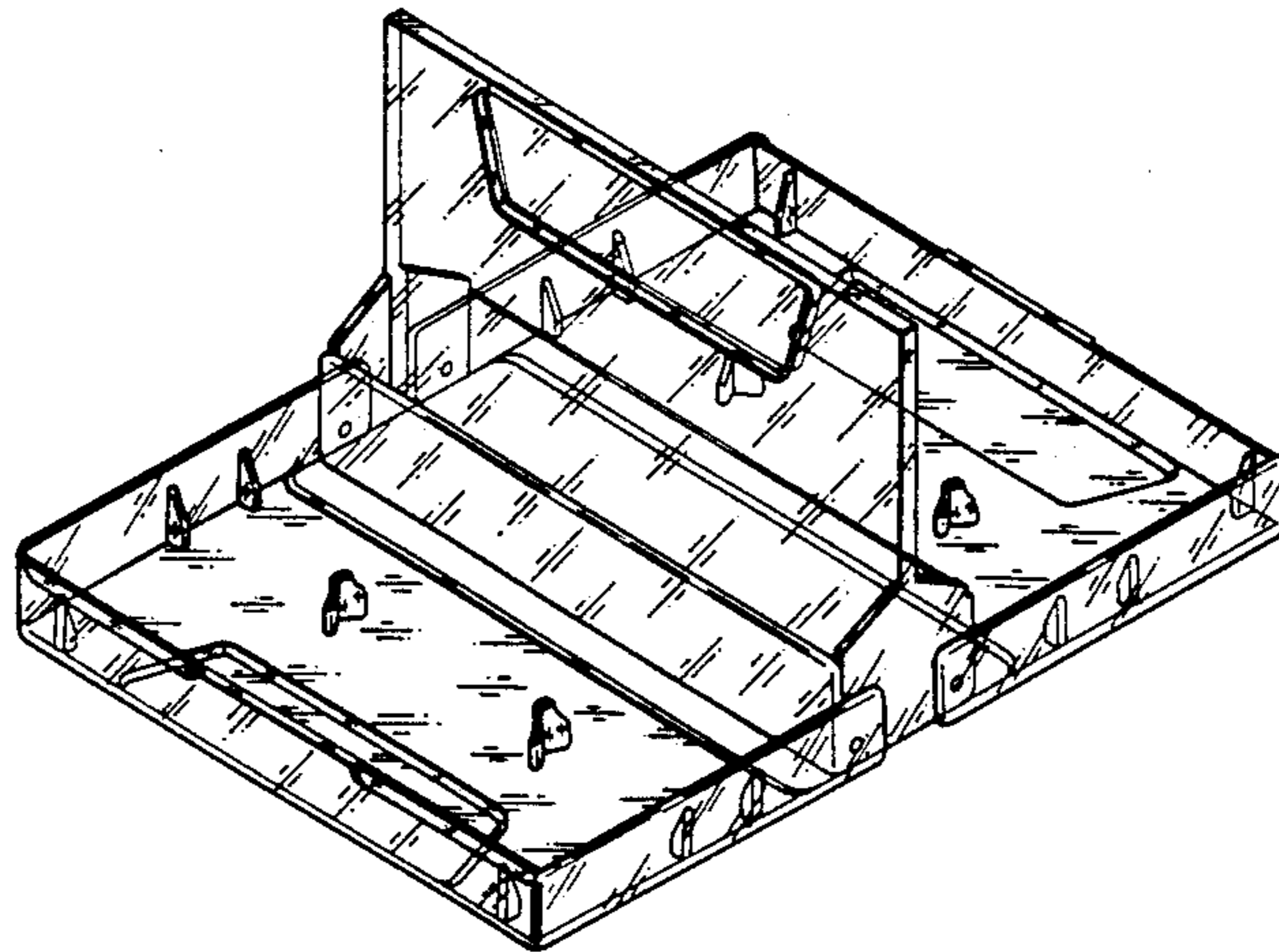

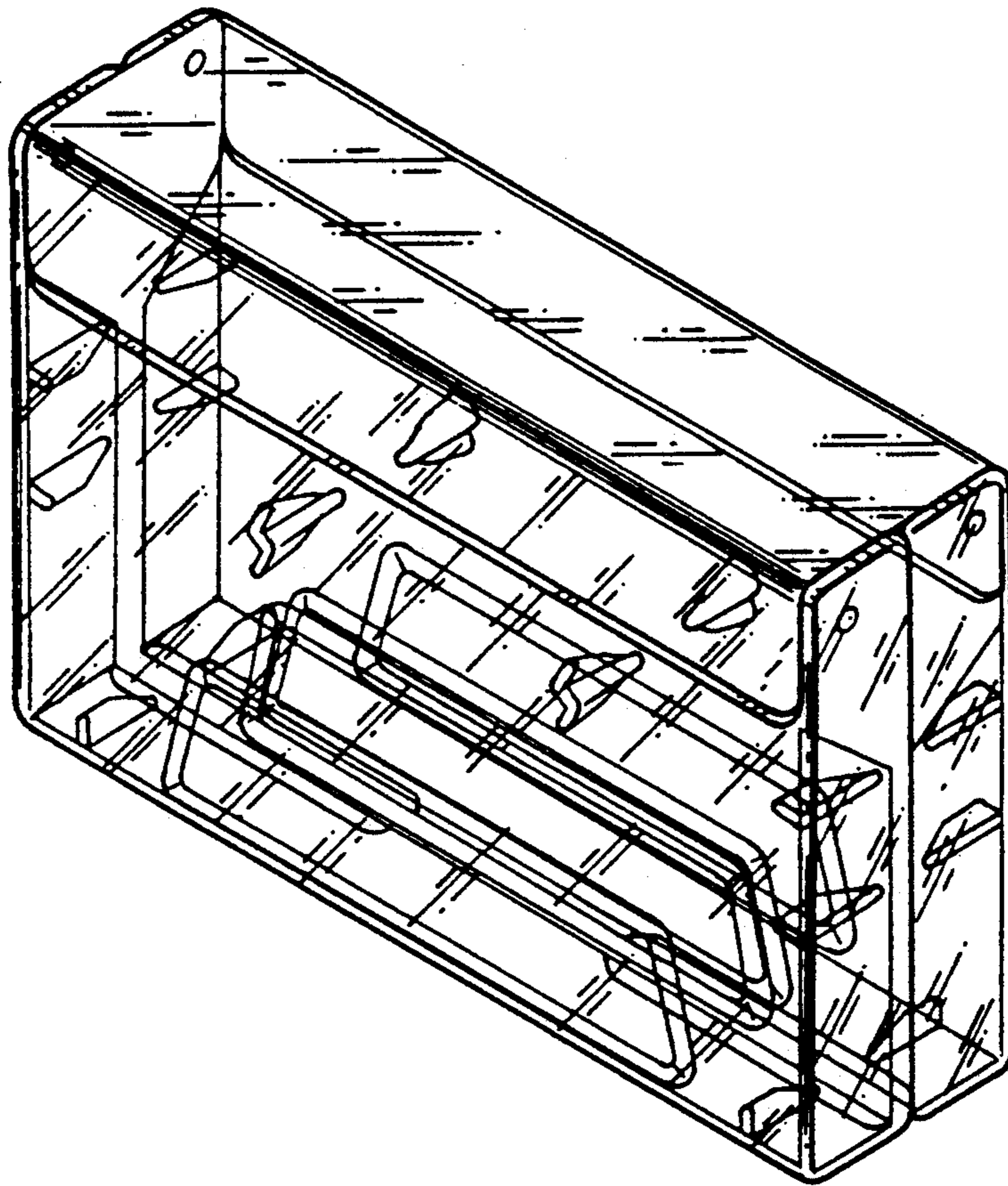

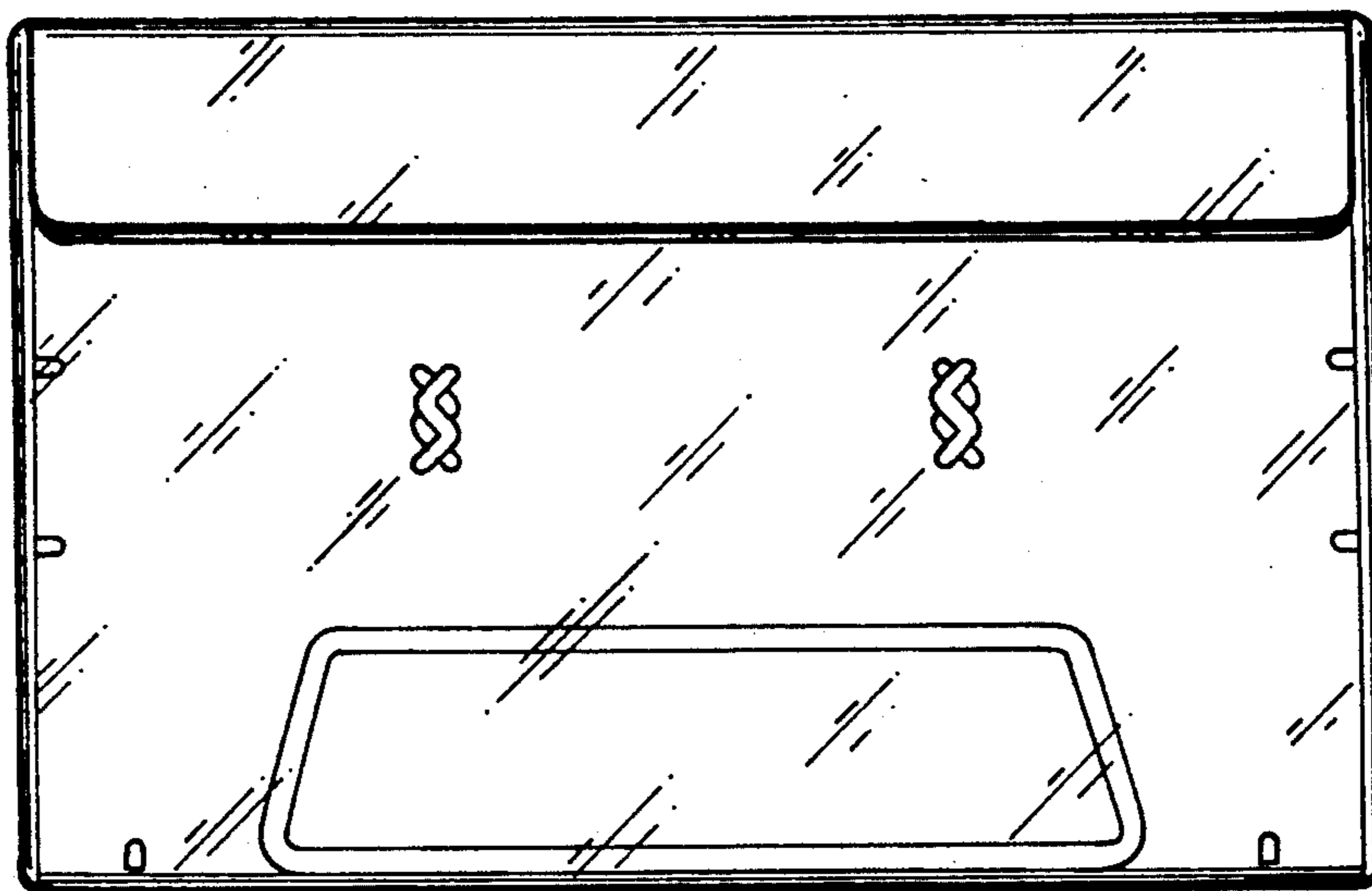

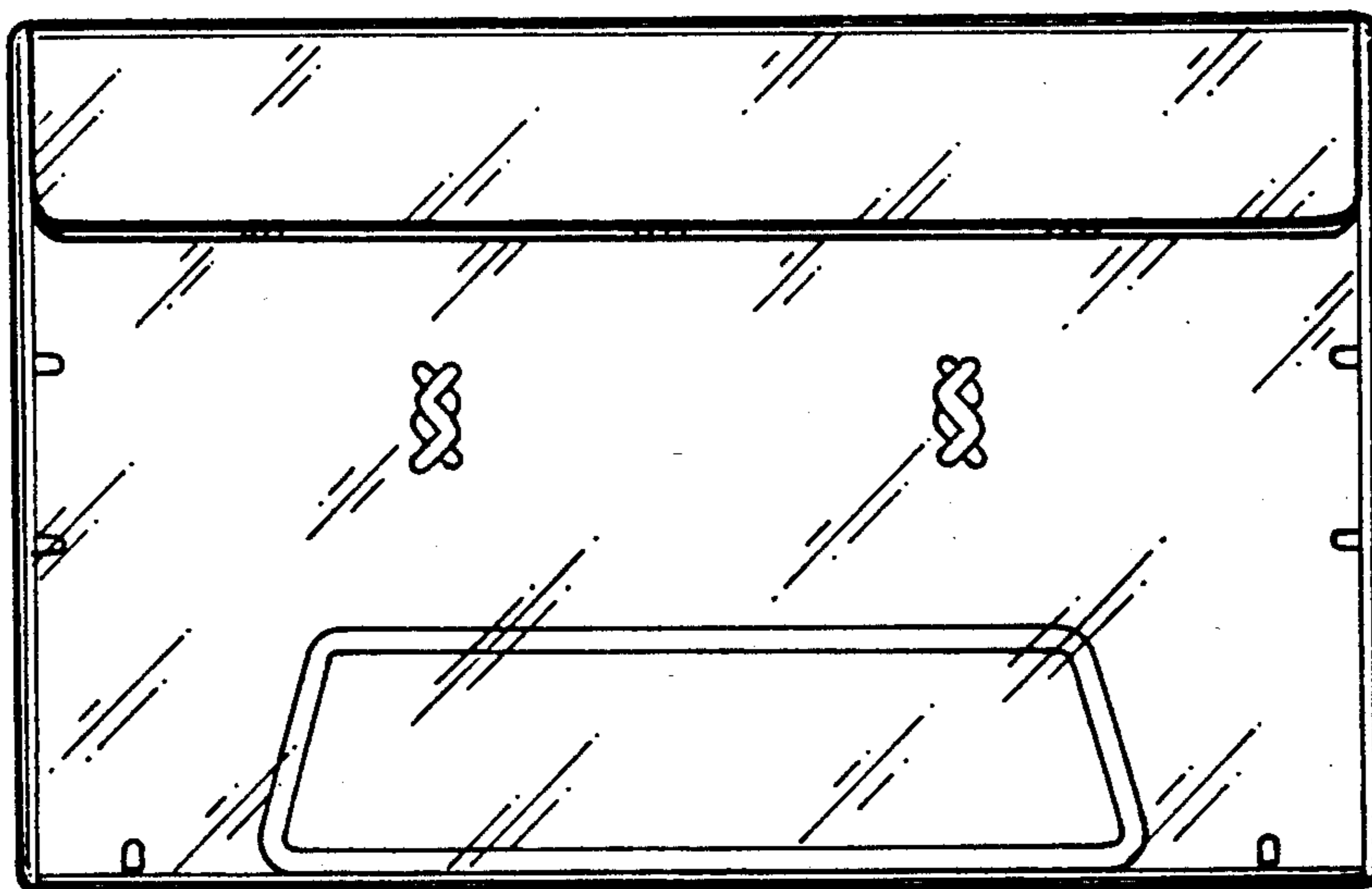

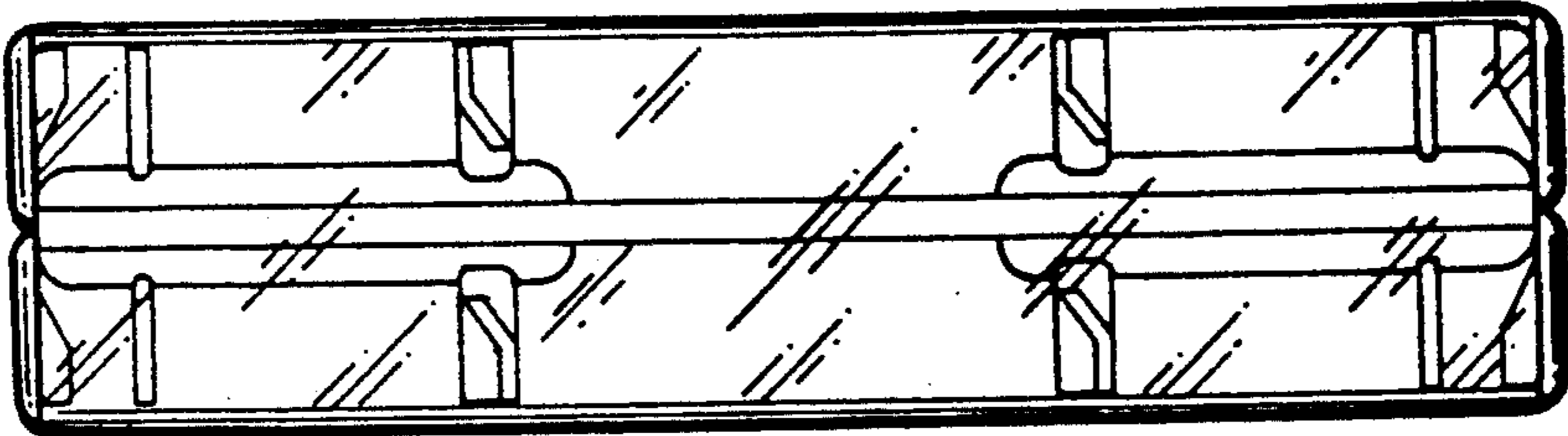

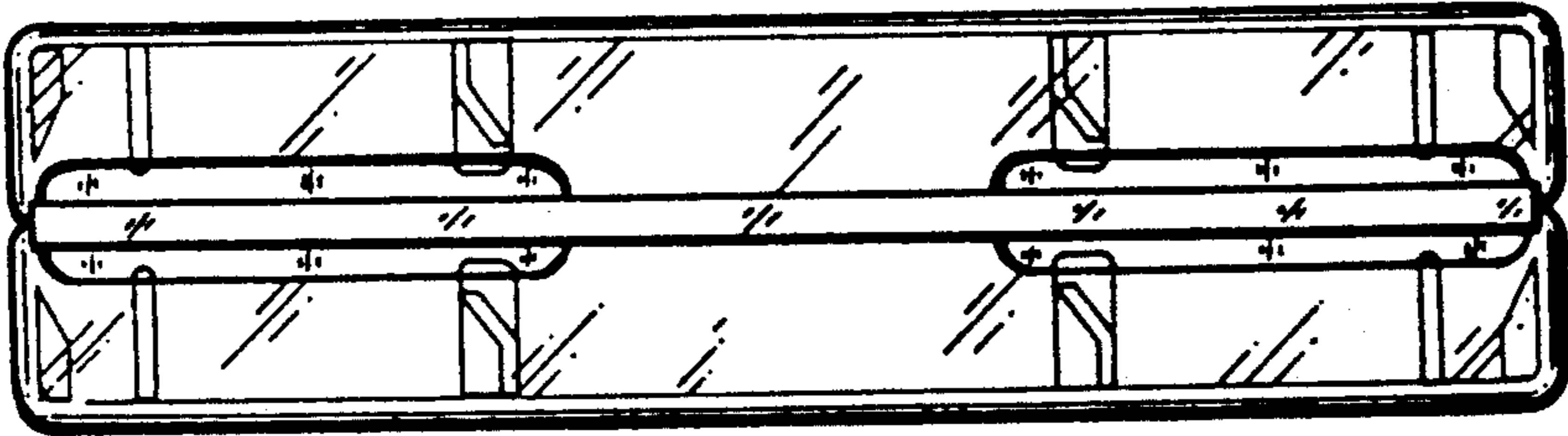

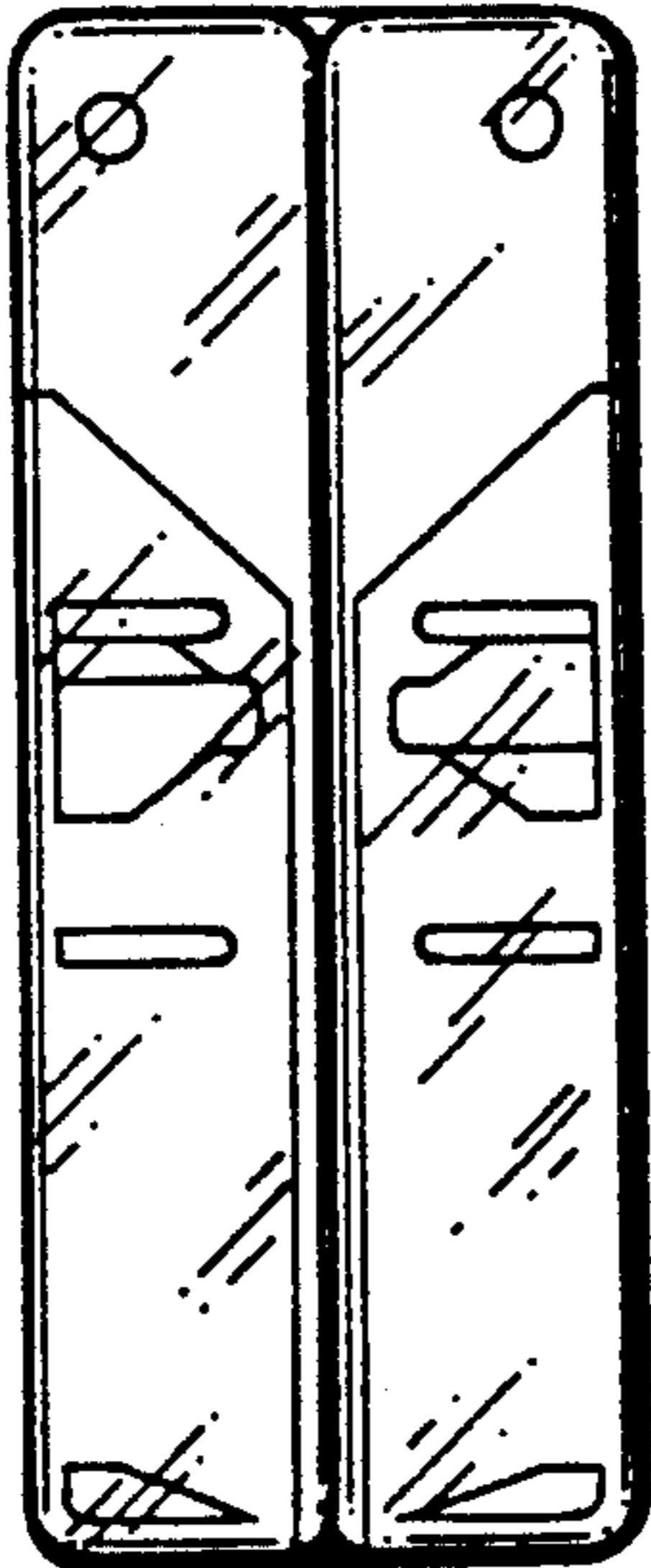

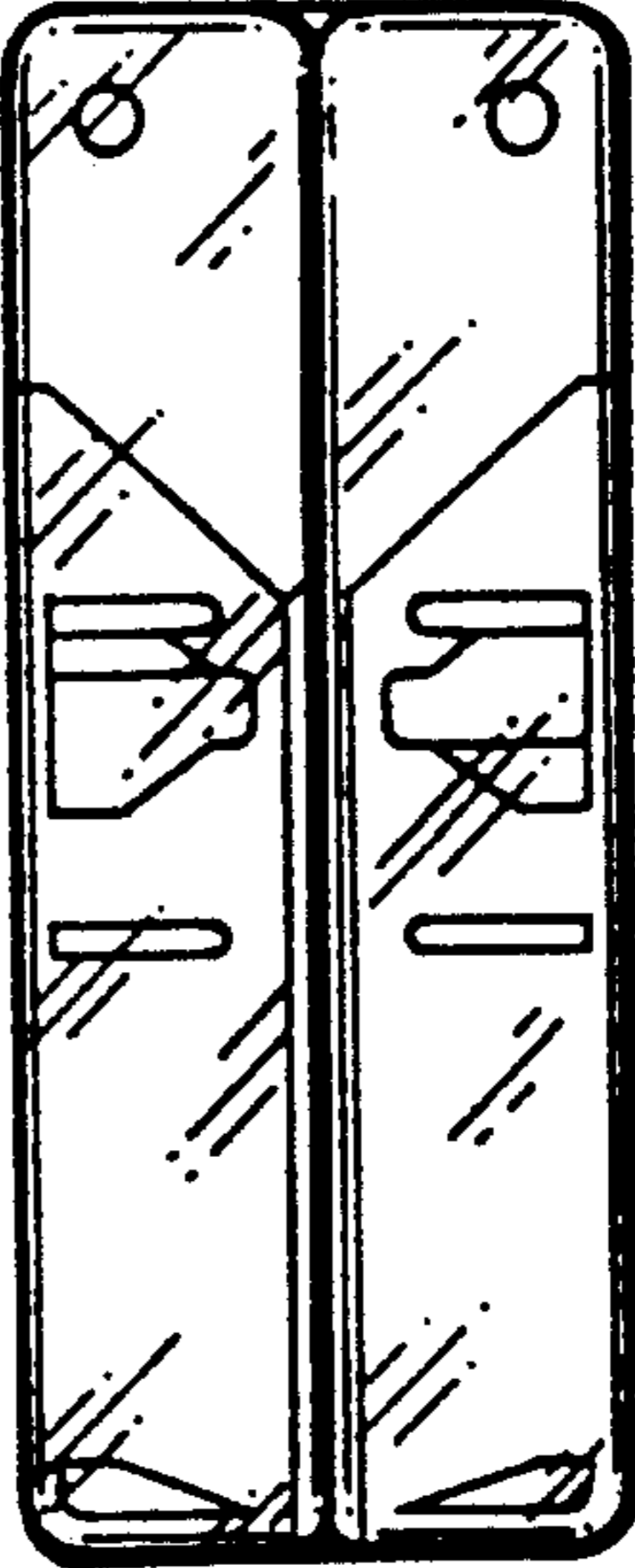

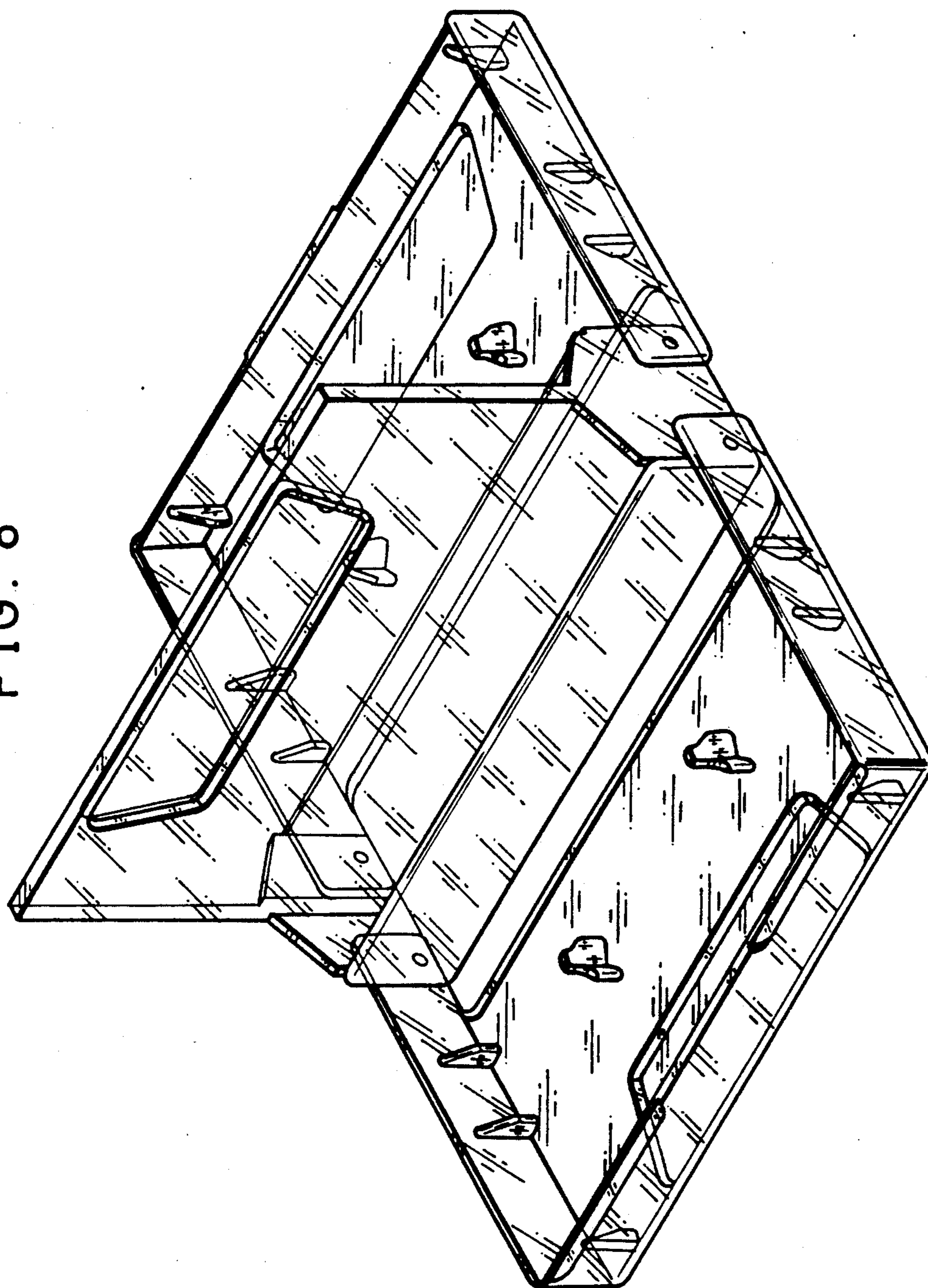

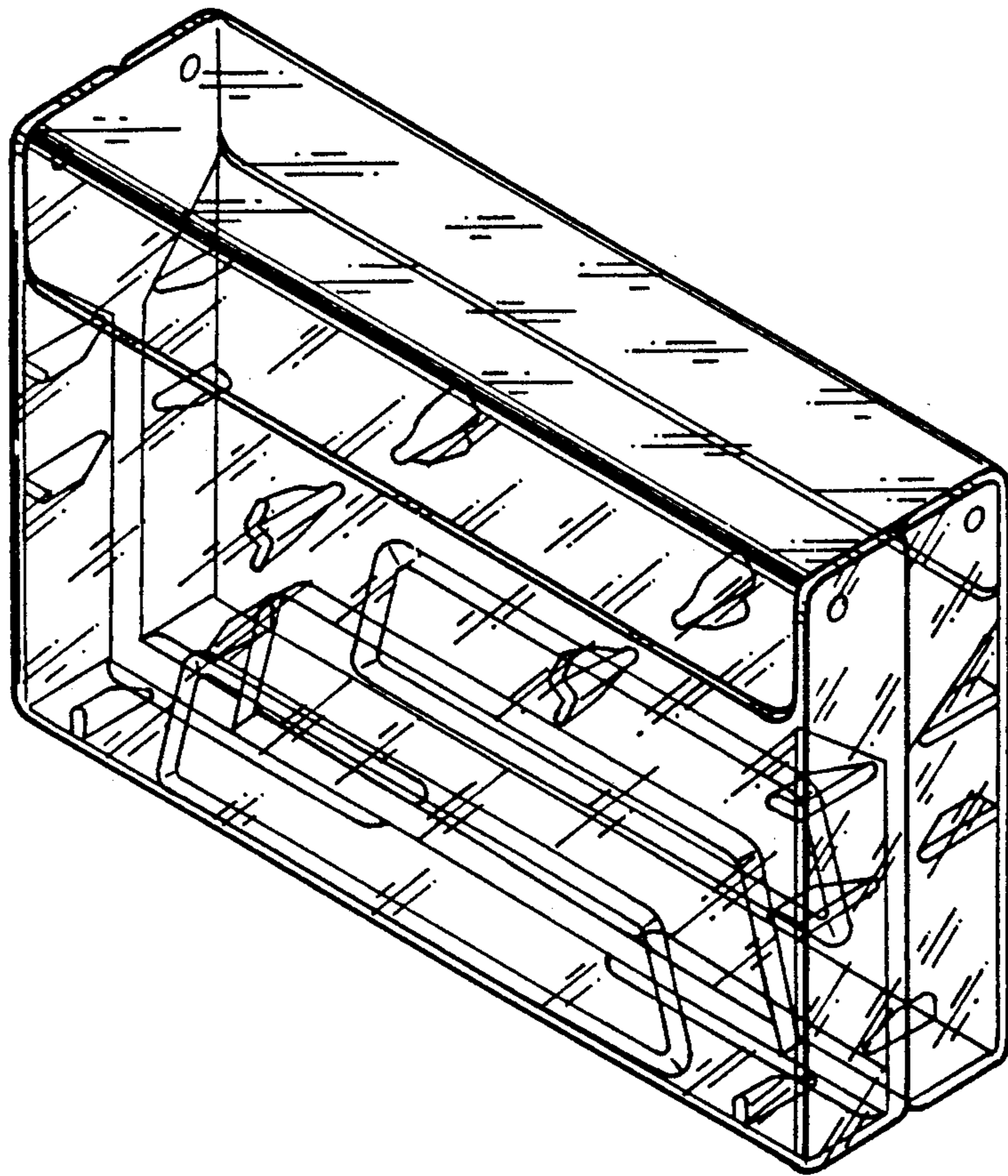

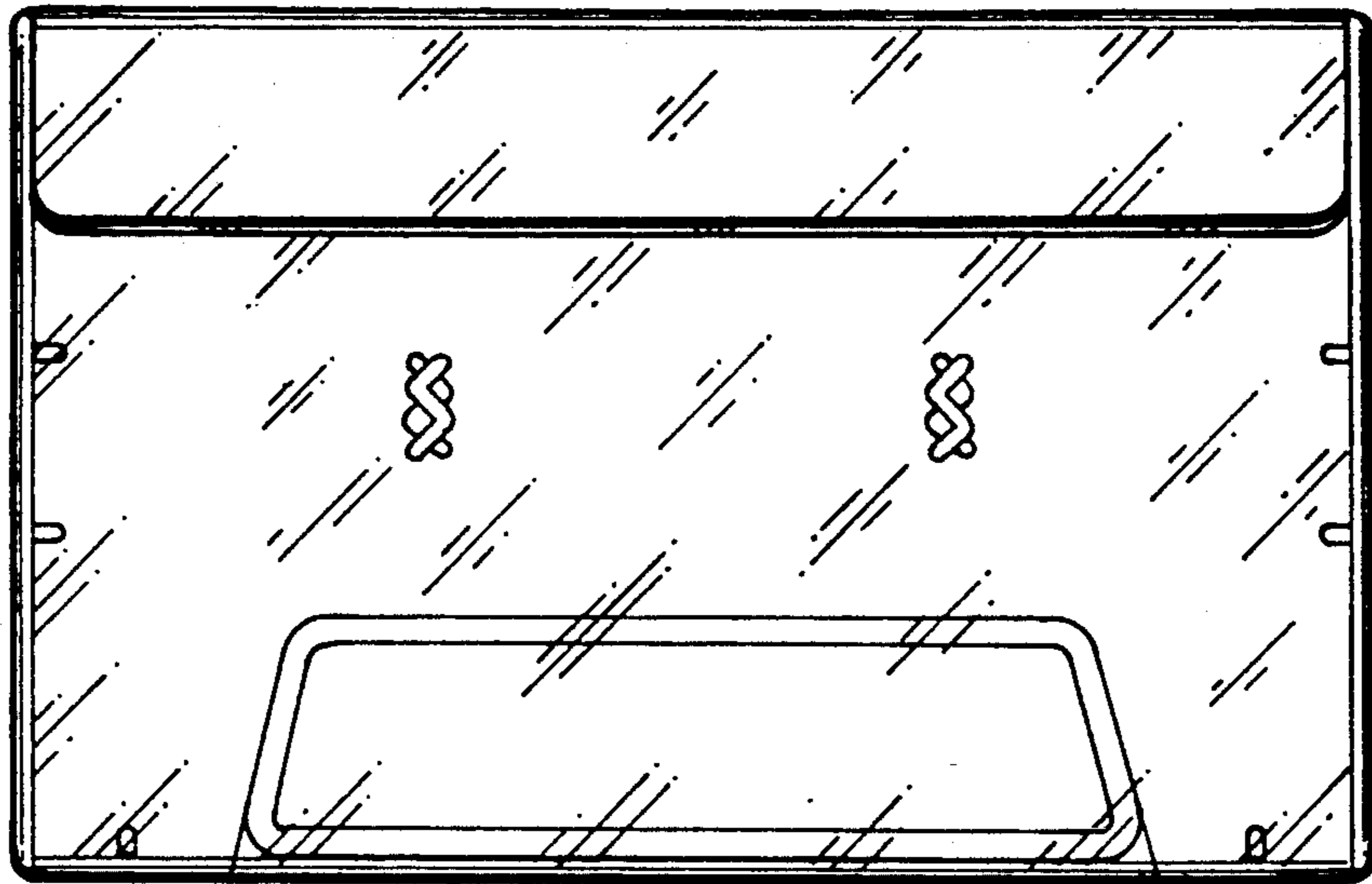

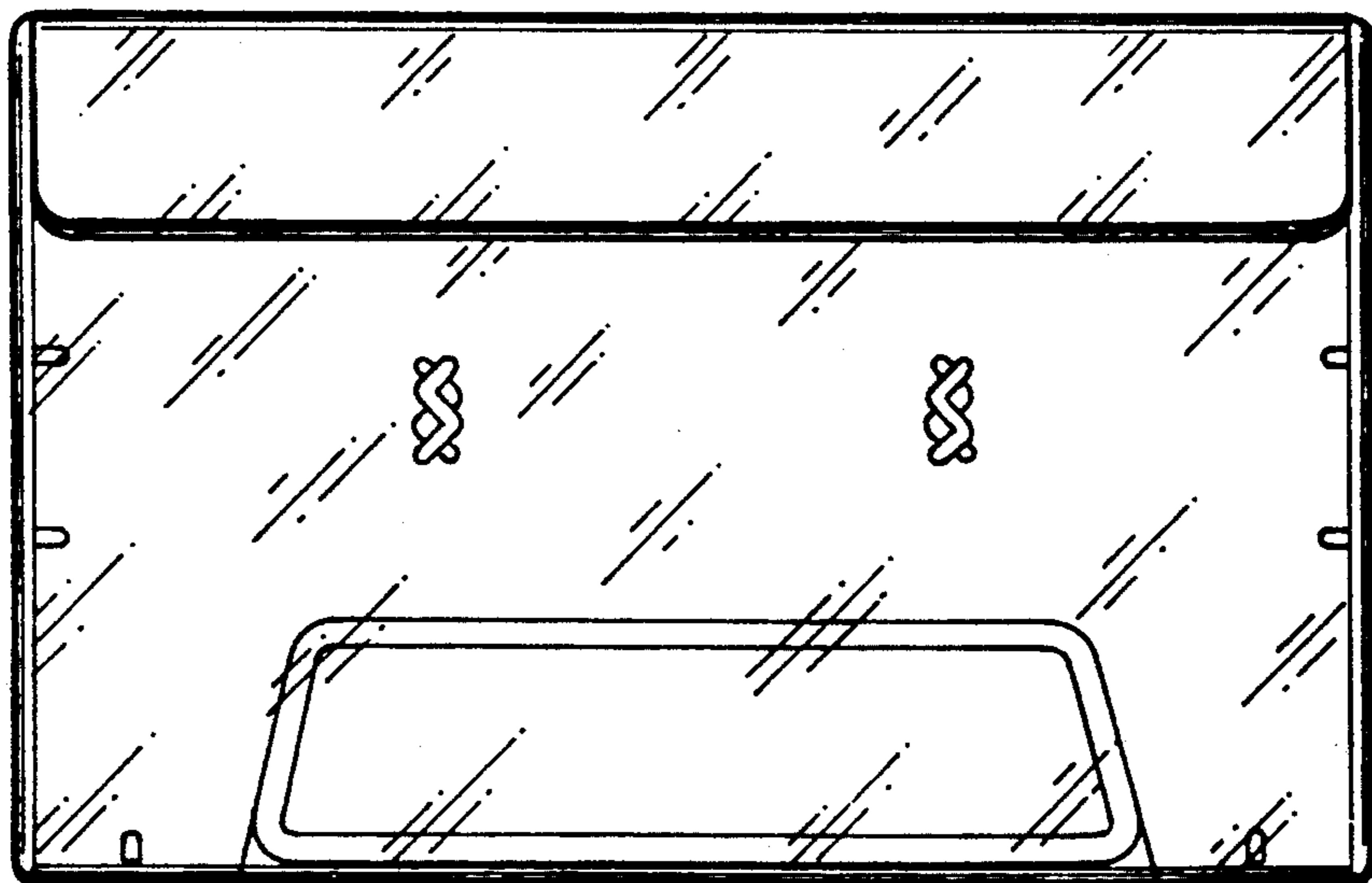

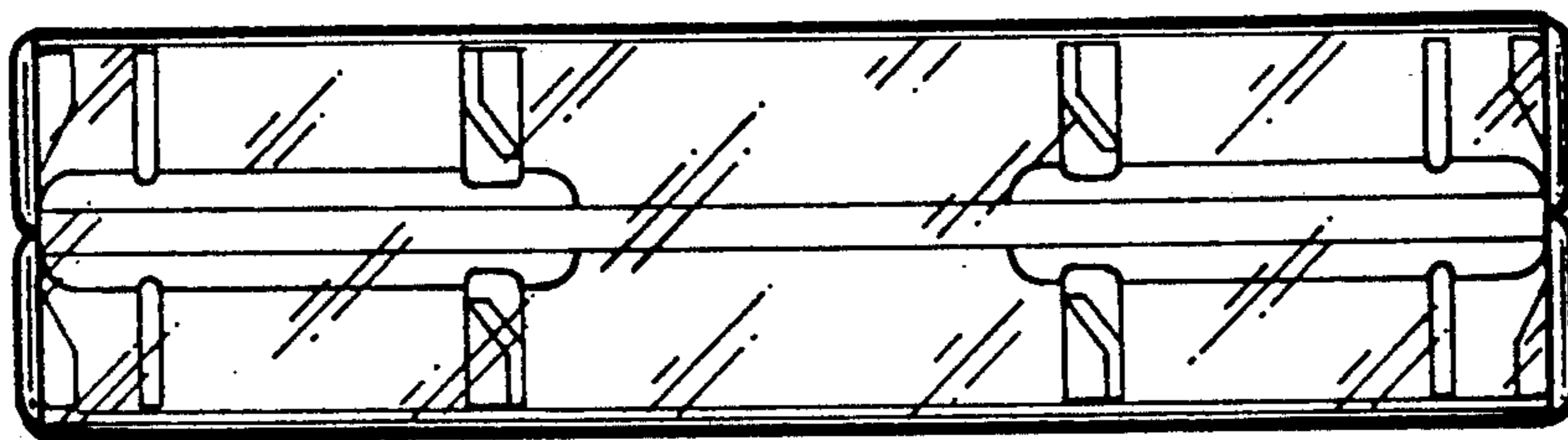

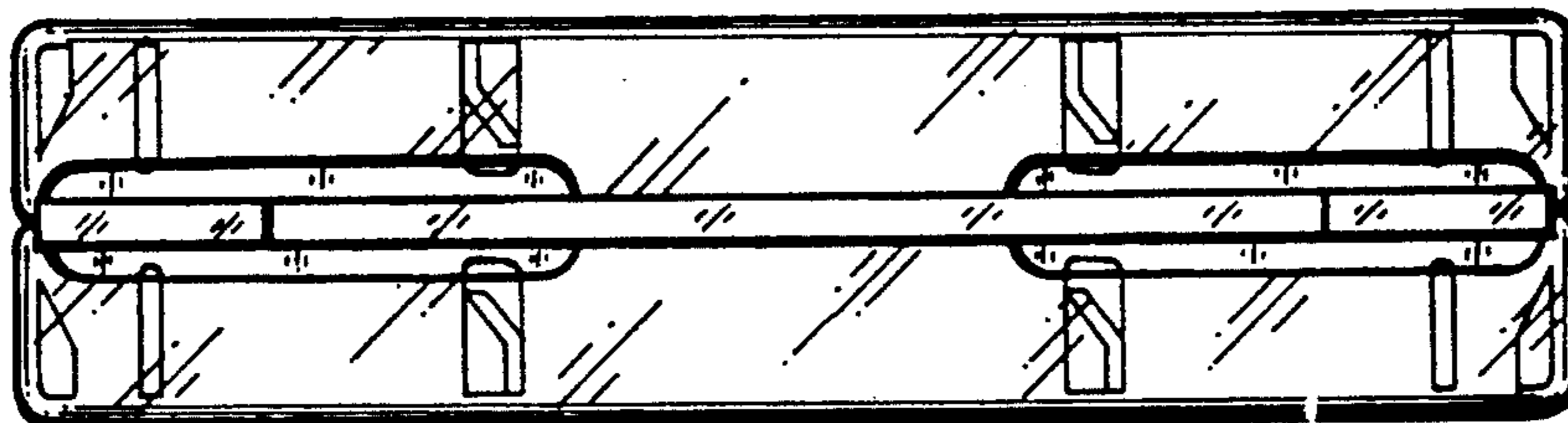

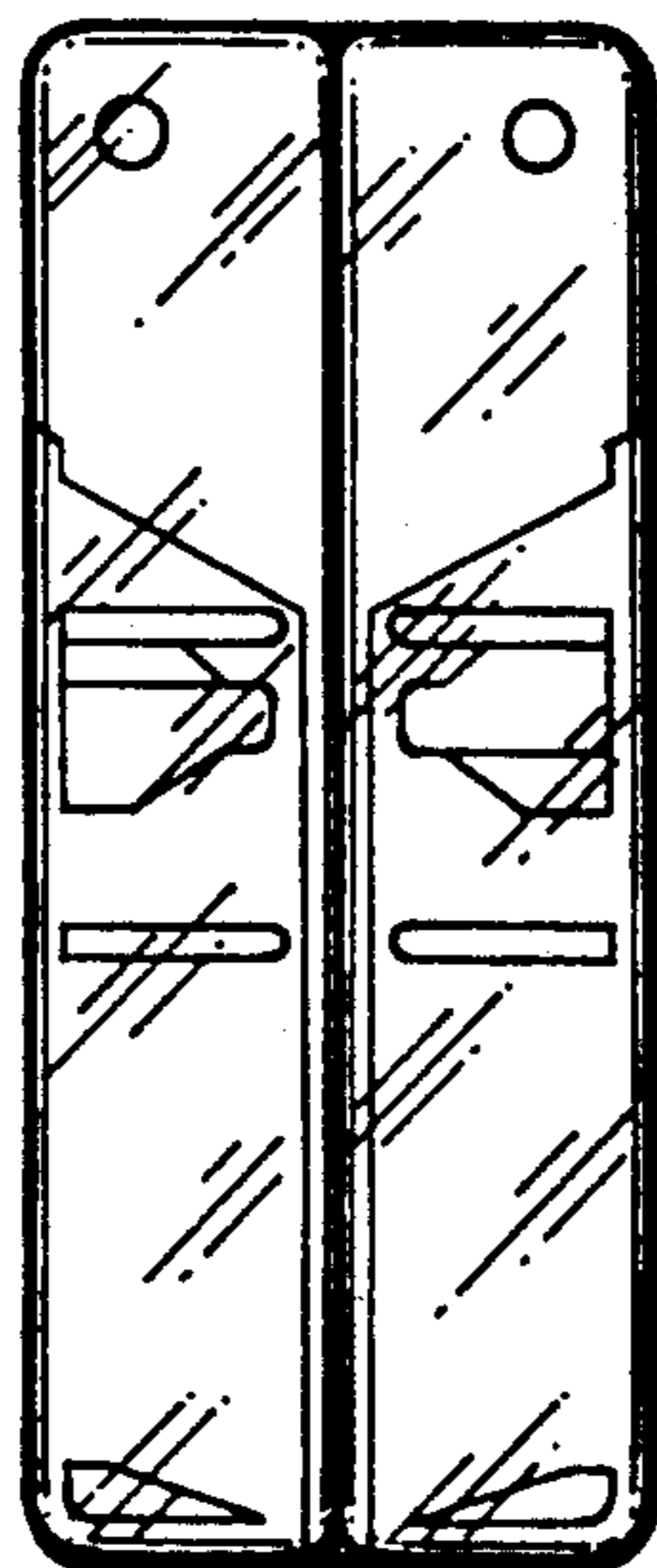

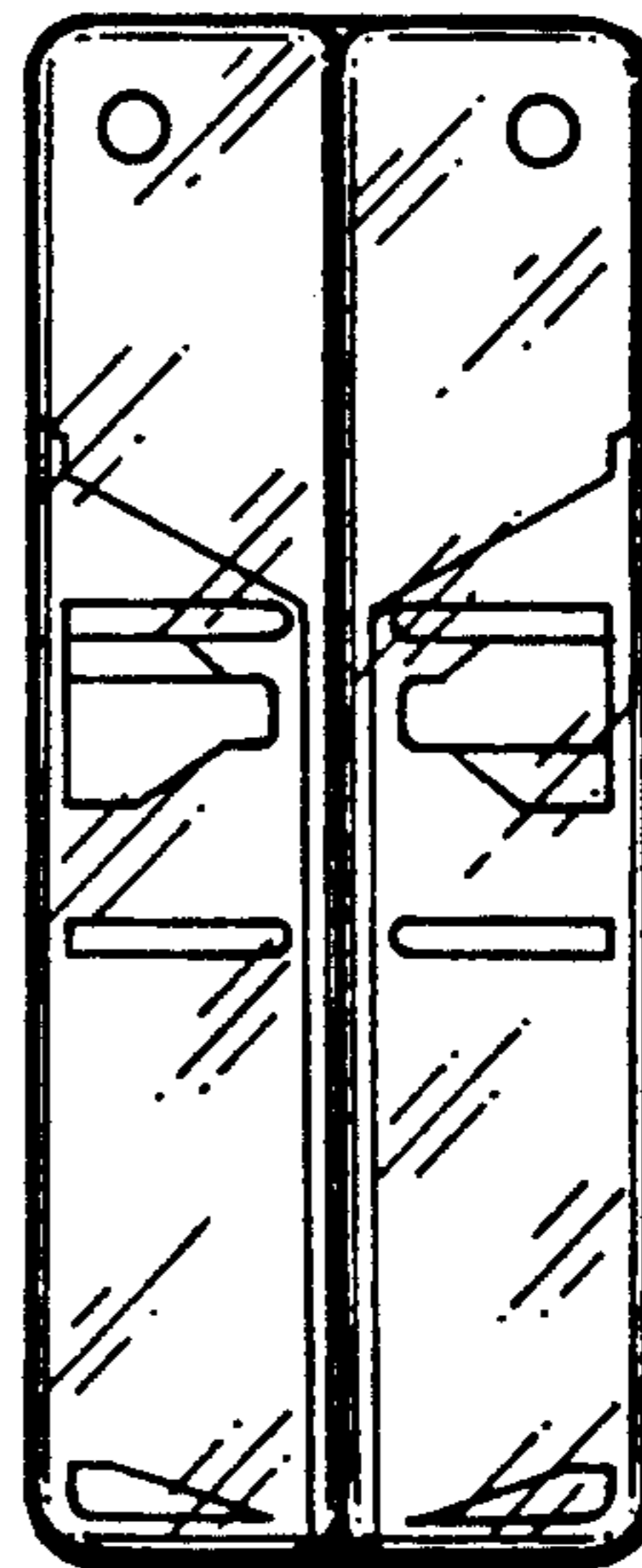
