DESCRIPTION

FIG. 1 is a right front perspective view of a preferred embodiment of a chair embodying my new design;

FIG. 4 is a front elevational view thereof;

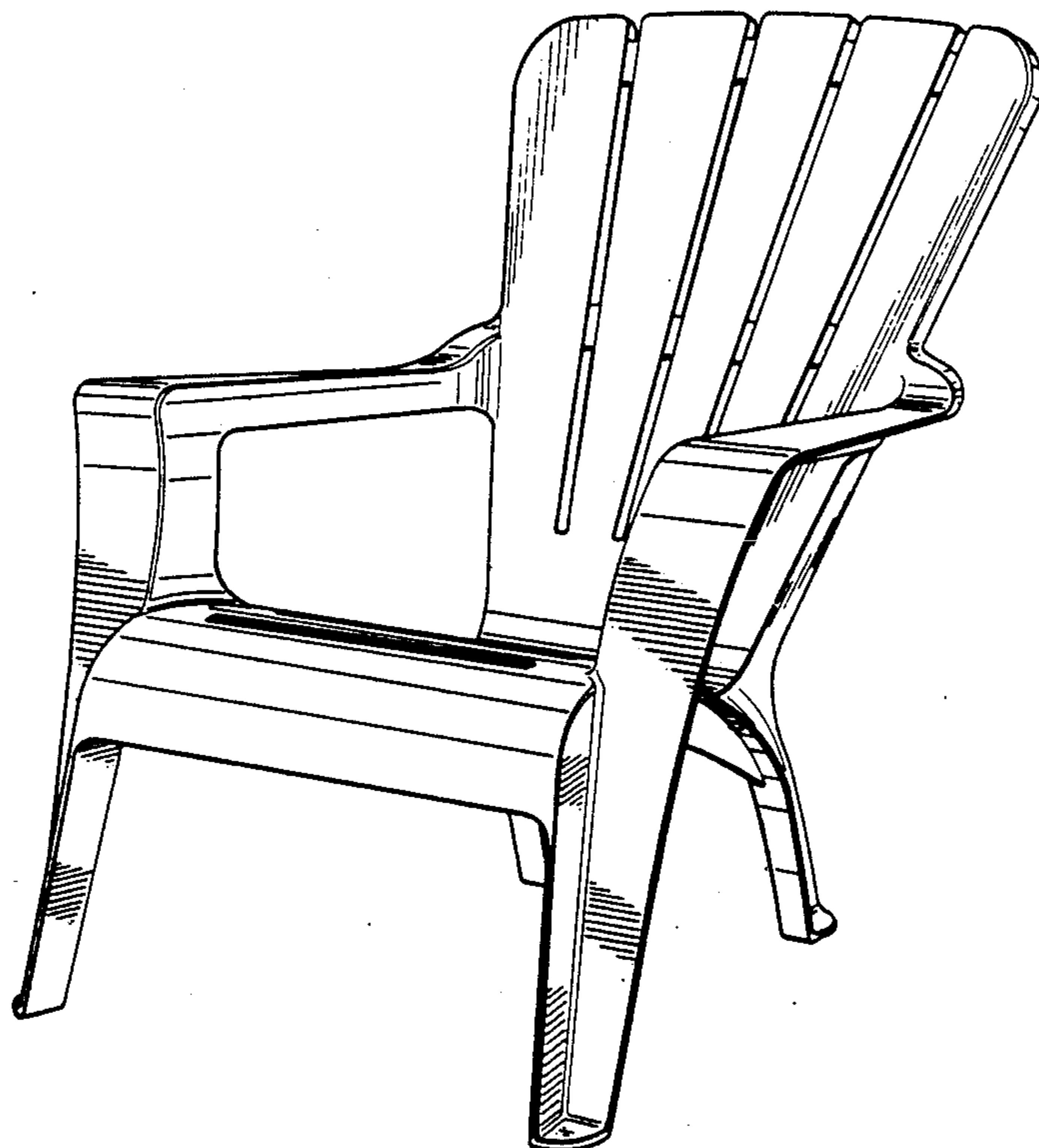
FIG. 5 is a rear elevational view thereof;

FIG. 9 is a rear elevational view of the alternate embodiment.



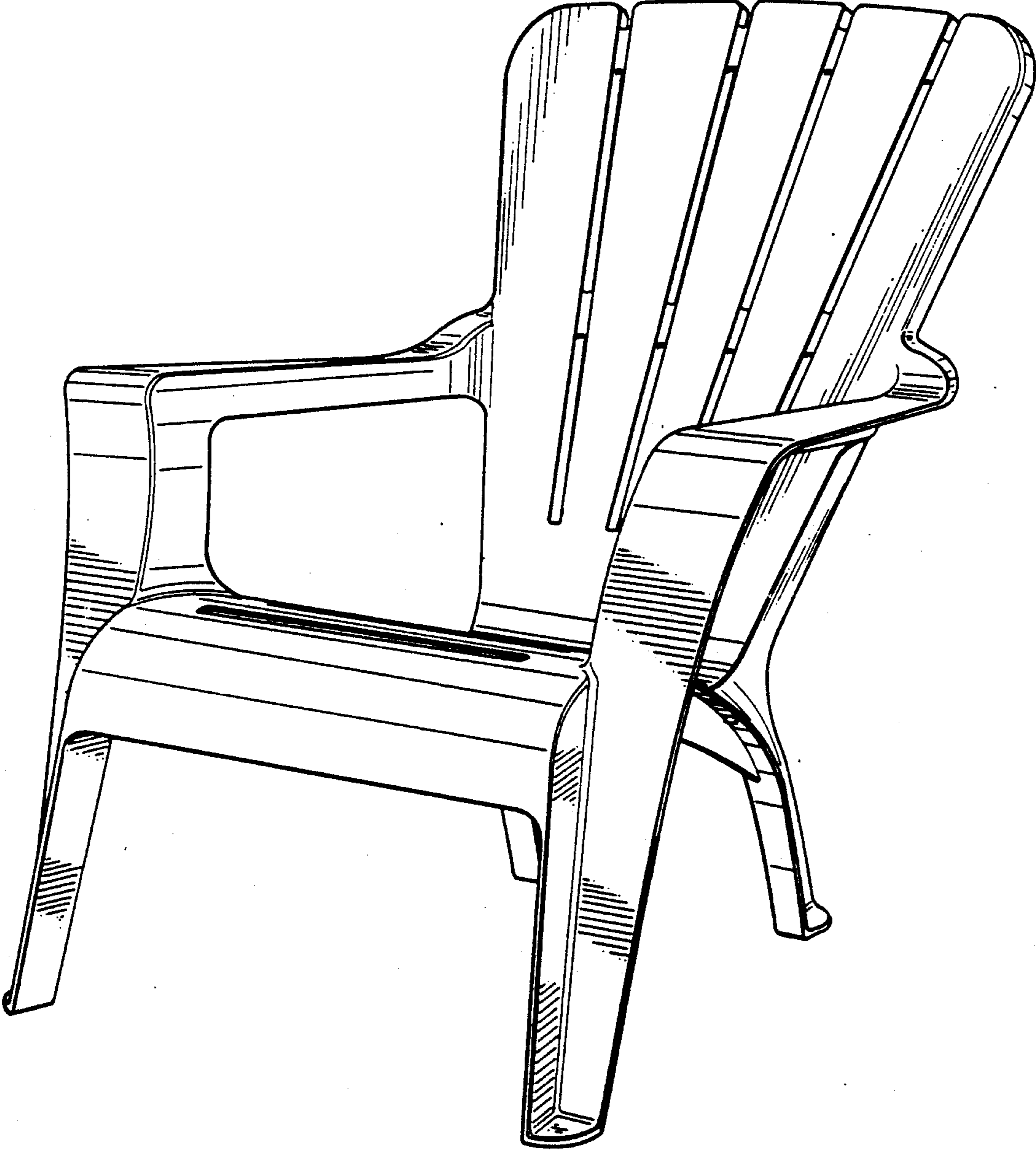

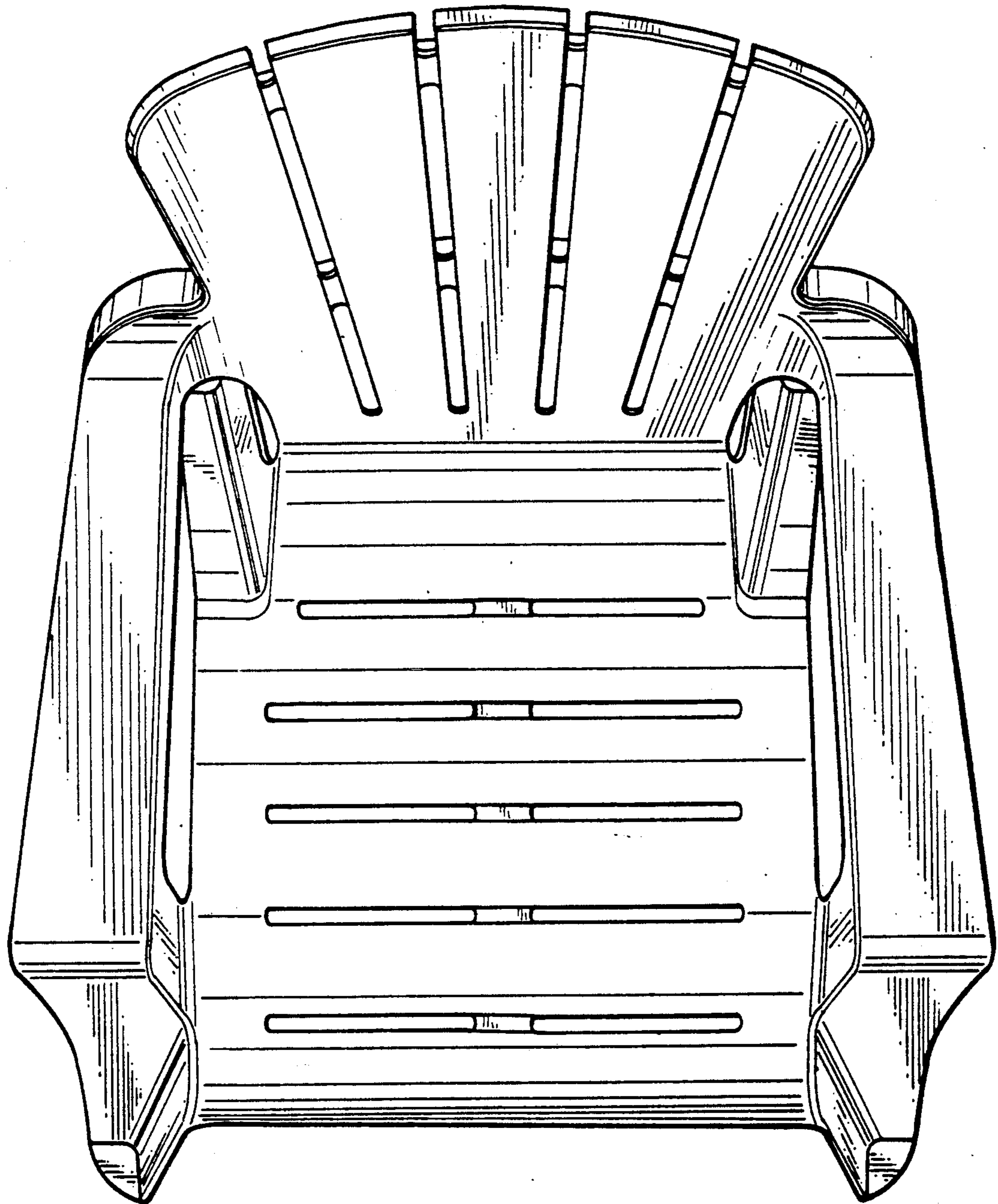

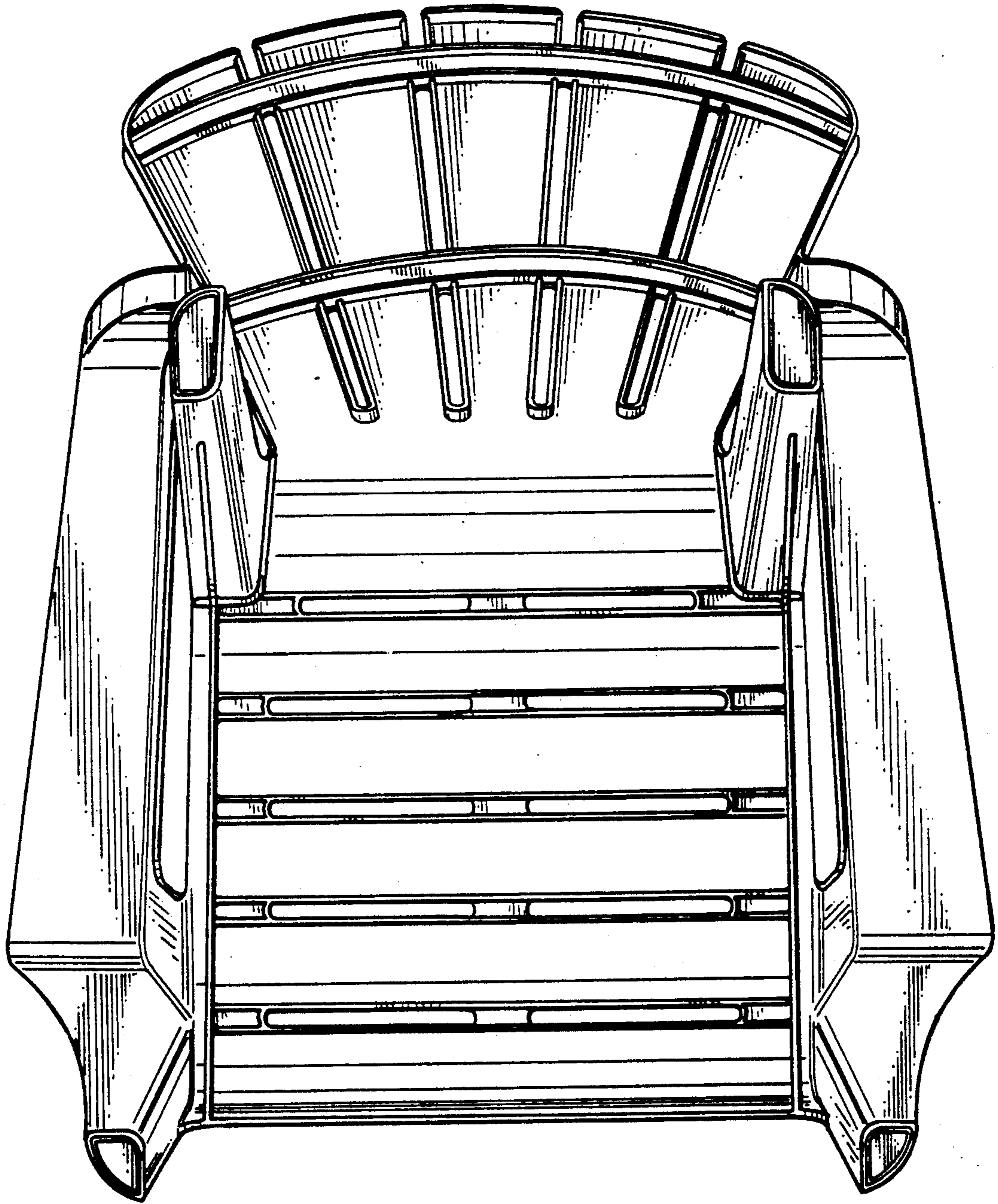

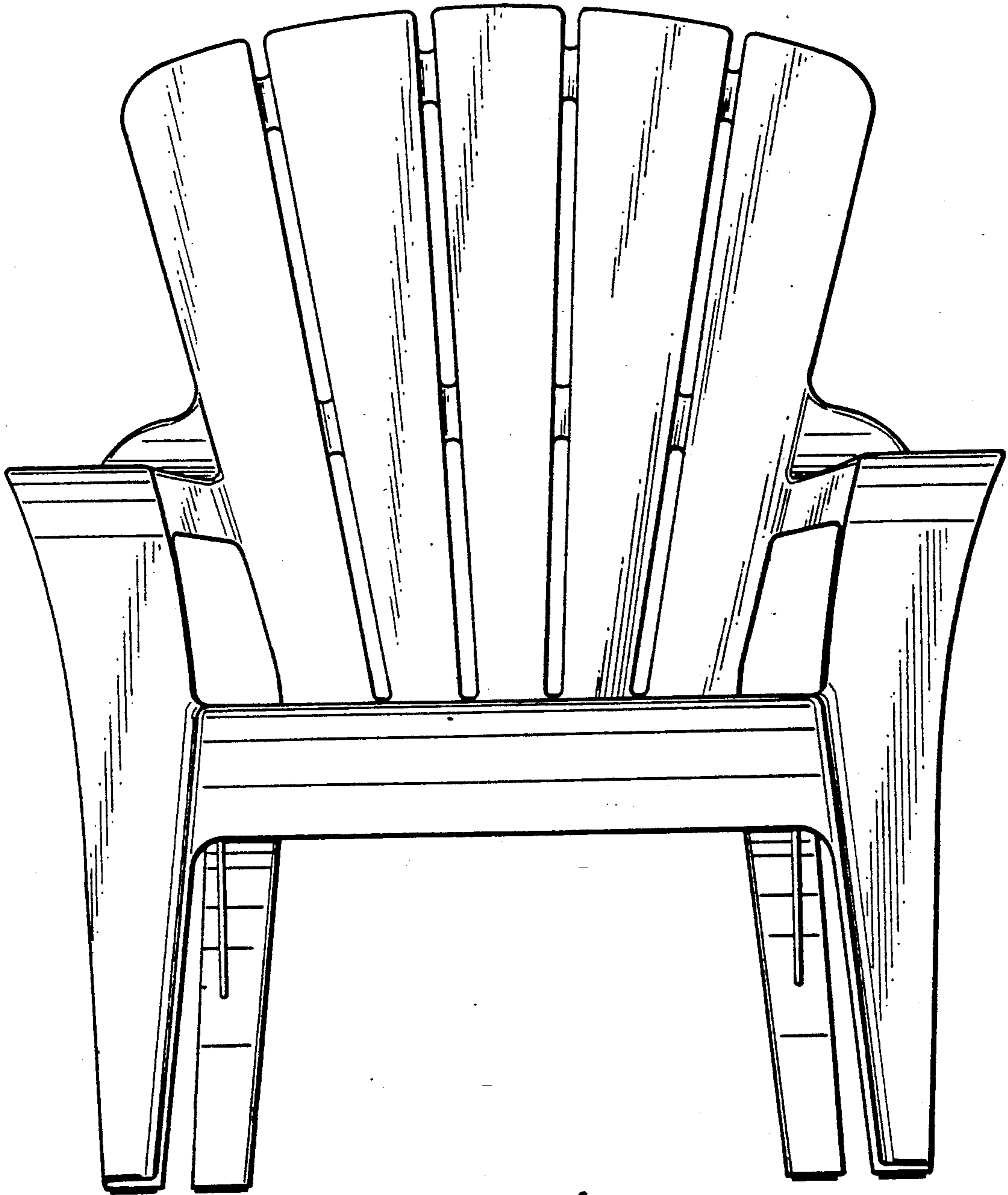

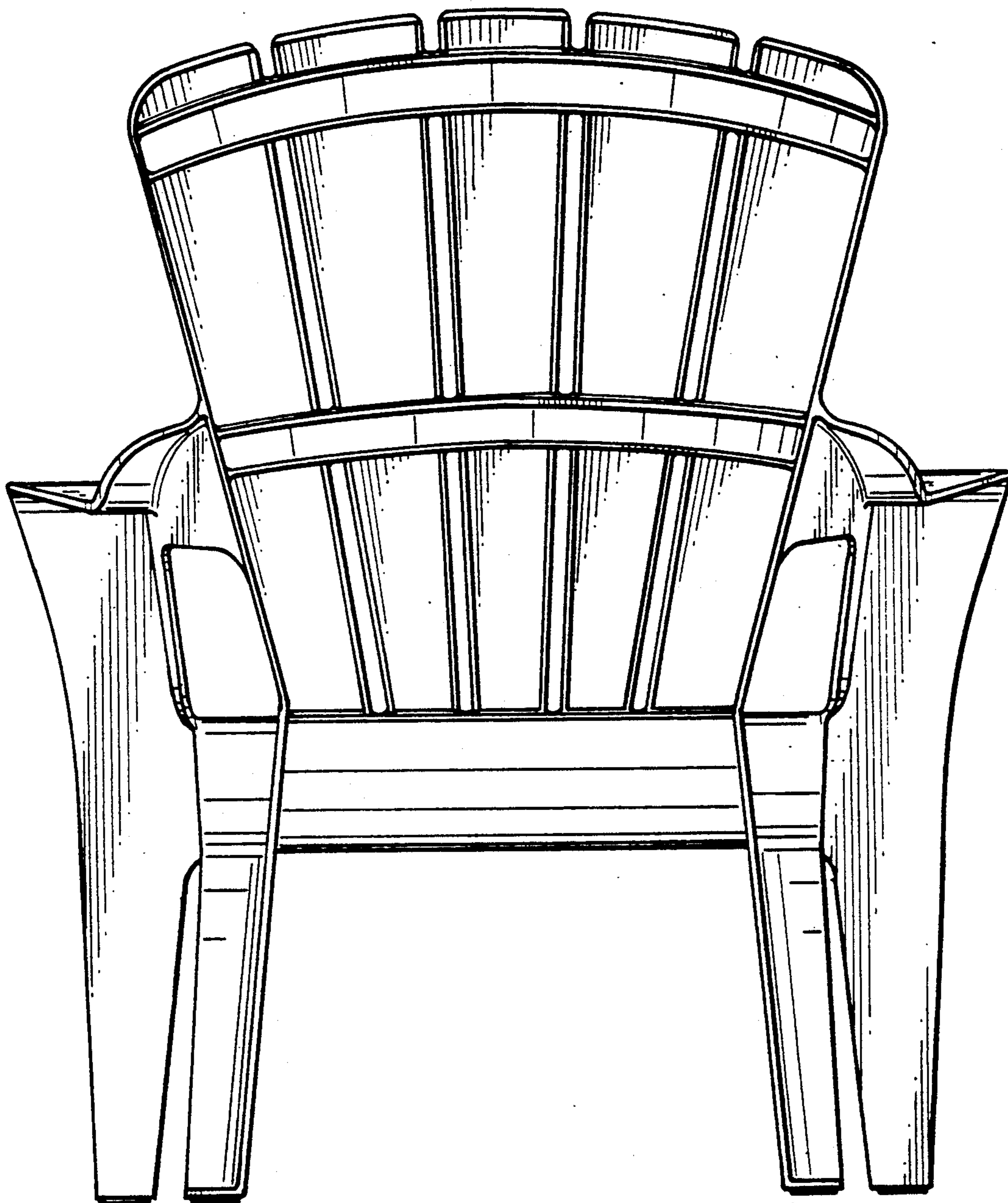

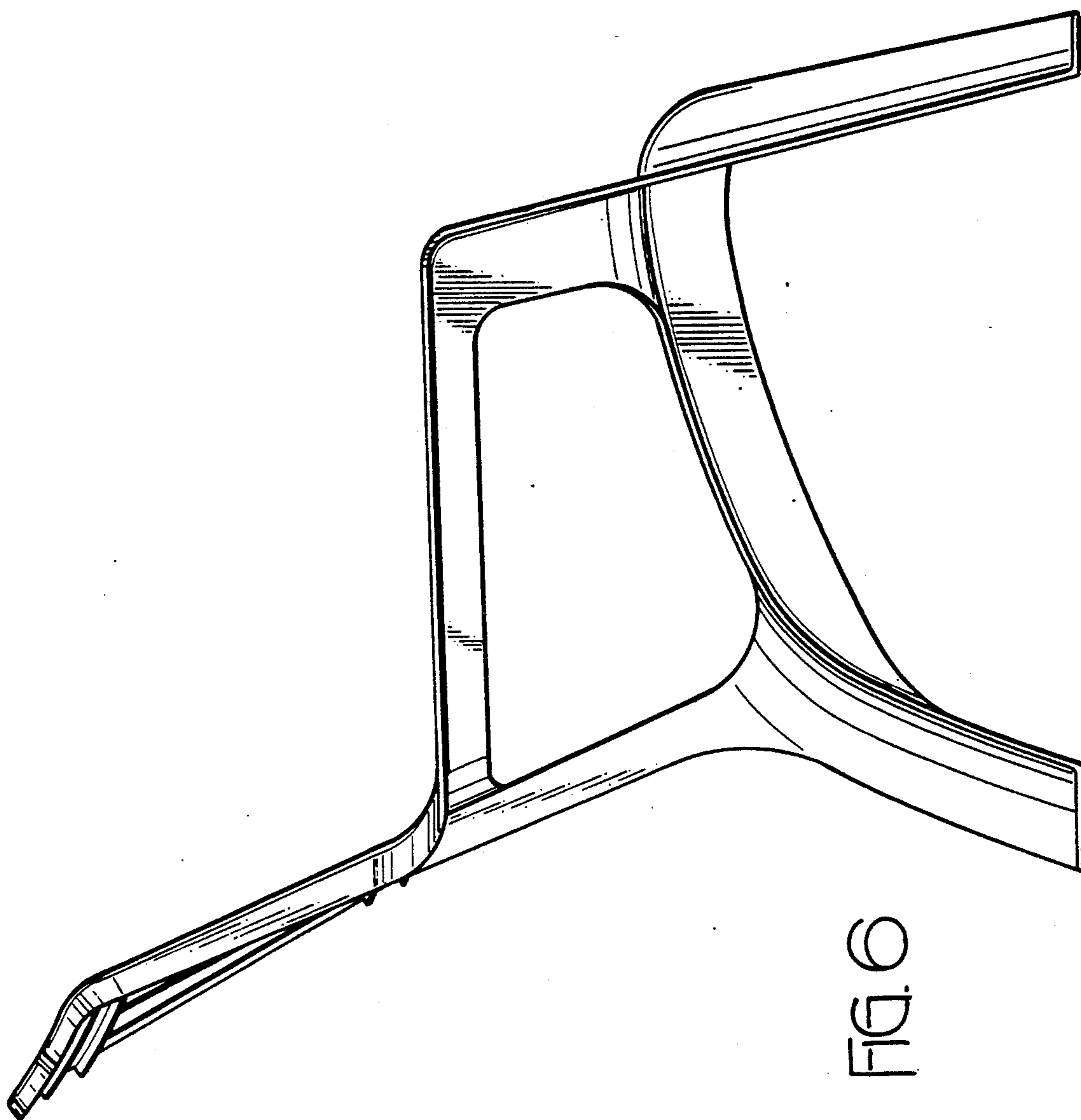

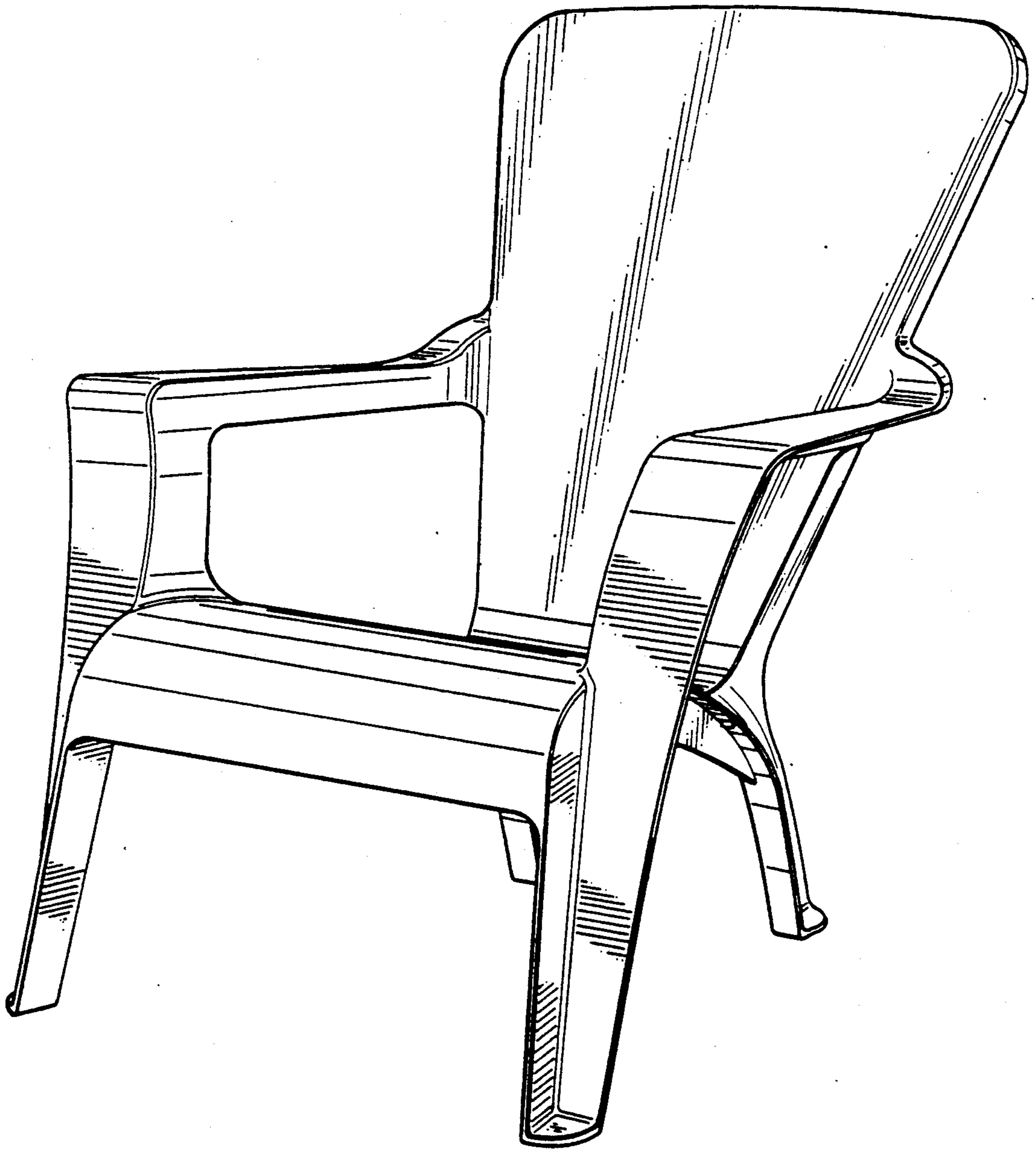

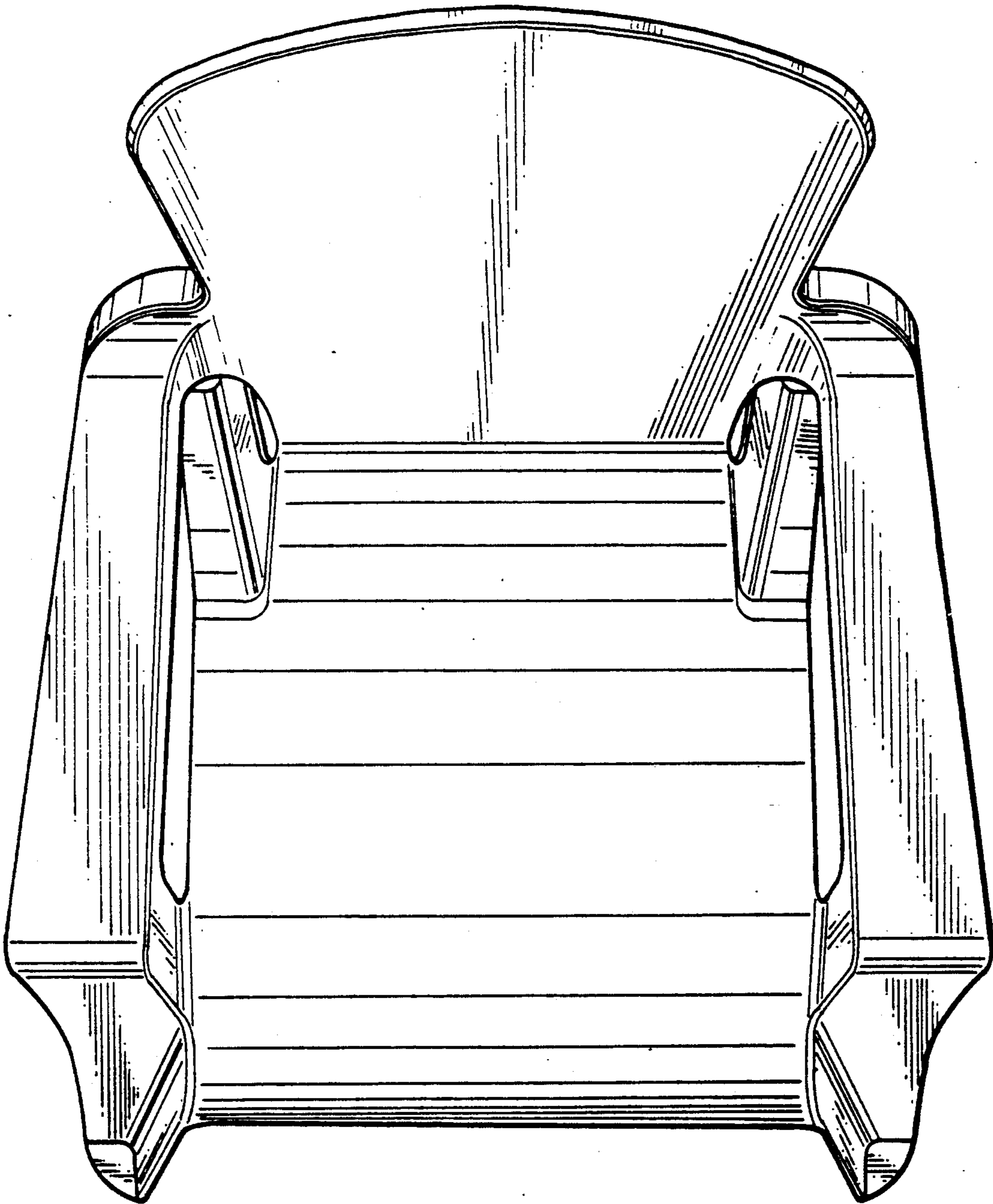

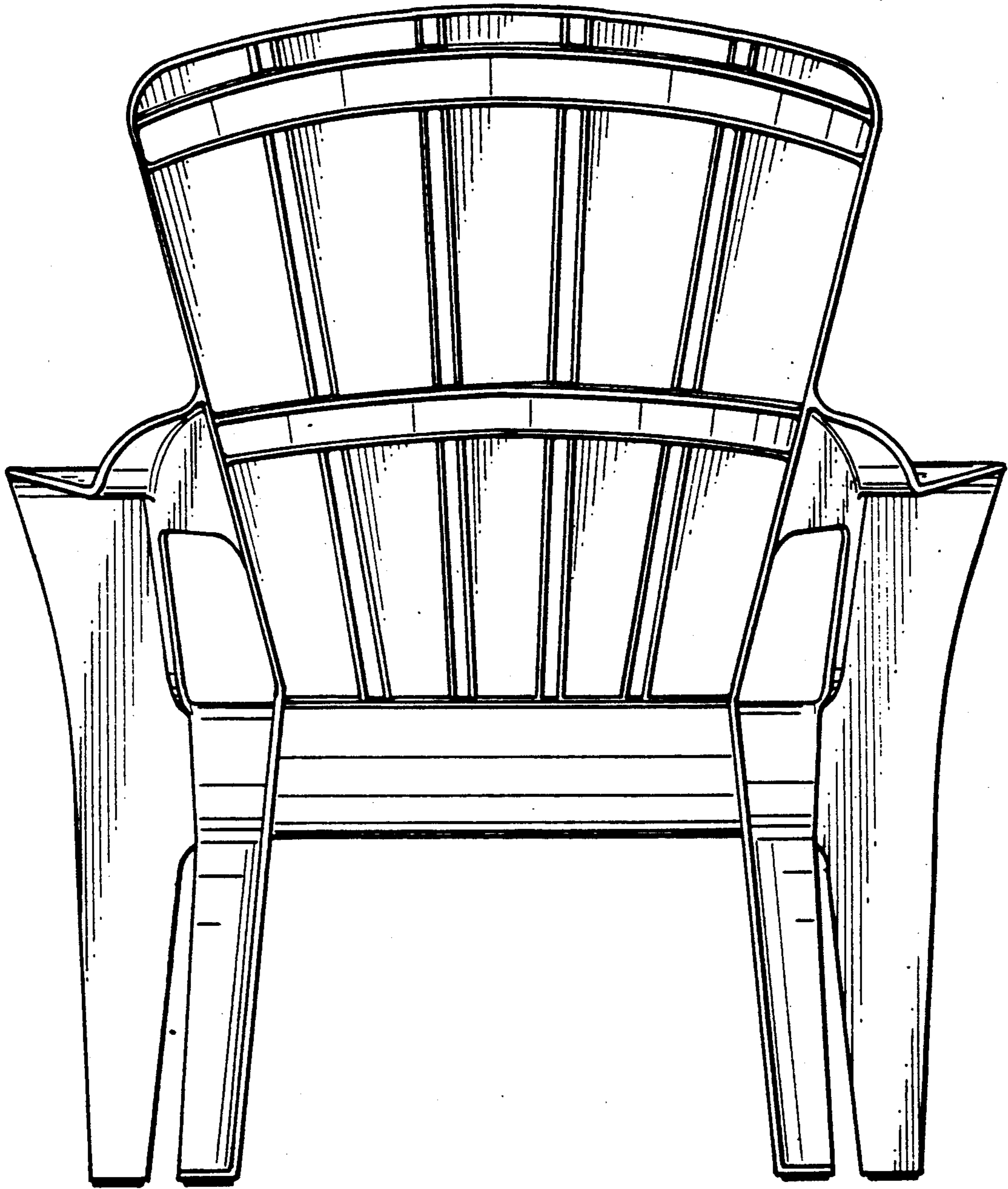
