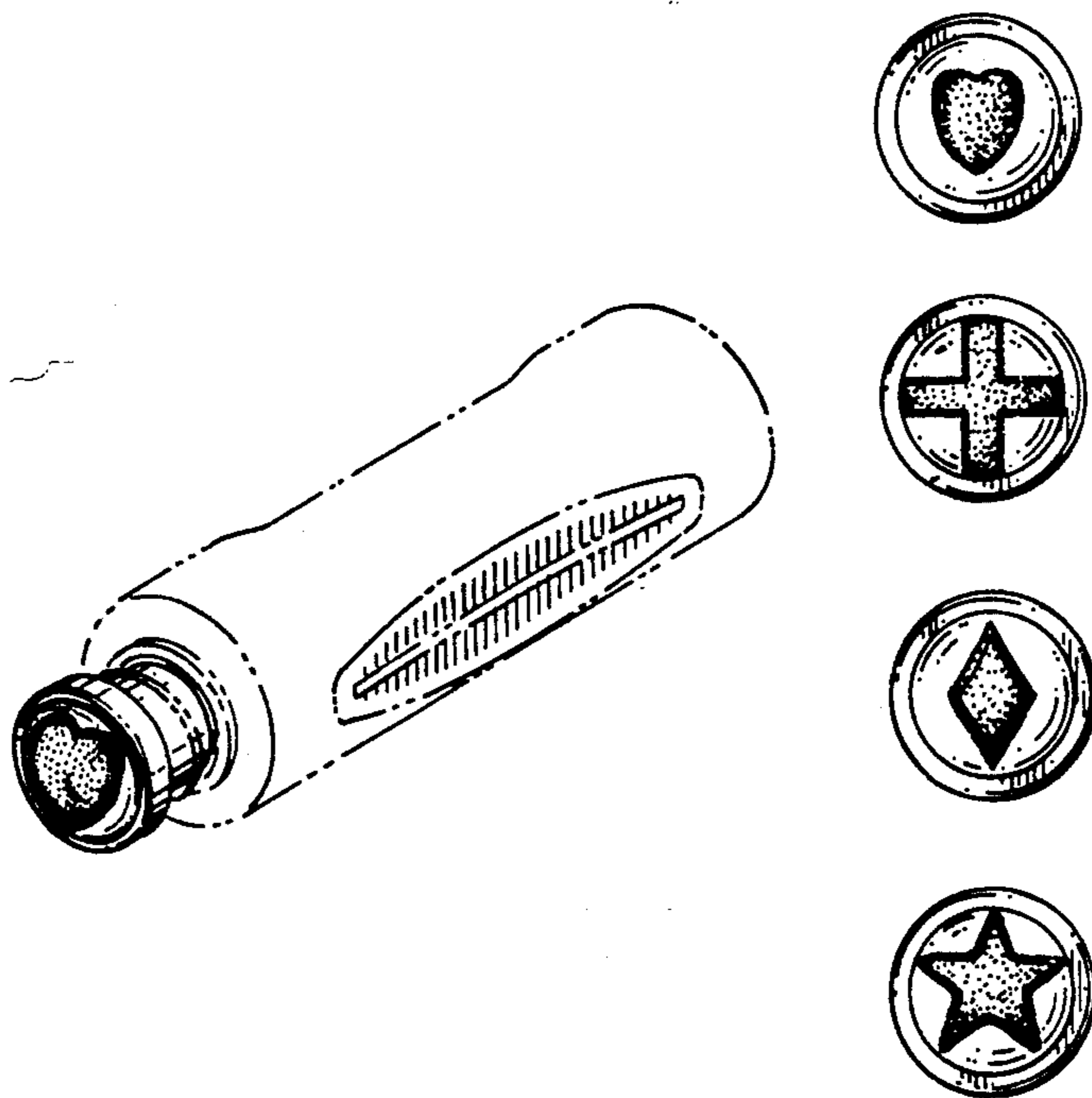

The ornamental design for an ink dauber, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of an ink dauber showing my new design;  
 FIG. 2 is a top plan view thereof;  
 FIG. 3 is a front elevational view thereof;  
 FIG. 4 is a right side elevational view thereof which is the mirror image of the left side;  
 FIG. 5 is a rear elevational view thereof;  
 FIG. 6 is a bottom plan view thereof;  
 FIG. 7 is a perspective view of a second embodiment of FIG. 1;  
 FIG. 8 is a top plan view of FIG. 7;  
 FIG. 9 is a perspective view of a third embodiment of FIG. 1;  
 FIG. 10 is a top plan view of FIG. 9;  
 FIG. 11 is a perspective view of a fourth embodiment of FIG. 1;  
 FIG. 12 is a top plan view of FIG. 11;  
 FIG. 13 is a perspective view of a fifth embodiment of FIG. 1; and  
 FIG. 14 is a top plan view of FIG. 13.  
 The broken lines in FIG. 1 are for purposes of illustration only and form no part of the claimed design.



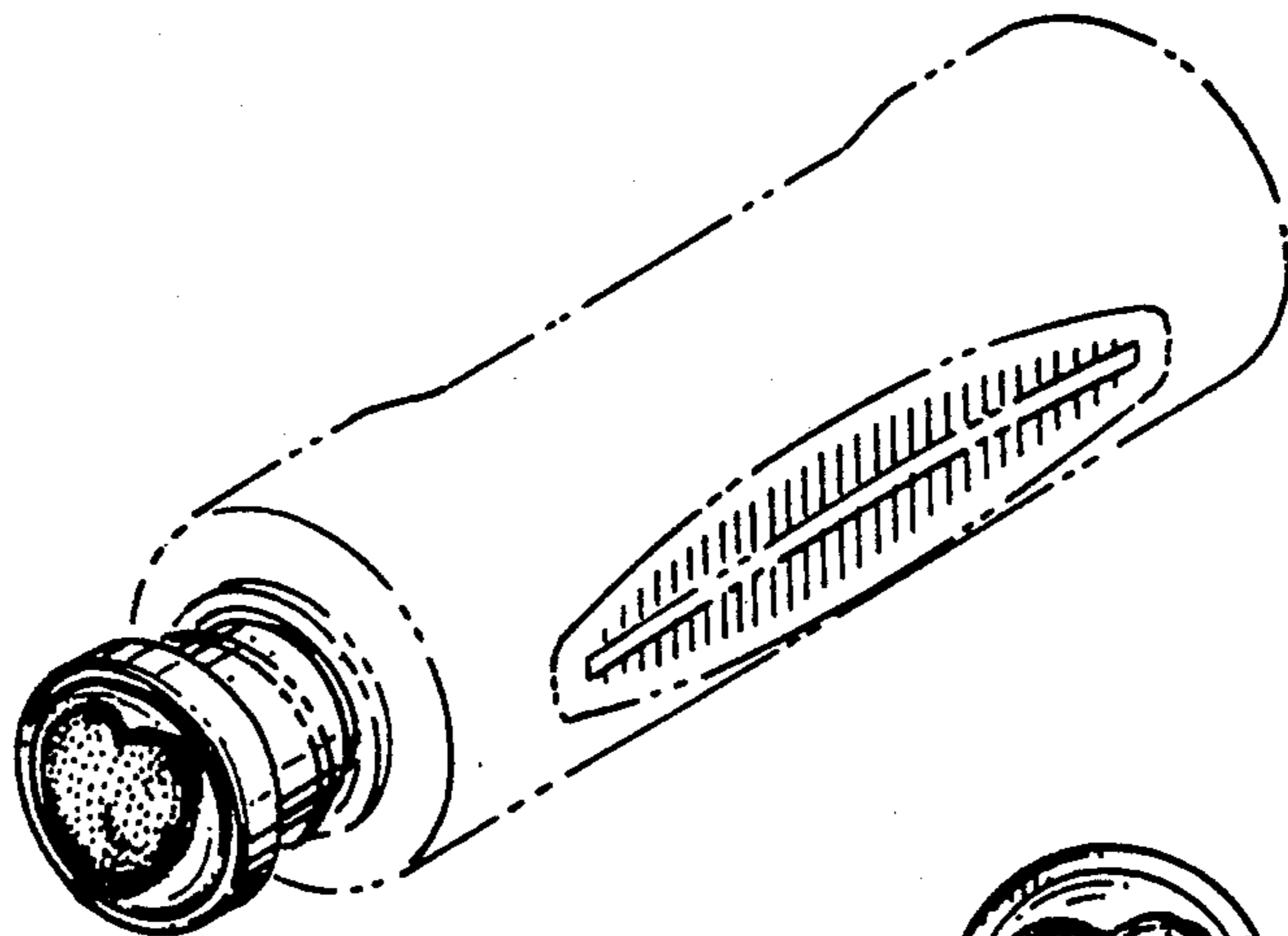

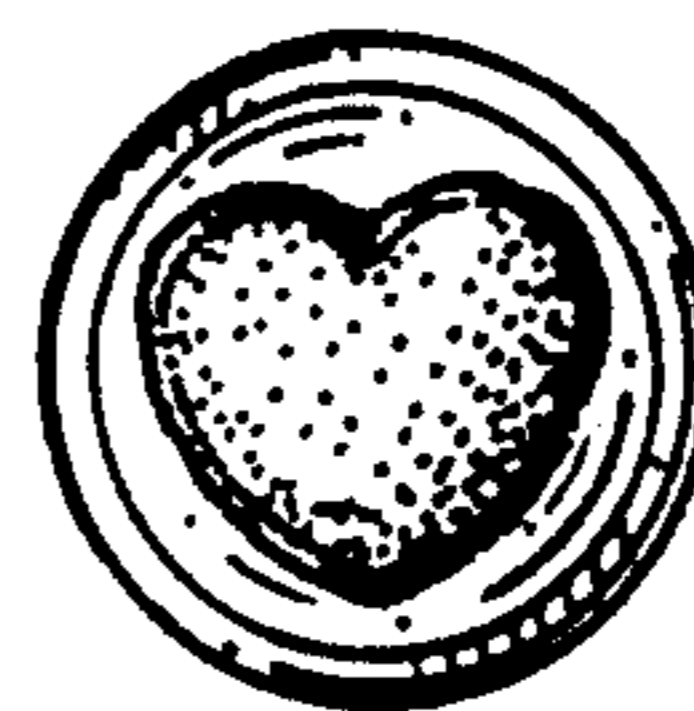

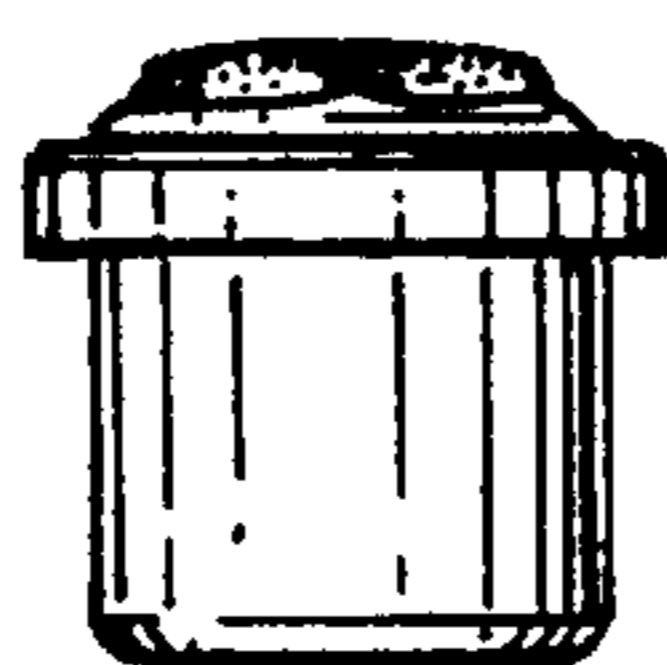

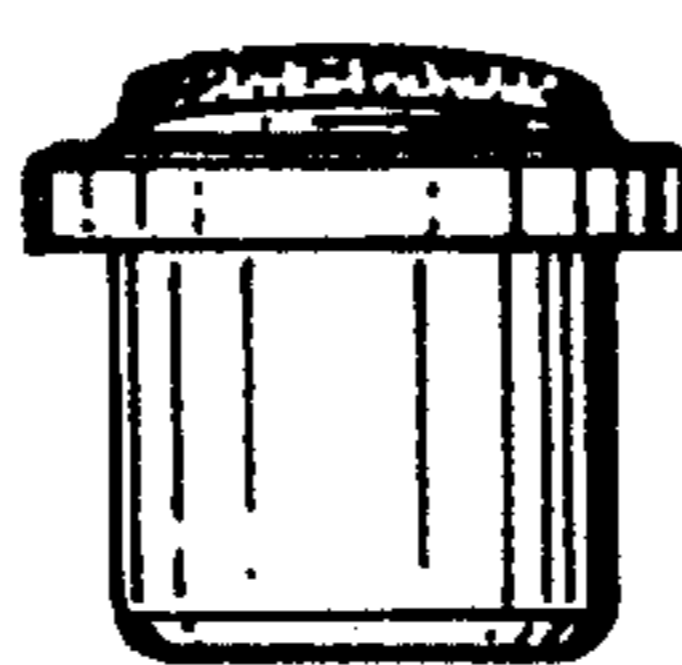

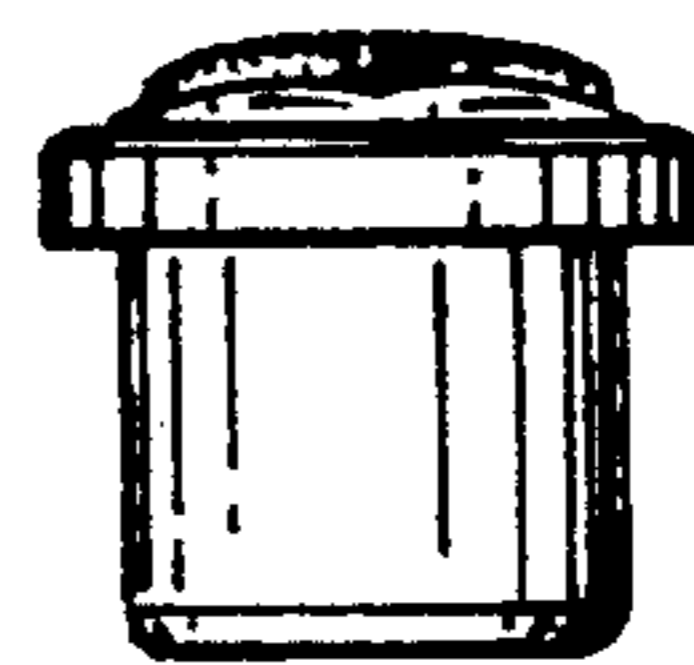

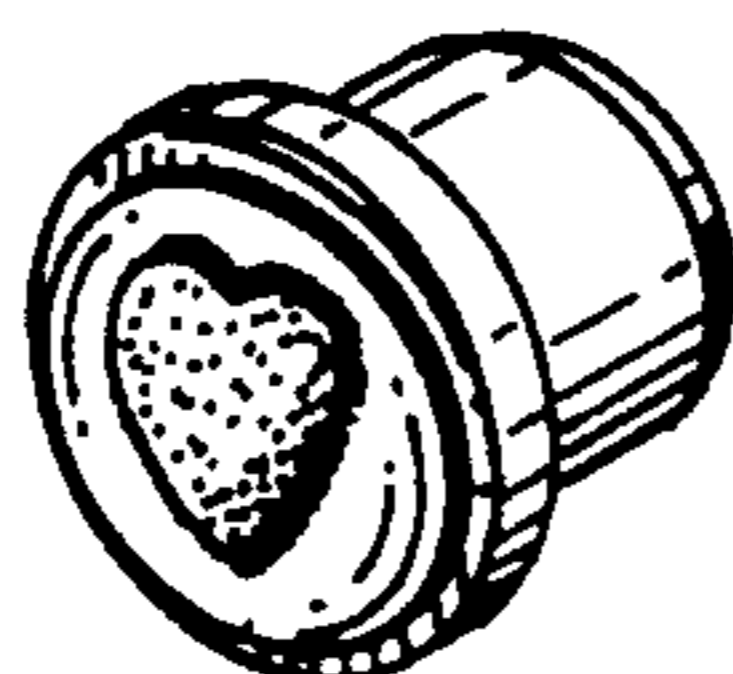

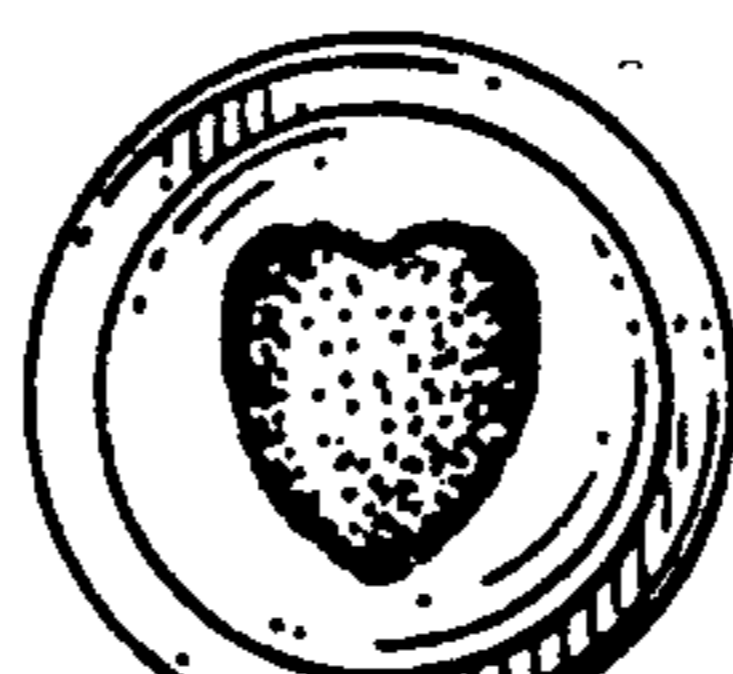

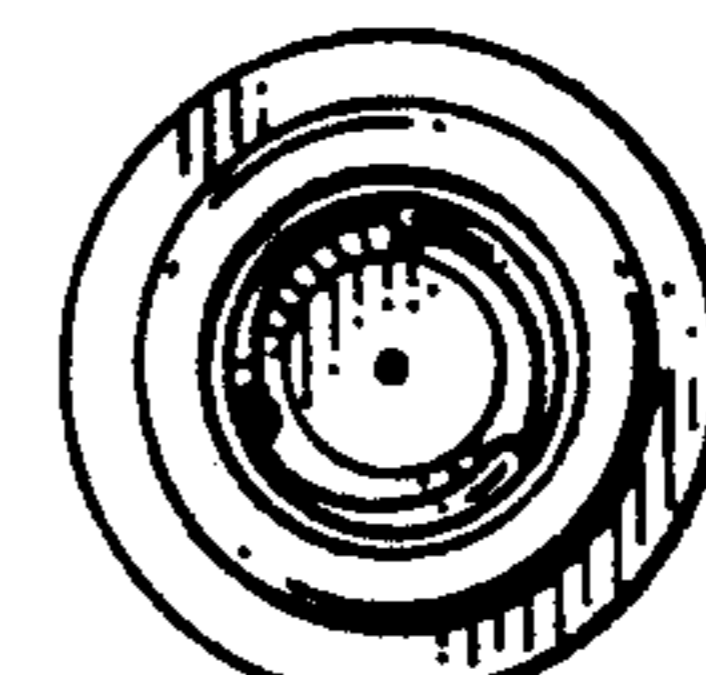

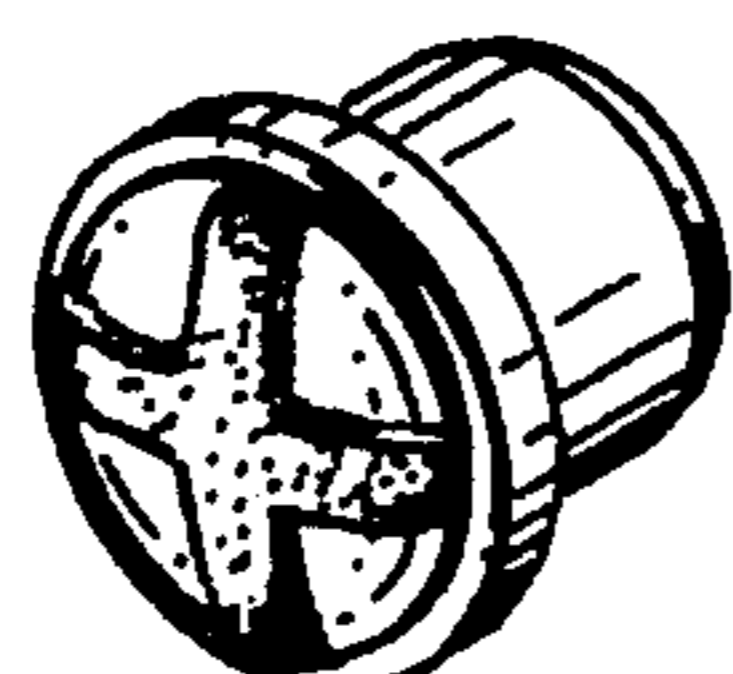

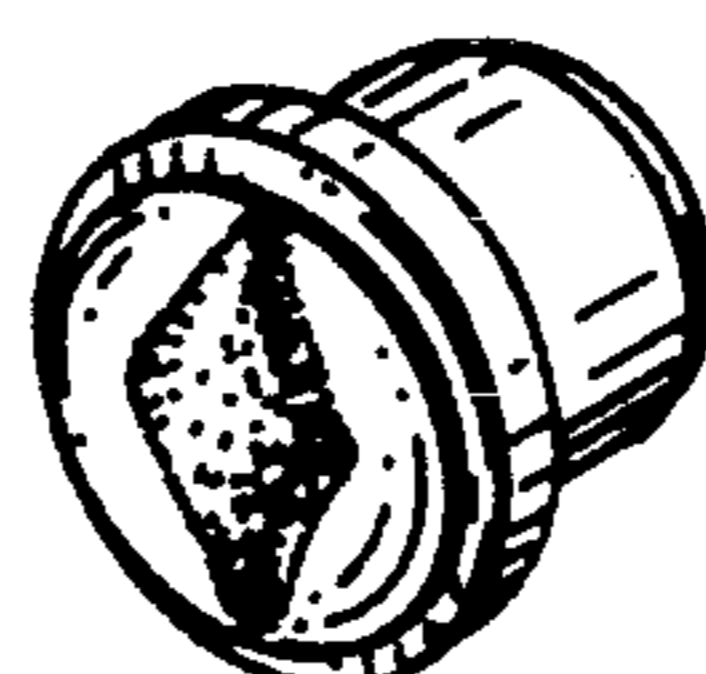

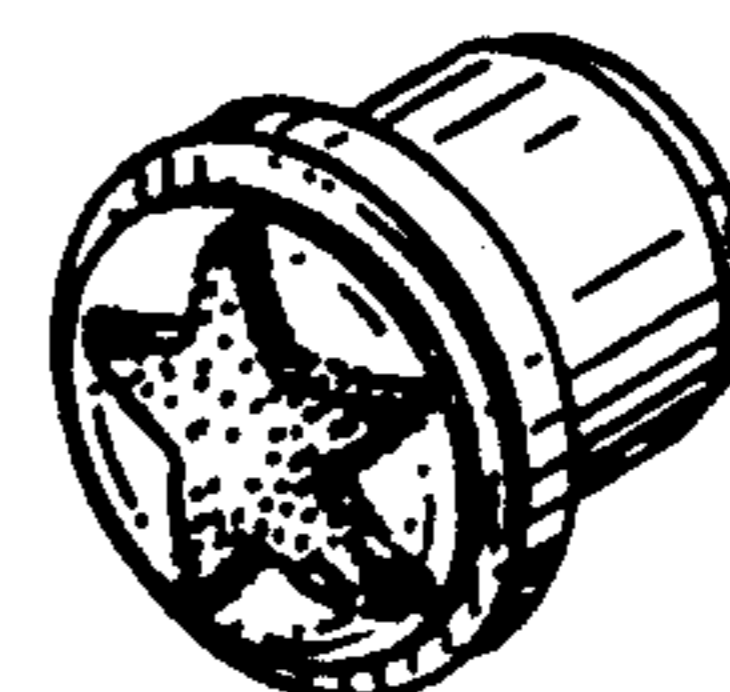

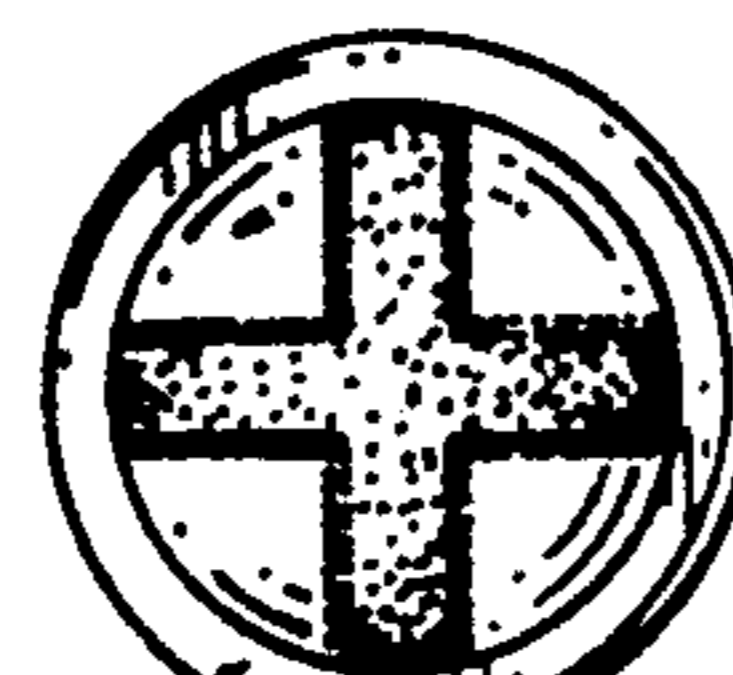

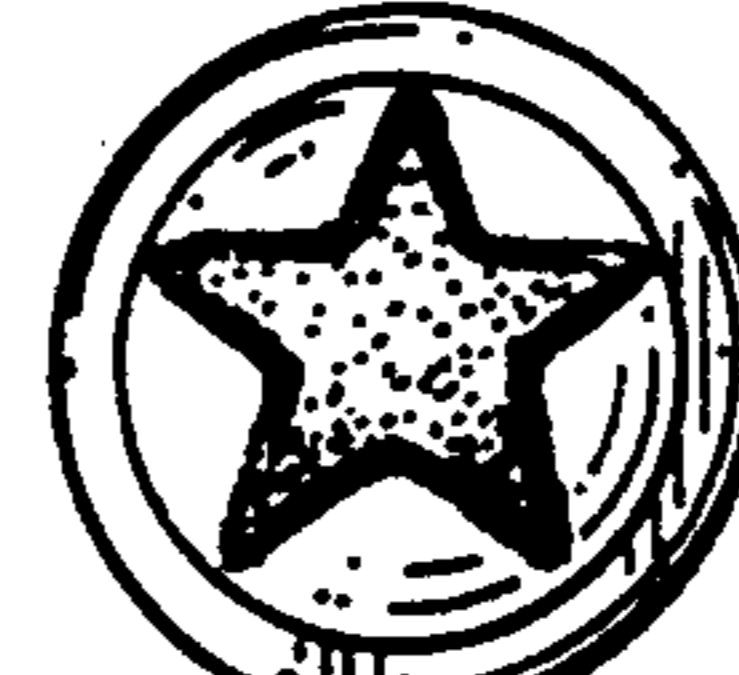
