[57] **CLAIM**

The ornamental design for baby bottle bank, as shown.

DESCRIPTION

FIG. 1 is a front elevational view of a baby bottle bank showing my new design;
FIG. 2 is a rear elevational view thereof, the left and right sides being same as the rear;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a front elevation view of the upper part of the cap portion of the baby bottle bank;
FIG. 6 is a rear elevation view thereof, the left and right elevation views being identical to the shown;
FIG. 7 is a top plan view thereof;
FIG. 8 is a bottom plan view thereof;
FIG. 9 is a front elevational view of the lower part of the cap portion of the baby bottle bank, the rear, left and right elevation views being identical to that shown;
FIG. 10 is a top plan view thereof;
FIG. 11 is a bottom plan view thereof;
FIG. 12 is a front elevation view of the intermediate portion of the baby bottle bank, the rear, left and right elevation views being identical to that shown;
FIG. 13 is a top plan view thereof, the bottom plan view being identical to that shown;
FIG. 14 is a front elevation view of the base portion of the baby bottle bank, the rear, left and right elevation views being identical to that shown;
FIG. 15 is a top plan view thereof; and,
FIG. 16 is a bottom plan view thereof.

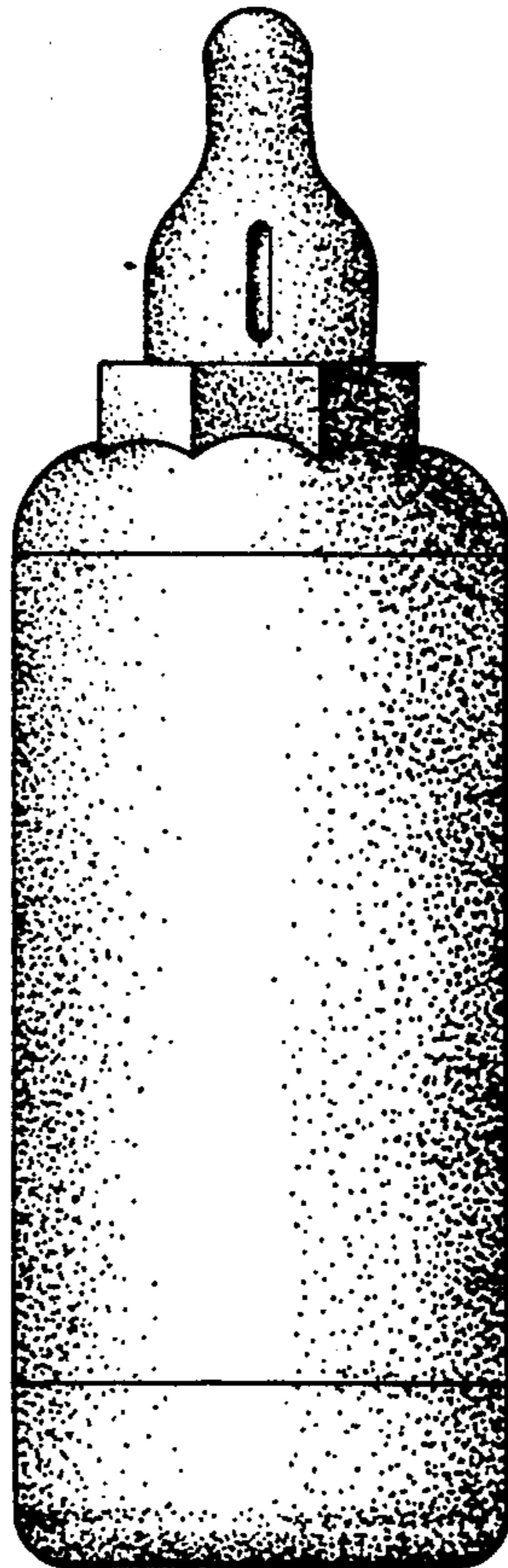

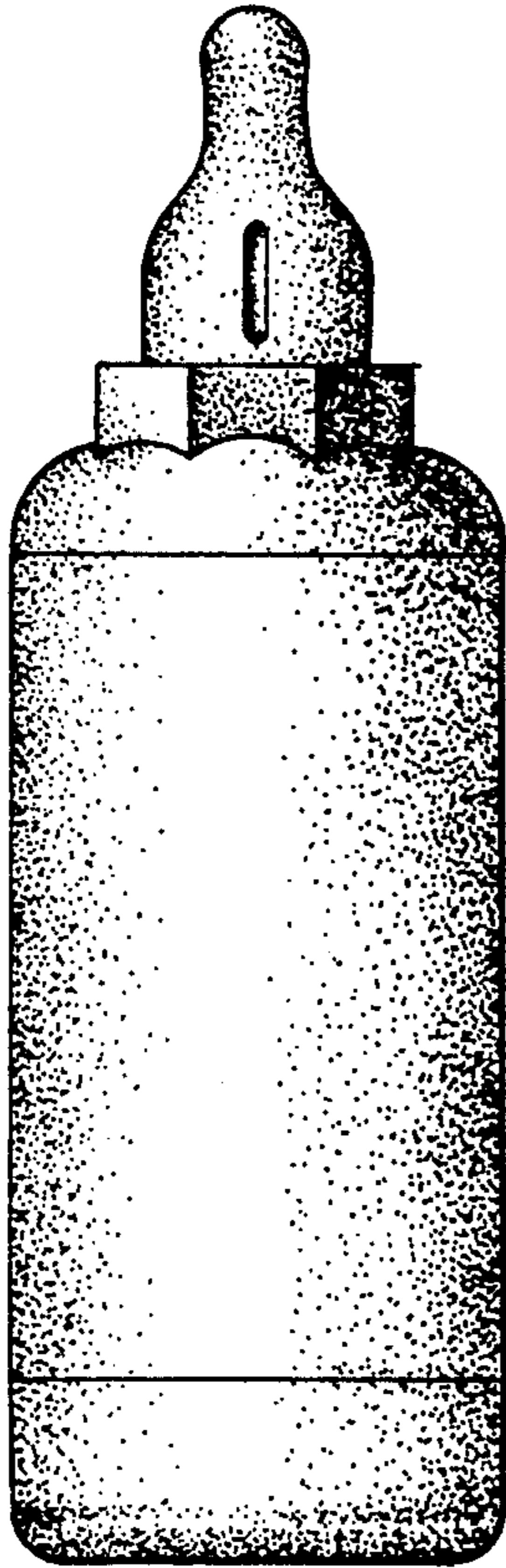

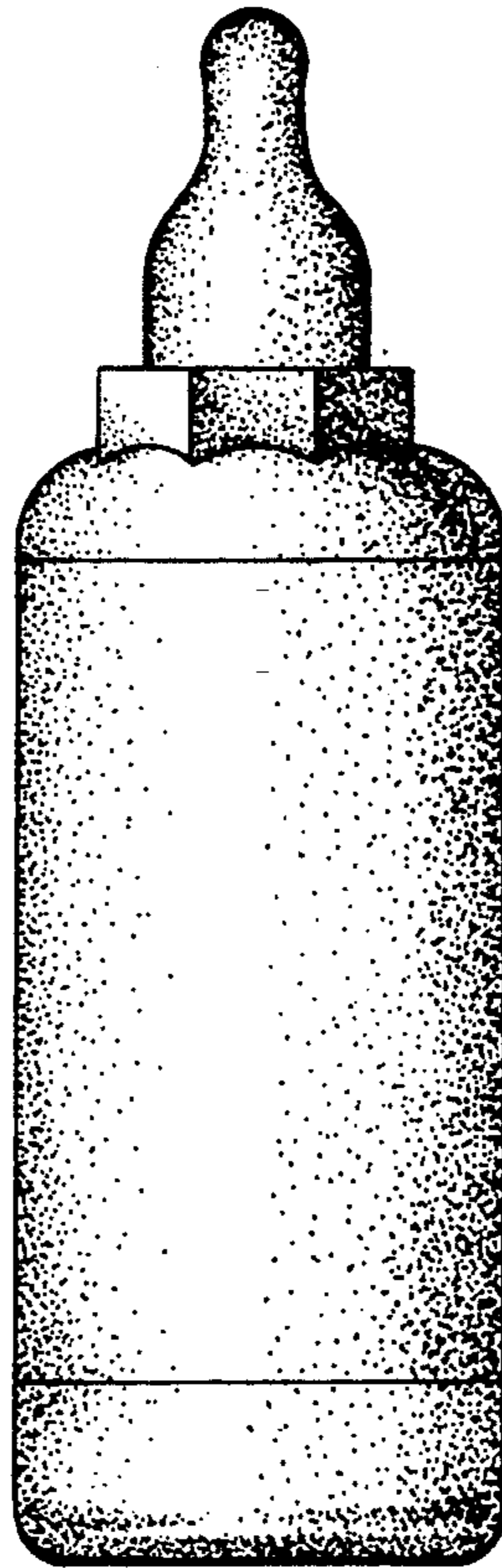

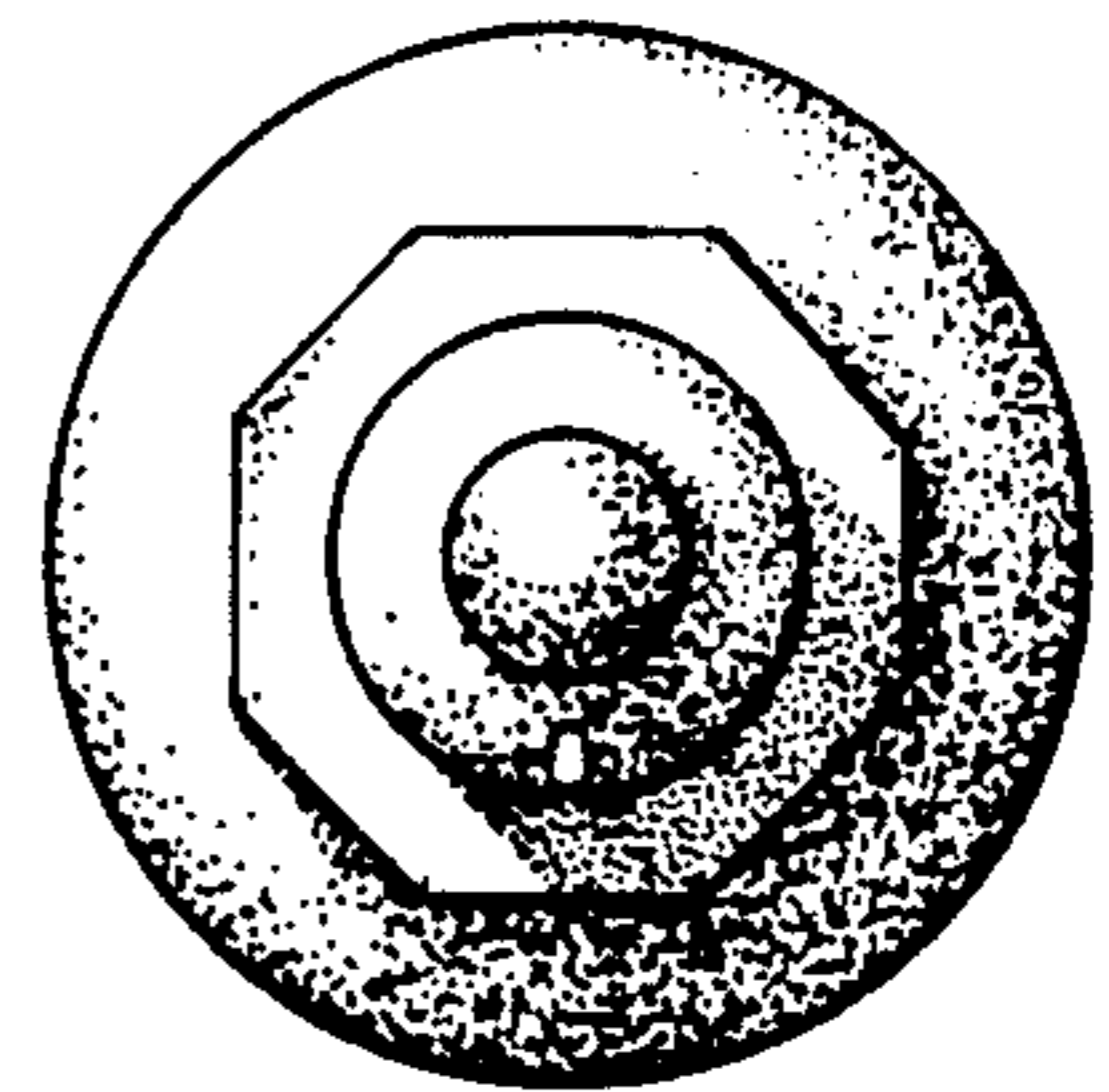

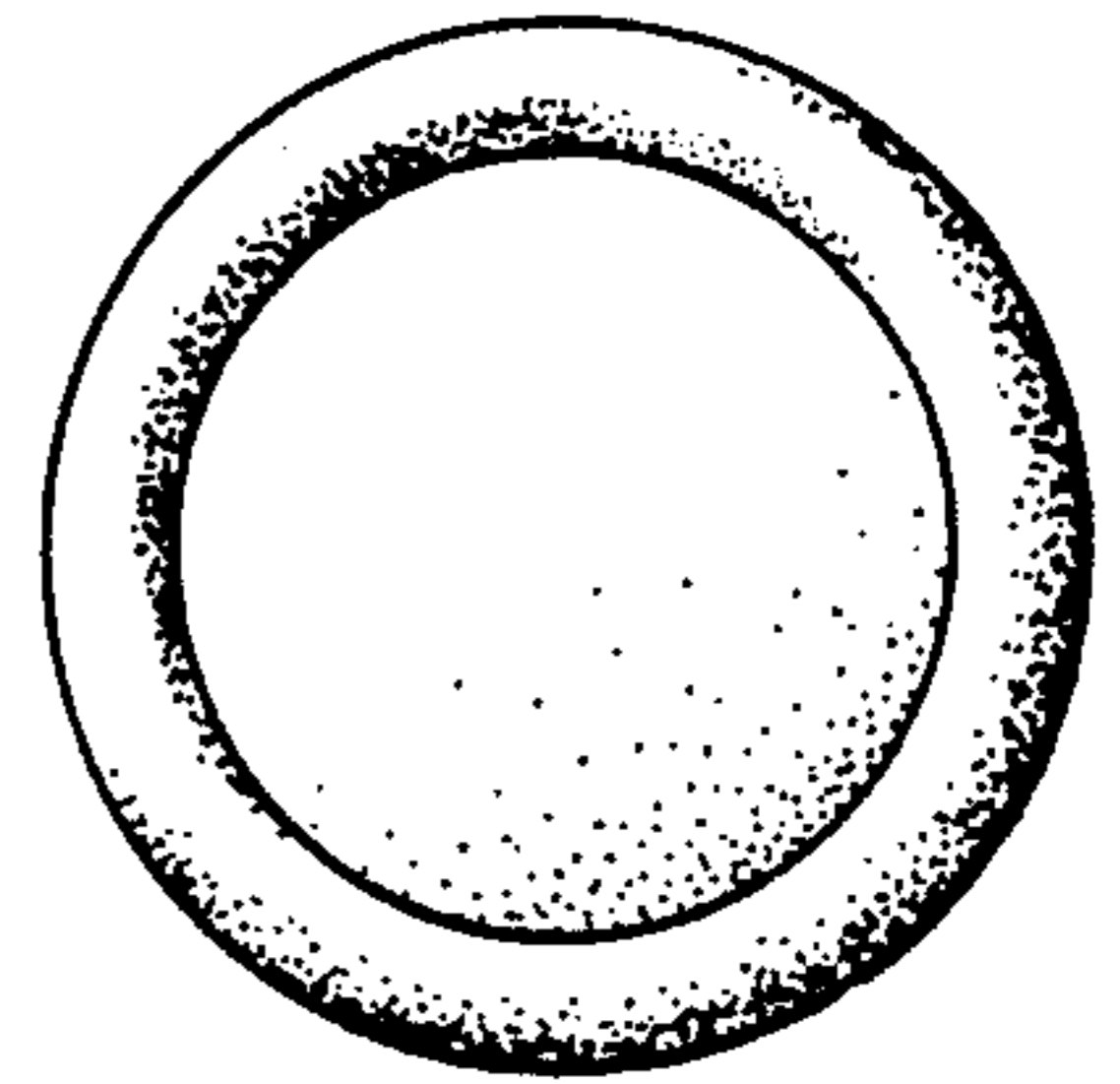

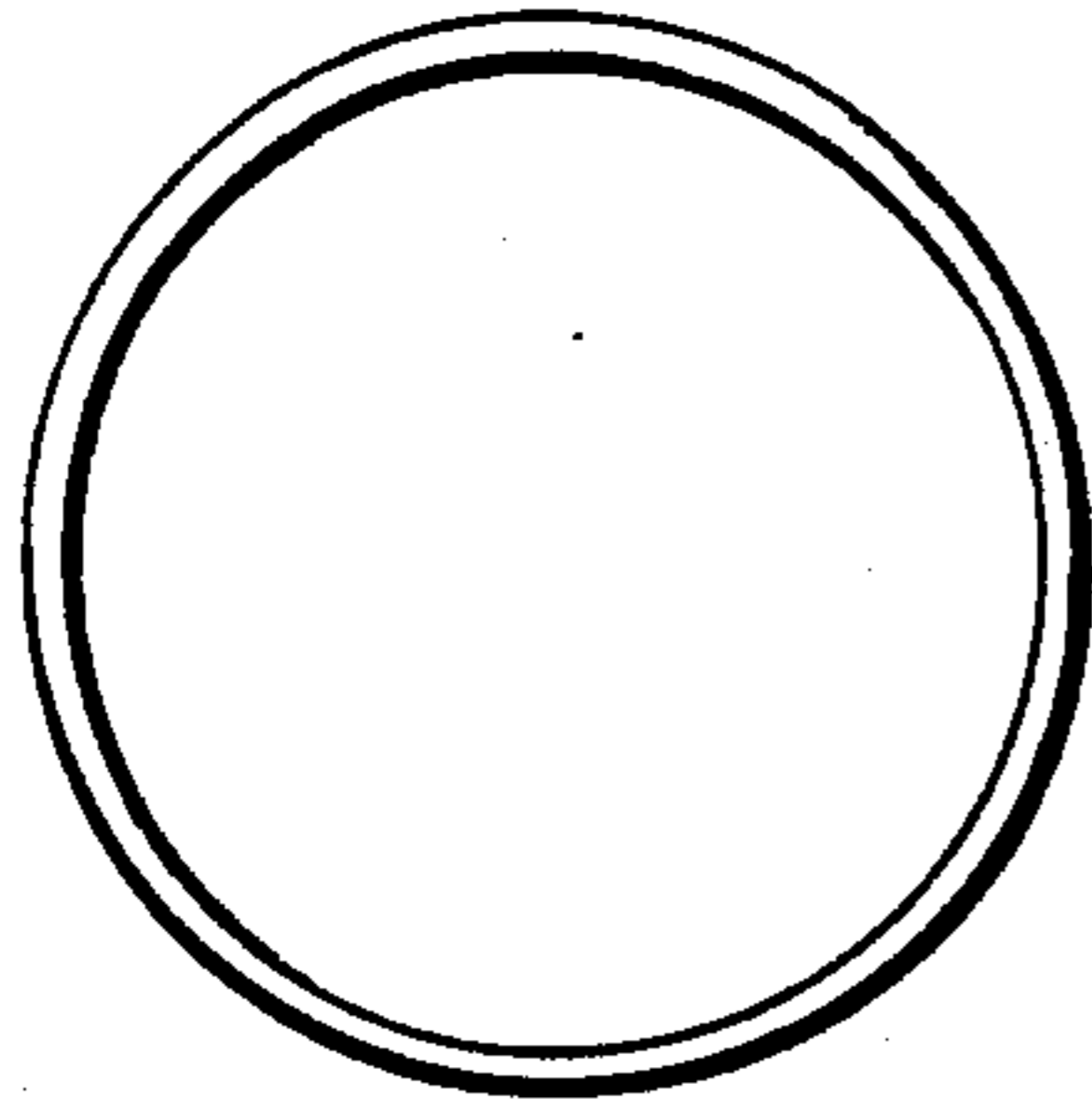

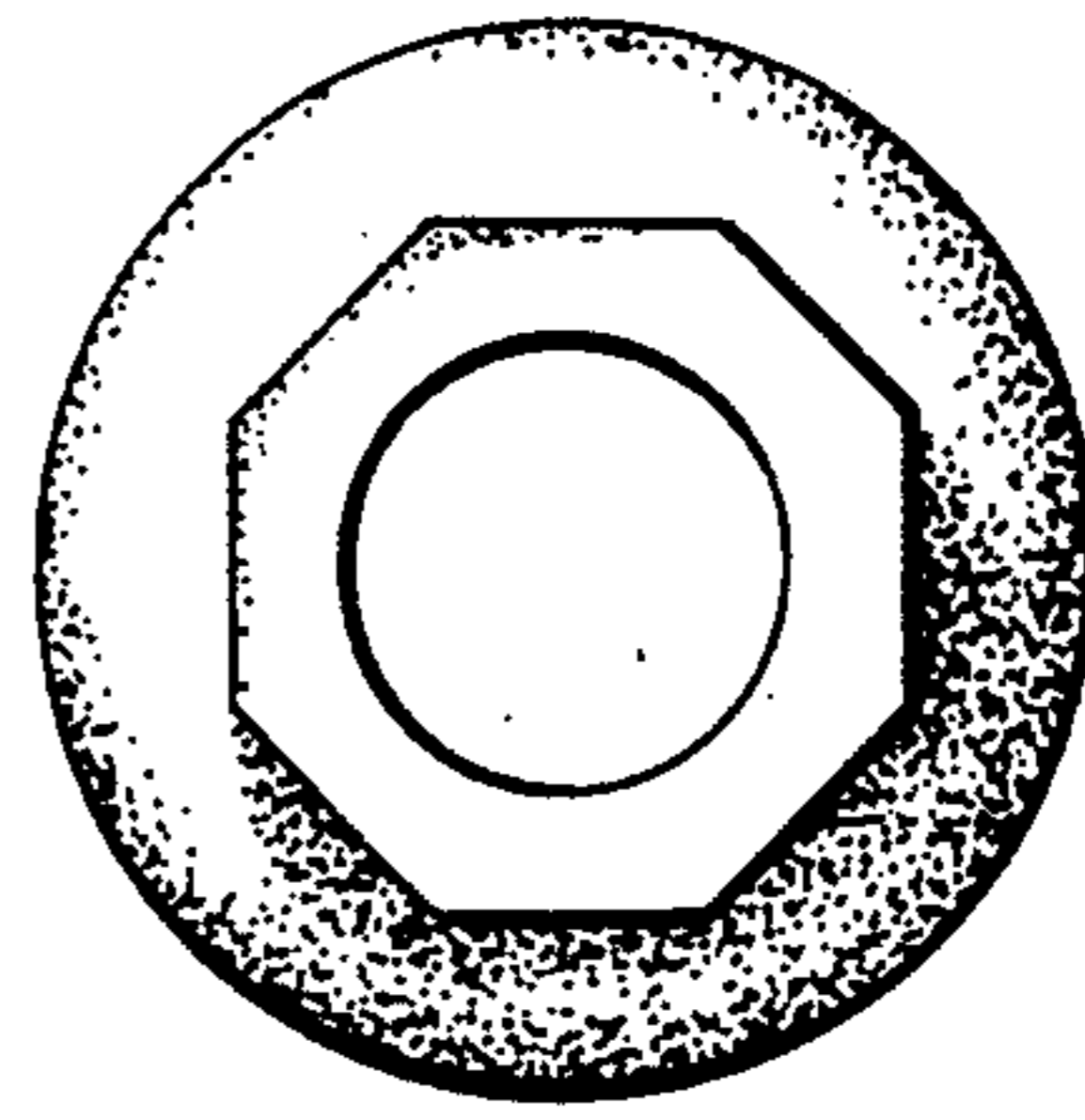

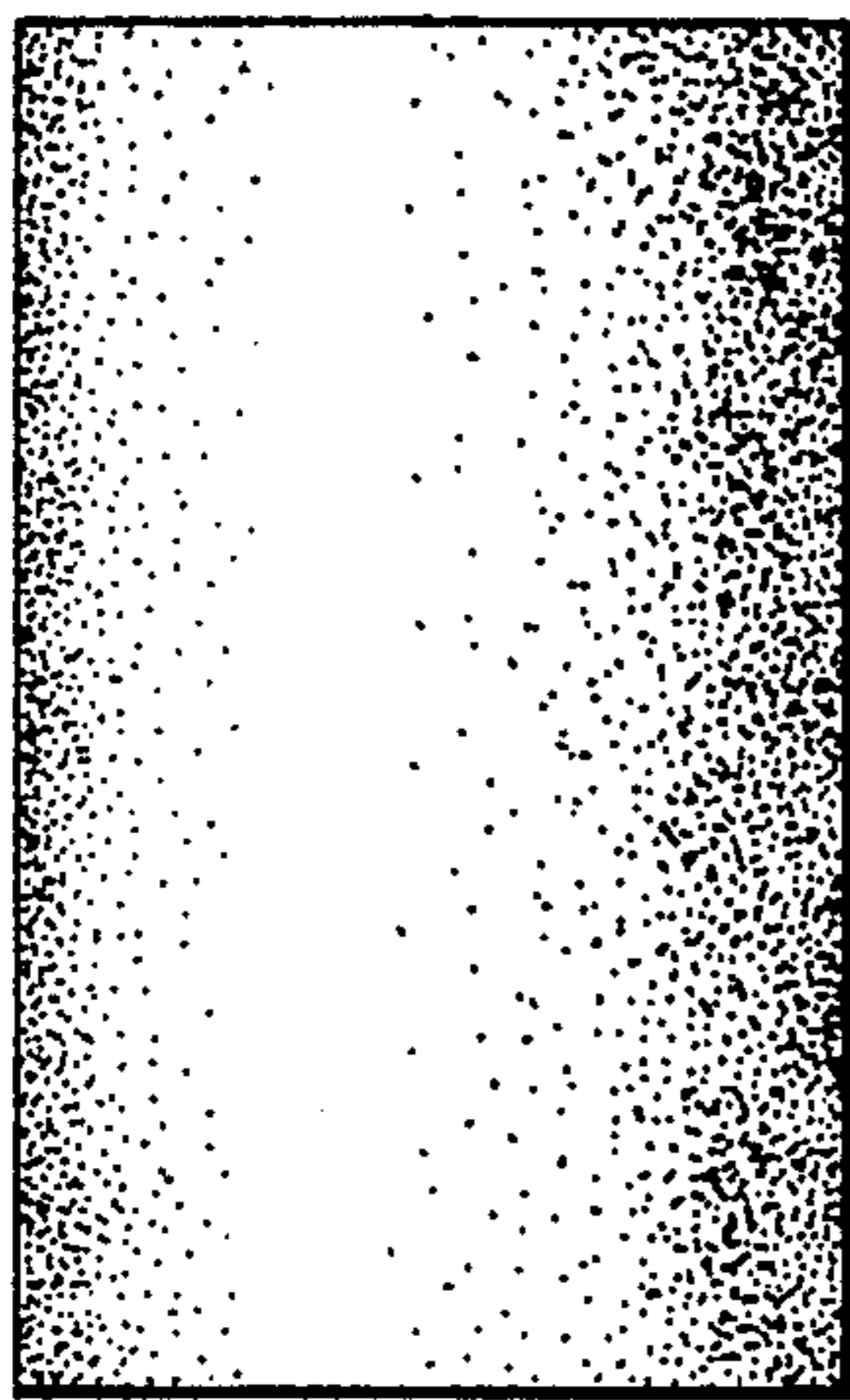

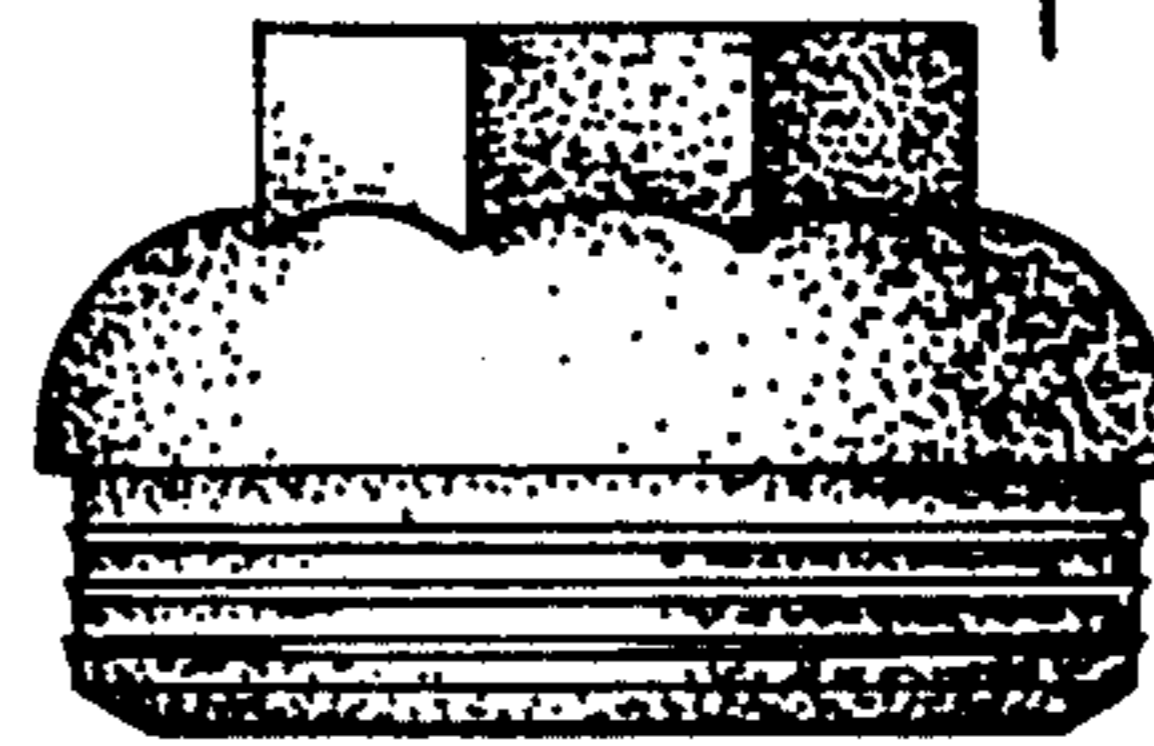

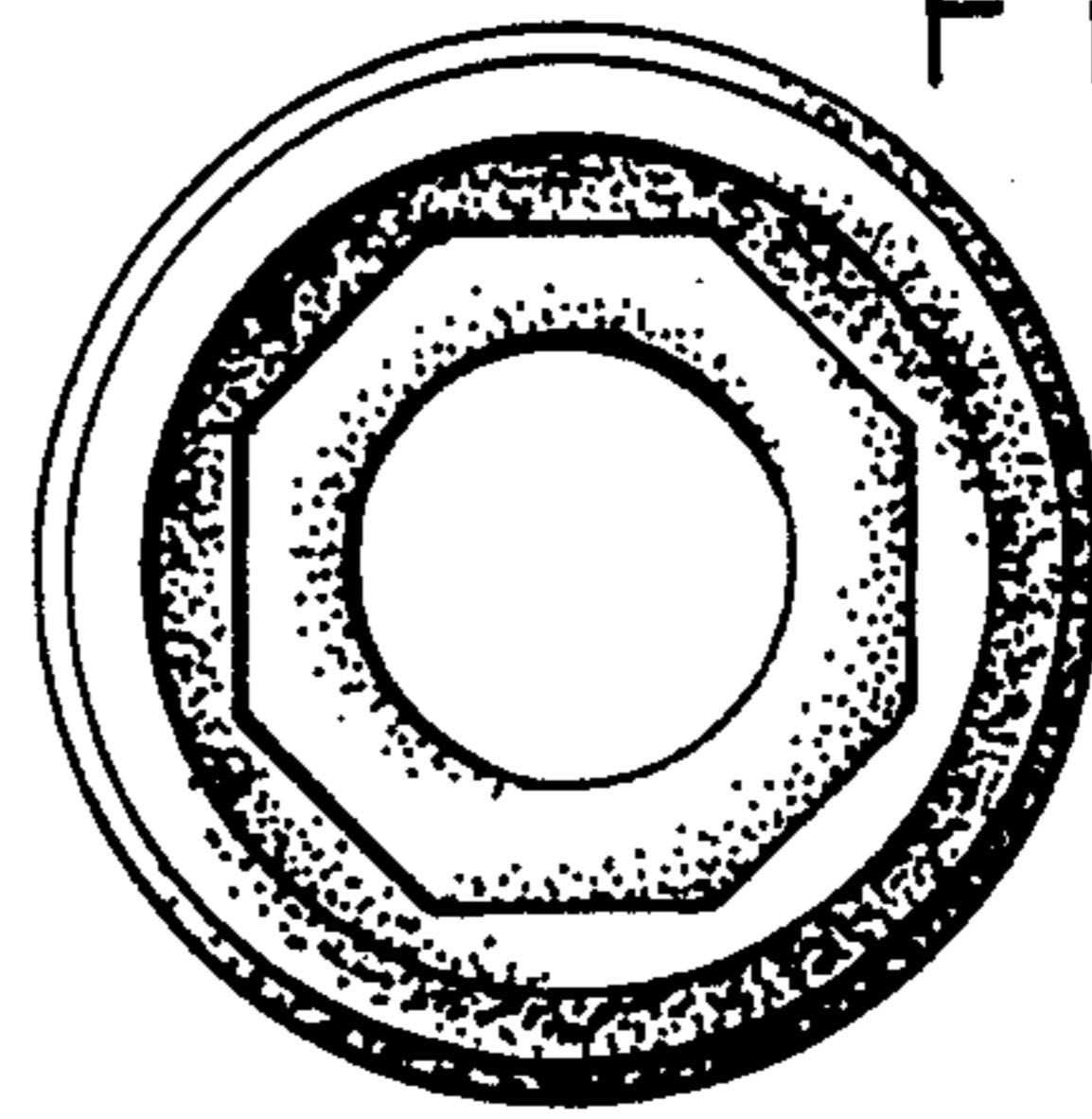

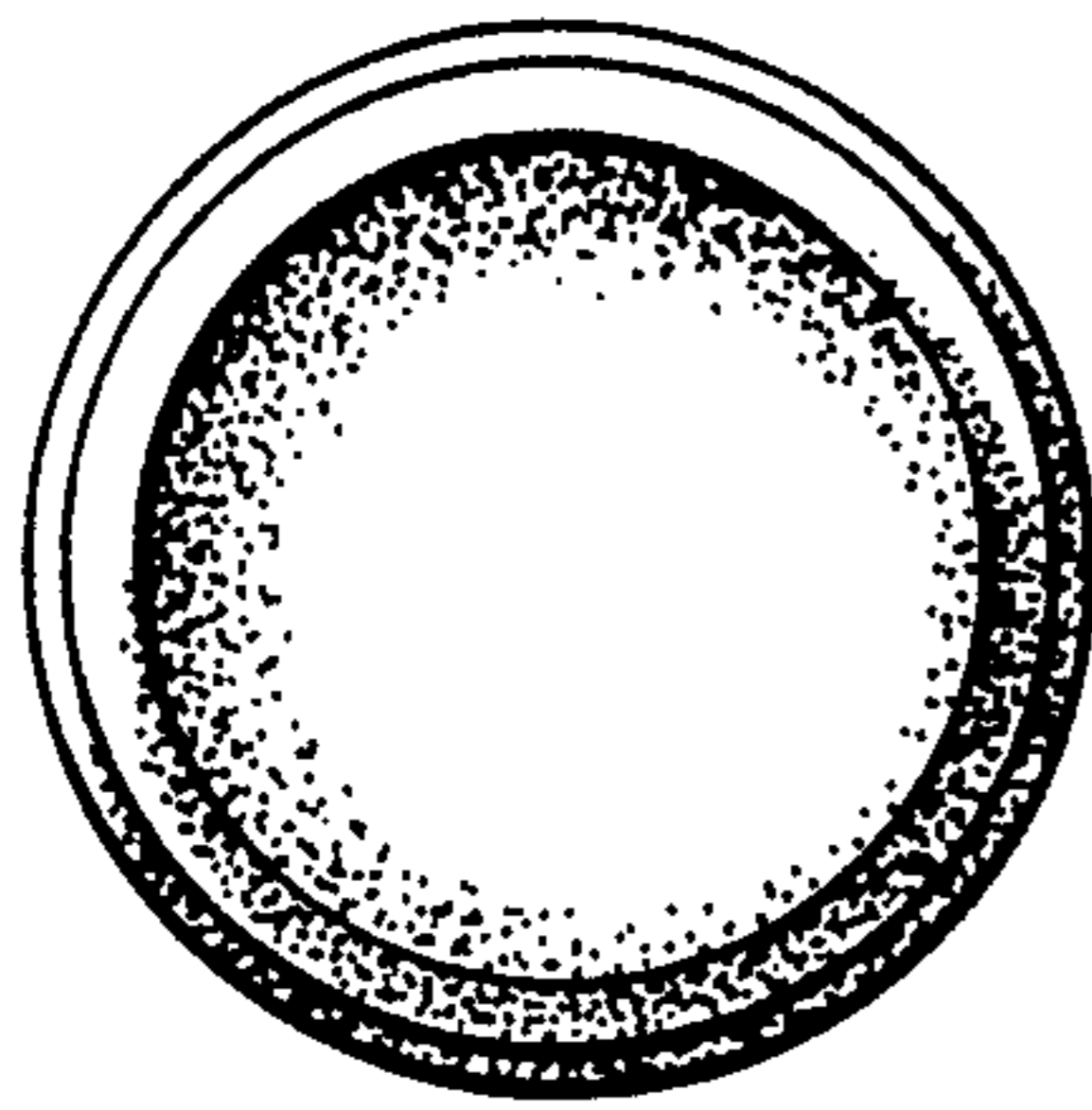

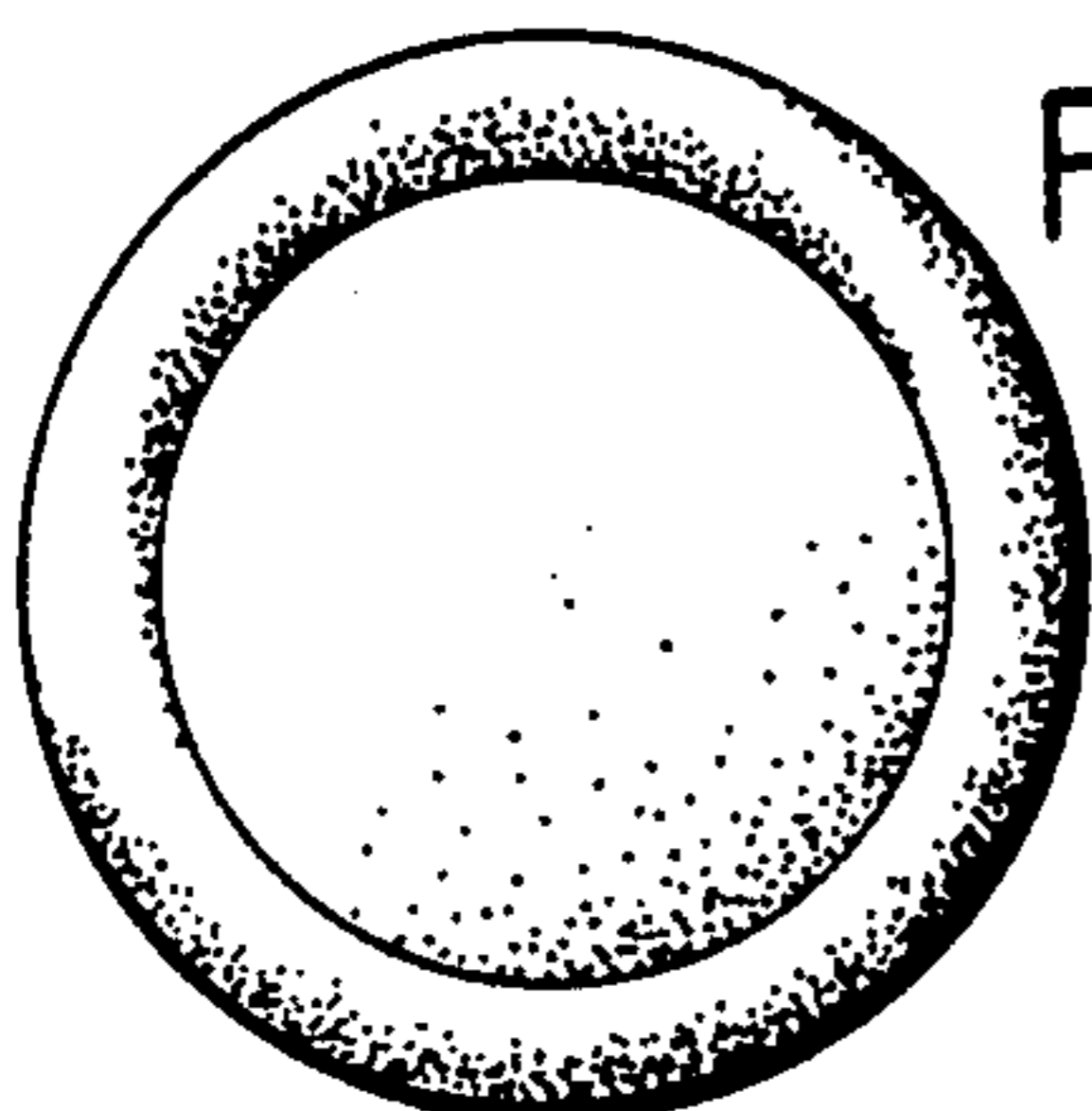
