[57] **CLAIM**

The ornamental design for a medical storage rack for holding sterile surgical instruments, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a medical storage rack for holding sterile surgical instruments, showing our new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a side elevational view thereof;
FIG. 6 is a side elevational view thereof, opposite that shown in FIG. 5; and,
FIG. 7 is a bottom plan view thereof.

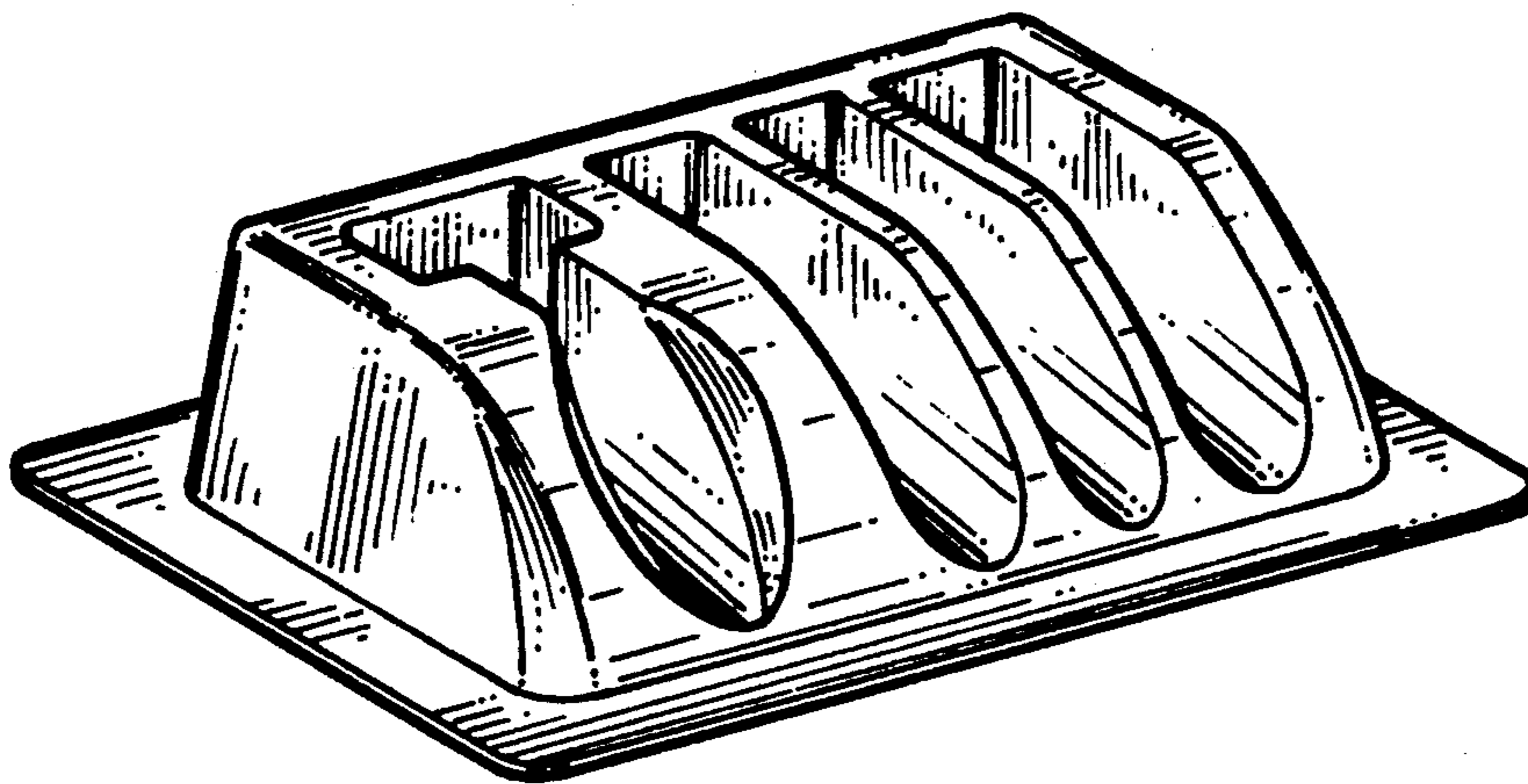

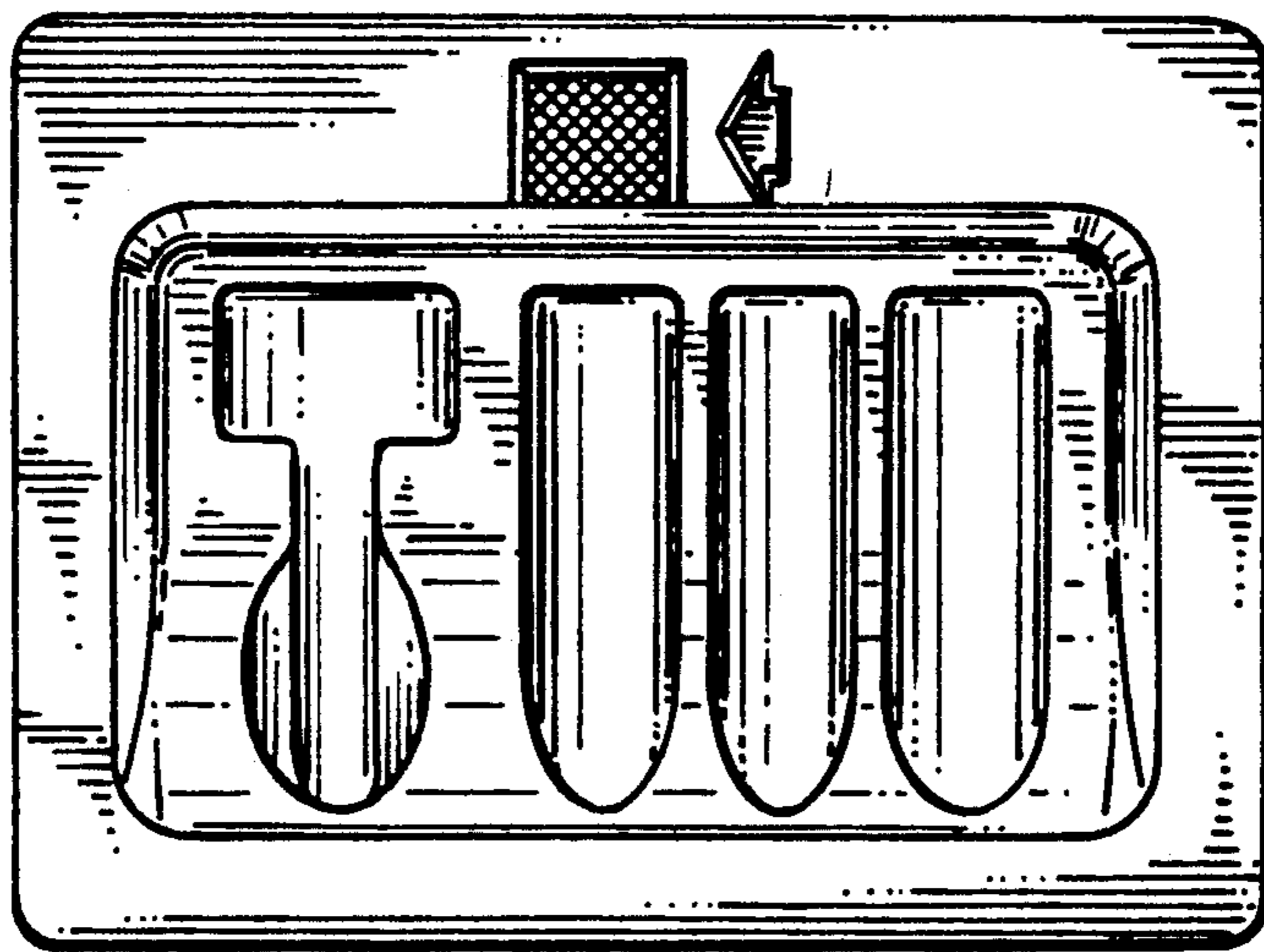
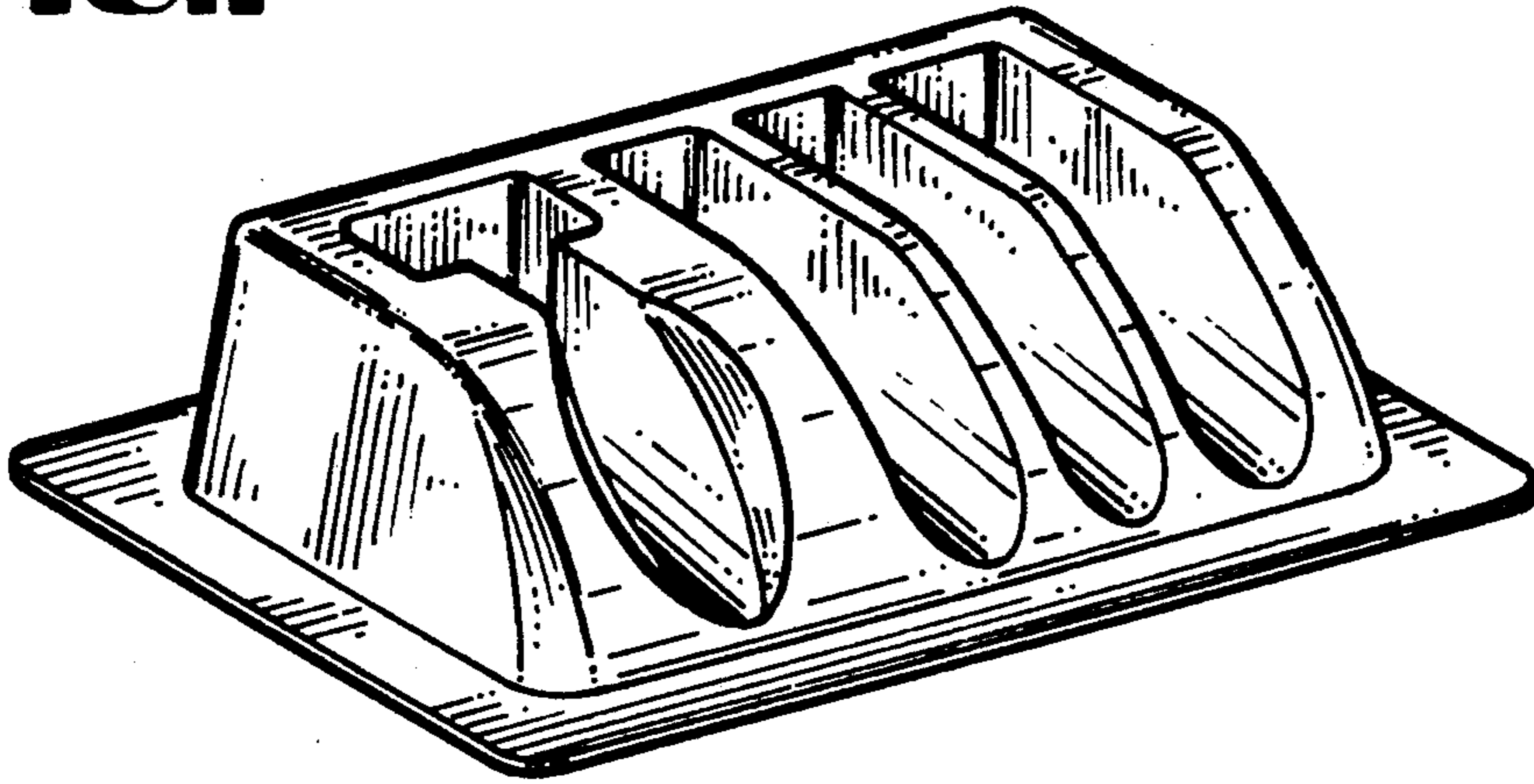

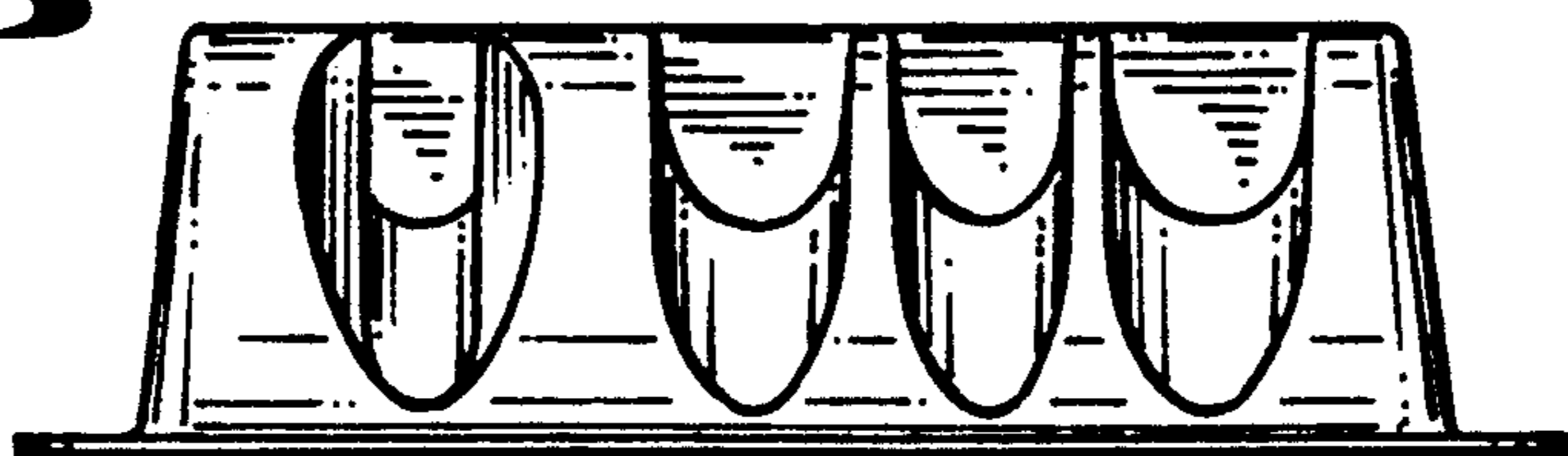

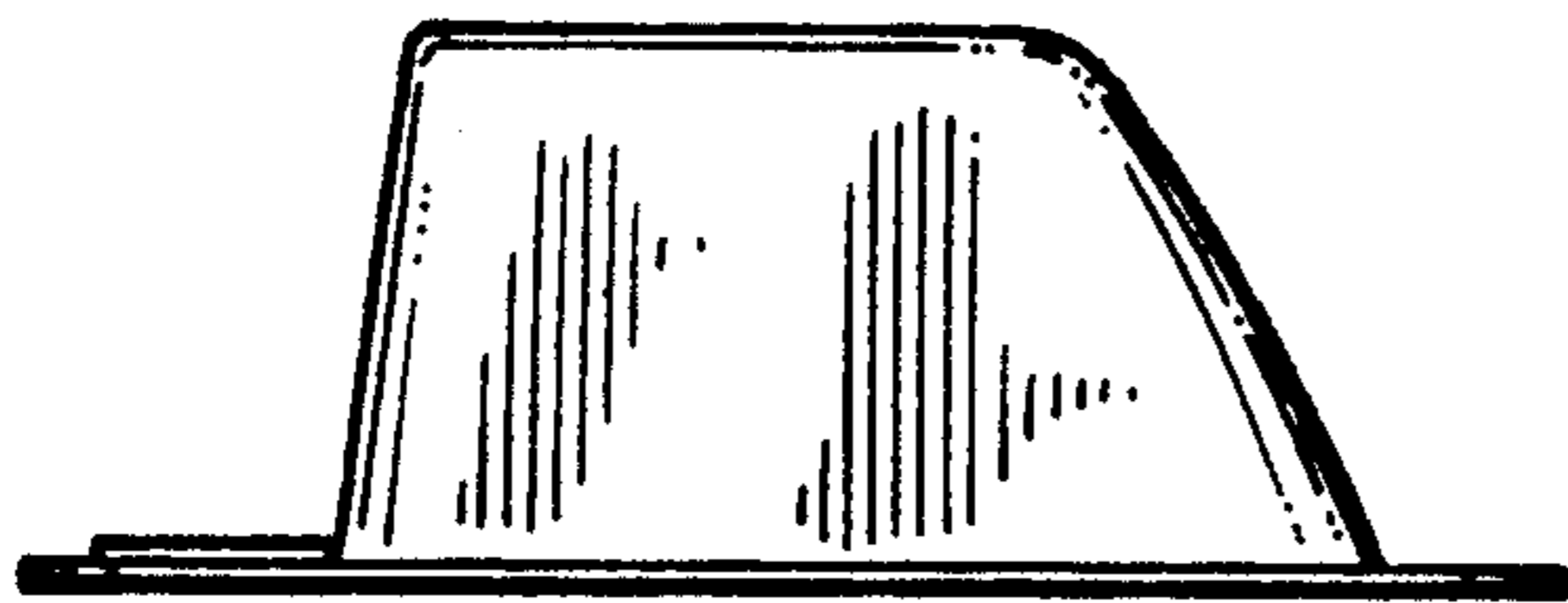
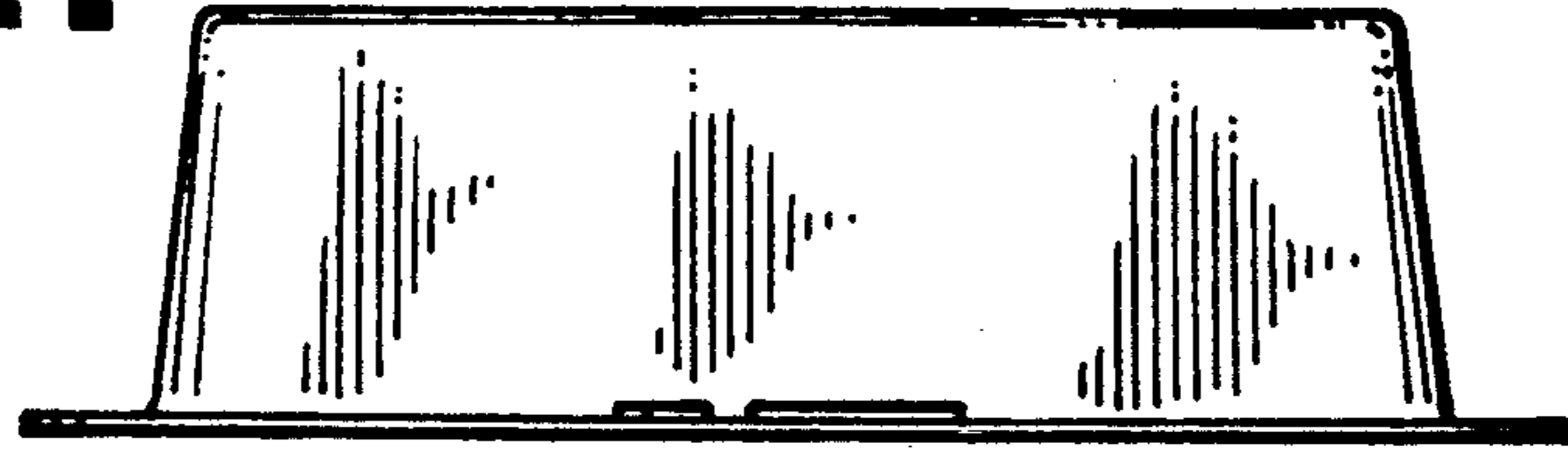

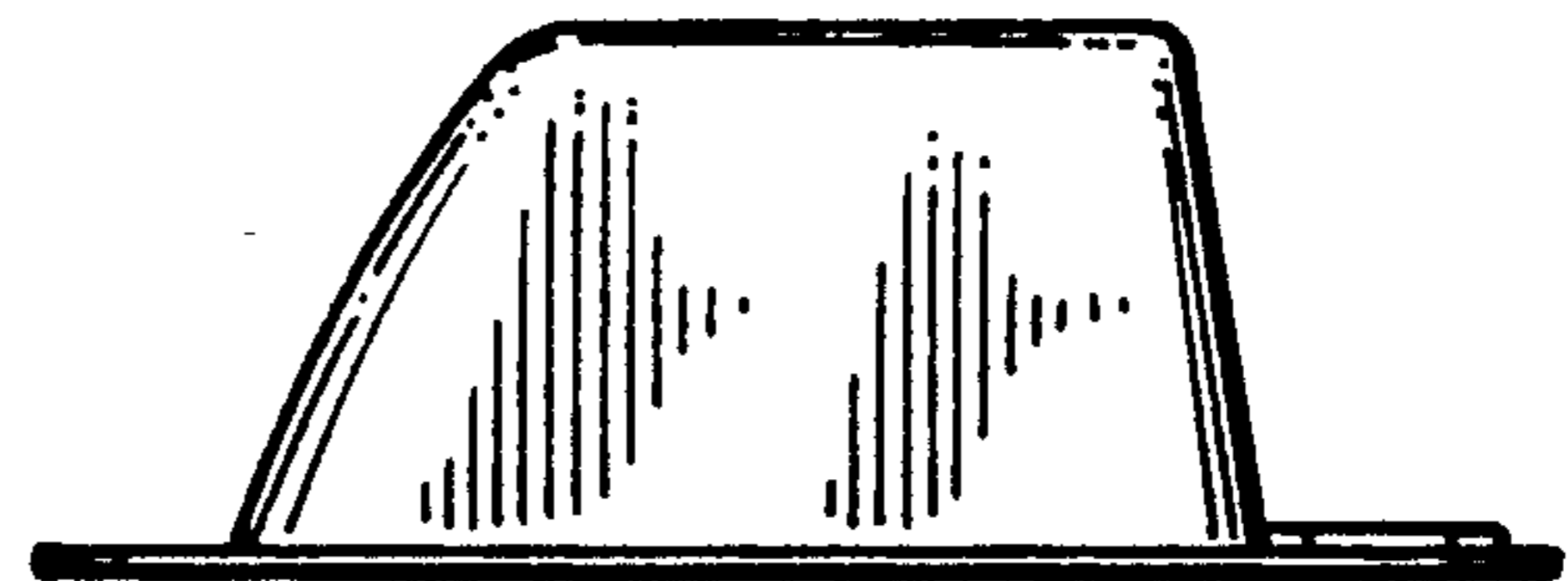
