[57] **CLAIM**

The ornamental design for a cuticle pusher, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cuticle pusher showing my new design;

FIG. 2 is a side elevational view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is an elevational view of the side opposite that shown in FIG. 2;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a right end elevational view thereof;

FIG. 7 is a left end elevational view thereof;

FIG. 8 is a perspective view of a second modified embodiment;

FIG. 9 is a side elevational view thereof;

FIG. 10 is a top plan view thereof;

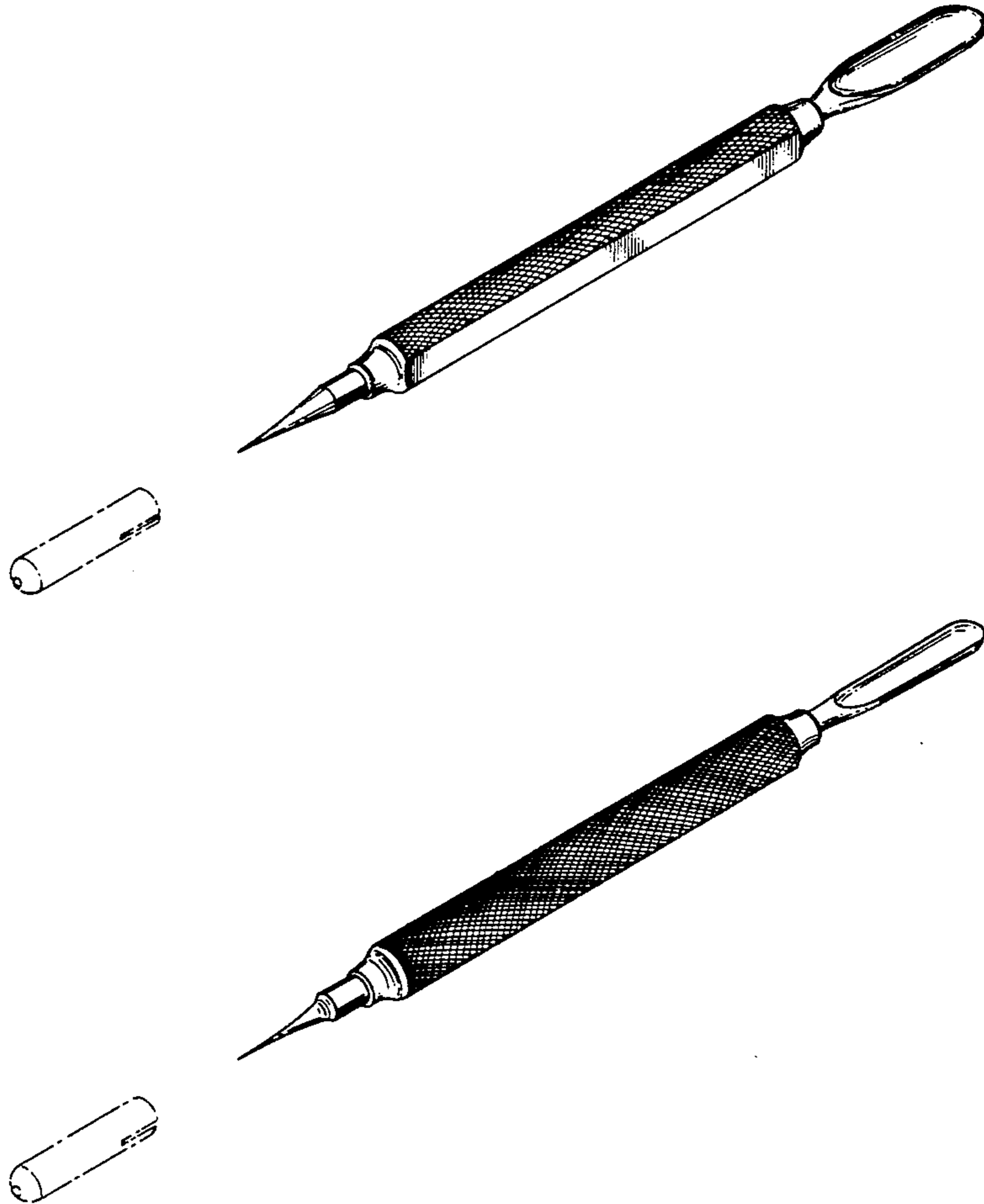
FIG. 11 is an elevational view of the side opposite that shown in FIG. 8;

FIG. 12 is a bottom plan view thereof;

FIG. 13 is a right end elevational view thereof; and,

FIG. 14 is a left end elevational view thereof.

The broken line showing the safety overcap in FIGS. 1 and 8 is for illustrative purposes only and forms no part of the claimed design.



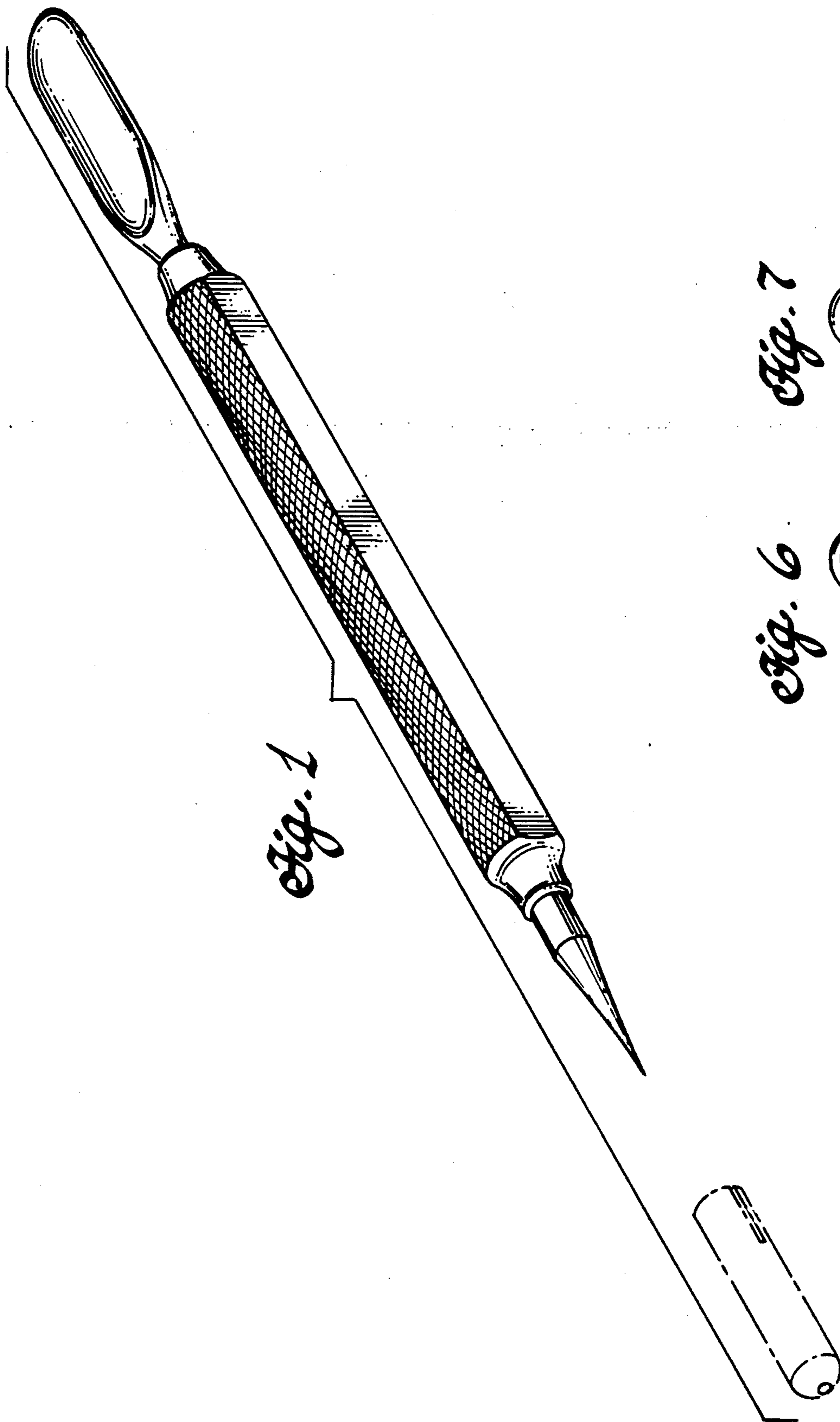

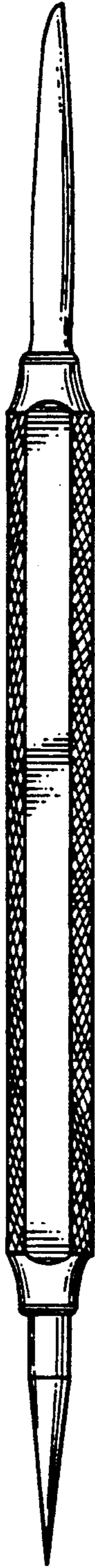

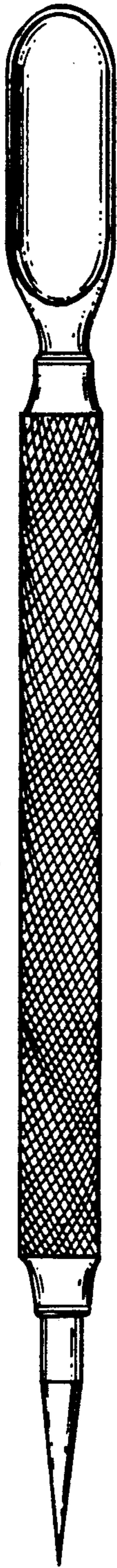

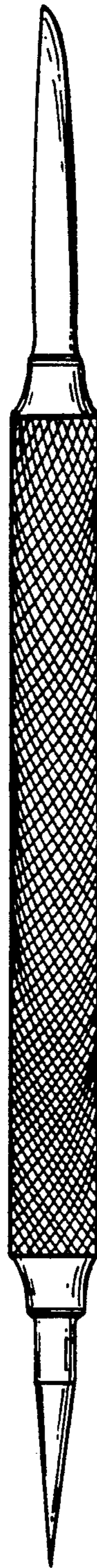

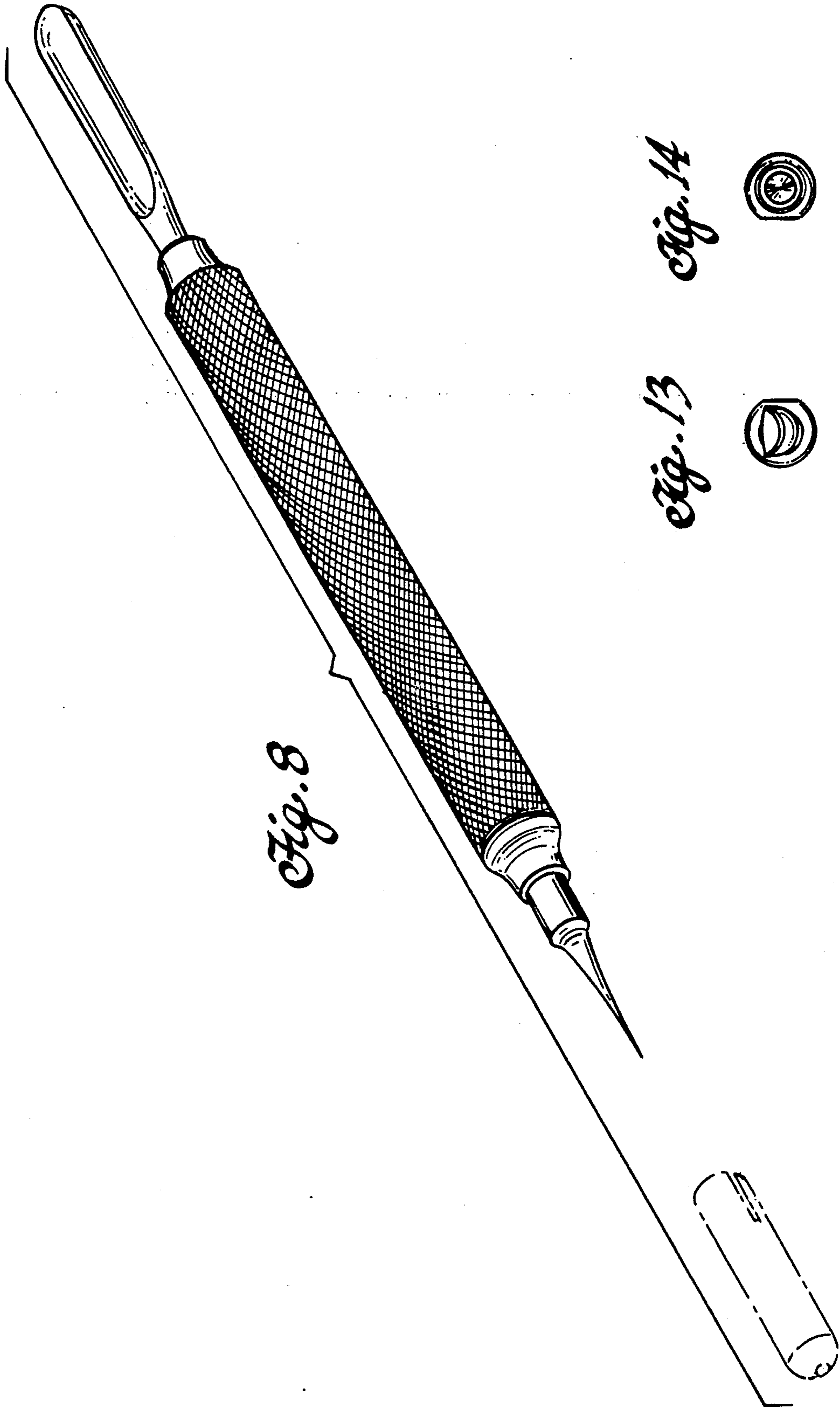

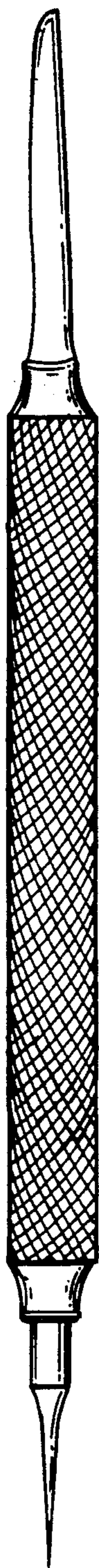

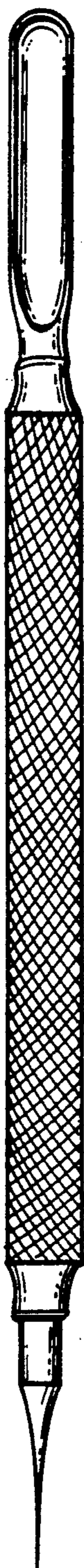
