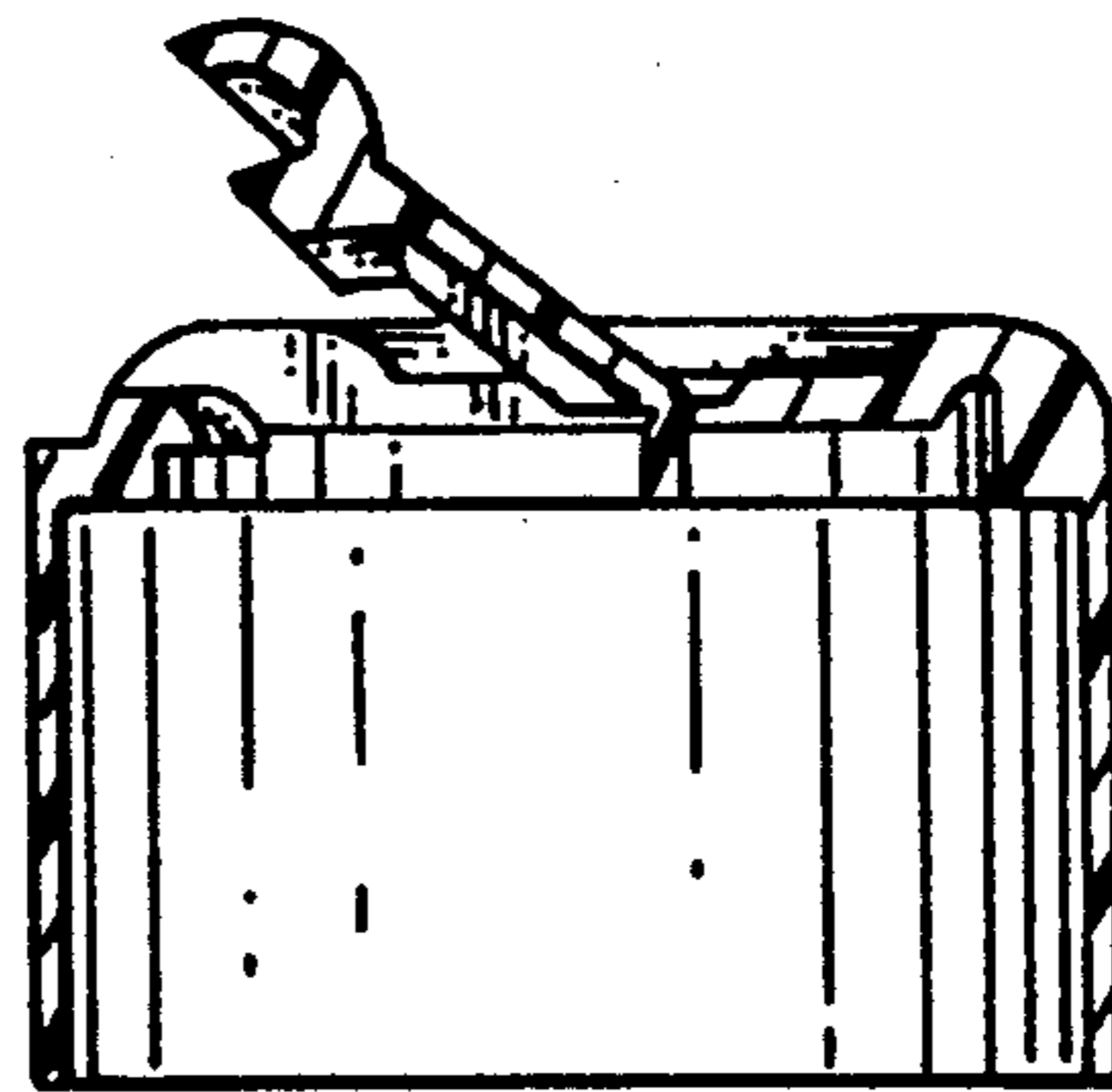
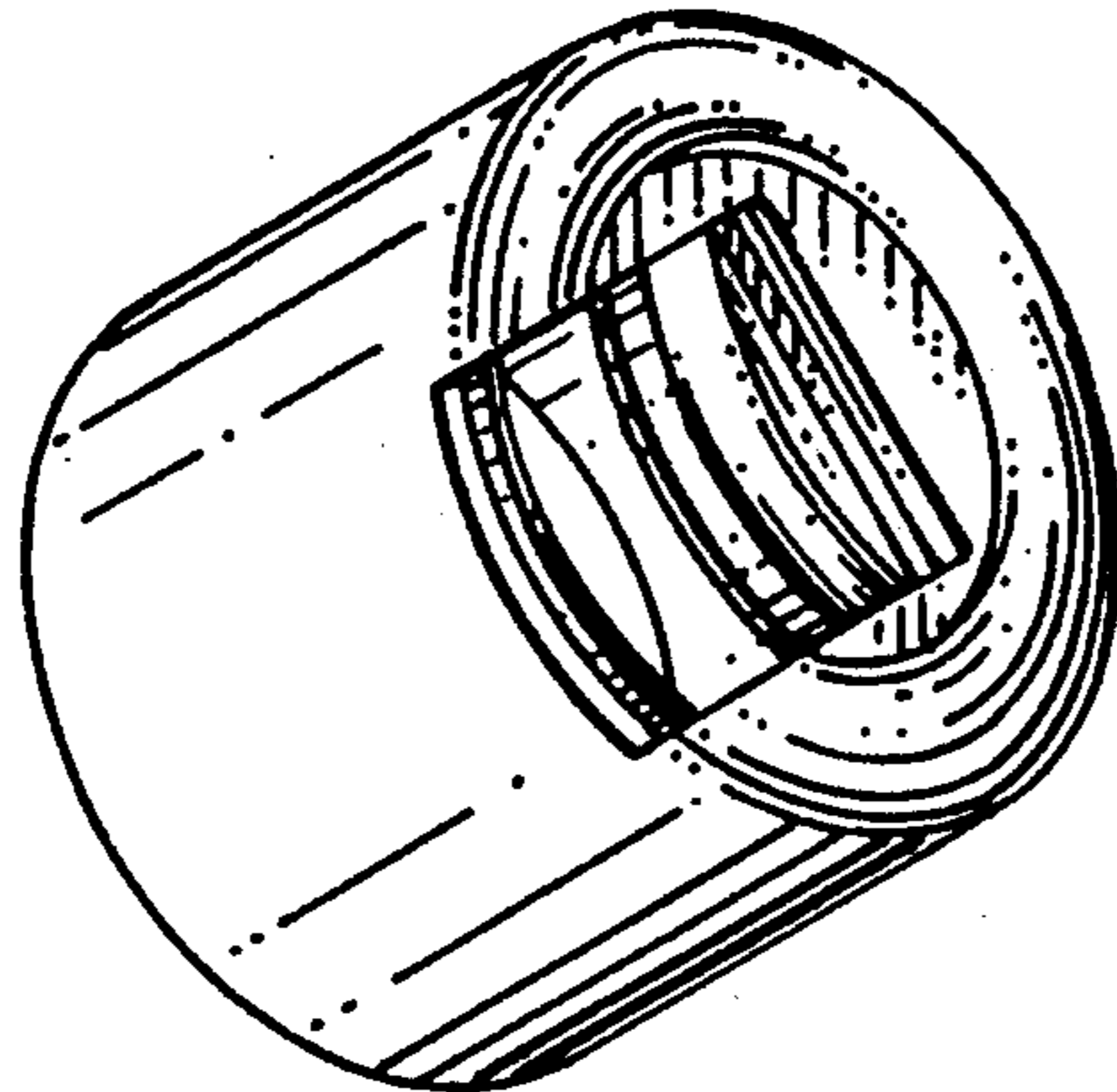

**DESCRIPTION**

FIG. 1 is a front perspective view of a closure showing our new design;  
FIG. 2 is a side elevational view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan thereof; and,  
FIG. 5 is a cross-sectional view, taken along line V—V of FIG. 3.

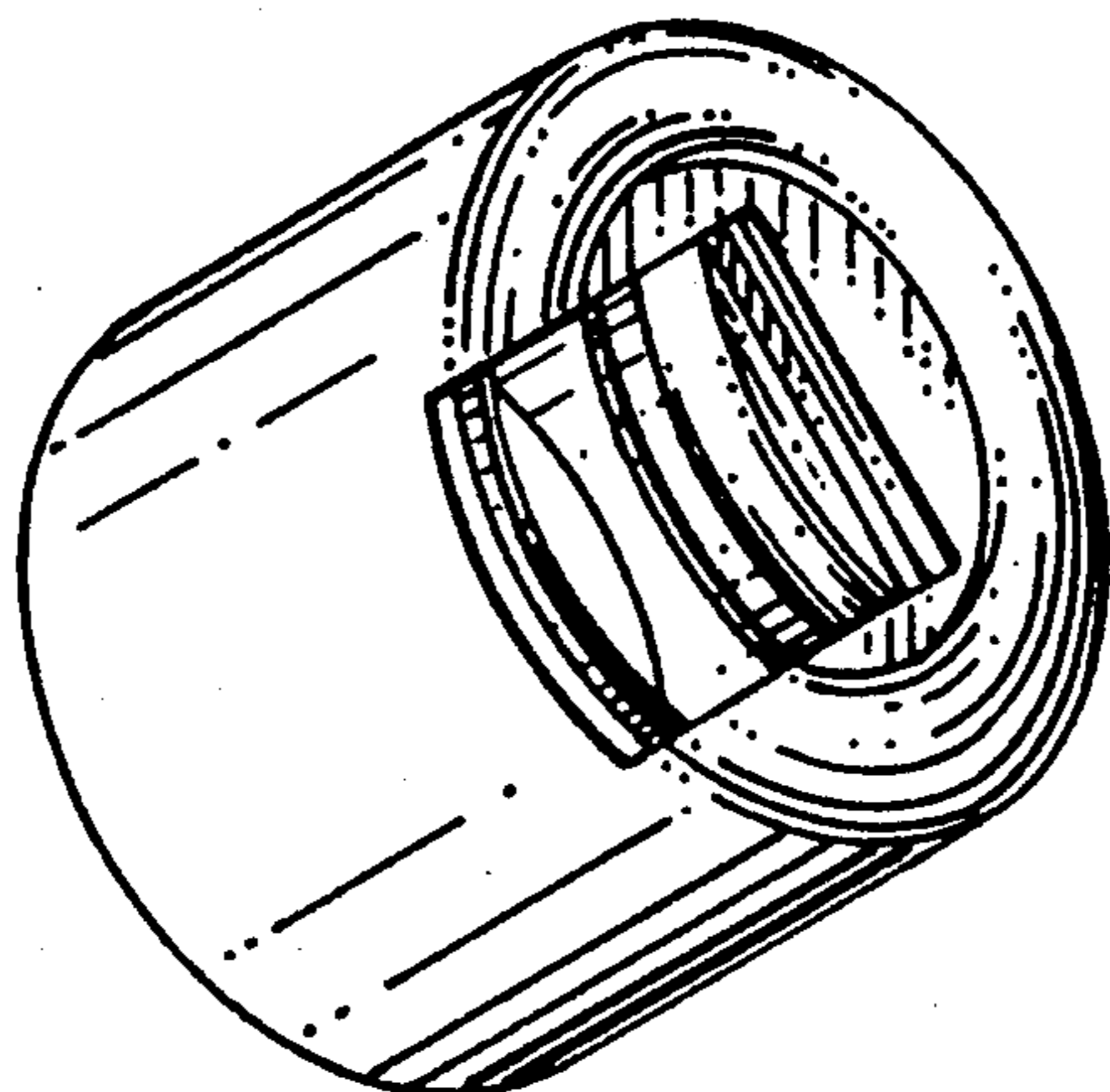

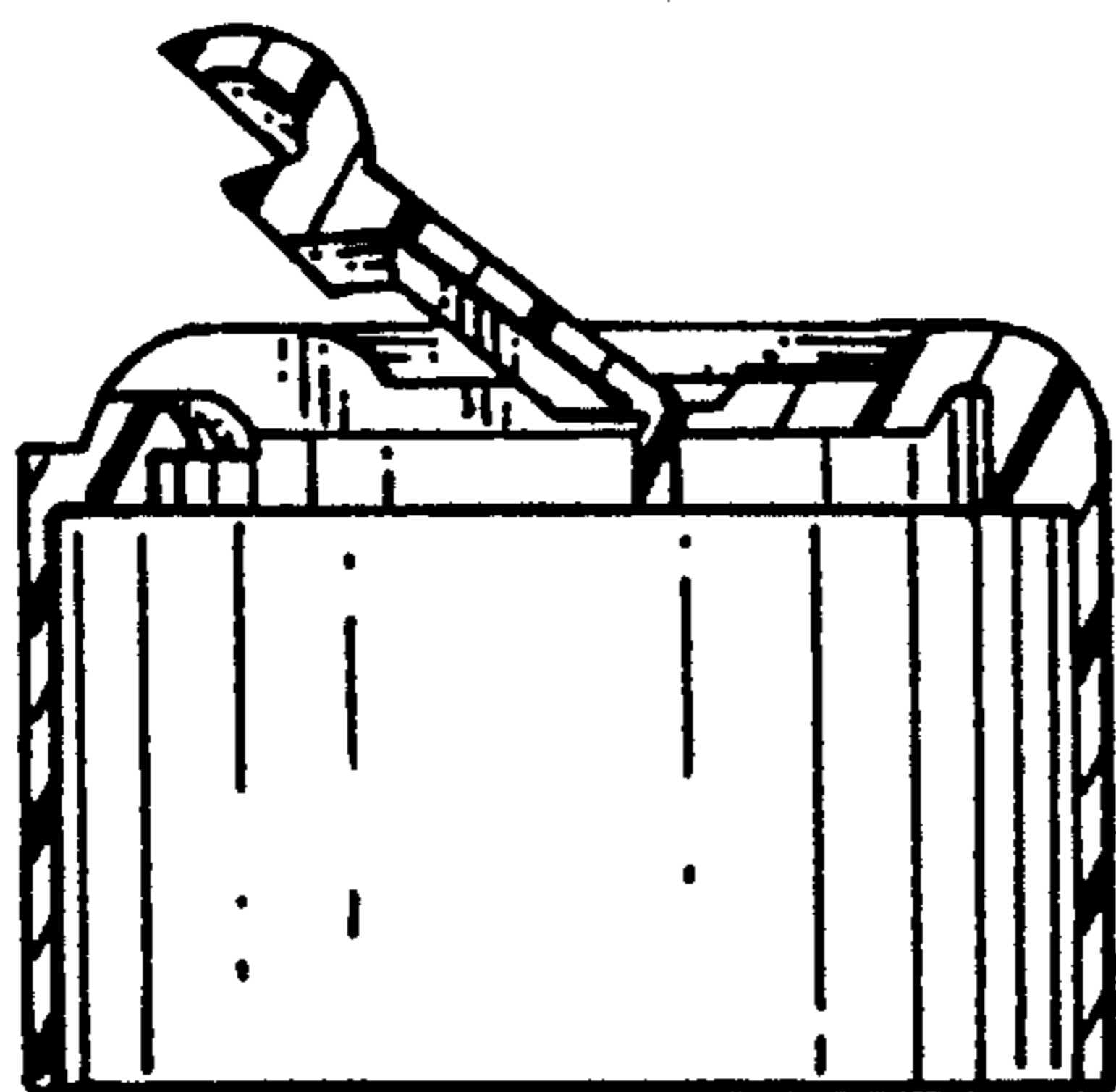
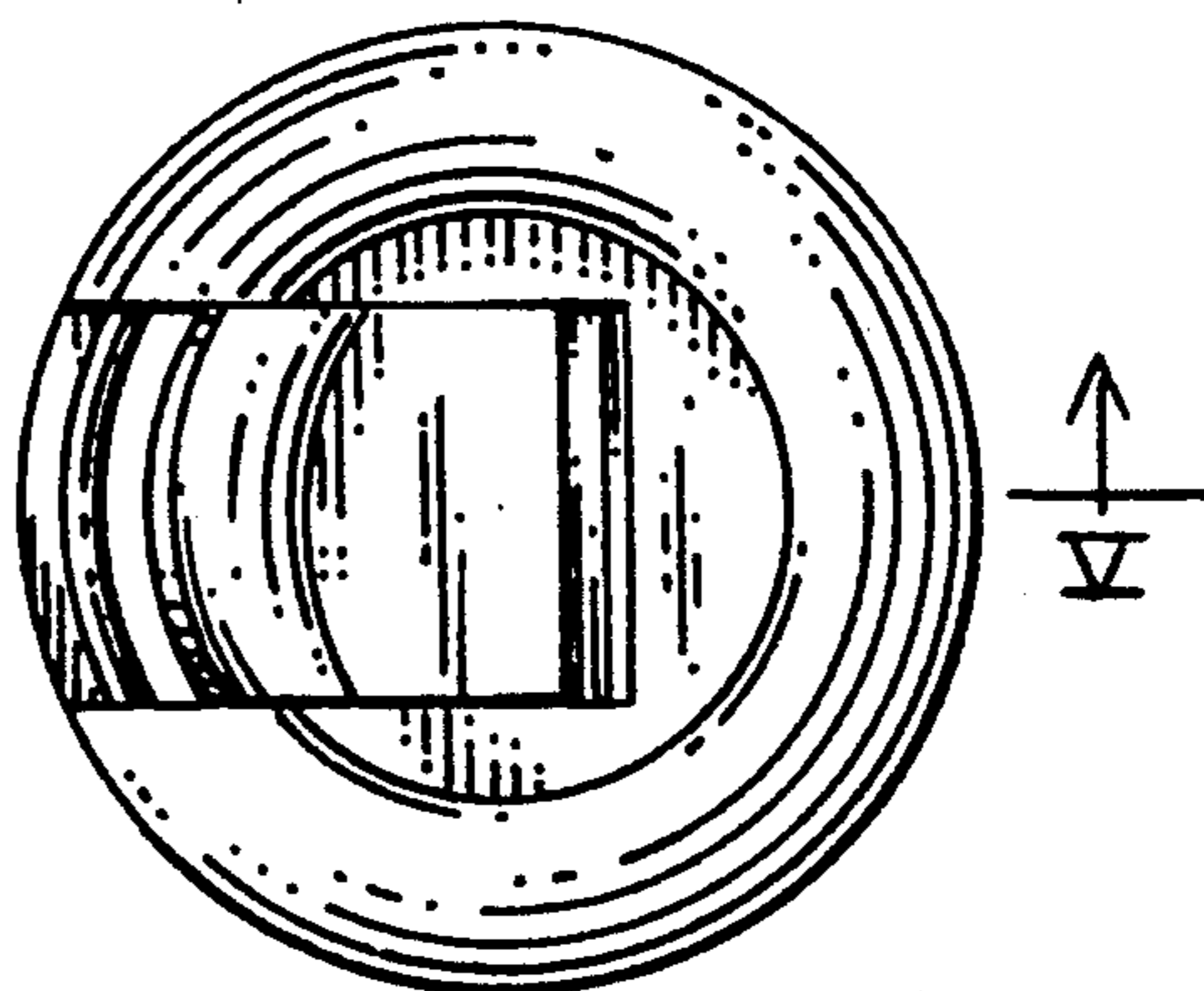

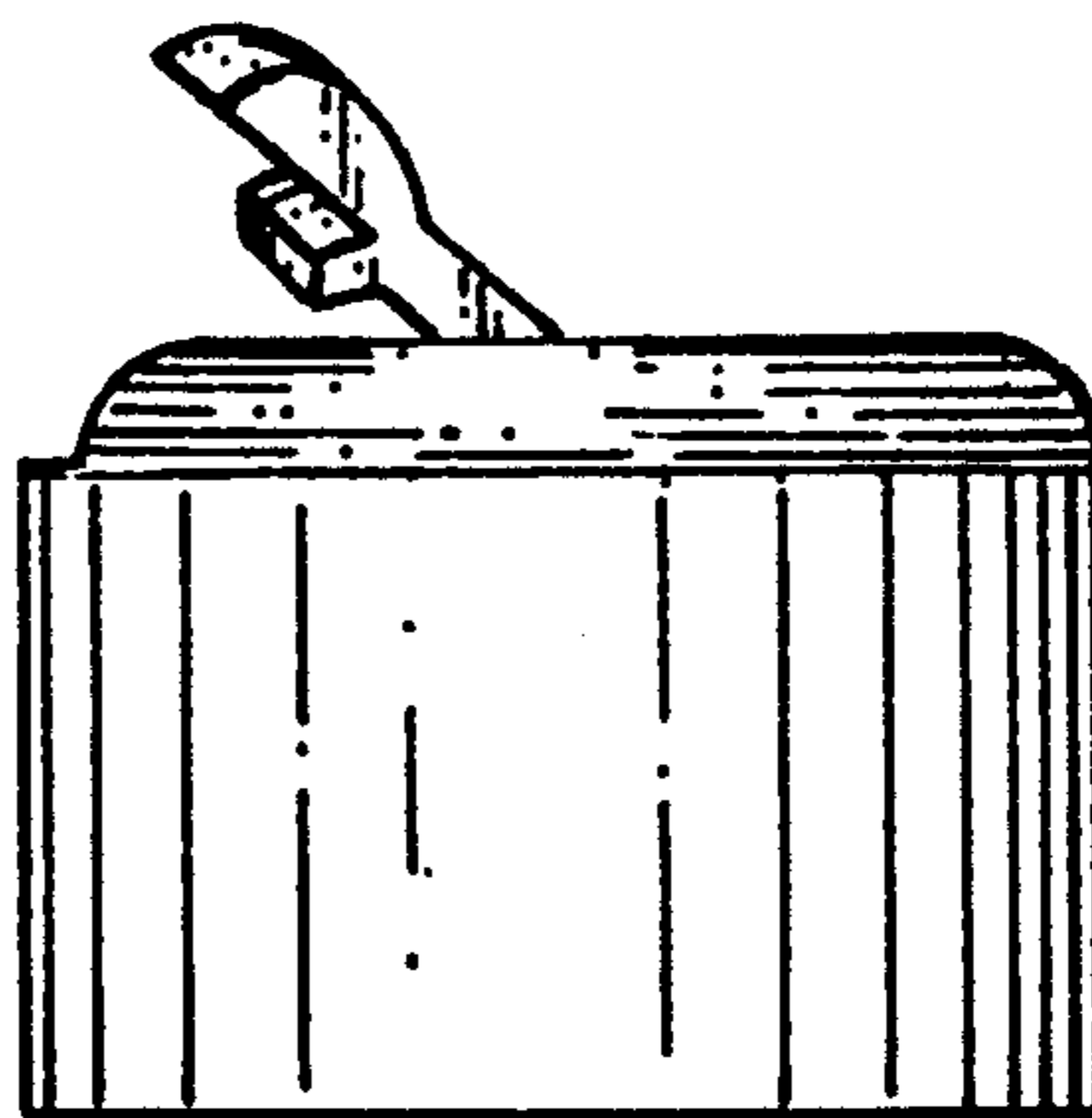
