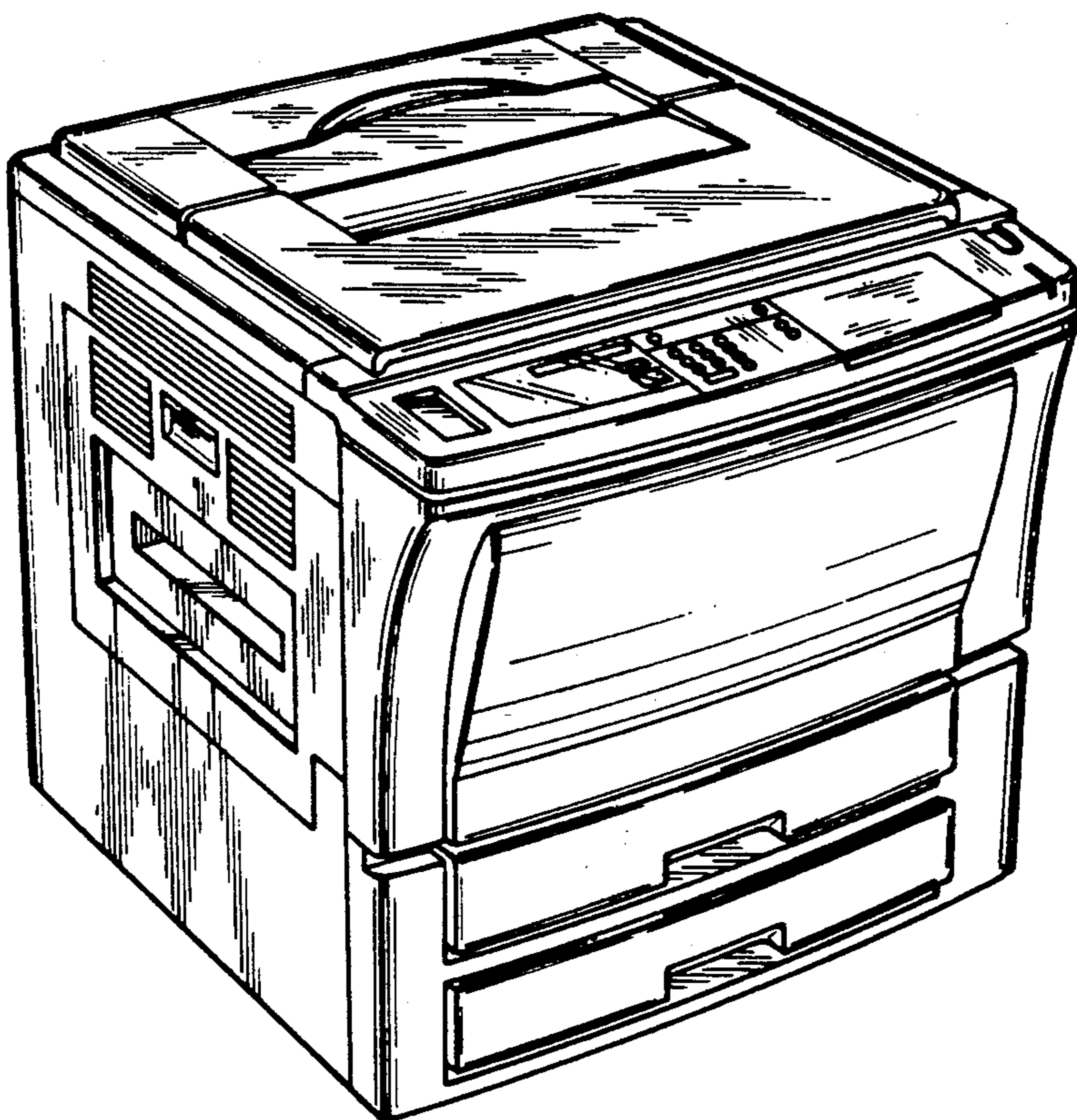

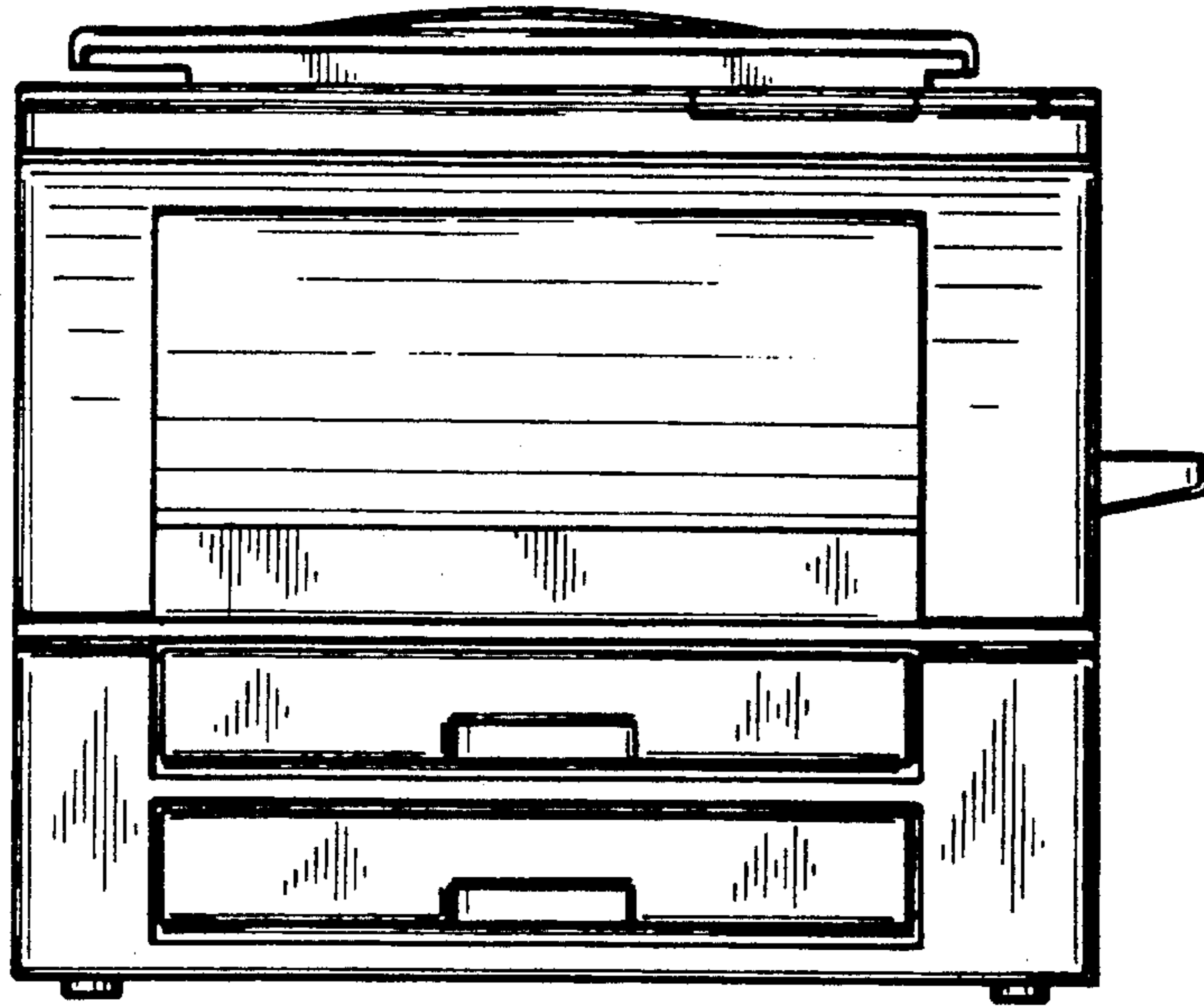
The ornamental design for a copying machine, as shown and described.

**DESCRIPTION**

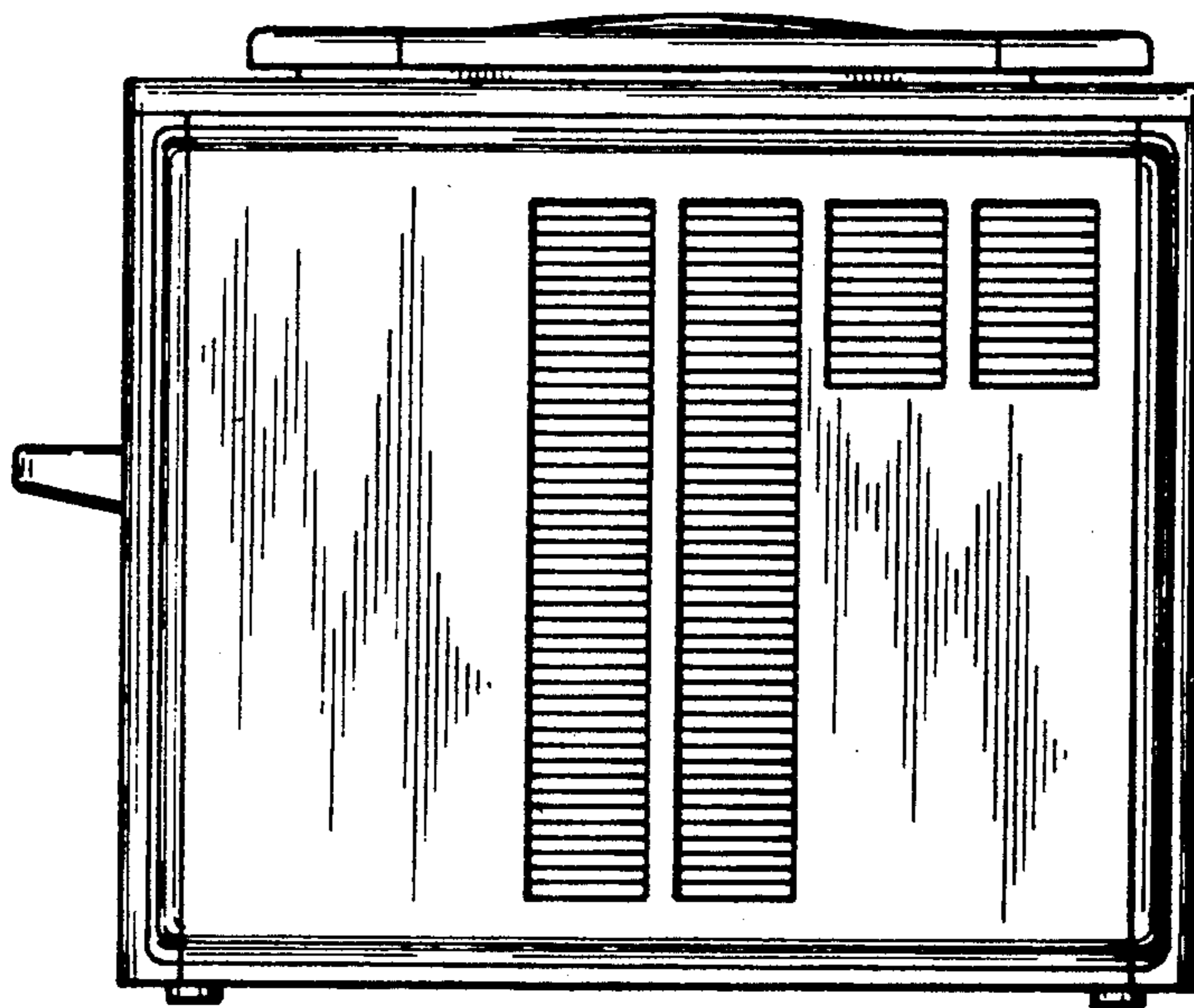
FIG. 1 is a front elevational view of a copying machine showing our new design;

FIG. 7 is a perspective view thereof.



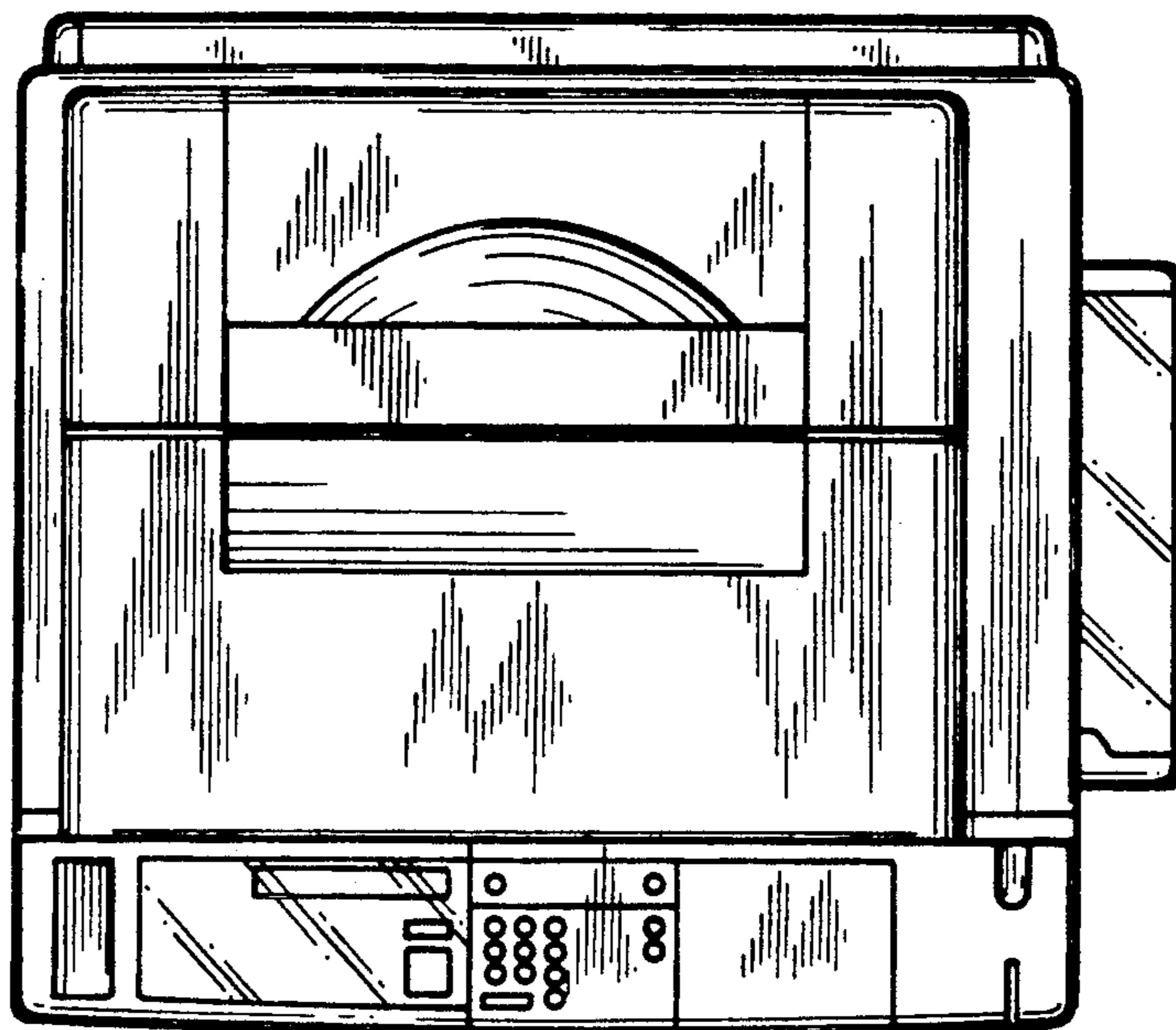

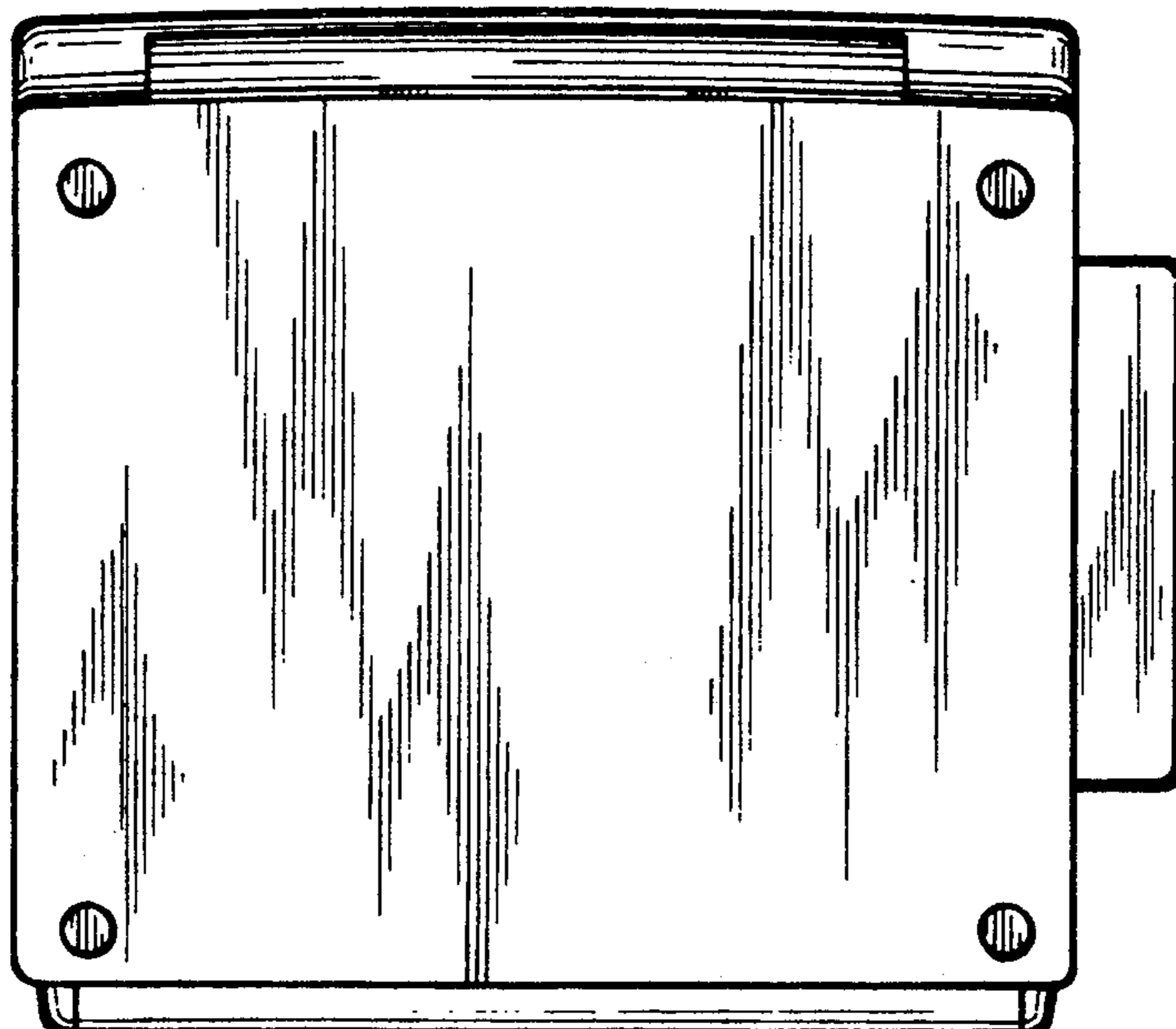

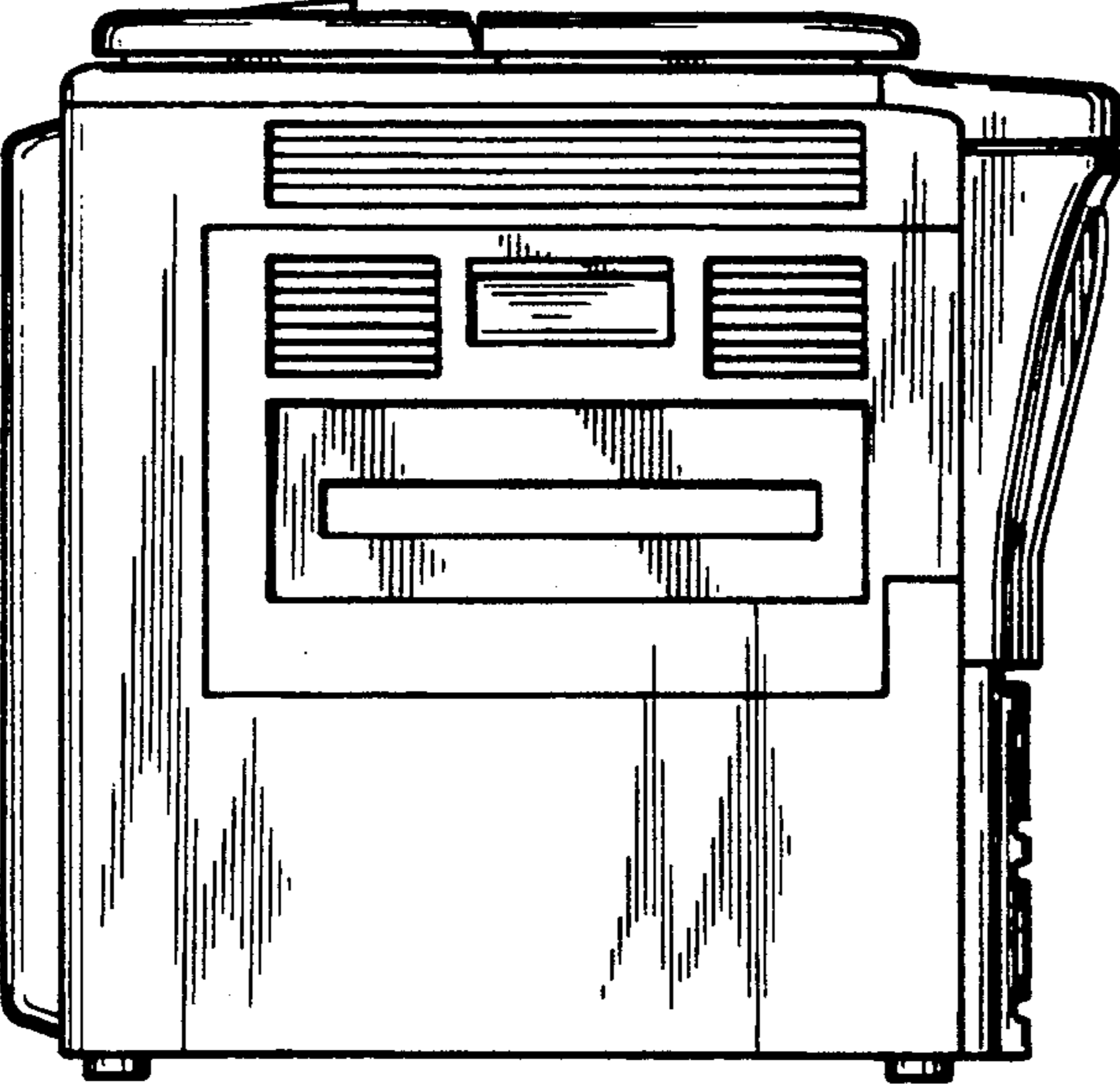

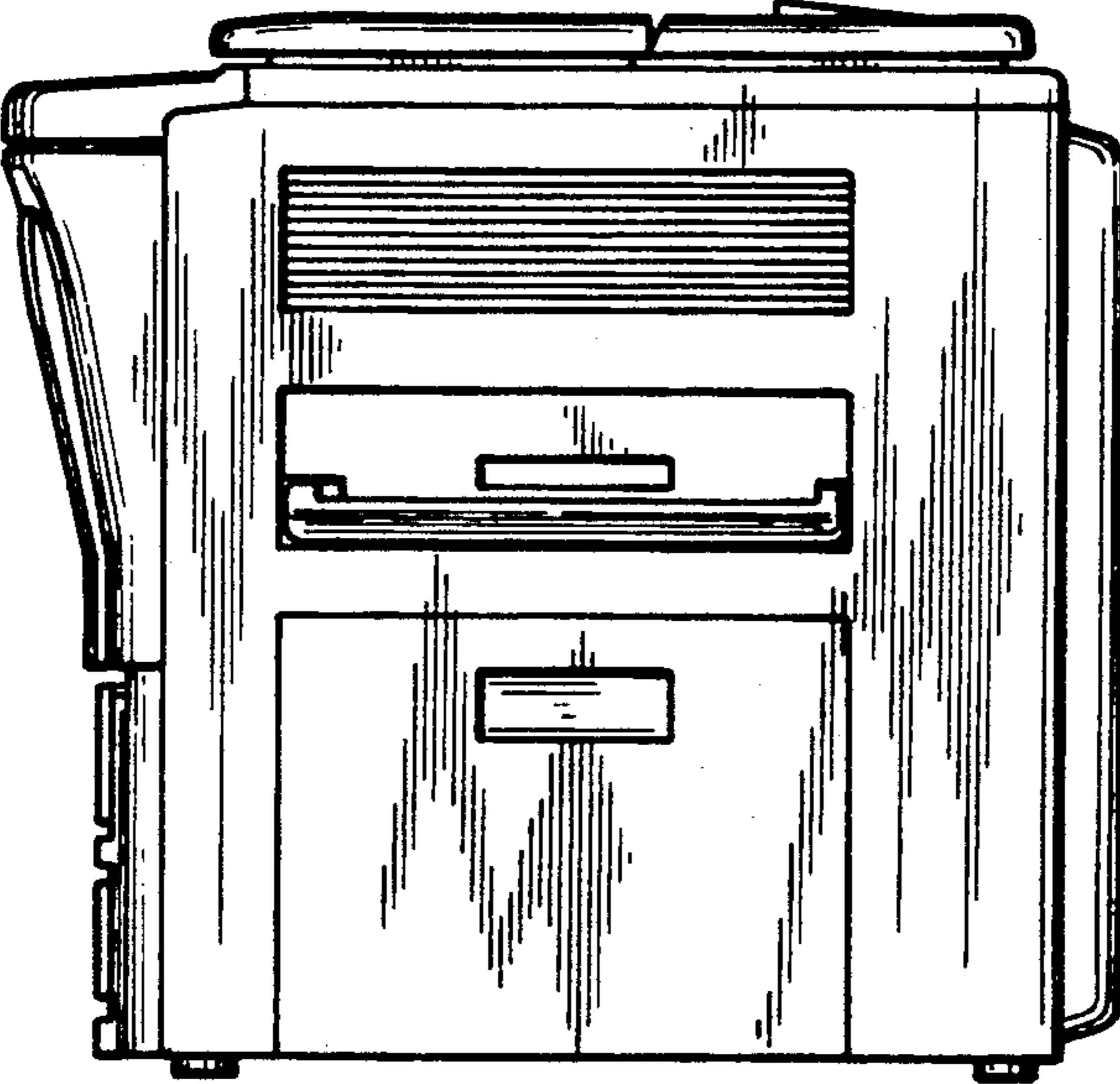
