The ornamental design for a combined still video camera and audio adapter, as shown and described.

### DESCRIPTION

FIG. 1 is a front, top and left side perspective view of a combined still video camera and audio adapter showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a left side elevational view thereof;

FIG. 6 is a rear elevational view thereof; and,

FIG. 7 is a bottom plan view thereof.

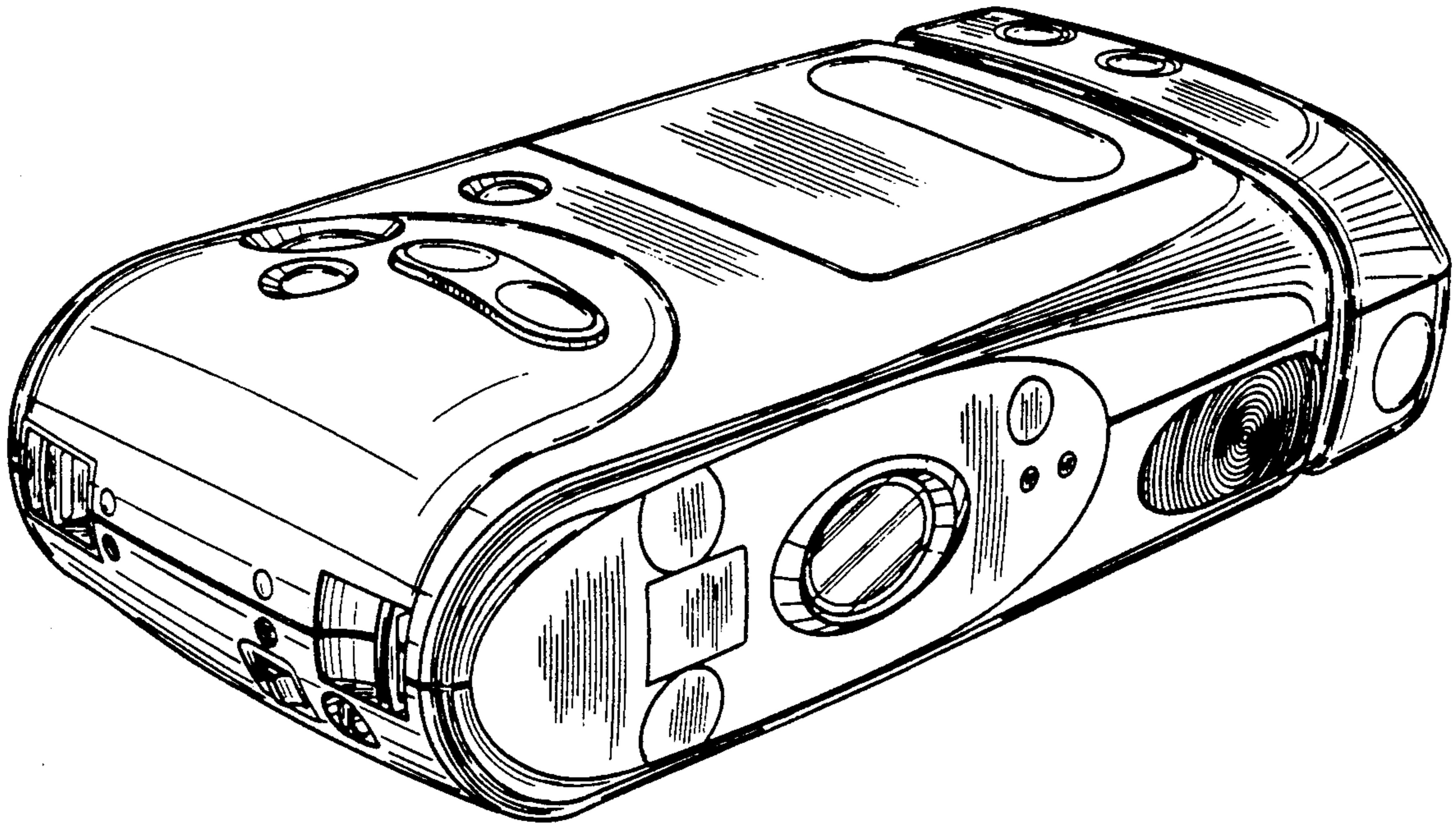

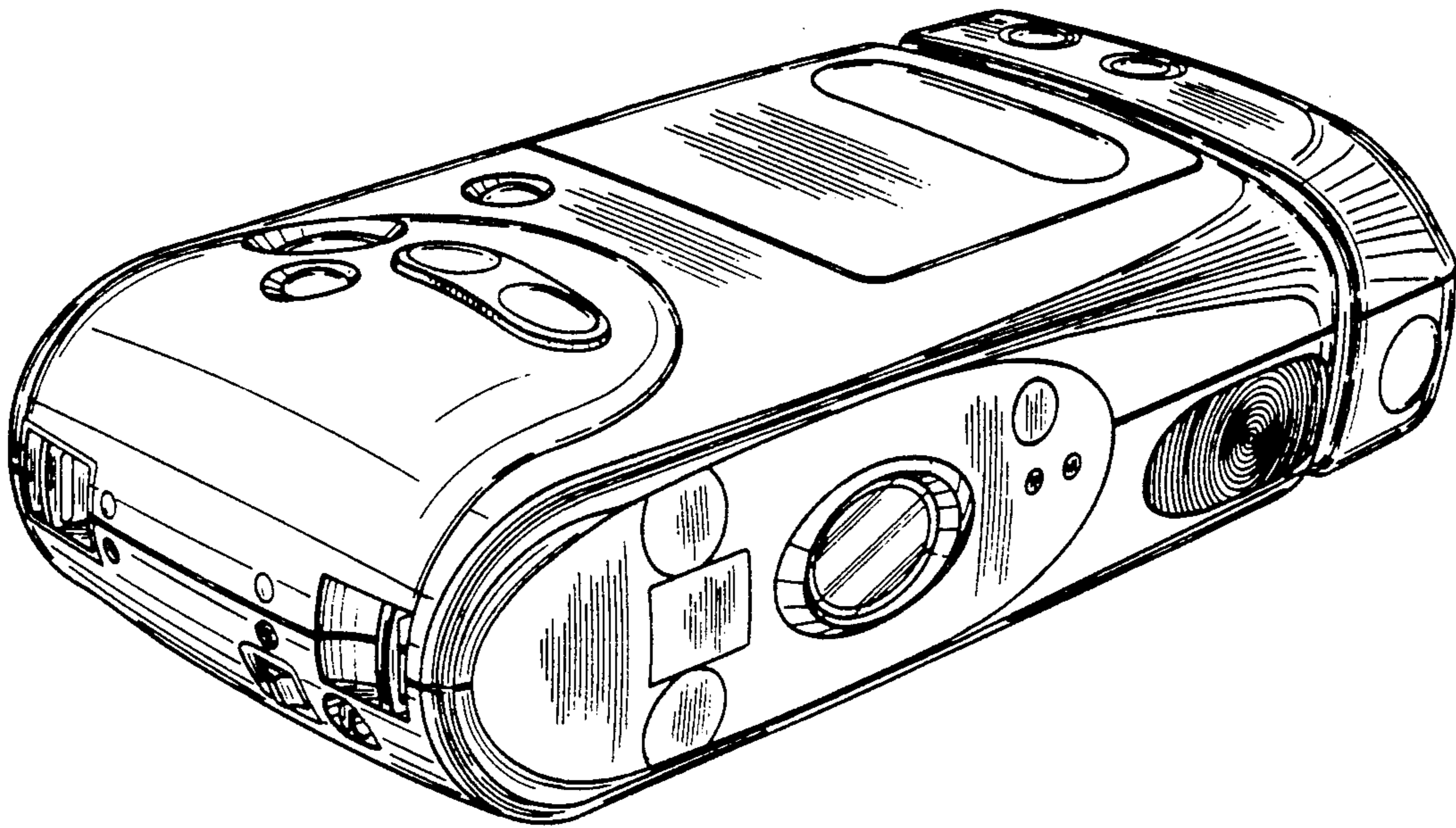

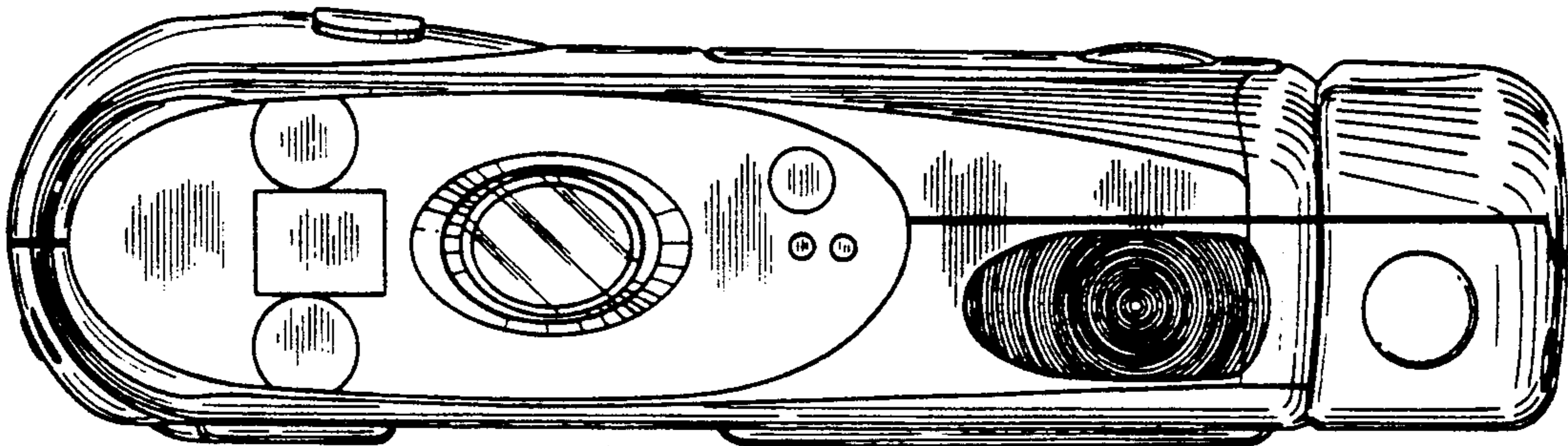

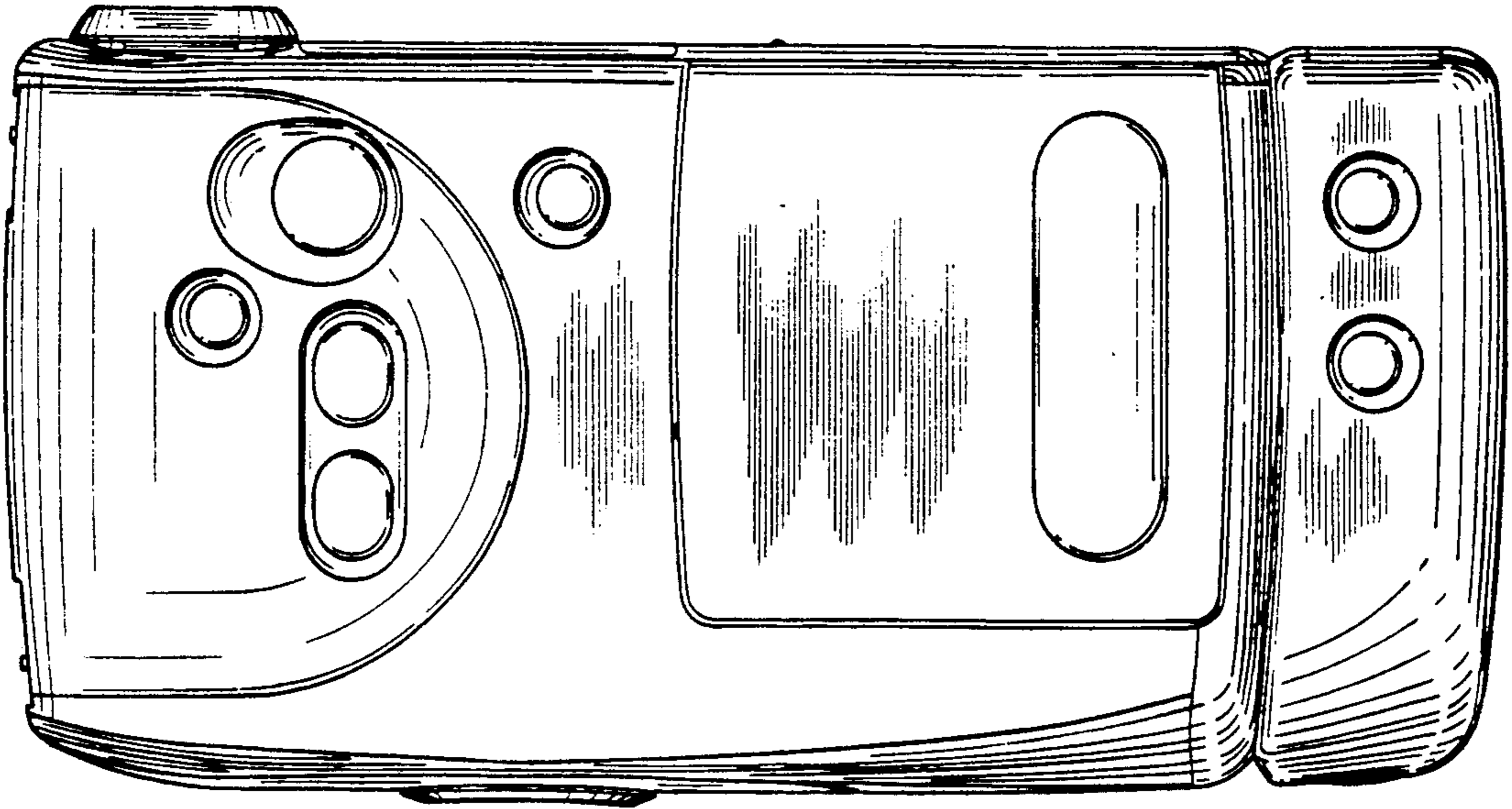

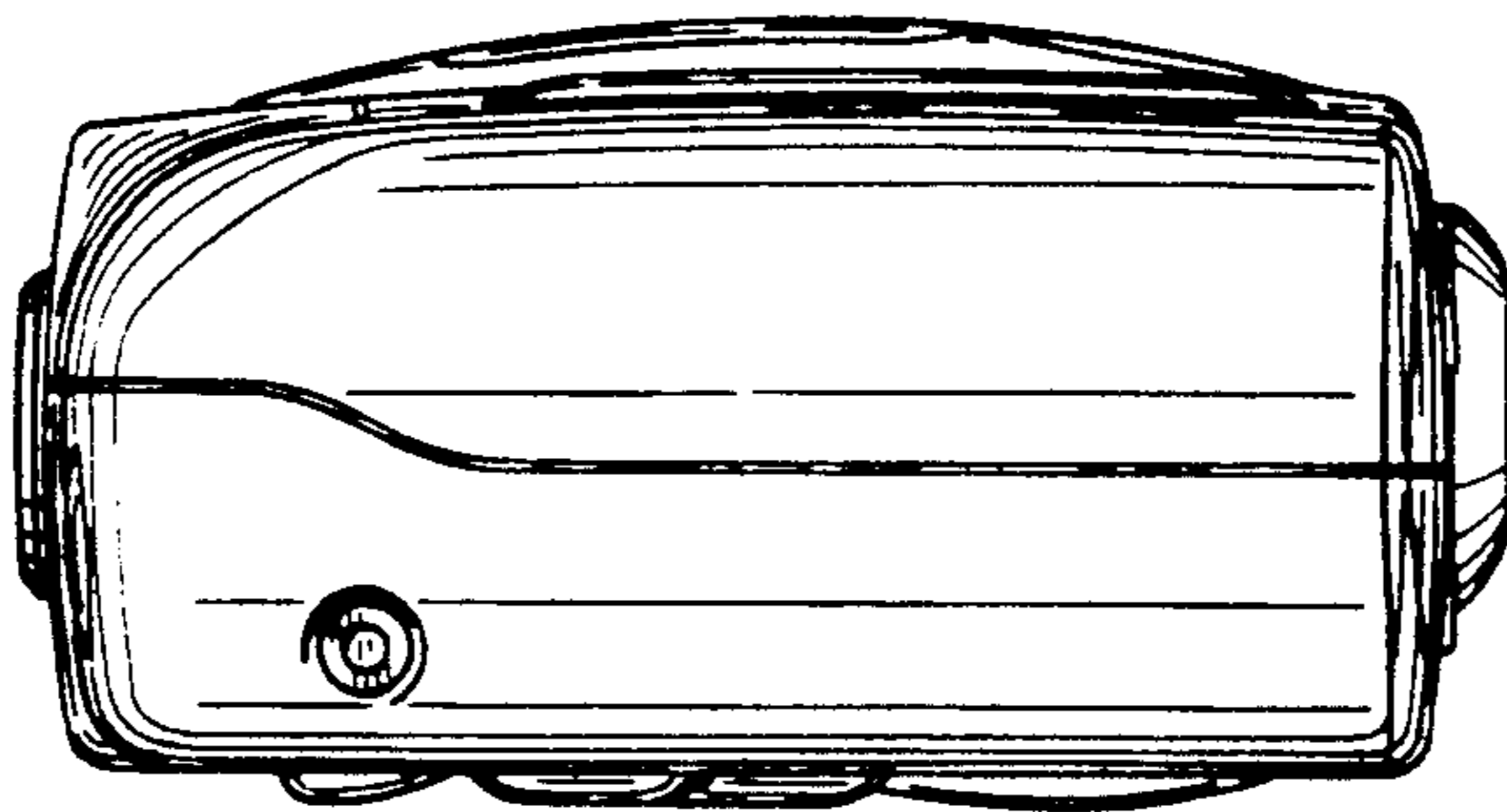

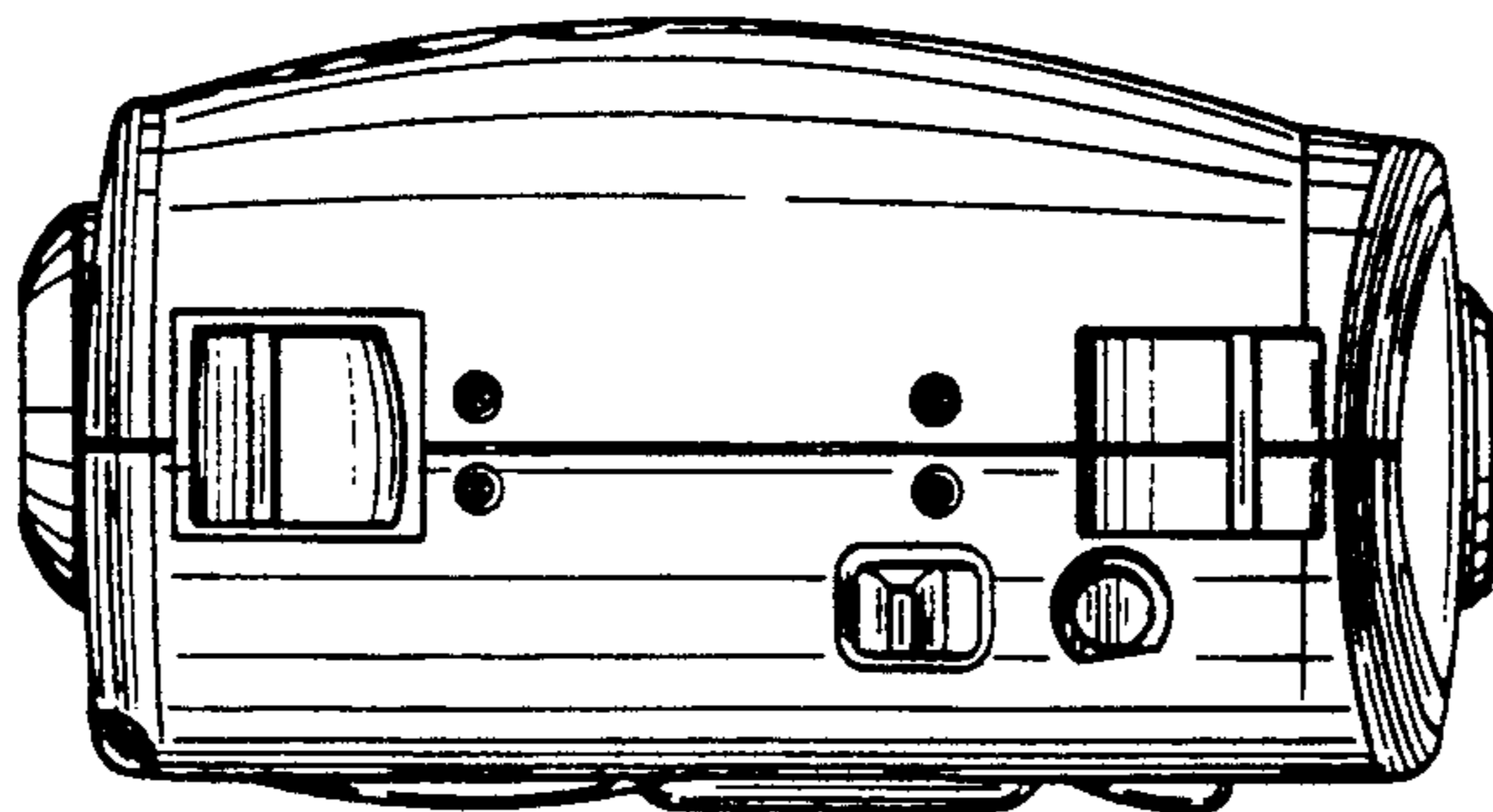

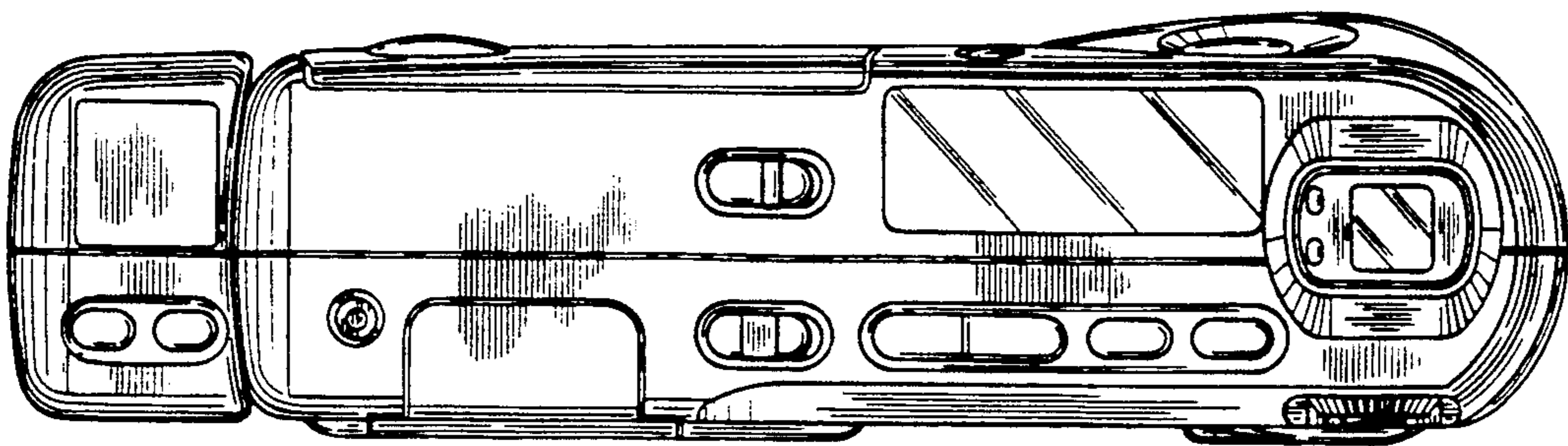
