The ornamental design for a financial services kiosk, as shown and described.

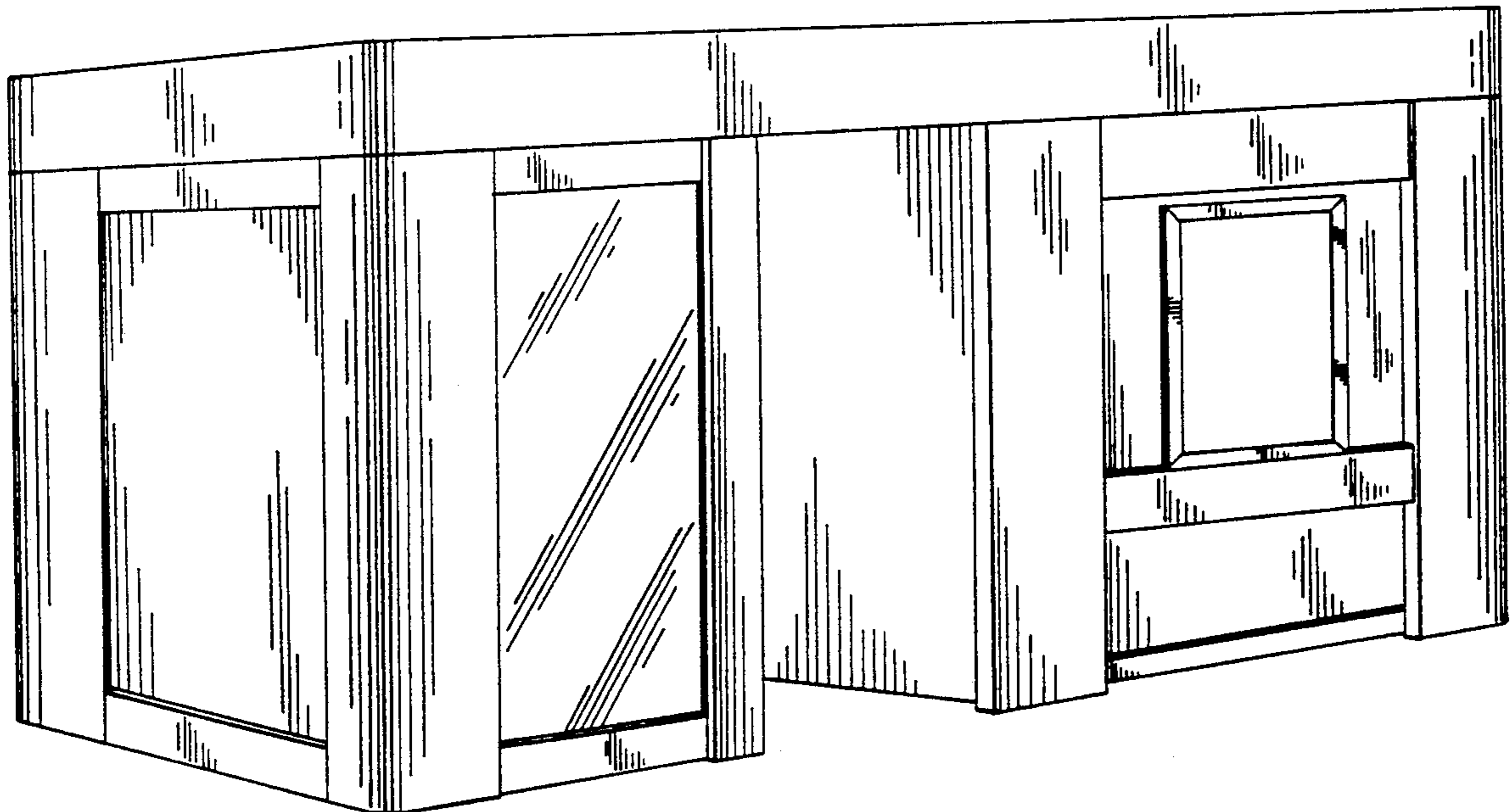
## DESCRIPTION

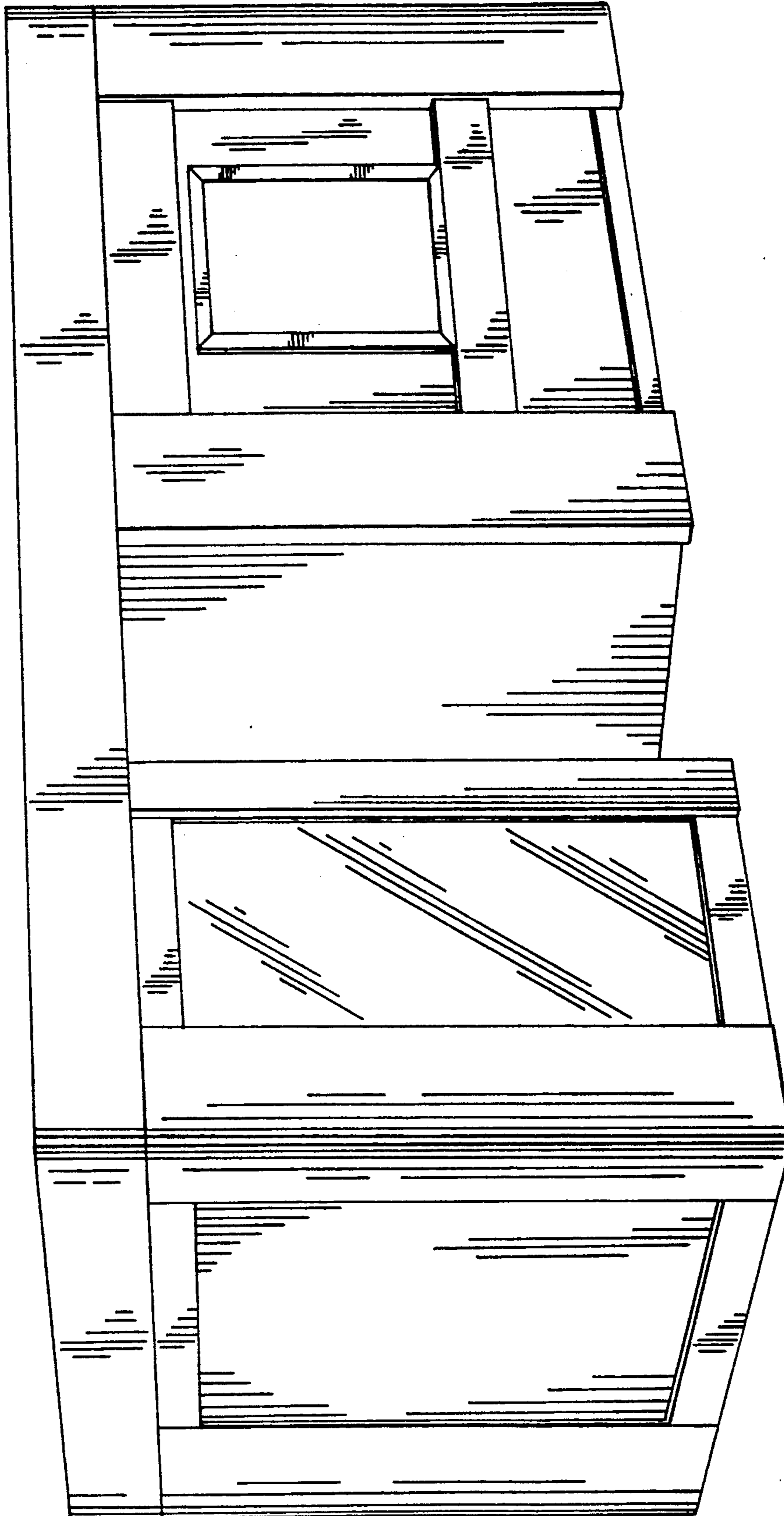
FIG. 1 is a front perspective view of a first embodiment of a financial services kiosk showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a horizontal sectional view thereof taken along line 5—5 in FIG. 2; FIG. 6 is a vertical sectional view thereof taken along line 6—6 in FIG. 2; FIG. 7 is a front perspective view of a second embodiment of our new design; FIG. 8 is a front elevational view thereof; FIG. 9 is a rear elevational view thereof; FIG. 10 is a right side elevational view thereof; FIG. 11 is a horizontal sectional view thereof taken along line 11—11 in FIG. 8; FIG. 12 is a vertical sectional view thereof taken along line 12—12 in FIG. 8; and, FIG. 13 is a vertical sectional view thereof taken along line 13—13 in FIG. 8.

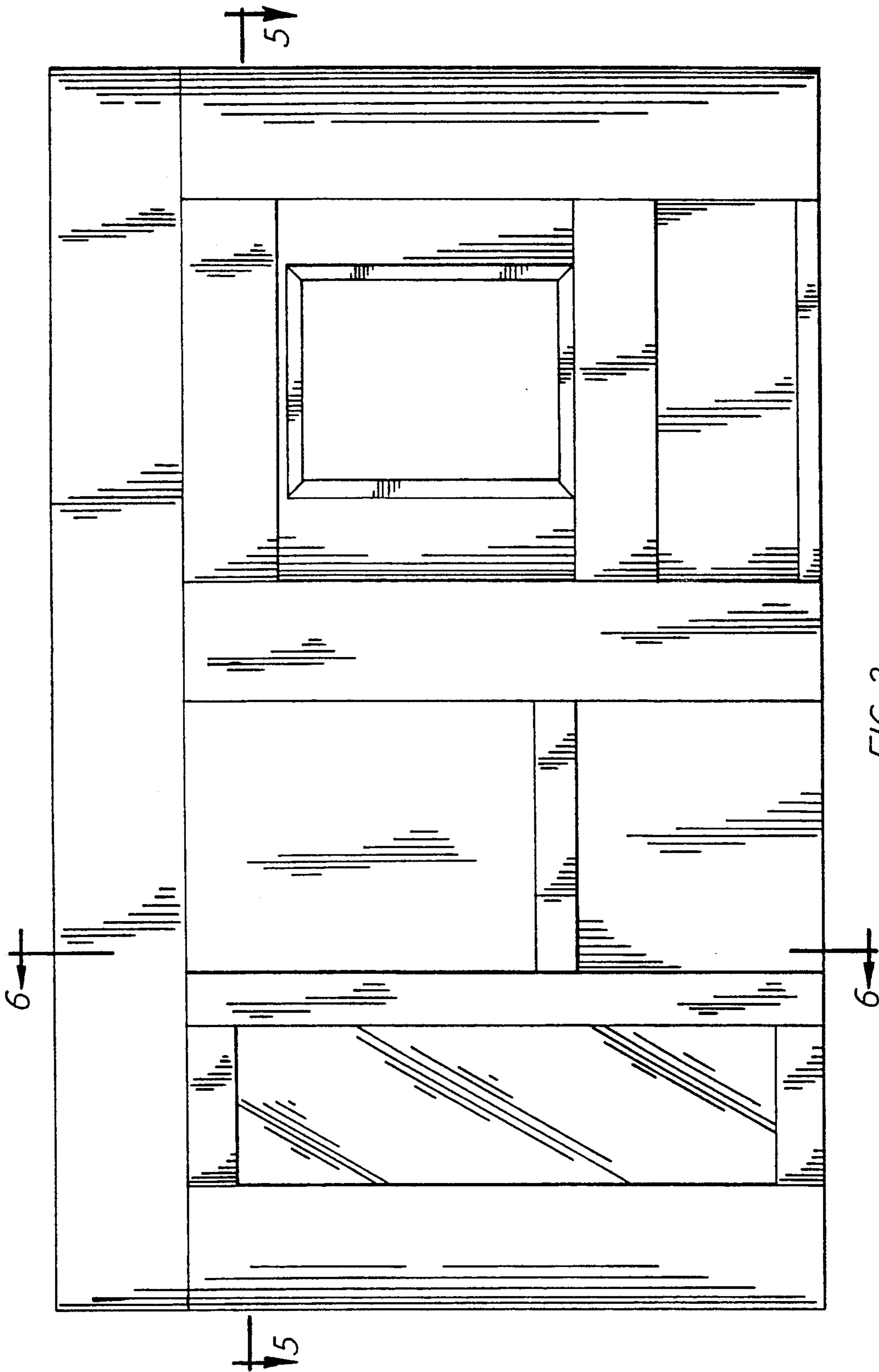

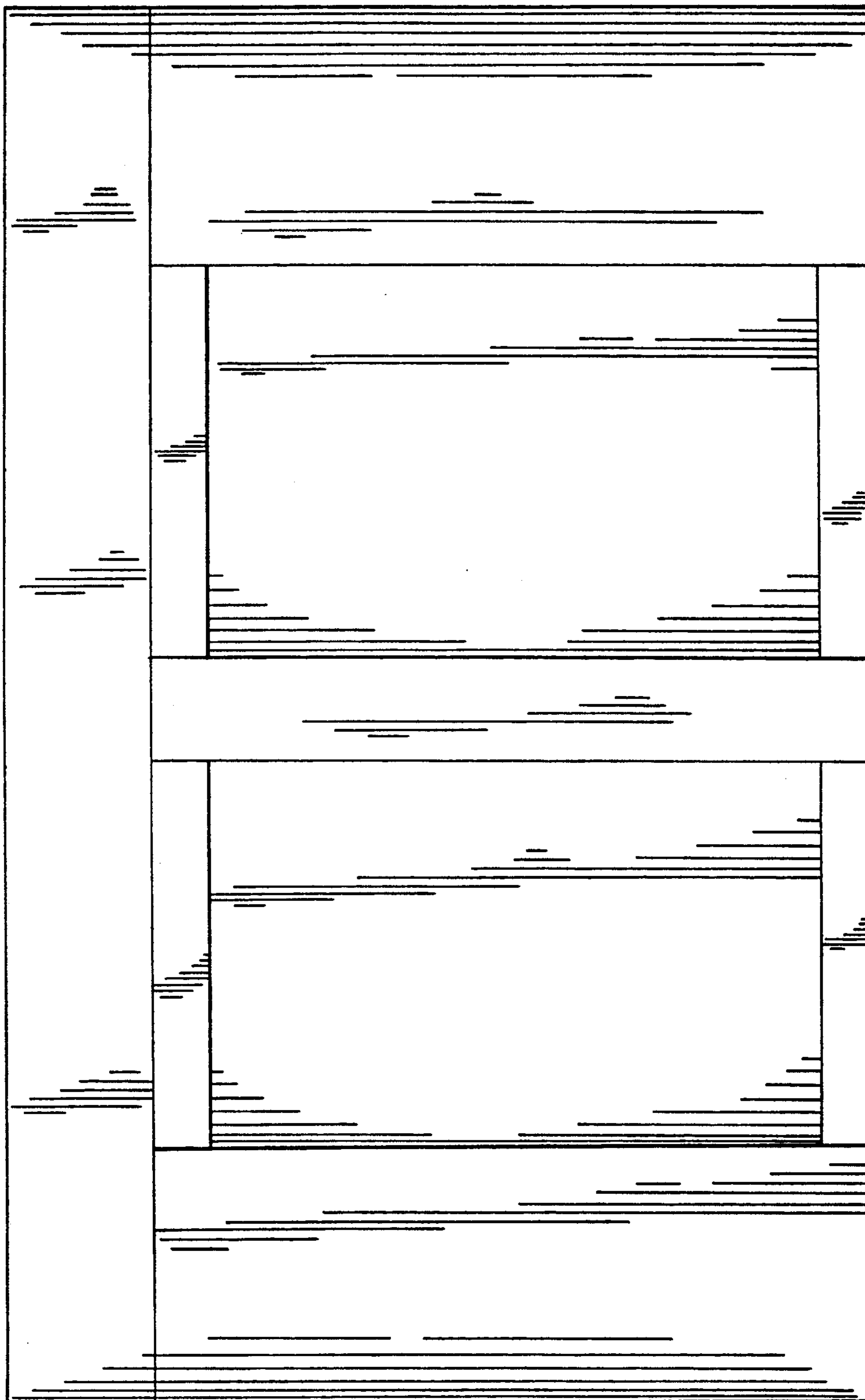

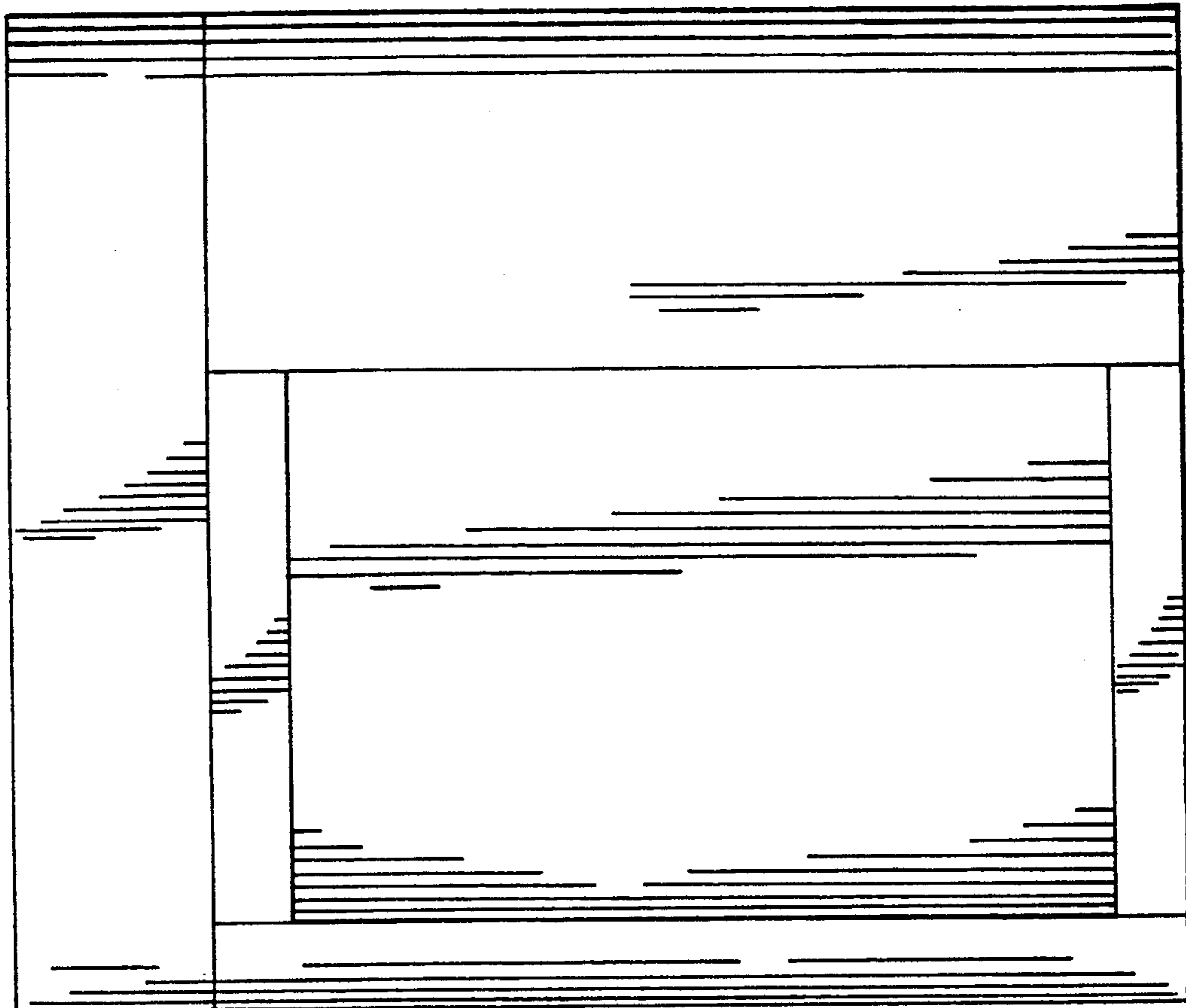

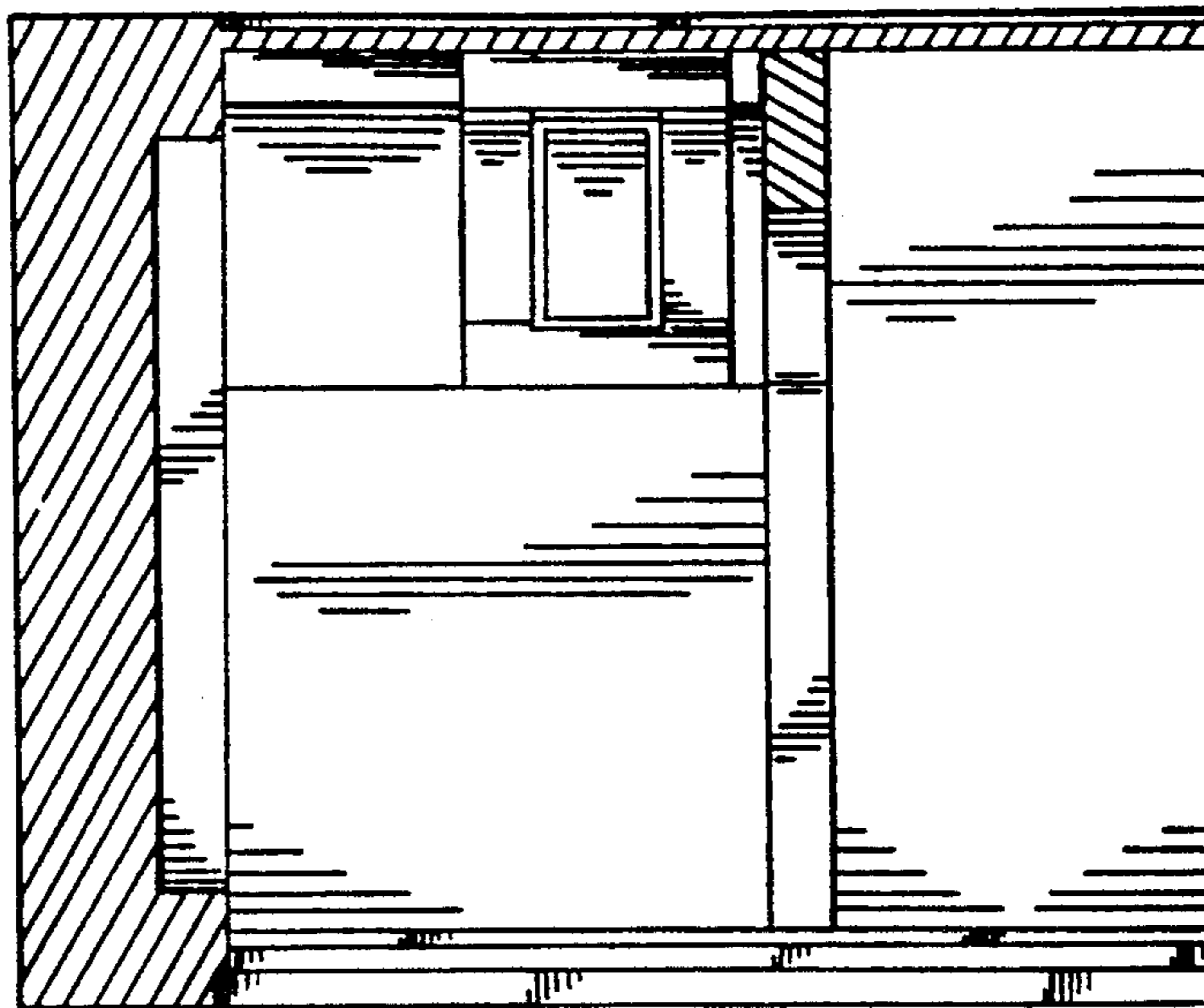

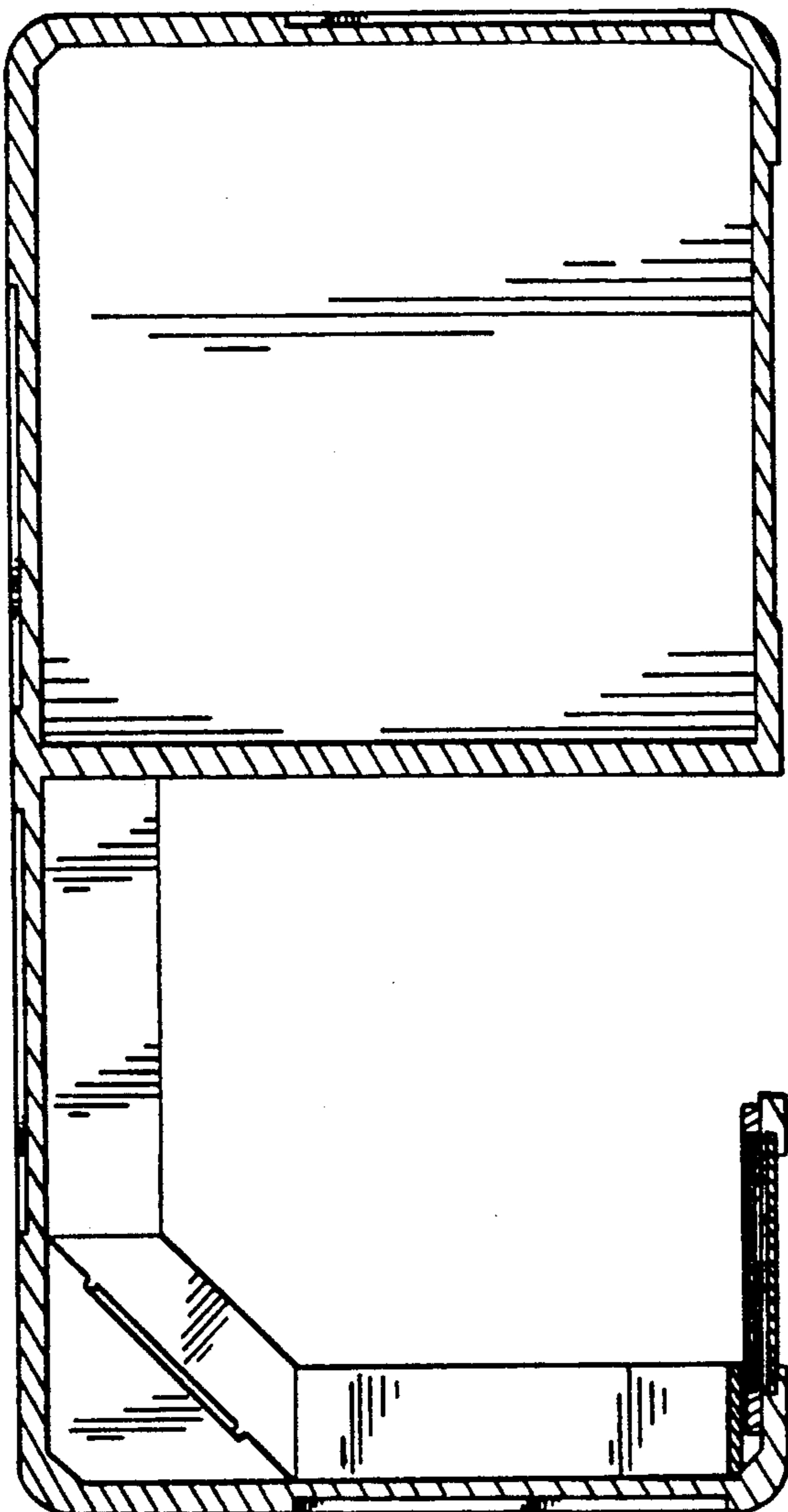

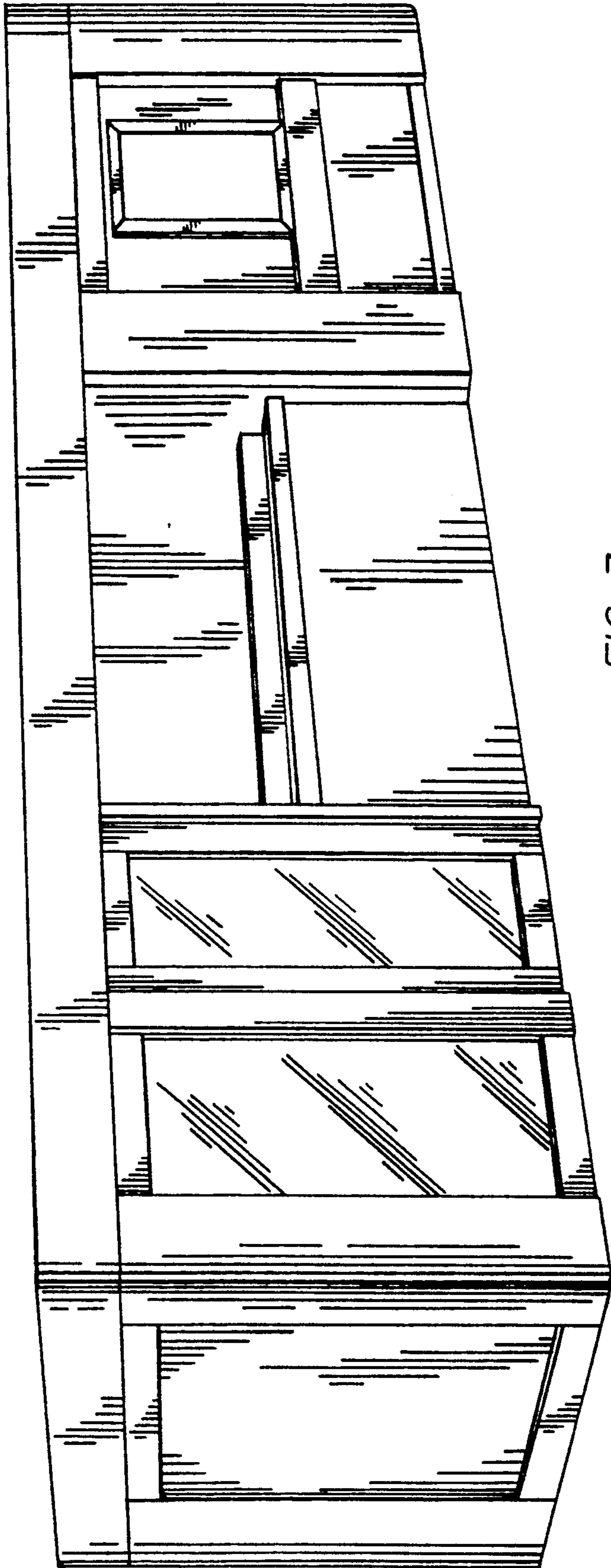

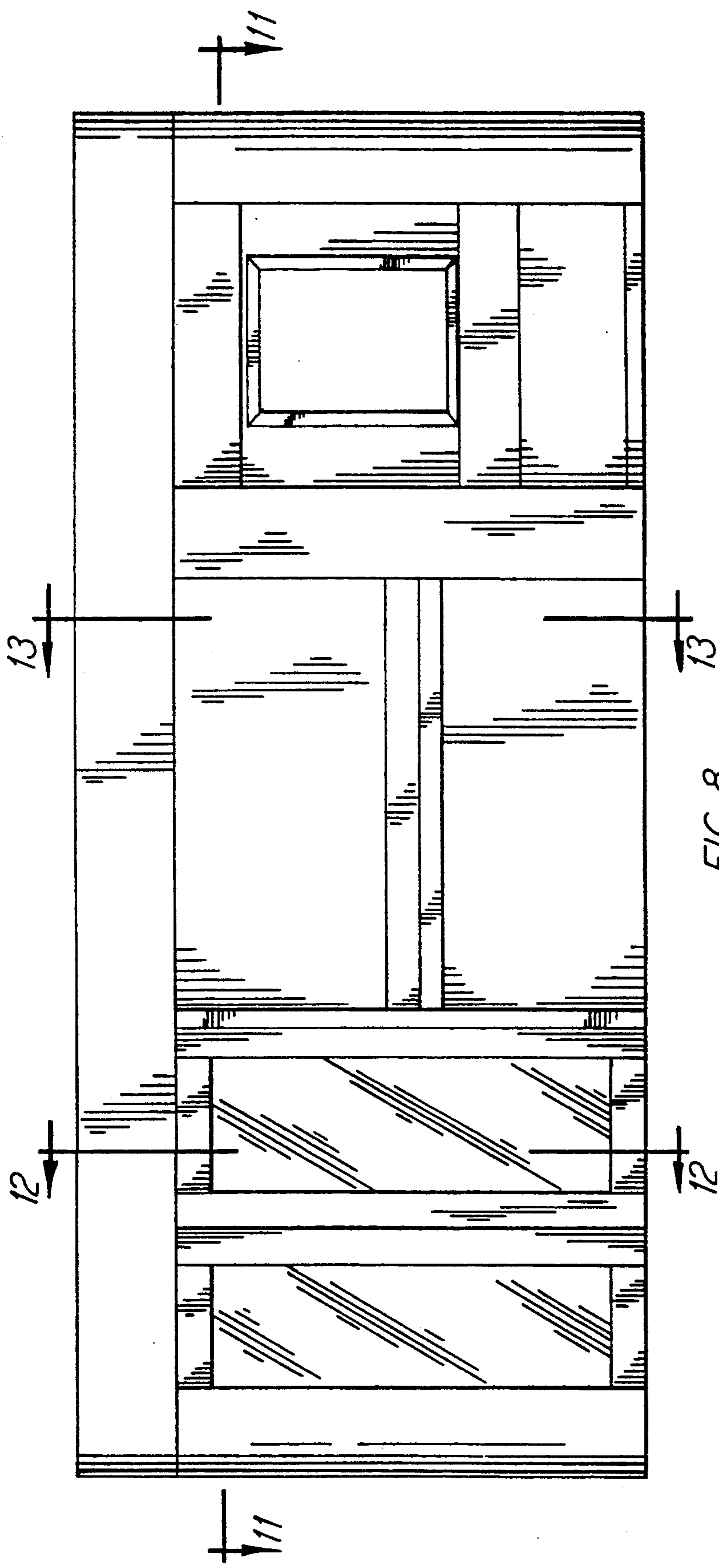
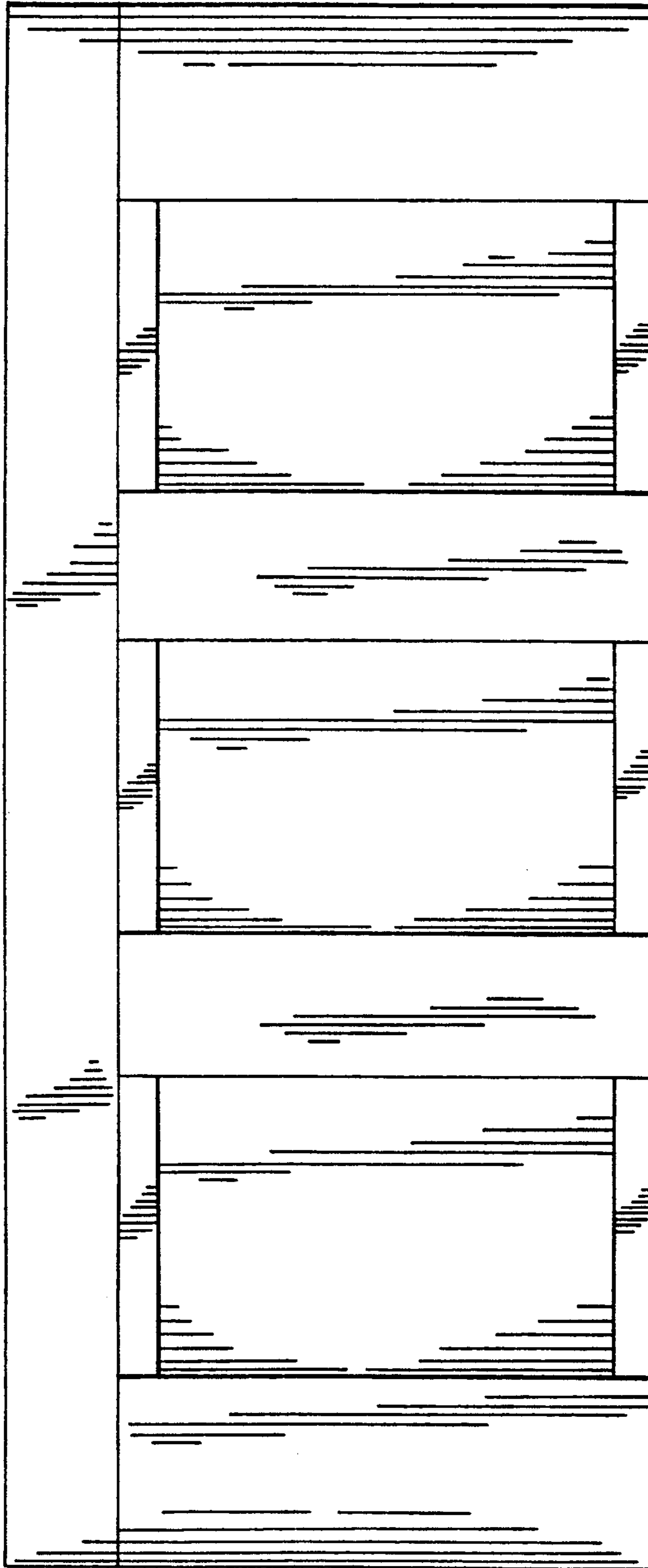

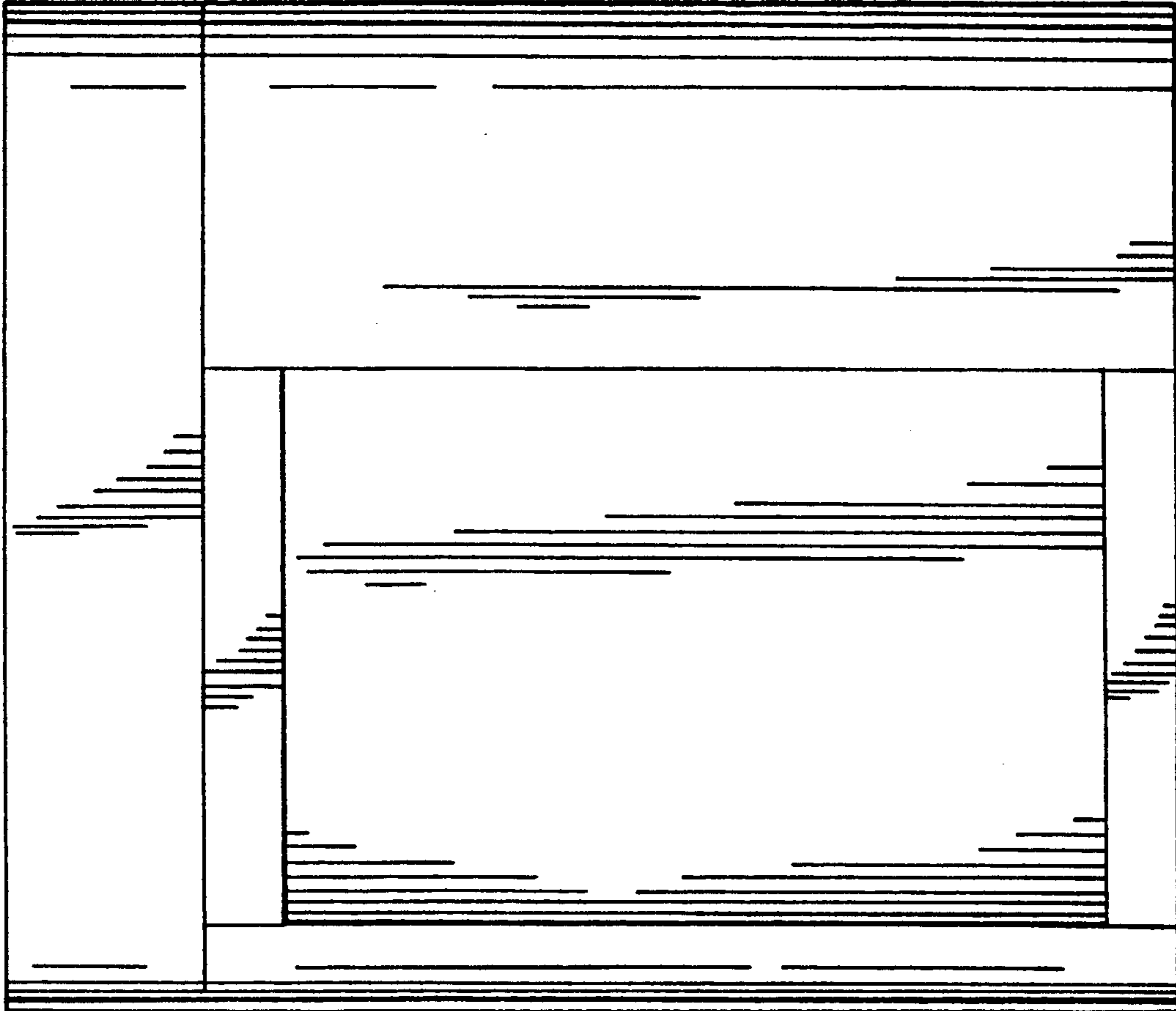

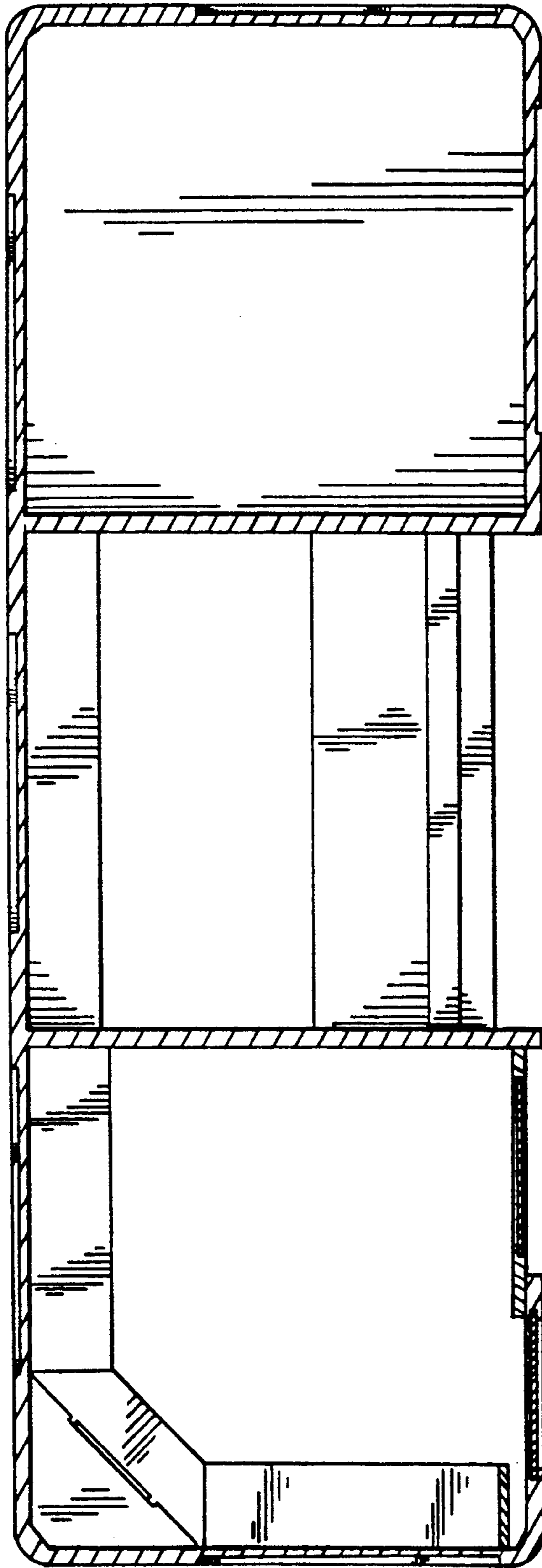
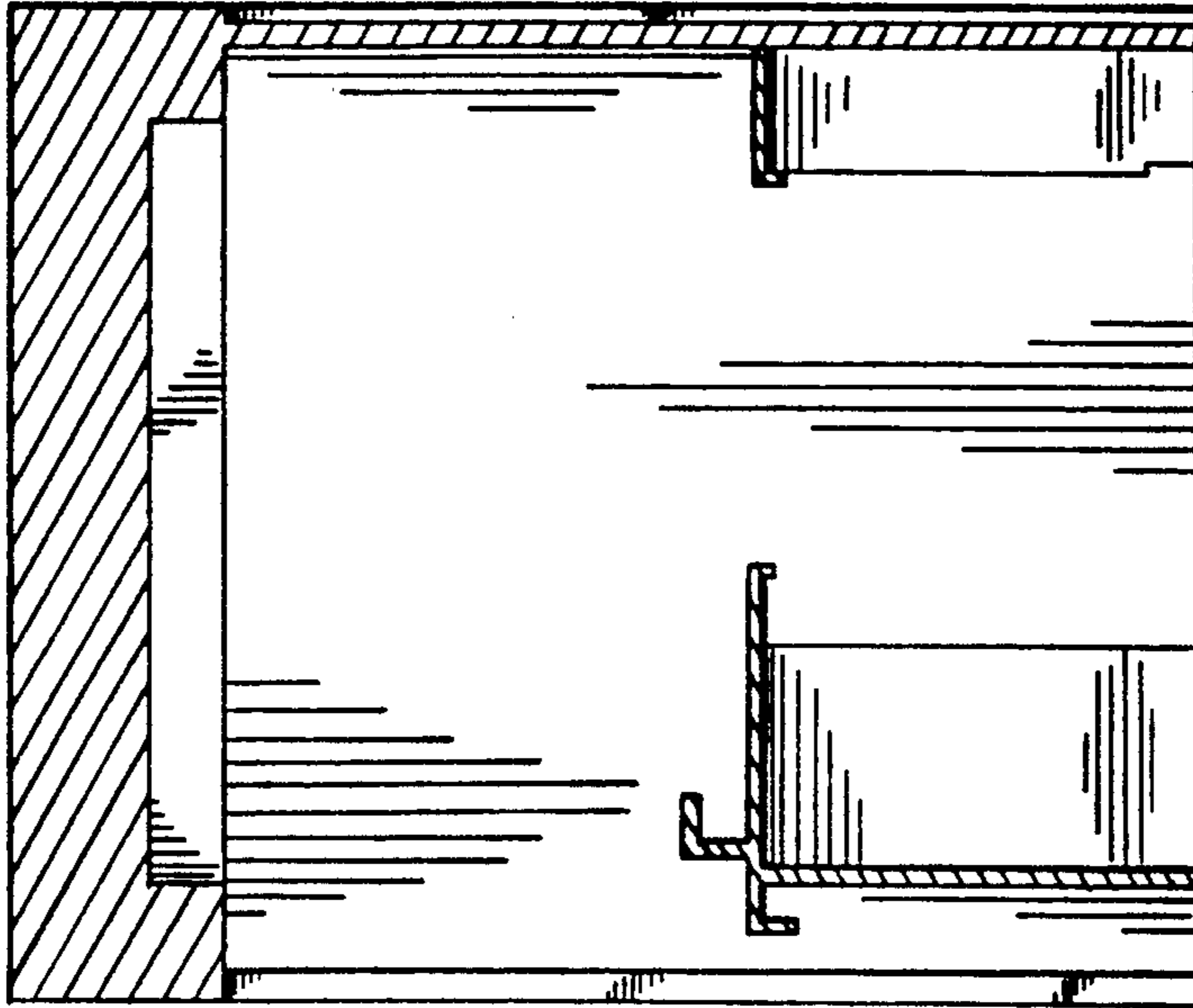
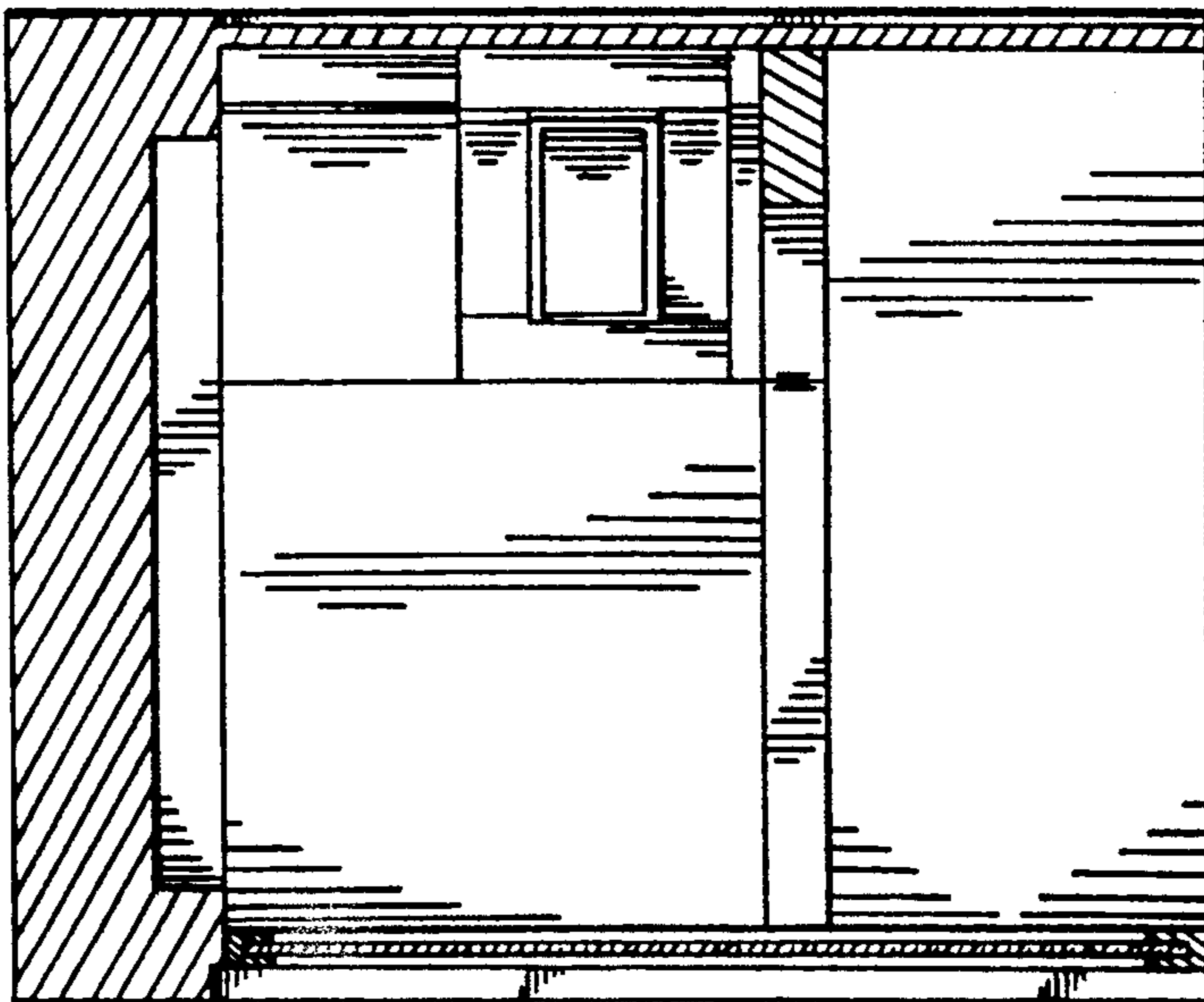
