[57] **CLAIM**

The ornamental design for a shoe midsole, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of one side of a shoe midsole embodying my new design;

FIG. 2 is a side elevational view of the other side of the midsole shown in FIG. 1;

FIG. 3 is a front elevational view of the midsole shown in FIG. 1;

FIG. 4 is a rear elevational view of the midsole shown in FIG. 1;

FIG. 5 is a partial cross-sectional view of the midsole shown in FIG. 1, taken on section line 5—5;

FIG. 6 is a partial cross-section of the midsole shown in FIG. 1, taken on section line 6—6;

FIG. 7 is a partial cross-section of the midsole shown in FIG. 1, taken on section line 7—7; and,

FIG. 8 is a partial cross-section of the midsole in FIG. 1, taken on line 8—8 appearing in FIG. 2.

The broken line showing of a shoe upper and outsole is for illustrative purposes and forms no part of the claimed design.

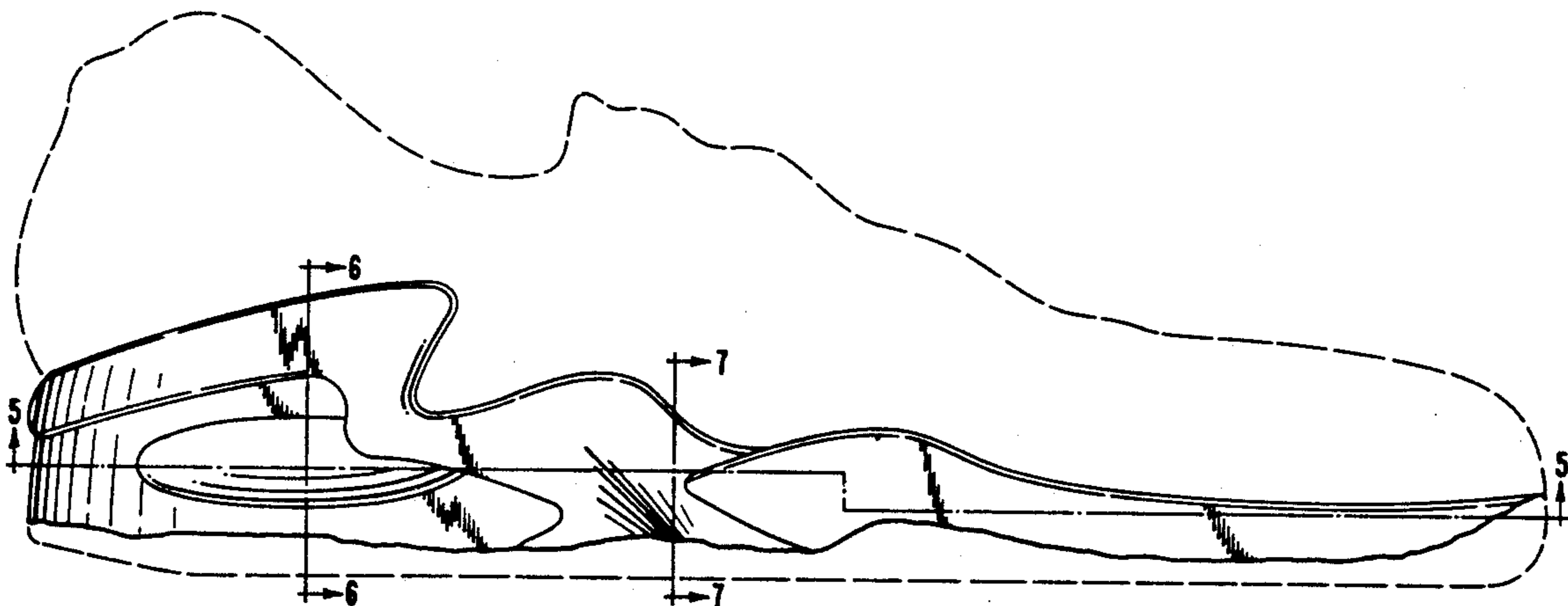
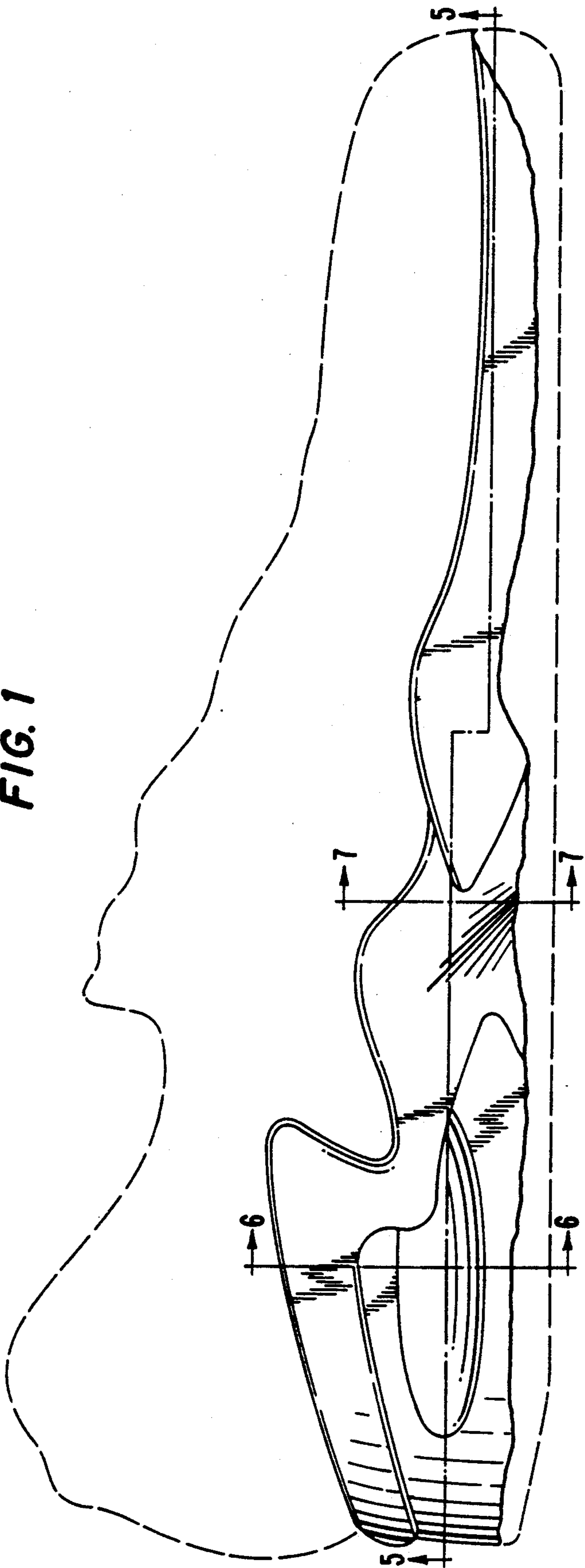

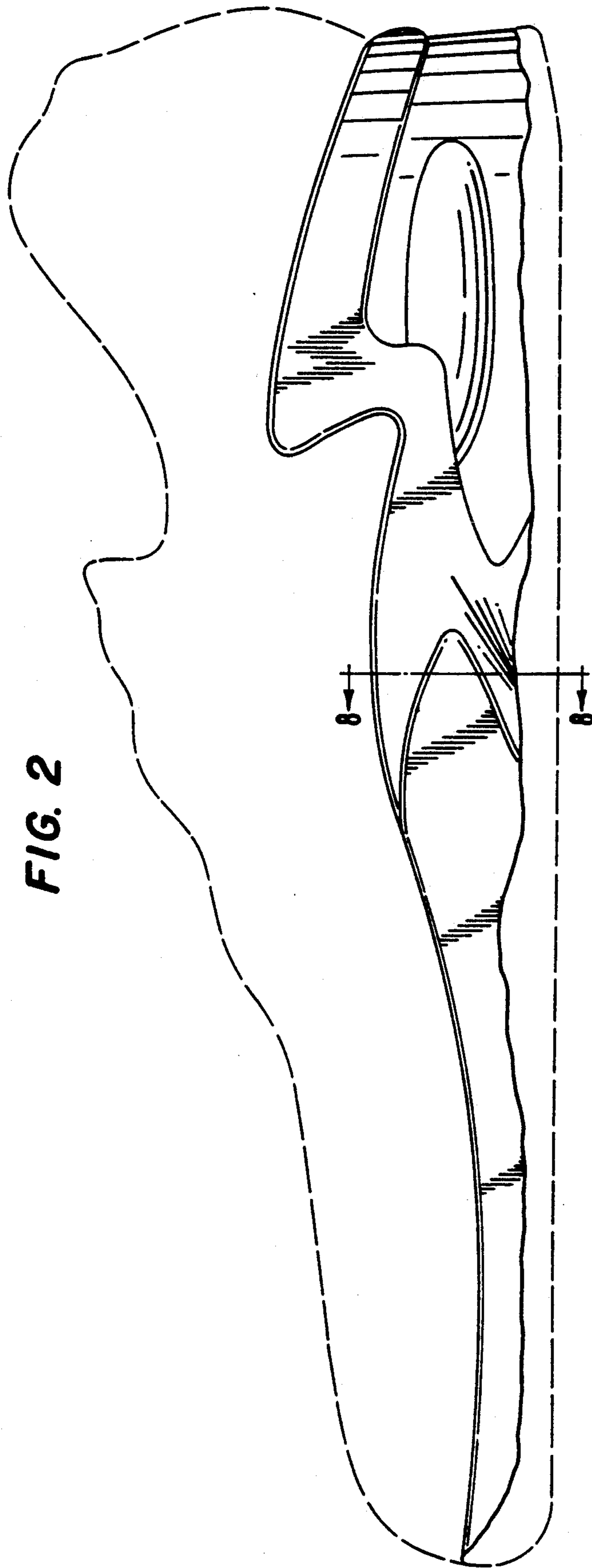

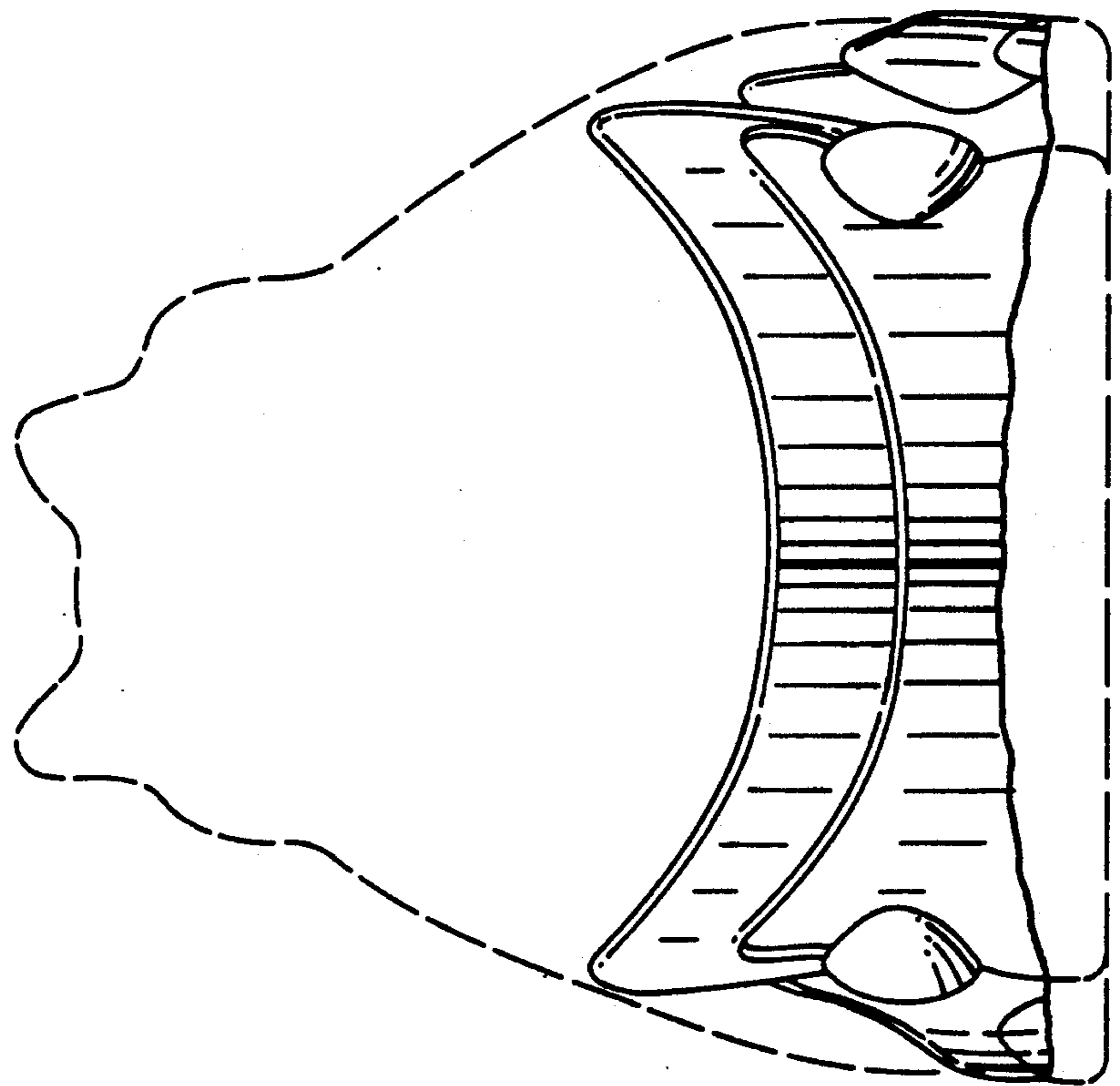

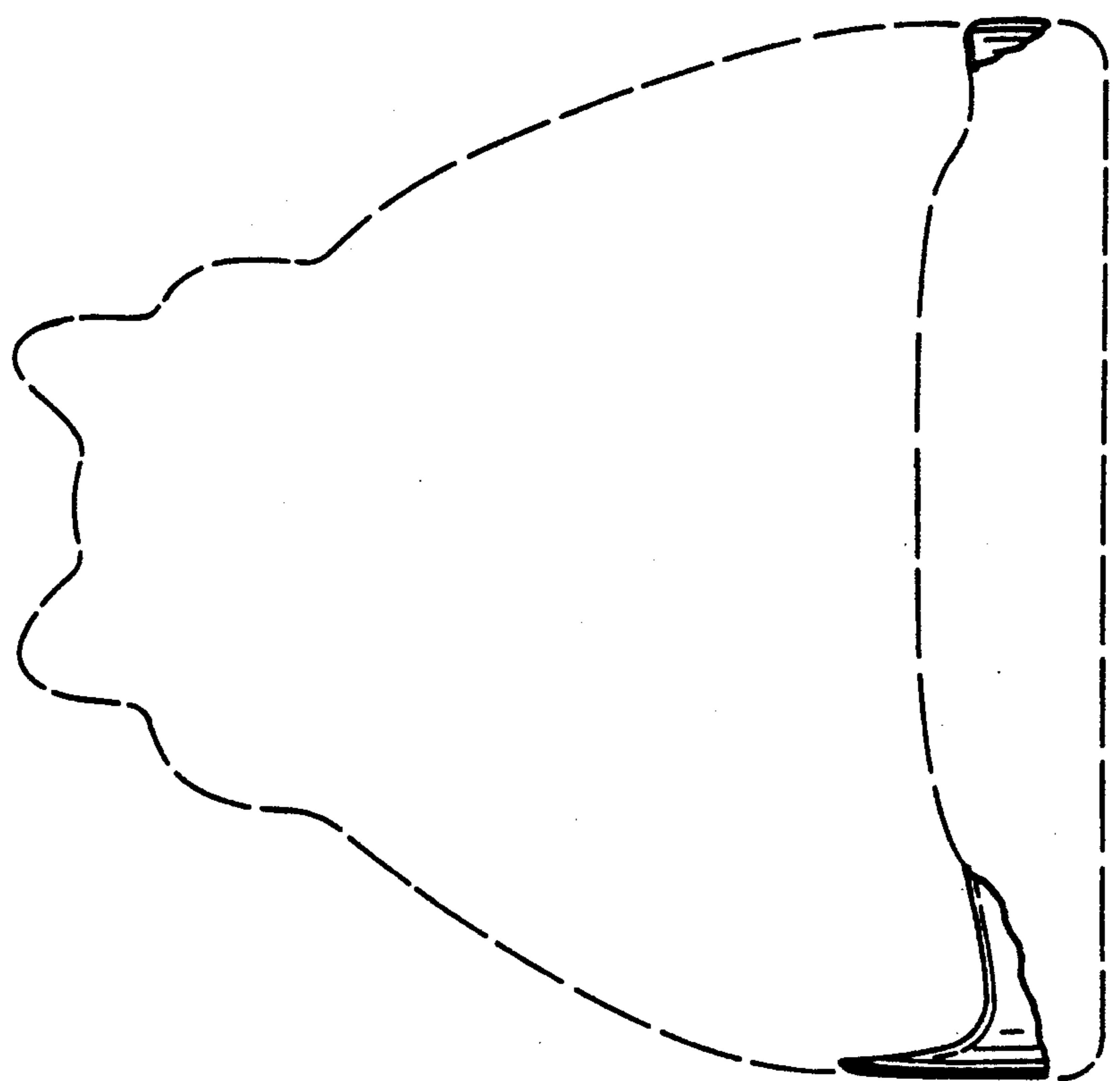

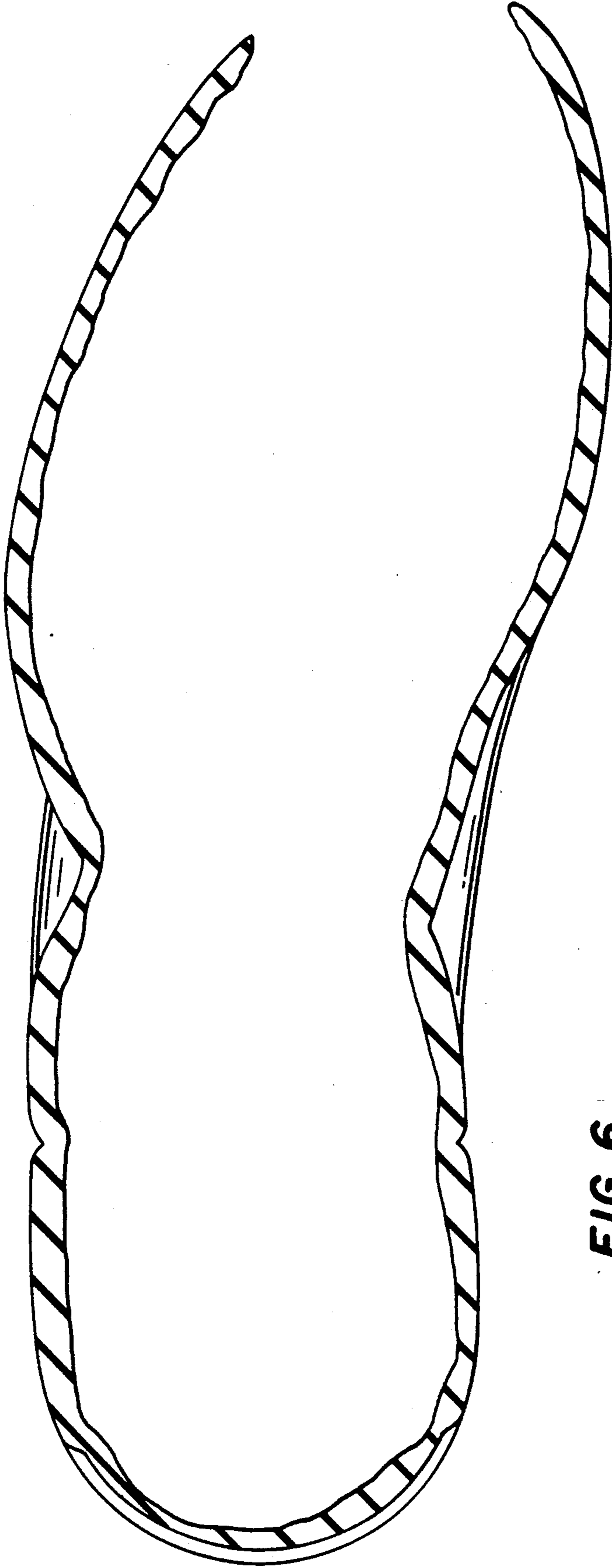
