The ornamental design for a boat fender cover, as shown and described.

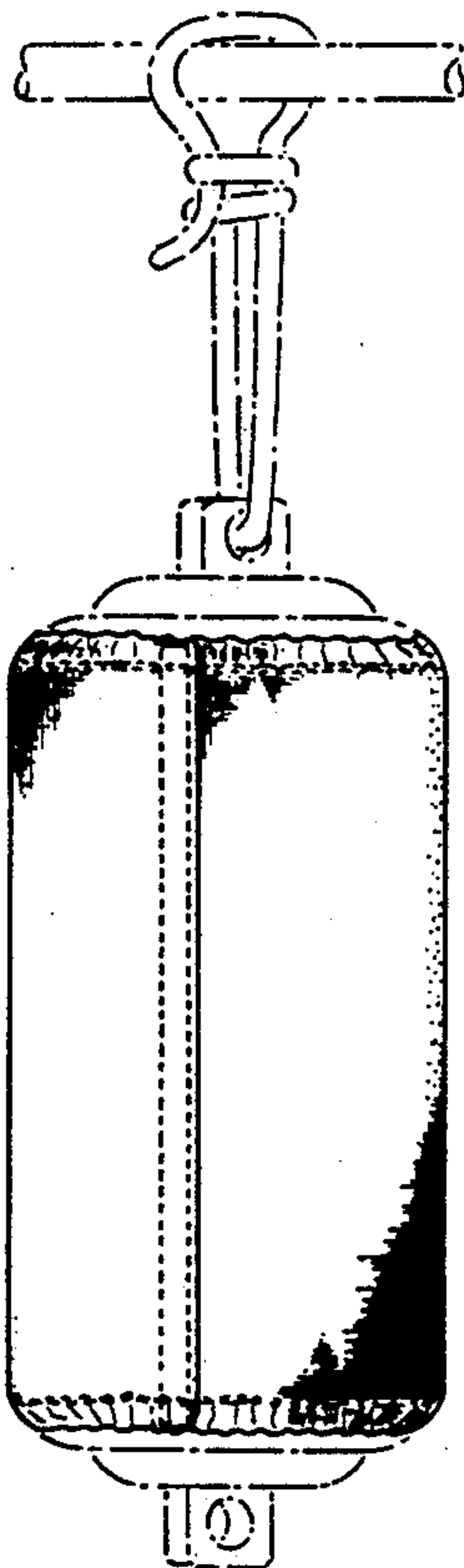

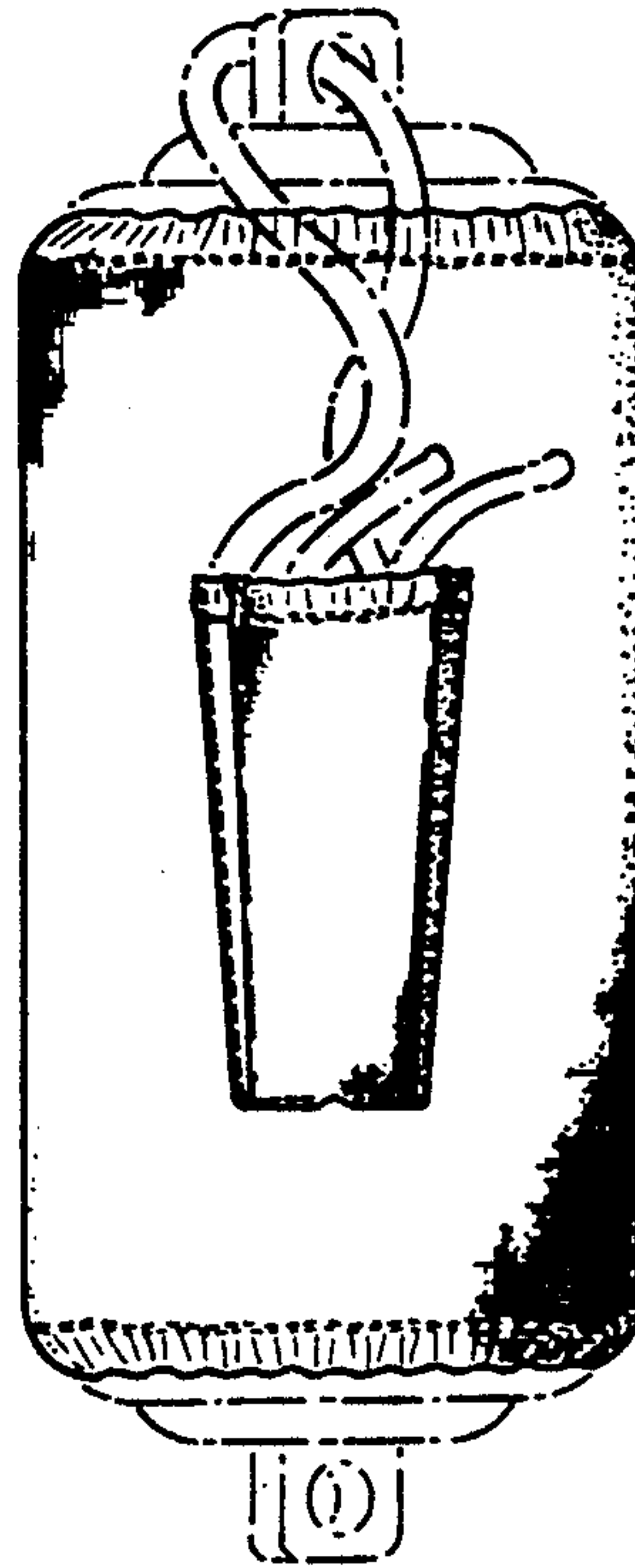
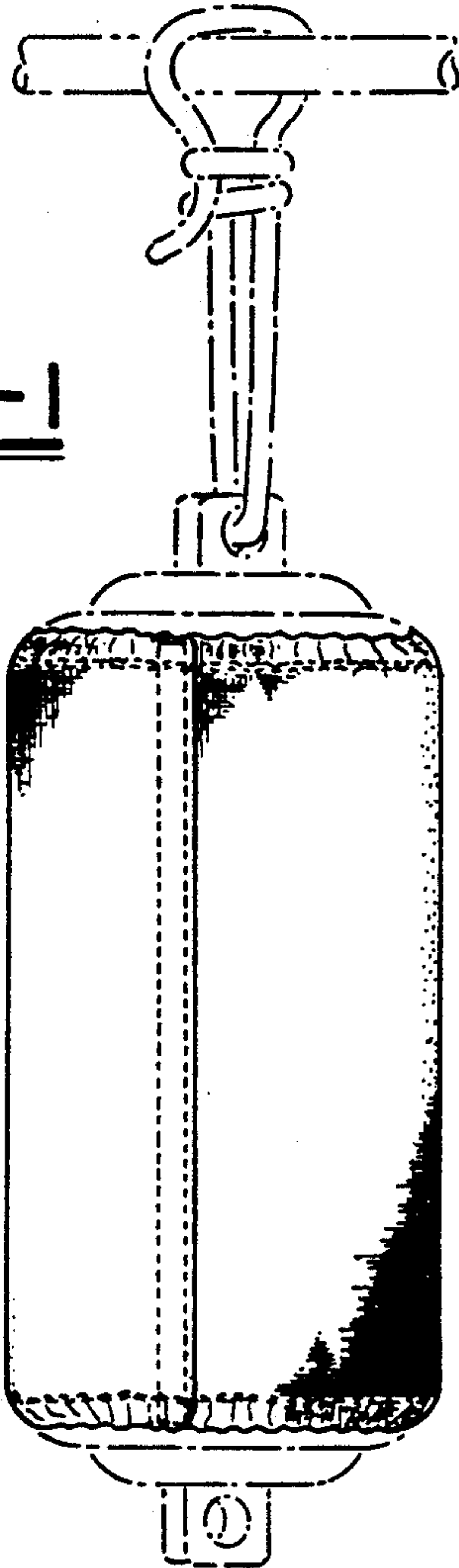

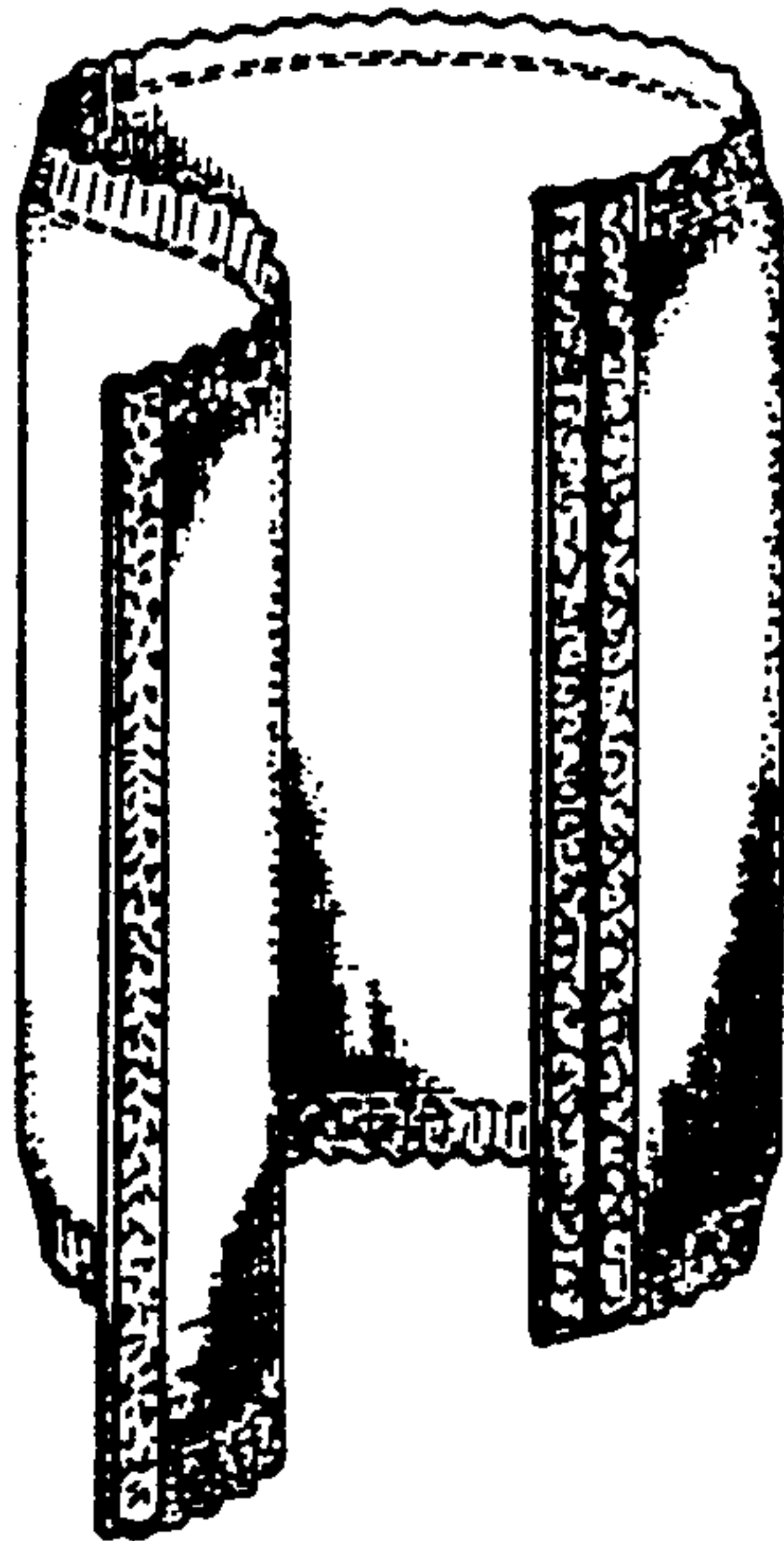

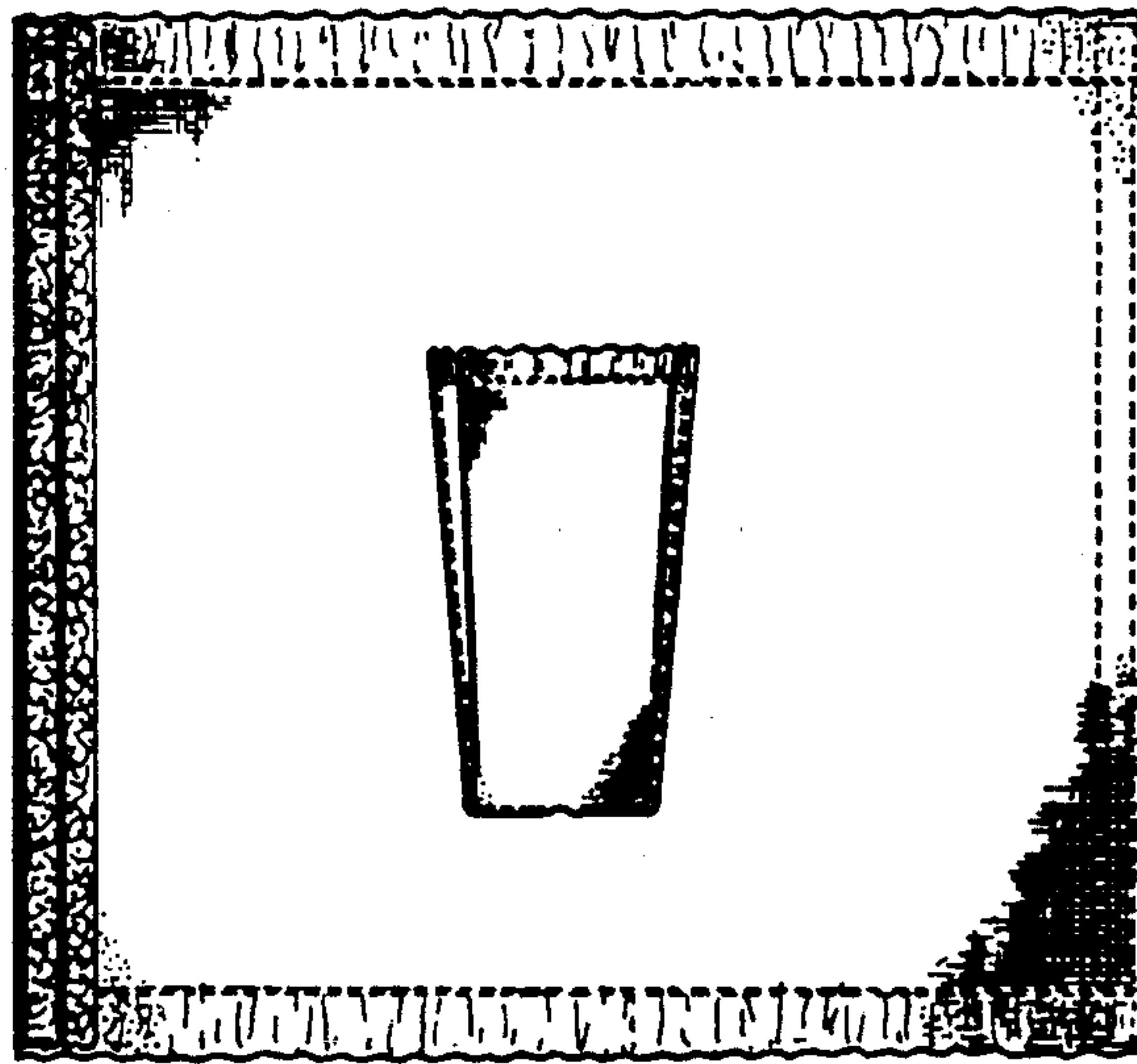

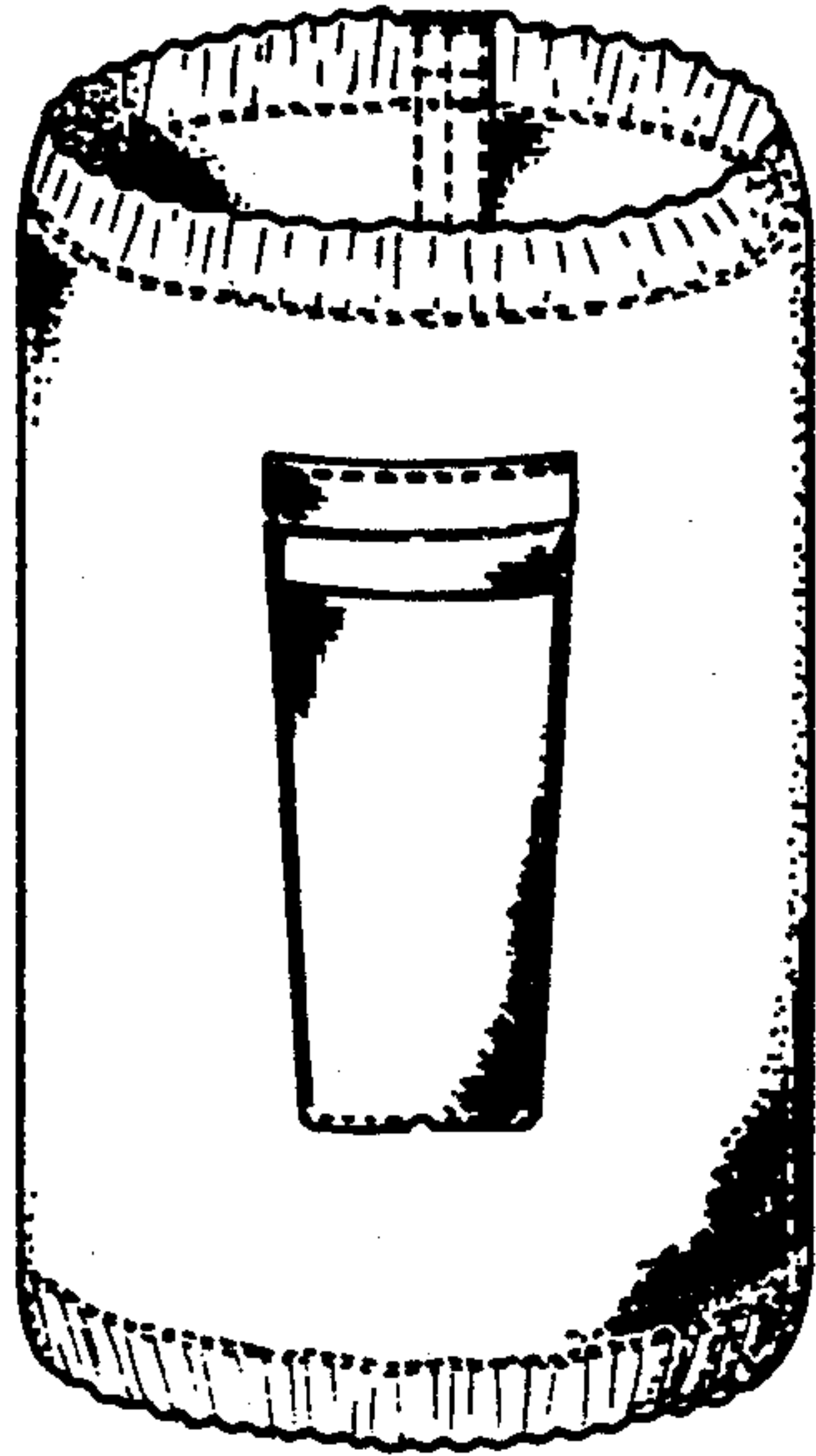

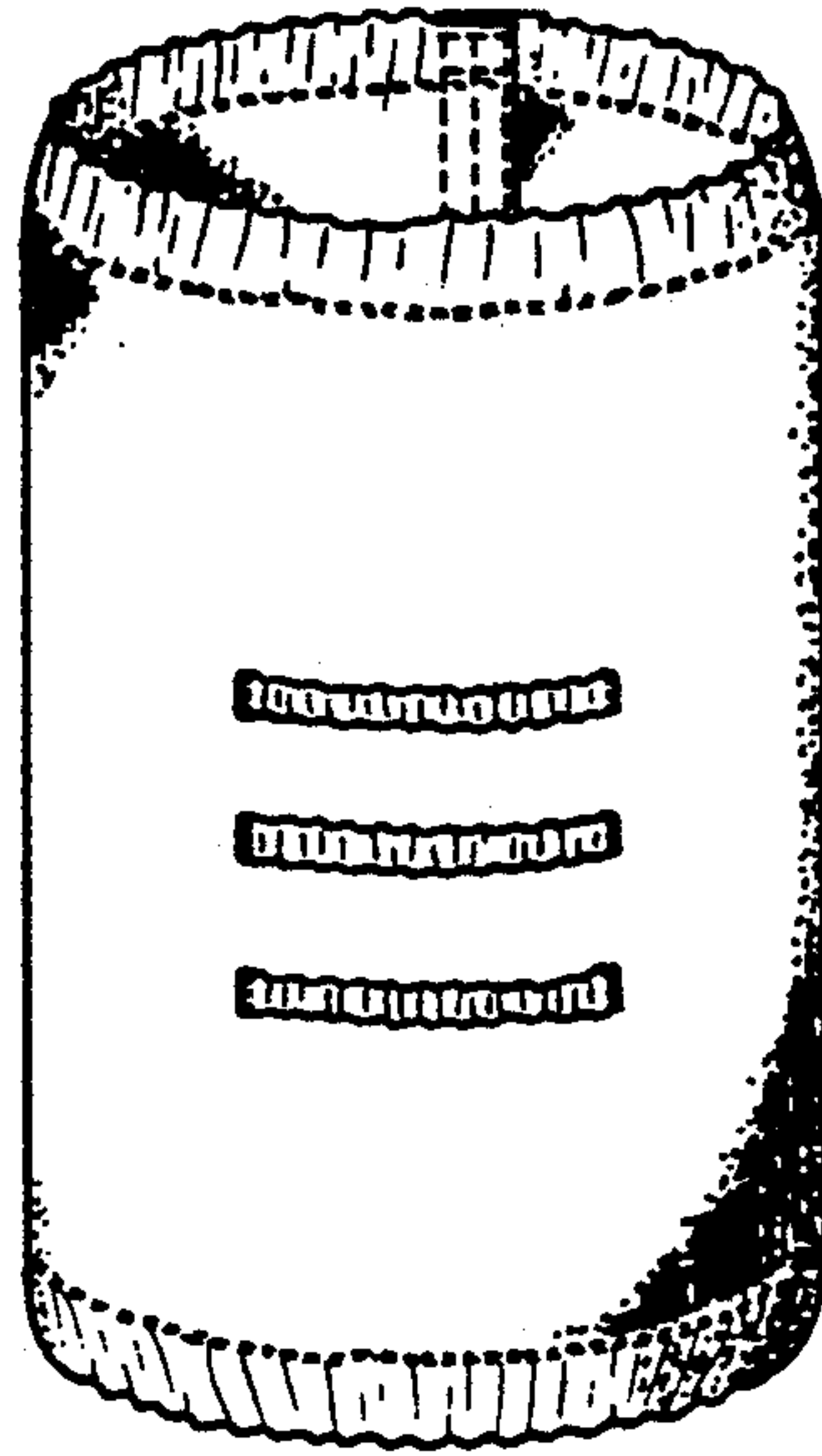

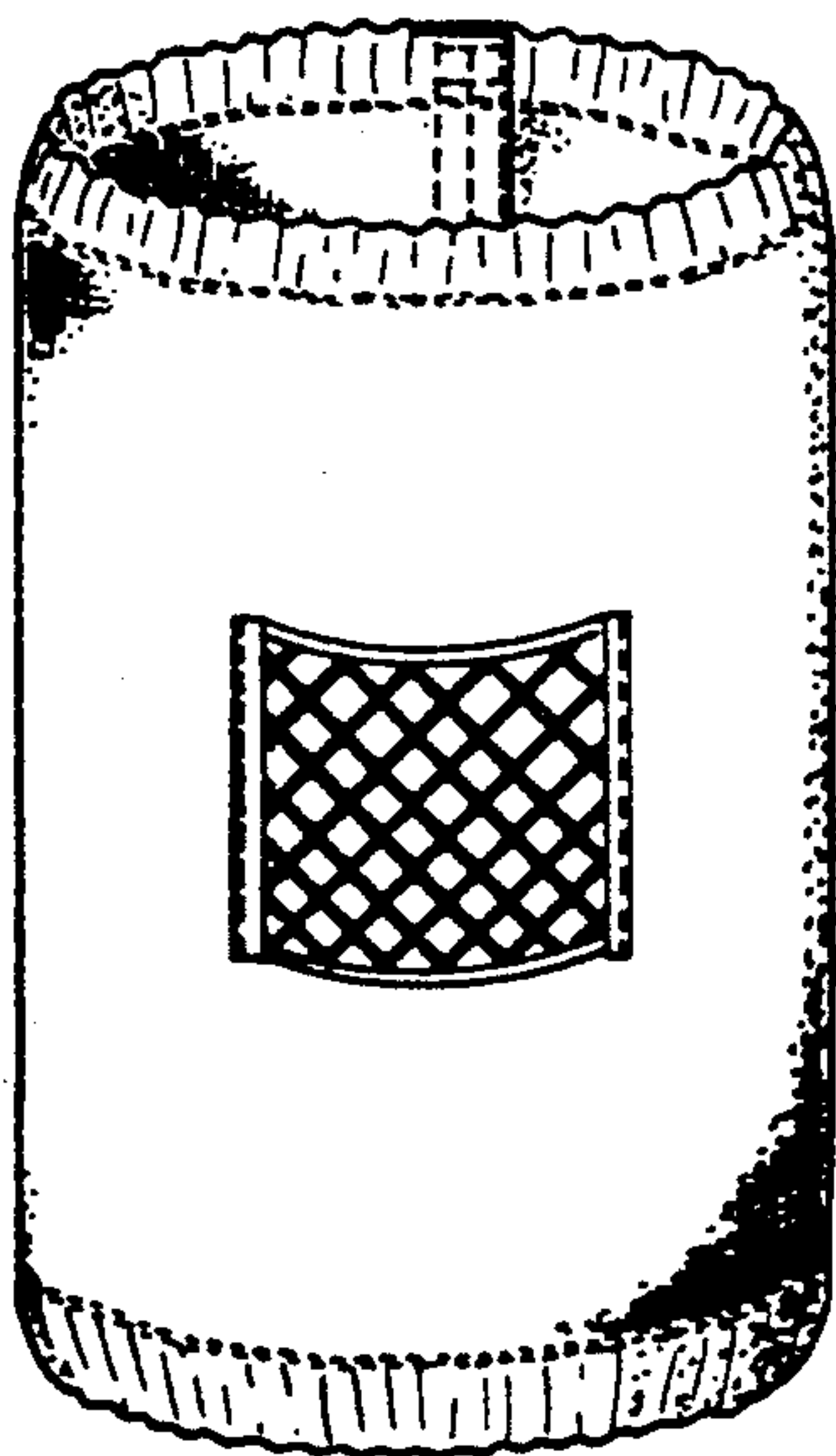

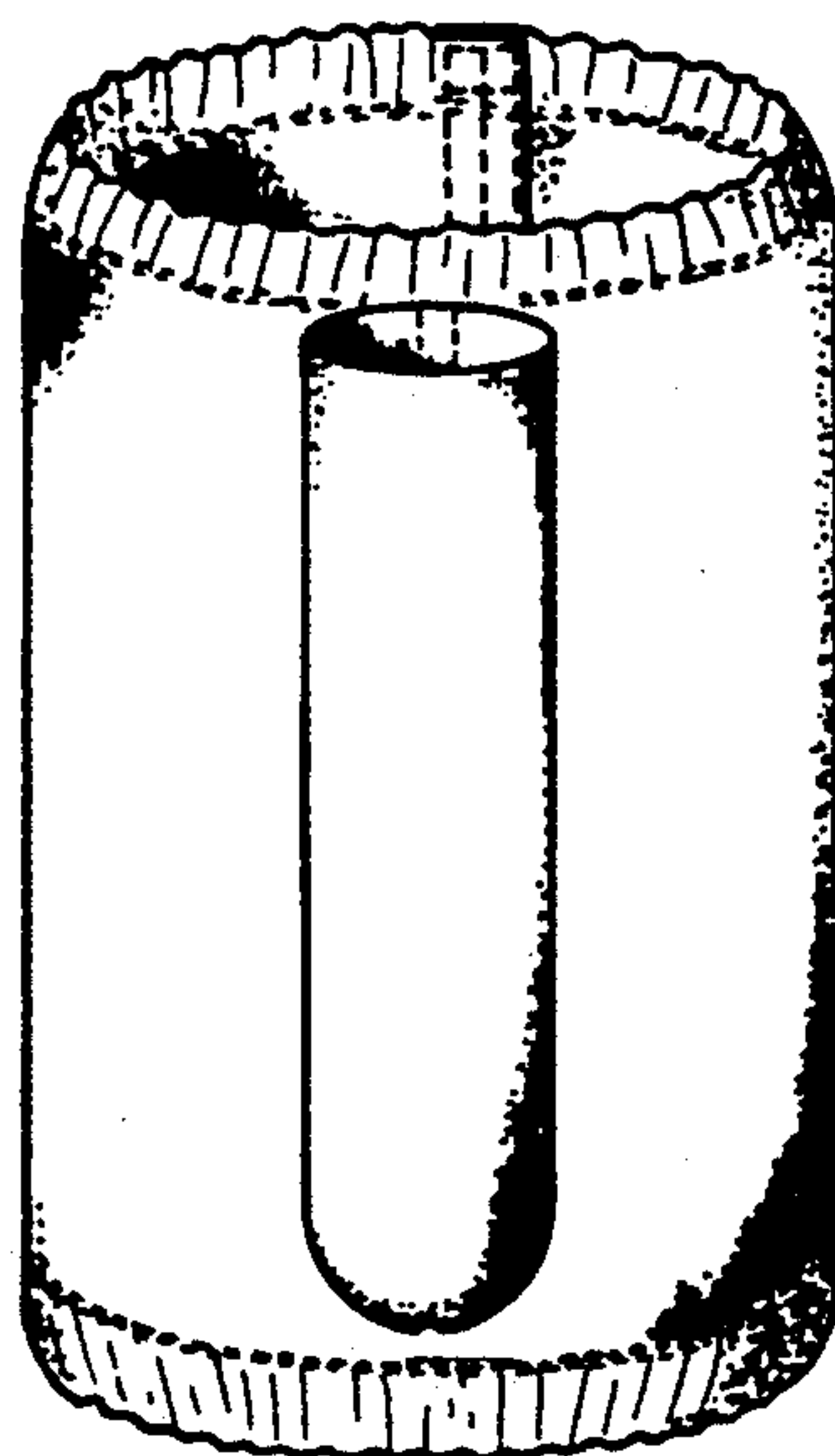

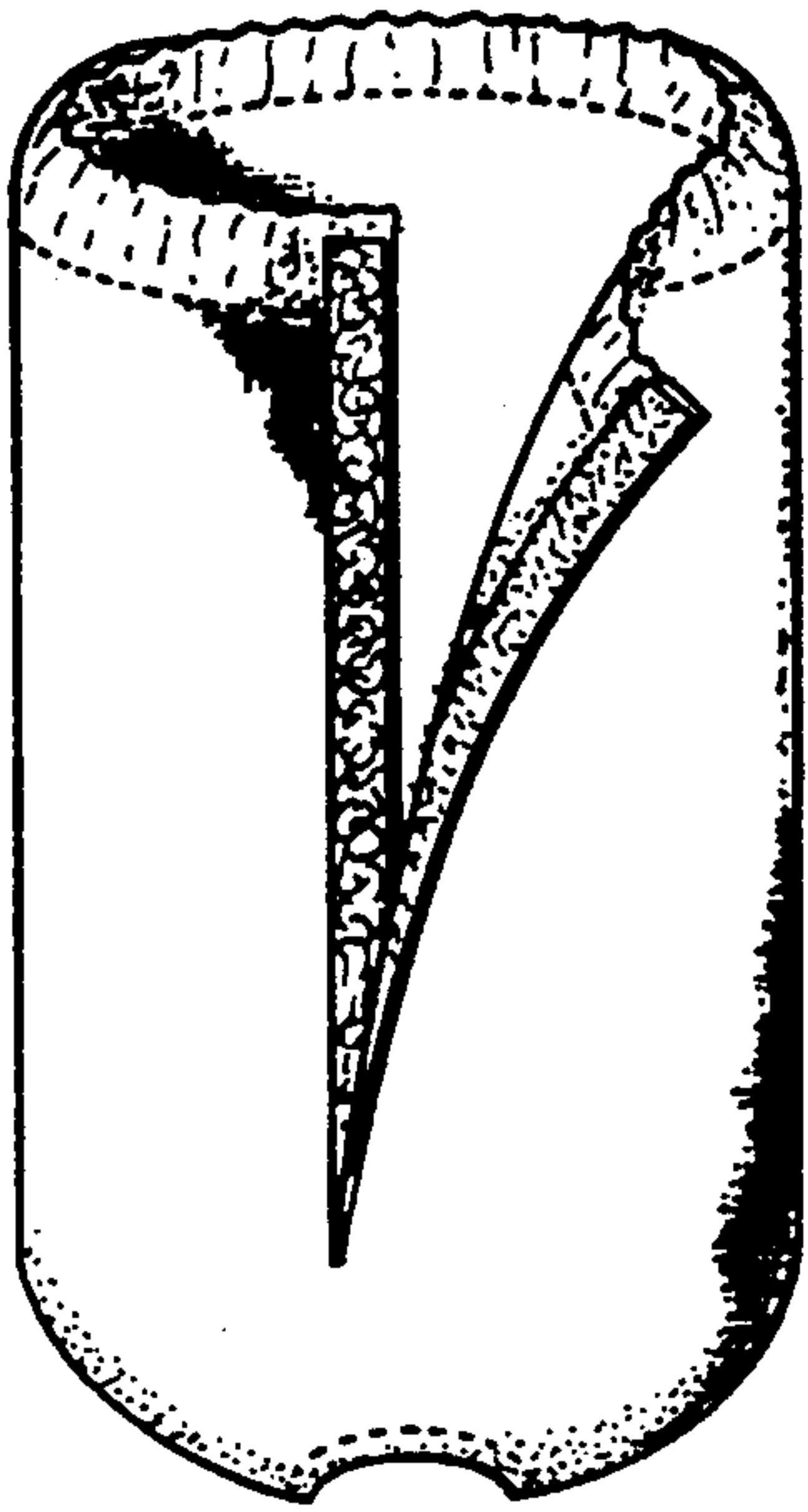

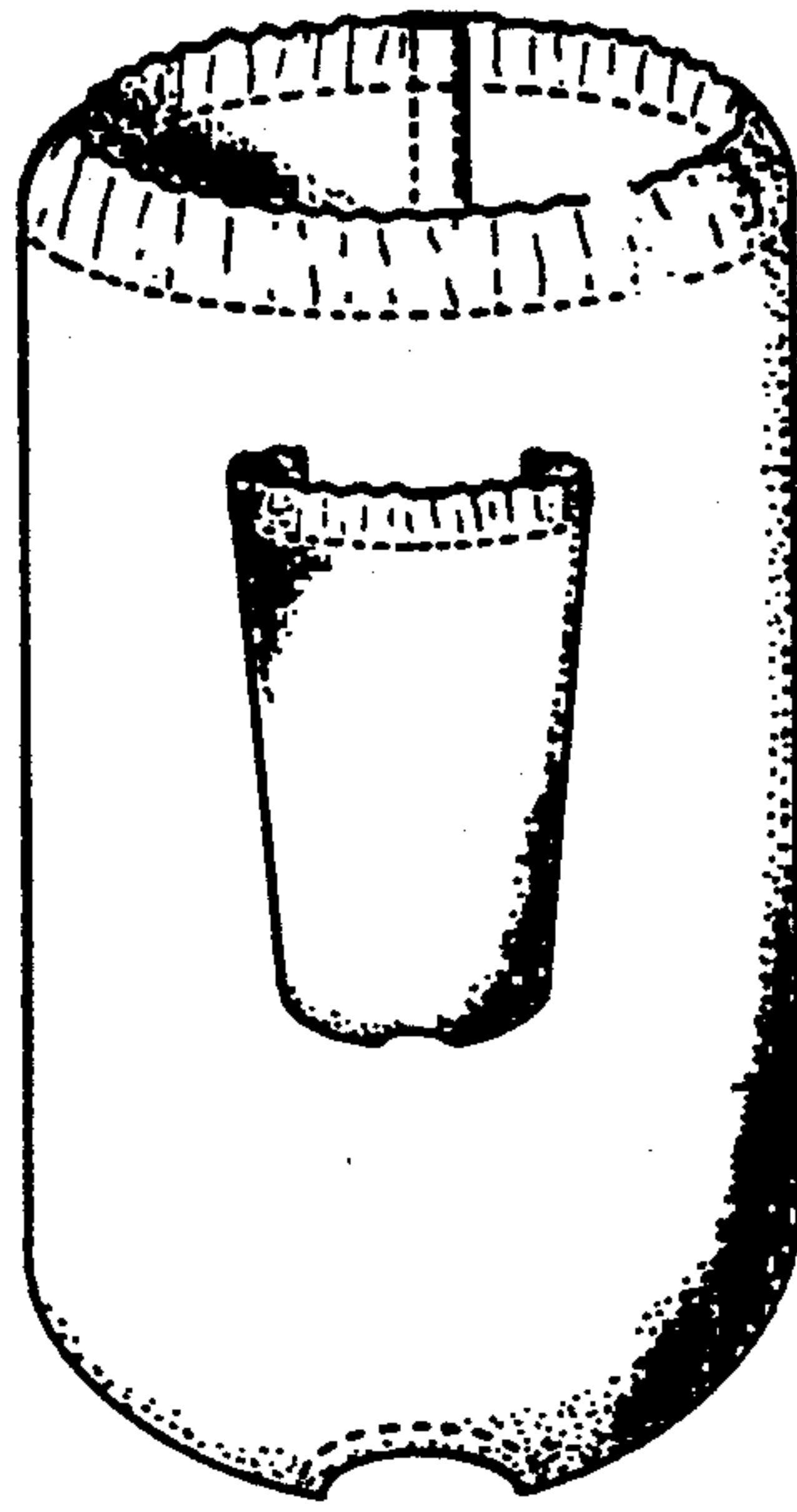

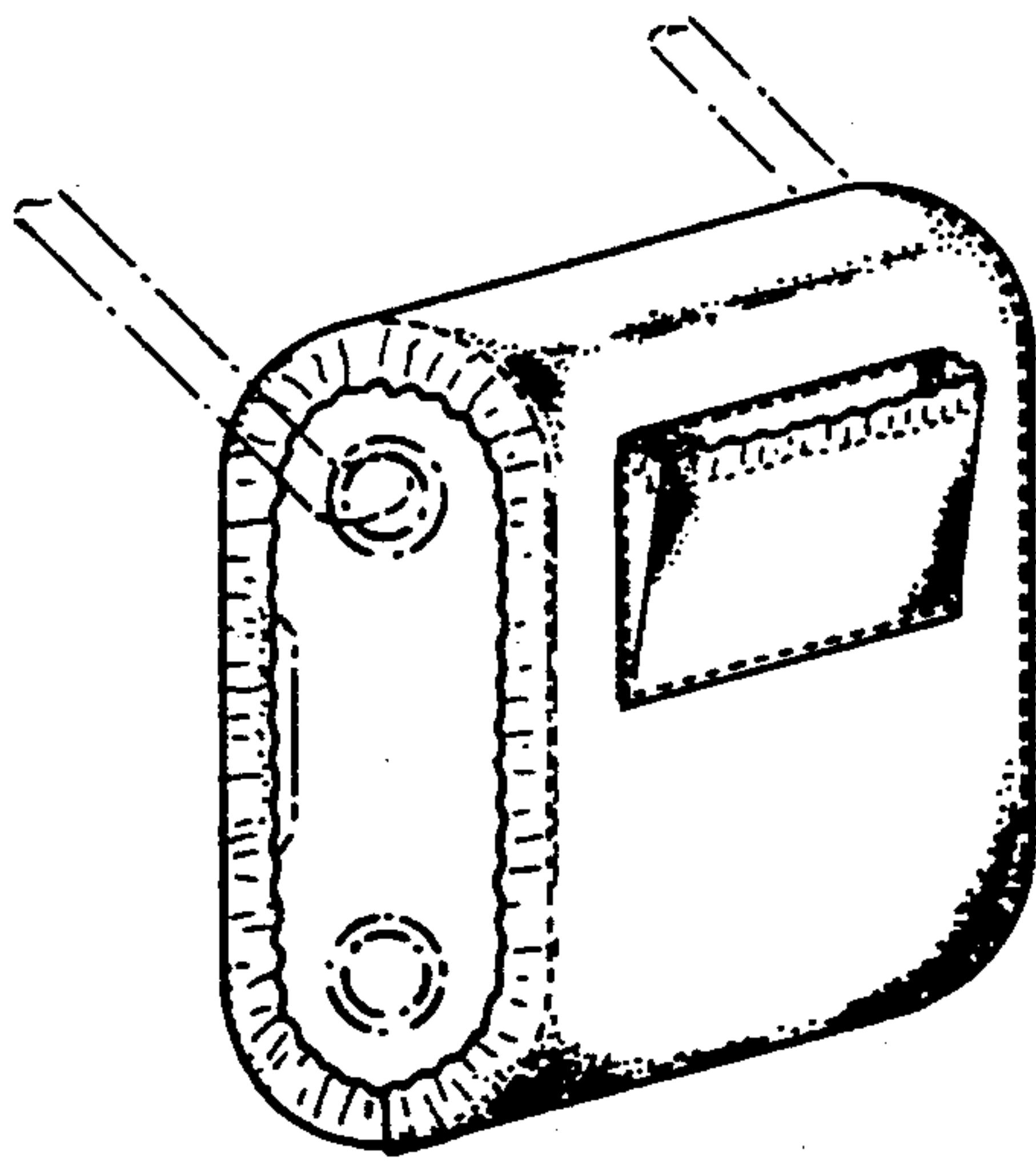

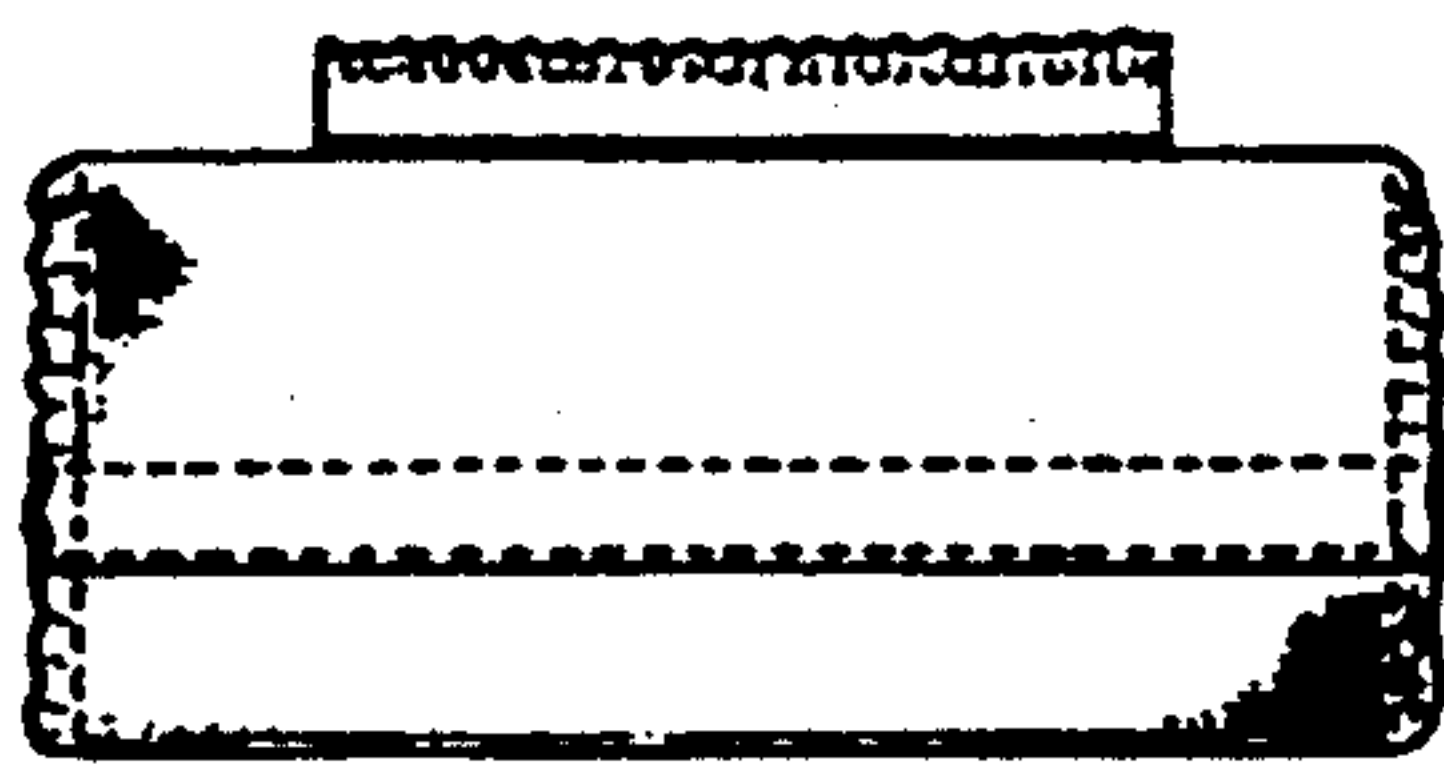
