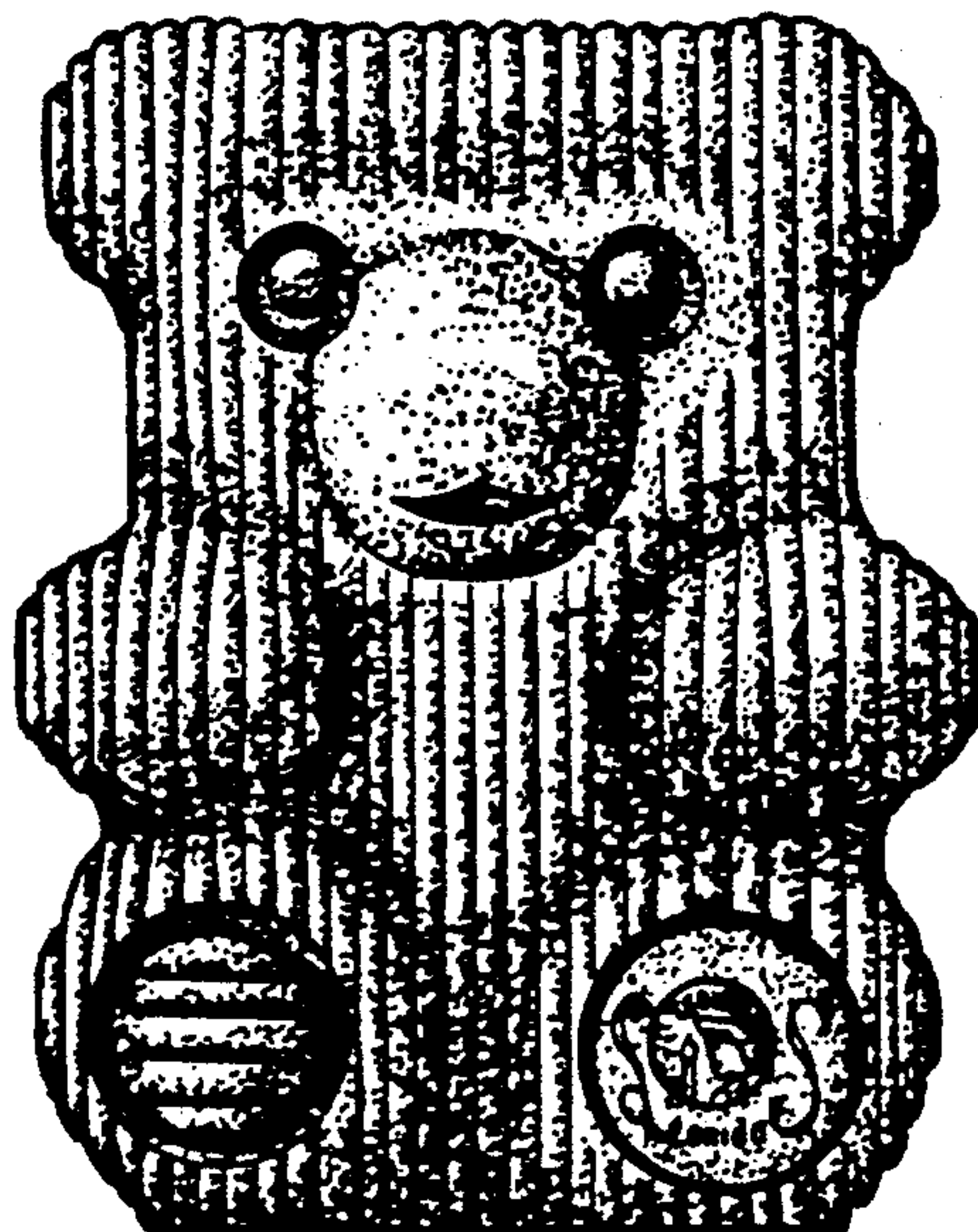

[57] **CLAIM**

The ornamental design for a chocolate candy in the shape of a bear, as shown.

DESCRIPTION

FIG. 1 is a front elevational view of chocolate candy in the shape of a bear showing my new design;
FIG. 2 is a bottom plan view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a side elevational view thereof taken from the left; and,
FIG. 6 is a side elevational view thereof taken from the right.



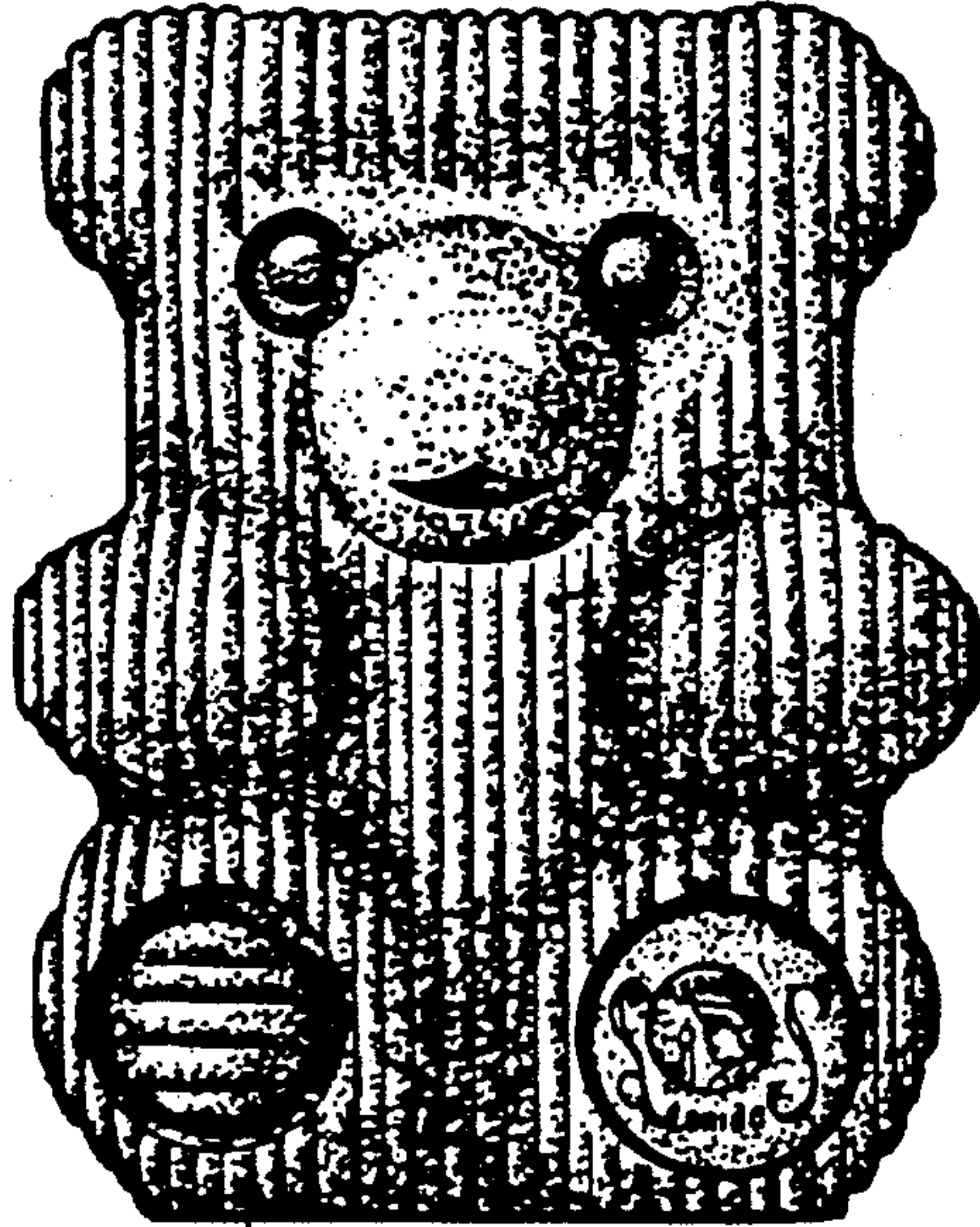

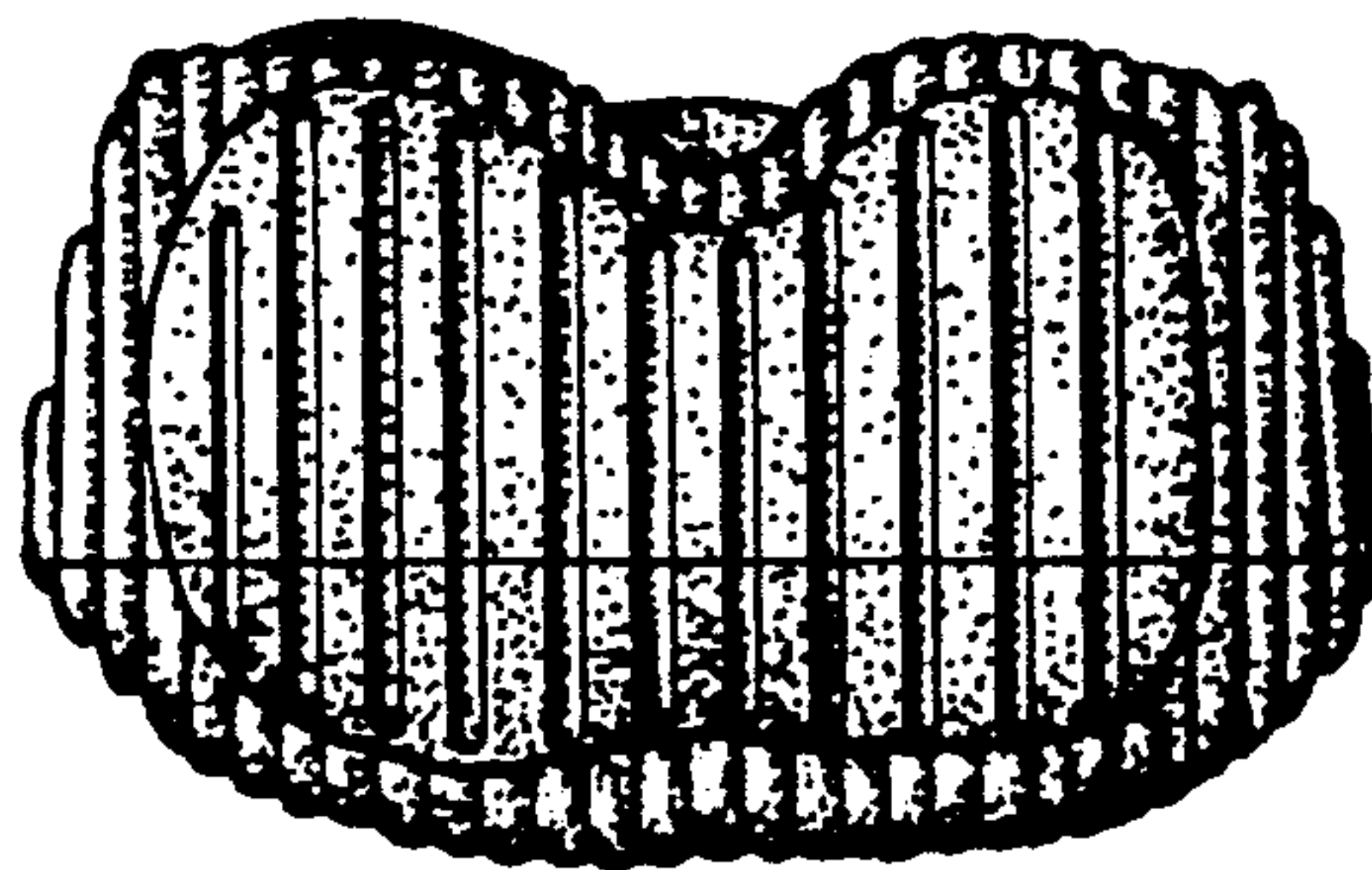

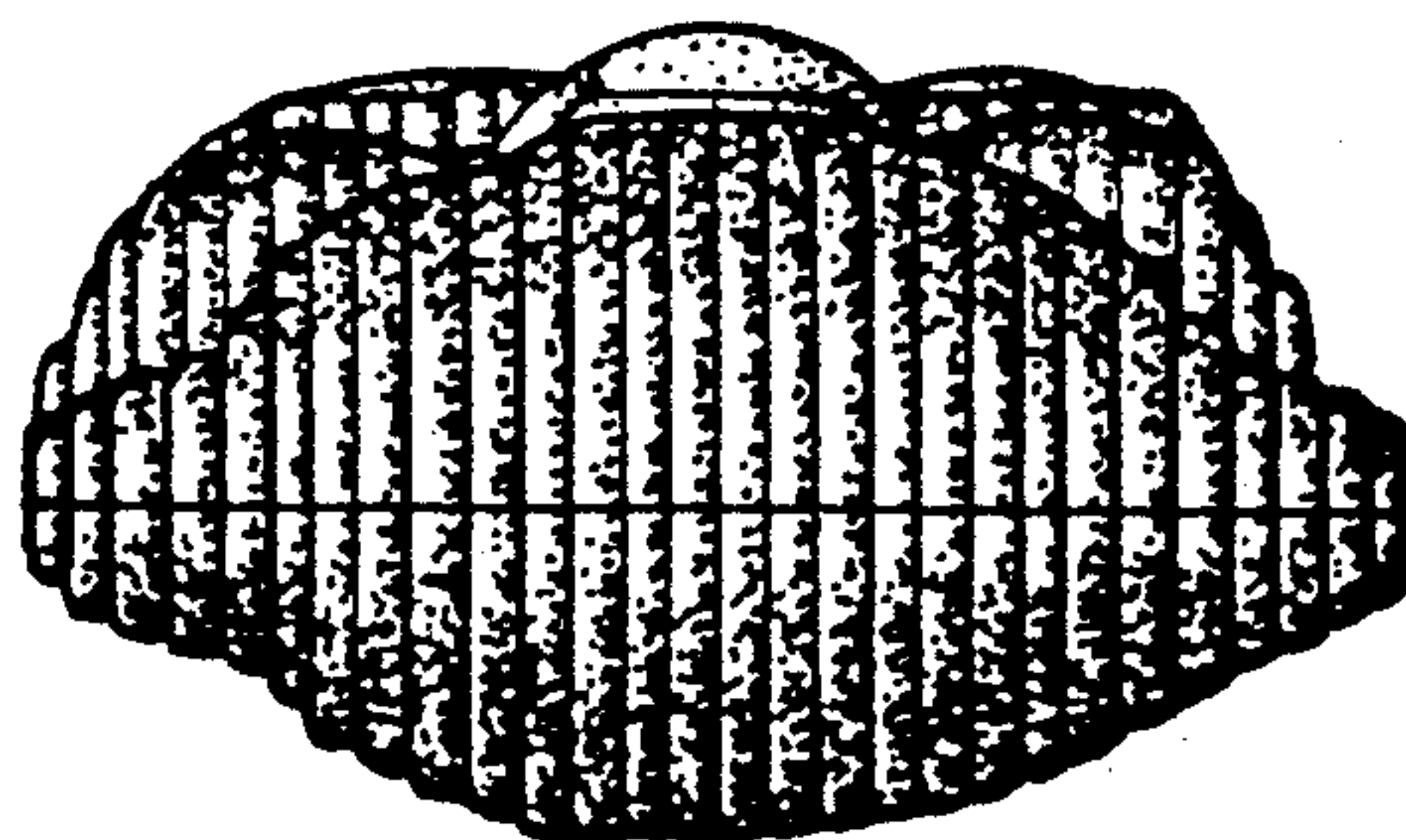

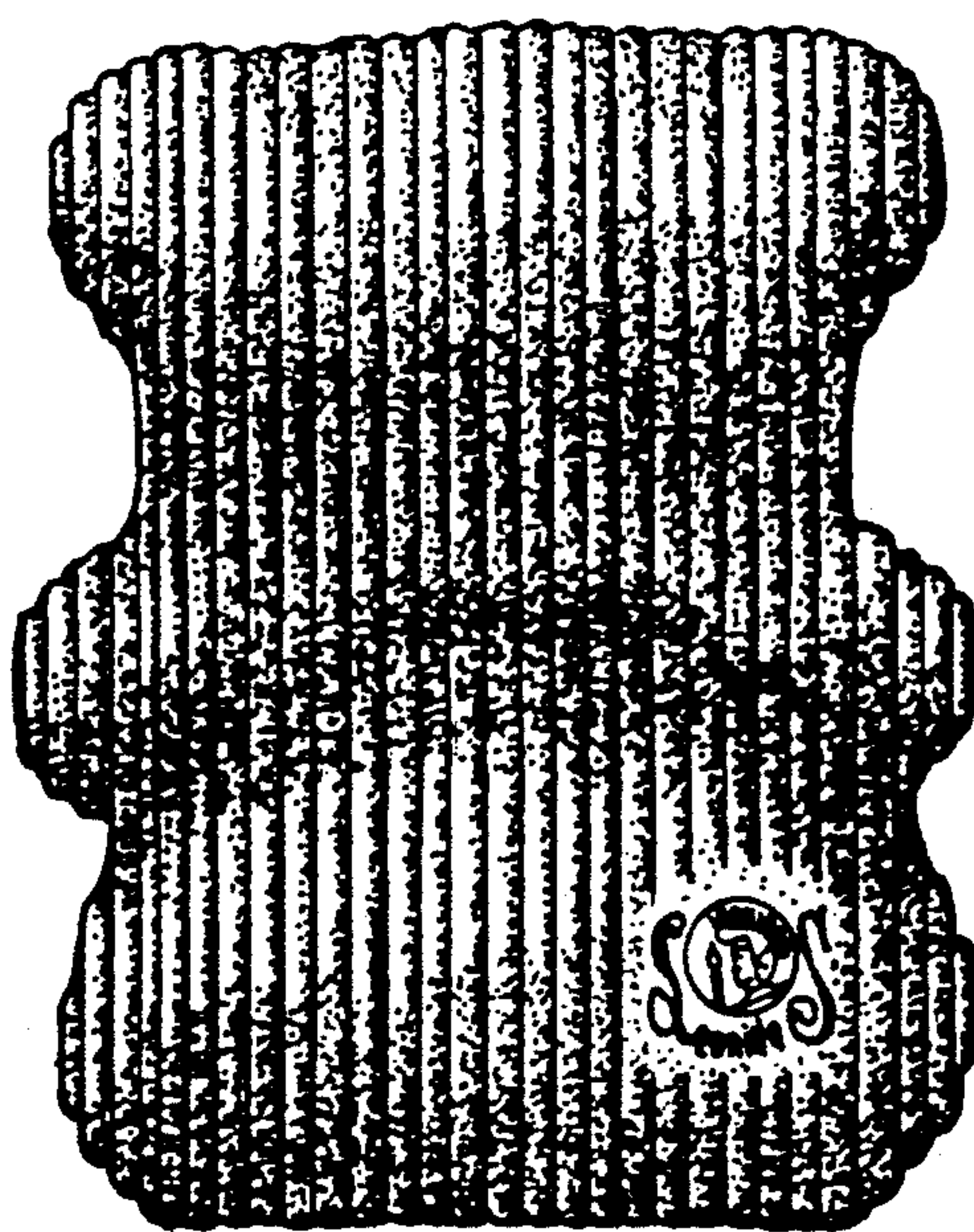

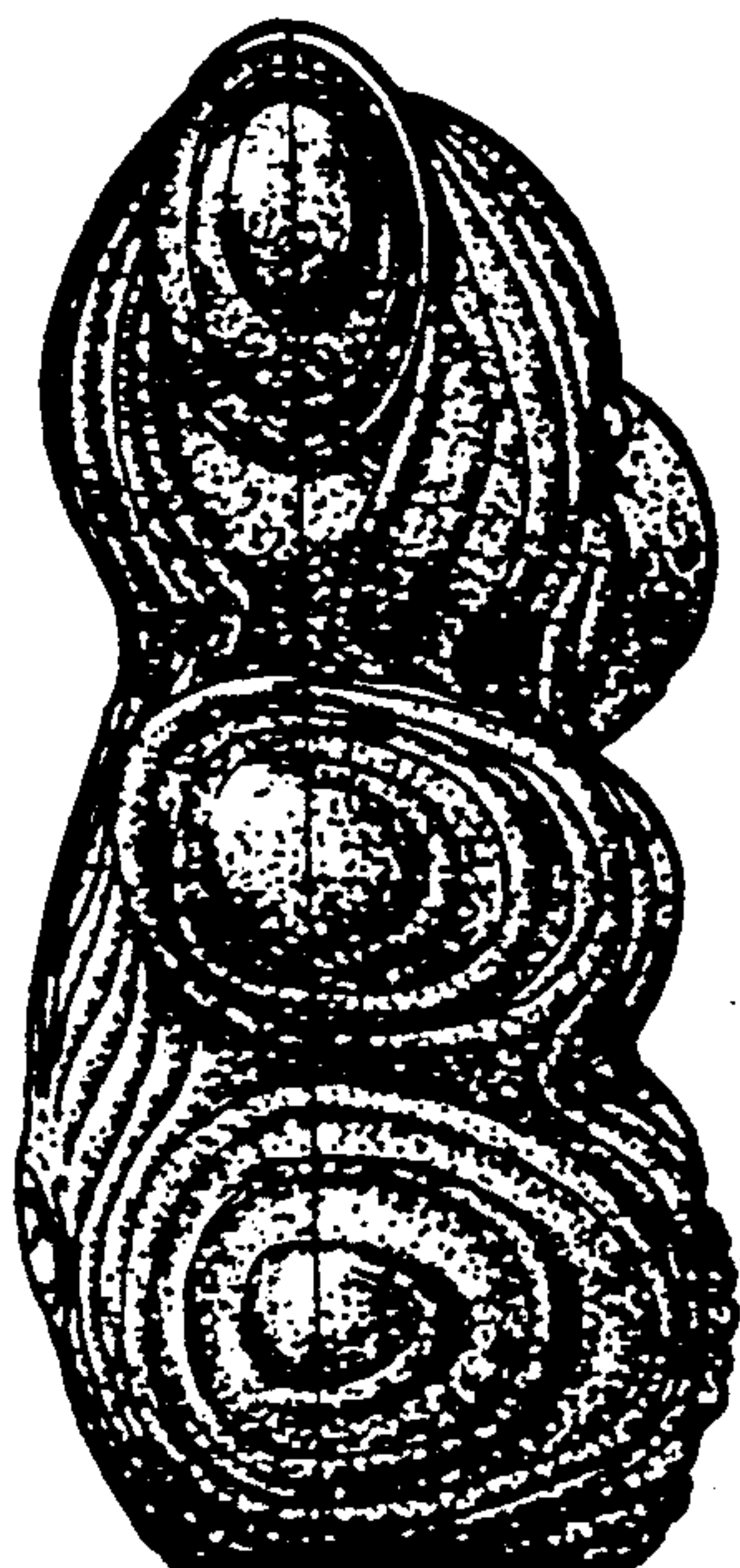
