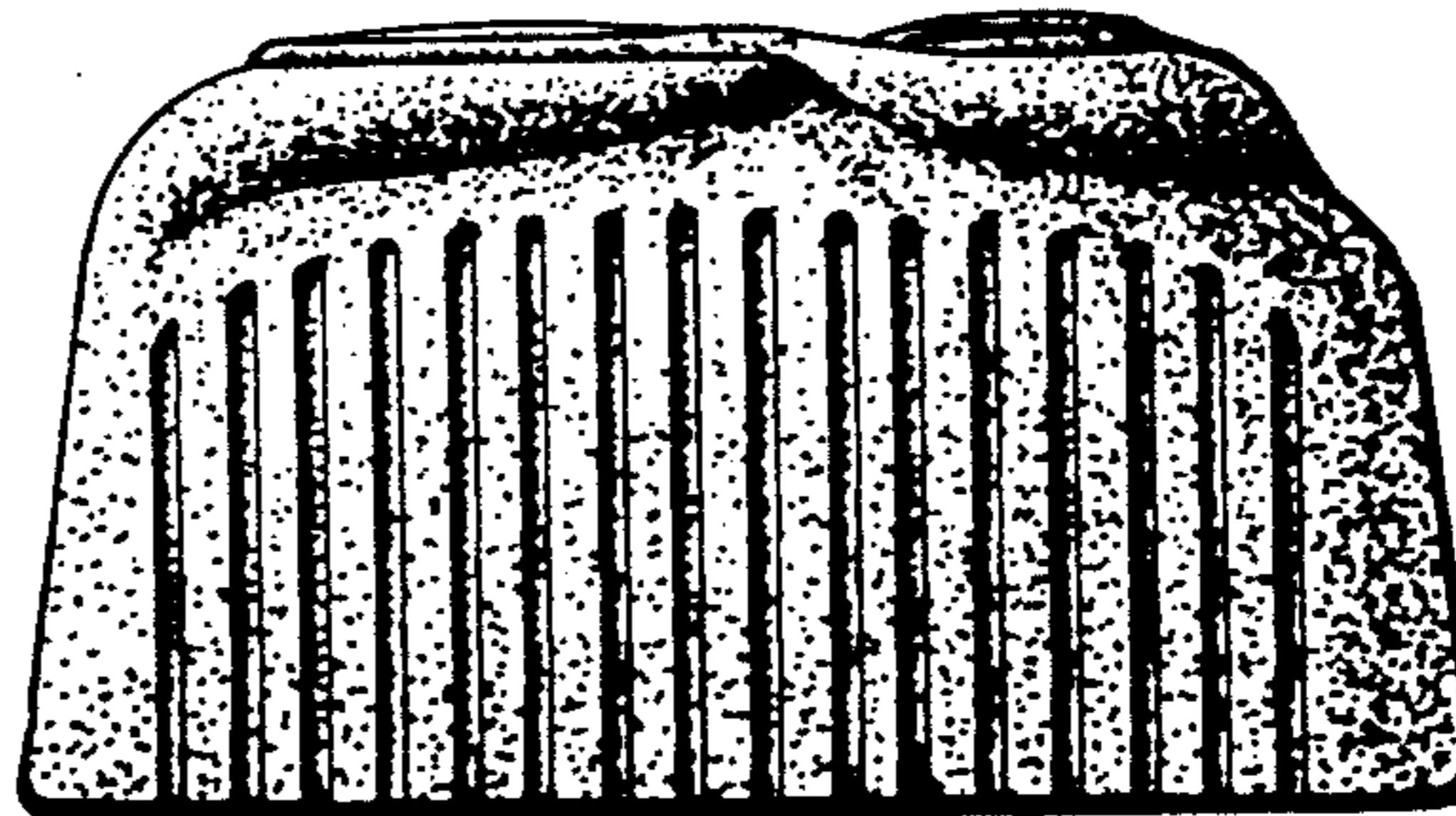
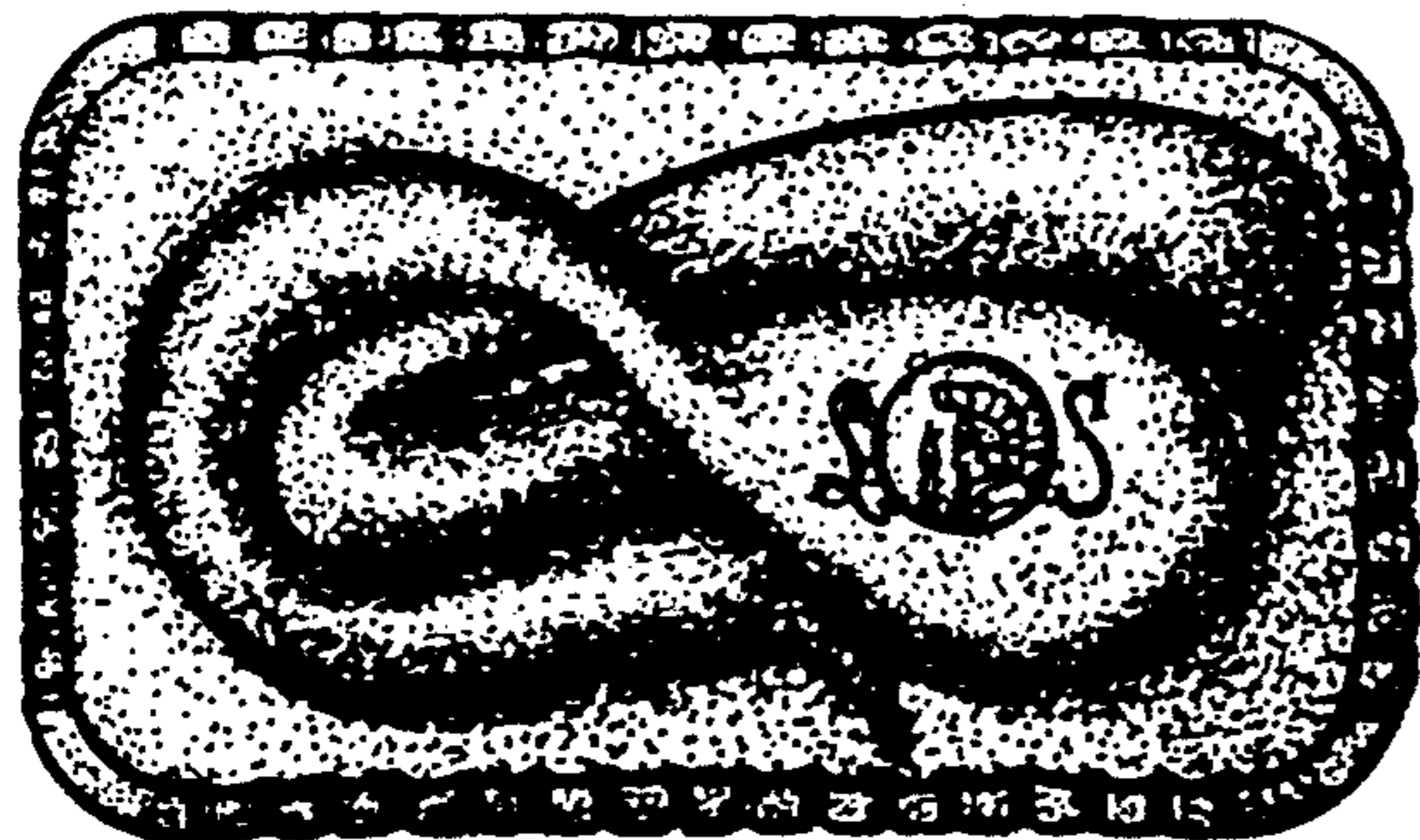

FIG. 1 is a top plan view of chocolate candy showing my new design;

FIG. 6 is a right side elevational view thereof taken.



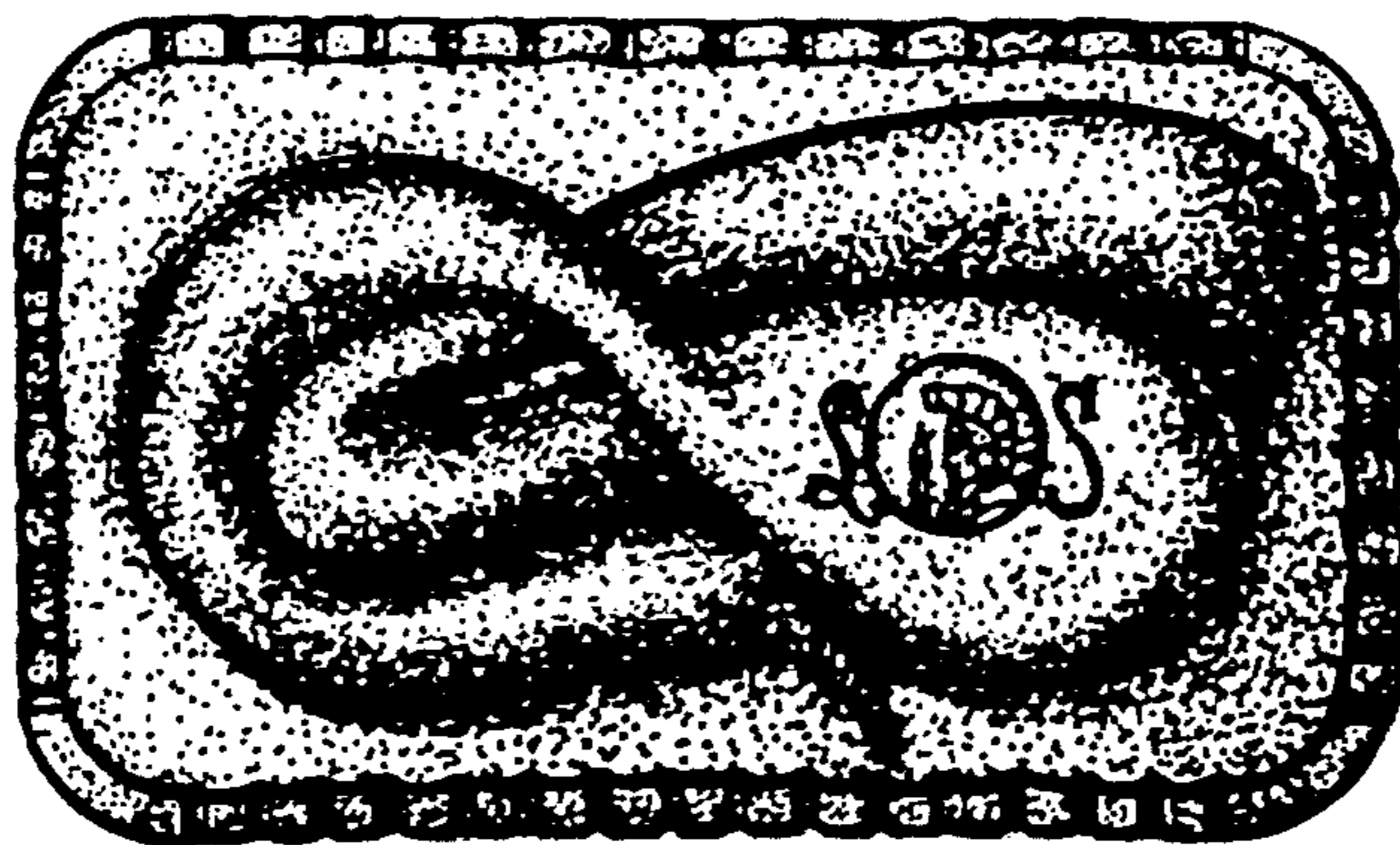

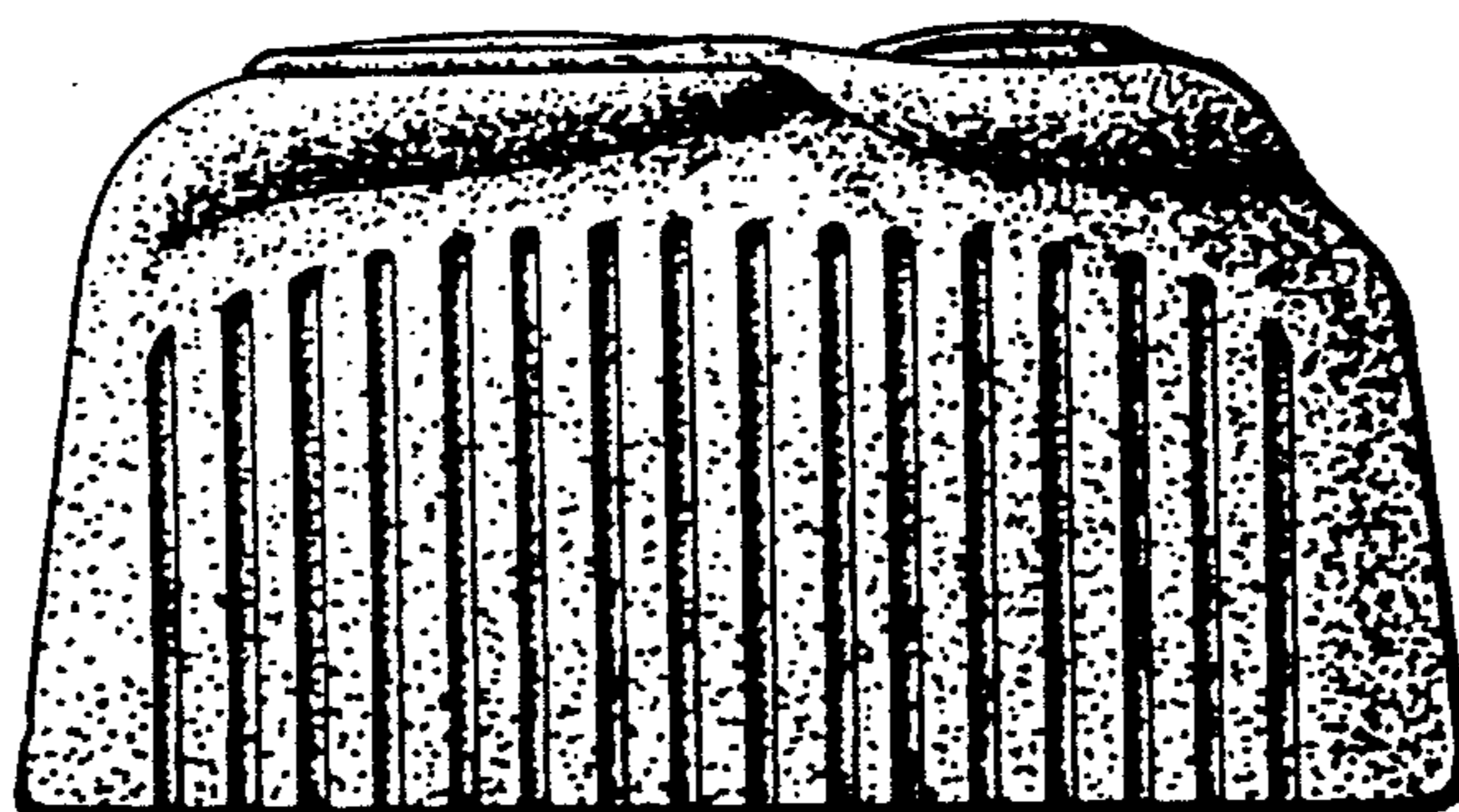

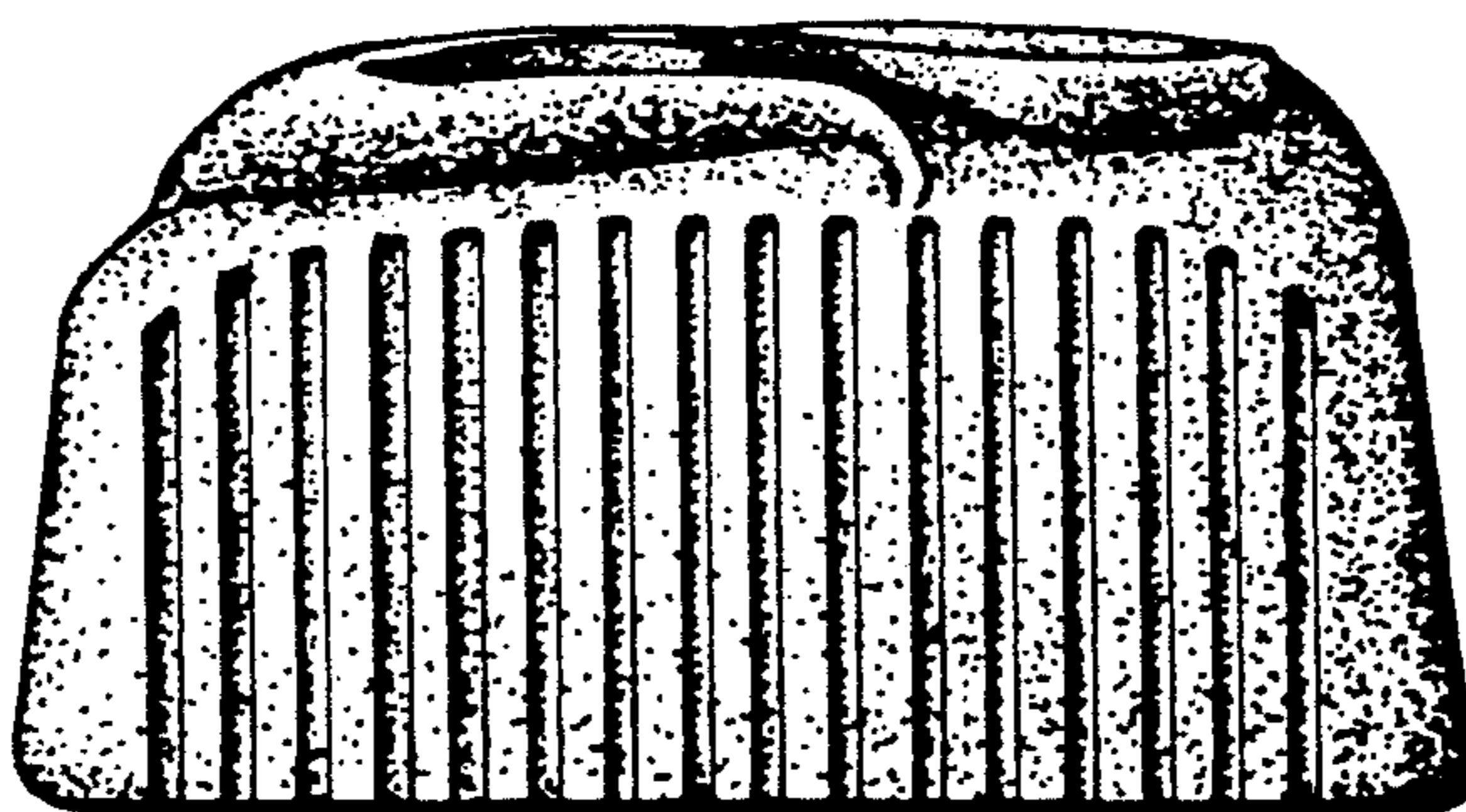

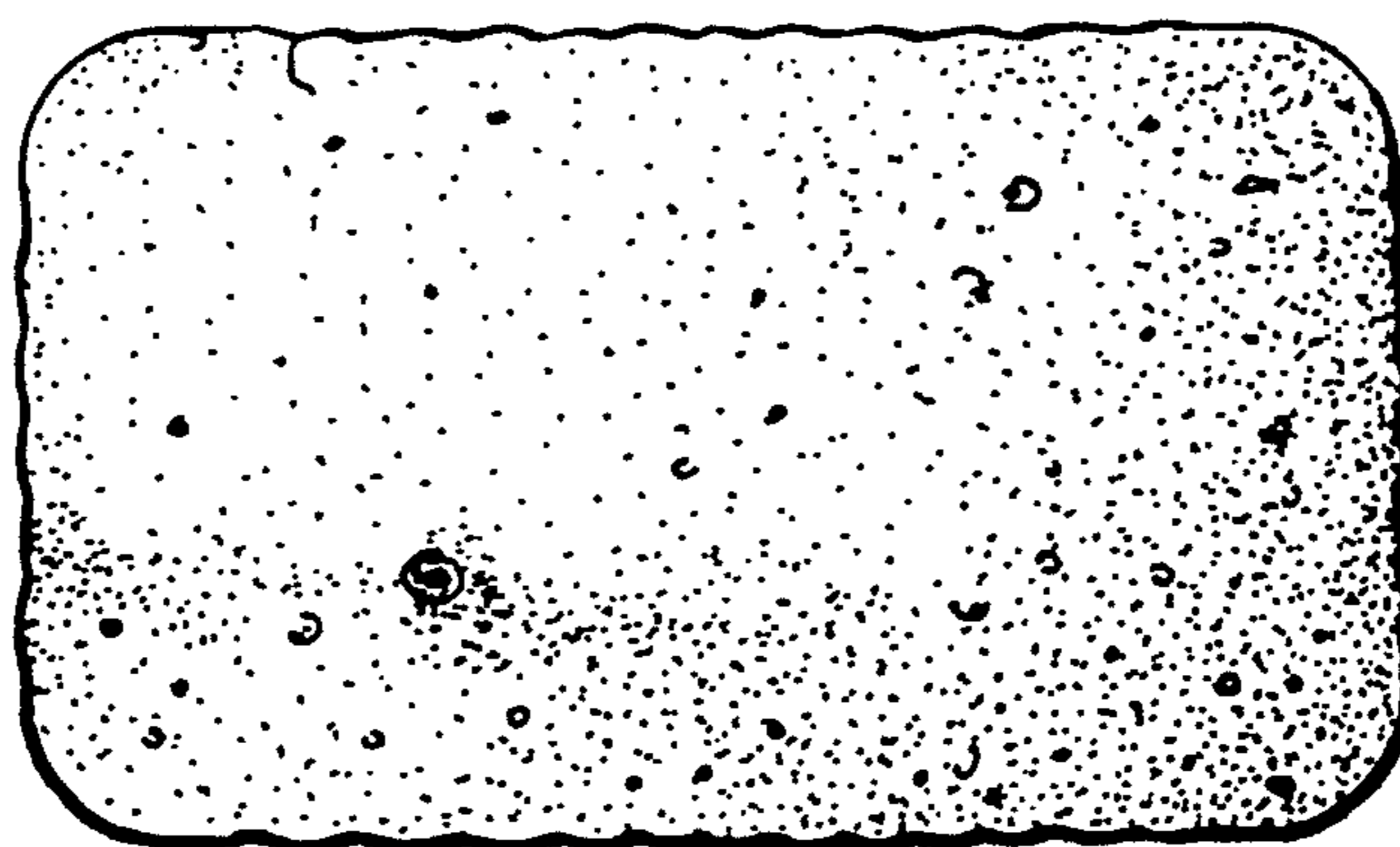

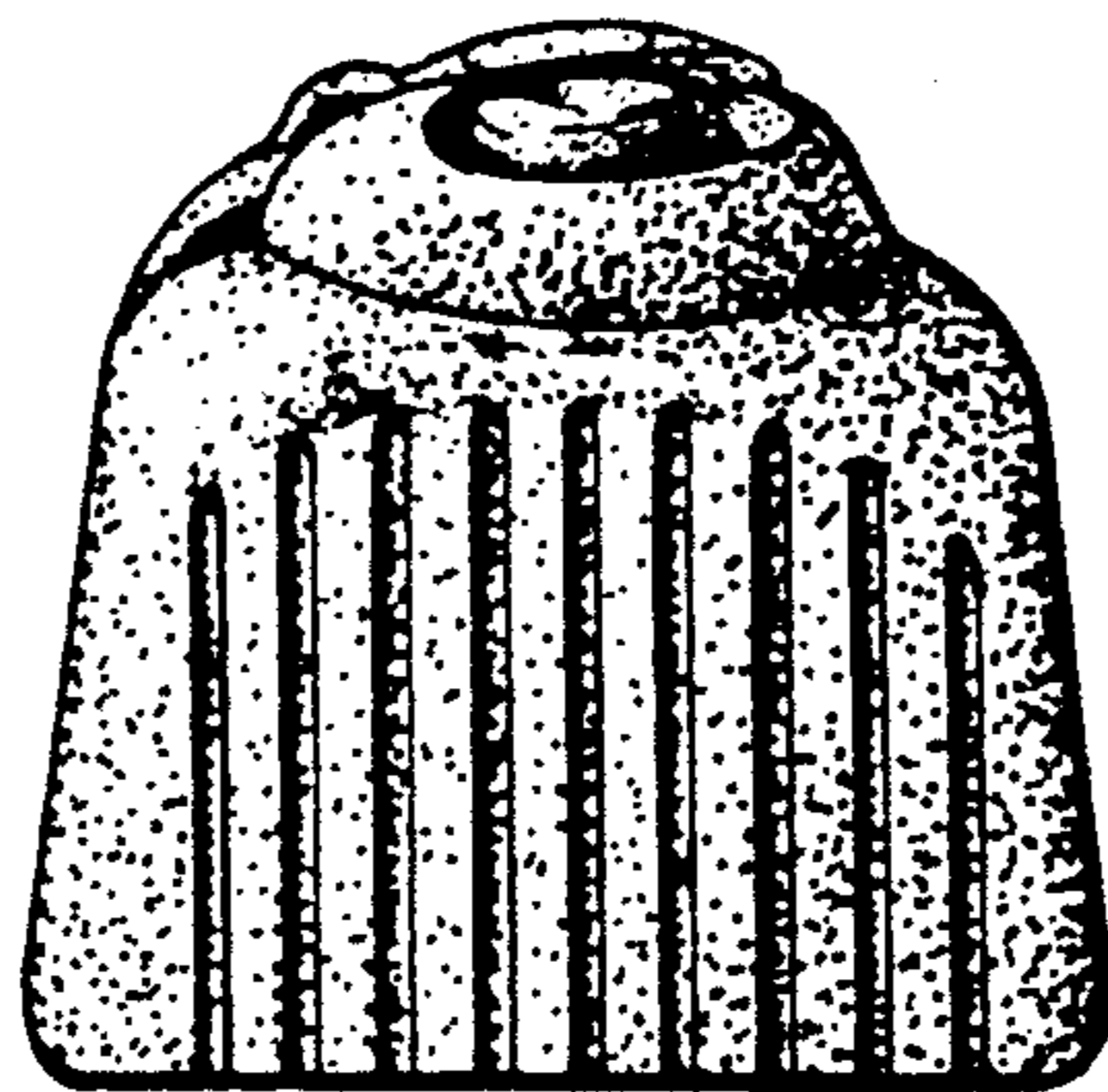

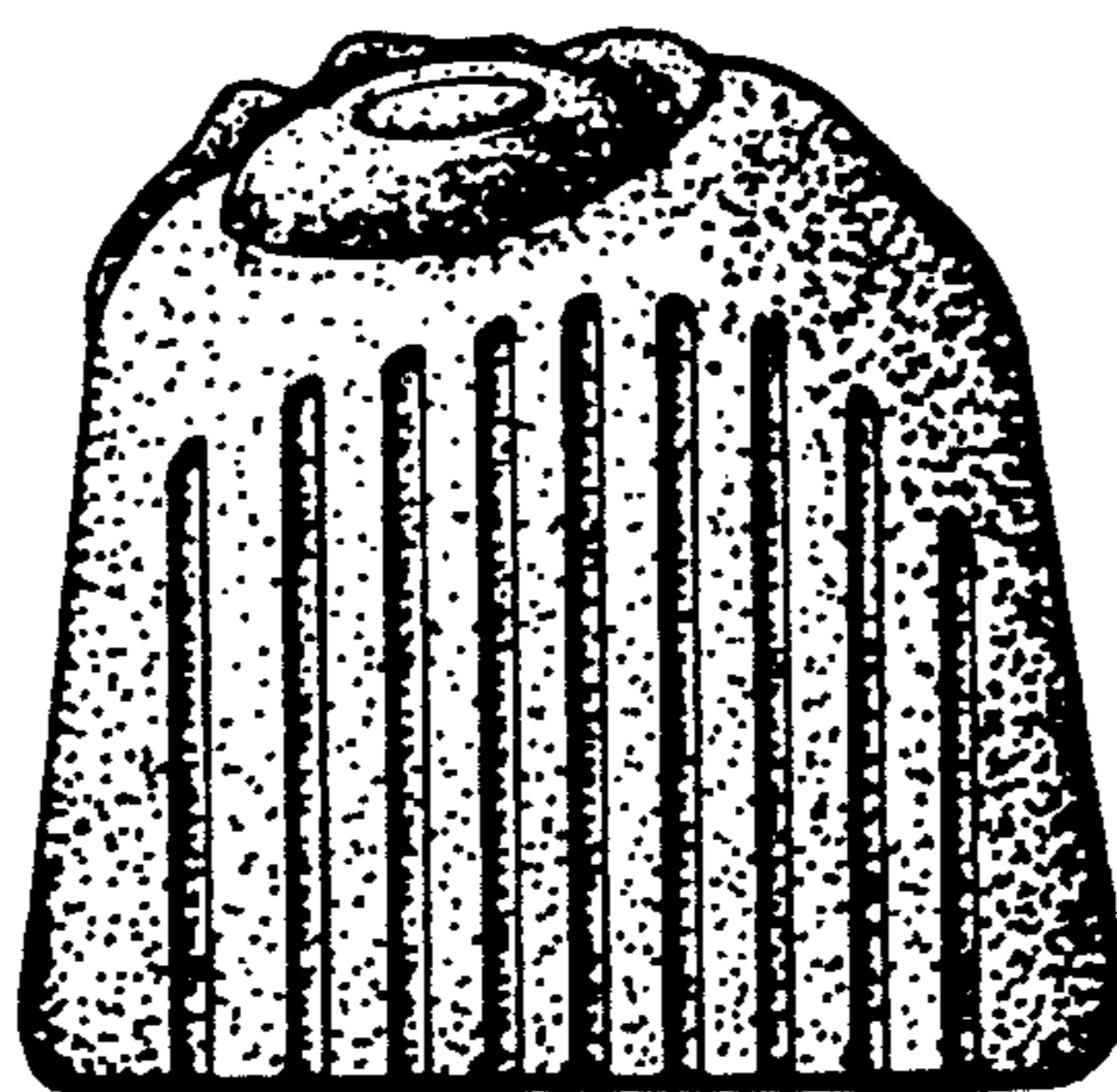
