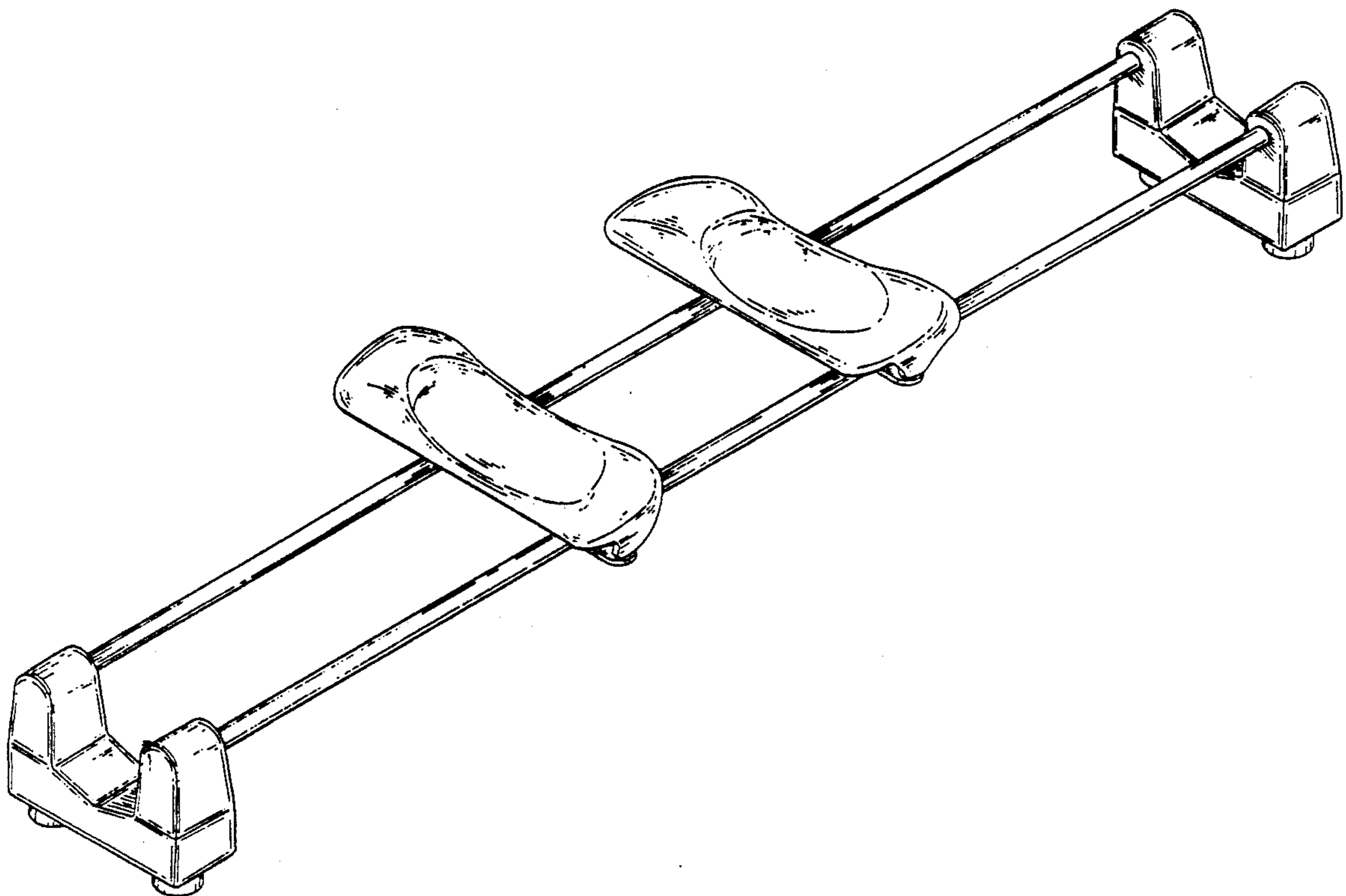

FIG. 1 is a perspective view of the free sliding hand rest showing our new design;
 FIG. 2 is a top plan view of the free sliding hand rest of FIG. 1;
 FIG. 3 is a bottom plan view of the free sliding hand rest of FIG. 1;
 FIG. 4 is a front elevational view of the free sliding hand rest of FIG. 1;
 FIG. 5 is a rear elevational view of the free sliding hand rest of FIG. 1;
 FIG. 6 is an elevational view looking at the left end of the free sliding hand rest of FIG. 1; and,
 FIG. 7 is an elevational view looking at the right end of the free sliding hand rest of FIG. 1.



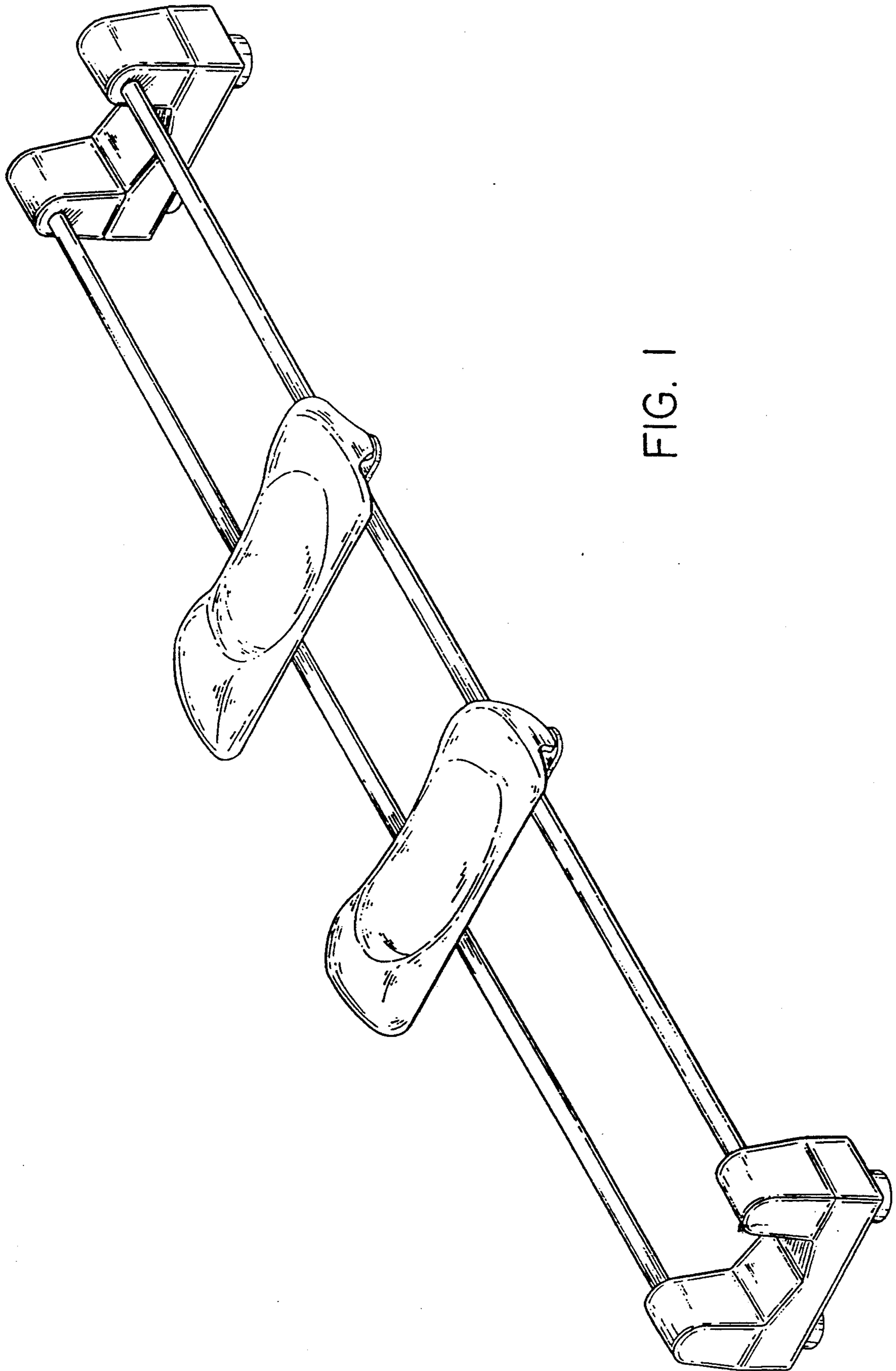

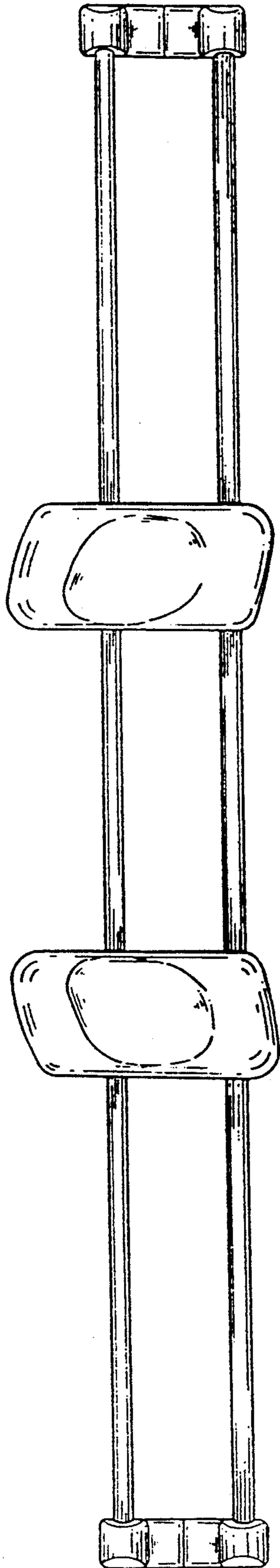

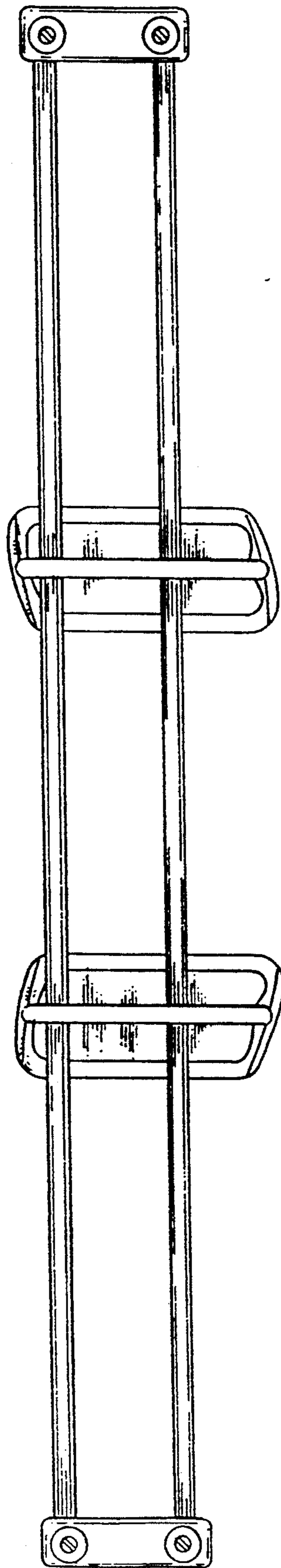

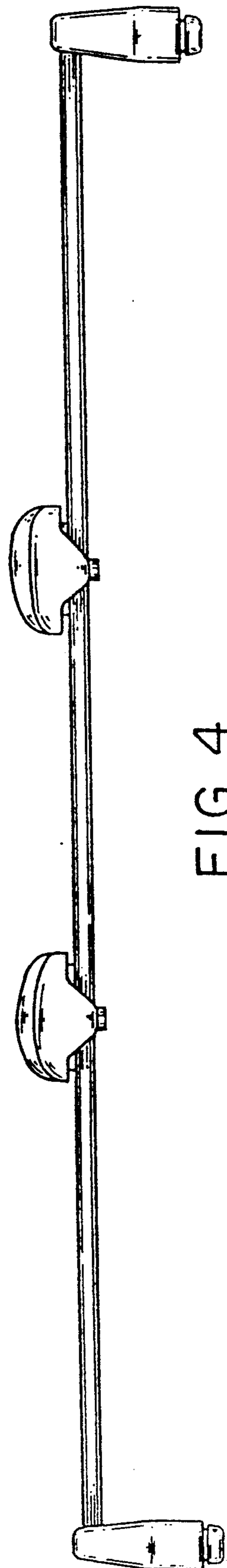

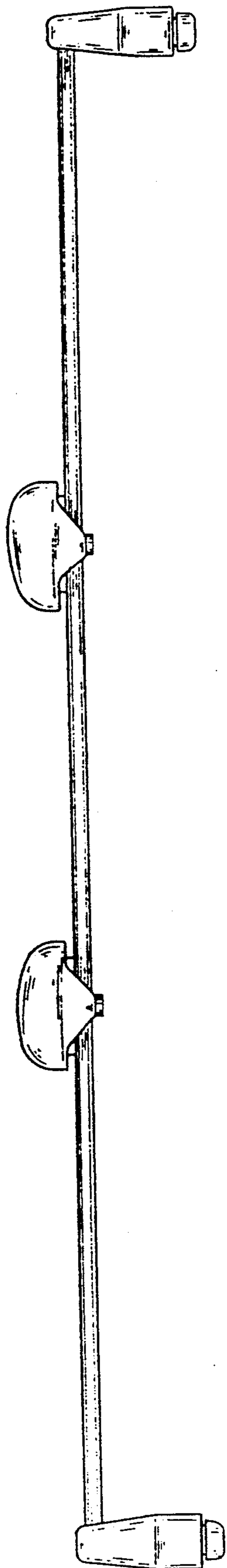

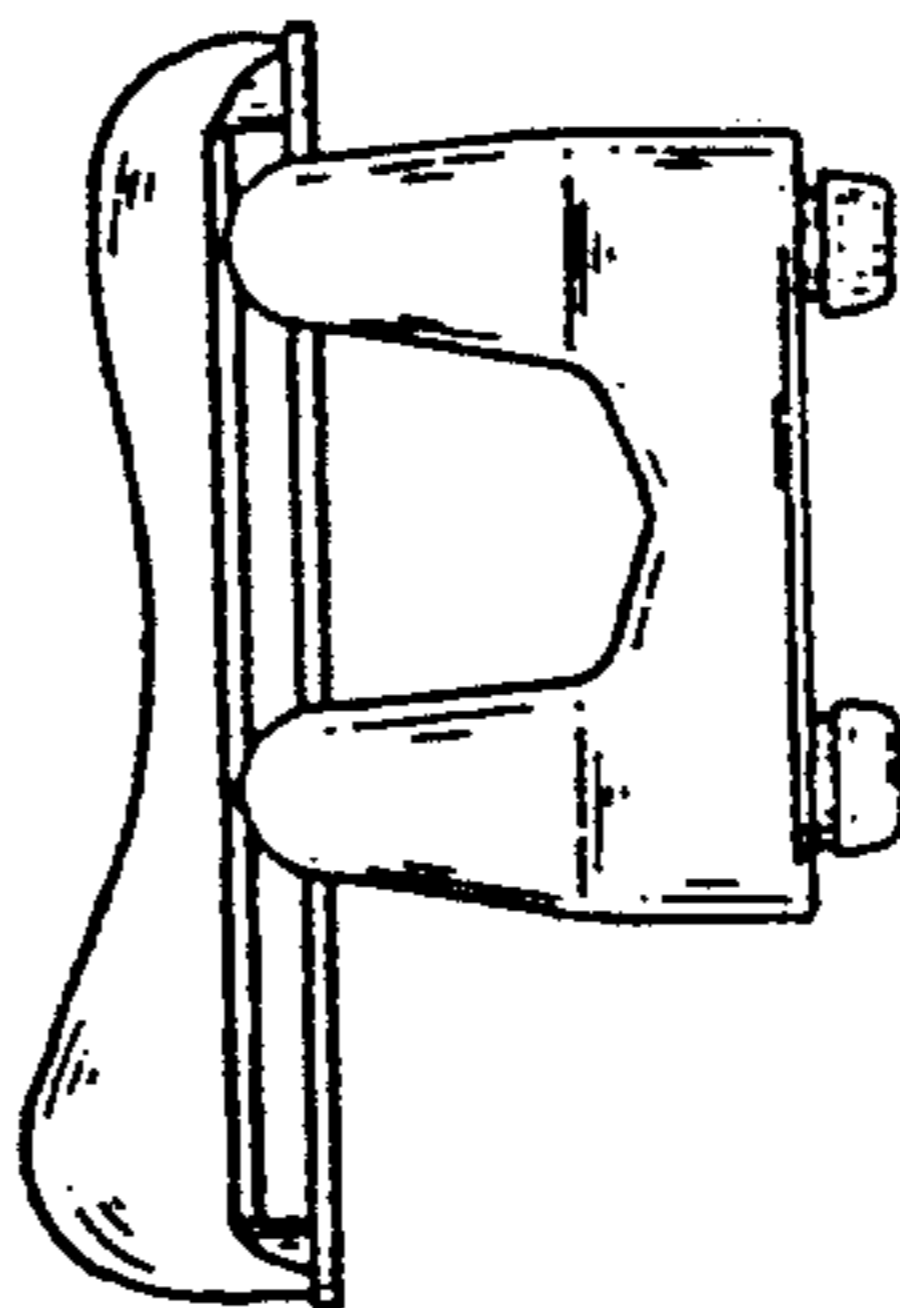

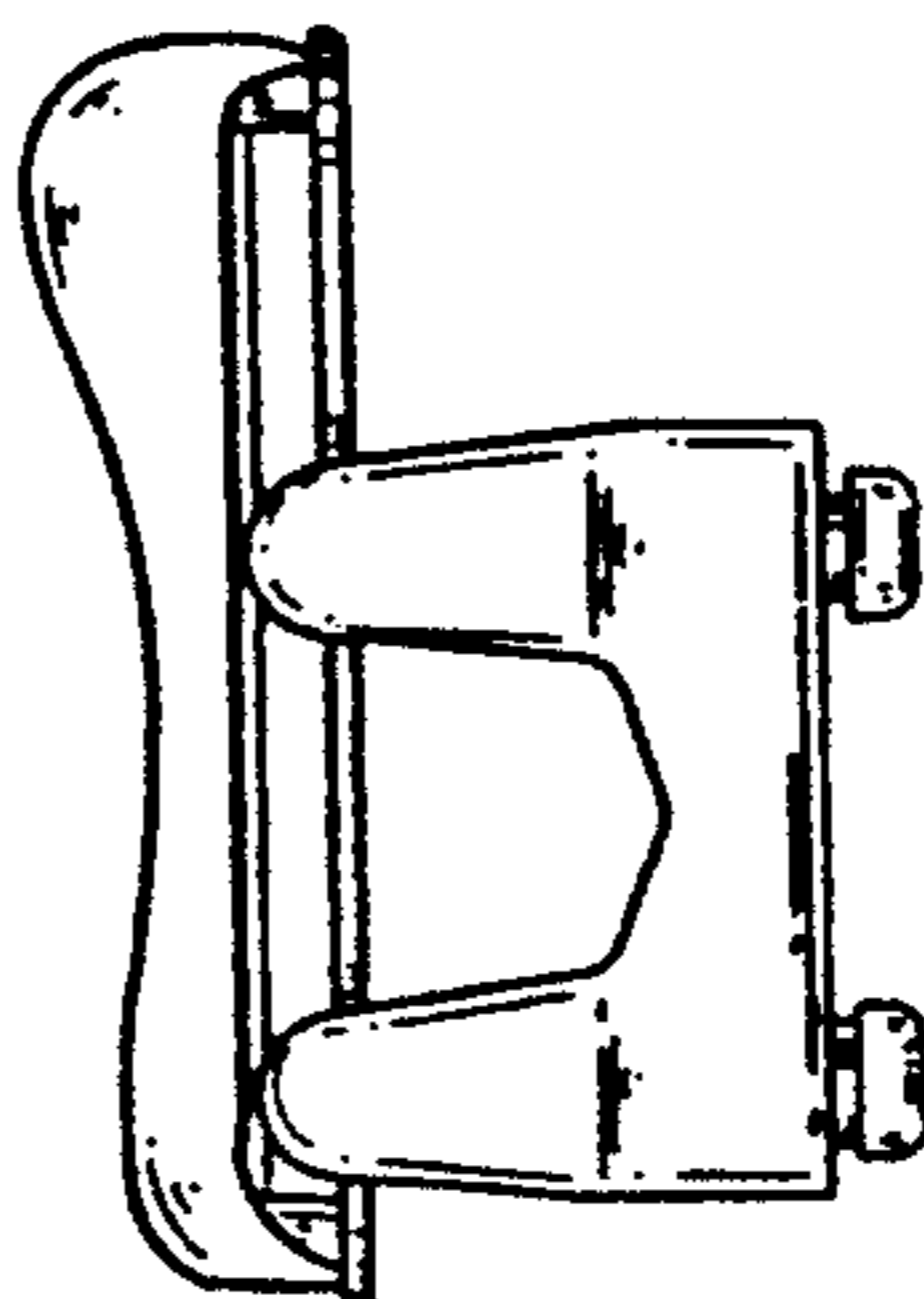
