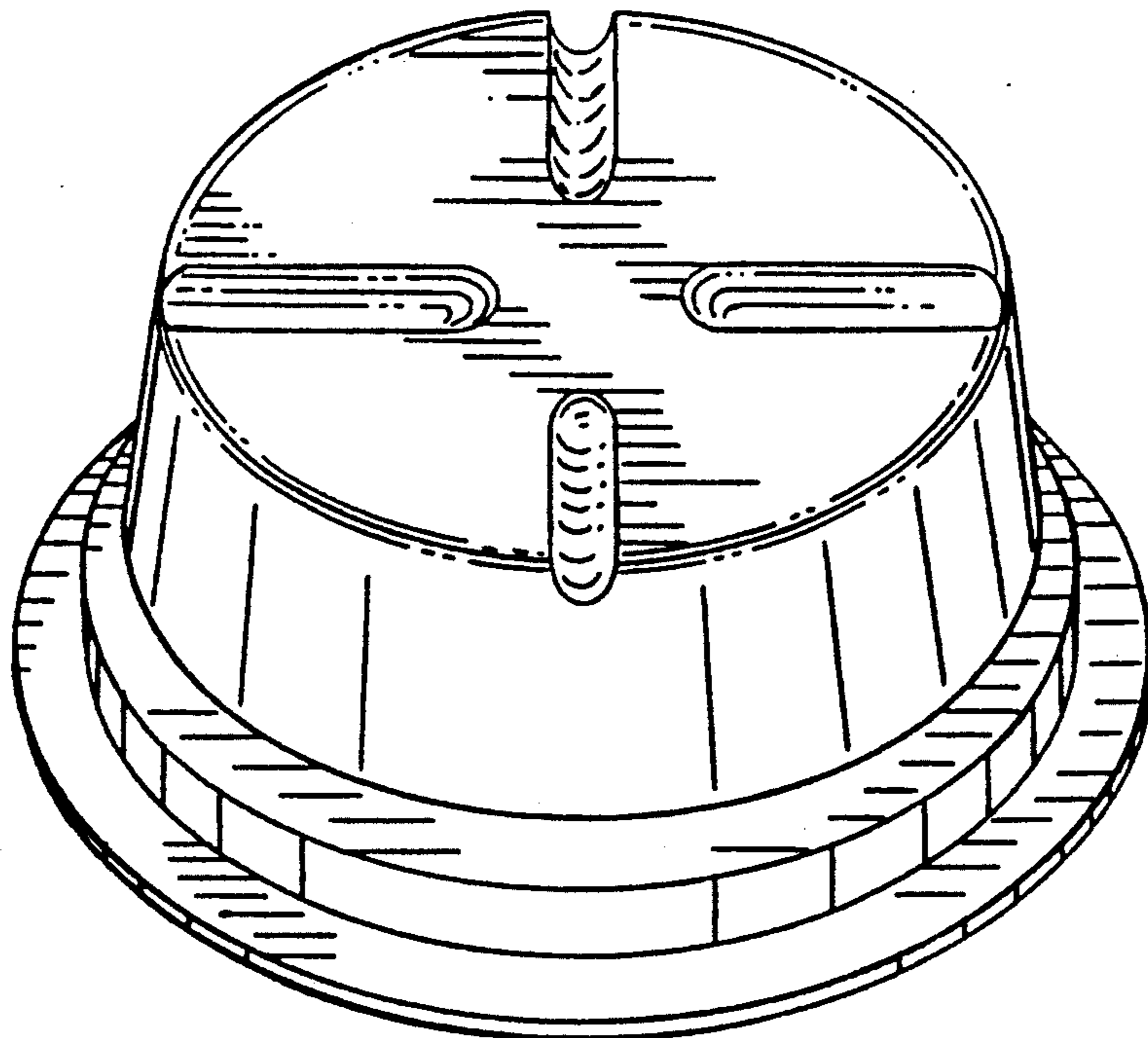
DESCRIPTION

FIG. 1 is a top perspective view of an extended release fragrance dispensing cartridge, showing our new design;

FIG. 2 is an inverted side elevational view thereof, each side being substantially identical in appearance;

FIG. 3 is a top plan view thereof; and,

FIG. 4 is a bottom plan view thereof.



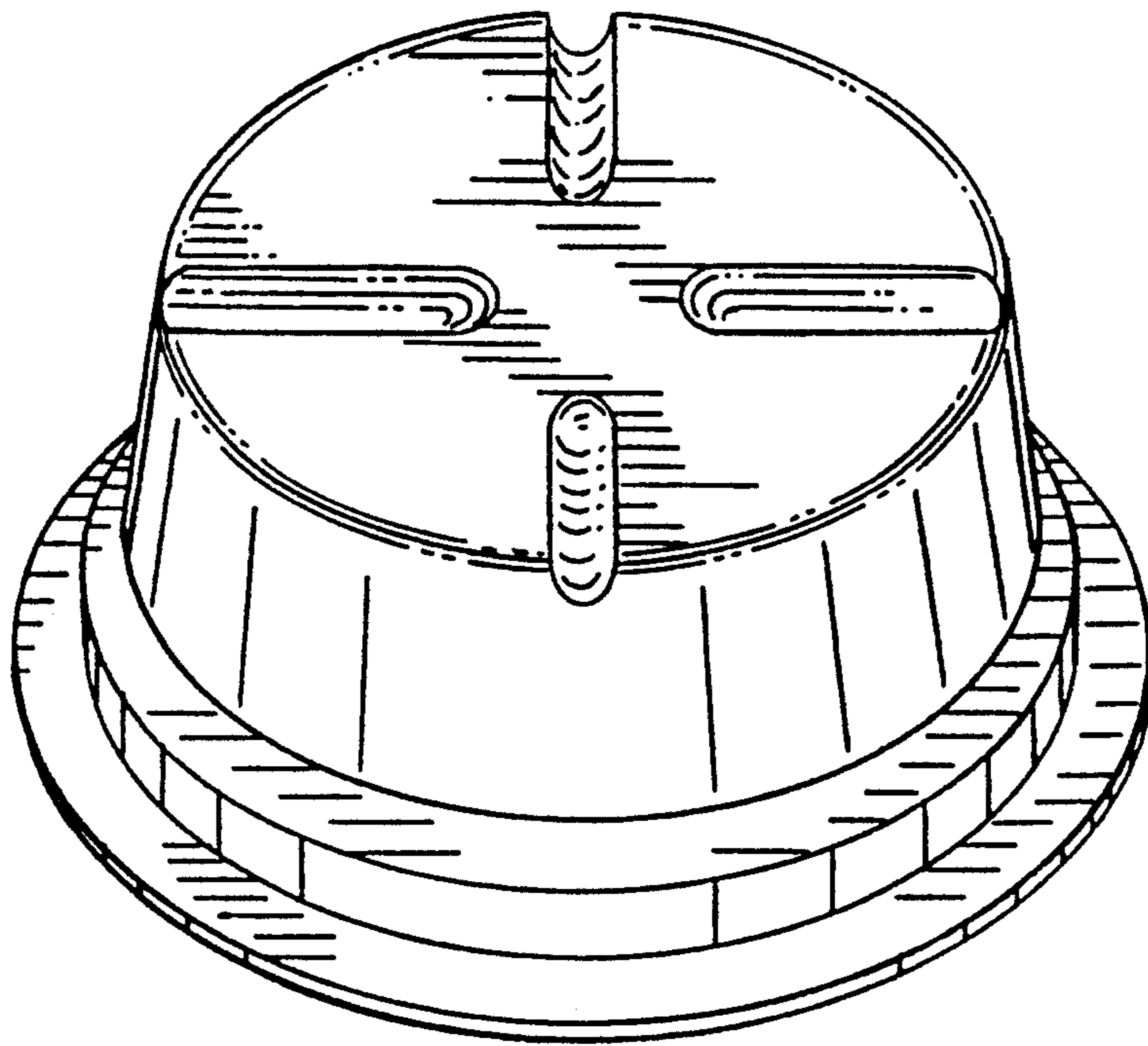

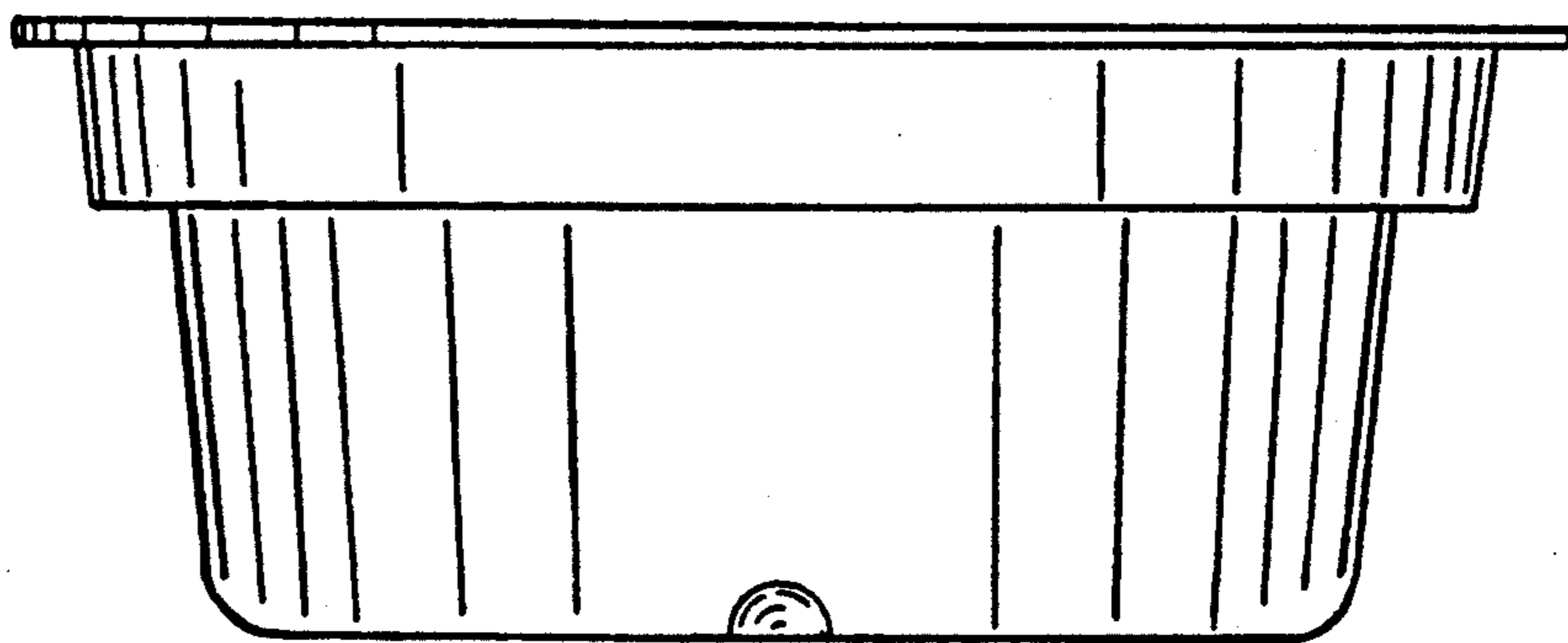

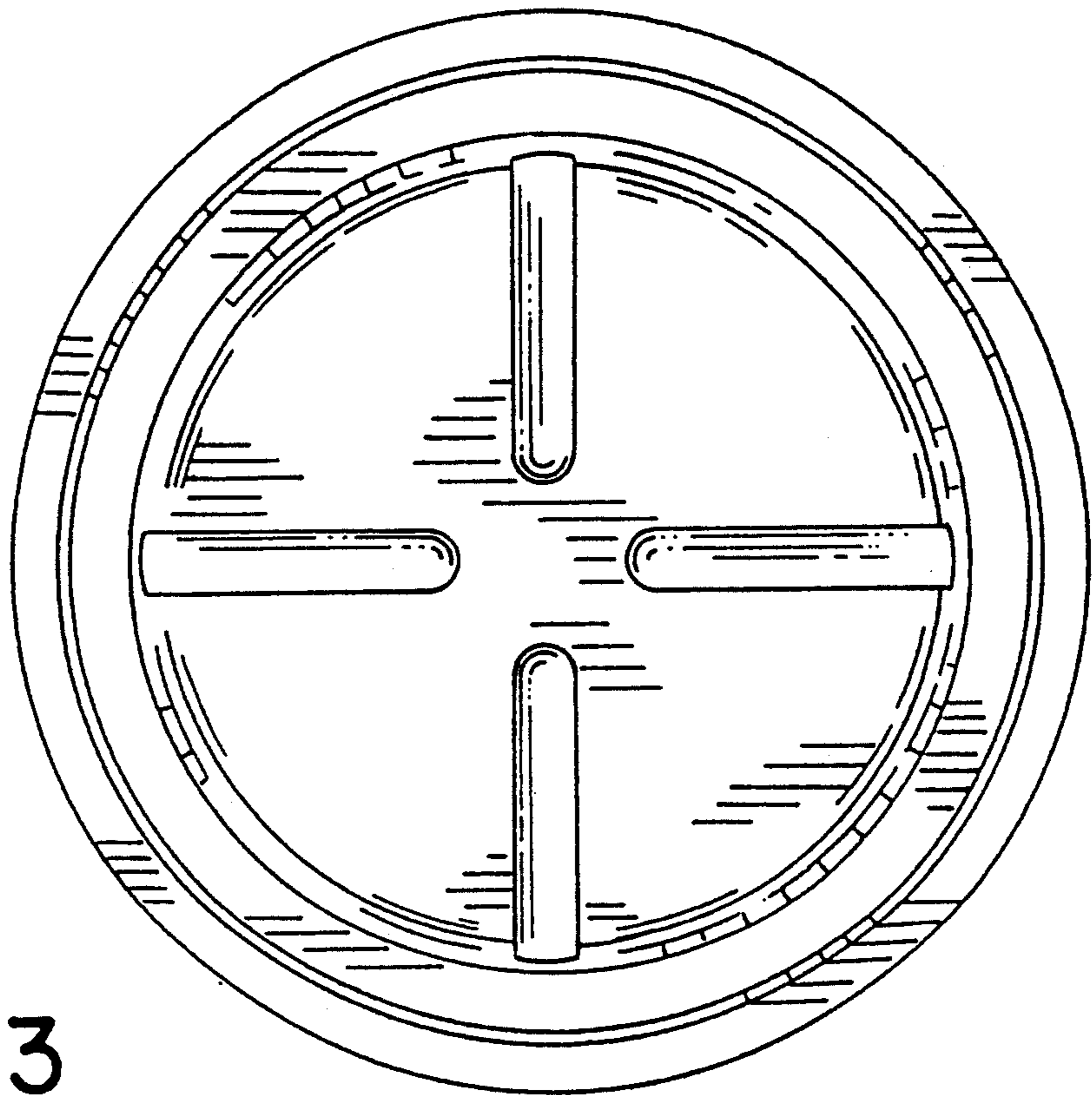

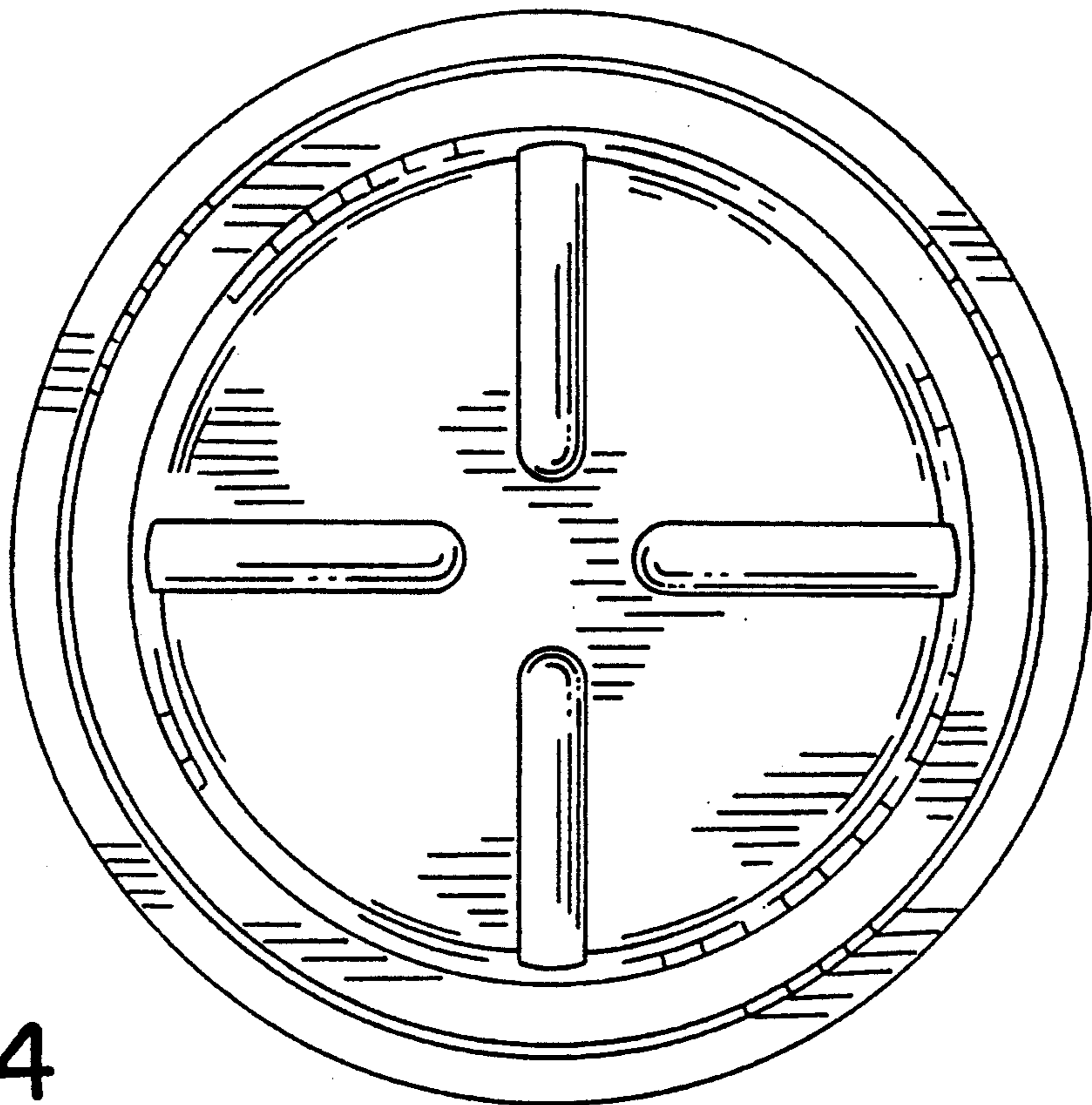
