[57] CLAIM

The ornamental design for a front headlight lens of a motor vehicle, as shown and described.

DESCRIPTION

FIG. 1 is an enlarged perspective oblique view taken from above and to the right of a front right headlight lens of a motor vehicle embodying a first embodiment of our novel design;

FIG. 2 is a front view of the headlight lens of FIG. 1;

FIG. 3 is a side view of the headlight lens of FIG. 1;

FIG. 4 is an enlarged perspective oblique view taken from above and to the right of a front right headlight lens of a motor vehicle embodying a second embodiment of our novel design;

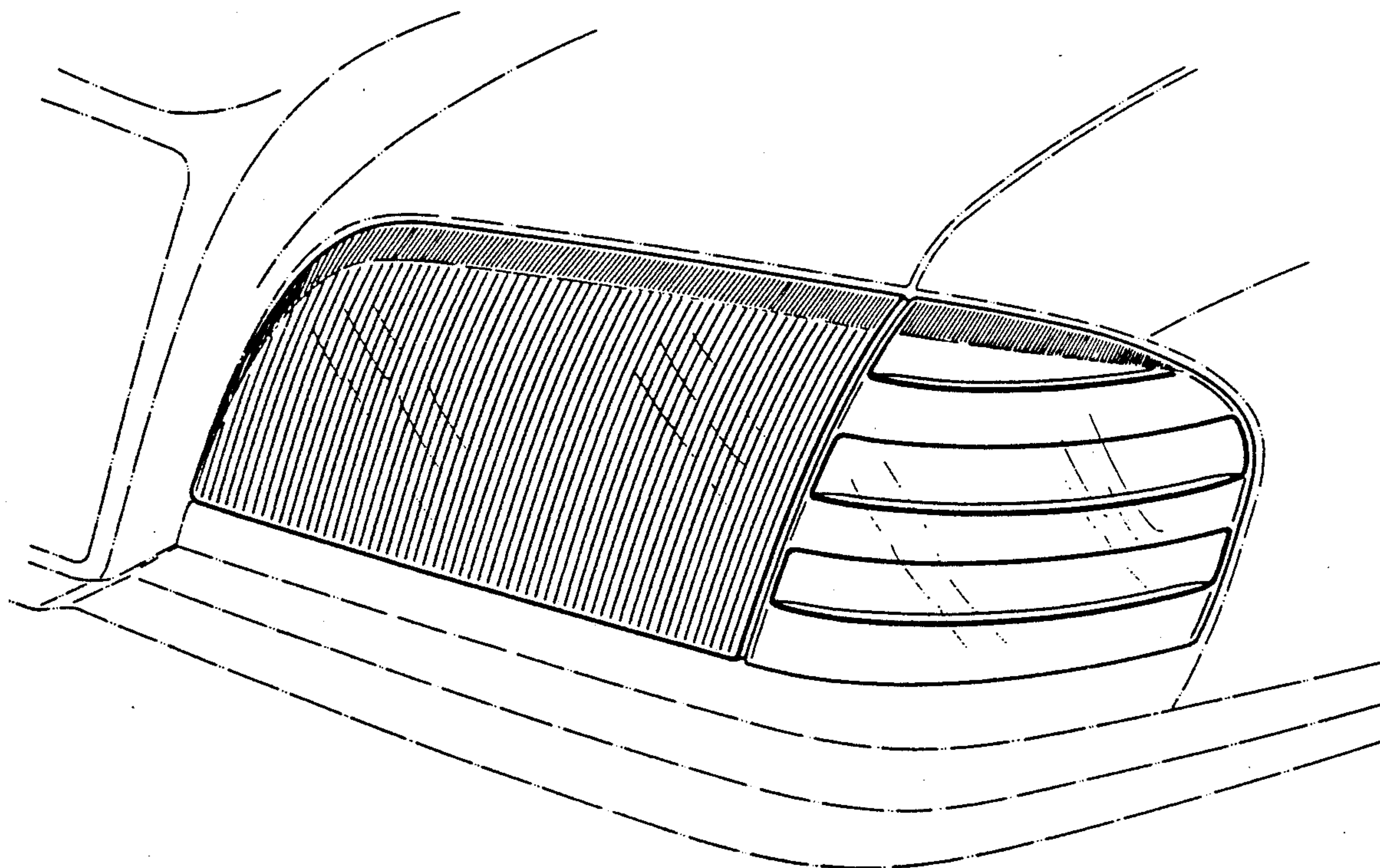
FIG. 5 is an enlarged front view of the headlight lens of FIG. 4;

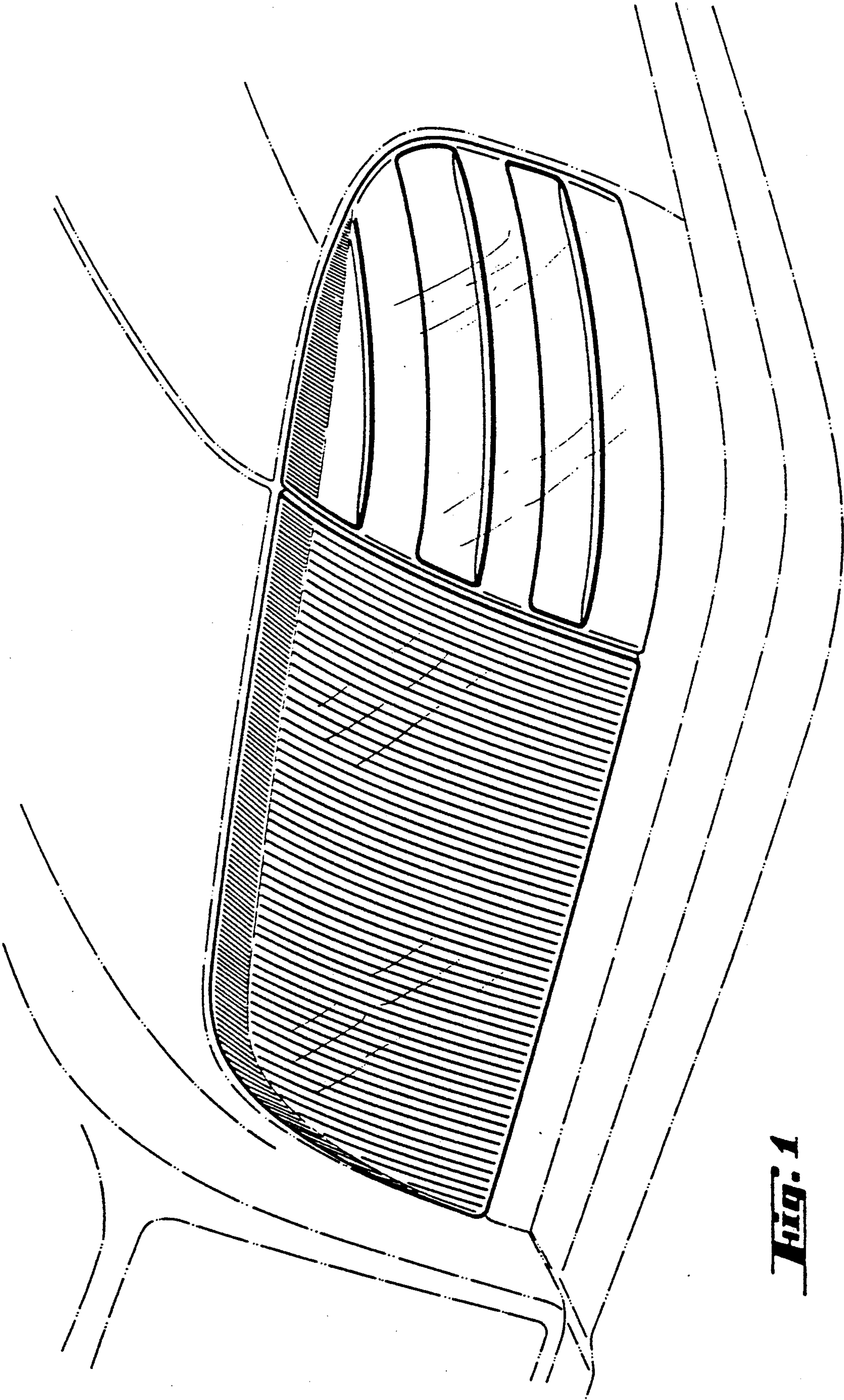
FIG. 6 is an enlarged side view taken from below of the headlight lens of FIG. 4;

FIG. 7 is an enlarged oblique view taken from above of the headlight lens of FIG. 4; and,

FIG. 8 is a front view of a front left headlight lens which is a mirror image of the front right headlight lens of FIGS. 1-3 and which embodies a third embodiment of our novel design.

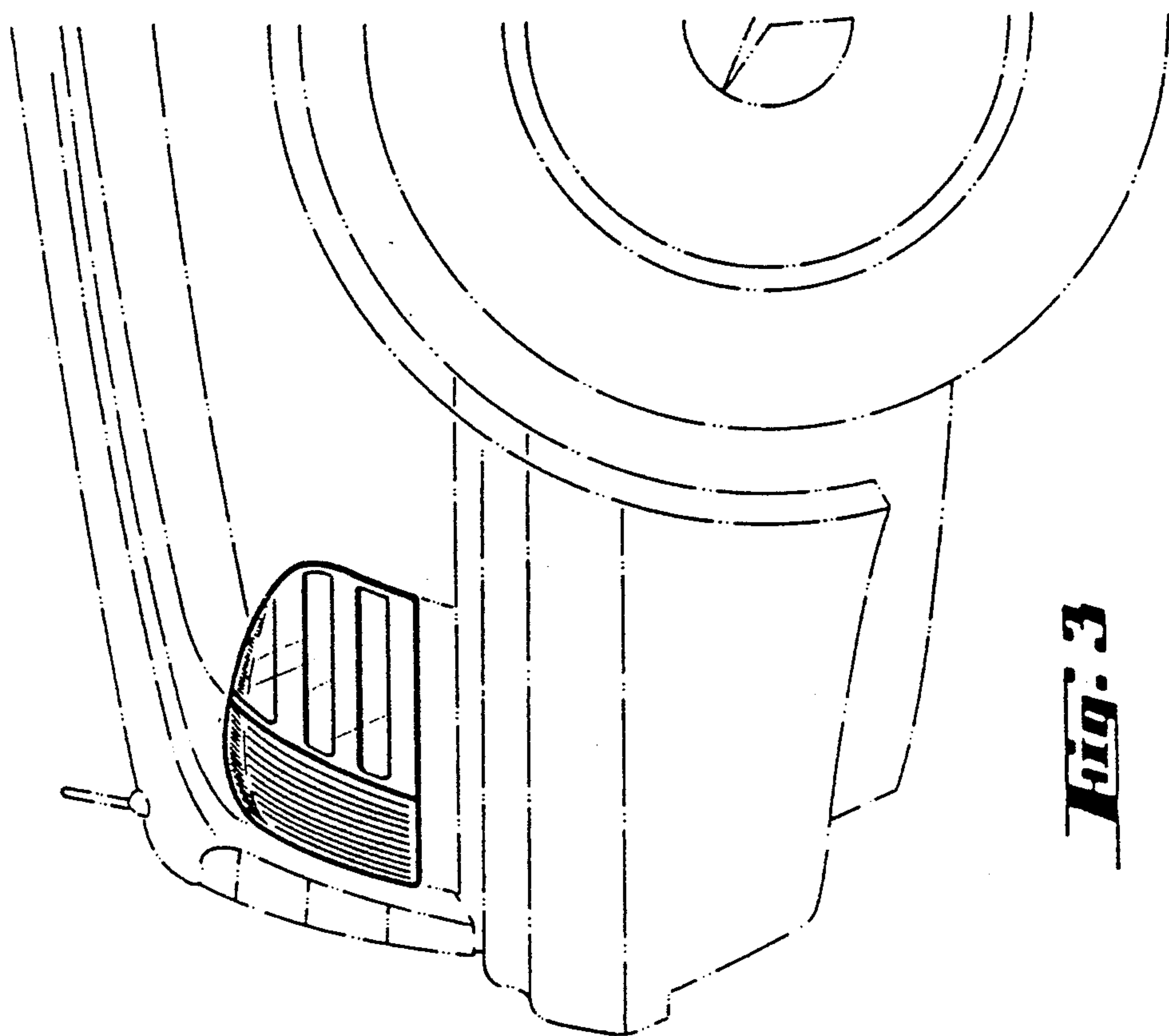
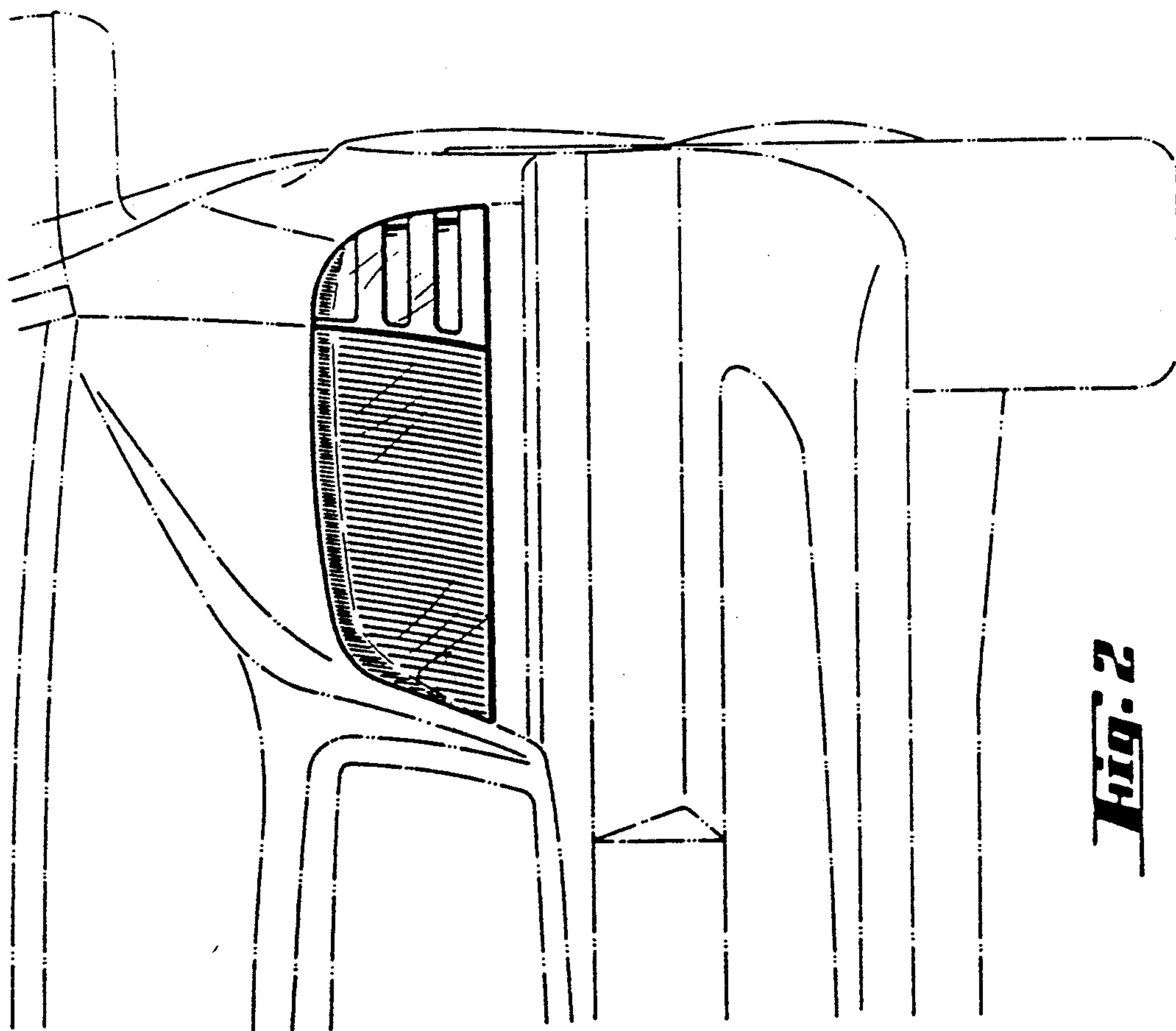
The motor vehicle is fragmentarily shown in broken lines for illustrative purposes only.

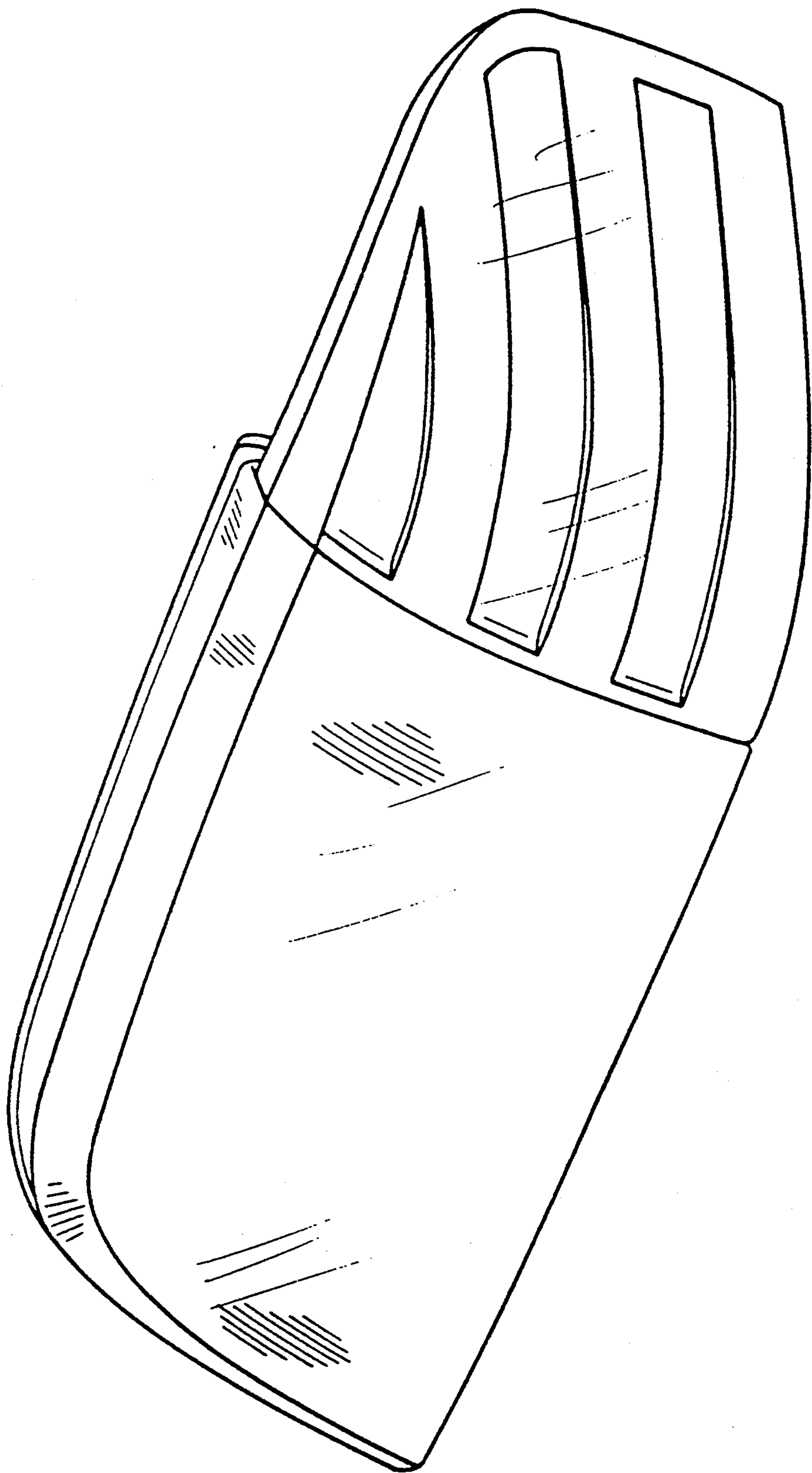




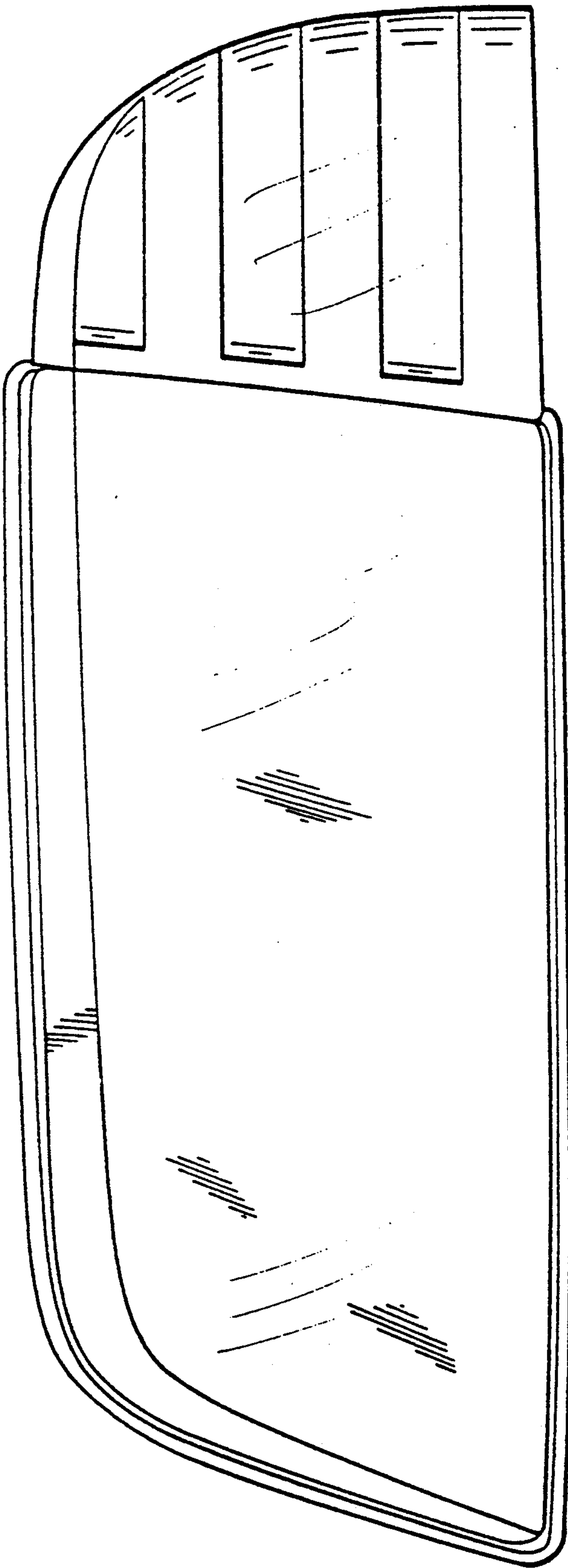

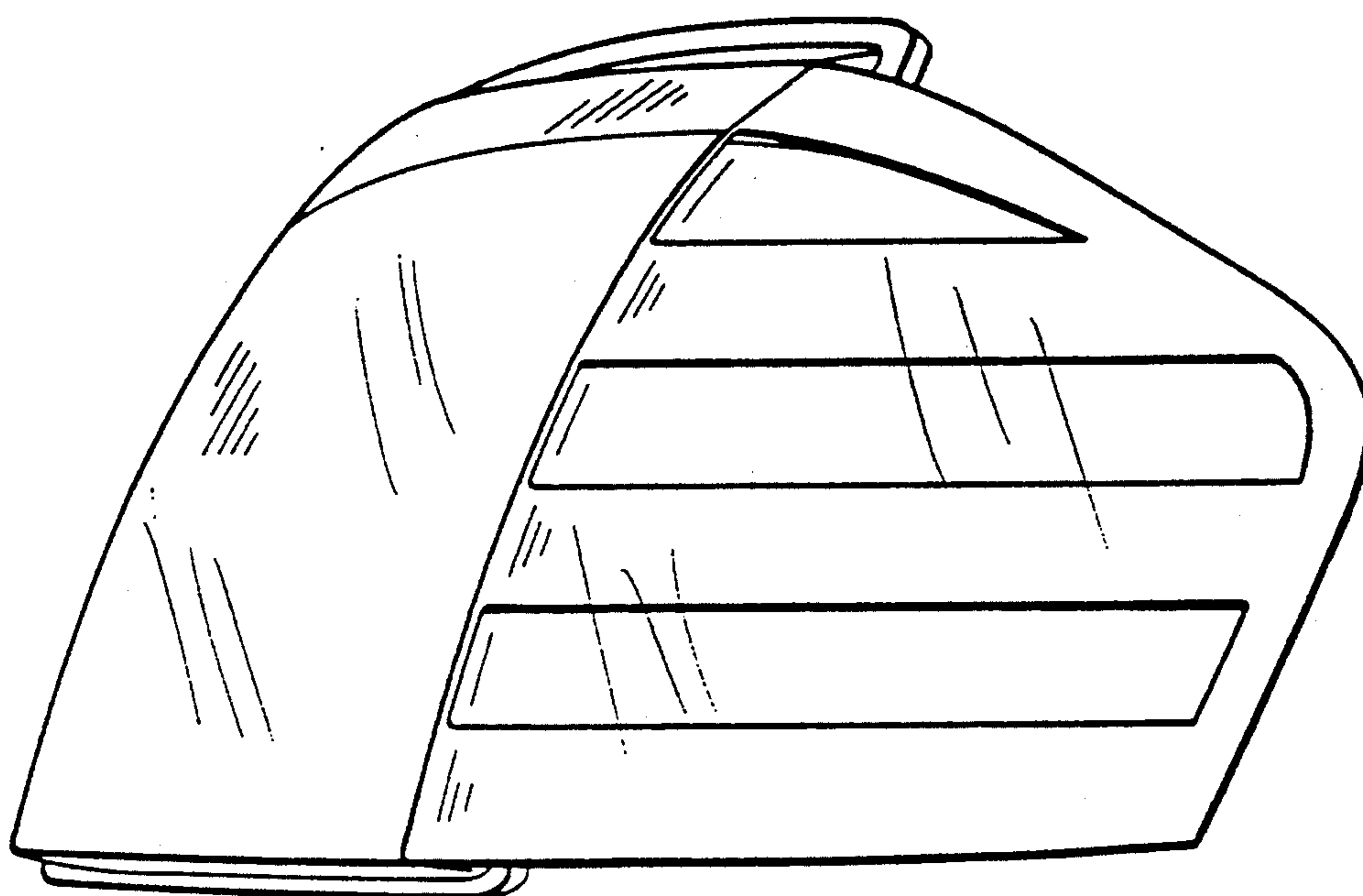




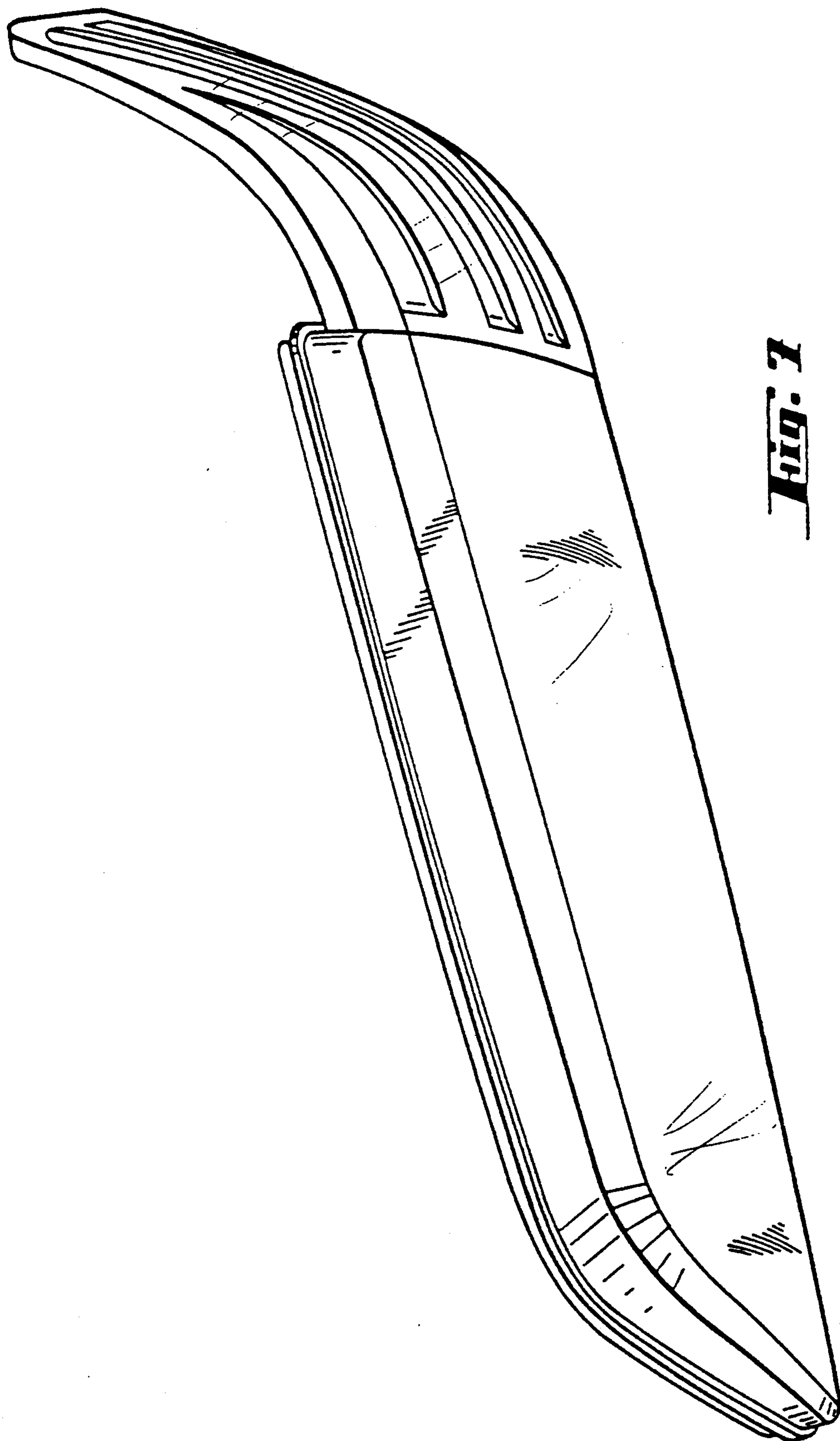
