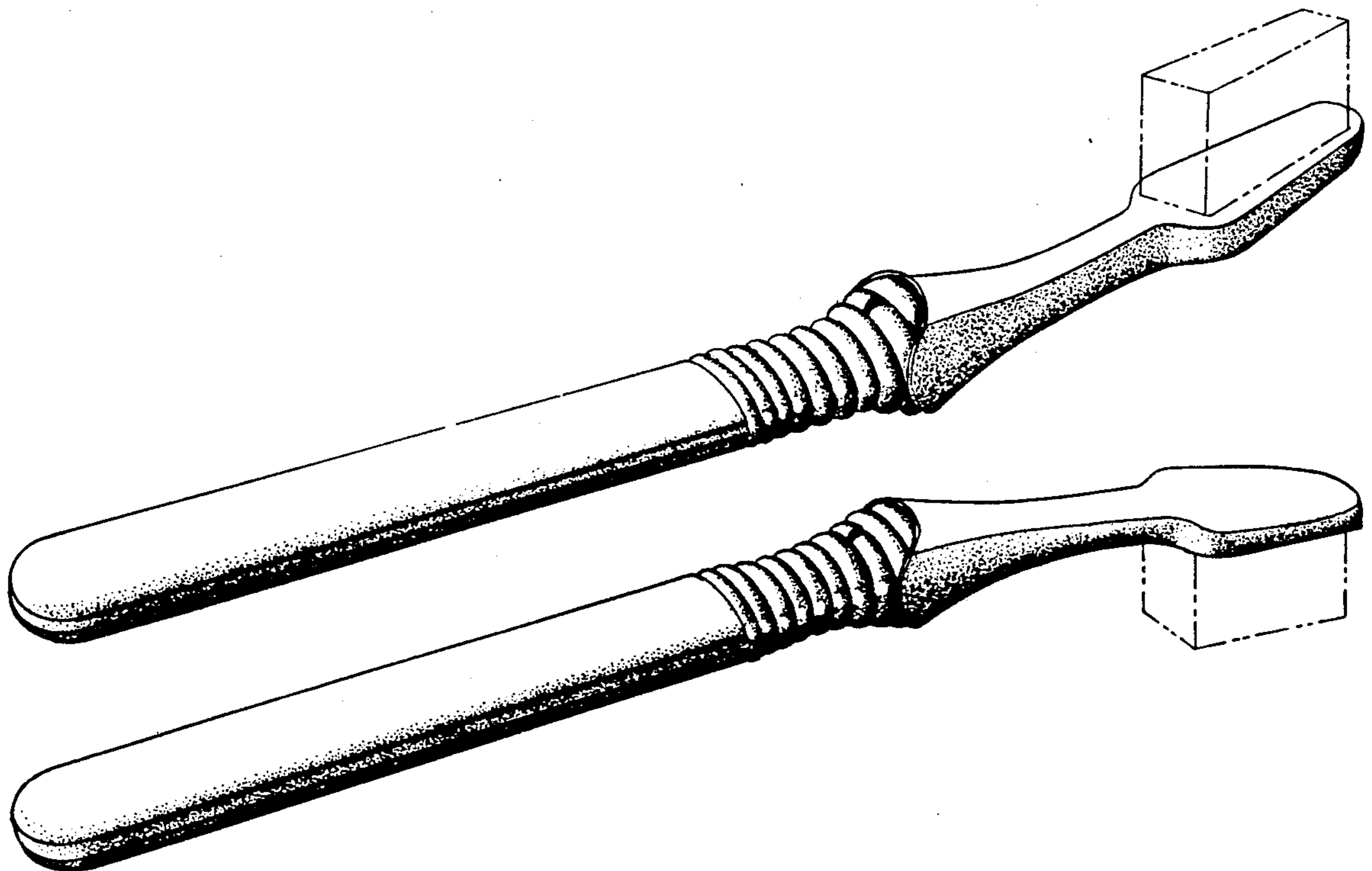

[57] **CLAIM**

The ornamental design for a toothbrush handle, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a toothbrush handle showing our new design;
FIG. 2 is a left side elevational view thereof, the right side being a mirror image thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a front elevational view thereof;
FIG. 6 is an enlarged top perspective view thereof; and,
FIG. 7 is a bottom perspective view thereof.
The broken line showing of bristles in FIGS. 2, 6, and 7 is for illustrative purposes only and forms no part of the claimed design.



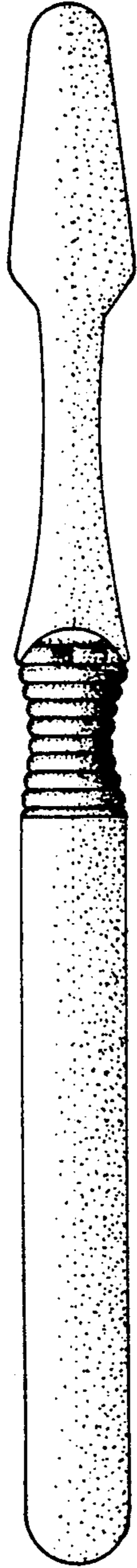

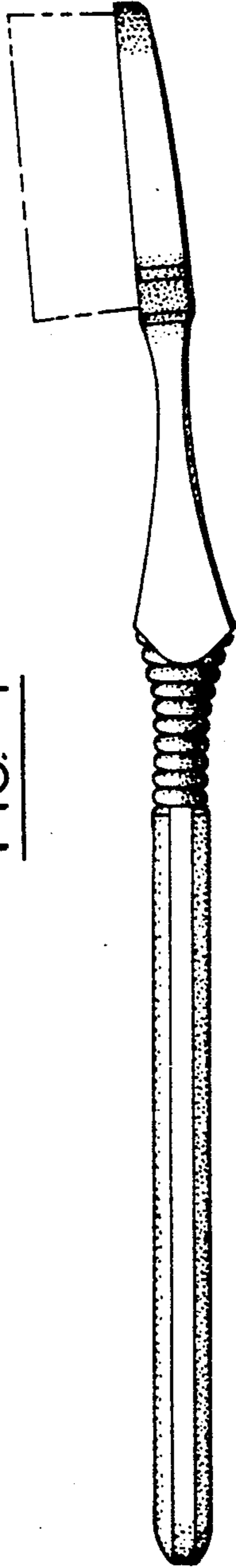

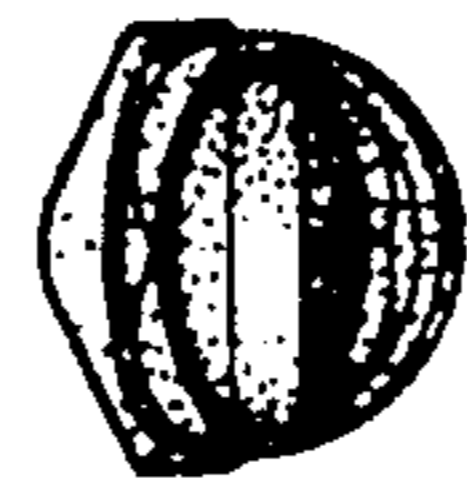

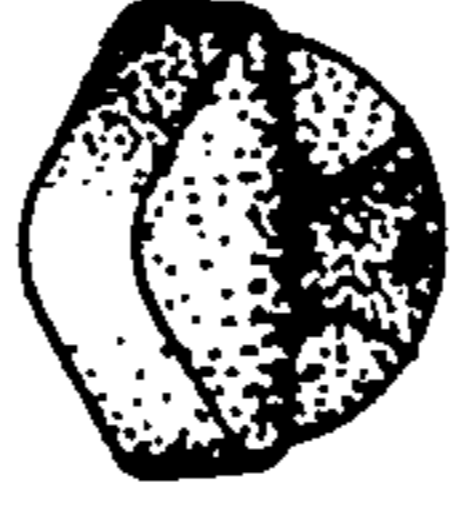

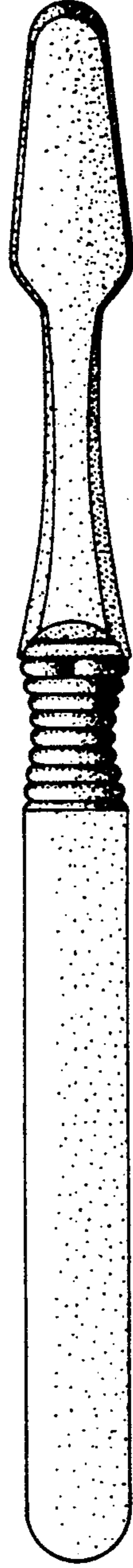

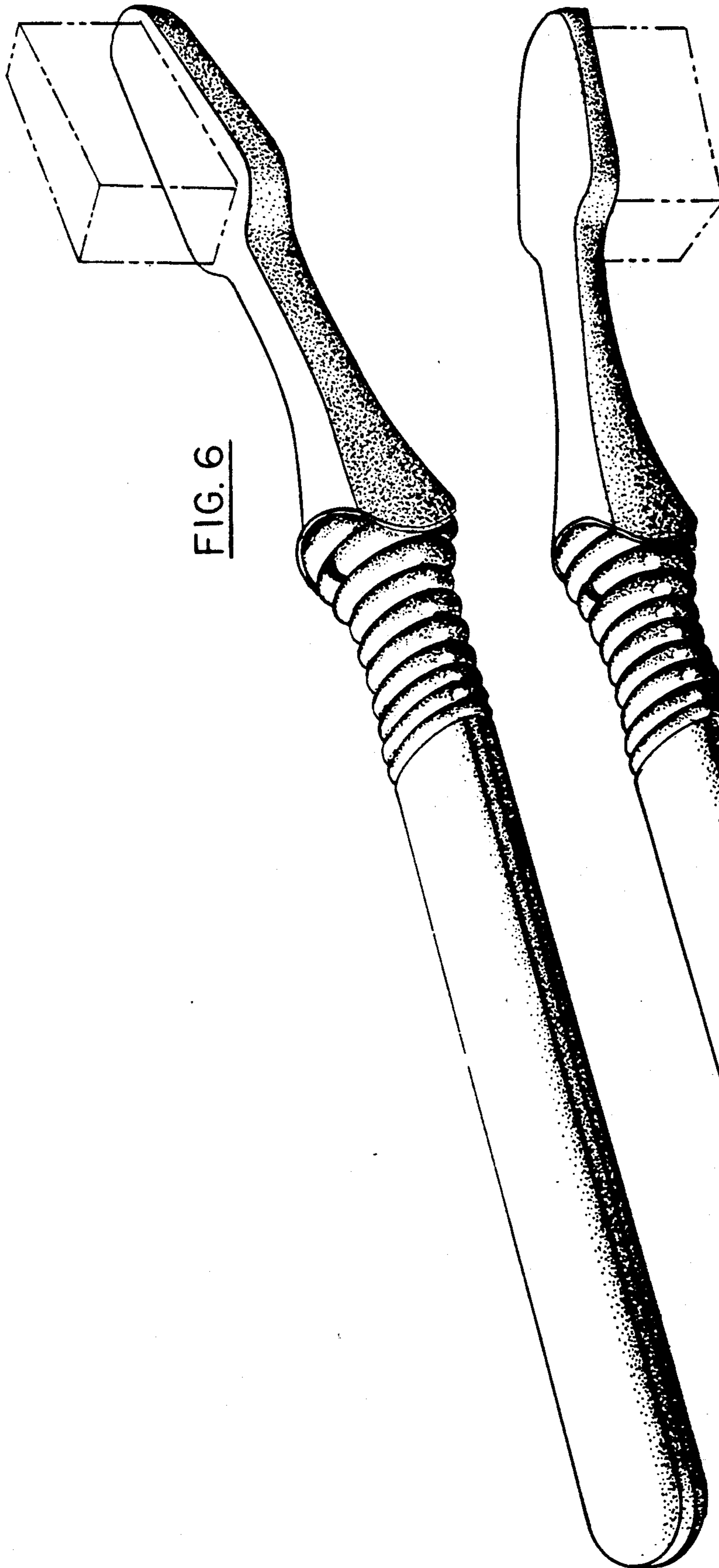
