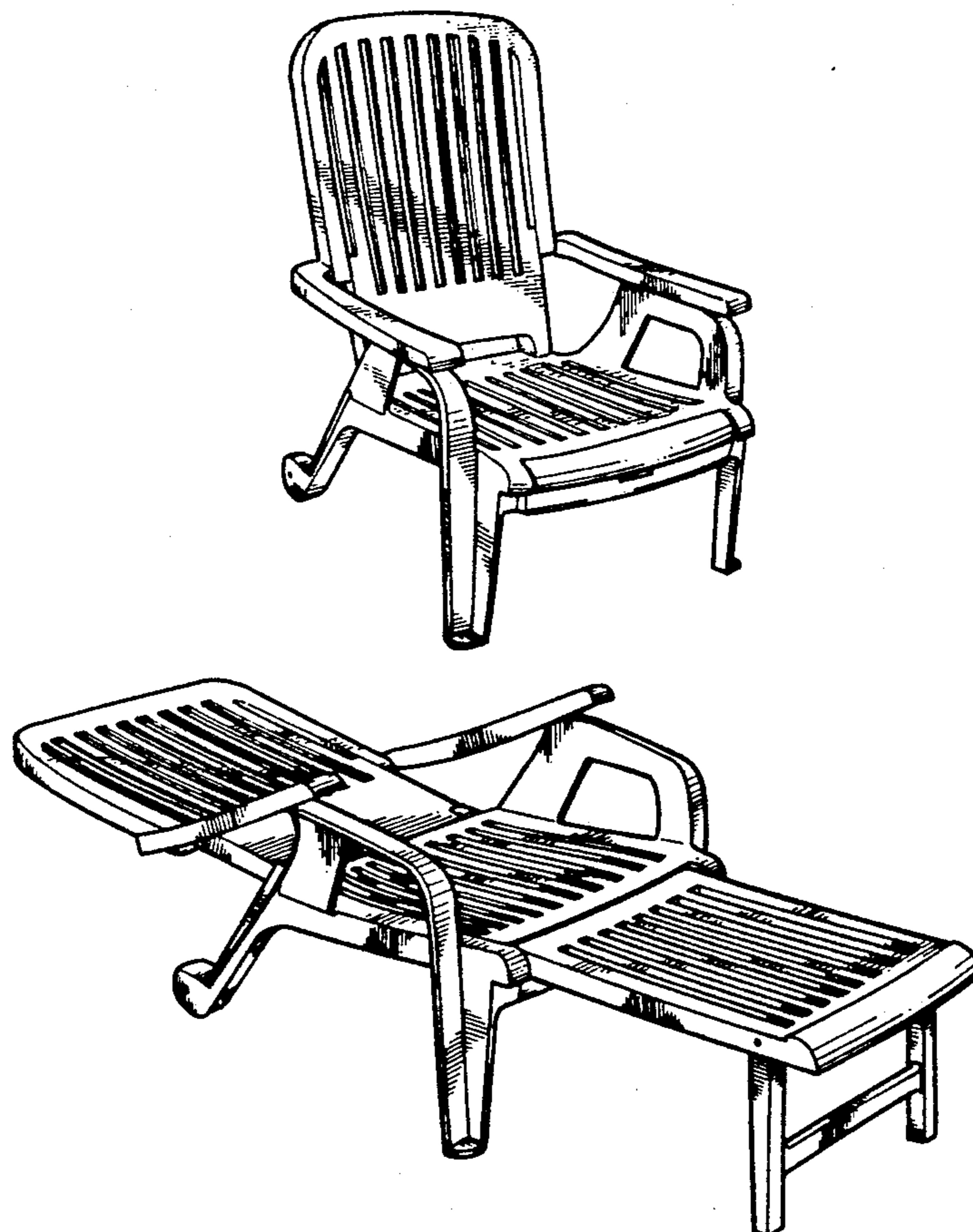

## [57] CLAIM

The ornamental design for a recliner lounge chair, as shown and described.

## DESCRIPTION

FIG. 1 is a front perspective view of a recliner lounge chair showing my new design;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a rear elevational view thereof;  
 FIG. 4 is a right side orthographic view thereof, a view taken from the left being a mirror image thereof;  
 FIG. 5 is a top plan view thereof;  
 FIG. 6 is a bottom plan view thereof;  
 FIG. 7 is a perspective view of the recliner lounge chair showing the legrest extended and the backrest in an alternate position; and,  
 FIG. 8 is a left side orthographic view of FIG. 7, a view taken from the right being a mirror image thereof.



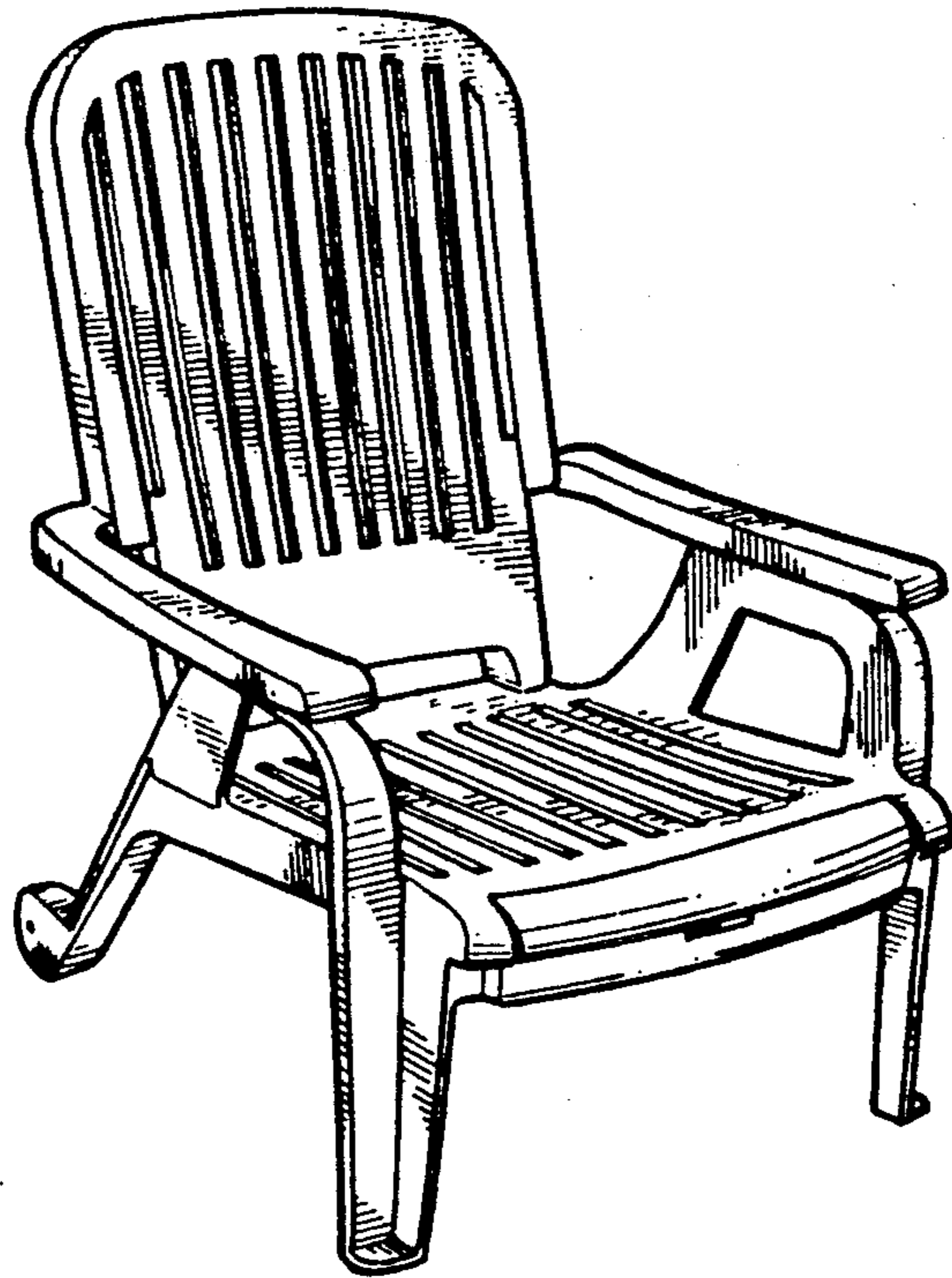

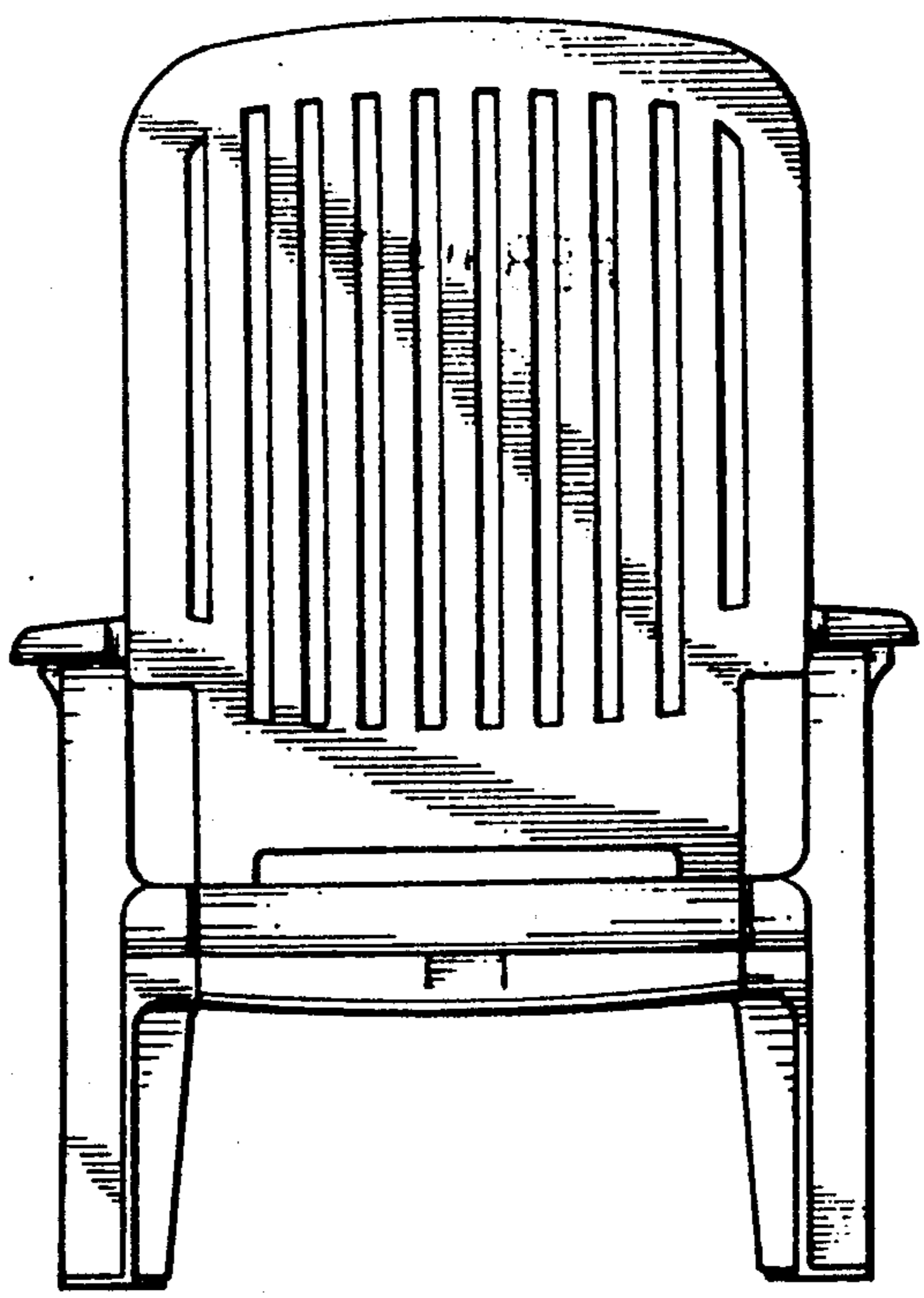

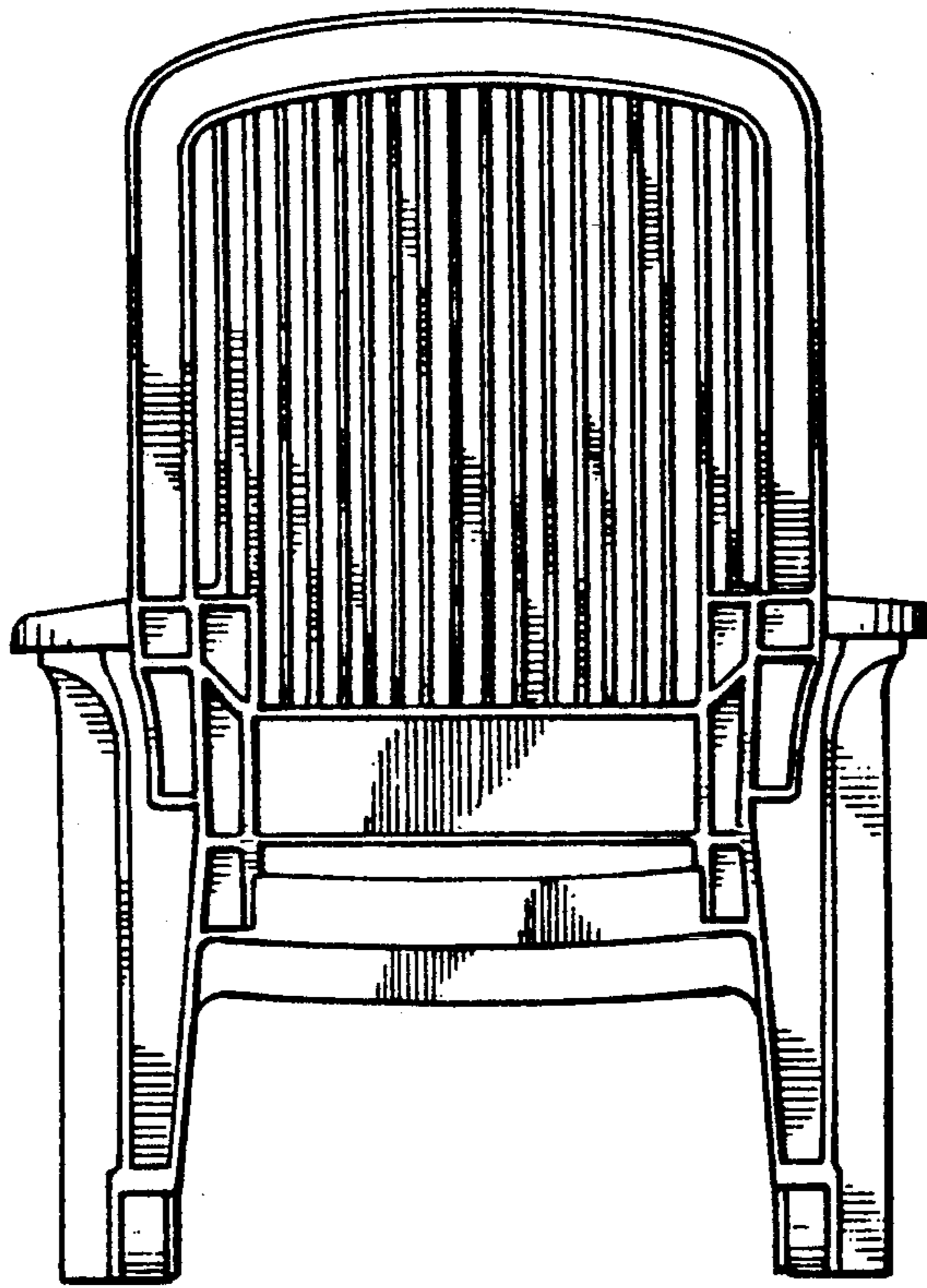

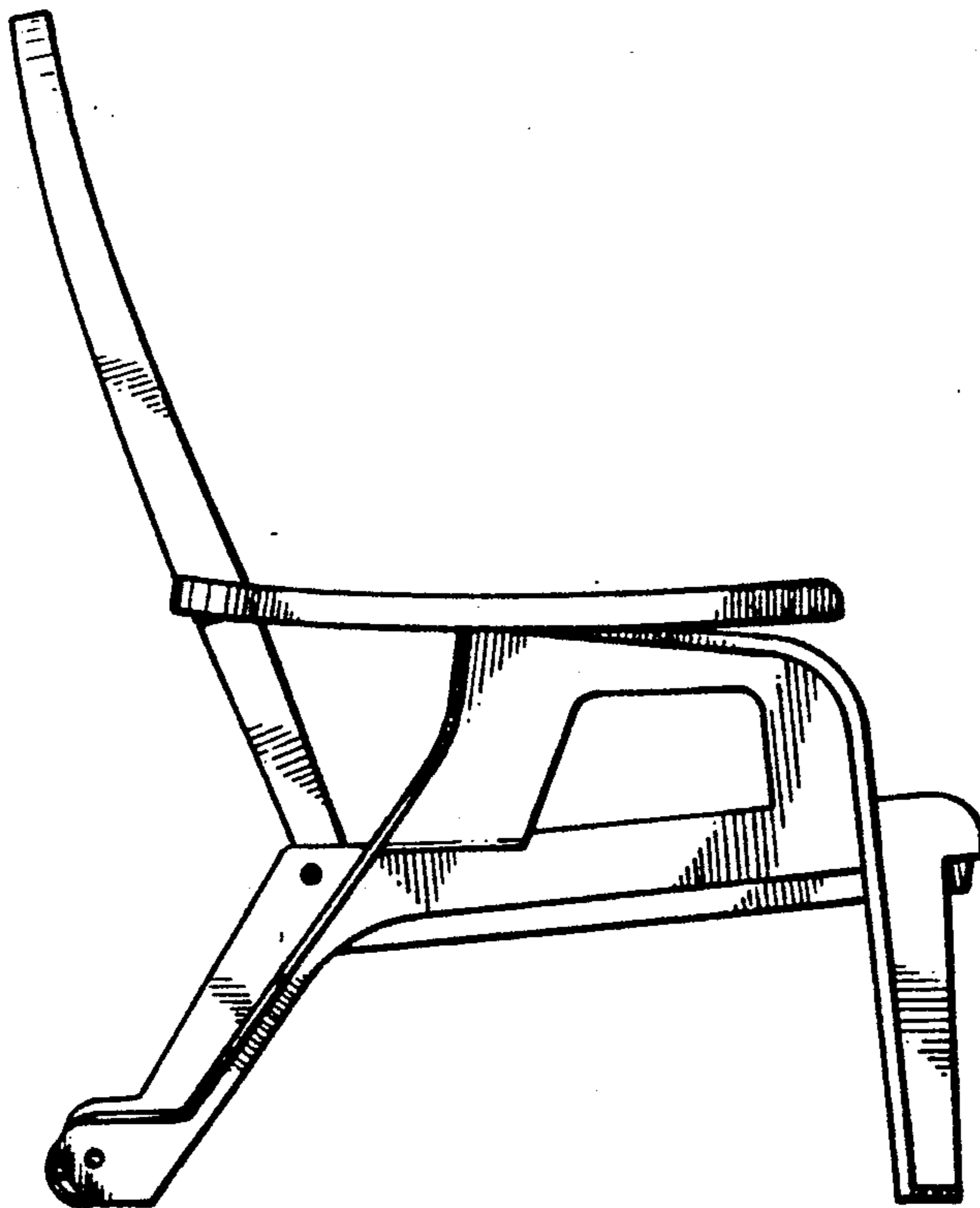

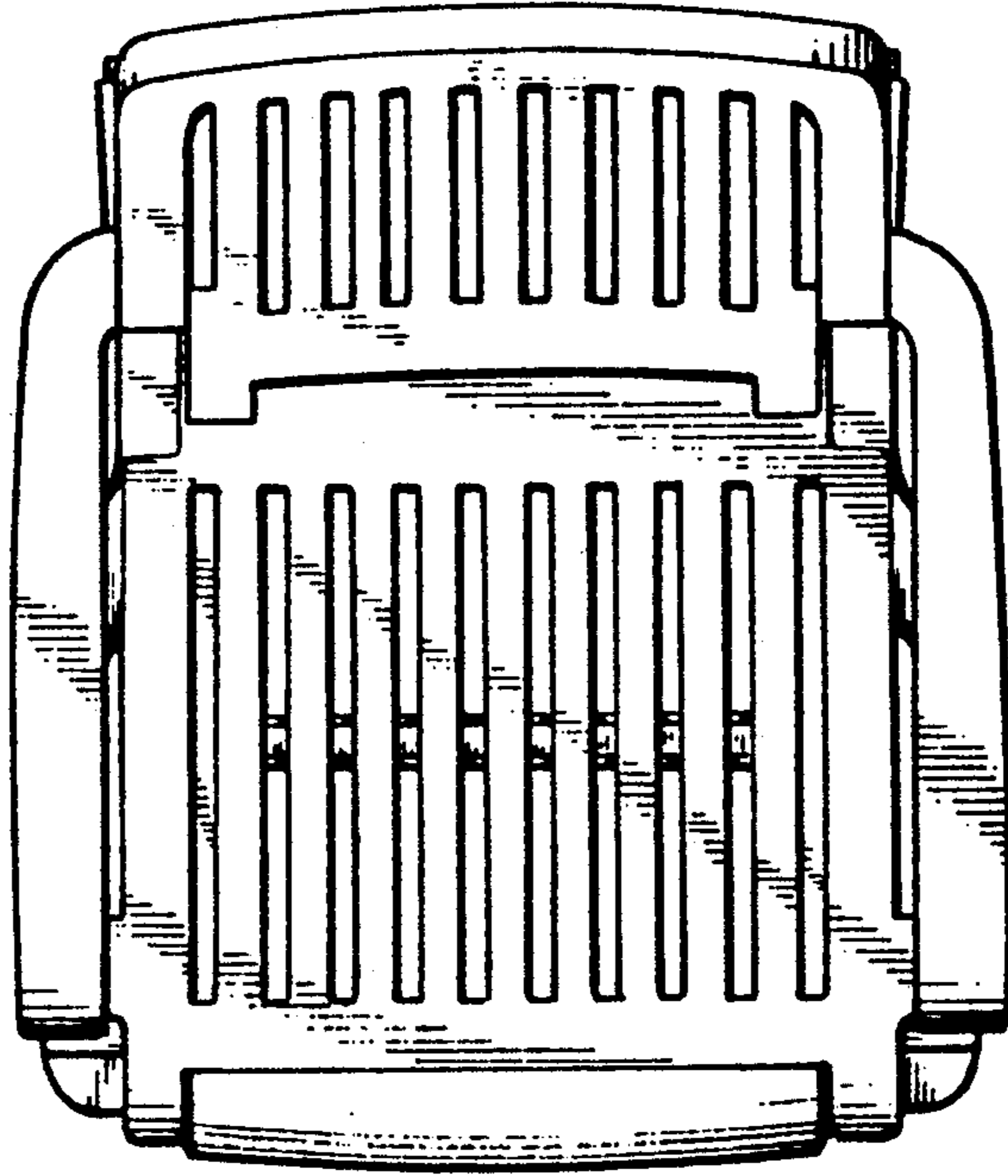

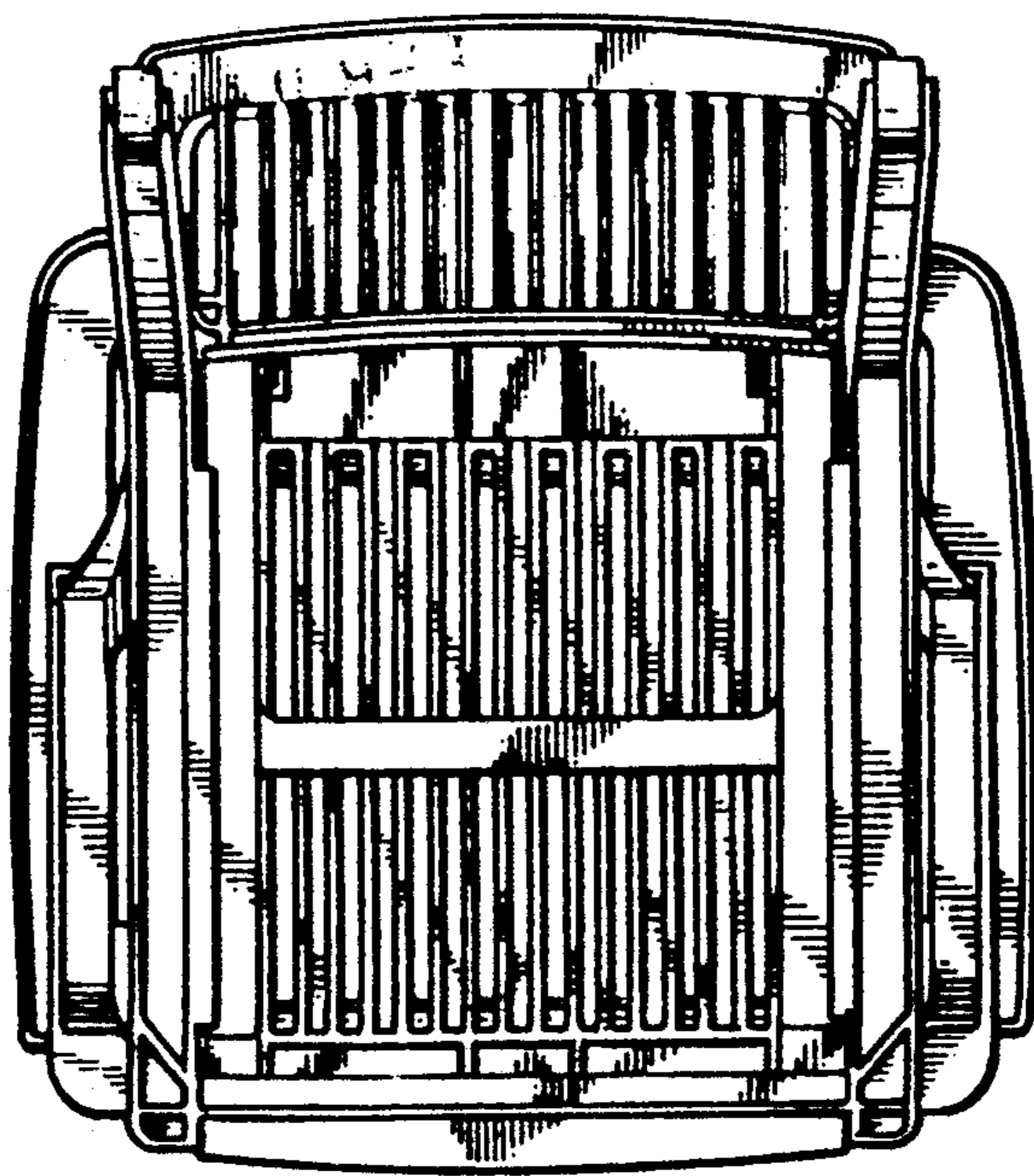

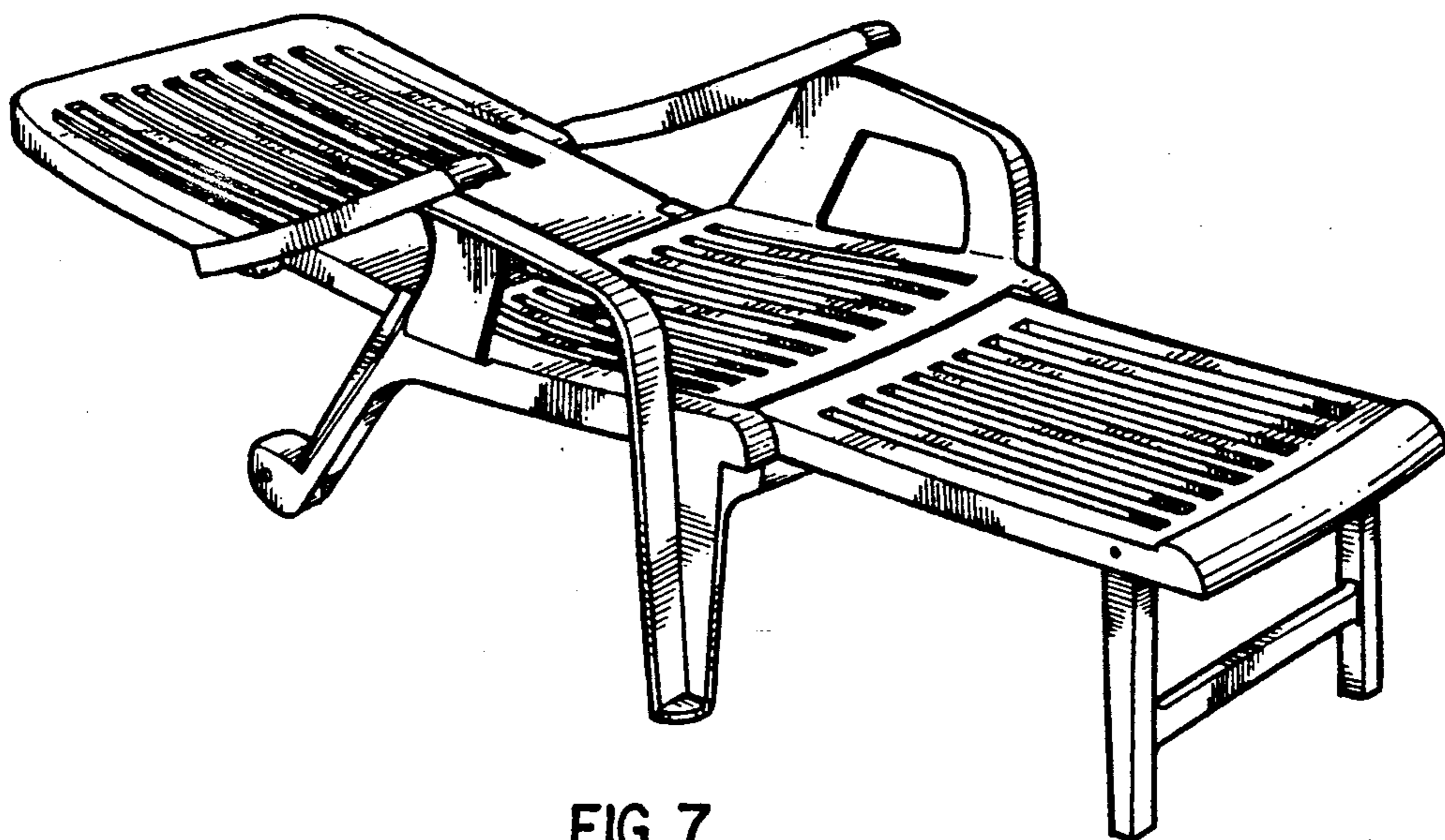

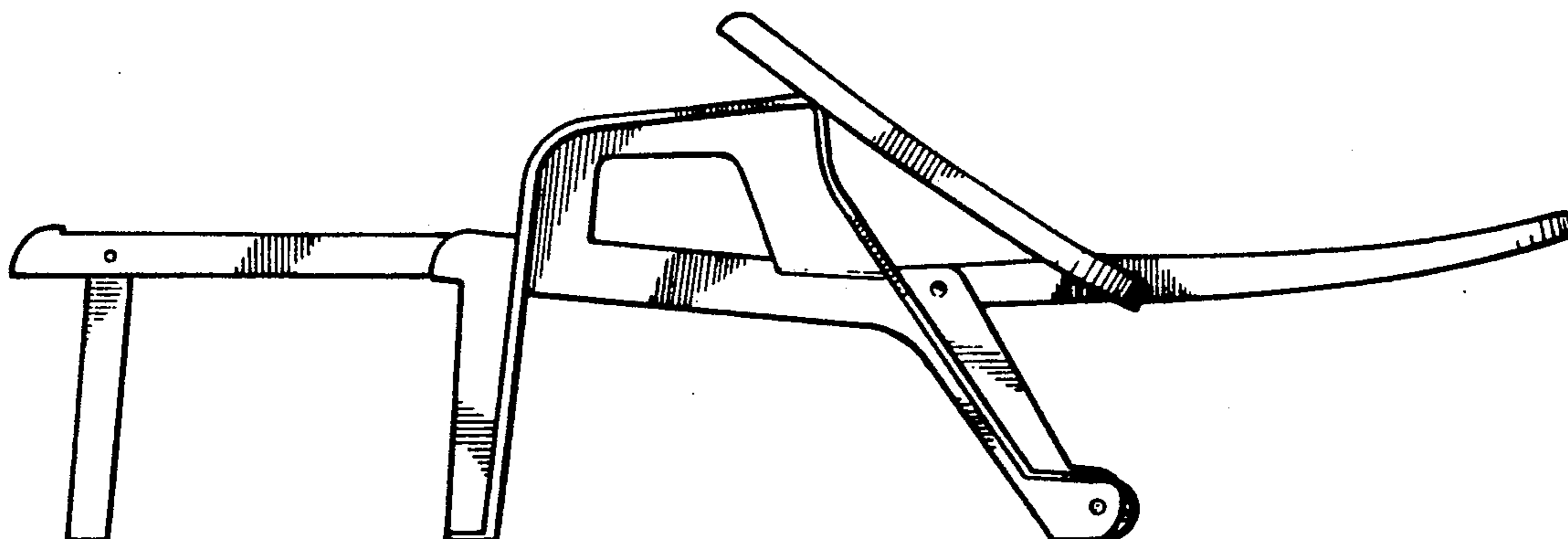
