The ornamental design for a bracket for a hand telephone, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view, taken from the top and rear showing the bracket for a hand telephone of our new design;

FIG. 3 is a right side elevational view thereof;

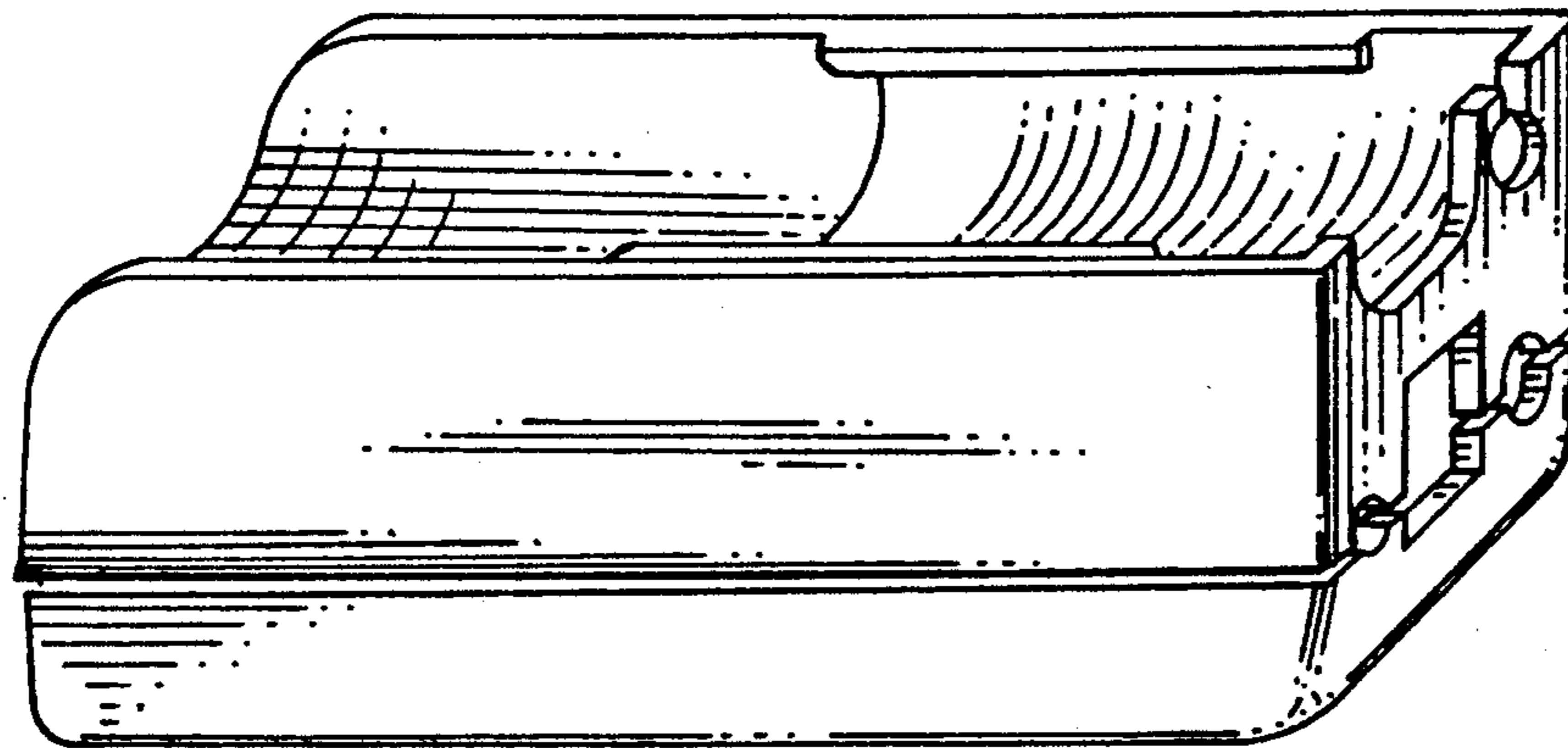
FIG. 4 is a top plan view thereof;

FIG. 8 is a perspective view taken from the rear and right side thereof.



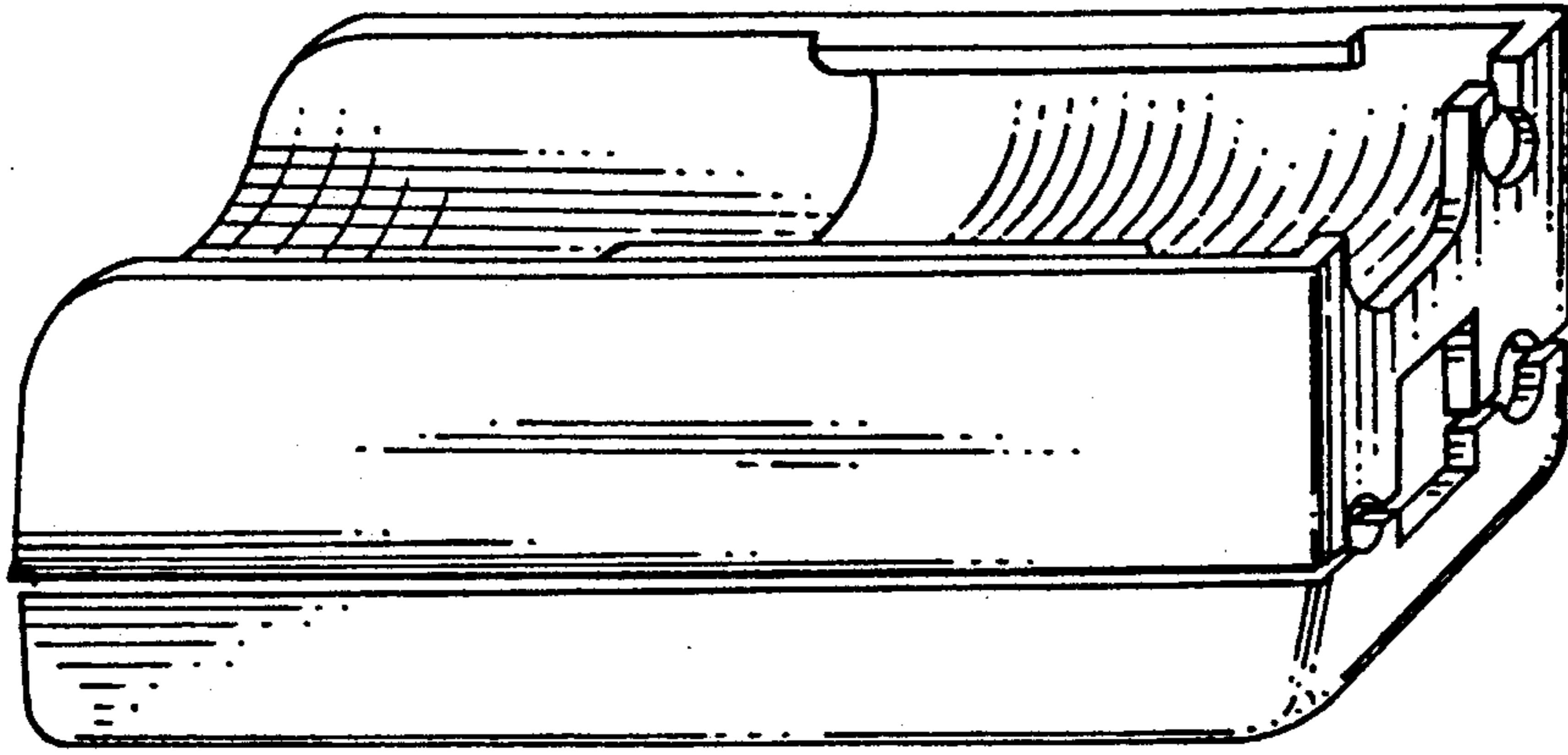

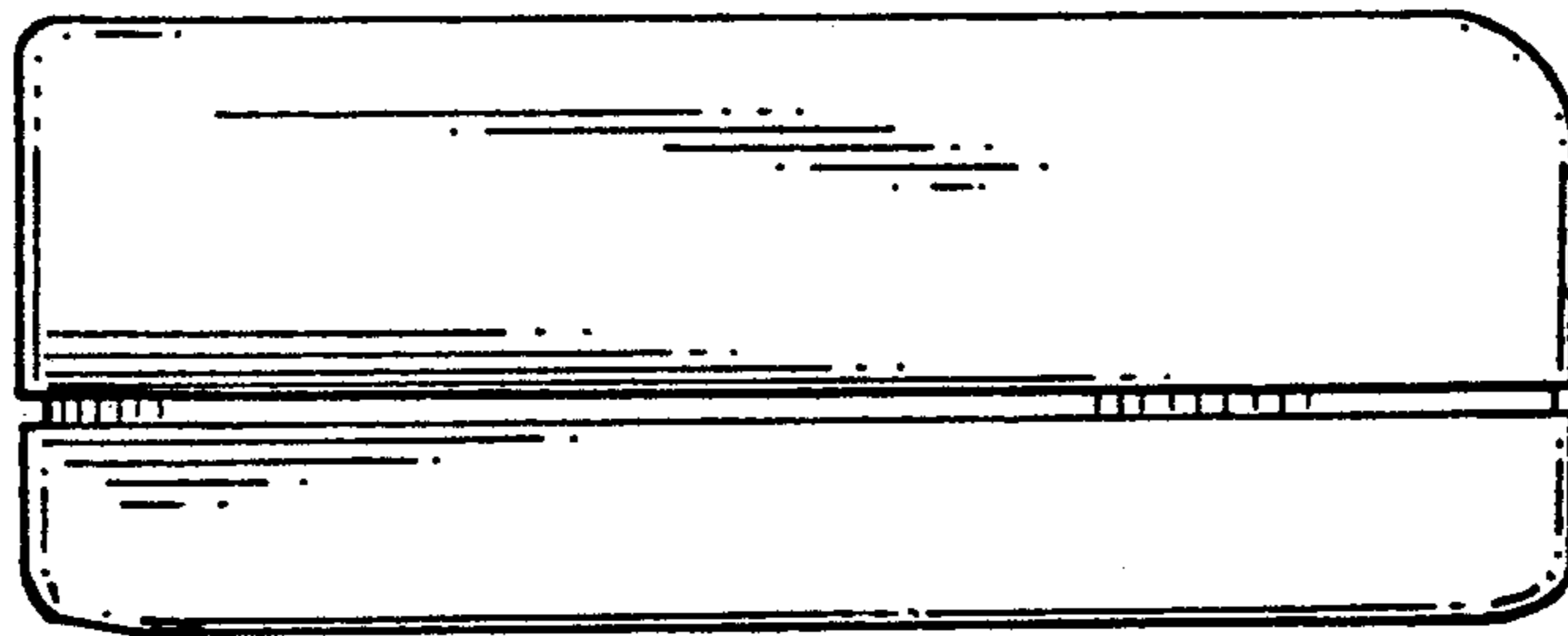

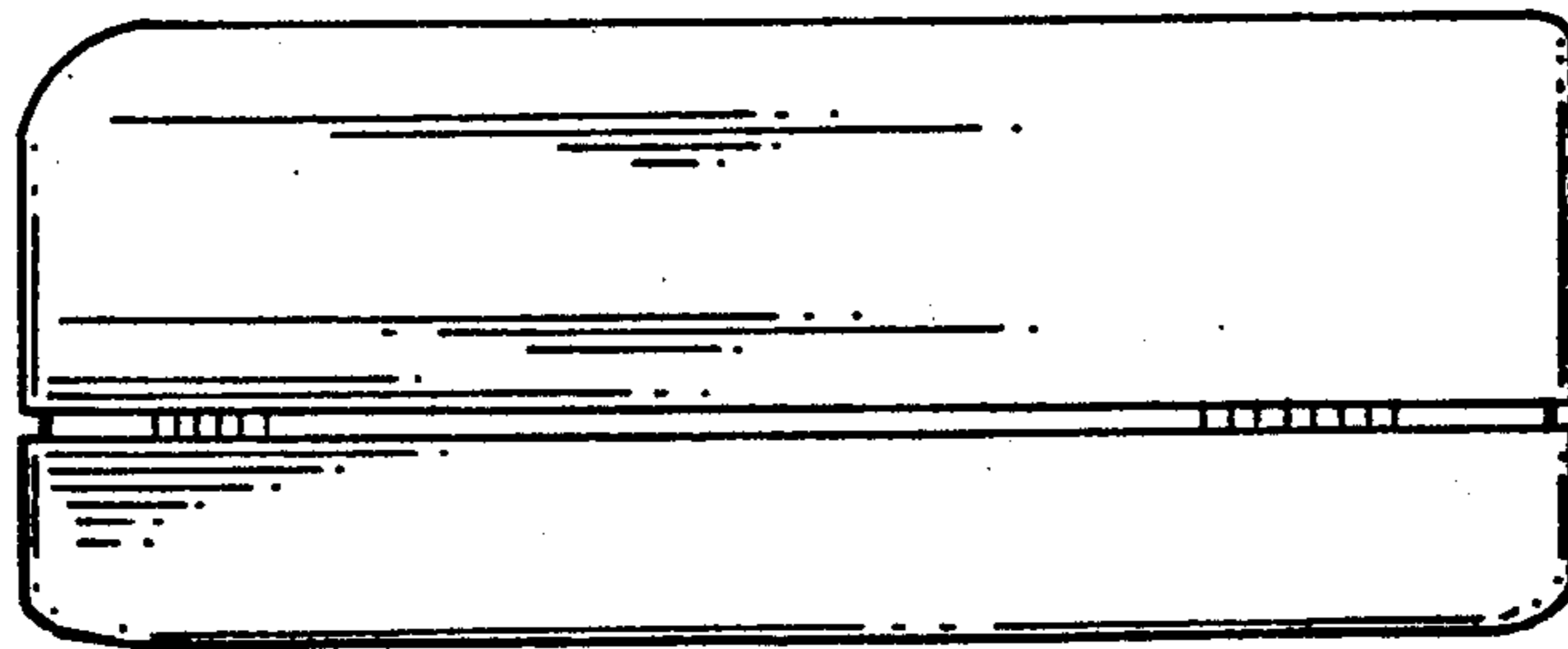

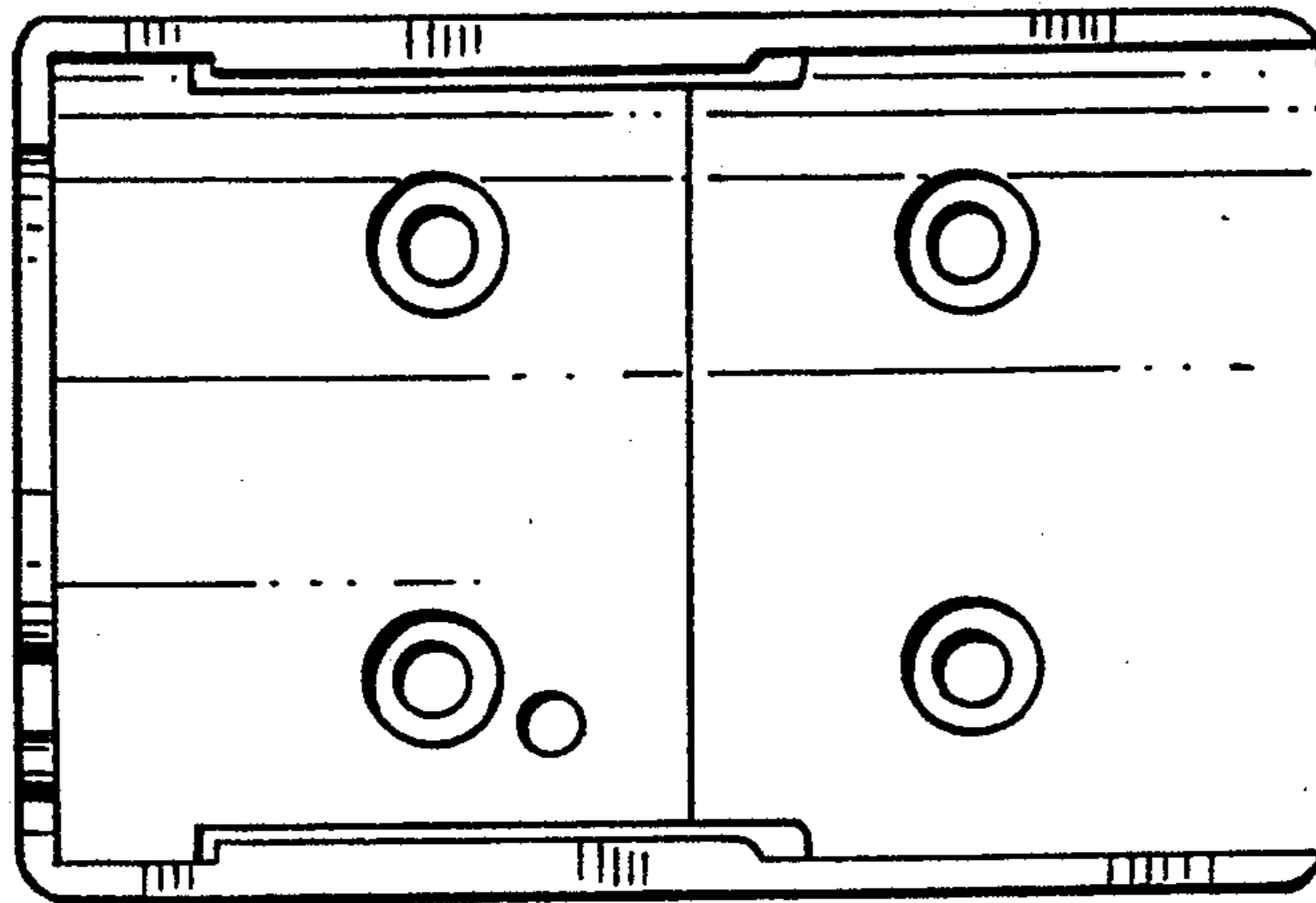

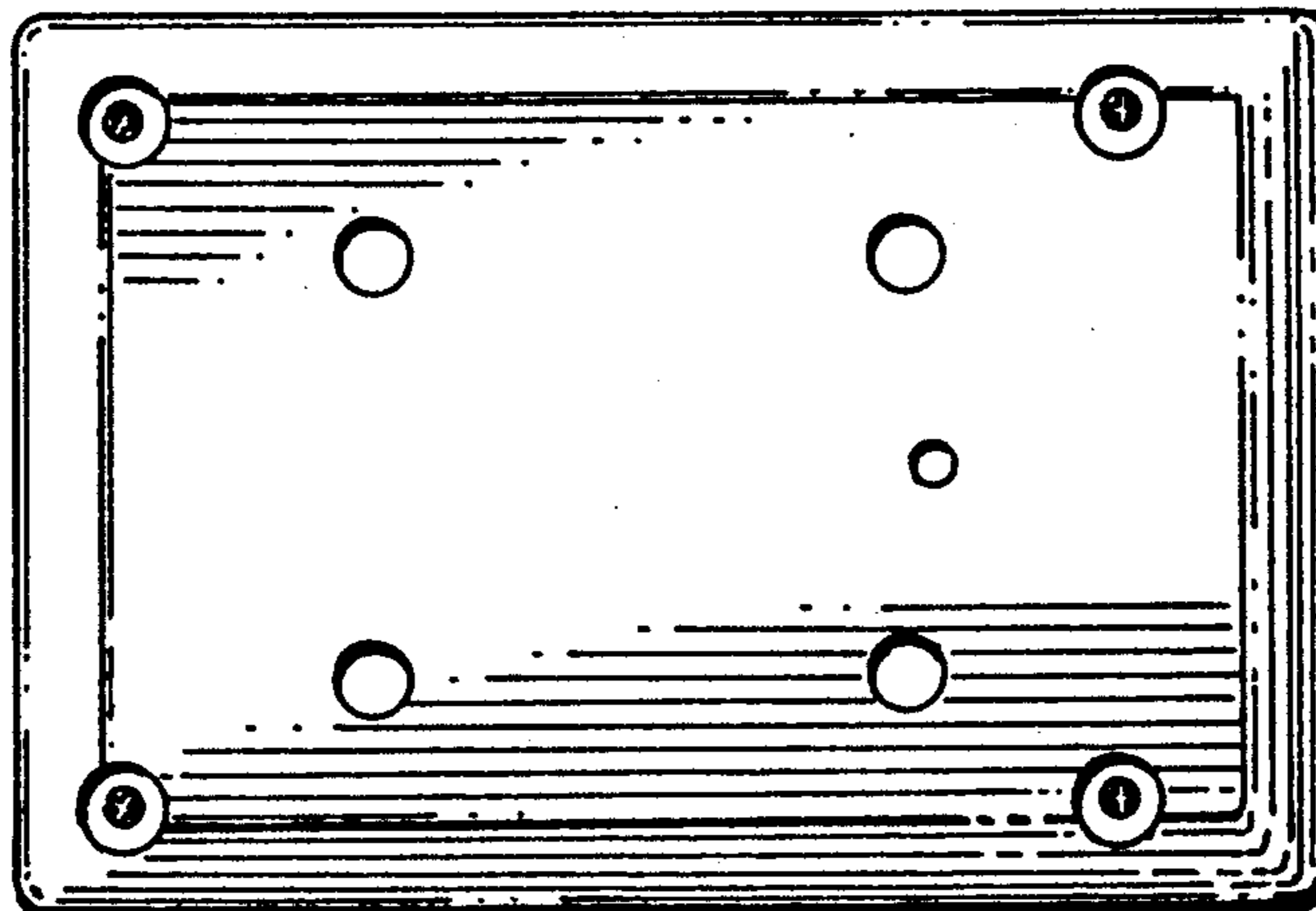

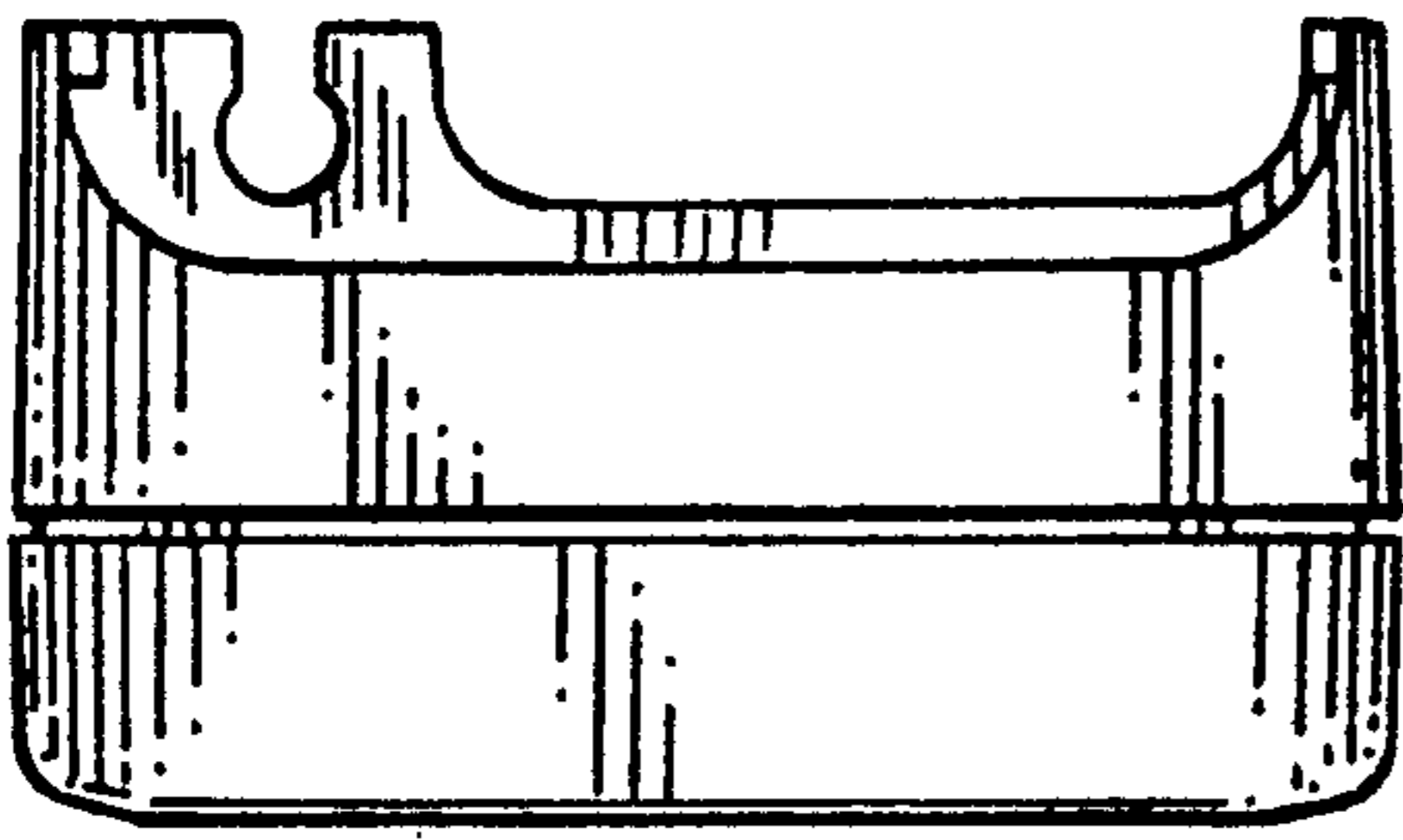

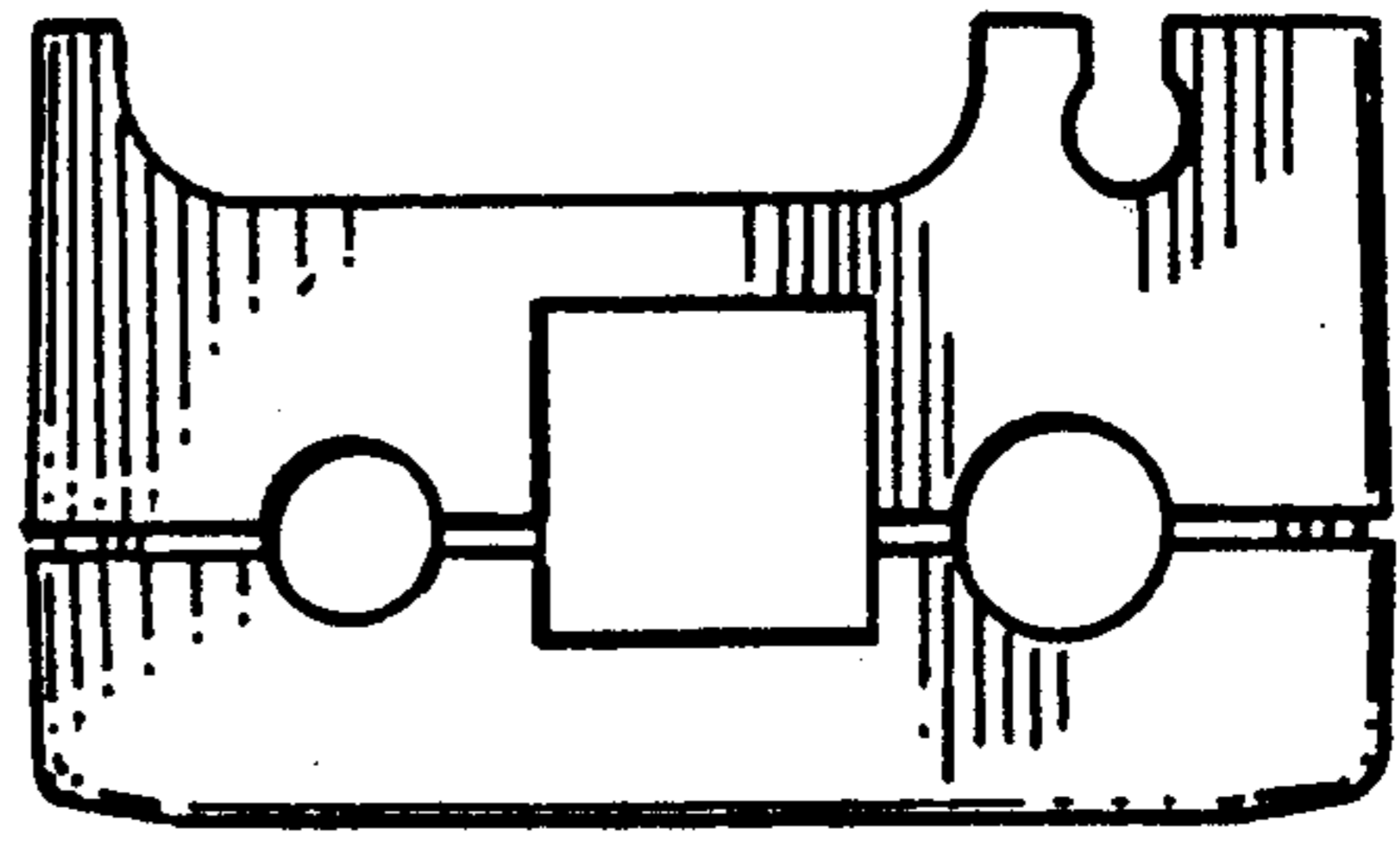

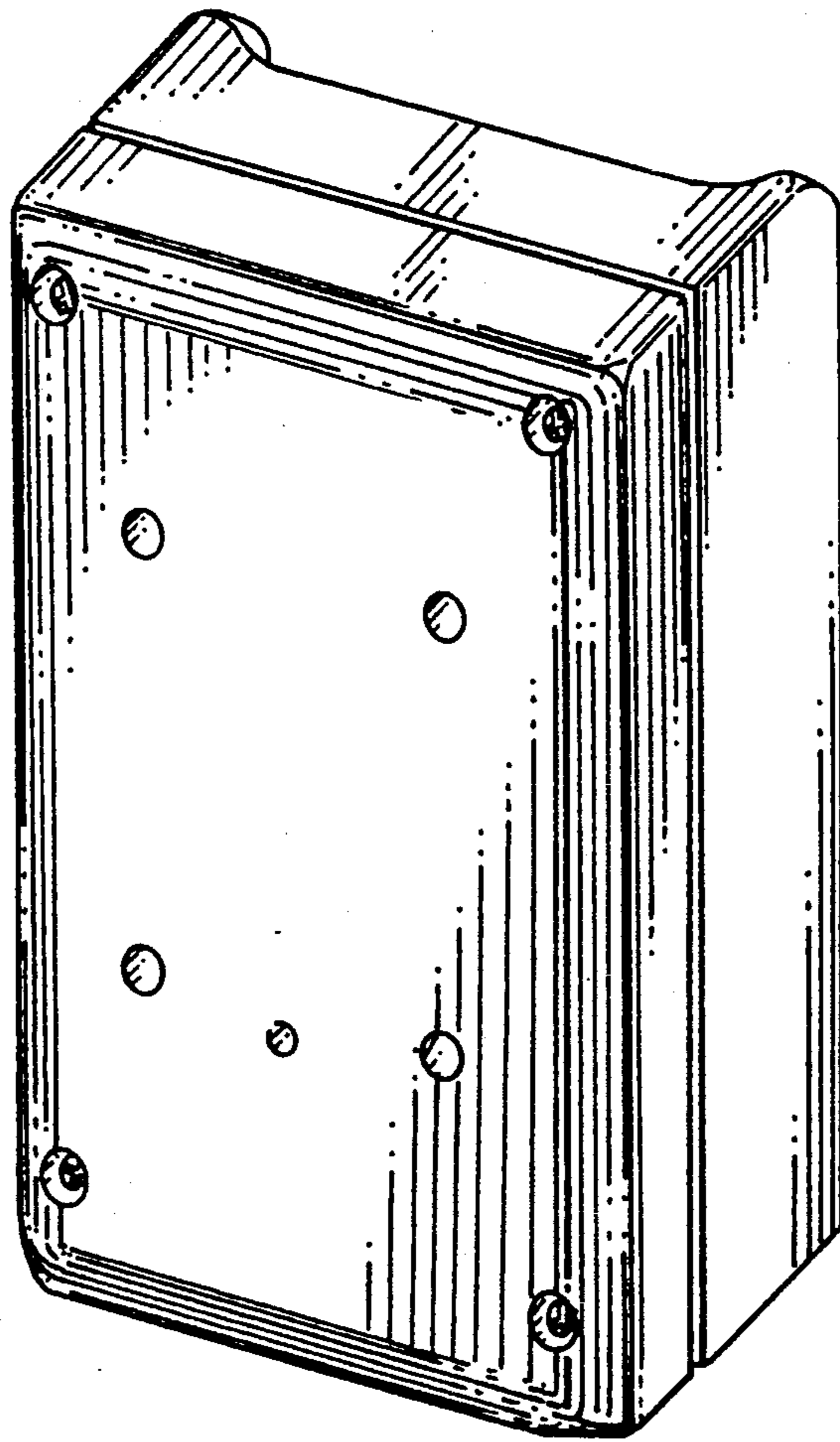
